tion took place the budget was reduced by several hundred thousands of dollars and despite cries by the Board of Education that the budget was very tight and with the budget cut, the Board of Education still had substantial amounts of money or what they lovingly term—"free balance."

Most of the support for the school budget came from Sayre-Woods South. The current expense question was defeated with a NO vote of 1879 and a YES vote only 757.

The capital outlay question was defeated by a similar vote 1869 NO votes as compared to only

755 YES votes.
The total YES votes in six districts comprising SayreWoods South voting districts 9-10-19-20-21-22 showed total of 447 YES votes for the Current Expense Question and a total of 217 NO votes.

The Capital Outlay Question on the ballot received a total of 448 YES votes in voting districts 9-10-19-20-21-22 with a total of 216 NO votes cast in the same voting districts.

School elections in the past as well as this election have shown that most people voting usually vote because of candidates seeking election to the Board of Education, the budget questions receive less votes than some of the candidates.

It has also been a proven fact that once the School Board race for candidates is over and the budget is defeated, the budget questions in the second election receive a very small vote compared to the amount of registered voters in the town.

The total budget voted upon and defeated by the voters at the polls exceeded the \$5-million dollar mark, which made it one of the highest budgets in history of Madison Township.

At the regular school board election the budget was set for some \$5.6 million dollars. The Board of Education made a half hearted attempt to reduce the budget, some \$48,000 was to be used from "free balance."

The residents of Madison Township are fast becoming tax conscious and it is quite possible that reports that the local purpose municipal tax might be doubled had a hand in defeating the school budgets.

It is expected that Council members and the members of the Board of Education will meet soon and plans to revise the school budget will be worked on.

It 'should be pointed out that no money in the proposed budget was for expanding the local school system, the budget merely covered Current Expenses which included teachers salaries, clerks, lanitors, operation of buses by contract or ownership, text books, various school sup-

#### Personal Property Tax For Appartments

Quite a few of the residents of Madison Township object to residents in Garden Apartments because they feel that the apartment dwellers aren't paying any taxes.

We wonder if it would be legal to appoint a Board of Tax Assessors and pass the necessary laws or ordinances that residents of apartment houses be assessed for their personal property such as furniture, clothing,

If this were possible this would represent quite an income to the Madison Township treasury.

The Board of Assessors could be on a parttime basis similiar to census takers, they would inspect each apartment and base the personal property tax on what they found in the apartments.

We feel that this might be a way out of the problem as far as objection to Garden Apartments not paying their proper share. We are still of the opinion that Garden Apartments are a suitable ratable.

#### Something Should Be Done

The accident rate on Route 9 continues to climb, the traffic is steadily increasing, traffic jams continue to plague motorists and yet the State Highway Department has done very little about the situation.

#### TAKE FIVE REV. JAMES SILVER

Pastor Laurence Harbor Community Church

"For whoever would save his life will lose it, and whoever loses his life for my sake will find it." Matthew 16:25.

Marya Mannes in an article in the "Reporter" magazine has made a penetrating comment about the meditation room in the United Nations General Assembly building. So that none of the world's religions will be offended, the symbols of all religions are banished. Miss Mannes describes the impact of this room as follows:

"It seemed to me standing there that this nothingness was so oppressive and disturbing that it became a sort of madness, and the room a sort of padded cell. It seemed to me that the core of our greatest contemporary trouble lay here, that all this whiteness and shapelessness and weakness was the leukemia of non-commitment sapping our strength. We had found, finally, that only nothing could please all. . ."

It is possible to become so broad in outlook as to stand for nothing. The curse of an age of tolerance from all ideas is that there is no strong commitment to anyone. But life demands commitment. Jesus made it plain many times that a man has to choose for him or against him, Fence straddling is one of the worst of sins. It ignores one or the things that makes man more than an animal, the right to make a conscious decision. I would ten times rather have strong disagreement, as long as there was respect for the freedom to disagree, than the indifference which we all too often label tolerance.

AN ORDINANCE AMENDING AN ORDINANCE ENTITLED "AN ORDINANCE PERMITTING UNDER CERTAIN CONDITIONS THE RECLAMATION OF LANDS IN THE TOWNSHIP OF MADISON BY SANI-TARY LAND FILL METHODS AND ESTABLISHING STANDARDS FOR THE DESIGN, OPERATION AND MAINTENANCE OF SANITARY LAND

FILL SITES."

BE IT ORDAINED by the Township Council of the Township of Madison, County of Middlesex, State of New Jersey that the above-captioned Ordinance be amended to read as follows: Section 1. Paragraph 2 (c) is hereby

amended to read as follows:
The cost for such construction permit shall be in the sum of Five Hundred (\$500,00) Dollars per year and such permit shall be renewed annually, if recommended by the Township Engineer.

Section 2, Paragraph 3 shall be amended to read as follows:

Section 2, Paragraph 3 shall be amended to read as follows:

After obtaining such construction permit as aforesaid, no person, firm or corporation shall operate and maintain a sanitary land fill in Madison Township without having also obtained from the Board of Health of the Township of Madison son an operating permit, the granting of a construction permit not being construed to be a permit for the subsequent operation of a sanitary land fill site.

Such operating permit shall be initially issued for a period of one (1) year and shall be automatically rehewed for a subsequent one (1) year period, provided that the land fill operation for which said permit was issued has been operated and maintained in accordance with the provisions of this Ordinance and the State Sanitary Code during the previous

one (1) year period.

The costs for such operating permit shall be the sum of Five Hundred (\$500.00) Dollars and there shall be an additional annual charge of Two Hundred (\$200,00)

Dollars for each automatic renewal.

Section 3, Paragraph 4 is hereby amended to read as follows:

amended to read as follows:

The Board of Health and the Township Engineer and any other officials designated by the Board of Health shall exercise close and rigid control of the method of operation and maintenance of any sanitary land fill project for which an operating permit has been issued, and the original operating permit or any renewal thereof may be terminated by action of the Madison Township Board of Health, after timely notice and a public hearing with respect to any alleged violations of the State Sanitary Code or of any other applicable Health Ordinance or of the State Sanitary Code or of any other applicable Health Ordinances, rules or regulations.

All Ordinances or parts of Ordinances inconsistent herewith are hereby

repealed.
This Ordinance shall take effect immediately upon publication and according
