## Madison Board Engaged In Illegal Activity

Melvin M. Roessler, candidate in last year's Board of Education election today stated that in a desperate attempt to insure passage of the \$4,290,000.00 high school bond referendum the Madison Township School Expansion Committee, which includes Board members William Rice, Carol Kosubucki and Frances White, directed that a 'Poster and Essay Contest' be conducted in grades 3 through 8.

This poster and essay contest was designed to stimulate an awareness of the problems and needs of the Madison Township school system and consequently to generate favorable consideration of the referendum.

Late Friday afternoon County Superintendent of Schools, Robert Blount, ruled this contest in violation of N. J. Statutes, and therefore, illegal.

This ruling was precipitated at last Thursday's Board meeting when former Board of Education member James Garland questioned Joseph Brust, Superintendent of Schools, on the purpose of the contest and suggested to the Superintendent that according to the law no school official shall "direct such pupils to engage in activities which promote, favor, or oppose any bond issue proposal..."

Mrs. Carol Kosubucki challenged Mr. Garland's assertion and stated emphatically that she and the other members of the expansion committee had checked into the legality of the program and had decided to

Not being satisfied with the Board's reply concerning this issue. Mr. Roessler obtained a legal ruling from his attorney that this was a clear cut violation of state law. Mr. Roessler then called County Superintendent Blount who immediately agreed that the program was illegal and also suggested that the Board was in fact jeopardizing the legality of the forthcoming referendum. Mr. Blount then informed Superintendent Brust of his decision and suggested that the contest be cancelled forthwith. Later Friday afternoon, Mr. Brust informed Mr. Roessler that he was issuing a directive to discontinue the contest.

Mr. Roessler further charged that "The Board is engaged in 'psychological warfare' where the students of Madison Township are the victims." "I think," stated Roessler, "that to terrorize the children with prospects of half-day sessions resulting in their being separated from their school chums and having no time to play at school and being burdened with twice as much homework is a despicable and contemptible method of promoting school expansion."

Mr. Roessler cited the case of one eight year old child who came home from school crying because

he was told these very things.

Roessler continued, "Certainly other eight and nine year olds felt the same fear and emotional shock from the brainwashing technique employed by the Board of Education.

"There is a right way and a wrong way to promote a bond issue. In their overzealous desire to obtain a favorable vote, the Madison Township Board of Education has apparently stooped to the detestable position that 'the end justifies the means' - and the strange part of the entire episode is that elementary students were being used to promote a high school."

AN ORDINANCE TO AMEND AN ORDINANCE ENTITLED, "AN ORDINANCE ESTABLISHING A CODE REGULATION THE INSTALLATION MAINTENANCE, REPAIR AND CON-TROL OF PLUMBING AND THE CONNECTION THEREOF WITH OUT-SIDE SEWERS, CESSPOOLS OR OTHER RECEPTACLES: REGULA-TING THE PRACTICE OF PLUMB-ING AND THE ISSUANCE OF LICENSES IN PRACTICE PLUMBING AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF:

- 5.3.4 Building traps are required only on plumbing systems constructed before April 30, 1962, or when a system is changed from a septic to a public sewer. When used, they shall comply with specifica-tions for cast-iron soil-pipe fittings, as specified in Section E-300, Table 3 and 4 and shall have a fresh air inlet on the house side of trap 1/2 the size of the building drain but not less than 4 inches in diameter.
- 5.5.1 A clean-out, easily accessible shall be provided at or near the foot of each vertical waste or soil stack, There shall be a clean-out with a Y-branch inside the wall near the connection between the building drain and the building sewer. Clean-outs shall also be installed serve each change in direction of the building drain and building sewer greater than a 45 angle.
- 5.5.2 Clean-outs shall not be more than 50 ft. apart in horizontal drainage lines and 100 ft. on building sewer
- 7,17,4 A washing machine trap or laundry tray shall be provided for each single family dwelling. There shall be one (1) washing machine trap or laundry tray for each 10 units in multiple family dwellings.

AN ORDINANCE TO PROVIDE FOR THE REGULATION AND LICENSING OF KENNELS AND DOG SHELTERS.

BE IT ORDAINED, by the Township Council of the Township of Madison, County of Middlesex:

 DEFINITIONS:
 "Kennel" shall mean any establishment wherein or whereon the business of boarding or selling dogs or

breeding dogs is carried on, except a pet shop. 2. No person, corporation, or firm 2. No person, corporation, or firm shall operate or maintain a kennel within the Township of Madison, unless such person, corporation or firm shall first receive a kennel license from the Town-

Application for a license for a new shall be made in writing to the kennel shall be made in writing to the Township Health Officer, Such application shall contain a full and detailed written description of the premises where the establishment is located or proposed to be located, and shall state the purpose for which the kennel is to be maintained or operated. The Health Officer may require the applicant to submit drawings. kennel require the applicant to submit drawings, sketches or plans describing the premises. The Health Officer shall review and examine the application to determine whether the operation and maintenance of the kennel will comply with the state and local health legislation, regulations, and standards regarding location, construction, operation and sanitation of and at such establish-ments. The Health Officer shall require the applicant to make such changes may be necessary to effect so effect such compliance. If the Health Officer deter-mines that the operation and maintenance of the kennel will comply with the state and local health legislation, regulations and standards, he shall then advise the Township Clerk, and upon receipt of the appropriate fee, the Clerk shall then issue the license.

shall expire on the last day of January of each year. All applications for annual renewals of kennel licenses must be made in the month of January. The annual license

fee for a kennel and for any renewal thereof shall be Ten (\$10,00) Dollars for less than 10 dogs and Twenty-Five (\$25,00) Dollars for more than 10 dogs.

5. No kennel shall be transferred, sold conveyed to another person, corporation or firm, nor shall any kennel be moved to another location, or its operation sub-stantially changed, without application first being made to the Health Officer for his approval. If the Health Officer determines that compliance with state and local health legislation, regulations and standards will be maintained, he shall approve such transfer, sale, conveyance, move or change.

6. No person owning, keeping or harboring any dog or dogs shall permit the same to habitually bark or cry so as to annoy any neighbor or other resident.

 The operation and maintenance of all kennels shall be conducted in accordance with the rules and regulations promulgated by the State Department of Health pursuant to N.J.S.A. 4:19-15.14.

8. All premises upon which kennels are operated shall be maintained free of any accumulation of filth or source including but not limited to the infestation of rodents, flies, fleas, parasites, or other insects, which may be hazardous to the health or comfort of the residents of Madison

Township. 9, All kennels shall have in constant attendance, a person or persons to maintain the premises. However, in the event that the kennel accommodates less then ten animals, there shall be daily inspections by the wner or persons maintaining the ken-

10. There shall be a regular inspection of the premises at least once every three months by a Township Health Official. The records concerning the operation of the kennel shall be available for the inspection of said Health Official. The records shall show the type of dogs, the ages of dogs, whether they are regis-tered with the American Kennel Club, and whether the said dogs are for sale or for breeding purposes. The Health official may require that the records kept provide additional information which he deems necessary.

11. Waste matters, excrement and other unsightly or dangerous articles shall be cleaned away each day. They shall not be burned on the premises nor shall they be buried thereon. At least once a week, the kennels shall be washed down with a recognized disinfectant.

12. All kennels shall consist of one

dogs. Adjoining each shelter shall be a fenced-in area known as a "run" upon which the dogs can exercise. The runs shall be generally rectangular in shape and fenced on three sides. The fourth side shall lead into the shelter. An ex-ercise area exclusive of the shelter and run area may be provided.

13 a. All dogs shall be confined to

their shelter and run area except when they are using the exercise area. They shall not be permitted to wander elsewhere on the owner's property or onto the property of neighbors or adjoining

13 b. No shelter and run area or exercise area shall be established less than ten feet from any property line.

13 c. If a shelter contains dogs classified as small or toy breed, in accord-ance with American Kennel Club specifications, the size of the adjoining run shall be no less than three feet by eight feet and there shall be no more than seven dogs housed therein. The fence enclosing the run shall be four feet high and shall be of chain link type or of heavy galvinized welded mash.

13 d. If a shelter contains dogs classified as medium or large in accordance with American Kennel Club specifications, the size of the adjoining run shall be no less than four feet by ten feet, and there shall be no more than three dogs housed therein. The fence enclosing the run shall be six feet high and shall be of chain link type or of heavy galvanized welded mesh.

13 e. Mongrels will be classified as either small, toy, medium or large according to their shoulder height.

13 f. Fencing for exercise area shall

be of such height and strength as to provide for the largest dog accommodated, in accordance with the specifications set

forth above.

13 g. At any one time, the use of the exercise area shall be limited to the occupants of one run so that there shall be overcrowding in said exercise

area.

13 h. All fences required by this ordinance shall closely follow the contour of the ground so that it will not be possible

for dogs to crawl under a fence.

13 i. The surface of the runs shall be composed of cement or macadam of sufficient thickness so it shall not crack. Surrounding the run, there shall be a one-foot border of crushed stone at least six inches deep, provided the soil underneath is permeable. If the soil is not permeable, the 12" border shall consist

of a six inch depth of sand beneath six inches of crushed stone. As an alternative to a hard surface run as described above, if the ground underneath is permeable, the run may consist of a layer of crushed

stone one inch deep.

14. In the event his ordinance or any provision thereof is violated, the license of the owner or operator of the kennel shall be suspended subject to the licensee's requesting a hearing on the question of whether there shall be a revocation of the license. In the event no formal request for the hearing is received by the health authorities within two weeks after notice of suspension, the license

may then be revoked.

15. In addition to the remedy set forth in the previous paragraph, for a violation of this ordinance, a complaint may be made by the Health Officer in the local Municipal Court. Upon conviction for violation of this ordinance, a penalty not less than Five Dollars nor to exceed one Hundred Dollars may be imposed. Each day which a violation continues or has continued shall be deemed to be a separate offense. After the first conviction, for violation of this ordinance, any subsequent conviction shall result in a penalty of not less than Fifty (\$50.00) Dollars per day nor more than One Hundred (\$100.00) Dollars for each day during which the violation continues or has con-

16. All ordinances or parts thereof inconsistent with the provisions of this

ordinance are hereby repealed to the extent of such inconsistency only.

17. All kennels properly and legally in operation in the Township on the effective date of this ordinance shall comply its provisions no later than three months thereafter.

18. If any section, paragraph, sentence, clause, portion or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, sentence, clause, portion or provision so adjudged, and the remainder of the ordinance shall be deemed valid and effective and not affected by such adjudication.

19. This ordinance shall take effect immediately upon publication thereof after final passage and approval according to
