Dems Endorse Smith For Assembly

Harold G. Smith, president of the Madison Township Young Democrats was unanimously endorsed to become a candidate for the New Jersey State Assembly in the appoming November election. At a meeting at which Robert N. Wilentz, Assemblyman, was a guest speaker, a motion was made by Councilman Spiros Columbus that Madison Township be accorded recognition in the Legislature and that specifically Madison Township provide an Assembly candidate in the upcoming election. Mr. Columbus

stated that Mr. Smith is eminently qualified, through years of political experience, at all levals in local and county politics. Mr. Columbus further stated that he did not presume to infringe upon the prerogatives of the County Democratic Organization in making this recommendation. He stated that he recognized the selection of candidates for the Assembly is a difficult task and at often times does not please everyone. He said that his endorsement was in the nature of a recommendation only and did in any way constitute a

unnecessary to do more than to recommend Mr. Smith. In his opinion, he said that the County Organization, in its wisdom, could not come to any other conclusion if Madison Township is to have a representative.

Mr. Smith is an attorney-atlaw who is associated with the law firm of Wilentz, Goldman & Spitzer, Esquires, 252 Madison Avenue, Perth Amboy. Mr. Smith is a graduate of Rutgers University, attended the Wharton School of Business, Philadelphia, and is a graduate of New York

University, where he was a member of the Law Review and the Phi Alpha Delta legal fraternity. Mr. Smith has served as township attorney for the Township of Madison, attorney for the Madison Township Board of Health, the Madison Township Planning Board and as municipal prosecutor of the Township of Madison. Mr. Smith was also County Chairman for the National Multiple Sclerosis Society for the year 1966.

Mr. Smith is a veteran of the Korean War. During his military service, he was awarded the Bronze Star. He served with the 31st regiment of the 7th Infantry Division and he was honorably discharged with the rank of First

Lieutenant.

Mr. Smith is active in many civic and social affairs. He is a member of the Madison Township Rotary Club, the Sayre Woods Lodge #229, member of the Laurence Harbor Lions Club, a trustee of the Madison Township Carleton Baseball League, a trustee of the Madison Township Babe Ruth Club, a member of the New York University Alumni Federation, member of the American Bar Association, member of the New Jersey Bar Association, member of the Middlesex County Bar Association, member of the Perth Amboy Bar Association, member of the Jersey, member of the NACCA Bar Association and a member

of the National Lawyer's Club. He is also a member of the Laurence Harbor American Legion and a member of the Laurence Harbor Veteran of Foriegn Wars.

Upon his admission to the Bar, Mr. Smith was legal secretary to Supreme Court Justice, Hayden Proctor for one year.

Board Candidate Hits Opposition

Board of Education candidate | Melvin M. Roessler has charged two other candidates with "trying to deceive the voters.

He lodged the charges against board candidates Mrs. Carol Kosobucki, an incumbent, and Edward Gardner.

The two are "trying to deceive the voters by attempting to discredit" Roessler's "fight for pupil safety, free recreaand quality education." tion Roessler c

Roessler said Mrs. Kosobucki's charges that he is narrowing his views to buses and ball games "displayed to the public her complete lack of concern for pupil safety and recreation."

He termed Mrs. Kosobucki's voting record on recreation "ap-

palling and intolerable. Roessler charged Mrs. Kosobucki with proposing the elimination of the high school athletic program, with voting against free use of the school facilities for the summer recreation program and with proposing a \$2.50 charge per day per school

for the Recreation Committee. Although the board pleaded insufficient funds, Roessler charged it paid an attorney \$25 hour to sue the township and footed expenses for members who attended an Atlantic

City convention. Roessler said Mrs. Kosobucki's "lack of concern for the children was further demonstrated this year when she recommended the complete

elimination of the kindergarten program hazardous route transportation and reduction of parochial transportation expense."

Roessler charged Gardner has been "conspicuous by his absence" at the board meetings although he claims he is liaison to the board for the PTA.

He also charged Gardner with giving inaccurate information on the average per pupil cost of education and on the hazardous route transportation policy.

Roessler said if he is elected, the board "would acquire an open-minded and unbiased person who has a deep and abiding interest in children."

He said the people will acquire "a board member who will be responsive to their desires as well as their needs."

NOTE:—The term "current expenses" includes principals', teachers' janitors', and medical inspectors' salaries, fuel, textbooks, school supplies, flags, transportation of pupils, tuition of pupils attending schools in other districts with the consent of the Board of Education, school libraries, compensation of the Secretary, of the Custodian of School Moneys and of Attendance officers, truant schools, insurance, maintenance of plant and incidental expenses.
