# School Board Election Set For Madison Township

On Tuesday, February 14, which by the way is Valentine's Day, the voters of Madison Township will have the opportunity to go to the polls and select three Board of Education members, but more important they will have the opportunity to vote on a proposed school budget. Needless to say the

school Board total budget is well in excess of Seven Million dollars, which is quite a bit of money.

Last year the school budget was twice defeated at the polls by the residents, it is expected that the school budget will pass, because many residents of the township are under the impression that they will be voting for school expansion and school rooms when in actuality they will

only be voting for Current Expenses. The local Board of Education which never seemd to have trouble getting teachers offered the school teachers a very good salary scale. It must be said that many of the teachers employed by the Board of Education do not live in the township nor do they pay taxes in our Town.

There is little doubt that the school budget will be voted down by the citizens of Madison Township, the present board of education, following defeat of last year's school budget curtailed quite a few activities, many of these unfortunately were school activities, we didn't notice that they cut out the Board of Education members attendance to Atlantic City, which usually cost several thousand dollars.

We hope that the budget is approved by the residents of the Township, we hope that the taxes are increased tremendously, we hope that the residents of the township can afford to pay their taxes. We certainly hope that the school budget doesn't become part of a November political

"But you shall receive power . ." Acts 1:8.

Now let's examine the facts. At present, according to the Board's audit report, there exists a surplus of \$225,328.73. Also, the Board has on hand \$242,252. of unspent sales tax money. The Board of Education agrees that they have not curtailed any programs except for site improvements.

However, if the Board of Education had a member who was skilled in school finance, as I am, the obvious solution would have been to call a special meeting of the school district to seek approval for the expenditure of idle sales tax dollars and surplus funds to make the necessary improvements. Because the Board is not versed in the many facets of school finance, the improvement work at Madison Park, Cheesequake, and other schools has been delayed at least

Mrs. Kosobucki wonders why I repeatedly refuse to comment on this year's school budget. It should be obvious to her, as well as to all of the disappointed residents who attended the Public Hearing on the proposed budget, that no one, not even the greatest financier in the world, could decipher the mumbo-jumbo that was presented to the public at that hearing.

I charge the Board with deliberately attempting to conceal the make-up of the budget because Installation Held they do not want it questioned. They have succeeded in this approach because no one has sufficient information to properly evaluate it, I, as an intelligent man well-versed in school finance, would not comment on a budget on which I have not been given the facts."
