SALE OF REAL PROPERTY FOR UNPAID TAXES
AND MUNICIPAL LIENS

Public notice is hereby given that the undersigned, the Collector of Taxes of the Township of Madison, County of Middlesex, State of New Jersey, will sell at public auction in the Municipal Building, Routes 9 and 34, Cheesequake on the 27th day of December, 1967 at 9:30 A. M. the following described lands:

Said lands will be sold to make the amount of municipal liens chargeable against the same as of the first day of July, 1967 exclusive however, of the lien for taxes and other municipal liens for the year 1967, as computed in the following list together with interest on said amount from the first day of July, 1967 to date of the sale and costs of sale. The subscriber will sell in fee to the person who bids the amount due subject to redemption at the lowest rate of interest, but in no case exceeding eight (8) per centum per annum. The payment for the sale shall be made before the conclusion of the sale or the property will be re-sold. Cash or certified check only will be accepted in payment.

Any parcel or real property for which there shall be no other purchaser will be struck off and sold to the Township of Madison for redemption at eight (8) per centum, per annum and the Municipality shall have the same remedies and rights as other purchasers, including the right to bar or foreclose the right of redemption.

The sale shall be made and conducted in accordance with the provision of the Statute of the State of New Jersey entitled "An Act, concerning unpaid taxes and assessments and other municipal charges of real property, and providing for the collection thereof by the creation and enforcement of liens thereon (Chapter 5 of Title 54 of the Revised Statutes,)" and acts supplementary thereto and amendatory thereof.

At any time before the sale the undersigned will receive payment of the amount due on any property with interest and costs up to the time of payment.

Receives Promotion

Marine Lance Corporal James G. Dunn, son of Mr. and Mrs. James Dunn of 37 Margaret St., Old Bridge, N.J., was promoted to his present rank while serving with the Fourth Battalion, 11th Marine Regiment, First Marine Division in the Republic of Vietnam.

His promotion was based on time in service and rank, military appearance and his knowledge of selected military subjects.

His battalion provides artillery fire support to the First Marine Division's infantry units engaged in combat against the enemy in South Vietnam.

The unit is also engaged in a civic action program designed to assist the Vietnamese people in completing self-help projects, such as the building of wells, culverts, small bridges and schools. Equipment and materials for the projects are made available through the Marine Corps Reserve Civic Action Fund. Marines in Vietnam provide the know-how and guide the Vietnamese people in carrying out these projects.

The new bulletin board outside the Laurence Harbor Community Church was dedicated by the Pastor, Rev. James H. Silver, on Sunday, December 17th. The family and friends of Walter J. Schmidt donated the bulletin board to the Church in memory of Walter, who was killed in Vietnam on November 8, 1966.

Specialist Fourth Class Walter Schmidt was attached to Company B First Battalion 28th Infantry. He was posthumously awarded the Purple Heart and Silver Cross Medals for gallantry in action. These were presented to his parents at a special award ceremony at Fort Monmouth on March 4, 1967.

He was later posthumously awarded the Military Merit Medal and the Gallantry Cross with Palm by the Republic of Vietnam for being a "courageous combatant, well-known for his sacrifices, good will and cooperation in blocking the Red Wave of aggression from engulfing South Vietnam and Southeast Asia." These medals were also presented to his parents, Mr. and Mrs.

Fred Schmidt, 731 Lawrence Parkway, in the Laurence Harbor Section of Madison Township.

Walter had lived with his parents and brother, Fred. He had attended Memorial School in Madison Township and Sayreville Memorial High School, and was a member of the Laurence Harbor Community Church. Before entering the Army he had worked with the Quiet Kool Division of Emerson Radio in Avenel. He was the first serviceman from this area to lose his life in the Vietnam conflict. Representatives of the Veterans Alliance of Madison Township, and the Laurence Harbor First Aid Squad were present.

OLD BRIDGE AMBULANCE AND EMERGENCY SQUAD

In the month of November, the Green and White Squad responded to 81 calls, which represented 403 man-hours spent and 1660 miles travelled.

This past year, this volunteer first aid service to the township can be expressed statistically by the response to 740 calls, 3612 man-hours spent and 15,619 miles travelled. It can be expressed in a more personal manner by hundreds of people cared for and administered to by trained, competent first-aid men.
