## Budget Approved

At a special meeting of the Township Council held at the Municipal Building on Route 9 Wednesday evening the Madison Township Council voted to approve its reduced budget. Budget cuts were announced at the regular budget hearing over 100 persons appeared at the regular meeting to urge that the council reduce its advertised budget.

The budget cuts were readvertised and approved at the special meeting of the council which was called to act on approval of the resubmitted budget.

The tax rate in the Township is expected to be \$7.17 per \$100 of assessed valuation, the local purpose tax \$1.15 or an increase of only eight cents, the school tax \$4.54 up a total of \$ sixty cents the county tax rate is \$1.48 which has increased 12 cents.

The township increased its estimated tax collection rate from 92 percent to 94.5 percent which would account for a reduction in the amount to be raised for uncollected taxes. The township council also increased its anticipated revenue and will appropriate \$200,000 from its "free-balances" or surplus.

Earlier this month the township council lopped off approximately \$700,000 from the Board of Education budget. The Board of Education budget was soundly defeated by a four to one vote. The original Board of Education budget asked for expenditures totaling some TEN MILLION DOLLARS. This was defeated at the polls by the voters, the Board of Education then voted to reduce its original demand for TEN MILLION DOLLARS by only \$250,000. The voters of the township again soundly rejected the Board of Educations second budget proposal. The school budget was then submitted to the Township Council. The council could have ac-

## And So It Goes

Once again the Madison Township Board of Education decided that it knows better than anyone else what the township needs. Now the Board of Education is negotiating directly with the Borough of Matawan---for the installation of a forced main sewerage system---the new main would handle the sewerage for the NEW HIGH SCHOOL presently under construction off Route 516 and another un-named school--the action by the local Board of Education is a "slap in the face" the Samuel Clark, Chairman of the Madison Township Sewerage Authority--Mr. Clark has spent many, long hours diligently working in behalf of the residents of Our Town in the Sanitary Sewer problems in Our Town---we must add that Mr. Clark in all probability knows more about the sanitary sewerage system in Madison Township than any other resident of the Township---the action by the Board of Education is a direct insult to the members of the sewerage authority---once again the Madison Township Board of Education is "off-limits"---the local board has once again shown disregard for other agencies in the Township---construction at the new high school is well underway, with reports that the school will not be ready for occupancy for September 1968---during the recent campaign Mr. Rice and his other running mates claimed that the New High School would be ready for occupancy in September this was only last month---How then can we lose six months in construction in one month---the problem involving the sanitary sewer line was pointed out in the Madison American prior to the passage of the school referendum---we believe that the problem of sanitary sewerage disposal should have been completed prior to the presentation of the school referendum to the voters of Madison Township---once again by deceit the Board of Education sold the residents of Our Town---"a pig in the poke"---the residents of Our Township should insist that the problem of providing proper sanitary sewerage disposal should be handled by the Madison Township Sewerage Authority and that a meeting should be arranged immediately between the Board of Education and the Sewerage Authority to work out the problem---What happens if the Borough of Matawan decides that it will not accept any additional sewerage into their system?--The Board of Education has already shown its wanton disregard of the wishes of the taxpayers---the Board of Education has squandered tax dollars with expensive taste like their new famous "weekend" at Motel on the Mount!---\$1,600 of the taxpayers money was used for this jaunt which was described by one Board of Education member as a "workshop"--We, the people would like to know just how much money is being lavishly spent by the Board of Education? cepted the Board of Education proposed budget or could have turned it over to the State Department of Board of Education or according to law the council could reduce the budget. The Council decided to cut the Board of Education budget at a special meeting, the council outlined the various areas for their reductions, the school budget was reduced by almost one million dollars.

Many of the supporters of the Board of Education budget were on hand at the Township Council Budget hearings and asked the council to cut its own local budget, the township council re-acting to the demands of the residents reduced its budget by a considerable amount which reflects in only an eight cent increase in local purpose tax for municipal purposes, most of the increase in the taxes reflects back to the Board of Education.
