## Matawan To Discontinue Sewer Service

It was reported from reliable sources that Matawan Borough will soon pass the necessary ordinances to discontinue sewer service for areas in Madison Township. Presently the Lakeridge Development located off Route 516 near the Mommouth-Middlesex County line is being serviced by Matawan Borough under an agreement drawn between the Madison Township Sewerage Authority and the Borough of Matawan.

Matawan's action came following reports that several hundred garden apartment units and homes in the \$40,000-\$50,000 bracket would be built in the Freanua area of Matawan, the proposed construction would place the Matawan Sewerage disposal system on a overload for the plant.

It is expected that the Madison Township Sewerage Authority will seek to find a solution to the problem in the very near future. What effect on the construction of the "new high school" presently under construction off Route 516 in the Browntown section of Madison Township is not known. Opponents to the Board of Education proposal which was approved by the voters in a special school election pointed out to the voters and the Board of Education that the school site selected was not in a sewer area.

The Madison Township Board of Education and the Madison Township Sewerage Authority have been at odds over proposals by the Board of Education to tie the system at the high school to the Matawan sewer line, the school which was originally planned to have been completed by September 1968 for the fall term in now several months behind schedule and many believe that the school will not be ready for occupancy before the fall term of 1969.

It was pointed out earlier this year that construction difficulties had arose in the planned construction of the school, a spokesman from the school system

stated that heavy frost had caused considerable damage to the footings and walls under construction and that they had to be replaced. Several new Board of Education members objected to the payment of bills for the school construction.

Superintendent of Schools Joseph Brust came under fire from parents as well as pupils when he decided to "split" the 1969 senior class, Brust later give in to student demands following a "wild" session at the Madison Township High School Auditorium, it was reported by several teachers attending the meeting that Brust was booed and jeered following his plans to divide the graduating class.

Other problems facing the Board of Education are "mass" resignations of teachers, many of the teachers in the school system are preparing to accept other teaching positions in other communities, according to many of the teachers leaving the system, it is not because of the present pay scale, teachers are blaming the chaotic atmosphere at the high school and place the blame on the Superintendent of Schools, Joseph Brust. It is reported that several teachers are banning together and will seek legal advice in an attempt to have the Superintendent of Schools either resign from his position or pressure the Board of Education to fire the present superintendent of schools. There is no doubt that residents of Madison Township will take the "fight" of the teachers, Brust has been under "fire" since his first appointment to the school system. Many of the teachers are opposed to the "importation" of administrators from other areas and feel that appointments should come from the ranks of the present employees of the school system. It is quite possible that prior to the closing of school that the "teachers" might call for a strike vote.

In 1955 fire destroyed several homes in the Old Bridge area after a bush fire jumped over fire lines. Former Mayor Walter Jurman declared the area a disaster area and many fire companies from neighboring communities were called to the scene.
