Following the filing for County Committeemen and County Committeewomen there appears to be a "inner party fight" in the G.O.P. It is not known at this time whether former Republican Municipal Chairman Donald Borst is seeking to make a "comeback" as chairman.

George Bush is presently serving as the Republican Chairman following the re-organization of the local Republican Party. Seeking election in the Republican Primary as a Freeholder candidate is Richard Dealy Jr., of Sayrewoods South, Dealy is presently serving as a Madison Township Councilman.

Seeking re-election as a Middlesex County Freeholder will be John A. Phillips, of Laurence Harbor. Phillips a former Mayor of Madison Township is presently serving as Freeholder and is Department Head of the County Road system.

One of the largest splits in the Republican Organization is in District One which takes in the older area of Madison Township and envelopes the Lake Ridge Development. The District One area has for many years been known as the "back bone" of the Republican organization in Madison Township.

The Democratic Party in Madison Township has for the past several been making "heavy" inroads in the voting strength of the District One area Republicans.

There had been expected a fight within the ranks of the local Democrats, however, it appears at this writing that the Democrats have more or less "mended" their fences and in all probability will back John Phillips as their only local candidate. It is expected that the Middlesex County Organization will support Hubert Humphrey as a presidential candidate, the vice president will make his announcement of his intentions on Saturday.
