SENTENCED BY COUNTY JUDGE

JAIL TERMS ARE URGED DURING YULE HOLIDAYS

If the state's chief justice has his way, every motorist caught drunk between Dec. 15 and Jan. 2 will go to jail.

Chief Justice Arthur T. Vanderbilt has urged municipal magistrates to send drunken drivers to jail and impose stiff sentences on traffic violators generally during the holiday period.

In a letter to the magistrates, Vanderbilt said the sterner penalties "will be the best Christmas present you can possibly give the people of your community."

"If every magistrate in the state lets it be known in his community, through his local paper and by announcements in his court that there will be no charity in the courts this Christmas when it comes to punishing traffic law violators, it is not too much to hope that some who would otherwise be killed may live to enjoy the new year."

Gov. Meyner has urged special emphasis be put on safe driving during the two-week holiday period. The campaign here supplements National Safe Driving Day today (Wednesday).

TOWNSHIP VOTERS DEFEAT SCHOOL QUESTION 903-313

Laurence Harbor-Madison Township school district voters Tuesday night defeated 903-313 a Board of Education proposal to build a \$700,000 26-room central school on Highway 9 in the Browntown section.

Turned down along with the construction question were board proposals to issue \$700,000 bonds, exceeding the borrowing capacity of the township by \$623,000 and to purchase a 17 acre tract in Browntown.

Four of the township's five voting districts went against the referendum with only District 1 in Browntown carrying the measure 242-106.

Voters in three districts in the Laurence Harbor-Cliffwood Beach sections were recorded more than 10-1 570-55 against the question. Old Bridge residents also turned down the question 242-106.

Thomas W. Wilson, chairman of the township Home and Property Owners Association which led the fight against the school board proposal said board president Walter Staeger had agreed to meet with association representatives in executive session to discuss new methods of obtaining additional school facilities.

The Association fought the board proposal on the grounds that two schools, located in Laurence Harbor and Old Bridge would provide a better solution to the facilities problem than would the central school in Browntown. Both factions, however are agreed that new facilities are needed to cope with overcrowded conditions and double sessions in the township schools.

MATAWAN MOTHER IS POLIO VICTIM

Mrs. Angelo Tomasello, 24, of 156 Lower Main St., Matawan, the mother of two children, was reported as the 81st infantile Paralysis patient in Monmouth County this year by Roland J. Hines, chairman of the county chapter of the National Foundation for Infantile Paralysis.

Mrs. Tomasello was taken to the polio ward of Monmouth Memorial Hospital early Friday evening when Dr. Howard Pieper, Keyport, diagnosed her illness a polio. She was reported in fair condition at the hospital.

MARLBORO VOTES TO SET UP NEW PLANNING BOARD

The Marlboro Township Committee has introduced an ordinance to set up a new planning board in compliance with a new state law.

Mayor Dennis Buckley said six members of the present board, whose powers ended officially in July, will be named to the new group while three new members will be named to increase the board's size to nine.

A public hearing on the ordinance is set for the committee's Dec. 23 meeting.

The mayor said the township hopes to set the planning board up in such fashion that it can handle both planning board matters and problems which now would come before a zoning board of adjustment. He said a legal opinion on the proposal will be obtained from Township Attorney Clifton T. Barkalow.

The new board will be a referral agency, making recommendations to the Township Committee on subdivision problems. Membership will consist of the mayor, another member of the Township Committee, a township official and six citizens.

The committee deferred action on accepting roads in the Blossom

Heights development at Wickatunk. The mayor said although the streets have been surfaced, drainage problems have not yet been solved to the committee's satisfaction.

TOWNSHIP REFUSES RELEASE FOR BUILDING FIRM

An application for release submitted by the Union Building and Construction Company of Passaic for work done in connection with the construction of the Garden State Parkway was refused by the Matawan Township Committee at its regular meeting.

Mayor John Marz, Jr., said in connection with the refusal that a report by Ernest E. Hodgson, township road supervisor, indicated two roads used by the company, Highfield and Matawan roads, have not been repaired satisfactorily.

The company had done construction work on the roads in connection with the building of the parkway. A stipulation of their contract called for the return of municipal property in the same condition as it was prior to the start of construction.

Other business saw a letter received from the State Highway Department informing the township that an appropriation of \$3,456 has

been allotted toward the installation of highway lighting in the municipality next year.

Joint insurance coverage between Matawan Township and Matawan Borough was authorized at the session. Both municipalities will cover jointly the insurance of the Freneau Volunteer Fire Department which serves both places. The cost of the insurance will be shared equally.

HOLDUP MAN GOES BERSERK IN COUNTY JAIL

An accused holdup man went berserk in the Monmouth County jail, had to be overpowered and then was taken to the Vroom Building for the criminally insane at Trenton.

Sheriff Ira E. Wolcott said Jordan A. Dillard, Perth Amboy, became so violent it took six men to restrain him. He was handcuffed, his legs manacled and then strapped to a stretcher and taken

to the hospital by the Freehold First Aid Squad.

Dillard and two other men, Fred (Buster) Williams, 22, Raritan street, Cliffwood, and James Baldwin, 17, Newark, are awaiting court action for the Aug. 20 hold-up in which Charles Slattery, Freehold gas station operator, was

beaten and robbed of about \$400. The night of the holdup, William and Baldwin were captured by Matawan police but Dillard escaped. He was arrested several weeks later.

Undersheriff Courtlandt White made the trip to Trenton with the first aid squad.

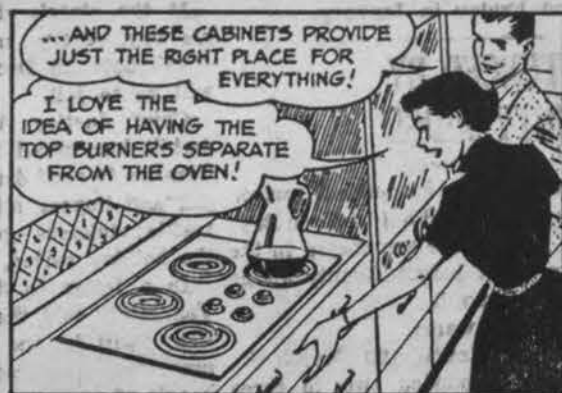

Scotch Plains red hot basketball team snowed the Red Raiders of Keyport High School under by a 97-58 score by rolling up 59 points in the second half.

The home team broke loose in a wild 31-point third period after being held almost even by the smaller Keyport five in the first half. Scotch Plains took a 23-18 lead at the end of the first period, but Keyport came right back in the second quarter to chip two points off the margin. At halftime the score was Scotch Plains 38, Keyport, 35.

In the third period, Dick Kelly and Bill Austin couldn't miss as the Group 2 Scotch Plains school scored 31 points to the Red Raiders' nine. Dave Truitt took over for the home club in the final period, rolling up most of his 14 points then to give Scotch Plains a 28-14 margin in that quarter.

POLICE CAPTURE WOMAN CHARGED WITH EMBEZZLEMENT

Mrs. Grace Lamberti, 42 of 115 Broad street, Keyport, Wednesday night was committed to the Monmouth County jail without bail on a charge of embezzlement after waiving a preliminary hearing before Magistrate Seymour R. Kleinberg.

She was charged with embezzling \$6633 from the Rollo Transit Corporation at Keyport.

Mrs. Lamberti Thursday entered

a formal plea of not guilty to the counts when arraigned before County Judge Elvin R. Simmill in county court.

Bail of \$7500 was later granted Mrs. Lamberti by Judge Simmill. Defense attorney Edward F. Juska told the court she would be able to post the bail in the form of a property bond.

Mrs. Lamberti, wanted since January 27 when the theft was discovered, was arrested Wednesday afternoon at 912 Willow avenue, Hoboken by Sgt. William Geiger of the local police, Trooper Detective Paul DeLuca of the Keyport state police barracks and

Detective Lt. Drew of Hoboken.

Arrested with her was John Wilson, 42 of the Hoboken address and 213 Carr avenue, Keansburg who was released under \$10,000 bond charged with concealing the Lamberti woman knowing she was wanted for embezzlement.

Wilson, also waiving a preliminary hearing said Mrs. Lamberti "has been a friend of the family for years," but denied he knew anything about the embezzlement.

**WALTER GEORGE
PROCEEDINGS TAKEN
"UNDER ADVISEMENT"**

Disbarment proceedings against former Union Beach Magistrate Walter George, under indictment for embezzlement of court funds were "Taken under advisement" Monday by Supreme Court.

George appeared before the court to give reasons why he should not be disbarred for the alleged embezzlement of \$1,090 in court funds earmarked for Monmouth County and for \$75 slated for Union Beach.

George is also charged in the indictment with an illegal transaction involving \$445 which he is alleged to have transferred to his private account from court funds last February, a month after he had resigned as magistrate of the Union Beach Court.

The funds allegedly embezzled were due Dec. 31, 1953.

An audit by the State Department of Municipal Governments uncovered the shortages last summer. George is reported to have returned the money last Aug. 31.

The state issued the results of its audit on Sept. 16, 1954 and the indictment against George was handed down by a Monmouth County Grand Jury on Nov. 18.

The hearing before the Supreme

Court was to be held last week. It was postponed at the request of J. Victor Carton, Monmouth County prosecutor, who told the court that after reading certain depositions sent to him by George, he was prone to believe the shortages were the result of "sloppy bookkeeping," rather than criminal intent.
