He was a man of brilliant attainments, and his prominence in politics in the stirring days of the civil war gave him a national reputation. He wrote the greater portion of his "Life of Lincoln." Colonel Lamon had been long in failing health.

Half a Million for Church Work.

BALTIMORE, May 9.—The will of Mr. J. Henry Stickney, a retired iron merchant, who died in this city on Wednesday last, has been filed for probate. After legacies to relatives, aggregating \$200,000, he gives the entire residue, amounting to more than half a million, to various Congregational churches and societies and for local improvement in Plymouth and other Massachusetts towns.

HAVANA, May 9.—The Infanta Eulalia, an aunt of the young Spanish king, and the representative of the Spanish crown at the Chicago fair, arrived here at 3 o'clock last evening from Porto Rico. She was accompanied by her husband, Prince Antonio, and suite. The party will leave for New York on Monday next.

NEW YORK, May 9.—The funeral of Mrs. Chaney M. Depey will be held at 10 o'clock tomorrow morning from St. Bartholomew's Episcopal church, of which she was a member. Immediately after the services in the church a special train will leave for the Central depot at Peekskill, where the interment will be held.

Devil's Rides from Parliament.

LONDON, May 9.—Michael Davitt, anti-Parnellite member for northeast Cork, has applied for the Chiltern Hundreds. This means the restoration of his seat in parliament. Although the bankruptcy act allows a man six months' grace after he has been declared bankrupt, Mr. Davitt prefers retiring at once.

WASHINGTON, May 9.—It was reported through the treasury department that Secretary Carlisle had said, when some of the chiefs of division whose resignation had been called for complained of the short notice, "You received notice on the 8th of last November in tones loud enough for all to have heard."

A Fair Commissioner Recently Hit.

CHICAGO, May 9.—Harry Davis Hooker, World's fair commissioner from the Argentine Republic, suffering from pneumonia, has been pronounced dead by a physician at his private apartments at St. Luke's hospital. Commissioner Hooker attended the conference of the fair, which he contracted a severe cold.

Six More Steamboat Victims.

CAIRO, Ill., May 9.—Six more of the men scalded by the bursting of the fine of the steamer Ohio have died. The victims were James Howard, William Hurlman, Fred Nell, William Henry, Eugene Woodley and Charles Jackson. The rest are resting easier and will probably recover.

CHICAGO, May 9.—This morning at 10 o'clock the tenth annual session of the national council of the Catholic Knights of America convened at Washington Hall. The dim in electricity's upward march.

The dim in electricity's upward march was reached last night, when the World's fair buildings and grounds were illuminated by the first rays of the electric light. The whiteness of the buildings was in contrast to the rays from the millions of incandescent lights in the great plan which the golden statues of the Republic and Liberty, upon which the rays from the west end of Administration Plaza poured in blinding showers, sent back a happy reflection. The Duke of Argyll and his brother were absent and no invitations were sent to the army officers stationed in Chicago, except to General Miles.
