MAYOR MALE WANTS THE LAW SUSTAINED, AND THORN'S LICENSE REVOKED.

Thorn's Bonds and Sureties Probably Forfeited Also Under the Ordinances.—**Forfeiture of one of the Sunday Drinkers.**

The ordinance published in The News, Saturday, whereby the license is suspended for a period of one month for a conviction of Sunday selling, was also surprise. It was passed only last month by a Council which, having received advice, had decided that the ordinance should be respected.

There is no alternative but to do so, inasmuch as the Judge had not done so it was claimed that the matter should go before the Council.
