# A TERRIBLE DISASTER.

Six Women Killed and Eight Injured.  
STREET CAR AND ENGINE COLLIDE.

Great Excitement—People and the...  
The Accident—Did Not Know the Signal.

KALAMAZOO, Mich., May 8.—Six women were killed and eight injured in a collision which occurred between a street car and a switch engine on the Michigan Central road here. The engine was on its way to a bridge over the tracks, and had just started to make extra speed. At the same time a street car on the West Main street line was crossing the track, and the driver, not having seen the engine, supposed that all was well and proceeded on his way.

Five Almost Instantly Killed.  
While the case was crossing the tracks the engine struck it squarely and carried it several rods before stopping. At the time there were a dozen people on the car. Of these five were almost instantly killed. They were:

Miss Gertrude Thompson, about 16 years of age.  
Mrs. M. E. Watson, wife of the former Lake Shore superintendent at this place.  
Miss George Stanley, wife of a prominent citizen.

Mrs. Alexander Haddock, wife of the professor of mathematics in the Kalamazoo College.  
Mrs. W. A. Antwerp.

Mrs. Middleton, whose home was broken; died of her wounds.

Those who saw the accident state that the engine was traveling at a speed of about 15 miles an hour, a rate not allowed in the city limits. It is not definitely known where the engine came from, but it is thought that it was not required to be at the post from 6 to 6:45 a. m. on the 7th.
