

Frank I. Donnelly, a Soldier of the U. S. A., Makes Supreme Sacrifice Somewhere in France

Somewhere in France, where gray crosses mark the last resting-place of the gallant crusaders of liberty, who shall never return; somewhere in the silent ranks of America's warrior dead; serene of face and stilled of heart, our young citizen-soldier, Frank I. Donnelly, his duty well and nobly done, lies in peace beneath the golden moss that clothes the slopes of the Blue Alsatian Mountains.

"Dear as life was to that young man, as he, in company with other loyal hearts, set out from our city to join their regiment on its way to the battle front of freedom, there were things infinitely more precious, and these things were in grave peril.

"It was for the preserving of these things that our country resolved upon war, and throughout the land the call of the Nation to its loyal sons to arise in their defense was heard. To that call Frank Donnelly answered, 'I am ready!' and clear and steady of eye, and proud of heart he stepped out on the pathway of immortality—a pathway that is for men and nations, a pathway that leads to the high altar of sacrifice superb.

"The Almighty God has placed upon the cold brows of the heroic dead the diadem of victory—'A Tribute' that in itself transcends in majestic beauty and glory, the fairest flowers of language that bloom in the poet's heart.

"Nothing that human tongue can utter, or pen can trace, can decorate with a brighter gleam, the radiance of a soul that goes forth in the service of our Lord and Master Jesus Christ.

"It is one of the pathetic tragedies of life that it was not given to the mother of our young citizen-soldier the solace of seeing her boy wearing the uniform of a defender of Faith, Liberty and Humanity, for the lustrous light of vision had faded from her beautiful eyes before that day. So let your voice of sympathy, as it reaches her ears be low and soft and sweet, and let your hand be tenderly lovingly warm in its clasp as you guide her steps, for she is the brave mother of a gallant American soldier, 'Killed in Action' 'Somewhere in France.'

"Dear Mother, when the shouting dies,
And hushed are the songs of victory;
My spirit lips from your dear eyes,
Shall brush the mists of memory."

"In Flanders' Fields, where poppies grow—
Amidst the crosses, row on row,
Your 'Littlest Boy' has won a grave
And the cross that God to your soldier gave."

Irving Dea Kyne Killed in Action

Sergeant Irving H. Dea Kyne, a member of the 309th Machine Gun Company, and a former Plainfield resident, was killed in action in France on October 31. Word to this effect came last night to his two sisters, Mrs. William Jaeger, of 740 West Fourth street, and Mrs. Charles Keiderling, Jr., of 262 East Front street.

At the time of entering the service nearly a year ago, Sergeant Dea Kyne was living with his parents, Mr. and Mrs. Elmer Dea Kyne, of Franklin Park. He was twenty-three years old and leaves beside Mrs. Jaeger and Mrs. Keiderling, one other sister, Mrs. Charles Sells, of Philadelphia, and two brothers.

During the summer of 1917, Sergeant Dea Kyne was employed by Thomas M. Muir at Camp Ram's Horn, Lake Hopatcong, as boat man. He was in charge of Mr. Muir's motor boats, "Marle M." and "Ethel H.," and will be remembered by many Plainfielders who enjoyed trips about the lake in these craft under his guidance. When in Plainfield, Sergeant Dea Kyne lived with his sister, Mrs. Jaeger.

Another Big Cut on Way At Aero Plant

Employees at the Elizabeth plant of the Standard Aero Corporation are looking forward to another big lay-off of hands tomorrow. Seven hundred were dismissed last Monday, and it is believed an equal number will be laid off tomorrow noon.

The Elizabeth plant is under Government control and it is rumored that Washington has ordered the working force cut in half. At one time there were 3,000 persons, many of them from Plainfield, employed at the shop, but the number was reduced several weeks ago to about 2,200. With Monday's lay-off and the one to come tomorrow, it is believed that only 800 to 1,000 hands will remain. Work on the \$400,000 worth of new buildings is still going on but it is believed this will be stopped in a few days.

The Plainfield plant of the corporation is not under Government control and at present not in line for a reduction of its force.

Mayor Asks For Discussion on War Chest Plan

Mayor Leighton Calkins has called for a public gathering on December 3 to discuss the plan of organizing a community method of raising and distributing funds. In connection with the call the Mayor issued the following statement this morning:

Notice is hereby given that a meeting of citizens will be held in the Council Chamber, 149 North avenue, Tuesday evening, December 3, 1918, for the purpose of considering the advisability of organizing a Community Chest as a permanent institution in Plainfield. Such an organization would undertake to raise in a single campaign each year all funds required in aid of local philanthropies dependent on public subscription. This meeting supersedes the one which was to have been held to consider the War Chest plan, postponed because of the epidemic and now indefinitely deferred in view of the United War Work campaign and the termination of the war, which undoubtedly will result in modified programs for war relief work of all kinds. A War Chest would have included war relief and local charitable activities. The Community Chest will be limited to the latter.

Our local charities require immediate relief. Either they must at once conduct separate campaigns, drives, and tag-days as heretofore or unite in a Community Chest, on the budget system, the organization of which is now being urged.

In a matter of such importance, a public hearing is the best means of obtaining a thorough exchange of views, and a necessary means of giving full opportunity for those who oppose the proposition to make their objections known in advance. I urge upon them the duty of doing so, as it is imperative that a definite policy be adopted, one which will have the whole-hearted support of the community.

Unless there is substantial opposition to the proposition to justify further consideration of the matter, a committee will be named to undertake immediately the organization of a Community Chest. The several philanthropies and charitable institutions of the city are requested to accept this public notice as a request to be represented by delegates authorized to speak for their organizations either in support of or in opposition to the plan. Without their approval and participation the chief object of a Community Chest, which is the elimination of separate appeals for funds, would fail of accomplishment.

To give vent to their feelings, they organized a peace celebration that took Jacksonville by storm and continued for nearly three days.

Sergeant Lee has now been in the service about ten months. He was first stationed at Camp Dix, but was transferred from there to Camp Johnston early in October. His promotion from corporal to sergeant came at the same time and later he was selected to attend the Officers' Training School for commission in the quartermasters' department. He was hard at his studies, in addition to performing his regular duties, when the welcome message came from overseas that Germany had surrendered.

Sergeant Lee adds in his letter that he thoroughly enjoys his military life and if Uncle Sam cares to keep him down South he will be perfectly contented. He is in the best of health and asks to be remembered to all his friends. Sergeant Lee is twenty-two years old and previous to entering the service was employed as a carpenter.

Red Cross Shop Clears \$1,400 on Opening Day

Big Salesroom in Babcock Building Thronged for Hours and Success of Enterprise Is Assured — Entertainment Tomorrow Afternoon and "Get Together" of Workers Next Tuesday Night

More than \$1,400 was cleared yesterday on the first day of the Red Cross shop in the Babcock building special feature. Mrs. Charles will be in charge and Senator William N. Runyon will preside at the piano. A field chapter with Mrs. J. M. Charles as chairman.

Freed of Criminal Charge But Must Answer Civil Suit

Although a jury in the Union County Court on Tuesday decided that Fritz Nowack, of 624 East Sixth street, this city, was innocent of a charge of involuntary manslaughter, brought against him by Prosecutor Walter L. Hetfield, for the accidental killing of fifteen-year-old Victor Brancatti, at South avenue and Terrell road on August 18 last, the defendant has been served with papers in a \$2,000 civil suit for damages. The proceedings have been brought by the boy's father, Earl Brancatti, of Terrell road, and will be heard at the January term of court. Robert Newton Crane will represent the plaintiff and Vincent W. Nash, Jr., the defendant.

Nowack was driving his automobile west on South avenue on the day of the accident and encountered a group of boys walking in the roadway near Terrell road. One of them was Victor Brancatti, and according to the defendant's testimony Tuesday, the youth stepped further toward the center of the street after a warning signal had been given twice. The tender of the car struck him, causing injuries from which he died in Mulenberg Hospital last.

In the car with Mr. Nowack were his wife and two children. They substantiated the defendant's claim that he was not proceeding about seven miles an hour and that after the victim was hit the machine was stopped within ten feet. Helen Miller, a sixteen-year-old girl employed in an ice cream parlor on South avenue, also testified that the Nowack car was moving slowly, that the Klaxon had been sounded twice and that the group of boys had been skidding in the road just previous to the accident.

Attorney V. W. Nash, Jr., who defended Mr. Nowack, had covered every detail in preparing his case to clear his client and he presented the facts in a masterly manner. Prosecutor Hetfield's main contention was that Nowack had been driving his car at an excessive rate of speed and he produced several Italian residents of Terrell road who asserted that this was so. When it came to a question, however, as to just what the speed of the Nowack car was at the time of the accident, the witnesses were unable to give any satisfactory reason as to why they had said the machine was overstepping the limits. None of them qualified as experts on rates of speed and no two held to the same opinion as to the rate when cross-examined by Mr. Nash. Frank J. Hubbard, of this city, was produced by the State to show maps and give a technical description of the roadway where the accident took place.

The case went to the jury at 3:15 in the afternoon after an all-day trial and the verdict of "not guilty" was returned within half an hour. Attorney Nash was warmly congratulated by Prosecutor Hetfield and numerous lawyers who had witnessed the proceedings for the complete defense he had set up for what appeared to be a sure conviction. Mr. Nowack, the defendant, is employed at the Scott Press Works as a toolmaker.

No Further Details Regarding Death of Private Lundstrom

Telegrams sent to Washington by Bror H. Lundstrom, of 623 East Seventh street, have failed to produce any further information regarding the death of his son, Private Carl A. Lundstrom, officially reported in General Pershing's casualty list as having been killed in France on September 28. Only the formal announcement was contained in the message as received by the father on Monday, but the promise was made that any additional word that could be secured would be sent on.

Private Lundstrom was born in Sweden and his death came on his twenty-third birthday. He was brought to America by his father after his mother's death and had lived in Plainfield practically all his life. After completing his course at school, he was employed in various ways about the city until early last year, when he secured an excellent position at the local plant of the Standard Aero Company. He was holding this in September, 1917, when called into service through the selective draft. After remaining at Camp Dix all last winter, Private Lundstrom went overseas in May as a member of Company A, 311th Infantry. It was this unit that saw active service at St. Mihiel, Grand Pre and Sedan, and his sacrifice for his country's honor is believed to have been made in the St. Mihiel drive. At Dix, he showed himself to be a soldier in every sense of the word and those who knew him are certain that he died like a true hero.

Private Lundstrom's associates all live or did live in the vicinity of South avenue and Berckman street. In that neighborhood and the one nearer his home, he is spoken of in the highest of terms. As one friend expressed it, "He had the faculty of minding his own business" and if he had been permitted to live he would have proved a credit to himself and his people. The blow comes all the harder to Mr. Lundstrom from the fact that the soldier-hero was his only son. The lad was also the pride of his stepmother, who had been entrusted with his rearing from the time that he was a child, and to her the sympathy of the community has been extended.

Stebbins' Sale Brings \$20,000 For Muhlenberg

The Albert C. Stebbins property at 335 West Seventh street, bequeathed by Mr. Stebbins to Muhlenberg Hospital, was sold during the past week netting a total of about \$20,000 for the institution. The property consists of a fine modern house and spacious grounds and the sale included the magnificent furnishings of the residence. These comprised imported rugs, bed-room suits, parlor and dining room furniture, bric-a-brac and tapestries. They were disposed of at a private sale lasting three days and under the supervision of a committee from the Women's Auxiliary of Muhlenberg Hospital, of which Mrs. J. P. Stevens, of Hillside avenue, was chairman.

The house and grounds were purchased by William H. Armstrong, of Carlton avenue, through the agency of J. T. Vall. It is understood that the consideration was about \$11,000. Mr. Armstrong will occupy the premises himself.

By the will of Mr. Stebbins, who was for many years the president and general manager of the Pond Machine Tool Company, Muhlenberg Hospital received previously in all about \$100,000. A portion of this amount was in cash and the remainder in property or ill-edged securities. The Board of Governors placed about \$80,000 of the bequest in Liberty Bonds, believing this would be the best method of securing a net annual income.

LOCAL NEWS IN BRIEF

Happenings of the Past Week Tersely Told For Busy Readers.

The Ford Machine Tool Company, which has entered suit in the Supreme Court to recover \$52,348.92 from Neiderösterliche Ka- comoto-Gesellschaft, a corporation of Austria-Hungary. The concern alleges that it sold a gun turning lathe to Donauwerk Ernst Krause and Company in 1913 and the bank was to make payment, but after accepting liability failed to do so. A. Mitchell Palmer, United States Custodian of Alien Funds, and John Burke, United States Treasurer of Custodian Funds, have been made co-defendants in the suit as they have one million dollars belonging to the banking corporation, this amount having been derived from the sale of property which it owned in the United States.

Lieutenant Nathaniel R. Hort, of Westfield, who was a member of old Company K for many years, and employed in Plainfield for a long time, is reported from Washington to have been killed in action in France on October 26. He was attached to the 318th Infantry. Lieutenant Hort was thirty-eight years old. At one time he worked at the Plainfield postoffice and shortly before going into the service was connected with Herr's Business College. He is survived by his father, a sister and a brother, all living at Oswego, N. Y.

Articles of incorporation were filed at the office of the County Clerk this week by the Jersey Sales Corporation of this city. The incorporators named are: William R. Codington, who is specified as the agent of record; Colin Dascombe and Albert J. Codington. The capital stock is placed at \$100,000, divided into 1,000 shares of \$100 each. William R. Codington holds on share, Mr. Dascombe, four shares, and Albert Codington, six shares, all paid in. The company's office will be located at 152 Park avenue.

Adjutant General Gilkyson this week notified all draft boards in the State to discontinue physical examinations of men in the new draft. However, they were instructed to continue classifying men from 19 to 36 years and also the 18-year-old group.

Rev. D. W. Skellenger, who is thoroughly familiar with the Wyoming valley and other coal regions in Pennsylvania, will give an illustrated lecture on "A Tour Through the Anthracite Region" at Hope chapel on Tuesday night, December 3. The pictures to be used were all taken by Mr. Skellenger himself and are considered exceptionally fine. The proceeds from the affair will be added to the Boys' Club pledge for the new Hope chapel building fund.

The street department has just completed an excellent job in putting Monroe avenue between Fourth and Seventh streets in excellent shape. The macadam has been re-surfaced and given a coat of tar, much to the satisfaction of the residents and persons using the vehicle. Thomas Day, engineer of the steam roller belonging to the city, is given much credit for the satisfactory completion of the work.

Alfred Luery, an accountant, living at 809 Clinton avenue, and his sister-in-law, Miss Jane Marsh, of the same address, were badly shaken up Sunday afternoon and also had a narrow escape from serious injury when an automobile in which they were riding was struck by an Arlington avenue trolley car at Seventh street and Arlington avenue. The automobile was hurled twenty feet away and would have turned over but for striking a tree. The machine was badly damaged but the occupants were practically unhurt after the first shock was over. George Lathia was motorman of the trolley and John Matthews conductor. Both claim Mr. Luery was to blame for the accident but Mr. Luery entertains a different opinion.

Boarding house robberies of the sneak-thief variety have been quite frequent in town of late and when Francisco Ries was arraigned in the city court, Monday morning, on a charge of appropriating numerous articles belonging to fellow boarders at 208 Watchung avenue, Judge DeMeza decided to make an example of the prisoner. He was accordingly

given his choice of paying the fifty-dollar fine or spending ninety days in jail. After sojourning at the Sycamore street "cooler" until Tuesday, Ries finally secured the necessary money to get him out of (durance vile. Another boarding house robbery was reported to the police this week by Miss Lamarah Adams, of 255 East Second street, who stated that a roomer who had only been at her place two days, had suddenly disappeared but before he went he looked over the effects of the other roomers and took whatever looked good to him. One of the articles stolen was a \$40 overcoat, and the police are trying hard to get it back for the owner who might otherwise put in a rather cold winter.

Luther S. Ayer, superintendent of the International Motor plant at Clinton avenue and West Front street, won the victory medal offered by John D. Rockefeller in the Red Cross tournament conducted at the Plainfield Country Club, Saturday, October 26. The affair netted about \$200 for the Plainfield North Plainfield chapter of the Red Cross.

Mrs. Frank J. Hubbard, of West Fifth street, was recently elected president of the Alumnae Association of the Plainfield Seminary.

Indications point to a large attendance at the barn dance to be given by Plainfield Lodge of Elks in the Watchung avenue clubhouse next Thursday night. Professor Wetton's orchestra will furnish music and appropriate Thanksgiving decorations will be in evidence. The committee, of which Frank Emmons is chairman, asks that only rural costume be worn by the young men and women responding to the invitations.

In awarding financial aid under the Widows' Pension Act, Judge Carlton B. Pierce recently inaugurated a new policy of first having the merits of the case before he takes action. Other changes that he has adopted in the giving of monthly allowances are expected to result in the saving of a large sum annually to the county. After a pension has once been granted it is no longer allowed to run for an indefinite period. Each case is brought up for consideration from time to time, and if it is found that and is no longer needed the remittances are discontinued. Among the new applications recently granted by Judge Pierce was one of \$30 a month to Catherine Pierson, of Plainfield, who has four small children. Dix to Muster Out 7,000 Soon

About 7,000 men will be affected at Dix when the orders for the demobilization of the development battalions in the various parts of the country go into effect. So far the Dix officers have received only instructions as to the manner in which the men are to be mustered out and everything is in readiness to begin when the word is received to start the weeding-out process. One of the Dix development battalions, numbering several thousand men, was sent South only a few weeks ago and the men in that organization will be mustered out at their present location.

The work of demobilization will naturally be slow until the kinks are smoothed out, but once the plan is in full working order the men will be discharged very quickly. In the meantime, work is going on as usual and the camp is being put in the best possible shape so that, if needed, it can be used by troops returning from abroad.

The order from Secretary Baker expressing the appreciation of the War Department for the patriotic zeal and service shown by the officers and men was read at retreat to the men of the Depot Brigade to whom the order is expressly directed as it was not their privilege to participate in the historic struggle in France, yet they are none the less a part of the army and entitled to the thanks of the Nation for their readiness to serve.

Official word that no new classes would be started at the Central Officers' Training Schools has been received from the War Department and caused great disappointment to the candidates for quartermaster and artillery commissions, who were ready to start when the telegram came holding up all transfers until the future policy of the War Department is decided upon. The telegram follows:

"If you have not already sent to Officers' Training Schools men reported eligible in your last report and who have been called for by school commanders, you will disregard instructions to send them to schools, as orders have been issued that no more candidates be admitted to officers' training schools."

Camp Dix has a series of chain stores which bids fair to rival systems of a similar nature in cities as a profitable investment. Under the management of Captain L. P. Sineath, of New York city, the stores have done such a business that approximately \$500,000 in profits have been declared during the year the stores have been in existence. Captain Sineath was formerly connected with the United Clear Stores Company.

When the camp was opened and the Seventy-eighth Division was in process of formation each regiment had its own exchange, with a regimental officer as the exchange officer and the colonel as supervisor. The profits went back to the company funds and were used at the discretion of the company commanders.

Then when the camp became an auxiliary to the embarkation port and units moved in and out very quickly, this plan was not found feasible, and the present system was devised. The buying for all the seven exchanges now in operation is done by one man, the exchange officer, and the business is conducted

the same as any big concern. An Exchange Council, appointed by Major-General Hugh L. Scott, the camp commander, acts the same as a board of directors in a big concern and has direction over the whole business, acting through the exchange officer. The business is run on a co-operative basis. That is, the men who do the buying also share in the profits. Once a month the council goes over accounts, and if it deems business satisfactory declares a dividend, and this is divided among the companies in the Depot Brigade and may be used to buy such equipment for recreation purposes or little luxuries, as the captain may decide.

Everything needed by a soldier is carried in stock and at times the goods, held at the warehouses, have amounted to as high as \$300,000. The monthly business averages about \$250,000 and in all the exchanges and also at exchange headquarters there have been placed competent men who have had experience in the business world before they accepted service with Uncle Sam.

One job that is going begging at Camp Dix is that of orderly at the officers' quarters where the duties include the care of steam boilers. Particularly is this so among the men of the Sixty-third Pioneers, for nearly all the orderlies offered to quit after an explosion the other day that nearly caused the death of one of their number.

How the accident happened may never be known, for the negro orderly was not found until hours afterward and he was then too frightened to explain. The general opinion is that he failed to watch the steam gauge and the result was that shortly after he had left the small boiler room of the quarters the boiler blew up with report that was heard all around. The boiler was destroyed, as was the small room, the entire top being blown skyward.

The following promotions have been announced in the quartermaster corps detachment: To be sergeants, Edward L. Dilatash, of Freehold; Samuel Leopold, of Newark; and Alfred Zimmer, of Paterson; to be corporals, Robert A. Young, Jr., of Orange; Joseph F. Gilmore and Percy B. Minnasian, of Jersey City.

Leniency has been exercised by Major-General Hugh L. Scott, camp commander, in the cases of two soldiers sentenced to long prison terms. Both were charged with desertion and sentenced to thirty years at the disciplinary barracks at Fort Jay, Governor's Island. In the case of Private Samuel T. Kilmon, of Wilmington, Del., the penalty was reduced to fifteen years, while Private Charles Steininger, of Buffalo, escaped with five years, as General Scott decided that he should only be charged with being absent without leave.

Week-end passes were granted last Saturday to eleven per cent. of the officers and enlisted personnel of each command in all cases where train service was necessary in reaching and returning from destination.

First Lieutenant Stanley Palmar, of Belmar, has been assigned to Camp Dental Infirmary No. 2.

Although a truce has been signed and peace is in sight there is every indication that Dix will be maintained for many months to come, and Major-General Hugh L. Scott, camp commander, is continuing plans for beautifying the camp grounds. Frank Wandle, director of Knights of Columbus activities, is chairman of a committee that will plant flowers, and he has received from the National Fruit, Plant and Flower Guild ten boxes of bulbs which will be set out along the Wrightstown-Lewistown road, between the fire house and K. of C. building No. 4.

Dix soldiers are in demand for peace demonstrations in various towns throughout the State, and each day requests are received for soldiers and bands, particularly the latter, whose services are generally desired by Red Cross and other War Work committees.

CO-OPERATION AND THE RED CROSS SHOP.

A brief visit to the newly opened Red Cross Shop, in the Babcock building yesterday, was sufficient to convince the most skeptical that it is already an unqualified success. From early in the morning until last night the big display room was thronged with eager buyers who gladly purchased of the wares because they knew every dollar of profit was just that much more for the boys in the army and navy. The noble women of Plainfield who assumed the task of starting the store were there to direct and the splendid corps of saleswomen extended uniform courtesy to all who sought their wares. It is probable that the shop will be crowded on other days and as long as it is continued it will make money for the organization that is doing such wonderful work in war stricken Europe.

It was a tremendous task, this undertaking. When Plainfield's warm-hearted women first began it, obstacles were met that threatened failure. Mrs. J. M. Charles, the chairman of the committee, is not easily daunted but at critical junctures it seemed as if she would have to put aside her cherished ideas. It was at one of these times that William Langer, business agent for the Plainfield Trades' Council, offered the services of himself and the mechanics of Plainfield. From then on there was no doubt as to the ultimate establishment of the Red Cross shop and a big boost in finances for the local chapter.

Mrs. Charles is entitled to all the credit that can be given for what has resulted but she generously puts herself to one side in favor of the mechanics who transformed the old postoffice quarters into the splendid salesroom that they are. They came from every trade, carpenters, plumbers, painters, electricians and masons. The contractors, the employers of the men, hurried up their own work that the mechanics might put in a few hours each night and Sunday at the Red Cross shop and also gave freely of material. They helped in no small measure to make the venture successful, and Mrs. Charles is anxious that they should know.

In numbers, the persons who helped make the shop what it is today, runs into the many hundreds. It has been a co-operation of willing hands, a unanimity of purpose that asks no other reward than that it will benefit the boys who are resting in France after the terrible ordeal just past. Mrs. Charles, Mr. Langer, the mechanics of Plainfield, the men and women of Plainfield, the shop committee and everyone else are entitled to credit and the boys who will be aided later on will see that they get it.

PLAINFIELD ONCE AGAIN GOES "OVER THE TOP."

Once again Plainfield has given of its means and given nobly. It was asked to contribute \$150,000 to the War Work campaign fund and responded to the extent of several thousands more. It only shows that this community is alive to the needs of stricken Europe and our men in the field who must be kept clean in mind and body while they are waiting for transportation back home. Every dollar will be put to good use and that is all that Plainfield asks when making its splendid donation.

The War Work campaign committee, of which J. Herbert Case was executive chairman, is deserving of commendation for the manner in which it planned the collection of the large sum of money. Every person in the city, the borough and suburbs was given a chance to help out and the individual number of subscribers runs into the thousands. The idea of collecting for seven War Work organizations at one time, as suggested by President Wilson,

worked out splendidly. Plainfield went "over the top" once again and stands ready to help out at any time in the future.

MUSTERING OUT THE PRETTY NEARLY WUZZERS.

Well, anyway, "Bill" Hohenzollern didn't have to slam the door when he went out.

While Clerk Freeman and the Exemption Board are closing up shop, it might discharge with a vote of thanks the selectives who almost broke into Camp Dix last Friday. It might ease off their disappointment and make them eligible for Constable George York's Army and Navy Union.

We intend giving thanks all right but for the nonce we have placed it in cold storage pending the arrival of some generous guy with a turkey. At fifty cents a pound, we don't believe in buying anything that might rob the boys "over there" of a little joy stuff next Thursday.

We have an anonymous letter saying, "I can produce a turkey feast on Thanksgiving if you will produce a genuine mince pie with the requisite amount of devilment in it." Of course, we are powerless to produce the kind of mince pie he requires but suppose we could, who is this fellow and where his old turkey?

We don't have to hark back to the days of Admiral Dewey and his gift house to be reminded that the American public is fickle. Up to November 11, when a troop train shot over Plainfield's thirteen bridges it was "Hooray, Hooray, Yip, Yip, Yip, Wow, Whop-ee" from the spectators. Now when one crosses along, the Plainfielders take a half glance at the earloads of boys who left homes and everything to do their bit and remark "wonder where those guys think they're goin'."

The first peace celebration was on November 7. The second one came on November 11. When you stop to consider that "seven or eleven" is the luckiest combination for any American taking a chance is it any wonder that the peace jubilee was a grand success? Carrying the gambling simile a little further, it comes to mind that the big poker game in Europe ended with five kings in the discard and every Yankee boy wearing a "royal flush" of excitement over the failure of William Hohenzollern to help his hand when he coaxed the United States to "Decorate the Mahogany."

We ended the war work drive with a few odd thousands over the quota but there will be other campaigns to tackle yet before peace settles down for keeps. And in addition the war's wakened up Plainfield so thoroughly that we'll have big projects of a civic nature which'll call for campaigning in after-the-war-days.

Collier says that human nature is more or less incomprehensible because people will pay generously to hear music that will make them weep. It costs something to drain our own tear tanks, but we can take a nickel and start an automatic graphophone that will agitate the lachrymals of the angels.

It was on the eleventh page of last Saturday's Curious-Snooze and it stared up at us from below a syndicate cut of a ruined chateau. We rubbed our eyes and cautiously peered at it again, thinking that perhaps we had made a mistake the first time and accidentally gotten into the 1893 editor's territory but no, there it was again in all its Rip Van Winkle serenity. There was nothing else for us to do but cull these few paragraphic gems and here they are: "Germany can be defeated and must be defeated, if American puts all its available strength into the struggle. The battle will be fought in France, but some of the work of preparation must be done here."

"Everybody can have at least a little share in the effort, for everybody can buy a bond in the Third Liberty Loan which will aid the American army in the task of making the world safe from the rage of the Kaiser and his sons."

"It might have gone on and ruffled the consciences of some of the slackers who ducked the Third Liberty Loan last April but the 'Printer's devil' or some other eagle-eyed employe smelled the mustiness of the article and notified his superiors. Thereupon the picture of the ruined chateau and the appeal for the loan that ended last April gave way to a page of fiction entitled, 'Harrington Gale, Lawyer Detective.' Thus was another chance lost to stir up the patriotic enthusiasm in the city's rhubarbs.

Splendid Work of Plainfield-North Plainfield Red Cross Chapter Shown in Reports at Yearly Meeting

A gathering which filled the Plainfield High School auditorium to its capacity listened to the addresses and reports at the annual meeting of the Plainfield-North Plainfield chapter of the Red Cross, Wednesday night.

It was intended that Lieutenant Colonel Charles Whittlesey, of North Adams, Mass., hero of the fight in the Argonne forest when his little band held out against a superior force for four days without food or water, should be the speaker of the evening, but at the last moment he wired that he was unable to attend. President Charles W. McCutchen presided and after briefly summing up the chapter's work since its organization, a little more than a year ago, introduced Albert W. Staub, assistant chairman of the Atlantic division of the Red Cross. After he had spoken on the importance of keeping up the present Red Cross activities, Lieutenant James Ackerman, of this city, recounted some of his half-breath adventures on the French front during which he told of the fight high in the air when he received wounds that caused him to be believed home. Other speakers were Arthur M. Harris, who was in France as a Y. M. C. A. worker, and Dr. Charles A. Eaton.

In the course of regular business an executive committee of fifty was elected. Mayor Leighton Calkins, Senator William N. Runyon and Mayor William L. Small were named as a nominating committee to select five officers and six others from the executive committee to act as an administrative committee. The executive committee will meet four times each year and in the interim the administrative committee will have full power. The executive committee is as follows:

The report of the chapter's work since its organization was distributed in printed form and was as follows: The greatest undertaking in the world service of humanity that the world has ever known is embraced in the activities of the American Red Cross. Its work of relief is as broad as the sum of human suffering and distress the world over; and for the performance of this world-wide accomplishment, the Red Cross plan of organization poses responsibility upon the individual woman everywhere, in the biggest cities—and in the most remote villages. The measurement of Red Cross achievement, therefore, is not complete in the camps, on the battle-field, in the hospitals and on the sea. The history of this greatest undertaking in human service begins where all Red Cross work begins—at the work rooms of Red Cross chapters, in the home communities of America.

The ultimate accomplishment of Red Cross service is dependent first of all upon the willingness with which thousands of women have accepted individual responsibility of a service devoid of glory, romance or adventure. Individual devotion to a duty by no means spectacular has resulted in the building of an organization, the achievements of which will endure as long as the pages of history. To acknowledge these achievements will be the task of those who chronicle the events of the World War.

Here we must record merely the labor of those who, through the Plainfield and North Plainfield Chapter have served the American Red Cross. The system by which a miraculous collective power is attained, through the concentrated energy of countless individual units, may be appreciated by the scope of the work of this chapter. The committees, which beside the work of organization, administration, publicity and office detail, constitute the program of the Plainfield and North Plainfield Chapter are: Sewing and cutting committees, surgical dressings, wool canteen, and educational committees; Junior Red Cross, civilian, Belgian, Armenian and Syrian relief committees.

In these various branches hundreds of Plainfield women have worked with tireless energy. Moreover, the city at large has, in two successful campaigns, demonstrated its generous support of the chapter. The membership campaign produced an enrollment of 11,000, 5,000 more than Plainfield's allotment. Again, in the second Red Cross War Fund, when the quota set was \$70,000, the response from our citizens resulted in a figure nearly double—\$123,643. Without such support from the community, the efforts of those in charge of the actual work would have been fruitless, and the first year's record would have been far from the creditable showing which it now claims.

Steady and substantial growth has marked the progress of the Plainfield and North Plainfield Chapter since its formal organization on June 20, 1917. On the ninth of the following month, Chapter Headquarters was opened for work on surgical dressings, sewing and knitting. Since that time the chapter has grown to include twenty-one auxiliaries and one branch transferred from another chapter. The development in the work of the extension committee, started in September under Mrs. E. Yard Breese, and later under Mrs. H. E. Butler, the first auxiliary of the chapter was organized in September at New Market. Later the demands of convenience, and growing interest throughout the community occasioned the necessity of other auxiliaries and they were established in the following order:

1. New Market; 2. South Plainfield; 3. Watchung; 4. North Plainfield; 5. St. Mary's; 6. West End; 7. Washington Park; 8. East End; 9. Fanwood; 10. Scotch Plains; 11. Booker T. Washington; 12. Central; 13. Local Daughters; 14. St. John; 15. West Front Street; 16. Benevolent Circle; 17. Washington Parent-Teachers; 18. Belvidere; 19. Hope Chapel; 20. New Dover; 21. Jewish, and Danellen Branch.

An interesting indication of growth is found in comparative figures. In the first three weeks after the work rooms were opened, 1,232 people worked in the sewing and surgical dressings departments, making 360 garments and hospital supplies, and 8,323 dressings. In June, 1918, the records show an increase in number of workers of four hundred per cent, with an output of 1,916 garments, and 225,701 surgical dressings.

The local chapter receives its allotments for garments, surgical dressings, knitted articles, etc., from the Divisional Headquarters in New York, and the purchasing and supply committee, of which Mrs. Charles G. B. Banks is chairman, purchases the materials necessary to fill these requisitions. The work is then prepared, assembled and apportioned out to the various work rooms in the auxiliaries to be returned when finished to Chapter Headquarters for inspection, packing and shipping.

Sewing and Cutting. These two committees are closely allied, and really are a part of each other. Until recently, when it has been possible to purchase cut garments at the Red Cross Supply Service in New York, all garments to be made in the work rooms have been cut and assembled by the cutting committee, of which Mrs. A. L. O'Brien is chairman. The cutting rooms are equipped with long tables, and practically all the work is done with an electric cutter.

In the sewing rooms, with Mrs. F. W. Yates as supervisor, the work has been varied, hospital shirts, pajamas, sheets and pillow cases are among the articles made for use in our hospitals, as well as those abroad. One line of work, for which there is an ever-increasing demand, is the refugee garments, to be sent abroad to the unfortunate population in the actual war-zone. The comfort bags, with which every draftee or enlisted man, when known, has been supplied before leaving Plainfield, are also made in the sewing rooms.

Surgical Dressings. When the chapter was organized, Mrs. Howard McWilliams was appointed supervisor of surgical dressings, and later was succeeded by Miss Edna Brown. During the year, 1,333,202 dressings were made by 36,822 workers. The requisitions have included all kinds of dressings, those intended for front-line, evacuation and base hospitals. The cutting of the gauze for these dressings has been done by a committee of which Mrs. W. L. Righter was chairman. Under the direction of this department classes were formed for instruction in the preparation of surgical dressings, which were attended by 137 women, 47 of whom took the course in special dressings, which qualified them to become instructors or assistants in work rooms.

Wool. The work done by this committee under the direction of Mrs. J. B. Patton at first, and later cared for by Mrs. Raymond Everest and Seymour Barr, has been very successful, and the 14,893 articles, sweaters, mufflers, socks, helmets, etc., are an indication of the army of women who have been busy knitting during the twelve months. While all the drafted and enlisted men have been furnished with these warm, woolen comforts before leaving Plainfield, the major share of the output has been sent to the Divisional Headquarters to be shipped to camps and cantonments in this country and abroad.

Canteen. Owing to the fact that Plainfield is not a junction or point of departure for troops, there has been no opportunity for the canteen committee to do the work which is naturally cared for by such a committee. Under Miss Jessie Munger, followed by Mrs. E. T. Barrows, this committee took charge of the filling of 1,500 Christmas packets, and later they filled the comfort bags. They have also co-operated with the citizens' committee in furnishing and serving farewell suppers for the drafted and enlisted men prior to their departure from town.

Educational. This committee, of which Mrs. C. B. Tyler is chairman, has had charge of the organization of classes for the purpose of teaching the subjects particularly recommended at this time by the American Red Cross. There have been seven First Aid classes with 120 students, the same number in Elementary Hygiene and Home Care of the Sick, with 108 students, one class in Home Service and one in Dietetics.

Civilian Relief. The work of the civilian relief committee commenced in January, 1918, under the direction of William M. Wherry. At that time there were seven families in the care of the Home Service Section under the chairmanship of Mrs. Laurens H. Van Buren, and most of the assistance was with respect to allotments and allowances. The report for July 1st shows the number of families under care increased to 69, of which 21 were added during the single month. Nine cases were closed and the scope of the work has increased so that it requires twenty-four headings to properly state it and it ranges from assistance in respect to budgets for families, to reports to the Adjutant-General, and includes legal and medical help.

Belgian Relief. This committee, which has had a particularly active year, is under the able leadership of Mrs. Frederick W. Wallace. Nine thousand garments have been collected, packed and shipped (and 38,160 cans of milk, and 5,019 cans of cocoa have been sent to Belgium and France. In addition, \$475.00 has been given to aid the children of East Hainault. In March a campaign for the collection of second hand clothing for the refugees of France and Belgium was cared for by this committee. Six tons of clothing were collected and packed for shipment.

Armenian and Syrian. The interests of the Armenian and Syrian relief committee have been cared for by a committee of which Howard H. Williams is chairman. Through their efforts the sum of \$5,914.60 has been raised to carry on their work.

Junior Aed Cross. Under the direction of Miss Emelyn B. Hartridge most excellent work has been done by the Junior Red Cross. Plainfield has the distinction of being a pioneer in this branch of Red Cross endeavor, being one of the first to recognize the latent possibilities of great achievement among the school children. There are thirty-six city and rural schools enrolled, including 7,074 pupils. The money raised by the Juniors is \$10,392.11. The pupils have made 2,899 knitted garments, 808 refugee garments, 102 afghans, 4,743 wash cloths, 140,545 surgical dressings, 799 pillowcases, 325 Christmas bags, comfort-kits, scrap books, picture puzzles, Red Cross booklets, bulletins and boxes and Y. M. C. A. tables. Out of their funds the schools have made gifts of money amounting to \$2,525.07, including \$1,216.24 to the second war fund. They have given 2,325 books and magazines to the soldiers and toys, candy and fruit to the hospitals. The children of 18 schools sold Liberty Bonds amounting to \$149,200, and Thrift Stamps and War Savings Certificates to the value of \$23,294.06.

Publicity. Mrs. E. Yard Breese was the original chairman of this committee, and after her resignation the work was carried on by Mrs. Sherman B. Joost. It has been the aim of the committee to keep the work of the Red Cross in all its many branches as much as possible before the public, and the newspaper articles dealing with the achievements of the local chapter as well as the American Red Cross in general have appeared regularly in the local press. Appeals for assistance have been made from time to time, always with a generous response no matter what the nature of the call, and the committee feels that whatever success has attended their efforts has been largely due to the unflinching courtesy and co-operation of the Plainfield newspapers, who have given lavishly of their space to further the work of the Home Chapter.

and Drum Corps, he was a Fourth Degree member of Watchung Council, Knights of Columbus, and the Drop Forge Local, formed of Spicer plant employees. In each organization he was a great favorite and the T. A. B.'s will not be the only ones to miss his fellowship and activities. Everywhere in town it was the same with "Bus" Donnelly. Everybody liked him, everybody was pleased with his persistence in seeking entrance to the army and everybody was pleased at the progress he had made as a soldier up to the immediate time of his supreme sacrifice. Before being called to the colors as a selective, he had sought enlistment three different times but on each occasion was rejected because of his height. It was a very small trifle below the military requirement, a fact that was overlooked by the national army physicians, much to the satisfaction of the young hero.

After reaching France, "Bus" never forgot the anxious parents and other relatives at home when he had the chance to write. Although the 113th was on the march from the time it landed at a French port until it reached the front line trenches, letters came from the young corporal at regular intervals. One of these reached his mother on October 14, just three days before his death took place. In it he stated that he had been "Over the Top" three times but had escaped without a scratch, although comrades all about him were never to charge again. He expressed the belief that the prayers of his mother, his father, sister and brother had brought him back unscathed. From inferences it is believed that he alluded to action at St. Mihiel and Grand Pre and the idea prevails that his end came as he was taking part in the big drive at Sedan.

In other letters Corporal Donnelly mentioned that his special bunkie all the way from Camp Dix was Corporal Thomas Heron, of West Fifth street, this city. He referred to the latter on numerous occasions. There is a possibility that the "bunkie" was near at hand when Corporal Donnelly succumbed to a Hun missile. If so, the full details of his death may be secured when the other young Plainfielder returns home.

Beside his parents, Corporal Donnelly is survived by one sister, Miss Mary Donnelly, cashier at the local office of the American Express Company, and one brother, Private John Donnelly, Jr., now in France as a locomotive engineer. The latter was employed on the New Jersey Central as fireman and apprentice engineer when he was called into service. Mr. Donnelly, the father, was for more than twenty-five years employed by H. U. Runkle, of West Eighth street, but for several months past has held a position as night guard at the Pond Tool Works.

More Deaths Due to Influenza Than Resulted From War

Approximately 78,000 deaths were caused by the influenza epidemic in forty-six principal cities of the United States in the period from September 8 to November 9, according to an estimate announced by the Bureau of Public Health. The announcement says the deaths resulting from the epidemic greatly outnumbered the deaths among American troops abroad, while the deaths caused by influenza and pneumonia in the camps and cantonments in this country were nearly equal to the number of Americans called in action in France.

Dr. Louis Henn Buys McCardell Property

The Andrew McCardell property at 314 West Front street has been purchased from Mrs. McCardell by Dr. Louis D. Henn, until recently a practicing physician at Unadilla Forks, Otsego county, New York. The residence is now undergoing certain alterations and will be occupied by Dr. Henn and his family this forepart of next week, the former maintaining an office in one part of the house for practice as an allopathic physician.

Dr. Henn was graduated from New York University and for nearly ten years followed his profession at Starkville, N. Y. From there he went to Unadilla Forks, where he has been for eight years. He had built up a splendid practice at the latter place but has been forced to leave it on account of the rigors of New York State winters which exacted a toll on his health from physicians forced to weather every storm.

Restrictions May Soon Be Removed on All Building Work

Governmental restrictions on building work may shortly be removed, according to the following statement made yesterday by Mayor Leighton Calkins after his attendance at a meeting of the New Jersey State Council of Defense at Newark, Wednesday:

"At a meeting of the New Jersey State Council of Defense, which I attended yesterday in Newark, a telegram from the Non-War Construction Section of the War Industries Board was submitted, inquiring whether our State Council was of opinion that labor, transportation, and supply conditions would warrant the removal now of all restrictions on building projects."

"It was our judgment that the annulment of the existing regulations would have the effect of enabling private business to return to normal conditions as rapidly as circumstances would permit in the various branches of industry, and that as this return to natural conditions is bound to be gradual in any event, all labor, supply and transportation factors would readily adjust themselves to the new order of things."

"Accordingly our State Council immediately wired our approval and the repeal of the war restrictions may shortly be expected."

Plainfielders Attending School at Camp Raritan

Privates John J. Greene, of East Seventh street, and George V. Gulick, of West Third street, who have been doing detached inspection duty in this city and Elizabeth for nearly a year, were recently transferred to Camp Raritan, where they are now attending the Ordnance Motor and Maintenance Instruction School.

The two Plainfielders enlisted at Washington, D. C., December, 1917, and were assigned to the Walter Scott & Company's shop in this city as inspectors on 4.7 gun carriage work. Later they were transferred to the Singer Manufacturing Company's plant at Elizabeth to assist in supervising the complete of French 75 millimeter gun carriages and inspection of stores for the administration division of the Ordnance Department. Because of the experience they had acquired in this way, they were selected from a large group of eligibles for the school instruction at Camp Raritan.

Although hostilities have ceased, Messrs. Greene and Gulick will profit by their new work and should the Government require their services in the future they will be in line for a commission. Their success since entering the service has been a source of pleasure for their relatives and friends.

Many Good Jobs to Be Given Out in Near Future

Governor Edge will have some important appointments to make at the coming session of the Legislature to fill vacancies in State offices which expire during 1919. Heading the list is the position of Attorney-General of the State for a term of five years at a salary of \$7,500 a year. This position is now held by John W. Westcott, of Camden. It seems to be a foregone conclusion that Thomas F. McCran, of Paterson, who, in the last session of the Legislature, was Senate president, will be selected for this office. The term of Chancellor E. R. Walker, head of the Chancery Court, also expires during the coming session. Like Mr. Westcott, Chancellor Walker is a Democrat in politics, but it is anticipated that the Executive will adhere to the practices of former New Jersey Governors to keep the judiciary of the State evenly balanced politically and rename the present Chancellor.

The term of Robert McAdams, Democrat, of Elizabeth, expires also during the coming legislative session, and it is expected that he will lose his political head. He is clerk in chancery, and his salary is \$6,000 a year for a term of five years. It is quite probable that Melvin A. Rice, of Red Bank, a Democrat, will be re-appointed as a member of the State Board of Education, of which he is now president.

The term of George T. Bouton, of Jersey City, as a member of the State Board of Taxes and Assessment also expires. His salary is \$3,000 a year for a term of three years. The term of John D. Prince, president of the Civil Service Commission, which pays \$2,500, and is for a term of five years, expires also: Mr. Prince is, however, a Republican, and may be reappointed.

Another office to become vacant and which the Executive will have to fill is that of State Commissioner of Public Reports, of which Benjamin B. Bobbitt, of Long Branch, is now the incumbent. He was appointed as a Democrat, but "sopped" a year ago to the support of the Governor, and it remains to be seen what disposition will be made of this office. The salary is \$2,000 a year and is for a term of five years.

Baird Extends Thanks to Anti-Suffragettes

Senator David Baird, elected to the Senate from New Jersey in the face of a bitterly concentrated attack from the woman suffrage forces, gives much of the credit for his success in the late election to the New Jersey Association Opposed to Woman Suffrage. In a letter to Mrs. Carroll P. Bassett, president of that organization, made public this week, he says, in part:

"The suffragettes sent their orators and agitators from many States into New Jersey and boasted that with President Wilson's aid they would defeat me. I appealed to the New Jersey voters on my record in the Senate. The verdict speaks for itself, refuting the statement made by Mr. Wilson, in a letter to Mr. Hennessey, that I had 'certainly not represented the true feeling of the people of New Jersey.'"

"I have nothing against the suffragettes in general. The women who want the franchise have the right to use all proper methods to gain their end, just as the women who oppose it have, but the methods of the suffragette leaders, who, after insulting the President by burning his words in front of the White House, posed in New Jersey as supporters of the President in order to gain votes for my opponent, was nauseating."

DIED IN FRANCE.

Irving Wahl, a member of old Company K, died in France, October 16, after an illness with pneumonia. Word to this effect was sent this week to his sister-in-law, Mrs. Nellie A. Wahl, of 1257 East Second street. Previous to entering the service, Private Wahl was employed as a clerk at the Scott Press Works.

Standard Will Build Planes for Postal Service

With the return of peace and the release from active service of thousands of aviators that is to follow as a result, plans are being formulated by the Postoffice Department for the extensive expansion of the air mail service. In this the Standard Aircraft Corporation, with plants in this city and Elizabeth, is taking an active part and will probably construct many of the airplanes that will be used.

Engineers from the Postoffice Department and employed by the Standard, are now working on the details for establishing the air stations. Every large city in the country will have one, including Elizabeth. It is likely that the large flying field that is now being completed on property adjoining the Standard factory at Elizabeth will be utilized in that city.

The six planes that are now being used over the routes between New York, Philadelphia and Washington were specially constructed at the Standard plant. It was said by an official of the concern yesterday that many of the craft that will be used in expanding the service will be those which were turned out during the war and which will be adaptable for their new purpose with but slight changes. Those that have to be built will be modeled after the Standard machines.

Endorsements of the plan for distributing mail throughout the country by airplane are being made by numerous State and government officials. The latest one to approve it is Senator Joseph S. Frelinghuysen, who, in a communication to the Standard officials, has promised to give his support in the furtherance of it.

Colonia Hospital Work to Continue

The government base hospital at Colonia will be in existence for a year and possibly much longer. Until every soldier who has been injured in the war has been restored to health as nearly as possible and is taught to make his own living, the work will be continued.

There are at the present time over 1,300 soldiers convalescing at the hospital, which is one of the largest reconstruction camps in the country. Within a very short time the War Department will start to bring all the wounded men in France and England to this country, and after they arrive here they will be distributed among the various hospitals. Colonia will receive many more than it now has and they will not be discharged until they have entirely recovered.

It may be that the hospital will be enlarged to accommodate a larger number of men than can now be taken care of. Units from the Medical Corps will be stationed there to care for the wounded and as the soldiers recover sufficiently to be about they will be taught trades.

Auto Tag Distribution Will Start December 1

Little delay is expected this year in the distribution of automobile tags for 1919, which will begin December 1 under the direction of the New Jersey State Department of Motor Vehicles. "The only delay we anticipate," declares Commissioner Dill, "is that which the owners themselves will cause." The machinery of the department has been put in readiness for attending to applications with the best possible dispatch.

A circular letter will be sent out this week by Commissioner Dill to all of his fifty agencies in the State, and to other automobile officials instructing them to urge owners to procure their 1919 tags at once, and not wait until the last minute to comply with this feature of the automobile law.

All the tags will be ready and every agency in the State will have a full supply of them before the opening date of distribution. They are of better quality than in several years and tests have shown that they will stand a greater amount of rough usage than any previously issued New Jersey tag.

"All that is needed to absolutely avoid anything even approaching delays or inconveniences this year," said Commissioner Dill, "is for the automobilists themselves to give early heed and action to the matter of obtaining their 1919 registration tags. The department will be ready in all its branches. We can do nothing more; the rest of it is distinctly up to the automobile owners and operators."

Local License Agent James J. McCann, whose office is on East Fourth street, is in readiness for applications and urges autoists to call early and "avoid the rush."
