Salary hike goes through for municipal council

A resolution introduced by Councilman Bernard Hayden rejecting 1987 council salary increases was defeated by the council at their regular meeting held on Monday night.

The resolution sought to reduce the mayor's salary and those of the council president and council member to 1986 levels of \$2,400, \$2,200 and \$2,000 respectively.

"Most residents and taxpayers of this township were appalled that the council would give themselves an 80 percent raise this year," said Hayden. "The amount of tax money they pay is phenomenal to the type of services they receive."

"The people who seek to put this resolution through cashed their checks and have not returned the money to the township," said Councilman William Caruso.

Councilman Carmine Cristiani has pledged to return the increase in his salary to the Township and Councilwoman Carol Plata stated "you don't know what charitable organization I give my money to."

The resolution was defeated with Councilman Caruso, Fred Eckel, Robert Ellenport and Joseph Pozniak voting against it.

The council also approved appointments to the Rent Monitoring Board. The list of names submitted by Mayor George Nucera includes the following: Homeowner Lilian Krov, tenant Kalman Grafer, tenant Norris Reisman, homeowner Donna Femia and landowner Solomon Rieder.

"I am voting against this because of the circumstances under which it became law," said Councilman Hayden. "The only fair and equitable way to put rent control on is by referendum."

"It is a misconception to refer to this as rent control," said Councilman Robert Ellenport. "It is an opportunity to provide a neutral forum to air complaints and to have an adult discussion between tenants and landlords."

The resolution was approved on a vote of four in favor with Councilmembers Hayden, Carmine Cristiani and Carol Plata dissenting.

In other business the council:

Appointed Luis Siessel as Director of the Bureau of Welfare.

Authorized a purchase order in the amount of \$3,355 to Storr Tractor Company, Somerville, for the purchase of a salt spreader.

Established an annual salary for Public Works Repairer Russell Roe at \$16,178.25.

Authorized payment of \$1,778.40 to Bertone Associates, Sewaren, for architectural services in connection with the construction of a new fire substation on Raritan Road.

Approved a resolution urging the State of New Jersey to reopen the I.L.R. Landfill in Edison to accept Union County's waste until the Resource Recovery facility is completed.

Approved the acceptance of \$18,115.28 in revenue from the Municipal Public Safety Act Program.

Established the annual salary for Building Maintenance Worker/Black Seal License, Mark Basile at \$13,347.

Established the annual salary for Communications Operator, Bernard J. Kane at \$13,156.

Approved an ordinance for final adoption eliminating the job classification of Senior Communications Operator.

Approved an ordinance for final adoption establishing the hourly rate for school crossing guards and special police officers at \$6.95 per hour.

Approved an ordinance

for final adoption adding glass, aluminum beverage cans and cardboard to the township's recycling ordinance.

Approved an ordinance for final adoption prohibiting parking on the northwesterly side of Madison Hill Road from Westfield Avenue to Washington Street.

Approved an ordinance for final adoption amending an agreement with Union County to modify the Interlocal Services Agreement.

Approved an ordinance for final adoption establishing restrictions on the installation of antennas.


