CLOSE OF REGISTRATION FINDS 1877 NAMES ON LIST—LITTLE LESS THAN LAST YEAR'S VOTE

Considerably Under Last Year's Registration But Votes, It is Thought, Will Nearly Equal

Two Wards Run Ahead

Second and Third's Registration is Higher Than Vote Cast from There At Last Election for Governor

Despite the fact that at the opening of the polls yesterday afternoon it was estimated that less than half of the voters of the city had registered, the final figures showed that the registration was only ninety-three less than the vote cast in this city last year.

The registration at the close of the polls last night was 1877. The vote at the last general election was 1970. This year's registration is considerably below that of last year's which was 2426. It is believed that a larger percentage of registration will vote, however, under the new German law.

The last few hours of registration were busy ones for the election officials. The last minute men came rushing into the polls a few minutes before closing time, and the figures were considerably increased in this time. The registration is pleasing to the voters of both parties as it has been generally expected that the new election law it would be very tight. The municipal election has been conducted so quietly that it was believed the people were but little interested in it, but the registration figures show that the voters are awake and are prepared to pass on the merits of the respective candidates for office in this city.

The first and the fifth wards show a falling off in registration as compared with the figures of the last general election. At the last election in the first ward 416 votes were cast, and the registration ending this year in the fifth ward 386 votes were cast at the last election, and the registration was only 278. The second ward showed an increase with a registration of 579 for only 574 votes were cast last year. The third ward showed a slight increase. The vote at the last election was 554, and this year the registration was 556. In the fourth ward the registration was less than the vote of last year. The vote last year was 536, and the registration yesterday was 507.
