He stated that "max w evaluation is supposed to be political suicide for the administration that has it. But I think it is murder for the taxpayers not to have it." o far, Mayor Martin said, "the taxpayers have been extremely intelligent and understanding about this year's record high tax in-<u>crease</u>. I receive phone calls every night from citizens saying, 'Mayor, we know that this tax jumpt isn't your fault, but what can we do about the future?

"The most distressing <u>part of spiralling taxes</u> the mayor observed. "is that the so-called 'little guy' is the hardest hit. That is why it is imperative to have a sound tax base, so the tax burden is equally spread out among industry, business and small property owners.' "A tax revaluation, of it--self, does not increase or decrease tax revenues. It just insures that people are

fairly and justly taxed. Since there are most definitely inequities in Rahway, some tax bills will go up, and some will go down. The rule of thumb for a tax revaluation is that a third of the bills go up, a third stay the same, -and a third go down." While in theory, if all

property is evaluated to 50%. then the tax rate will be lowered sufficiently to keep the taxes the same dollar amount, if the property was assessed equitably in the first place. Most appeals before the

Union County Tax Board arise, however, after a revaluation, because taxpayers whose property the appraisers feel is assessed too low. usually are hit with substantial increases, especially since a reevaluation has not been made in 18 years in the city and one hike will have to encompase the inequities of that long period. When Rahway and Roselle have completed their reevaluations, then all 21 Union County municipalities will be evaluated at 50% of true value, and the county will proceed to evaluate property a 100% of value and cur the tax rate in half, keeping the total tax bill the same but avoiding the problem of converting assessed evalu-

This is what makes it so absurd that the American Bar Association should select as its prize winning essay a dissertation by Boston attorney Edward Lev unabashedly advocating the forced unionization of the nation's millions of public employees. This policy, of course, would inject into the public sector's bloodstream the same poison that enables union

officials to exercise dictatorial power over private sector employees and employers in the 31 states without right to work laws. Mr. Lev's rationale? Endorsement of compulsory unionismi would produce an additional sooo-million yearly in dues, which would have "incalculable political

Self-serving union professionals can be counted upon to seize the Lev recommendation and attempt to build a case for federal legislation authorizing them to exact tribute from the nation's public employees through compulsory union agency shops. To them only dues money matters, not the public employees who allegedly "benefit" from union representation they don't

The American Bar Association's apparent endorsement of such a policy, through publication of the 'award-winning'' essay in its official journal, is nothing short of incredible. But, as the poet once said, "Against stupidity the very gods themselves contend in vain.

Government Utilities Are Privileged

Unfortunately and unfairly, advocates of government in business always try to show that government power projects are somehow superior and more efficient than taxpaying, investor-owned business enterprises. Whether they are or not is virtually impossible to determine, since they enjoy tax advantages and freedom from regulation not accorded the taxpaying private companies.

One local, rural electric co-op, like many other utilities across the nation, was recently compelled to increase its electric rates. There were no public hearings. The rates were simply increased to meet rising costs--just as the lennessee Valley Authority, the federal government's huge power project in the Southeastern part of the United States, raised its rates. When government-owned or co-operative electric projects raise rates, electric consumers have no say in the matter. They pay the bill without recourse to any utility commission. In the case of the one co-op rate increase, the blow was softened somewhat by an item in the local newspaper telling of its "donation" of \$4,400 in lieu of taxes to the county in which the co-op displaced the pro-

perty taxes of a private utility. No doubt the hard-pressed taxpayers of the county will appreciate the co-op's "donation." Merck paid the students \$1.60 an hour for a maximum of 30 hours a week in their positions. The types of jobs included clerical and assistant positions with the board of education, fire department, John F. Kennedy Community Center, the city building inspector, the guidance department at Rahway High School, the Head Start program at Grover Cleveland School, and other local businesses such as doctor's and dentists' offices.

<u>Participants for the pro-</u> gram were selected on the basis of need and desire. Though public programs exist to aid young people, government financing necessarily required strict guidelines. Merck noted that these guidelines disqualified many students in need of summer jobs. TOPS was designed to 1111 the gap. Reaction to the program's first summer from both the

Iree Law Criticized And Tabled

An ordinance designed to save trees, especially those on the Searles estate, was the subject of criticism and praise at the Monday night meeting of the City Council. The ordinance on second reading was tabled.

Alonzo W, Lawrence, president of the Rahway Taxpayers Association, said that the law was ambiguous in stating that appeal of a person aggrieved was not before a person who knew much about treets.

He said the limitation imposed by the law saying that builders could not touch trees within 15 feet of the houses they are constructing, and builders would not be allowed to lay "material, machinery or temporary soil deposits ... within six feet of any tree truck or stem" were too severe. He also objected to the use of the word "stem" which he felt could be applied to a flower, just as

Abe Reppen of 454 W. Grand Avenue also felt it was better to remove most trees during construction as Mr. Lawrence suggested, because removing them afterward results in heavy char-

well.

Mr. Reppen also pointed out that disturbing the natural environment of trees by laying roads and constructing buildings cuts off the roots and often results in the death of large trees several years after the erection of a new home. Mrs. John Brogan of 383 Seminary Avenue hoped that the ordinance would be passed b save the trees on the Searles property, A resident of Jaques Avenue also cired oxygen manufacture as a way of depolluting the air that is a benefit of trees.

Proposal to Buy Former Gas Office the ordering of 25 "No Littering" signs to be placed For Police HQs Gets Mixed Reaction

A proposal by the administration of Mayor Daniel L. Martin to purchase the former branch office of the Elizabethtown Gas Co. located at the intersection of Central Avenue and Irving and Hamilton Streets was approved on first reading,

The measure is scheduled for final adoption at the October meeting of council which will be held Tuesday. Oct. 12, because the regular date, Monday, Oct.11, is Golumbus Dav. The ordinance provides \$130,000 to finance the purchase, but Fifth Ward Councilman Peter M. Donovan charged that the project could cost as much as \$300,000

or more and does not have the advantage of combining a new facility for both fire and police services. Mr. Donovan further pointed out that the administra-

tion was proposing to purchase a tax ratable. He said he did not understand why the new combined facility could not be located in the Redevelopment area where 25% financing of the total cost could be obtained from the federal government. ——— He said the combined facility could make possible the reduction of the fire force by four men which would come to around \$44,

The proposed site is known as Lots 11 and 14 in Block 941, having a frontage on Central Avenue of 401,83 feet and a depth of 165.5 feet more or less.

The building is presently vacant, and other parties have expressed an interest in bidding for it.





Black Mortuary Is Turned Down, 6-3 Tense Session

in a bi-partisan vote, city -council denied a variance but council denied it on Oct to James C. Jones, Sr. to permit the maintenance of a funeral home at 247 Elm_ Ive., Rahway. The action was taken by a

6-3 vote after long statements giving reasons for the action. Voting to deny the variance were Republicans Peter M. Donovan of the 5th Ward in whose area the funeral home was to be operated, Third Ward Councilman Richard J. Voynik, Secund Ward Councilman James R. Pickens, and Sixth Ward Councilwoman Mrs. Donald Forsythe, and Democrats, Wilson D. Beauregard and Francis R. Senkowsky, both counctimen-at-large.

Voting in favor of the variance were: Council President Dr. Adam T. McDaniel of the Fourth Ward, First Ward Councilman John J. Gilgannon, and Councilmanat-large James E. Crowell, all Democrats. The Superior Courtorder-

ed the city council to give reasons and to take action on the matter. In October 1969. a GOP-controlled council denied the variance, 5-4, but did not give reasons for the action. On an appeal to Superior Court by Mr. Jones, Judge Milton Feller ordered reasons to be

- given. In the resolution passed at Monday night's session, five reasons were given for denial: firstly, that off-street parking is insufficient; two, that a hardship was not demonstrated; three, that alternative suitable sites were not established by the applicant; fourth, that no special reasons were established and, fifthly, that "granting of this variance application would substantially impair the intent and purpose of the zoning plan and zoning ordinance by over-commer--cializing a residential district with consequent and substantial alteration of the character of the neighbor hood and resulting devaluation of the property values in the area." The board of adjustment had recommended approval

of the variance on May 19 to meet standards for state 1969 after it was ordered

was put off for lack of surfiring affirmative votes because Council President Mc. Daniel believed the variance would be approved and had a resolution drafted in the affirmative. When several votes changed, the matter could not be acted upon, stared Mr. McDaniel in the July 29 issue of The News-Record, because a resolution stating reasons in the negative could not have been drafted in time.

The action of council is one in a series of votes going back three years. The matter is probably not yet concluded because the Superior Court retained jurisdiction on the matter, and the decision can be appealed Fifth Ward Councilman Donovan said he received 40 telephone calls on the matrer and not one favored the granting of the variance. He said further that "within one and a half blocks north of the proposed site there are more than 40 children of teenage years and under.

Mr. Crowell said council was "making a big mistake" by not voting for the funeral home variance. He said I did not matter than another -mmerat-home. - Gorey and-Corey, 259 Elm Avenue, was located next door, but that Mr. Jones should be granted the right to open a business.

Councilman - at - large Beauregard said granting the variance would be promiscious spot zoning," and that councilmen should protect established residential zones from "creeping commercialiasm.

Mr. Gilgannon said that the area was only partly residential because it had some professional offices located there. Dr. McDaniel, the only black member of the body, was most displeased with the vote to deny the variance, terming the action "blatant racism." He said in the 12 years he has sat on council no professional variance had been denied. Dr. McDaniel stated fur-

ther if there was any justice in the courts there was no question in his mind that the variance would be ultimately approved. Third Ward-Gouncilman---Voynik, citing his vote to kill a parade ordinance suggested several years ago to stop demonstrations that was opposed by the black community, felt that the funeral home

variance should be denied no matter who applied for it. He said it was unfortunate that Dr. McDaniel used the word "racism" in referring to council's action. Mr. Mc. Daniel clarified his earlier statement that he was not applying the word to councilmen but to the general undercurrents seeking defeat of the variance.
