City students improve testing over two years

America's two-party system is smalling into content, and democracy will be dragged down with it. warns Rutgers University Prof. Gerald M. Pomper. Prof. Pomer., who directs the new Center on Political Parties at the State University's Eagleton Institute of Politics, says television, the federal campaign-spending laws, the spread of superfluous Presidential Primaries and the growth of more open state and local Primaries togethe are weakening the influence of both the Democratic an Republican parties. As a result, the political scientist said, many candidates have grown increasingly estranged from the two major parties, and, once in office, those usaligned officials have ittle or no resson to co-operate with the parties, nor the

parties with the officials. Consequently, it is difficult for either party to develop and follow a coherent policy direction, At the same time, the professor noted, voters have grown by the fact the number of independent voters rose from 22% n 1960 to 35% in 1976. In addition, only 54% of the adult population actually cast their ballots in the last presidentia election, nearly a 7% dip since 1960. The inability of President Jimmy Carter, a Democratic Party outsider, to push a comprehensive energy plan through a Democratic Congress is a clear example of the potential fo
