## Cranford rally tonight to protest plane noise

A rally protesting recently increased aircraft noise over residential areas in New Jersey will be held tonight at 8 p.m. in Room 108 of the Cranford Municipal building, 8 Springfield Avenue.

Sponsored by Cranford's Stop the Noise Committee, the rally will draw together elected officials and citizens challenging the Federal Aviation Administration's new East Coast Plan and its effects on New Jersey residents.

The meeting is open to all communities.

"According to the FAA, the East Coast Plan was to improve arrival and departure times out of Newark, Kennedy and LaGuardia airports," said Paul LaCorte, former mayor of Cranford and chairman of the Stop the Noise Committee. "As a result of this plan, planes have been channeled into

air corridors directly above some of the most populated areas of the state, communities now battered by the sound of low-flying aircraft up to 24-hours a day."

LaCorte continued "How successful has the FAA's Plan been?" Newspapers across the state are carrying reports that the airlines are unable to maintain their flight schedules and are in fact seeing a deterioration in customer satisfaction rates."

## City considers new proposals for Rahway Corporate Center

In the process of negotiating an agreement with new developers for the Rahway Corporate Center, a 14-acre site located adjacent to City Hall, the Municipal Council heard two presentations from hopeful groups last week.

Marshall Weinerman, representing a group consisting of John A. Strama, Joseph Gelber and Robert Gelber, suggested a mixed-use facility consisting of a hotel and conference center, mid-rise condominiums with commercial space and office buildings for the site.

Weinerman, who lives in Clark, is the owner of Marshall's Cleaners on St. Georges Ave. and manages the strip center containing Drug Fair and the Elizabethtown Gas Company.

He also rehabbed the property and planned and built the Commercial Trust Bank building on St. Georges Ave.

Mr. Weinerman has been involved in the real estate field for the past 30 years and currently manages 850 apartment units throughout the state of New Jersey.

He is also the president of The Summit Hotel, Summit, a 144-room luxury hotel which recently underwent a \$10 million renovation.

Previously, he was a partner in charge of operations for two Sheraton Hotels in the Atlanta, Ga. area.

Weinerman is also a co-founder and president of Devon Development Company which builds luxury single-family homes, and retail and commercial space.

Weinerman and John Strama are co-founders of Ridgeway Development Corporation, "one of Atlanta's fastest growing and successful development companies."

Ridgeway has a New Jersey division, based in Toms River.

Strama has developed a 92,000 square foot and 220,000 square foot office building as well as a 93,000 square foot shopping center in the Atlanta area.

Strama is a former executive vice president of Hovnanian Enterprises, a major home-builder.

Robert Gelber is an attorney in charge of overseeing both the legal and accounting areas of Devon Development Company as well as being on the Board of Directors of Ridgeway.

Joseph Gelber is an attorney who was a real estate investor and manager of apartment complexes. He resides in Florida.

"With many years of 'hard knocks' and experience, we have all the different pieces to do what we want to do in Rahway," said Weinerman. "We have local knowledge of the community and we are familiar with Rahway's history. We have the ability to understand the needs of the community. We can work together as a team."

Subject to the results of a feasibility study, the team would build a luxury hotel and convention center, condominiums with commercial space, complete the office building now standing on a five-acre site in bankruptcy proceedings and construct another 40,000 square foot office building.

"We are bright and hard working," said Robert Gelber, "and we have the financial strength to do what has to be done."

"It is our hope that the project in general and the hotel in particular will become the focal point for the downtown area," said Weinerman. "We are very sensitive to the problems

and needs of the residents of Rahway."

The second development group in present a plan to the Municipal Council consisted of George Albanese, Eli Kramer and Allan Cooperman.

"Rahway has a unique site and a unique opportunity in the Rahway Corporate Center," said Albanese. "As a resident of Union County, I've said that Rahway is undergoing a quiet renaissance. This would be an excellent opportunity to work with the officials of Rahway."

The group has constructed projects in Newark, Paterson and Trenton, said Albanese, with experience in projects costing \$160 million down to townhouses. "A very important factor is financial capability," he noted.

The proposed plan would be to locate a major supermarket chain and other "interested tenants" in the area. Albanese proposed a "major commercial development."

"The commercial site would be used as an anchor for the central business site," he said. The plan would encompass the downtown business area by drawing shoppers to the area.

"If you keep retail where retail should be, it will get stronger," said Albanese. "Let's build from strength. If you start off with a strong supermarket, other retailers will come along and perpetuate themselves," said Cooperman. "This nucleus will open it up to existing retail."

The unfinished office building currently on the site would be finished, said Albanese.

All proposals would be pending the solution of bankruptcy hearings currently instituted against developer Daniel Cozart, of Clark, who was the original developer of the site.

Over 300 voices were raised in celebration to commemorate Dr. Martin Luther King, Jr. at an ecumenical service held in his honor at the Second Baptist Church on East Milton Avenue on Sunday evening.

More than 300 residents and their families joined in with the Male Chorus to honor Dr. King.

## Dr. Martin Luther King

### A man with a dream

Martin Luther King, Jr. was an American clergyman and civil rights leader who was born in Atlanta, Georgia in 1929. He received a Bachelor of Arts Degree from Morehouse College in 1948, a Bachelor of Divinity Degree from Crozer Theological Seminary in 1951 and a Ph.D. degree from Boston University in 1955.

He was ordained a minister in his father's church, Ebenezer Baptist Church, Atlanta, in 1947 and became pastor of the Dexter Avenue Baptist Church, Montgomery, Alabama, in 1954.

In 1955, after a Negro woman was arrested for refusing to give up her seat to a white woman on a bus,

King began his active leadership of the civil rights movement by taking charge of a successful 382 day boycott of the Montgomery bus system.

During his marches and speeches, King always emphasized the need to act in non-violent ways.

In 1957, he was instrumental in founding the Southern Christian Leadership Conference, a group of southern Negro ministers and other professional persons which became one of the leading civil rights organizations.

In 1960, he was named co-pastor of his father's church in Atlanta.

In 1963, King led a second massive civil rights campaign in Birmingham,

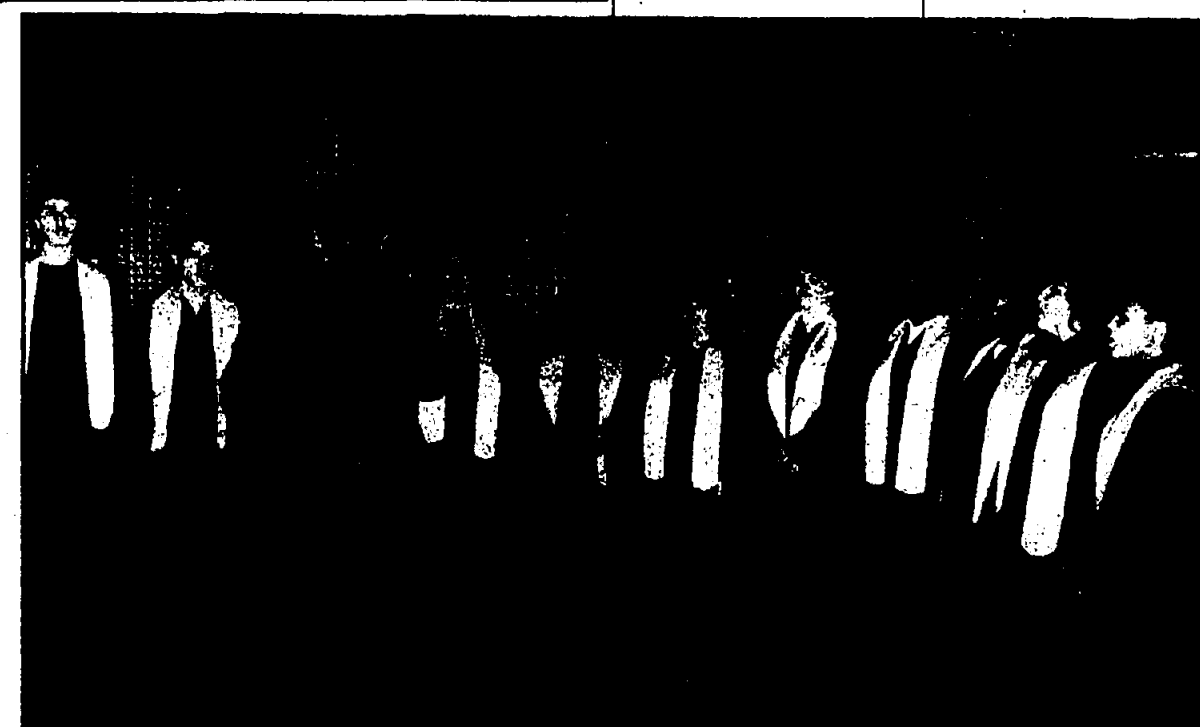
Alabama, followed by major campaigns for Negro voter registration in the South, desegregation and for better education and housing.

These campaigns were later expanded to the northern states. During these non-violent campaigns, King was arrested several times.

On April 4, 1968, while in Memphis, Tennessee, to lead a march of striking sanitation workers, he was assassinated.

Dr. Martin Luther King, Jr. was awarded the Nobel Peace Prize in 1964 and was the author of several books including "Stride Toward Freedom," "Strength to Love," "Why We Can't Wait" and "The Trumpet of Conscience."

## Hospital Auxiliary looks back on years of growth in service

With its recent presentation of a "donation of \$175,000 to Rahway Hospital, the hospital Auxiliary fulfilled a pledge of \$303,000, an achievement unprecedented in the group's 69-year history.

In just a five-year span, the Auxiliary raised \$500,000 toward the hospital's Expansion and Modernization (E&M) Program as well as \$303,000 that was used to purchase telemetric and radiologic equipment in combination with a \$100,000 grant from the Fannie E. Rippl Foundation.

"This achievement took a great deal of work — over 18,000 hours of service contributed by our members — and we did it in only five years," said Auxiliary President Marydel Grailh in making the presentation to hospital President John Yoder and Foundation Chairman Nelson Taylor at the Auxiliary's Annual Meeting.

Mr. Yoder responded, "I thank all of you for working so hard toward this achievement. Your roots go back to 1918, the year after the hospital was founded, and you have been helping ever since. Hospitals need their auxiliaries and our staff will always support you."

The Auxiliary was formed on May 18, 1918, when a group of 15 women met at the home of Mrs. John Ackley under the leadership of Mrs. W.J. Cudek and Mrs. Frank Stillman. Since then, the members have put in countless hours of service to raise money for a multitude of items as well as for building projects.

Early funders for the first hospital building included rummage sales, card parties and dances to purchase such items as a hot water heater, linoleum for the hospital kitchen, china and linens for the nurses, as well as to build a walkway to connect the main hospital building with the nurses' quarters located next door.

Peggy Jones, a dedicated member of the Auxiliary since the 1940s and a past-president, fondly recalls a very special fundraising event which took place for many years called "Rose Tag Day."

"We sold roses gathered from our own gardens to the people waiting for trains at the Rahway station. The commuters were so pleased and happy to accommodate us," she explained.

Other Auxiliaries were stationed at traffic intersections to sell the flowers to the drivers of passing cars. It was with this special day in mind that the rose was adopted as the hospital's symbol in the 1960s, and has remained so since.

Over the years, the Auxiliary has started up many other fund-raising projects which still endure. Today's Auxiliary is responsible for the administration and/or staffing of many important hospital amenities, including the Rose Tree Gift Shop, Shop-on-Wheels, Shots-for-Tots, Snack Bar,

hobby photo and television services and the infant car seat program.

Financed by the Auxiliary, the hospital's television system is undergoing improvement through the gift shop and the other services for purchases ranging from an elevator and air conditioning system to laboratory and radiologic equipment.

said. "Reports from agencies that deal with the homeless in the county say that 80 percent of the total are families with children, and that demands for their services since 1986 have tripled, so this is an extremely serious problem that needs to be addressed."

The problem is so severe, according to officials, that money allocated the county in 1987 from the state Homeless Prevention Program was used up during the first six days of the year.

## Store employees to receive millions in back wages

Some 20,000 present and former employees of a New Jersey dairy and convenience store chain will share about \$4.4 million in back wages under a federal court consent judgement announced late last month by the U.S. Department of Labor.

The Labor Department charged in a suit filed in the U.S. District Court for the District of New Jersey April 14, 1982 that the company had violated the minimum wage, overtime pay, and record-keeping requirements of the Fair Labor Standards Act since at least 1979.

The act requires payment of a minimum wage of \$3.35 an hour and overtime at time-and-one-half after 40 hours in a workweek. Employers are also required to keep adequate time and payroll records.

Judge Cowan's order prohibits the defendants from future violations of the minimum wage, overtime, and record-keeping requirements.

Filing of the case followed an investigation by ESA's Wage and Hour Division area offices at 970 Broad Street, Newark, and 3131 Princeton Pike, Lawrenceville, New Jersey.

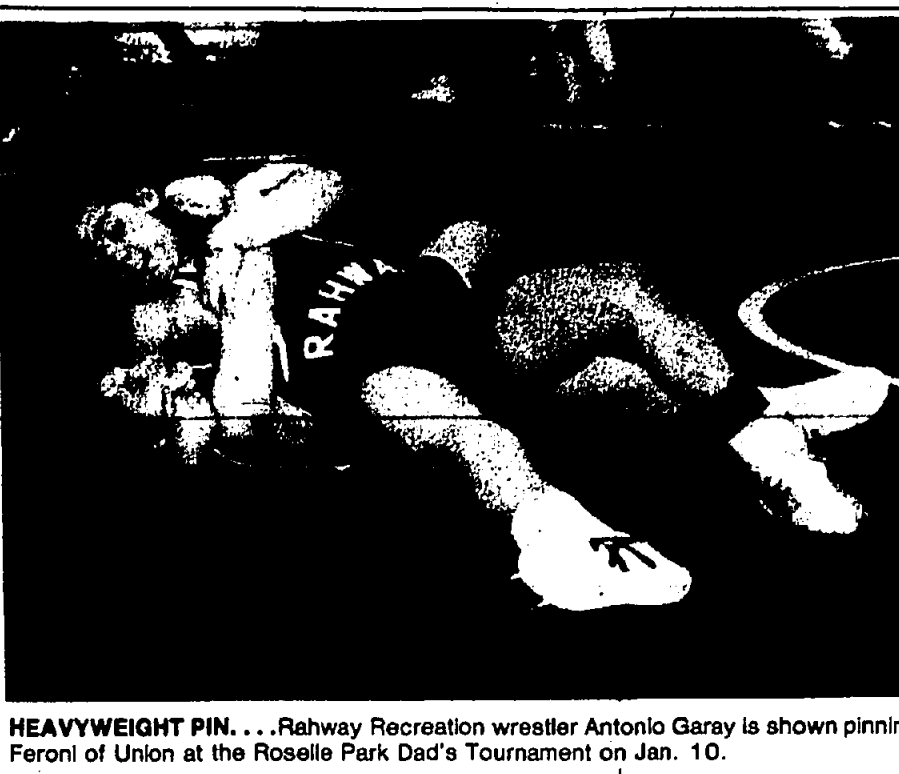

# Weather station offers stats

Santa brought Union County area residents rain instead of snow for Christmas this year.

Rain fell ten days in the month of December, for at least six of which 0.10 inches or more was recorded, according to the Union County Cooperative Weather Station at the Cranford Campus.

The greatest amount of rain to fall in December was 0.62 inches on the 15th. Total December rainfall was 2.51 inches, which is 1.71 inches below normal.

The greatest December rainfall on record was 9.60 inches in 1973. The lowest was recorded in 1980 at 0.74 inches.

The total precipitation during December, 1987 was 50.13 inches, which holds the record for the greatest total precipitation during December when 72.01 inches had fallen by the end of December.

Prof. Raymond J. Daily, station director, reported that the average relative humidity per day was 81.87 percent. December 7 saw the lowest humidity reading for the month at 65 percent. The maximum relative humidity of 100 percent was recorded on the 4th.

15th, 20th, 25th and 29th. A total of 2.5 inches of snow fell on record was 22.8 inches in 1960. The total snowfall through December 1987 is 4.7 inches. Total snowfall through December 1986 was 2.2 inches.

The lowest daily average temperature was registered at 21 degrees on Dec. 30. The record low temperature for December was -5 degrees in 1980. The highest temperature for the month was 47.5 degrees on the 10th and 25th. The record high temperature for December was 75 degrees in 1977.

The mean temperature for December, 1987 was 50.13 degrees, 2.92 degrees above the normal.

The mean temperature for 1986 was 50.13 degrees, 2.21 degrees above the normal. The maximum temperature recorded on the 9th, while the minimum temperature was 21 degrees on the 31st.

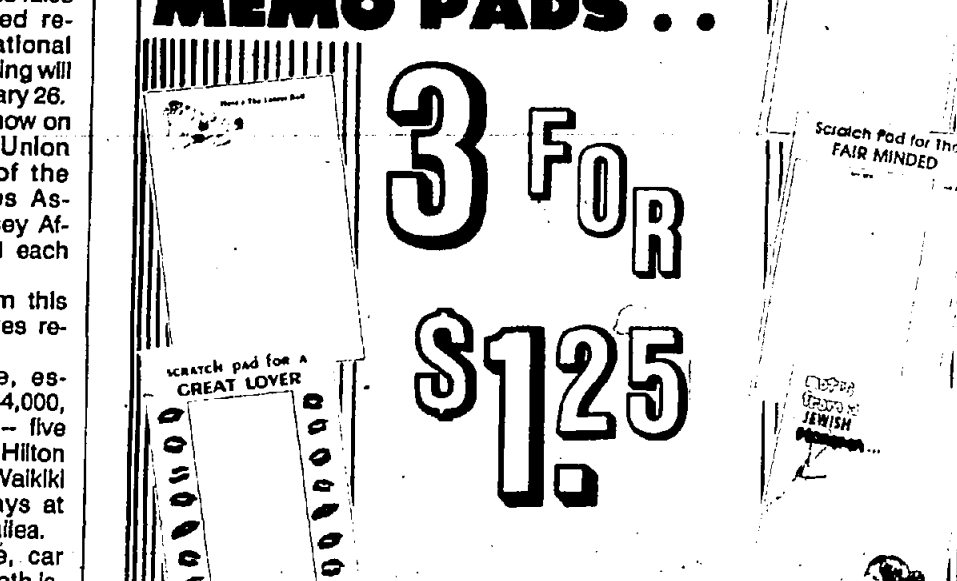

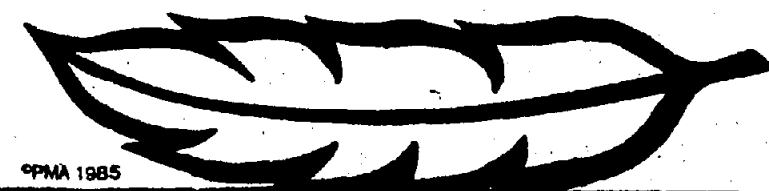
