Council paves way for Rt. 1 pool hall

Rahway's Municipal Council amended an ordinance to pave the way for a new billiards room to be located on Route 1. City Attorney-Louis Raimone said there are no billiard room licenses currently held in the City, but plans for a proposed pool room to be located in the Granite Plaza strip center on the highway called for an update of the City's laws governing operations. The ordinance sets a \$250 licensing fee with \$25 for each billiards table. Each licensee must maintain good order and prohibit gambling, and no one under the age of 17 may be allowed on the premises. Pool halls will be limited to B-4 or highway zones. A public hearing on this ordinance will be held during the council's February 11 meeting. In a previous meeting, some members of the council voiced their concerns over the safety of youngsters who might cross Route 1 to enter the proposed billiards room. Representatives of the company said they were also concerned with safety and would work with the council to alleviate their concerns. The license to operate the recreational facility has not yet been applied for or granted. The Things War Deprives Us Of

Sen. Cisselway of Rahway called the following item to our attention: In a recapitulation of something that appeared in the "Business & Professional Directory" published by the Rahway Record in 1983, at the height of World War II, Read and Jennings, who the dollars being spent on the current war in the middle east, might have bought: STOP--LOOK--LISTEN According to the Congressional Record, the money the World War I cost could have given every family in the U. S., Canada, Australia, England, Wales, Ireland, Scotland, France, Belgium, Germany and Russia a \$2,500 house furnished with \$1,000 worth of furniture, placed on five acres of land worth \$100 an acre. There would still have been enough money left over to give each city of 200,000 inhabitants and over in these countries a \$5,000,000 library, a \$5,000,000 hospital and a \$10,000,000 university. Then, out of the balance, there would still have been enough money to have set aside \$100 million to give a \$1,000 yearly salary to 125,000 teachers and 125,000 nurses. And after all this, there still would have been enough money left to build a school in France and Belgium and everything else that was needed.

Franks seeks repeal of resource recovery tax

Legislation presumes Rahway burn unit will never be built

Assemblyman Bob Franks (R-Dist. 22) has announced his introduction of legislation to ease garbage costs and provide tax relief by repealing the outmoded Resource Recovery Investment Tax. The bill, A-4312, would repeal the \$4-per-ton tax on garbage dumped in New Jersey and return the savings, including the account balance, to local governments to lower solid waste collection and disposal charges. The action would result in an immediate \$50 million windfall for counties and their taxpayers and an annual savings of as much as \$20 million, according to Franks. It makes no sense to continue to collect a tax to support solid waste incinerators that may never be built," said Shinn. "The original purpose for the tax is no longer valid." The \$50 million balance in the resource recovery tax account would be returned to counties in proportion to the amount paid into the fund. Franks stated, "The Florio administration has taken action to delay the building of the Resource Recovery facility in Union County. Therefore county taxpayers should not be paying into this tax fund." The resource recovery tax was intended to assist in the construction of solid waste incinerators — a policy option which recently has been rejected in favor of greater recycling efforts. "The homeowner should see relief in both garbage costs and taxes if this tax is repealed," said Franks. "At a time when residents are

KUC is new city clerk Succeeds former boss



St. Agnes to remain intact! Clark parochial school has many Rahway students

Parents and children in the St. Agnes School family are jubilant over recent news from the archbishop that the school will remain open. Archbishop Theodore McCarrick notified school personnel that a co-sponsorship plan will not be enforced on the elementary school. Over the past few months, the Archdiocese School Office was in the process of investigating the possibilities of co-sponsorship whereby communities in different parishes would be combined in cluster schools. Rumors circulated that St. Agnes would be closed and joined with St. John the Apostle School in Clark. Rev. Eugene Marcone, pastor of St. Agnes located on Madison Hill Road in Clark, instead submitted his own configuration plan to the archbishop explaining why the school would not fit into the co-sponsorship plan. Eventually, his presentation was successful because the archbishop realized the school last week that St. Agnes may continue operations as a separate entity. Part of Rev. Marcone's presentation included plans for a full-day Kindergarten to begin in September of 1991 to be followed by a pre-Kindergarten program to be implemented in September of 1992. We are anxious to start our Kindergarten program," said Father Marcone. The archbishop was pleased with the plan we set forth and with the support of the families and parishioners of St. Agnes, our school will continue its excellence. St. Agnes School is a 1-6 grade elementary school with a current total enrollment of 157. Teaching staff includes eight full-time instructors with part-time science, music, gym, and art staff members. The parish of St. Agnes includes 1,600 families as communicants. Rev. Marcone said projections for the Kindergarten program show 15 students the 1st year, 20 the 2nd, 22 the 3rd, 25 in 1994 and 25 in 1995. Additionally, population projections for the pre-K program show 12 students in 1991, 13 in 1992, 14 in 1993 and 15 in 1994. A portable music building will be used as classroom for the upper grades, which will make those in the main building available for younger students. With the archbishop's approval, members of the St. Agnes Church School family are committed to following through on future plans and programs. There is a groundswell of support for the school and students are braced for a high of relief over the decision to remain open. "Parents' participation is important," noted Father Marcone. "They have confidence in their school. We are happy about the decision and I am confident we will continue to provide the best education possible for our children."
