Burnett said: "We are dealing with human problems as distinguished from geometric designs. We are going to work out the 200-foot regulation in the ordinary way that any good citizen himself would do if he were walking from the school house or church to the licensed premises."

To obtain the temporary licenses which are authorized applicants will have to pay the legal tax to June 30, 1934, or about seven-twelfths of the annual fee.
