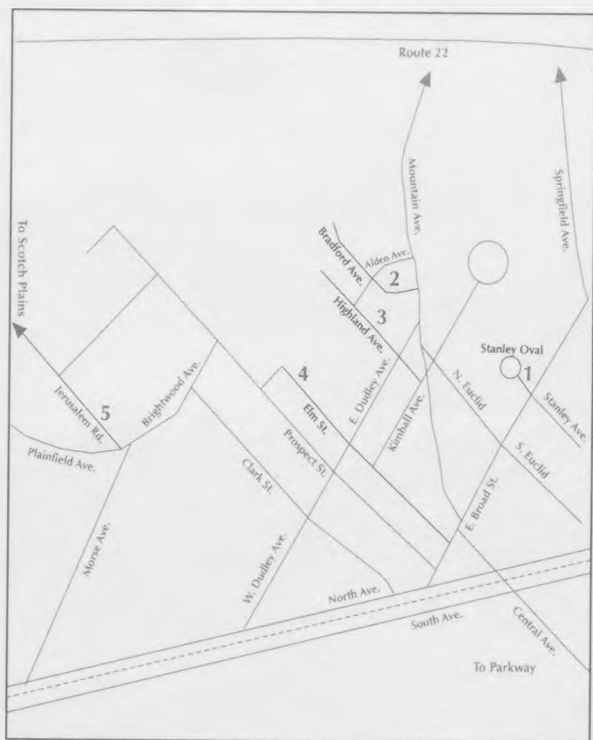

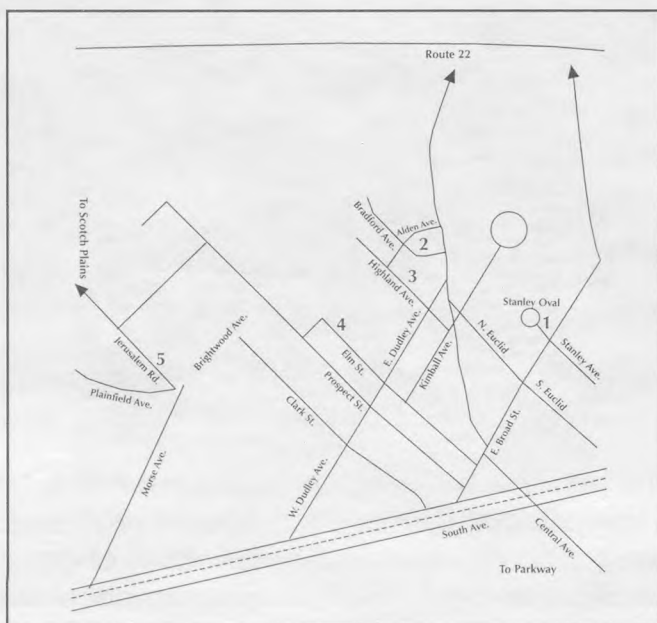

#1 — 1 STANLEY OVAL

"FAMILY HOLIDAY HOMESTEAD"



The history of this delightful home inspired its "Family Holiday Homestead" theme. When you arrive, the wide and spacious front porch will enchant you with its charming and winsome décor and invite you inside to reminisce about your family's traditions.

It's easy to imagine cozy family gatherings in the kitchen and family room while the formal dining and living rooms will impress you with their sophistication. Make sure to find the gingerbread carousel in the kitchen – good enough to eat!

A smile will most certainly cross your face as you delight in the abundance of children's toys on the welcoming wreath, nutcrackers marching up the stairs and the Christmas trees bedecked with handcrafted ornaments made from classic children's toys. A whimsical toy truck adorned with holiday blooms is featured in the family room. This home surely will bring back childhood holiday memories and the warmth of simpler times.

#2 — 531 BRADFORD AVENUE

"WOODLAND TIDINGS"



Pots brimming with greens and gilded pinecones hug the front steps, setting the "Woodland Tidings" holiday theme for this house. In the entry, a rustic old St. Nick and his companion fox greet guests. Vines and greens intertwined with lime and cranberry ribbon adorn the staircase.

Woodland turns to elegance in the living room where the mantel features an asymmetrical design of burgundy amaryllis, greens, berries, and candles. Nestling in the living room is a grapevine swan overflowing with flowers keeping company with our pianist, Carolyn, serenading us with Christmas carols.

Handmade stockings stuffed with flowers introduce the den, which is decked out in grapevine wreaths and handmade pillows. The elegant woodland theme flows into the dining room with European-influenced floral arrangements. In the kitchen, dinnerware is set amidst a forest of birch and pine on an embroidered runner of Nordic design. Hand-crafted "Tomte Nisse," Scandinavian forest gnomes, wish us good luck in the coming year. Finally, in the family room, Santa keeps watch over a Christmas tree with handmade birds, handcrafted birdhouses and gilded balls nestled within its boughs.

#3 — 540 HIGHLAND AVENUE

"FROM FARM TO CITY CHRISTMAS"



"From Farm to City Christmas," the theme of this bright and cheery home, reflects the origins of our homeowner who grew up on a Midwestern farm. As guests approach this spacious home, they will find themselves greeted along the walkway by metallic farm animals decked out for the holidays in sprigs of greenery.

The country Christmas continues with the family room tree decorated with hand-stitched farm animals. In the kitchen, a homemade gingerbread farmhouse sits on the island tempting all who walk by. The Hoosier cabinet, a family heirloom, is adorned with a small tree made of branches and berries. The library's hot pink desk will feature an unusual centerpiece made to look like plants growing from a book – what story is it telling? The dining room focal point is sure to be the table with its unique table runner fashioned from burlap, greens and flowers with napkins folded in the shape of miniature Christmas trees. As you move into the dining room, discover the magnolia leaf placemats showcasing the place settings for the family's holiday meal. In the kitchen, observe the clever use of magnolia leaves, winter greens and kumquats in the arrangements and window treatments to interpret the teal, orange and lime color scheme.

The family room tree is a delight for young and old with hand-strung popcorn garlands, candy icicles and everyone's favorite Christmas treats – candy canes! They are the perfect complement to the homeowner's cherished Nutcracker and Santa Claus collections so lovingly displayed. The mudroom focuses on the family's three large dogs (Truly, Juno and Brody) featuring their own tree decorated with dog biscuits and apple-cinnamon ornaments. Every four years, The Rake & Hoe Garden Club of Westfield, New Jersey, a non-profit club founded in 1952, holds the *"Deck the Halls Holiday House Tour"*. We invite you to join us to tour four elegant *homes for the holidays* where our 80 members have decorated with fresh green, wreaths, flower arrangements, Christmas trees and unusual natural decorations showcasing the theme developed by each home's design team. Another feature of *"Deck the Halls"* is a Holiday Boutique. Rake & Hoe club members design holiday gardening and flower arrangements that are available for purchase in the Boutique during the House Tour. Proceeds from the Tour support the club's numerous service projects and club operations. Donations are also made to our local schools, libraries, arboretums and land trusts. These community service projects include:

Flower Arrangements & Holiday Decorations

- Westfield Mobile Meals: quarterly tray-top arrangements.
- Jardine Academy: holiday trees, decorating parties, book donations
- Lyons Veterans Hospital receives quarterly desk-top arrangements for veterans and staff; holiday gift bags for veterans; Memorial Day and Veteran's Day personalized note cards of appreciation; annual luncheon and flower arranging workshop at the Women's Trauma Unit.

Community Gardens Design and Maintenance

- Miller Cory House and Gardens including the Juniors Dye Garden.
- Westfield Train Station Northside Garden.
- Shadowlawn Pocket Park and Blue Star Memorial Garden including the Juniors Butterfly Garden.
- Claire Brownell Memorial Wildflower Garden
- Westlake School: Members work with students & staff to make Valentine's Day arrangements that are sold to other students at the school store.

House Co-Chairs Meeting Notes

- Introduction of everyone's roles
 - Co-chairs manage the contact with homeowners. Form: **What Homeowners Can Expect** which is included in folder.
 - Co-chairs attend monthly update meetings held 15 minutes prior to each Rake & Hoe general meeting.
 - Call periodic team meetings for planning, workshops to make design components and/or boutique items and to keep everyone involved in the team's progress. You never know which creative energy will inspire the next great idea!!!
 - Co-chairs keep a running log of all meetings and information to be compiled into your final report. This will also build your final report and electronic files.
 - All members work collaboratively to develop a house theme and designs for the entire house.
 - All members develop item(s) to be used in the house's design/sold at the Boutique.
 - Co-chairs assign rooms to members and begin structuring/pricing designs.
- Each House will develop its own theme under the "Deck The Halls" event theme.
- Use vignettes to tell each house's story. While your designs will be the stars of the show, other items can be supporting actors in your story telling. Please take advantage of them! Some of these items include:
 - Some of our houses have very interesting histories that can be incorporated into your vignettes and write-ups. Discuss with the homeowners.
 - Please let your homeowners know that we appreciate that they have collections (e.g., ornaments, villages, silver tea service, Christmas china, spectacular vases/containers) that are very special to them and that they would appreciate having incorporated into your house design. Assure them that you will make every effort to do so. Who knows – they may be the key pieces to the vignettes you're trying to create!
 - Hopefully each of our guests is anticipating what they'll get for Christmas, so let's use beautifully wrapped presents under the tree and in any other nooks that would benefit from them.
- Attend the initial walk through of your house with 2018 DTH Co Chairs by March 23rd.
- Complete Co-Chairs and Teams first walk-through by 4/15.
- Hold Teams' first meetings with DTH 2018 Co Chairs
- House plan and boutique item(s) due 6/15/18 (Form provided). Form: **Plan**
- Please include in your design seating at the house's entrance/exit to assist guests with footwear.
- Deliver electronically your article regarding your house's history to Joe Da Rold and Betty Round by 6/30.
- Construct design and craft items constructed during the summer. 2018 DTH Co Chairs will pitch in!
- **Budget** is \$2,000/house. Please remember that the arrangements bought by either the homeowner or guests offset our costs. ***This is a fundraiser*** for us and we need to maximize income from the arrangements.
- Deliver the electronic copy of your house design write-up to Joe DaRold, Betty Round and Pat Wilson (copies to Sharon) by September 30th.
- Order flowers through Ferris (courtesy of Kay Cross) using the form provided. To minimize confusion for Ferris, please select 1 person to do the ordering for your house. Form: **Flower Order Form**.
- Deliver requests for expenditure reimbursements at the October and December general meetings. Please use the provided Expenditures Summary Form with ***original receipts*** attached.

ALSO, please note that Rake & Hoe will not reimburse anyone for sales tax. Sales Tax Exemption Form Has been provided. Forms: **Check Request; Tax exempt; Expenditures Summary.**

- Remind the homeowner what items are theirs at your last walk-through & in early November
- 1 undecorated tree, 1 mantle décor, 1 front door décor, Roping used inside & outside

*Accept tree delivery on or about 11/27. Please arrange to be there to set up the tree.

*Deliver items to be sold at the Boutique to Boutique co-chairs on Tuesday, 11/27.

*Pick up your flowers from Ferris on Wednesday, 11/28 and hold your team's flower conditioning party!

*Decorate the house Friday, 11/30 – 9:00 a.m. to 5:00 p.m. (Lunch will be provided at the house so that the group can work through the day.)

*Work with photographer to make your fabulous creations shine! Photography has been donated and will take place on Friday and first thing Saturday (to use daylight lighting for your designs).

*Prepare and deliver to Sharon the **DESIGNS FOR SALE** price list of all the arrangements in the house noting the cost and sales price of each at the end of Friday. Please also note whether the item was given to the homeowner at cost or purchased by the homeowner at cost as well as what items are available for purchase by club members at cost or guests at the "marked-up" sales price. Please keep a copy of this list available with your cash box and use it to record purchases by tourists. Form: **Designs for Sale**

*Determine the day/time of unpurchased designs removal with homeowner.

*Participate in the Friday evening walk-thru of all the houses (7:00-9:00 p.m.) and invite your homeowners to do the same. Please make certain that a member of your team is at your house at all times during the evening walk-thru.

*Place price tags for each of the designs in the house that are for sale. Once a design is purchased, please collect payment (cash or check), remove the tag and record the purchaser's name and phone number on the Design Price List.

***STAFFING:**

**All team members are expected to work on Friday (9-5) decorating the house.

**All team members will perform one 3-hour shift as a docent on Saturday...please make sure all members are prepared to describe how the arrangements were made. It's the best way to close a sale!

**Please determine where docents must be to avoid any unfortunate incidents (e.g. – slip & falls; broken crystal, etc.)

**One team member/shift must have the responsibility for the cash box including final delivery of a balanced cash box with completed Designs for Sale to Sharon/Susan lies with the Co-chairs.

**One team member/shift should be in charge of booties/bags.

WHAT OUR EXTRAORDINARY HOMEOWNERS CAN EXPECT

Design Team Walk-Throughs

The Design Team typically walks through their home several times before the tour. This gives the Team members the opportunity to view the home and develop design schemes. With your permission, they make photos of certain parts of the home for planning purposes.

Set-Up

House History.

Built in 1928, this 4-bedroom, 3-bath home is a cottage-style Tudor Revival design. Typical of this style is the mix of brick and (fish-scale) shingles on the facade. Also traditional to the Tudor style is the steep-pitched roof, which proved popular in snowy Northeast America.

The front door features an unusual beveled glass porthole window. The wainscoting on the staircase is also seen throughout the living room. The family room addition was completed in 1990, along with a master suite on the second floor. The kitchen was updated during a 2014 renovation. Among the notable architectural elements is an elegant stained-glass window in the den with a central fleur-de-lis.

Theme: "Woodland Tidings"

Room by Room: At the **Entry**, a rustic old St. Nick and his pet fox set the mood for the woodland theme, inspired by the homeowner's love of birds that she has incorporated into her decor. The **Dining Room** theme will include trees, moss, and ivy. Cylinder containers will contain layers of apples, balls, and lights. The **Living Room** will feature a grapevine swan containing greens and flowers/plants on a small table by the window. The Scandinavian inspired **Kitchen** will feature a birch log, an embroidered table runner, and a floral centerpiece with gnomes, winter animals, and birch candleholders. The main attractions in the **Family Room** will be Santa and the Christmas Tree, which will be decorated with felt cardinals, gnomes, rustic birdhouses, and lamb's ear ornaments. Greens and floral arrangements throughout the room will set the woodland tone for the coming holiday. Antique Lionel trains will stir memories of the 1940's. On the window seats, teddy bears will be reading Christmas stories to their young bear friends. Christmas presents, waiting to be opened, are decorated with woodland materials of pinecones, magnolia leaves, and arborvitae fronds.



The Home

641 Elm Street



House History

Built in 1927, the house was completely renovated in 2016, with a 1,500 square foot addition. As you walk into the foyer, to the left is the formal dining room and to the right, the formal sitting room. The continuous hardwood floors transition into the spacious, multi-functional kitchen that includes a breakfast room, a home office, and an oversized island. From the cabinets to the Subzero to the light fixtures, the kitchen was almost entirely outfitted with "re-purposed" materials. Only the countertops, backsplash, and cooking appliances were new. Other features are the quartzite countertops and the mosaic backsplash. The breakfast room and oversized mudroom have large windows with views of the lush yard. The living room opens to a large wraparound porch.

Theme: "A Magnolia Christmas"

Design Palette: Orange, lime green and metallics

Room by Room: At the **Entry** you will be greeted by a female manikin made with plant materials. A large diamond-shaped wreath will bring your attention to the door, with magnolias on light and posts. The **Living Room** features a tree with magnolia-pod angels ornaments. In the **Hallway**, the focus is on a garland with dried pomegranates on the banister. In the **Kitchen**, the key materials are kumquats and greens in wreaths, garlands, and in floral arrangements. The **Dining Room** picks up the house theme with Magnolia placements under dishes on table. In the **Family Room**, the tree ornaments are teal and apricot. On display are Santa and Nut Cracker collections. The **Mud Room** features four wreaths, decorated with dog biscuits made by the Juniors). The table tree will be decorated with apple-cinnamon ornaments and dog ornaments made by Juniors.



The Ross Home

1 Stanley Oval



House History

This 4-bedroom Colonial home was built in 1911. Gracing the front of the home is a wide, pillared porch with a terra cotta floor and a portico on the side. Multi-colored terra-cotta tile, leaded stained-glass windows, and hardwood floors are found throughout this home. Before electricity was installed, the house was powered by gaslight. The kitchen was renovated and a family room was added in 2012. Sixteen homes surround the Oval, which is owned and maintained by the homeowners. Historically, the Oval provided a campground for the Raritan Indians. Then the William Pierson Family farmed the land for generations. During the Revolutionary War, the Oval served as a military post with an arsenal located between Stanley Oval and North Chestnut. A cannon, with the loss of its right arm from a skirmish, was captured there and now stands today at Fairview Cemetery as one of Westfield's most famous relics.

Theme “Family Holiday Homestead”

Design Palette: Wine, Hunter green.

(The general theme of greens & pine cones and toys will give each of these areas a coordinated look.)

Room by Room: Entry: The front door wreath accented with children's toys sets the tone for what's to come. The family traditionally decorates a Christmas tree on the porch and hangs a sled from the columns. **Foyer:** Large Nutcrackers stand guard on the steps. **Dining Room:** The sideboard is decorated with large St. Nicholas figures set among greens. The centerpiece runs the length of table using Deep Red Roses. **Living Room:** The Main Tree will be decorated in handmade, childlike ornaments. The tree skirt border resembles train tracks; owner's trains will be displayed there. The five small end tables will each have a distinctly different motif using silver and wine colors. Children's toys will be integrated into the overall whole. **Kitchen:** A gingerbread carousel will be a highlight of the kitchen. Also featured will be a hazelnut wreath, fresh arrangement in a soup tureen, and table settings with tree and toy motif. A low, running centerpiece will utilize pomegranates among the greens. Hanging Pinecone and nuts will drape from the window. **Family Room:** The coffee table will be decorated with a children's toy truck filled with appropriate flowers and greens. A small table tree will follow through with the toy theme. End tables will be decorated with children's toys.



The Ferguson Home

540 Highland Avenue



House History

The house was built between 1910 and 1915. Originally a center hall Colonial, the addition of a front porch by the current owner in 2004 has given the home more of a farmhouse style. In 2008 the owner completed an addition that created a spacious library and family room. The striking windows in the library are original to the home, having been removed from the home's former sun room and reinstalled in the new space. Another interesting feature of the home are the kitchen's pantry doors. They were originally the exterior doors of a neighbor's home, acquired and repurposed by the Ferguson family when the neighbor removed them in order to complete an addition to her own home.

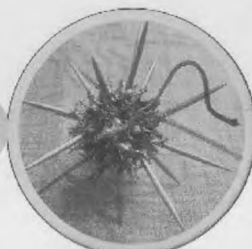
Theme: "From Farm to City Christmas"

Room by Room: **Entry:** Homeowner's metallic farm animals are to be decked out in sprigs of greenery. Planters will be wrapped with burlap and ribbon and filled with greens, branches, and winter berries. Wreath of fresh limes and lemons will lead you into the home. **Dining Room/Butler's Pantry:** Accents will be lime green and lemon yellow. Greens and flowers will set off a burlap table runner, with homeowners white and blue china. Lime green napkins will be shaped into mini Christmas trees. Burlap wreaths on the windows will echo the runner. **Kitchen:** Farm elements and furniture in red, white and blue will burst with accent colors as above. A gingerbread house will be on the island, and the homeowners red and white enamelware will be on the counter. The Hoosier cabinet will contain a glass vase with branches and berries, and twigs forming a triangle shaped tree strung with ornaments. **Family Room:** An old-fashioned tree will be decorated with stitched animal ornaments, gingerbread ornaments, animal cookie cutters with ribbon, and a handmade chain. The mantel will display topiaries and pomegranates. **Office/Library:** The hot-pink desk will be accented with Lily Pulitzer colors of lime green and hot pink, along with a holiday floral arrangement. Three unique arched windows will be festooned with garlands of greens, pink and lime green ribbon, and fruit. Floral boxes will be made to look like wrapped gifts. The hallway will contain spray-painted, tree-shaped tuteurs. **Living Room:** Decor is contemporary country, in colors of ivory, pale yellow and hints of green. A tabletop tree will have white and gold decorations incorporating natural elements with a touch of glitz. Topiaries will bracket the fireplace, and 3 window wreaths will echo those in the dining room. The hall mirror will be accented with a pinecone decoration, and white flowers and greens will set off the newell post

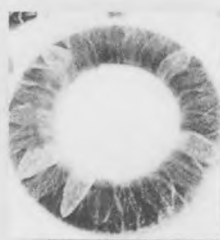
