REPORT TO THE PEOPLE

Hundreds of Lee County citizens will gather at the Fort Myers Exhibition Hall patio Friday, September 15, to hear a "Report to the People" by the county's state legislators.

All residents of the county are invited to enjoy a welcome home party for our lawmakers from 3:30 to 6:00 p.m. Citizens will enjoy free refreshments and rub elbows with many other local officials as well as our State Senators and Representatives.

Combined with the social and personal contacts will be serious discussion of governmental problems faced by this year's Legislature. In record-breaking continuous sessions spanning from early January to late August, the legislators have not only dealt with Florida's complex problems of today but have almost completed the work of revising the State Constitution.

The members of Lee County's delegation to the Legislature have been in the forefront of these accomplishments. Each of them will speak briefly on one feature of the Legislature's work.

Rep. Ted Randell, who began his service in the House of Representatives in 1964, emerged as a seasoned veteran this year. He is recognized as an authority on the manifold problems of conserving our natural resources. The law he drafted for protection of tidal lands received state-wide acclaim. He will discuss on Friday some of the pitfalls which have beset his efforts to protect Florida's shore lands.

Rep. Lorenzo Walker, a 12 year veteran House member, served this year in the key position of Speaker Pro Tem. His diligence in spending long hours to facilitate the orderly flow of legislation has stamped him as one of the most effective members of the House. He will explain the difficulties encountered in getting a law passed to prohibit purse seining for the protection of the small-scale local commercial fisherman.

Sen. Jerry Thomas was voted most outstanding freshman member of the House in 1961, and then repeated as recipient of the most outstanding award when he entered the Senate in 1965. This year he is chairman of the Agriculture Committee, vice chairman of the Ethics Committee, and a member of committees on appropriations, Banking, Rules, and Water Conservation. At the coffee he will outline some of the possibilities for better government which can come from the new Code of Ethics.

Sen. Elmer Friday, member of the upper house since 1962, has achieved a position of prominence which causes his name to be mentioned when almost any important vacancy arises in state government. He served on the interim commission which conducted state-wide hearings to prepare a draft of the proposed new Constitution. 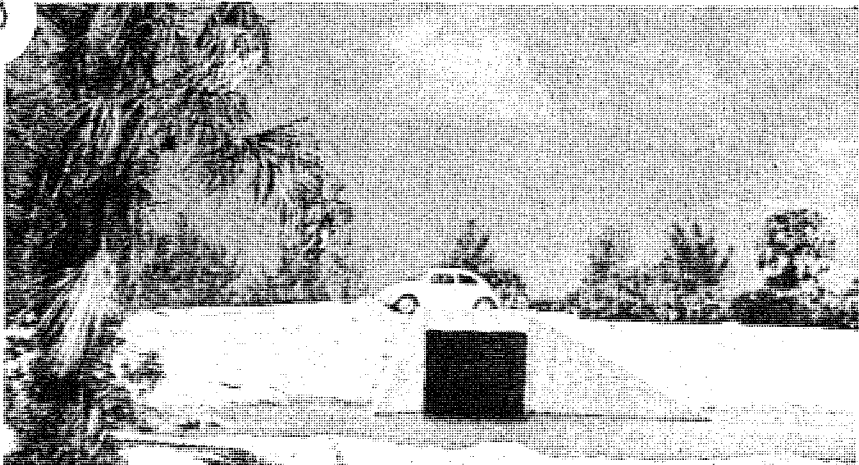

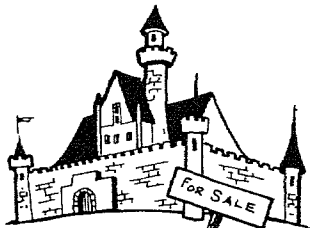

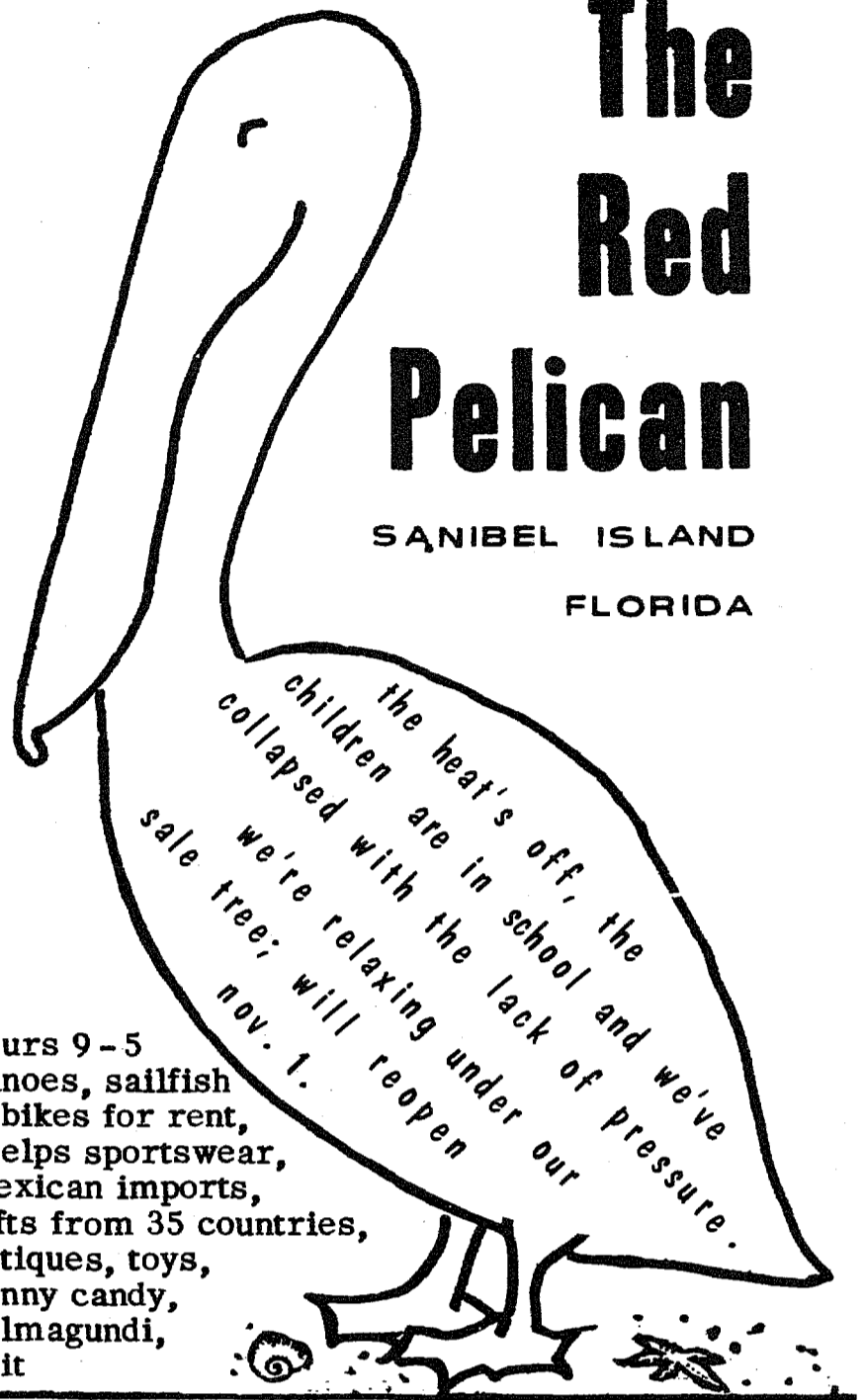

SEA CHEST

Do you remember a half fable they used to teach us in grammar school? It goes like this: Christopher Columbus had an idea that the world was round and that he could go east (that is, sail to China) by going west. Everybody thought he was crazy because everybody thought the world was flat and if you sailed a ship too close to the edge, you'd fall off and be lost forever.

Isn't that about what you remember? The same sort of fable is being taught in school today.

Why is it a fable? Scholars knew for centuries before the time of Columbus that the earth was round. They even calculated its diameter (with remarkable accuracy).

What Columbus set out to do was PROVE that the earth was round. He failed even in this since he had to return the same way he had come. It was Magellan who in the end proved that the earth was round by circumnavigating it. He isn't given credit for this, though. He was merely the first to circumnavigate the earth.

I'm not trying to detract from Columbus' accomplishments. . . it took a lot of guts to do what he did. He was an excellent sailor and navigator. What is bothering me are the distortions that creep into our history.

Remember the MONITOR and the MERRIMAC? First ironclads in history, right? Nope. A French ironclad, the GLOIRE, was the first ironclad. The MONITOR & MERRIMAC were the first ironclads to engage each other in battle.

How about the SAVANNAH? We named the first nuclear powered merchant ship (not the first surface ship) after the first SAVANNAH which we were taught was the first steamship to cross the Atlantic. The first steamship to cross the Atlantic was a Canadian ship whose name escapes me at the moment. The first SAVANNAH was a sailing ship in which a steam engine had been installed. She used her engines only about three days in the whole trip which

took more than a month. The engines were removed later because they were of so little value and the ship continued in service as a sailing vessel.

If you ask Navy men who invented the submarine, they'll usually give one of three names; John Holland, Simon Lake or David Bushnell. None of them invented it. Holland won a Navy sponsored design competition in 1888. While Holland's submarine was being built for the Navy, Simon Lake was demonstrating his submarine, the PROTECTOR, by diving and surfacing it through the ice off Newport. The Navy pretended not to notice, but the Russians did. They bought Lake's submarine.

David Bushnell built a submarine called the TURTLE out of barrel staves and iron. He propelled it by turning a hand screw. This was in 1776, a long time before either Holland or Lake. But even at this time more than two dozen successful submarines had been in operation.

When we have a right to brag a little, we sometimes fall down on the job. The first submarine to sink an enemy ship, for example, was the Confederate submarine DAVID. It sank the heavily armed Union ironclad, HOUSATONIC, in 1864. You never see this in school history books.

I consider myself a student of marine history and it accounts for all these marine items. It makes you wonder how much of the non-marine history is similarly distorted.

Taxpayers Ask IRS

This column of questions and answers on federal tax matters is provided by the local office of the U.S. Internal Revenue Service and is published as a public service to taxpayers. The column answers questions most frequently asked by taxpayers:

Q. -- The amounts I claim for business travel and entertainment expenses are being questioned. What records do I need to back them up?

A. -- Generally speaking, you must be able to produce records to establish each of the following: (1) the amount of the expense; (2) the time and place; (3) the business purpose, and (4) the business relationship of those entertained.

A receipt or other documentary evidence is required for each travel or entertainment expenditure of \$25 or more, with certain exceptions. IRS Publication No. 463, "Travel, Entertainment, and Gift Expenses," outlines the rules for deducting these expenses. You can get a free copy by sending a post card to your district director.

You may want to look over this publication before you have your audit interview. It will also be helpful in maintaining your expense account records currently.

Q. -- I just sold my house and had to pay a penalty on my mortgage since I paid it up early. Can I deduct this penalty when I file my tax return next year or do I add the penalty in as a cost of selling the house?

A. -- The penalty for paying off a mortgage before the due date is considered an interest charge and should be included with your other interest payments when you itemize deductions. This penalty is not to be included with your selling costs.

Q. -- I was granted an extension of time to file my return. I sent the return in last month with what I owed but now I get a bill for interest. Doesn't the extension of time take care of that?

A. -- No, the extension of time excuses you from the penalties for not filing a timely return. The law requires interest to be assessed on taxes that are not paid when they are due and this cannot be prevented by obtaining an extension of time.

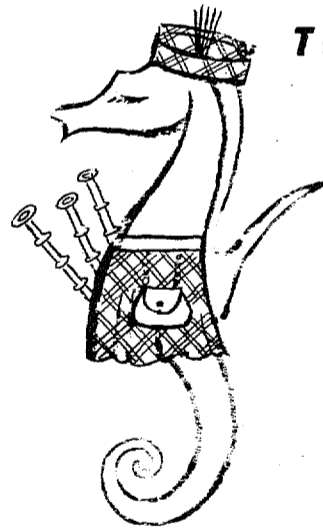
Q. -- My uncle has been our dependent for several years. Does the fact that he just turned 65 give me another dependency exemption?

A. -- No. You are entitled to one exemption for your uncle when he qualifies as your dependent. His age does not give you an extra exemption. This extra exemption may be taken only on a taxpayer's own return when he or his spouse is 65 or over.

Q. -- What kind of records do you need to establish a theft loss? Our house was broken into while we were away on vacation.

A. -- To establish a deduction for a theft loss you must: (1) show the date the theft was discovered; (2) show the property was stolen and not lost or mislaid; (3) establish ownership; (4) show evidence of value of property; (5) show any amount taken or allowable for depreciation; and (6) show the amount of insurance or other compensation for the loss received or recoverable.

The unreimbursed amount in excess of \$100 is deductible for each theft of non-business property.

SCHOOL BUS LAWS

The Florida Highway Patrol wants to remind motorists that school buses which are moving traffic control devices are back on Florida highways and appealed to drivers to be alert for the State's most precious cargo - our children.
"The big yellow school

buses with their cargo," said Colonel H.N. Kirkman, Director of the Department of Public Safety "should be treated with the greatest care at all times by all drivers on our highways."

The Patrol Chief went on to say, "Motorists knowing and obeying the school bus laws and regulations help prevent school bus accidents because the rules are designed to provide maximum protection for school children traveling to and from their schools and a minimum of interference with the movement of traffic."

Florida's traffic laws require motorists in both lanes of a two-lane highway or all lanes of an undivided four-lane highway to stop for school buses when the flashing red light goes on and the red stop arm is extended. However, on dual highways with a dividing strip of more than five feet or a physical barrier, it is not necessary to stop for a school bus in the opposite roadway across the divider.

Wherever you meet a school bus - whether it's in the city or on the open road - use caution. Remember to Give The Kids The Brakes.

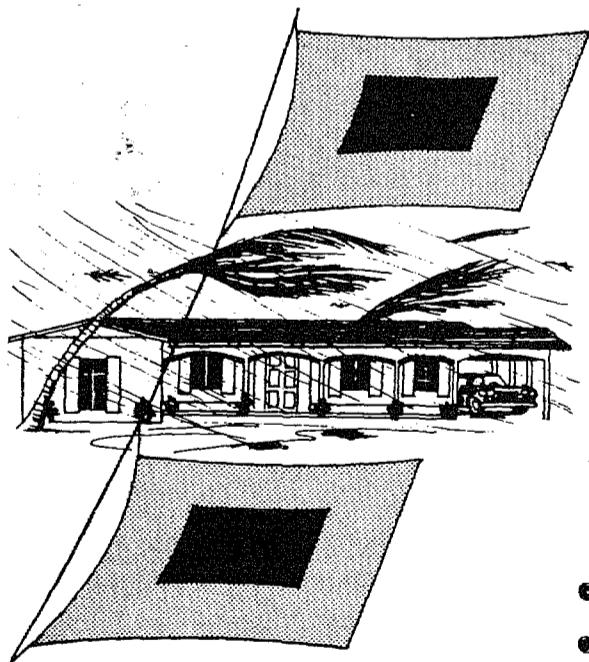
