CHAMBER OF COMMERCE

The Sanibel-Captiva Chamber of Commerce was founded by a few far sighted, energetic, honest and hard working men and women in January of 1955. The organization was then known as Sanibel-Captive Islands Business Association. The office was located in the Sanibel Community House. "The Sanibel Community Association" gave the Business Association a spot free of charge to operate in. Both organizations worked hand in hand in solving Island problems as they arose. The Islanders showed an active interest in everything that went on. The regular and sometimes "special" meetings were held in the simple democratic way typical of those days. Difference of opinions were many and varied. The meetings would sometimes last well past midnight. Some were really rip-roarers; but after each one, the Islands had taken another step forward towards regulating its growth and development in a manner we could all be proud of. The unselfish way the people of the Islands have contributed their time and talents over the years is certainly commendable. When the going got rough, they always came across with extra effort, etc. to get the job done. As to the tremendous amount of work involved in getting the office work out and on time in the past, I humbly say to you all, that without your help it just could not have been accomplished.

Let me put down a few things that were done gratis for your office by some of your members; typing of all sorts, answering mail, knocking out the weekly bulletin, folding form letters, folding maps, stuffing brochures, maps, letters to mail, stamping letters, envelopes, etc., change of telephone number on all literature, packaging brochures and maps in bulk. These are mailed to places in the United States, Canada, Mexico, South America and other countries. A lot of this work was done in their homes and returned to the office. There are many other things, too numerous to mention.

The shrubbery around our building was planted by a group of members and helpers. Another member brought a crew in to do the floors, windows, etc. Other members installed curtains, rods, etc. Another member contributed a man and a machine to plow and cultivate the entire lot. And so it goes.

In March of 1962 the Association changed its name to the Sanibel-Captiva Chamber of Commerce.

Advertising has increased greatly over the years and everyone profits accordingly. We run newspaper ads in various cities, such as Chicago, New York, Philadelphia, Cleveland, Orlando, Miami, etc.

Visitors signed in and interviewed at your office during the fiscal year 1967 - 1968, totaled 52,200. Letters of inquiry received and answered for the same period totaled 5,529.

The total amount of brochures distributed from your office for the fiscal year 1967 - 1968 were 93,800. The total amount of Chamber of Commerce maps distributed for the same period was 67,350. This is just a part of the job your Chamber of Commerce is doing for you.

You are the "Chamber of Commerce" and have done a tremendous job through the years and I am proud to have been a small part of it.

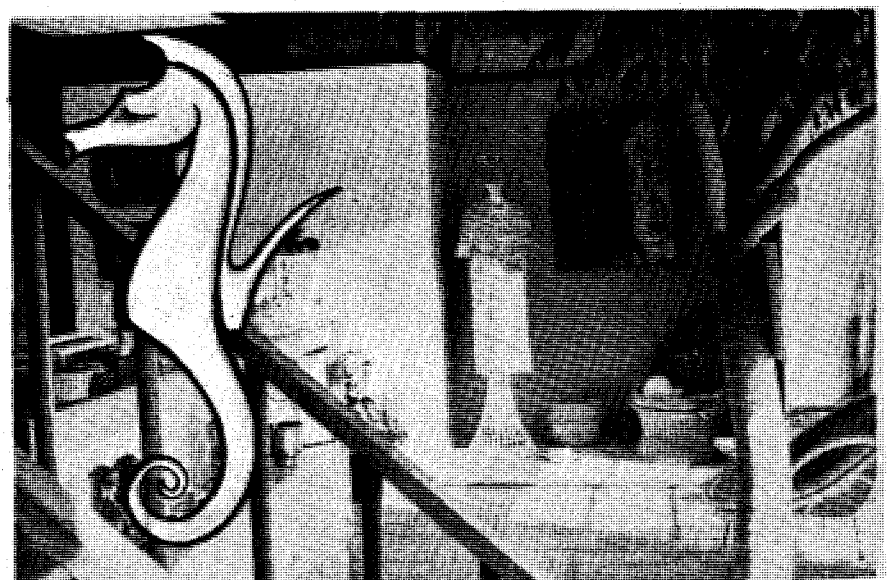

CHRISTMAS MAILING DATES AND INFORMATION

Christmas cards sealed or unsealed require 6¢ postage now. Enclose a slip of paper in each parcel listing the contents and the name and address of the mailer and addressee in case outside

wrapper becomes detached.

There will be no delivery of Christmas cards or letters or gift parcels other than special delivery on Christmas Day.

Parcels for Armed Forces overseas going via surface transportation should be mailed by November 9th, earlier if possible. Those going via SAM (Space Available Parcel Airlift) by November 23rd, via PAL, not later than November 30th, and via Air-mail by December 11th.

Gift parcels for distant states should be mailed before December 2nd to insure delivery before Christmas. Gift parcels for local and nearby areas should be mailed not later than December 14th.

Greeting cards for distant states should be mailed not later than December 11th and those for local delivery not later than Dec. 16th.

Mail for Alaska and Hawaii via surface should be mailed not later than December 2nd and air-mail not later than December 16th to insure delivery before Christmas.



CAPTIVA LIBRARY

The Captiva Library now has a collection of LP recordings to be loaned on the same basis as books. These discs are the gift of the RCA Corporation and interested patrons. They range from popular numbers through musical comedies and Christmas albums to the classics.

In addition, it has access to larger libraries through the interlibrary loan system. Books may be borrowed from any library in the Lee County system. The Florida State Library, from which the Captiva Library regularly borrows, is linked by teletype with the Jacksonville and Miami Public libraries so that Captiva borrowers have available to them many more volumes than are actually shelved in the local library.

ful pink birds, that have almost totally disappeared from the scene. Old timers, still living, remember when parrots and parakeets were as common in Florida skies as Blue Jays and Mockers. Egrets were common through South Florida and could be seen feeding along our lakes and streams as far north as Ocala and Tampa.

Then my lady decided she must have egret plumes to adorn her person. With the dollar sign glistening in their eyes, the poachers entered the picture and the egret became almost extinct.

Florida alligators never bothered anybody who didn't bother them, but the public demand for alligator bags, shoes and accessories made their hunting a profitable venture and, while we have belated laws for their protection, they are fast disappearing.

Your grandmother and mine were indirectly responsible for this wanton destruction of wildlife. Although they would be horrified at the thought, it was their desire and demand for feathers to decorate their silly hats and person that made poaching profitable. The same holds true for the women of a later date who gloated over their alligator bags and shoes.

But worse was the murder of Florida wildlife officers who gave their lives in their effort to protect our wildlife and enforce the laws intended to insure their survival.

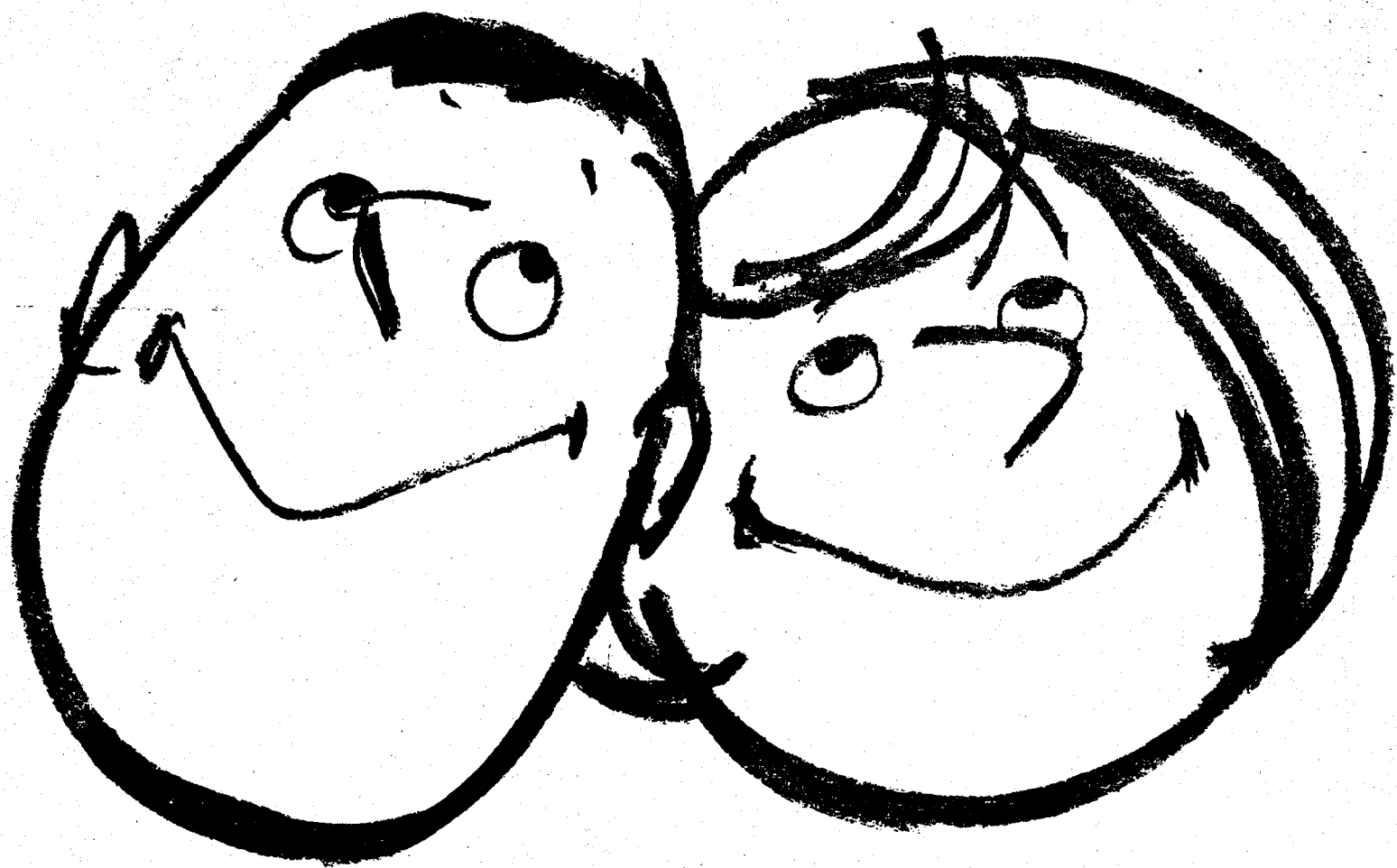
In the Everglades you will find graves of Florida game wardens who sought to protect the egret, among them were Guy Bradley, murdered by poachers in 1905 and Columbus McLeod another warden murdered in 1908.

Today women no longer provide a profitable market for tropical plumage, but they still crave adornment that calls for the killing of other types of wildlife that are fast becoming extinct.

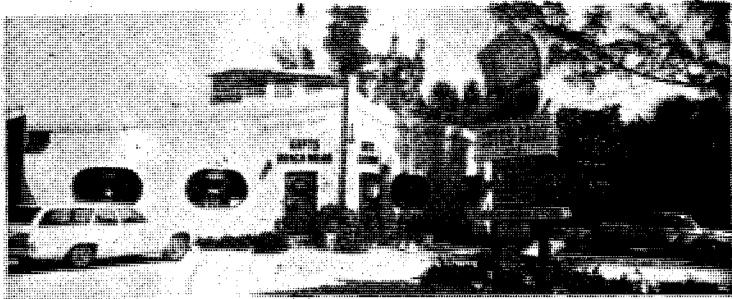
The scene has switched to Africa and Asia where poachers are hard at work killing tigers, leopards and other animals to satisfy the vanity of silly women.

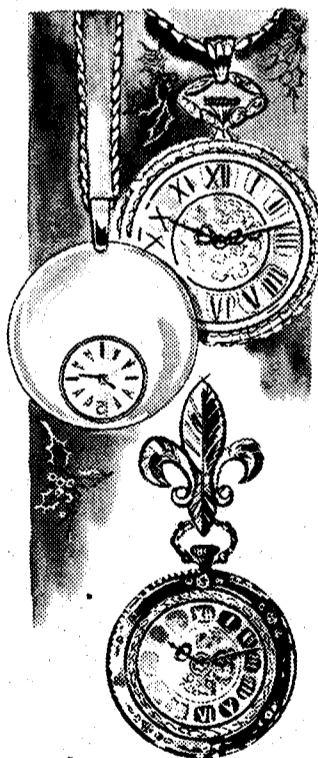

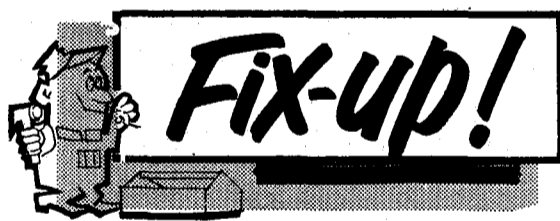

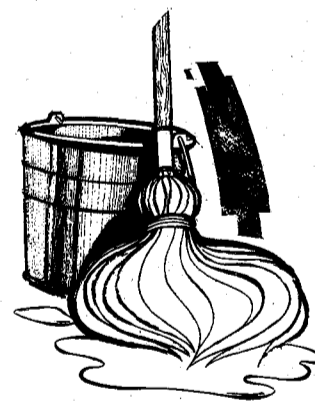
