


SANCTUARY EXPANDED




City Planned Communities, one of South Florida's leading land developers, recently announced plans for the new center. It is planning a "super-regional" mall with access from Dade, Broward and Palm Beach counties. The firm's chief executive officer Herbert Sadkin, has already begun negotiations with four major department stores and two specialty department stores for locations in the space-age shopping center.

Tri-County Mall has already been keyed as one of the largest to be developed in the Southeastern United States, and one that will include every up-to-date innovation ever used or planned on being used in a shopping center in this country.

Some of these innovations stagger the imagination, such as moving sidewalks, the entire project completely air conditioned and covered, vertical construction and others still unrevealed. Everything is being planned for the comfort and convenience of the shopper. The retail area will include an enclosed mall area of over a million square feet. The Mall location will be on


Commercial Blvd., one of the main east-west intersections of Ft. Lauderdale running from the ocean westward, and on University Drive, which, when the State Road Dept. finishes its program, will run from NW 27 Ave., in Miami northward to Plantation, Lauderhill, Tamarac Lakes, Coral Springs, and Boca Raton right into and along side Florida Atlantic University in Palm Beach County. In other words, the center's location will be a direct route from Miami to the Palm Beaches.

Sadkin, who does not select shopping center locations by chance, apparently knew what he was doing when he selected the Tri-County Mall site. In the immediate area Haft-Gaines, a leading South Florida developer, recently announced a \$500 million apartment and townhouse community, and Ken Behring and Jackie Gleason also have new
