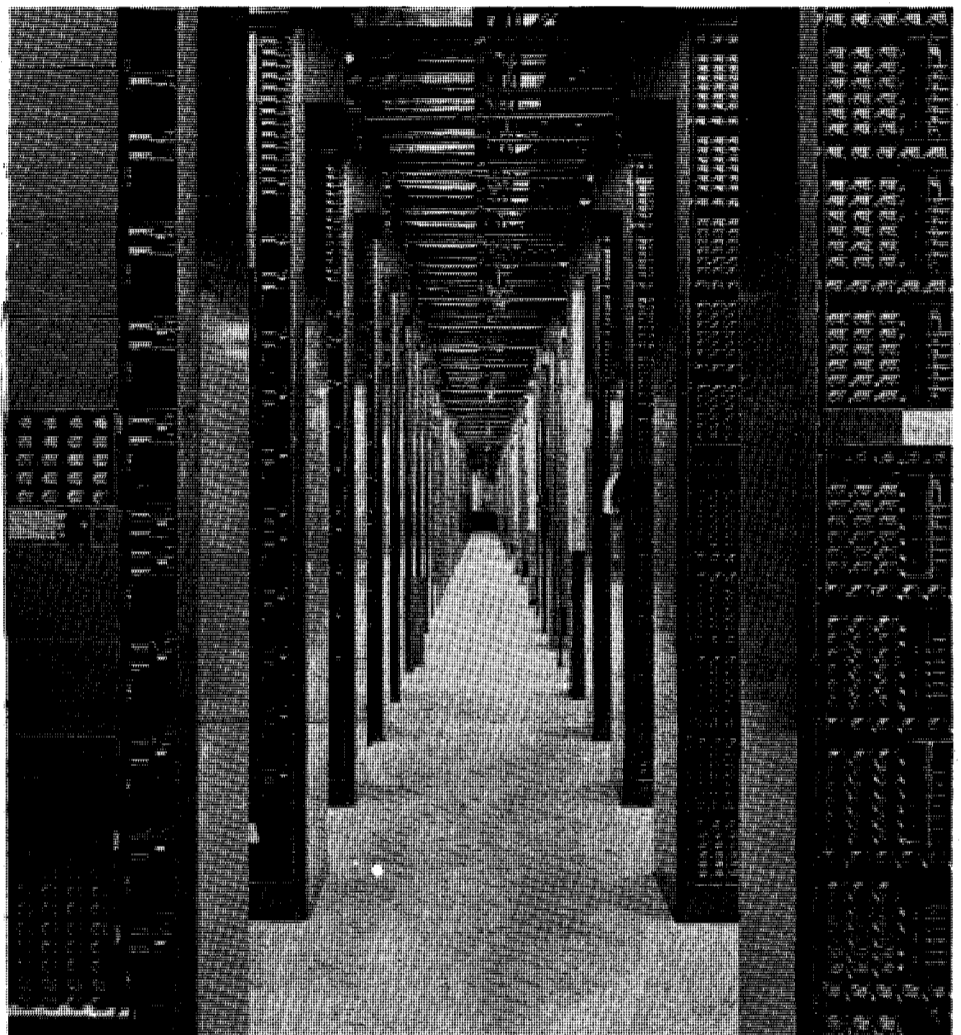
## NOTICE

## WHAT IS UNIQUE ABOUT YOUR ISLANDS?

What is unique about your islands? Well, certainly not your shells! You can find most of the same species on the coast of Texas. Most of them live on the Carolina coast as well. I have even picked up the same species on the coast of Brazil. There are a few endemic species, but these range all along the southwestern Florida coast from the Tampa Bay area to the Keys. Even the nine armed starfish, which many local residents have thought to be unique to the southwest Florida coast, is named *Luidia Senegalensis* and was first described, more than a century ago, from the coast of west Africa. It is a wide ranging species found on both sides of the Atlantic. Well then, what is unique about your area? I would say that you have a very special environment. Sanibel lies at the southern end of a chain of barrier islands formed by the sea after sea level rose to its present position several thousand years ago. The islands end with a big sand spit, Sanibel Island, at the edge of deeper water. Sanibel faces south, not west. So what you have is an area where the southward flowing currents form an eddy, and this area is extremely favorable for the growth of marine bivalved mollusks. This is self-evident as many of these clam and scallop shells get washed up on the beach.

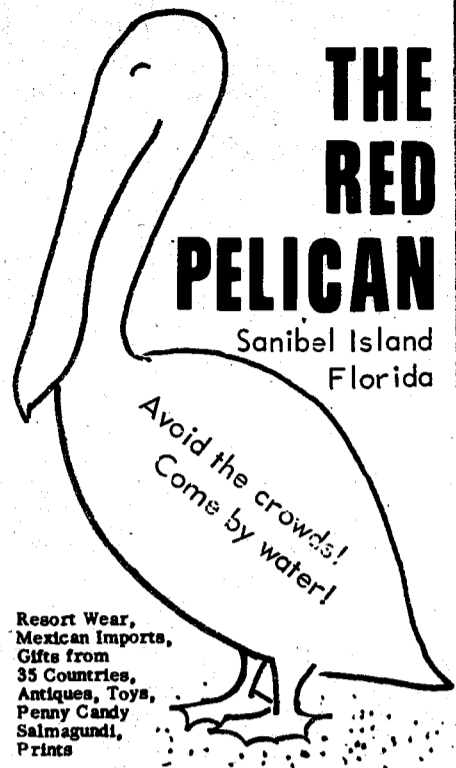

## ANNUAL REPORT

The office of Joseph P. D'Alessandro, State Attorney, 20th Judicial Circuit, Lee Collier, Charlotte, Glades and Hendry counties, has issued the following case-load report for the fiscal year, July 1969 through June 1970.

**PURSE SEINE MEASURES BECOMES LAW**

Representative Randell announced the passage of the entire package of purse seine bills for five southwest Florida counties.

Randell stated that the purse seine control laws which recently were passed in Tallahassee will prohibit the use of purse seines for the taking of menhaden or trash fish within 10 miles of the shore line along Lee, Collier, Charlotte, Sarasota and Manatee Counties. Sports and commercial fishing interests have for many years attempted to have these control measures passed by the Legislature. In his pleading for passage before the Legislature, Randell argued that industrial fishing, making use of purse seine nets, is not compatible with the established sports and commercial fisheries. The many concerned citizens who urged Randell to introduce the legislation were aware that the industrial purse seine was highly detrimental to such fish as snook, redfish, trout and other food fish. Randell stated that the fish meal industry, dependent upon the huge purse seines, would now have to operate at least 10 miles off shore along Florida's southwest coast.



6 slices fillet of flounder.  
Salt  
Pepper

1-10 oz. can Frozen cream of shrimp soup  
1/3 cup dry sherry

Heat oven to 325 F. Sprinkle fillets lightly with salt, pepper and Accent. Arrange fillets on an edged cookie sheet covered with aluminum foil. Place unopened soup can in hot water for ten minutes. Pour soup into a small saucepan; add sherry and cook over moderately low heat (about 225 F.) until soup is melted, stirring constantly. Pour over fillets. Bake 30 minutes, or until fish flakes with a fork. Serve with rice, if desired. Serves 4.

### WHAT IS UNIQUE ABOUT OUR ISLANDS?

And, of course, where you have a great many clams, you also have hordes of hungry gastropods that feed upon them.

You have a great area where young and old can walk the beaches and collect many species of mollusks. This is the best area in this country to collect shells, and only a few places around the world can compare with it.

Now, the question we should ask is, can anything happen to this beautiful setup? The answer, I'm afraid, is yes!

This area -- both Sound and the shallow Gulf close to the beach -- are part of one ecosystem. If Pine Island Sound falls victim to the developers, and the bay bottom is dredged and filled and the shoreline bulkheaded, you will have a slab-sided Sound in which sea grass and most algae will be unable to live. Large numbers of mollusks, as well as other animals, live in the shallow grass beds, and once the sea grass is gone, so are the mollusks. Builders of large apartments and hotels also like to build right on the beach. After this is done, a small amount of erosion can remove what beach is left. This has happened to Miami Beach, and now there are long stretches where the Atlantic crashes into a concrete bulkhead and there is no beach to walk on. Hopefully, this will not happen at Sanibel.

If Pine Island Sound falls prey to grandiose schemes of development, it will be ruined as an environment for many plants and animals. It will also affect the shallow marine environment adjacent to the beach on Captiva and Sanibel. Mollusks are generally a pretty hardy lot, but they can be discouraged and forced to move further offshore. You would still have some mollusks here, but the number of species would be reduced, perhaps as much as one half or more.

So, my advice is to band together, fight fiercely, and protect the environment that you still have here today.

long distance and also extended area service (E.A.S.) calls. Hundreds of additional "trunks" (channels) will expedite toll calls from here across the nation. Better access within the eight-exchange greater Fort Myers E.A.S. dialing area will also occur after the July 12 "cutover" say local telephone spokesmen.

United Telephone technicians have each had more than 1,000 hours experience working with the new switching and toll ticketing systems. This includes special training courses sponsored by North Electric Company, the system's manufacturer, which also assisted in equipment installation.

Intensive installation and testing operations have kept the new center "on target" for the cutover, according to Norm Doving, United Telephone's major project manager. "More than 700,000 local test calls and approximately 30,000 trunk tests have been completed over the past eight months," he said.

The new office says Doving "is one of the largest toll switching centers in the United Telephone System which has companies operating in 21 states."

New telephone directories --- about 65,000 of them --- will be distributed to Lee and Charlotte County subscribers during the period July 3 through July 11. The directories will contain information concerning new dialing changes and also new numbers which have been assigned to subscribers in several area exchanges. These include Fort Myers (present Edison exchange), Pine Island, Sanibel-Captiva and Fort Myers Beach.

### MEYER TO ATTEND AMU CONVENTION

Maude W. Meyer who represents the Sanibel-Captiva Shell Club on the Advisory Board of the Sanibel-Captiva Conservation Foundation, has been asked to serve on the Conservation Committee of the American Malacological Union. The organization meeting will take place at the AMU Convention in Key West the middle of July.

Co-chairmen of the committee are Dr. Ruth D. Turner of the Museum of Comparative Zoology at Harvard who has done much work for the U.S. Navy on

the work being done, and Anne B. Speers who was at the Welder Wild Life Refuge in Sinton, Texas and is presently with the Houston Museum of Natural Sciences in Houston, Texas. To date, the fourth member of the committee is Dr. Dolores S. Dundee, Department of Biology, Louisiana State University, New Orleans, La.

The program will be aimed at utilizing members of the many Shell Clubs in gathering data (not shells) and in working with local conservation groups. Since the clubs are scattered, many in the coastal areas but a number far inland, the program will have to be a broad one for the present and the problems encountered will vary from club to club.

### ISLAND GARDNER

The warm summer weather can bring on some devastating effects on bushes like crape myrtle and roses, says the Florida Nurserymen and Growers Association (FNGA). One of the worst diseases that attacks crape myrtle at this time of year is powdery mildew. Powdery mildew is a fungus, but it is explained as a plant with no coloring that feeds on another plant. Some pathologists may take exception to this statement, but it is given as a loose definition of any fungus.

Powdery mildew attacks the young tender growth, turning the foliage a grayish white, and causes disfigurement of the leaves and flower buds. It may inhibit

flowering of your crape myrtles and roses.

The fungus itself thrives on cool nights and hot, humid days. It is scattered by tiny seeds or spores which float on the air currents and finally land on your favorite bush. One of the best controls for powdery mildew is Karathane or Acti Dione PM. Two other controls can be used from time to time, but caution must be observed with reference to the temperature. If the temperature rises above 80-85 degrees there may be some burning of the leaves. These two materials are sulphur and phaltan. It is advisable to use these materials only when the weather cools off or it is extremely cloudy.

# matt tanza's memories

Hello Folks!

My son is a very friendly fellow and whenever there is a gathering of the clan his greeting on arrival is "Hello Folks." I like it.

Back when I was going to college in the "Twenties" Gimbel Bros. was a big department store in New York City. It still is. In those days they maintained their own delivery service and I delivered for them a couple of summers.

They maintained a depot in Westchester County and I worked out of that depot. We delivered in big "White" trucks.

One of the places we delivered to was the quay in New Rochelle where the launches took off for the Island Yacht Clubs in the sound.

I used to think what wouldn't I give to belong to one of them and ride out to the Club in a launch. Years later, I joined one of the clubs and rode back and forth in the launch.

I acquired a small boat and observed all the beautiful houses along the shore with their private docks and their boats moored to them.

I thought what wouldn't I give to have a waterfront property and my own dock. I have that now -- here in Florida. Will the reality prove as bright as the dream?



## SHRIMP-EGG CASSEROLE

- 1 Tbsp. margarine
  - 1-1/2 Tbsp. flour
  - 1-1/2 cup skim milk
  - 1 tsp. Dijon-type prepared mustard
  - 1 Tbsp. minced green onion
  - 1 Tbsp. minced parsley
  - 2 Tbsp. minced green pepper
  - Dash of cayenne
  - 1 tsp. lemon juice
  - Salt and pepper to taste
  - 1-1/4 cups peeled cooked shrimps
  - 2 hard-cooked eggs, diced
  - 2 Tbsp. grated Parmesan cheese
- Melt margarine in saucepan over low heat. Blend in flour and cook about 1 minute. Gradually add milk and cook, stirring, until smooth and slightly thickened. Add remaining ingredients, except last 3, and simmer 3 minutes. Carefully fold in shrimps and eggs. Pour in broiler-proof ramekins or baking dish. Sprinkle with cheese and broil about 3" from heat 3 to 4 minutes, or until hot and lightly browned. Makes 5 servings.
