Fishing Pier Approved

The Coast Guard has given the Lee County Commission permission to construct a fishing pier on Sanibel Island, County Administrator Lavon Wisher said Friday.

Mrs. Wisher said she had been contacted by Cmdr. L. A. White, of the Coast Guard's Miami district office, last week and was told a new pier could be built on land near the Sanibel Lighthouse at the eastern tip of the island.

The pier will be a joint project between the county and the U.S. Department of the Interior and will be constructed near the old fishing pier on Sanibel that was condemned last year.

In granting permission to build the fishing pier at Sanibel, the Coast Guard will retain its ownership of five acres it owns at the Sanibel light.

Mrs. Wisher said the Coast Guard did not indicate specific sites it would consider for the relocation of the rescue station, although the agency did indicate earlier this month a Punta Rassa coice "might be acceptable."

Shell Fair Today

What promises to be the biggest and best of free Shell Fairs opens today on Sanibel at the Community House. The affair which has grown from an insular "country" fair has burst into astomical proportions, with people and judges from all over the world, and persons entering their exhibits from all over the world, as well as local shell collectors. Thirty five years of growth is marked by this year's fair, which is recognized by professionals and amateurs as one of the nation's foremost competitive events in the exhibition of world-wide rare and spectacularly beautiful shells.

There are live shells in their native living environment on exhibit that are always fascinating to watch, and this year's exhibit of living shells and sea life promises to be as great as in preceding years, despite the fact that many of the living shells in the area have been decimated by the Red Tide, a deadly situation in the waters surrounding the islands last summer, but it is as old as recorded history, having been mentioned in the Bible, and all are hoping that the live shells will promulgate and replace themselves in the living cycle of sea life in and around the islands.

In the beginning of shell fairs, school children received the first ribbons for their shells but in the past ten years, the fair has grown to where it is recognized even internationally, and large crowds have gathered on the islands to participate.

Sanibel Community House was open to professional photographers last night after the judging of the exhibits, and the winners will be announced today at 10 a.m., with reporters and photographers being permitted in from 9 till 10 to photograph the exhibits before the crush of viewers makes this an impossibility.

JUDGES

William E. Old, Jr., a recognized malacological authority and curator of the "American Museum of Natural History" in New York City is one of the judges. Mrs. Germaine Warmke, noted author of shell books and an authority of no mean merit, is the other judge. Mrs. Warmke was Oceanographer at the University of Puerto Rico and has won all sorts of honor and recognition in her field.

AMATEUR PHOTOGRAPHERS ADMITTED FRIDAY

Friday morning from 9 until 10 a.m., amateur photographers will be admitted before the doors open to the general public, so that they may take photos of the exhibits again before the crowd impedes. Your camera is your passport to this early admission.

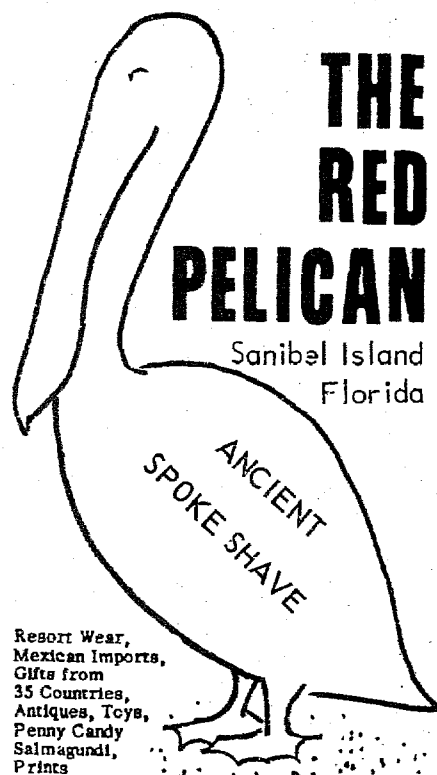

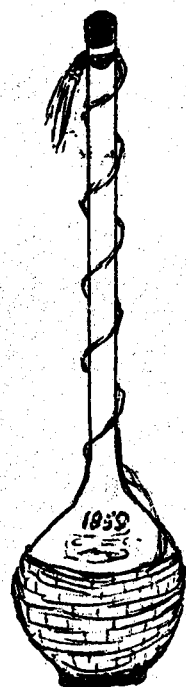

LETTERS TO THE EDITOR

TO THE ISLANDER:

Why is it that our County officials are so reluctant to recognize the nature of population density and come to grips with its reasonable control?

Did they ever see a slum or ghetto that wasn't densely populated? Did they ever hear of an area that grew out of hand in population density that didn't need roads, water supply, sewers, and other public services beyond the ability of the inhabitants to pay? Or did they ever see a rowboat that could stay afloat with stem to stern and gunwale to gunwale people?

In all my life, I have never seen such foot-dragging as goes on in Lee County officials over establishing for Sanibel and Captiva Islands a reasonable control over land-use density.

I suspect the "County Fathers" must have an inkling that already we are running out of privately-financed drinkable water on the Islands. Since they continuously have costly consultants to tell them, they surely are somewhat aware of the effects of a growing population density and are planning expensive public sewer and highway systems in an attempt to side-step the sure results of over-using the land.

My questions are: Why don't the Commissioners come to grips with the cause so as to eliminate the effect? Do they think that absentee land developers will volunteer to control building density? Do they collectively believe that it is un-American to limit the

number of passengers in the rowboat? Or do they agree with Developer Knudsen's philosophy that is inherent in his below quoted remarks at the Feb. 23 hearings on height and density proposals for Fort Myers Beach: "My understanding is this is a free enterprise system where we don't frown on those who are trying to make an honest profit." He also dubbed the proposed controls the "beginning of non-recognition of private property."

Fae has worked hard for three years on the Shell Booth and should be given a big hand for her contributions to the Shell Fairs. In fact, I am going to take more lessons from Fae in Shellcraft when I come back to the Island next year. She is a wonderful

teacher and generous person. I also understand that Fae collects and stores shells all year for this event, which is a job. Bravo to you, Fae, sell those Sanibel Shells, we're for you!



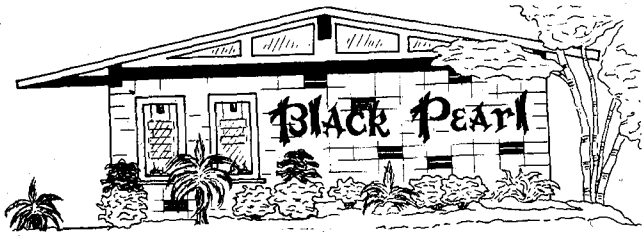

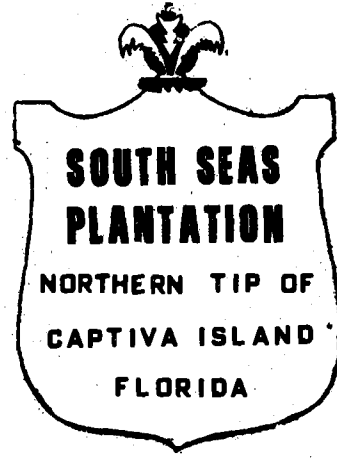

THE BATTERS BOX

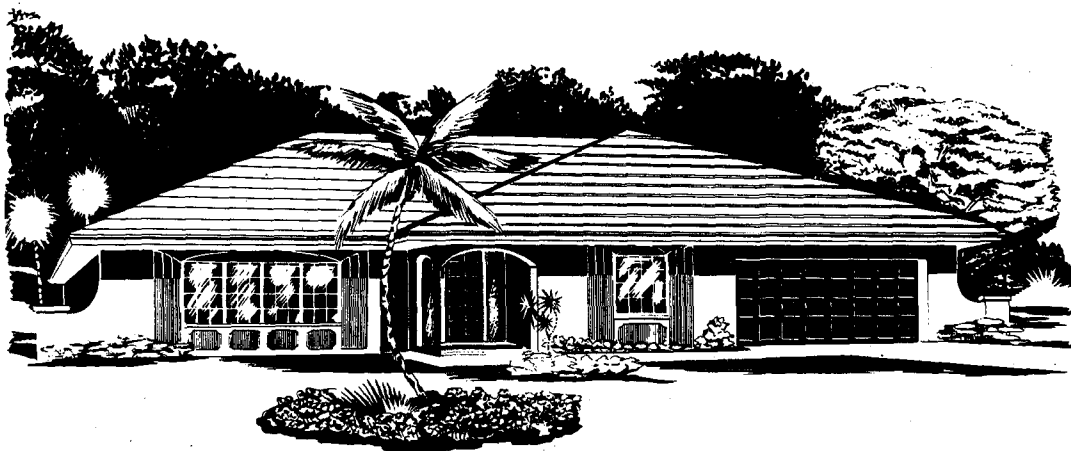

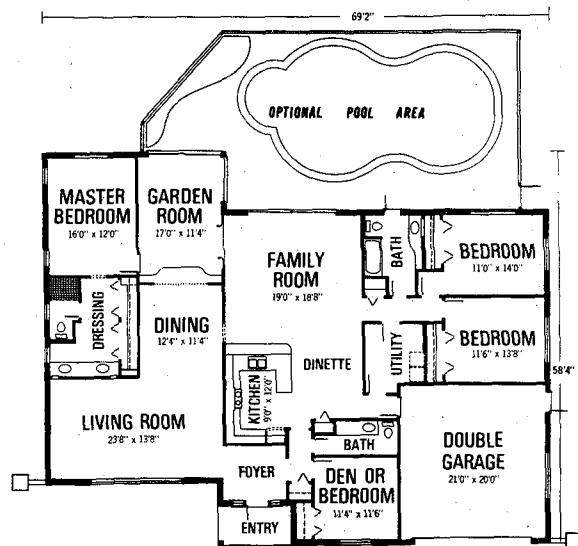

A lovely shell table filled with over \$500 worth of Florida specimen shells donated by a large group of individuals and shops on the Islands will be awarded to some lucky holder of the winning ticket, which has been on display on the island while sale of the tickets goes on. The table is truly a work of art, having been fashioned by Charles LeBuff from Naples, who is a cabinet maker extraordinaire. The woods used in the table are Hawaiian Koa and African mahogany, seasoned to perfection, and then worked into this work of art, with guaranteed safe delivery to any city in the United States. And the winner does not have to be present. Tickets may still be purchased from any member of the Community Association or any business listed in the Shell Fair booklet, as the drawing for this table will not occur until the last day of the Fair.

COMMUNITY ASSOCIATION SPONSOR FAIR

The Sanibel Community Association sponsors the annual Shell Fair and also sells tickets for the shell table and generally acts as liaison between all island community groups and organizations, as most of them developed as a result of the Community Association, which erected the present building and also maintains. Allied community organizations who are involved in the Shell Fair are: The Chamber of Commerce, the Public Library, Volunteer Fire Dept., the Wildlife Sanctuary, the Audubon Society, the Shell Club and the Island Improvement Association, not to mention the many local shops and businesses.

The Community Association is interested in all projects of community welfare, and they sponsor programs of community interest and effort, with monthly meetings and non-partisan forums which include programs about ecology, planning, conservation, better government, community health, safety and child welfare and a growing interest in the older person too. Many other community organizations and groups use the Community Association for their meetings also, and the building is in almost constant usage.

The Community Association has been stressing the conservation of many vanishing species of island sea shells, which as aforementioned, were drastically curtailed by the Red Tide. Also, indiscriminate collection has wreaked its toll on the living shells, and it is urgently requested that collectors do not take more than two of any live specimen of small shells, and only One of the large shells such as conches or whelks.

PEOPLE'S TROPHY

A new trophy has been added to the Shell Fair's judging for the first time, and true to democratic tradition, persons 15 years old and up will be eligible to cast a vote of their liking for a single shell, a special display or several shells. And the winner will be picked by popular vote of those attending, and his or her name will be placed on a plaque which will be on display in the Community Association Hall.

OUTDOOR ART EXHIBIT

One of the main features of growing popularity and interest is the outdoor art show. The works are original and painted by residents of Sanibel and Captiva or visitors to the islands, and they will be on exhibit and for sale throughout the fair. They have attracted artists from all over who come to view the lovely collection of rare artistry. Many of the pictures are sold, but even if you cannot be a buyer, you can come and enjoy looking at these works, many of which are painted by artists of some renown.

DRIFTWOOD SHOP

Many people have been working all year on this popular project featuring handmade gifts and useful items for general use and enjoyment. There are some lovely driftwood pieces and novelties and also some wonderful and delightfully delicious homemade goodies from the shelves of islanders who specialize in unique delicacies such as calamondin marmalade, sea grape jelly, guave jelly and on and on.

Dare to be different and try some of these marvels at this one chance of a whole year, and we guarantee you will be agreeably surprised. And there will be refreshments offered for the hungry, with chairs for the weary too.

Last year, school children competed in four categories, with Kevin Vellake capturing the Sanibel Community Association cup. Mrs. Such won a trophy for her self-collected island shells. Helene Eker captured a prize for her one large shell family display. Gladys Rodriguez won for her miniature and juveniles showing. The coveted Dupont Trophy for Florida Shells in 1971 went to Jo and Rusty Bennett. A first time exhibitor, Chip Chippeaux, won on his Foreign Shells exhibit, and Shell of the Show for her large shell was won by Eugenia Wright.

Results of this year's judging will be announced in next week's Islander.

Last year, the ecological study by high school students which detailed wetlands' life and ecology won wide acclaim, and there will be more such exhibits of high calibre and interest, particularly along conservation and ecology preserving lines, and the "Ding" Darling Memorial Sanctuary and the Audubon Society will again be showing some very interesting and beautiful displays, plus all kinds of shell craft exhibits.

WILDLIFE NOTES by griffing bancroft

Mrs. Dorothy Mendinhal is back on the islands banding birds. And if the rest of her stay is as successful as her first day, this may well be a record year.

With her mist nets up only a few hours, Mrs. Mendinhal banded a total of 78 birds of eleven different species.

By all odds, the highlight of this first day was an American Woodcock. This bird had been located on Sanibel in courting display by two skilled ornithologists, Charles Newell and George Weymouth. It had never before been reported on the islands and never seen in courtship flights this far south.

Mrs. Mendinhal netted it, banded it, displayed it to guests at the Island Inn and returned it, unharmed and apparently undisturbed, to its courting ground.

Other birds banded on the first day were: ground dove, 13; red-bellied woodpecker, 2; mockingbird, 1; catbird, 8; white-eyed vireo, 1; myrtle warbler, 11; palm warbler 1; red-winged blackbird, 1; cardinal, 33; towhee, 6.

Of particular interest is the fact that in a few hours 33 different cardinals were captured in one back yard. We are accustomed to seeing cardinals around our feeders, but seldom more than two or three at a time.

We tend to think these must be the same birds all the time. We are beginning to learn that often there is a constantly changing population.

Three of the birds were what they call "returns," that is, ones that had been banded before. Two were ground doves with bands Mrs. Mendinhal had put on them a year ago. These are resident birds so this is not so surprising.

What was surprising was the fact that one of the myrtle warblers had been banded in the same yard a year ago. This bird is a long range migrant, nesting only in northernmost United States and Canada.

So, presumably, this tiny warbler had traveled hundreds of miles to the north and then returned to the exact spot where he had been the year before.

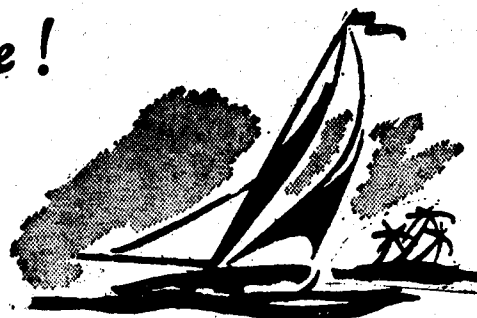

FLORIDA RED FLAG CHARRETTE PLANNING TEAM

The Southwest Florida Red Flag Charrette Planning Team met in Fort Myers at the Environmental Education Center, Saturday, Feb. 26, to locate the areas of critical concern in the region. "Charrette" is an architectural term which describes a concentrated, strongly focused effort toward a goal, while "Red Flag" is used as the danger signal, the sign of urgent action.

Five critical land use items were identified and mapped by the Southwest Florida Charette Team during the day of concentrated effort. These were: (1) areas which are now destroyed and which need to be destroyed; (2) existing critical areas; (3) future critical areas; (4) reserved lands, existing and potential; (5) lands appropriate for development.

Members of the team for Lee County include: Julian Hudson, County Commissioner; Roy Bazire, Sanibel-Captiva Conservation Foundation; Forrest Banks, civil engineer; Robert L. Barber, Director, J. N. Ding Darling National Wildlife Refuge.

General resource specialists on the team include William Hammond, director, Lee County Environmental Education Program; Thomas Provenzano, Florida Board of Trustees of the Internal Improvement Trust Fund, Fort Myers; Durward Boggess, U. S. Geological Survey, Fort Myers; William Moore, U. S. Forest Service, Fort Myers; Antonio Kayanian, International Planner, Fort Myers; James Anstis, A.I.A.

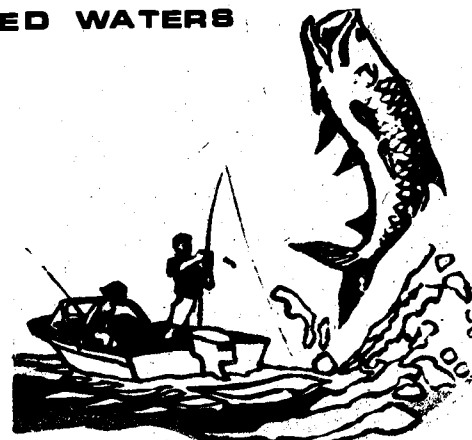

SANIBEL-CAPTIVA ART LEAGUE

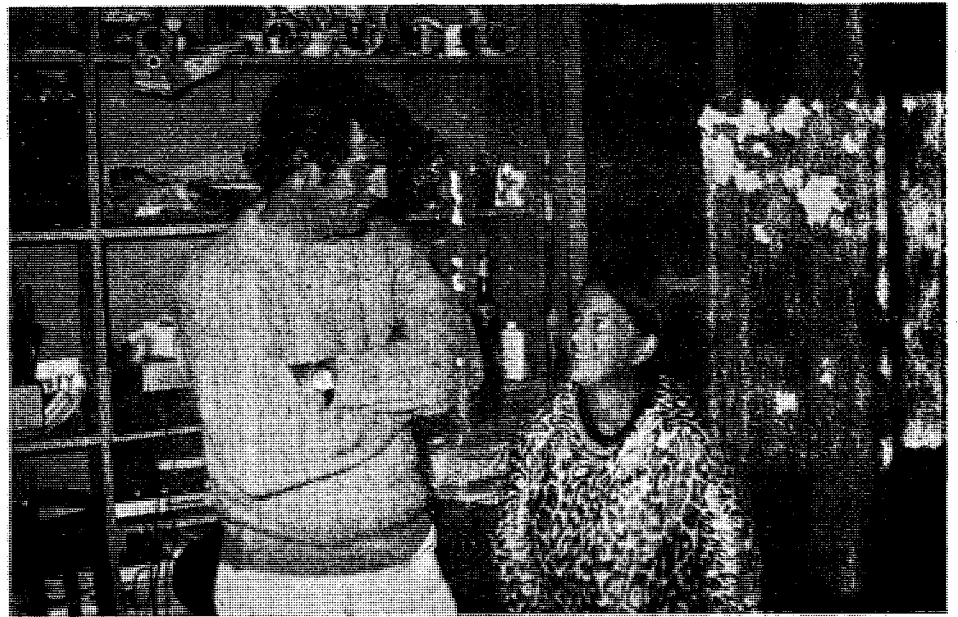

SANIBEL SIGN ORDINANCE

The Sign Ordinance presently regulating advertising on Sanibel and Captiva is the continuation of efforts made by the Islanders over many years to prevent visual pollution of their islands and preserve, for the enjoyment and pleasure of all, their unique, natural beauty.

The Ordinance has been in effect since Feb. 1, 1971 and its implementation is the duty of Lee County authorities. Several civic groups of the islands, Sanibel-Captiva Chamber of Commerce, Sanibel-Captiva Planning Board and Sanibel-Captiva Conservation Foundation, with the agreement of the County authorities, have formed a "Sign Ordinance Coordinating Committee" to help everyone on the islands and the authorities in the administration of the Ordinance. The committee has six members representing a cross section of the islands' residents.

The Sign Ordinance "in extenso" is available at the island Chamber of Commerce where it can be purchased for \$1.00. The sign committee has just completed a summary and has asked the Islander to publish it. It is not an official document or an interpretation of the Sign Ordinance; you are warned not to rely upon this summary alone in erecting or maintaining a sign, but must refer to the Sign Ordinance itself for the official regulation. This summary is intended only as a handy guide to the types of provisions contained within the Sign Ordinance.

SIGNS PROHIBITED BY THE ORDINANCE

(1) Banner sign; (2) Beacon light sign, a sign using a directed revolving or flashing light beam; (3) Flashing sign, a sign in which the light goes off and on; (4) Sandwich sign; (5) Billboard sign, a sign which is sold, rented or leased; (6) Snipe sign; (7) Animated sign, any sign including moving parts or changing lights; (8) Neon sign, a sign employing neon or lighting having a similar effect.

SIGNS PERMITTED ONLY IN IU, BU or RU-3 DISTRICTS

(1) Lighted sign; (2) Roof sign, a sign above the roof of a building; (3) Ground sign, a sign supported on the ground; (4) Marquee sign, a sign on a marquee; (5) Projecting sign, a sign extending more than 12 inches from a building, wall or structure; (6) Wall sign, a sign affixed to or painted on the wall of a building.

RESTRICTIONS ON PERMITTED SIGNS

(1) A roof sign may not be lighted or extend more than one foot above the peak of a roof; (2) No sign shall be erected closer than 30 feet from a district in which it is prohibited; (3) Maximum size of a sign shall be 100 square feet with height, width or

depth limited to 10 feet; (4) Lighted signs shall be shielded if located within 100 feet of a residential district; (5) The top of a ground sign may not be more than 35 feet above ground level; (6) No business establishment shall erect more than one sign; (7) Only signs specifically authorized by this ordinance may be constructed after Feb. 1, 1971.

No signs are permitted in EU, RU-1 or RU-2 districts.

EXCEPTIONS: (1) A platted subdivision may have one roof, wall or ground sign on a lot if the subdivision is entirely within EU, RU-1 or RU-2; (2) All signs shall conform to the Southern Standard Building Code; (3) No off premises commercial signs are permitted; (4) No signs are permitted at information or sales offices advertising sale of goods or services at another location.

MULTIPLE HOUSING ADVERTISING

(1) An outside sign advertising room rates is not permitted.

GENERAL REGULATIONS

(1) No one shall erect a sign on another's property without obtaining their consent; (2) No one shall put a sign on any tree, telegraph, telephone or power pole; (3) Erection of a sign in the above locations is not prohibited if done by federal, local or state government or by a quasi-public body (churches, non-profit organizations serving a public purpose and the Chamber of Commerce.)


REGULATION OF NON-CONFORMING SIGNS ERECTED BEFORE FEB. 1, 1971

(1) Every sign which does not comply with the above regulations is non-conforming; (2) All non-conforming signs shall be altered to conform, moved or removed by Jan. 31, 1974; (3) A non-conforming sign may be maintained until Jan. 31, 1974 but may not be structurally extended or altered except to make it more closely conform to this ordinance; (4) A non-conforming sign damaged or destroyed by Act of God or vandalism may be re-erected but shall contain the same advertising and not be enlarged; (5) The following non-conforming signs should be removed after August 1, 1971: Banner sign, a sign made of cloth, paper or fabric; Sandwich sign, a sign which is portable; Snipe sign, a small sign attached to trees or other objects.

EXCEPTIONS TO ORDINANCE

(1) Professional sign not exceeding two square feet; (2) Bulletin boards for public, charitable or religious institutions not exceeding 32 square feet; (3) Sign denoting architect, engineer, contractor or subcontractor of work under construction not exceeding 32 square feet must be removed 30 days after acceptance of the building; (4) Occupational signs not exceeding four square feet in area except on dwelling houses in BU and IU districts and in all AU and GU districts; (5) Memorial signs on buildings; (6) Traffic or governmental signs; (7) Inside business sign not designed to be visible outside; (8) Temporary real estate signs: a) located only on property advertised; b) in all non-residential districts size is limited to 100 sq. ft.; c) in RU-1, RU-2 and RU-3 districts size is limited to 2 sq. ft.; d) only one sign may be used on a lot with less than 100 foot frontage. On larger lots signs shall be 200 feet apart with a maximum of four signs regardless of the size of the parcel; e) signs shall be removed 30 days after closing of sale or rental of property.

The Sign Committee has already contacted a number of businesses which, without knowing it, had erected non-conforming signs; everyone of them readily agreed to follow the regulations and removed or altered their advertising to make it comply with the law. The Sign Committee has now started to ask some businesses to go a step further and limit their sign advertising even more than the law permits. It is hoped that the Committee will, there again, encounter the same unselfish desire from businesses involved to help the Islands keep their charm unmarred.
