

# Police Chief Appointed for Sanibel City

John Butler, 49, who has had 26 years of law enforcement experience as a patrolman, Lieutenant, Captain and Chief of the Mansfield, OH, police force, was appointed as the first Chief of Police of the City of Sanibel at Tuesday morning's City Council Meeting. The appointment was made by acting city manager Dave Bretzke, who selected Butler from 24 applicants. Bulter, presently a resident of Fort Myers Beach, assumed active duty yesterday (Wednesday).

Also during the morning session. Dave Bretzke reported that the City now had some actually earned income.

amounting to \$817.50, which was collected for 10 building permits issued by the City thus far--seven for single family dwellings, two for swimming pools, and a set of six tennis courts for Sundial Condominium.

County Commissioner Bob Whan attended the Tuesday session, said he planned to work closely with the City Council in the future, and that he planned to attend at least every other Council meeting. "By golly," said Whan, "we'll do everything we can to work with

He also reported that Sanibel Enterprises, the Hilton Hotel developers, has filed a countersuit against Lee County for an as yet unspecified sum in excess of \$100,000. He said that, to his knowledge, the City of Sanibel was not yet named as a defendant in the suite, but City Attorney Roger Barres commented that it was likely the City would soon be included since he (Barres) had received a notice of appeal from a Sanibel Enterprise attorney.

The Hilton Hotel matter was scheduled to be reopened as item #11 at 2:30 p.m. Tuesday afternoon (too late for the ISLANDER deadline) at which time Dave Scarboro was to present new information on the Hilton appeal. More on that next week.

Other business accomplished at the Council's Tuesday morning session included the Council's approval of an additional secretary for Sanibel City Hall, requested by Dave Bretzke, the authorization to begin to expand the present City Hall offices into the upper floor of the adjoining building at

Periwinkle Place, and an authorization for furniture for the new wing.

The Council also discussed a tentative proposal for bringing cable TV to the Islands with Gulf Coast Television of Lee County, a division of Palmer Broadcasting. Bill Ryan and Quane Fletcher of Palmer Broadcasting told the Council they presently have a request pending before the FCC for a 100 foot tower on Sanibel, which would receive microwave signals from the existing 500 foot tower on Pine Island. During the discussion, the question of the legality of such a tall tower was brought up, but no final decision was made since a formal application has not as yet been made to the Council. If the Council did grant such a franchise, the city would receive 3 percent of the gross revenues collected. The Council requested that the press announce that the Council would be grateful for any public input on the situation (that means, please write them a letter and tell them how you feel about it) and that public hearings would be held on it in the future.

Bill Damroth, chairman of the City Seal committee, reported that the committee had decided to make a conglomerate of ideas submitted to the committee, and the symbols of a porpoise, a palm tree, a pelican, a conch, and possibly the lighthouse, be worked into a large shell design with the words "Sanibel, Florida, Incorporated 1974" emblazoned upon it. This will be the Ceremonial Seal, not the official seal of the City, which will read "The City of Sanibel, Florida. Incorporated November 5, 1974. Official Seal."






Renee Wadkovsky - Sanibel







# Reel Eel Tips

It's nice to see the sun shining brightly once again with the shart cold spell last week, the sheepshead were plentiful. Small live frezen Teducated" shrimp were used as boit.

Speaking of fish. Mr. Leslie Merrell caught a 14 lb. snook off the Sanibel Causeway last week. One by one. those wonderful Florida game fish are being caught. Doc Ledbetter was there to weich him fight the fish for 15 minutes on light tackle and 10 lb. test. He was using a. No. 3 hook with live "scucated" shrimp. Both men are visiting the islands from Murireesburg, Tenn.


I've been having reports of black drum being caught under the Sanibel Causeway. This fish is of chunky size with a dark brassy metallic sheen. Dark bands mark the body vertically from dorsal to the off-white belly. The fins are black and numerous little beards extend from the lower jaw. These fish are usually found around the shoreline such as inlets, river mouths and beaches. Still-fishing on bottom is the method used for catching a black drum. They feed mostly over hard shell-bottoms. Their favorite foods are oysters, clams, mussells, crab and shrimp. The drum will strike slowly but gives a good fight once he is hooked.

Seems that many of our visitors mistake our ladyfish for a bonefish when caught. Their characteristics are actually

very different. The ladyfish has small scales and is silvery in color with a light green back. It is a siender fish with a pointed head and large jaws. The bonefish has a more silvery body with heavy scales and a smaller mouth. Around the islands the ladydish is being caught casting into the surf off the Gulf beaches using light tackle. This fish will jump as soon as it's hooked where as the bonetish never leaves the water.

Are you ready for the tip of the week? If you're fishing off your boat and there doesn't seem to be any fish around try chumming. It's like smelling fresh coffee in the morning and bacon in the frying pan. The fish get hungry and follow the stream of chum as it seeps through the water. Soon you'll have a lively fishing spot. Use your unwanted fish, put them through a meat grinder and toss it over. Even easier, use a can of sardines or fahy car food. Simply punch holes in it and hang the can over the side with apiece of line. Good luck and may the fish always be hangry!









#### SOUTHWEST CHAPTER OF USF TO HOST ALUMNI DINNER

proposed Causeway Bridge refinancing, involving the sale of eighteen million dollars worth of bonds. After a short prologue concerning the yearly increase in revenue from causeway tolls. Goss outlined a four point recommendation for the Commission's consideration.

Goss reported that roughly seventy percent of people who have crossed the bridge in the past year are either Island residents or businessmen, leaving only slightly over thirty percent of causeway commerce to tourists. Goss cited the fact that Periwinkle Way, from the causeway to Bailey's Store, was the 14th most congested area in terms of traffic in Lee County last year as another reason why Sanibel is entitled to its fair share of causeway revenues.

Goss requested that section 3B-4 of the amendment passed by the Commission last week be redrafted to give Sanibel 27 percent of the funds derived from bond sales, leaving 3

percent for the county to administer for Captiva and the other 70 percent for the county itself. He also requested that 27 percent of the net surplus after costs be given to Sanibel, and that the agreement be finalized by a court order, so that a future commission cannot change it by amendment or resolution. Goss also asked that the language of the resolution be tightened so that causeway revenues cannot be used for maintenance elsewhere in Lee County.

Lee County Attorney James Humphrey concurred with Mayor Goss's recommendations with only one reservation, this being that Sanibel's share of the net proceeds from the sale of the bonds be deposited in a trustee account under the control of the commission, rather than going directly to the city. This specification was due to concern for the: salability of the bonds, said Mr.

Commission Sayers expressed a desire to establish a practice of friendly cooperation with Sanibel city officials and asked Goss if the litigants would drop their suit if the commission accepted Mayor Goss's proposal. Goss answered affirmatively for all of the litigants except one, a non-Island resident.

Commissioner Whan made a motion to accept Goss's proposal to amend last week's resolution, subject to the agreement of the bond attorneys. which was passed unanimously by the commission.

Another matter of interest to Island residents which transpired at last Wednesday's commission meeting was the inquiry into the status of the Quillinan suit, which apparently has been in limbo since being filed in early 1973. Ex-Lee County Attorney Frank A. Pavese reported to the commission that he has been preparing diligently for the trial which is slated for March 25. Pavese showed the commissioners a number of aerial photographs and diagrams indicating that the disputed area of Turner's Beach was formed by accretion, and therefore should be county property rather than a sandbar belonging to the Quillinan estate, as Carol Quillinan avers.

# What makes Jade Green?

Iron imparts a green color to Nephrite, the original chinese jade. The more iron there is in the compound, the darker the green. Without iron, Nephrite is white (Mutton Fat Jade).

Chromium gives a green color to Jadeite, the Burmese Jade used by the Chinese since 1784. In this case, chromium is an impurity, present in small amounts. With enough chromium, a deep emerald green results, the color of Imperial Jade. Other impurities may give other colors to Jadeite including lavender, yellow, red, and brown in varying shades. Without impurities, Jadeite is pure white.

# How to Survive in Real Estate Lending Today


