Have you taken a look at the lovely homes on Rabbit Road? If you're house hunting there are really some pretty places still available on the island—don't despair just look around more.

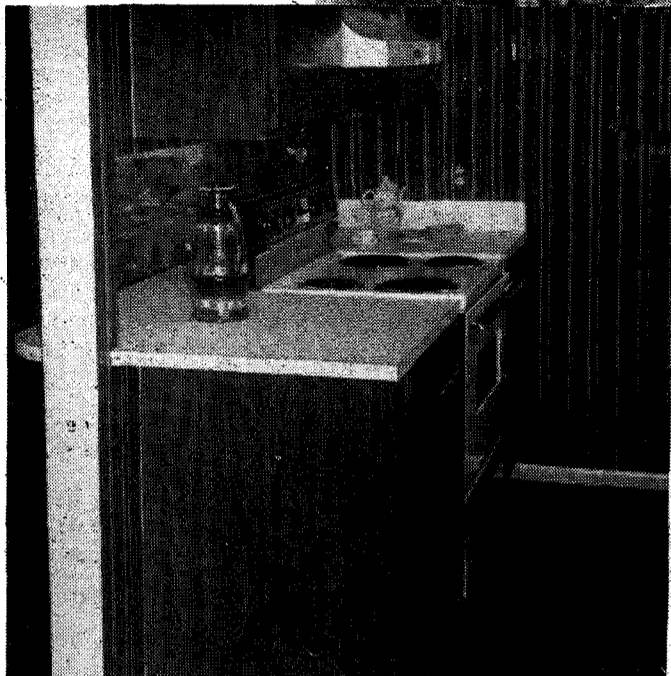
We're in the summer type pattern of weather now—80 degrees during the day with our thunderstorms in the afternoons. Plenty of time for beaching and fishing!

Blind Pass grand opening

Civilization has finally arrived on West Sanibel, in the name of Blind Pass, "Sanibel's finest condominium homes." Looking from outside in, the buildings which will eventually comprise 110 living units, 43 of which are now built, 33 sold, are two story brown frame structures with cedar shake roofs backed by ocean breezes whispering through tall Australian Pines.

The compound is located half way down Bowman's Beach Road. The entrance on Sea Belle Road was bedecked for the pre-opening of the condominium development with bicentennial flags. Inside the compound, each set of three buildings is built

around a courtyard of pools, greenery and a touch of island charm.

Two tennis courts, a large swimming pool and recreation building, in which are sauna facilities, will be at the disposal of all the residents of the development.

Four models, 2 bedroom, 2 bath, three bedroom, 2 bath and townhouse are on sale ranging from \$46,900 to \$51,900 with the monthly fees beginning at \$400.

The development was planned and built in concert by William Broeder and Stan Baumann.

Blind Pass is celebrating its official Grand Opening Saturday and Sunday, March 13 and 14 with an open house from 10 a.m. to 4 p.m. Everyone is welcome.

Police report

Looks like the word may really be getting around that Sanibel and Captiva are nice places to visit, but not nice places to speed. Only 22 moving violations, in the form of verbal or written warnings or citations—13 of them for speeding, four for regular moving violations (such as running stop signs, etc.) four for illegal or improper parking and one for improper equipment.

Four groups of campers were reported and/or found and asked to move to a more suitable place (which all of them did) two business alarms went off (one by the owner resetting it—new owner and new alarm) and the pesky business alarm which had been playing it really cool the past few weeks blew it all by going off 19 times—by this time, the SPD doesn't bother to write down WHY, just that everything was 10-4 when they arrived on the scene.

Calls for assistance and/or ambulances totaled 11; there were two accidents (one of which was reported on in last week's ISLANDER—the car which went off the causeway into four feet of water whose owner STILL hasn't been found) and one minor one; two pairs of glasses, one set of checks and one set of keys were reported lost or strayed, while one hunk of money (sizable) two wallets and three purses, contents intact, were turned into the SPD for safekeeping, most of which were returned to their anxious owners.

Three auto B&E's were reported (that's Breaking and Entering) and we ask you once again, please do not leave any valuables in your car, locked or otherwise, while you stroll for a moment on the beach. What's valuable to you is probably also valuable to someone else, so you're not likely to find your possessions where you left them. Carry your purse or attache case with you—the few extra ounces of weight you carry may make the difference between a happy vacation and a spoiled one.

Outside of that, it seems to have been a pretty calm week (outside of a few incidents here and there) on the Islands. Maybe everyone was so busy being happy at the Shell Fair that they forgot to be mean.

A suspicious small car was reported parked by a motel with one occupant, but with lights off, and then was sighted pulling into or around nearby condo with small trailer attached. GOA (Gone On Arrival).

A suspicious vehicle was reported—turned out to be a bike without any lights.

Red beaked bird with broken wing reported "flopping around under Blind Pass Bridge." Bird had white band on one leg, red band on other. SPD reported same to U.S. Fish and Wildlife.

Report came in of a man's lost wedding ring on the beach sometime in December.

Captiva businessman reported that unlocked car, containing purse, was parked in business driveway for over two hours.

Sanibel businessman complained that a certain car at a certain time every day goes around a corner on two wheels. The vehicle in question is designed to normally run on four wheels.

Young female reported sleeping illegally.

Lost mother found and returned home.

Assault (verbal) reported—officer talked to both persons involved—no further action taken.

Lights on and window open where they shouldn't be. Premises secured; no apparent damage.

Car reported in water (See last week's ISLANDER, Page 19).

Call came in that business utilizing heavy equipment was more or less illegally using his property and possibly had moved some of his trees.

Call came in that young person was driving golf cart on street and nearly caused an accident.

Abandoned motorcycle reported; had been there three weeks.

Somebody removed a box of furniture parts from trailer between toll booth and Chamber of Commerce; 22 minutes later box located and returned to owner.

Car parked on private property and then walked across other private property to gain access to beach. Talked to walker.

Call came in at early evening that "12 times motorcycles had been running up and down beach" but just got around to calling then.

Noisy motorcycle reported. GOA—UTL.

Couple reported lost dog; same recovered 36 minutes later.

Complaint came in that mother and two children were lost; same reported home safely 24 minutes later.

Other abandoned motorcycle found and impounded.

Person called in to report illegal cutting of mangroves.

Boater reported lost boat trailer license plate.

Calls came in of mailboxes moved by moving vehicle.

Call came in of suspicious vehicle, possibly foreign, as its headlights were close together, which turned lights on and off at strange times. Vehicle GOA—UTL.

Business person called in that people in "groovy" van parked on private property and "gave a lot of lip," as did "good-looking dude" evidently not connected with van people.

Dog reported hanging around motel for three days.

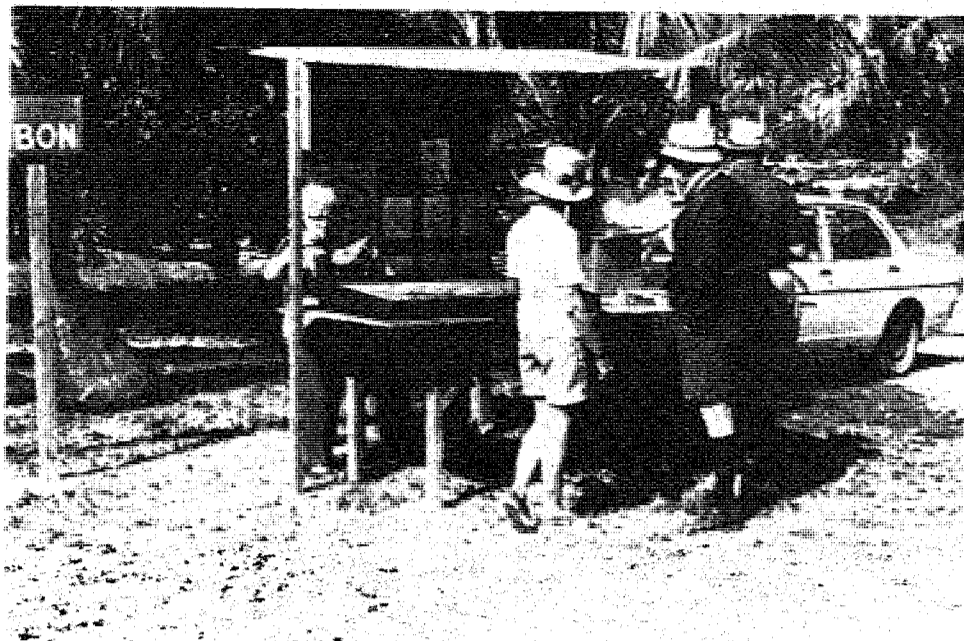
Real eel tips . . . by skip purdy

We couldn't ask for finer weather than the past week has produced. Even if the mighty anglers didn't pull in a fantastic haul of fish, they were still smiling.
Do you like to fish for spanish mackerel? They're being caught around the lighthouse end of the Island.

These fish are usually found in scattered schools offshore.
Live educated shrimp, small fish and squid will bring about some results.
When trolling from a boat use a feather jig or silver spoon tipped with a piece of bait.
The trout and sheepshead are still being taken readily.

The Sanibel Causeway seems to be a very productive spot for these particular fish.
Are you bothered by line twist? Many fishermen have this problem—my tip of the week is how to solve it. Simply remove the leader weights and hook and trail your line behind a boat in the water. Happy Fishing!

Poitical activity around Sanibel

Case One—denied

"It's been pointed out that there are a lot of nice people on Sanibel and a lot of nice people want to come to Sanibel." Councilman Butler said after Richard Brodeur, attorney, presented the history of the Beachview Cottages, pointing out that Pete and Ellen Bertram ran a family operation, their guests were long term visitors needing more than 500 square feet of "motel" type space which was part of the request to build four large duplex units on the Beachview property.

Brodeur said that his clients rejected artificial boundaries and asked council's consideration to look at the neighborhood instead and acknowledge the need to grow of the cottage complex. "We don't want to be prisoners to the plan," he said after asking for an adjustment in the density allocation on the Bertram property.

Butler said that "MORE PEOPLE (living on Sanibel) were in direct conflict with the plan, that she did not approve of septic tanks, that a sanitary sewer system was a must and therefore could not vote for the petition. Charles LeBuff agreed.

Francis Bailey asked the Bertram's to withdraw their petition. The mayor said that density was the main problem.

Elija Camp, attorney, commented from the audience, that he agreed with Councilman Butler saying, "If we're going to have a plan, stick to it."

Prof. Emeritis Wilson of Ohio State University spoke as one of the long-term Beachview guests as being in favor of Bertram's desire to improve. He added that 700 square feet of living space during a long cold

winter led to "cabin fever."

A letter was read from Malcom Beattie who expressed concern about "creeping commercialism" on the north side of Gulf Drive.

Bailey motioned to deny the petition without prejudice which was not agreeable with the other councilmen. "Without prejudice" was withdrawn. The motion to deny was passed unanimously.

Case Two—Continued until April 6th

The Tracy-Ridge Travel Trailer Park was continued by City Council in a continuing effort to give the Plan a chance to reflect the needs of a growing tourist population which moves around on wheels.

Alan Gold, attorney, asked the Council to examine whether travel trailer tourists could be kept out while council was "ardously struggling" to balance "public and private rights." He said that laws against camping and parking had been passed, that damage to the environment had been done because sufficient facilities had not been provided. He cautioned that governments should not through any action help create monopolies but "help to have good competition which is part of our country."

He talked briefly about mother and son. "They are hard fighting people," he said. "They have fought for Sanibel and have fought against Sanibel, but like anyone else in this country, they have a right to speak their minds."

The request to build a travel trailer park met the Plan's criteria, he continued. "Density allocations are a function of the text" and quoted Pages 1-103, 1-

3... tolerance of the ecological zone proximity to existing facilities and vested rights.

"The Supreme Court of Florida has determined that there must be a balance between public and private rights," he said. "One public body can't give rights and another take them away," he said talking about the existing Lee County permits already obtained in the past several years for the trailer park. "You may think you can ignore existing zoning, but we don't think so, especially when the Supreme Court has said you can't where vested rights are concerned.

Councilman Butler spoke to the issue of hurricane evacuation saying that the proposed trailer park would "put a lot of people unnecessarily in danger." She said that the recreational vehicles found parking along the roadsides were day trippers and agreed that Sanibel does not have adequate parking at beach access points.

Charles LeBuff said that he had all sorts of problems with the petition. He mentioned that Loggerhead Cay now stood on the site of the old Ridge property, that the Dunes Subdivision was now on the site of another trailer park, that the existing trailer park had been given permission to expand and that he was opposed to monopolies.

Francis Bailey asked the petitioners to withdraw the petition and wait for the Plan.

Mayor Goss said that it was "ill-advised to proceed with a travel trailer park now," and added that there was no doubt in his mind if all of Sanibel were travel trailer parks "We'd sell it out." He said that he did not agree with the Plan that there would be no more trailer parks forever but to grant a TTP now would be a "monumental injustice to

76-1." (76-1 allows for administrative relief while the Plan is being finalized.)

Gold took exception: "Why have 76-1 if you're going to turn around and say there's no relief route? When a man can't earn a living in this country, that is a hardship. The constitution not only protects private rights but the right to earn a living. The plan is a final guide. It's locked in stone. Don't tell us that we can change the Plan, that's misleading. What you're saying is we don't want travel trailers and that only certain tourists are O.K. We're here to reason. How do we solve the problem without destroying people along the way? Good people have a right to have their story told. Bosselman is a fine attorney, but he doesn't have to live with this Plan."

Butler said there was no Plan as yet and questioned if the petitioners would be agreeable to continue the hearing until the Plan goes to the State for review.

Gold replied if there would be a real opportunity for discussion all right, but if not, they would prefer to let the courts resolve the matter. He asked for a time limit of four weeks. Tracy asked if they could sit down with the planning firm, Butler asked where everyone had been during "innumerable hearings?"

She then motioned to continue the case until the 6th of April which passed on a 3 to 1 vote with Goss voting against. The matter, he said, was not going to change between now and then.

Cases Three, Four and Five Approved, Continued and Denied.

Edward Carmody won approval to build a single family home 2 feet landward of the DNR setback line on the Gulf in the Sea Side Subdivision. No questions were asked of Hugh Sarnes, attorney or Bill Frey, contractor. The Council agreed with the recommendation of the Planning Commission to approve the request.

Dave Holtzman's request was continued for further definition from WMRT of "motels," a clarification of whether the Planning Commission had approved the project as presented or a "concept" of the project and clarification of why the proposed restaurant was not advertised for hearing since it was drawn on the concept

sketches and asked for in the petition.

No specific date was set for the continuation.

The Herta Trost case requesting a Holiday Inn Motel and residential subdivision of 510 units total on 178 acres of land was denied.

Tax warrants

May 1st will be the day when holders of the City of Sanibel 1975 "warrants" may go to the Bank of the Islands, cash them in or renew them. The council passed an ordinance Tuesday, "appropriating funds from the 1975 ad valorem tax receipts to pay May 1975 series tax anticipation notes and interest accumulated thereon."

According to Mayor Goss the city must retire 10 percent of the warrants, which amounts to \$25,000, and that the city must bear the cost of printing new warrants of about \$350. The Bank will send a letter to the holders of the warrants sometime in April.

A continued hearing on the ordinance providing for the issuance of new warrants not to exceed \$225,000, will be held at the regular city council meeting March 30.

CPOOS

The Concerned Property Owners Assn. of Sanibel announce that Harry Schooley, Property Appraiser for Lee County, will be speaking at their regular meeting on March 9, at 7:30 p.m. at the Island Beach Club conference room.

The meeting will be open to the public and all interested residents and visitors are invited to attend. Time will be allotted for questions after Mr. Schooley's remarks. Mr. Schooley plans to comment on the impact of the Comprehensive Land Use Plan as it will effect assessed property values on Sanibel.

Sign

committee

The sign committee got down to the rewording of the sign ordinance so that it would be more enforceable and less of a chore to administer. Mary Johnson and Clark Newcombe had been asked to review

several paragraphs for consideration by city council.

One paragraph changed the setback for commercial signs from 25 feet to 10 feet back from the property line and to be located and designed not to be a traffic hazard.

Another revision would allow individual businesses in shopping centers to advertise but not in conjunction with the main shopping center sign. Another would eliminate the necessity of a seven day waiting period but did not eliminate the necessity of the sign review committee reviewing every sign application.

The committee felt that routine signs should be permitted by the city manager or designee and others of a non-conforming nature should come under the scrutiny of the committee. Mary Johnson recommended a three-member sign advisory committee for this purpose.

William Nungester, new city manager, suggested that a "Special event" section be included in the sign ordinance to cover permitting for special promotional sales not necessarily carrying a fee but allowing for special events to be advertised.

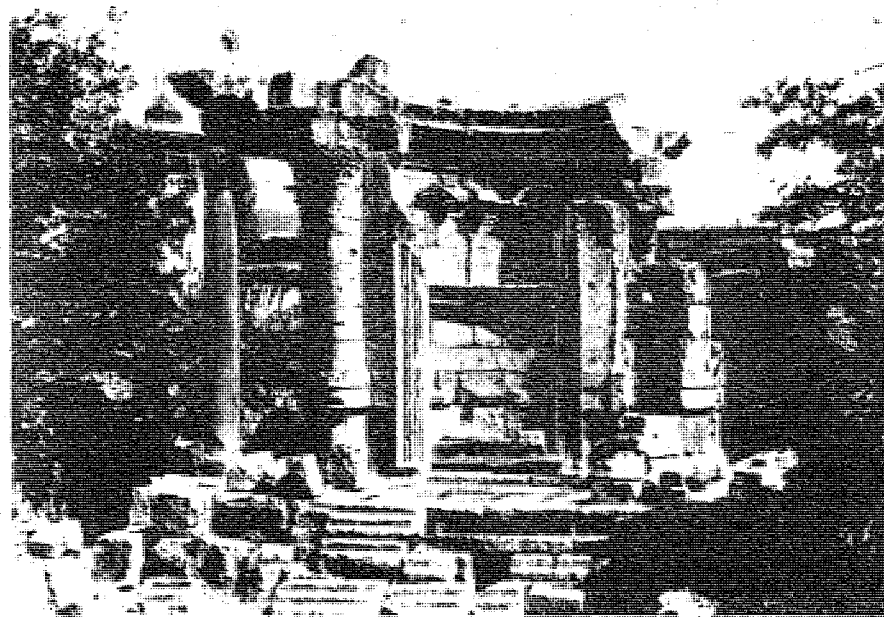
In discussing esthetics, it was not determined how the committee could govern the esthetic qualities of signs without reviewing every sign. Frank Vellake was asked to study the problem. Nungester suggested writing up criteria to be used by the person issuing conforming sign permits.

The Committee determined that the Yum-Yum sign was illegal because it was too high. The ordinance states that signs cannot extend above the roofline of a building.

Mr. Burn, resident of Ocean's Reach, requested a sign to take the place of the one on Casa Ybel. Maggie Klausmann informed Burn that the existing sign was illegal because it was an off premise sign and advised him to file an application but cautioned that it would be turned down since Ocean's Reach property does not extend to Casa Ybel, and that he would have recourse to request relief from City Council.

TO THE CITY COUNCIL:

I am here at the request of the Sign Review Committee whose members are: Myself, Chairman, Frank Vellake, Norm Chambers, Mike Peceri, Winifred Iurka, Mary Johnston and Clark Newcombe. At our last meeting on February 5th, it was proposed that the Committee tender its resignation as a body to the City Council. Although the Committee was making every effort to work under the provisions of the Ordinance, the lack of enforcement of this Ordinance made our position untenable and we felt that the injustice of the situation left us no alternative. However, the Committee felt that an effort should be made to acquaint the Council of our feelings before taking such a step.

As you know, a sign ordinance has been in effect since before incorporation. Upon incorporation the City Council adopted the Lee County Ordinance as an interim measure and appointed a committee with Resolution 75-5 January 28, 1975 to amend the existing ordinance. This resolution in part states: "Whereas, time is of the essence to prevent precedents to be established that may ultimately cause the Sign Ordinance to become ineffective and, Whereas, it is in the best interest of the citizens of Sanibel that the Sign Ordinance be promptly accepted and enforced!"

Although the Ordinance as it presently stands could be improved in simplicity and clarity and as we have worked with it we have found areas that need further changes it seems that the greatest stumbling block to its enforcement is the 25 ft. setback required for single businesses and the up to two weeks waiting time for a permit. I feel that the City Council at this time should immediately amend the Ordinance allowing single businesses the same setback as shopping centers and motels ie: Ten ft. from property line, with approval of Building Dept. taking into strict consideration as to safety per traffic hazards etc. It has been suggested by the Building Dept. that they be permitted to issue all permits that are legal under the Ordinance and refer other applications to the Committee for review and their recommendations for acceptance or denial forwarded to the Council as provided in the Ordinance at present. The Committee is not unanimously in approval of this suggestion. These items, I believe would permit immediate enforcement of the Ordinance and

allow the Committee members who have been appointed to rewrite the Ordinance and cover the other areas of debate. Secondly it has been suggested by numerous people that a Committee should pass on the aesthetic qualities of a sign as referred to in our charter and our present Ordinance:

"Whereas it is necessary to prevent proliferation of signs and to regulate their location and characteristics on Sanibel in order to comply with the mandate of the City Charter that the unique and natural characteristics of the Island shall be preserved."

However, a committee of this sort would have to perform as the present committee does and pass on all signs before presentation to the Building Department. I offer this for your consideration.

In closing I would like you to understand how very strongly this Committee feels about enforcement of this Ordinance. We have sat as a body and reviewed applications of responsible businessmen and women who have generally made every effort to cooperate with the Ordinance and they and we are constantly found with the fact that non-conforming businesses have been allowed to continue illegally with no enforcement by the City of its own Ordinance. We feel this is an injustice to these people and to the citizens of this City.

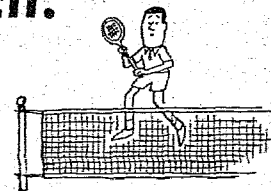

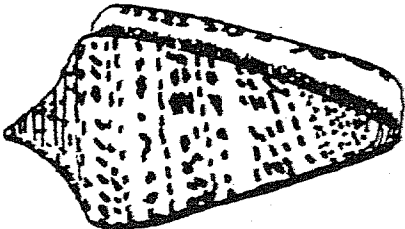

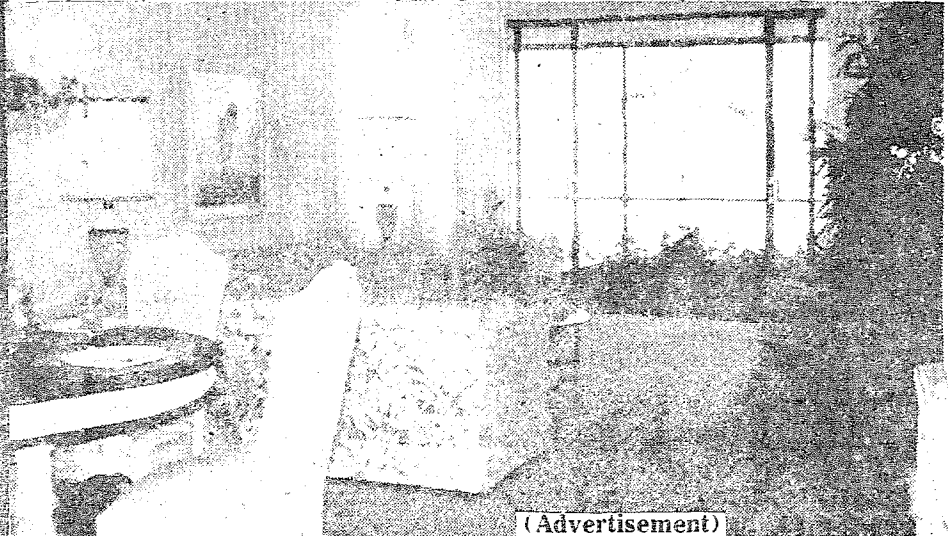

One of his first experiences playing por-ball was playing against "Scrawney, little Bubba Smith" of the Houston Oilers.

"Bubba is 6 foot 9 and weighs 295 pounds and I'm 6 foot 5 and weigh 245 pounds," he said explaining his problem. "The only thing was to go see the coach. "Coach," I said, "How in the world am I going to block this monster?"

The coach wasn't much help. "You have to want to block him more than he wants to get by you," he told me.

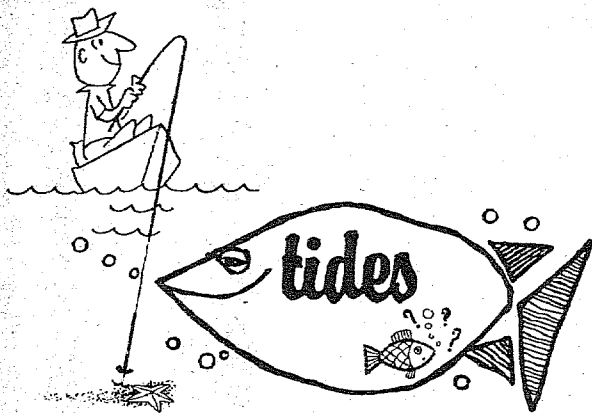

Conversion table: The above tides are for the lighthouse point of Sanibel only. To convert for Redfish Pass (north tip of Captiva), add 55 minutes to the time shown for every hi tide, and subtract two (2) minutes for every low tide. (NO, we don't know why, but it works. Instructions following are even less sense-sical but, as we stated, they do work.)

For Captiva Island, Gulf side, subtract 30 minutes from each high tide, and subtract 1 hour and 16 minutes for each low tide.

For Captiva Island, Pine Island Sound (bay) side, add 1 hour and four (4) minutes for each high tide, and add 52 minutes for each low tide.

In between these points on gulf or bay --- guesstimate --- and have good fishing and - or shelling.

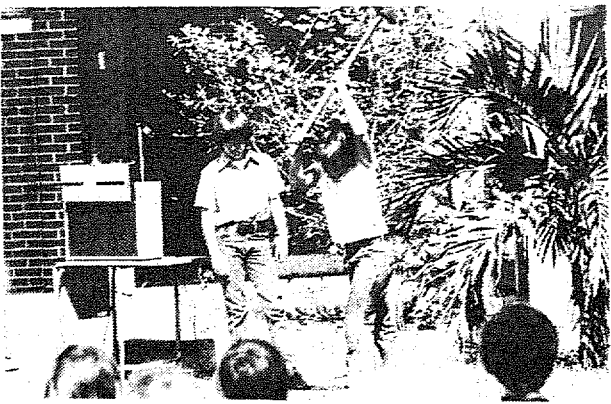
Mrs. Watson gets a gift...
