## planners continue development permits

In their meeting yesterday, Monday, Sept. 11, the Planning Commission voted to continue three requests for development permits and approved one by the Community Association for an addition to their existing building.

One request for a development permit to build a Christian Science church in Palm Lake Subdivision at the intersection of East Palm Lake and West Gulf Drive submitted by Jovan De Rocco for the Christian Science Group of Sanibel-Captiva Ltd. was continued because of lack of representation by the applicant.

A second request for a development permit by Outer Island for a nine-unit condominium at the end of Buttonwood Lane was, after much discussion, continued on a technicality. The developer's authorizing letter from the Sewer Authority expired September 7; an updated version of the letter was presented at the Commission meeting yesterday, but planning commissioner, Twink Underhill, contended that because it was not in their file one week prior to hearing time, it was not admissible. Architect Ron Stout replied that the reason the letter had not been updated prior to yesterday's hearing was because the hearing had already

been continued once. The new letter extended the sewage authority by 60 days.

The move came after a heated discussion by neighboring residents about the proposed development. They told the commission that they felt the proposed building is not in keeping with the character of the neighborhood. The building, a three-story, complex was termed "aesthetically poor" by Planning Commissioner Ray Fenton. Stout replied that the building represented the most efficient use of the property.

Commissioner Judy Workman raised another question about the location of the pool which is currently slated for an area on the coastal construction setback line.

"It has been my experience," Commissioner Joseph McMrtrrey agreed, "that use of any pool extends over its borders and I am worried about the destruction of the vegetation seaward of the pool."

According to the staff report prepared by the city's planning department, the project as it stands

now, meets the standards set forth in the comprehensive land use plan.

The hearing was continued while the architect and developer attempt to work out a building design with the Planning Department that would alter the height of the complex.

A request for a development permit by Dan Royal, Jr. (Trustee) and the Hugger-Kennedy Corp. for a 27-unit building on 12.51 acres at the west end of Gulf Drive was continued because the commissioners had questions about

## five announce for city council

Two contenders for the city council seat now held by Councilman Duane White have emerged to challenge the incumbent White in the November elections.

Joe Gault, a Sanibel resident since 1954 and owner of the Sea Horse, plans to file this Friday for White's seat.

"I have everything ready to go and plan to file this Friday," Gault said yesterday. He just returned from a family vacation and said that he was not yet prepared to comment on his candidacy.

A second contender, Gerald Wierman officially filed his candidacy this week. Wierman is president of the Rocks Civic Association.

Councilman Duane White filed his application for re-election last week, after returning from a vacation. "I

always said that I wouldn't run again if someone came along whom I could wholeheartedly support," White said, "but as of the time I filed, there were no other certain candidates.

"I am not a politician," White continued, "but I have invested four years of my life in Sanibel and I am dedicated to the concept of saving this barrier island from total despoilment."

White, who moved to Sanibel in 1968, was Chairman of the Planning Commission before filling a seat on the council vacated by Vernon MacKenzie in November, 1976.

The only challenger to the seat held by Mayor Zee Butler thus far is Myron (Mike) Klein. Both Klein, and Mayor Butler, who is seeking re-election, filed their applications last week.

The deadline for filing is this Friday, September 15.

# Snell resigns from IWA;

## Watson named interim replacement

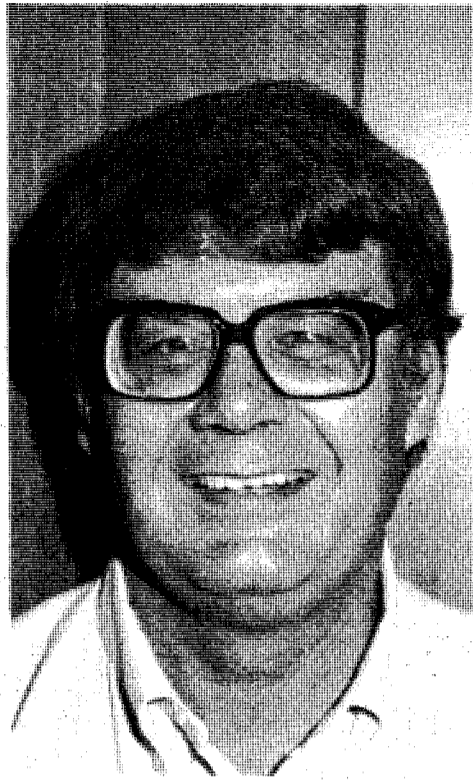

In a surprise move last week, Island Water Association (IWA) general manager Larry Snell submitted his resignation at the regular meeting of the IWA Board of Directors on Wednesday.

In his letter of resignation, addressed to IWA Board President Joe Winterrowd, Snell stated he felt "I have worked myself out of a job." According to Snell, over three years ago, he joined the IWA as general manager intending to spend a year or two introducing modern business practices to the rapidly growing organization.

"We became financially sound (during that period)," Snell wrote, "and developed a strong and motivated human organization. Just when I felt my job was almost done, we discovered that the Lower Hawthorne Aquifer was not as dependable as we were led to believe. We then faced together a new round of problems including the necessity of a long building moratorium."

After weathering that storm, Snell

says that he believes that the IWA is well into a sound, well-concieved, long-range development program that he feels will solve future problems. These included the addition of an engineer, a fiscally responsible rate structure, loyal employees, and a long-term contract with Pine Island for water supply.

"The IWA is in good shape, all the systems are set up and I just can't see sitting on my tail," said Snell last Friday.

Snell also stated in his letter of resignation that the conflicts engendered with friends and acquaintances on the Island, while trying to protect the IWA's interests, had taken their toll.

"When you wear a particular hat," Snell said, "you have to represent that organization. I have many friends who are developers and they took it (the ten-month ban on new water hook-ups) personally. They thought I was out to get them. That wasn't true. On the other hand," Snell added, "there were

people who took it remiss when we did lift the moratorium. They didn't want that either."

The IWA Board appointed their engineer Ian Watson as interium general manager, after a strong recommendation in that direction from Snell.

Snell feels with Watson in the interium general manager position, there will be a nice orderly transition and expects to leave the water company "fairly soon." "Of course," he added, "I'm not going anywhere; I will be available for questions."

IWA Board President Joseph G. Winterrowd, in accepting Snell's resignation, commented that "There is no question that the company improved during his tenure." His sentiments were echoed by Board member Jim Robson who said that "Larry brought the company up to modern business standards with sophisticated systems."

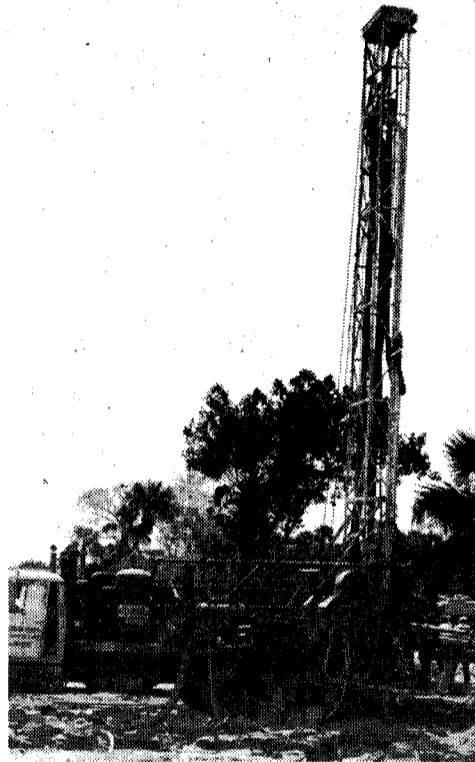
Winterrowd would not comment on whether Watson's appointment as general manager would become permanent. "We haven't made that decision, yet," he said.

## Suwanee aquifer test well better than expected

Preliminary reports from the Island Water Association's (IWA) test well into the Suwanee Aquifer indicate that the latest test well is providing the IWA with water of a much higher quality and quantity than they had anticipated. According to outgoing IWA general manager Larry Snell, the well is producing 4800 parts per million of total dissolved solids. "We were hoping that it would be under 7000 ppm," Snell said, "but we didn't expect this." IWA officials have added that the flow is also much stronger than anticipated. "The Wulfert Point Well produced very good water," one spokesman said, "but it is

so far away that the cost in pipe to get the water to the plant would be tremendous." The new test well is located close to the planned site of the IWA's proposed reverse osmosis (RO) plant.

"If this holds, Snell said, "it has some terrific ramifications. It means that we will be able to blend water of deteriorating quality from the Lower Hawthorne Aquifer from the electrolysis plant with higher grade reverse osmosis-treated water for a much longer time than we expected. "That should extend the life of the ED plant considerably," Snell concluded.

the section lines, property ownership, vegetation removal and ownership.

The Planning Commission decided to recommend to City Council that the Community Association be granted a specific amendment to build a 5,000 square-foot addition to the current building on the south side of the property.

In other action, the Commission also decided to recommend that a specific amendment be approved that would require a four-fifths vote of the Council for adoption of any amendment where a proper protest by certain residents is submitted. According to Commissioners, they feel that, as the island becomes increasingly developed, future city councils will be under more and more pressure to increase the island's density. They feel that this amendment would form a safeguard against that.

## city to receive pedestrian safety award

The City of Sanibel has been awarded the Pedestrian Safety Citation by the Peninsula Motor Club for 1977. The special citation gives recognition to communities with outstanding pedestrian death injury records. The award is based on an evaluation of the pedestrian death and injury rates, rate comparisons, percentage of total traffic deaths and injuries and fatality-free record.

The presentation has been tentatively scheduled for Friday, September 15 at 3:30 p.m.

## research vessel to study red tide

In an effort to determine how far the red tide organism has spread in Gulf waters, the research vessel Cortez left yesterday, Monday, September 11, on a three-day trip to collect water samples well offshore.

A spokesman for the Marine Research Laboratory said this morning that fish kills were reported some four miles offshore near Venice, with additional discoloration in the water apparent there.

As the outbreak of the fish-killing red tide works its way slowly up the coast, the collecting of shellfish was banned in Hillsborough county on Thursday afternoon when patches of dead fish were discovered in lower Tampa Bay near the Sunshine Skyway and off Edgmont Key.

The ban was imposed earlier this week on Lee, Charlotte, Sarasota,

Manatee and Pinellas counties. Divers have been taking water samples from various depths along the affected area from near Fort Myers to just north of the mouth of Tampa Bay.

Biologist Mark Moffler announced this morning that he didn't think the outbreak was "as severe as it was originally thought to be" when it was discovered last week in the Englewood-Charlotte Harbour area, but that the final results could not be evaluated until the data from the off-shore research vessel Cortez had been compiled.

Red tide is the result of a heavy population explosion of a marine microorganism which gives off a toxin that paralyzes the gills of a fish.

The toxin does not kill shellfish, but is absorbed by them and can cause severe illness in humans who eat the contaminated shellfish.







## vote "no" in today's referendum on tourist tax

Lee County voters go to the polls today to make a myriad of choices that will substantially effect life in the County in the future. Of all the issues that will be voted upon today, few have raised the fuss and furor of the

proposed two percent tourist or 'bed' tax, and one percent gasoline tax.

The ISLANDER has no quarrel with the one percent gasoline tax -- there is no question that the road system in Lee County is inadequate and the gasoline

tax is the closest thing to an impact fee we can levy. The people who utilize the roads will be the ones who help pay for their repair and reconstruction.

The tourist tax is, however, another matter. The islands, with approximately 3,000 rental units and Fort Myers Beach, with almost that amount will be the ones who will fund the new projects which include a sports stadium, fine arts complex and aquatic sports center to be built on the mainland. While its true that some year-round Island residents might take advantage of a fine arts complex, it is still sophmoric to seriously suggest that these projects will substantially benefit either Estero or Sanibel and Captiva Island, and we will be paying

the majority of the costs. It is similarly naive to believe that the tourist tax will cover the construction of the buildings and their maintenance in the ensuing year. Twice in as many weeks, the Board of Lee County Commissioners has almost dropped the proposal that has area Chambers of Commerce up in arms. That would have been wise but, at the very least, the tax should have been dropped until the funding proposal (which seems to be on the optimistic side) has been more thoroughly investigated.

Whether or not this happens depends now on the voters. A vote against the tourist tax is the prudent course of action.

Dear Mayor Butler,

It is my understanding that a request has been made for permission to undertake a "controlled burn" in the wildlife refuge. With this letter I would like to raise several points of objection. As a life-long ecologist and nesomaniac, I am very much concerned with this proposal, and the following are just a few of the reasons:

1. Such a burn will consume large amounts of oxygen. Everyone knows that fire consumes oxygen, and that the supply of oxygen on the earth is finite.
2. The burn would naturally produce large amounts of carbon dioxide, which can cause death.
3. The heat produced would naturally upset the thermal balance in the area.

4. The particulate matter byproducts are extremely undesirable. Are we trying to create another Los Angeles? We all know of the dangers of eating hamburgers grilled on an open fire, they can be carcenogenic. So, perhaps, carbon dioxide created in an open fire, may also be harmful to our health. Perhaps we should seek the SurgeonGeneral's advice. Incidentally, do they have an EPA permit?
5. Vegetation will be destroyed. This is contrary to our CLUP. How can our vegetation committee permit this? Can't they have an open season on transplanting the multiple-limbed varieties?

Moreover, vegetation consumes undesirable carbon dioxide. Through a

complex process, known as photosynthesis, sunlight is combined with chlorophyl (the same stuff used in breath mints). This has been known to create oxygen, among other things. As every school boy knows, this is the essential ingredient of life itself...as we know it.

6. A large number of insects, including the much-touted Sanibel Mosquito, will be destroyed. These are the very same insects that form part off:the vital food chain, permitting our beautiful birds to survive, in our unique and delicate ecosystem.
7. Other wildlife could also be effected, though I am told by competent authorities that this is t not their mating season. Some of the wildlife involved have held this territory for

many years, hoping only to make Sanibel their final roosting place. Are we to deprive them of this privilege? They have no voice, only the beauty that comes from living in the wilderness. Are we to deny them of this their last wish in life?

8. The burnt earth would be laid bare to the elements, permitting erosion. Should a hurricane hit, in this the critical hurricane season, we might loose valuable land...wetlands at that ! Had this happened before we got ours, we might not have ours now. Moreover, silt on the roads could hamper hurricane evacuation.

First thing you know, developers will be wanting to clear their land with



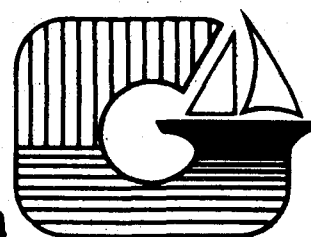

One jogger came to an

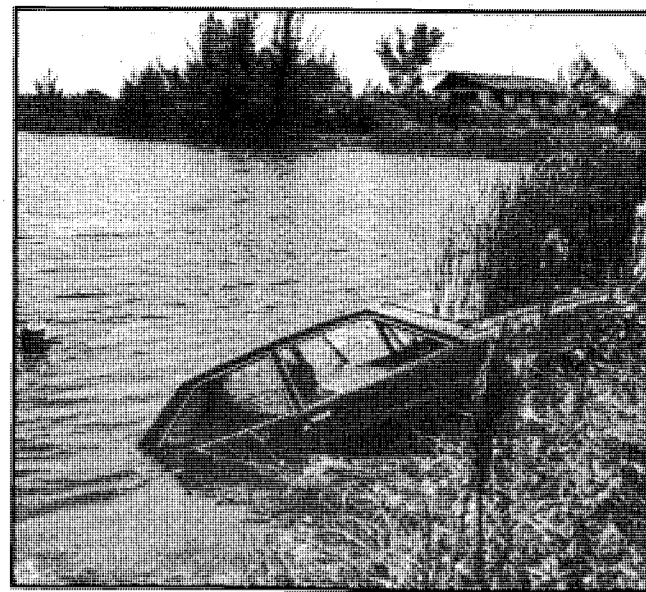

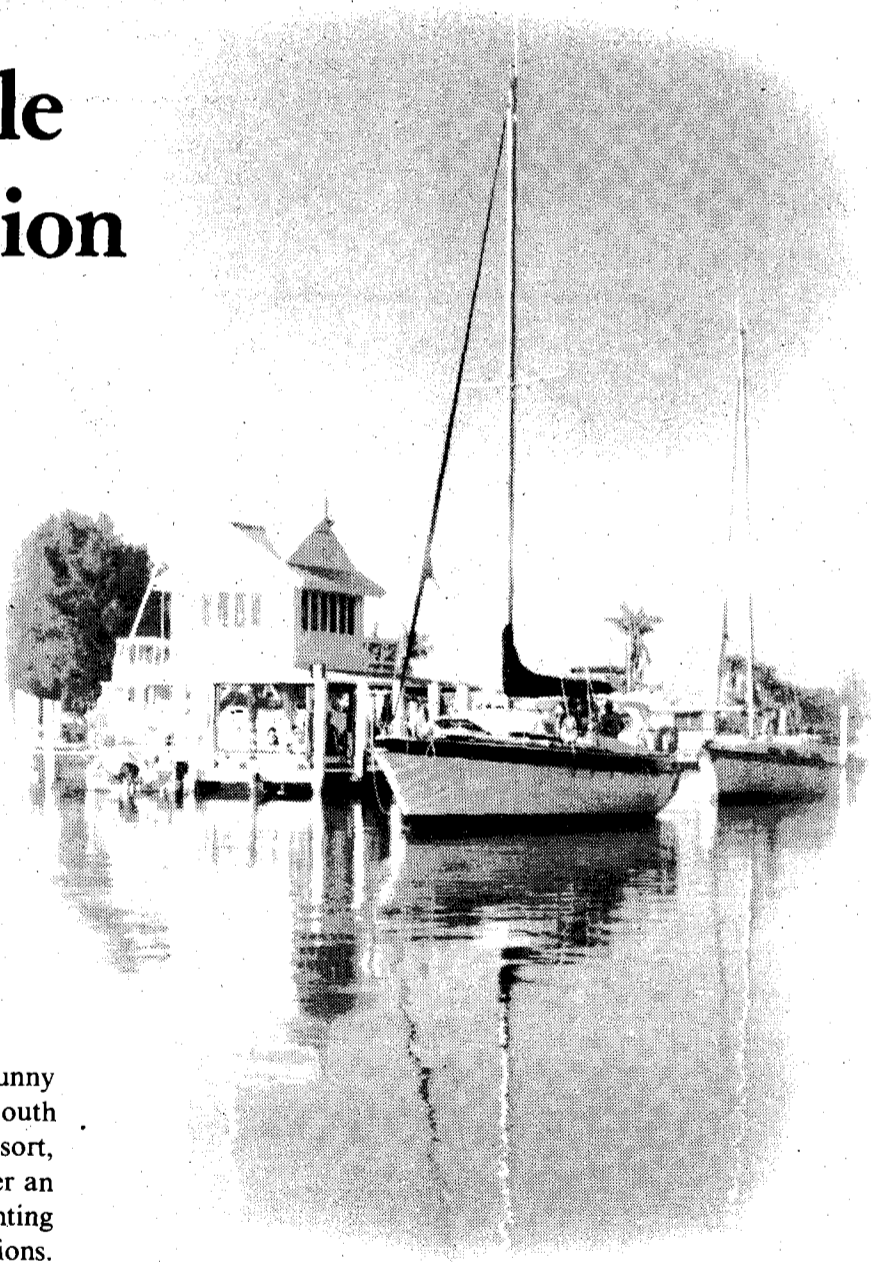

# Nancy Eckerd visits Sanibel

## on Dad's campaign Trail

A smiling, vivacious and fiercely loyal Nancy Eckerd visited Sanibel last Saturday in the wake of accusations levelled at her father for alleged improprieties during his term as administrator for the General Services Administration (GSA).

"Hopefully, I'll be able to keep my mouth shut," she said determinedly, and then went on to term Republican gubernatorial candidate Lou Frey's allegations as "ridiculous." The whole thing reeks," she said.

Nancy Eckerd does not believe that the charges have hurt her front-running father's chances.

"I canvassed a neighbourhood in Bradenton, yesterday," she stated, "and of the three households that were familiar with the charges, they were all for my father."

Although Miss Eckerd admitted that she had been hurt by the charges, she stated that her father will not sling mud. "Some people wonder why he won't give more specific answers," she said, "but we're just not going to get to that level." However, "she contended, "the GSA was a hotbed of political tricks and what's coming to light now are the results of investigations my father started although we will never get the credit.

"If I didn't believe in him, I wouldn't

work for him, even though I am his daughter" she stated.

And work she has.

Campaign '78 has been work for the entire Eckerd family. All of those who are available to work for the candidate are involved. Nancy started "Young Floridians for Eckerd" and took a year's leave of absence from college to work on the campaign. "I've been in 65 of the 67 states," she said.

"It has worn me out," she admitted. "But my schedule is nowhere as hectic as Jack and Paula Hawkins, Eckerd's running mate."

It is a fast-moving campaign," she said, "but a campaign is shallow without people contact."

Although she is a major in political science, her own political aspirations revolves around background political work. "I've learned never to say never," she said, "but I can't see myself running for office." Her own future vocation, she hopes, will be a travelling aid to a political candidate.

"This has been wonderful experience," she enthused. "We've made a lot of mistakes, but hopefully, we've learned from them."


Eckerd, who started with two run-down drugstores in Tampa at age 25 and is now extremely wealthy, would bring the government back to the

people, back to basics, according to Nancy Eckerd. "Dad is not a professional politician," she commented. He would run an efficient operation. "Dad can talk to businessmen -- he can also cut waste in government," she said.

Nancy Eckerd's life in 1978 has been wrapped up in her father's campaign.

"I used to play tennis and swim and run," she said.

It seems, however, that Nancy Eckerd is still running and, if Eckerd emerges victorious today in the primary election, will continue to race through the remaining weeks to the general election on her dad's campaign trail.

# on the water

If we can get past the next couple of weeks, then chances are that we will escape a confrontation with a hurricane this year, but have you kept an emergency plan for your boat if we do get hit?

I know that each year you read about what to do and where to go in the event of a hurricane. We get bombarded with media advice about this precaution for ourselves, but also each year more and more people are on the islands who have never been through a major storm. And chances are that they have no idea of what to do with their boats.

Self-bailing boats have the best chance to survive a bad storm, providing of course that they don't sink from being pounded down upon the tops of a piling in high tides or aren't driven ashore and overturned. But don't rely upon a boat being able to "self bail" faster than water can rain down or come over the sides.

Lots of us have boats, but no trailers. Some say that putting a 20 to 24 - foot boat on a trailer is only asking for problems, so that means many boaters will keep their craft in the water and hope that it rides out the storm.

Under these conditions, even though my boat is supposed to be self-bailing, I always rig up an automatic bilge pump and charge up the battery. Naturally, there are quite a few boats which rely upon bilge pumps as the only way to rid the boat of water. This is dangerous under storm conditions because the pump will eventually drain the battery from continuous running. That's when you can expect to either stay aboard the boat, bailing all the while or if you have to evacuate the island, just hope your boat insurance is set to cover your loss.

The problem I always feel is the most bothersome when tying off a boat to weather a hurricane is the boat being torn free, and drifting onto shore or drifting up on a submerged dock and being pounded to pieces.

Incidentally, most boat engine mechanics advise owners to leave their boat and engine on the bottom should

the rig sink. That's not to say that your boat can't be raised and used again. What they like to do is leave the engine under the salt water until just a few minutes before they go to work on it trying to save the machinery. If the owner goes out and hauls his engine out of the water, chances are good that he won't know how to properly wash and take down the engine. A good mechanic can save an engine if it hasn't been exposed to air before his arrival. It sounds funny, but if your boat does go down, better to leave it right where it is until a professional can pull it for you.

I've had boats make it through some bad storms by double typing all the docking lines and putting out a couple of anchors. If all boaters leaving their craft in the water would take some of these extra precautions, then surrounding boats would suffer less damage. I saw a runaway cruiser on the Miami River during a hurricane ram three or four boats after it broke it's docking lines. It finally wedged between a boat and a dock and nearly sank them both.

Those who have larger boats, say over 30 feet, usually try to make it into a canal in Cape Coral or take the boat up the Caloosahatchee River past the first lock.

This idea of trying to get up the river always sounds easier than it really is, because of the Edison bridge opening schedule. Heavy vehicle traffic and the possibility of a power failure might add up to a closed bridge, leaving your boat exposed to winds and seas. There are very few protected, deep water anchorages for larger boats on Sanibel and Captiva Islands. Most of the public marinas have some protection, but unless you have your boat there now, the slips available will probably be full long before the storm hits.

Have some plans ready just in case, and let's hope we get by without a hurricane paying a visit to the Islands this year.

# islander angling




monumental snow job. So much for the surface info - now for the "in depth" report.

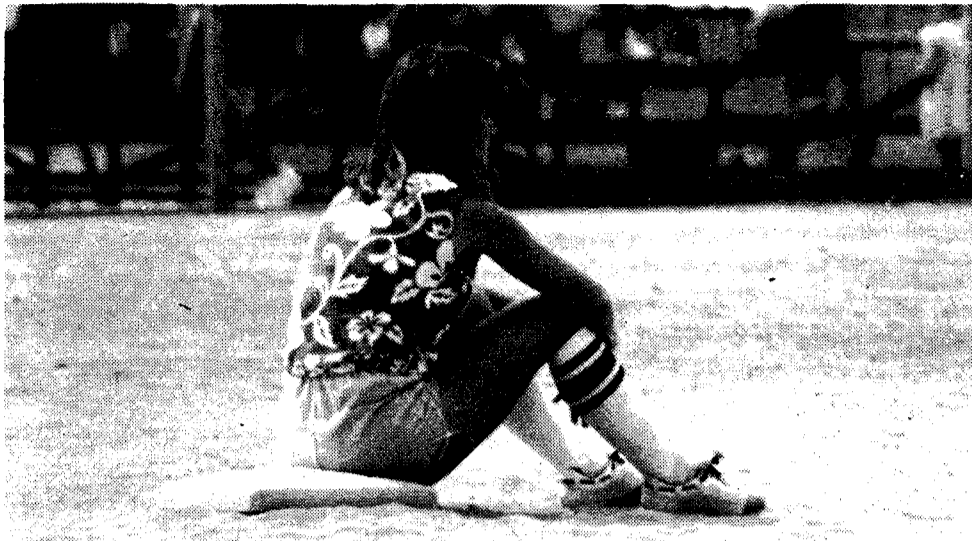

The Mens' Nosee'um Classic begins this Friday, September 15 at 6 p.m. and the championship game will be held at 6 p.m. Sunday.

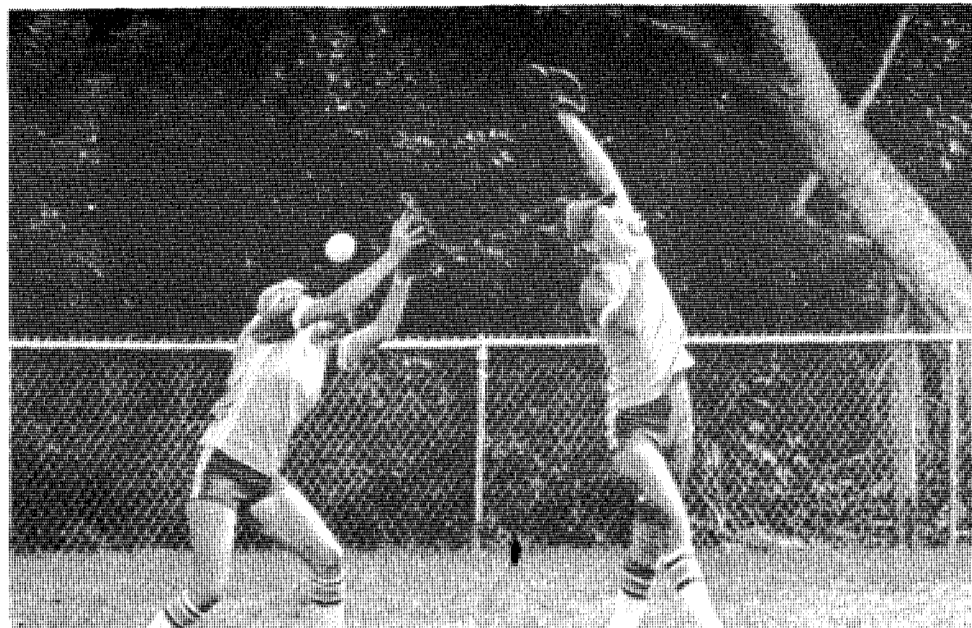

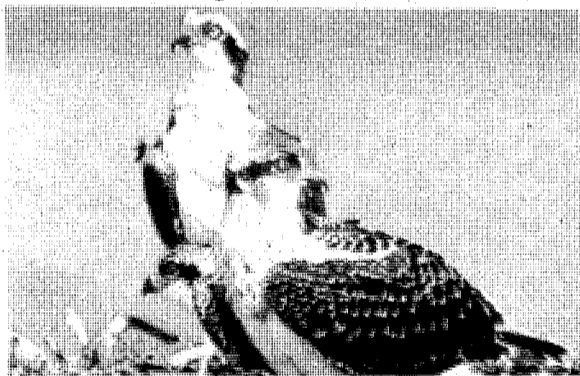

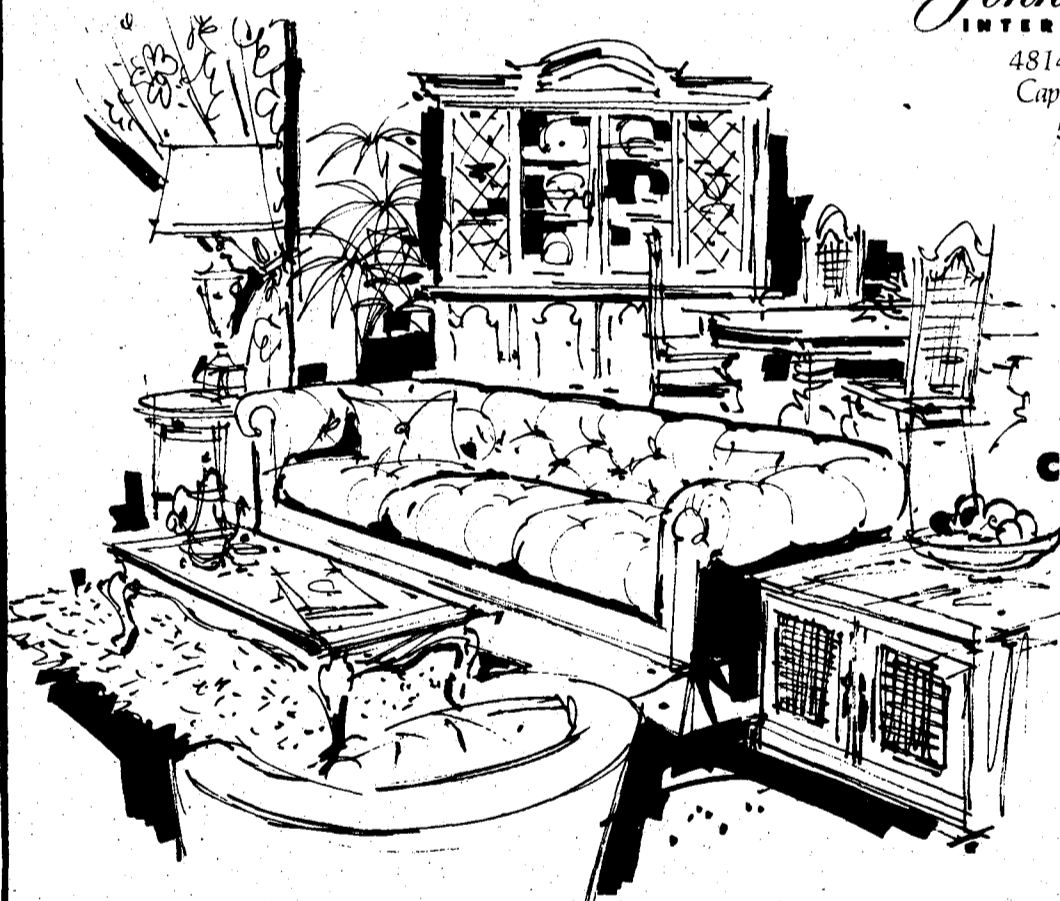

# CETA program working well

While abuses of the Comprehensive Employment Training Act (CETA) program are front-page news in many areas of the country, and pending federal legislation may further restrict use of the program, CETA audits conducted periodically have indicated that Sanibel officials have made ef-

fective use of this program since the first employee began training on the island in 1976. CETA was established in 1975 by the federal government to provide funds to train citizens for employment in many trades and professions. Unfortunately

in some areas of the nation CETA-funded trainees never appear to work at assigned tasks, or remain as "subsidized employees" long after their training program should qualify them for employment outside the program. According to Sanibel City Manager William Nungester, the 1978-79 proposed city budget has projected eight CETA employees; four utilized as

police dispatchers, two in administration, and two in public works. The proposed budget for this program calls for an expenditure of \$82,854, all but a fraction of which will be reimbursed under CETA. Over the past two years a number of CETA trained personnel have been placed on the permanent city payroll where jobs were available and the trainee met the job requirements.

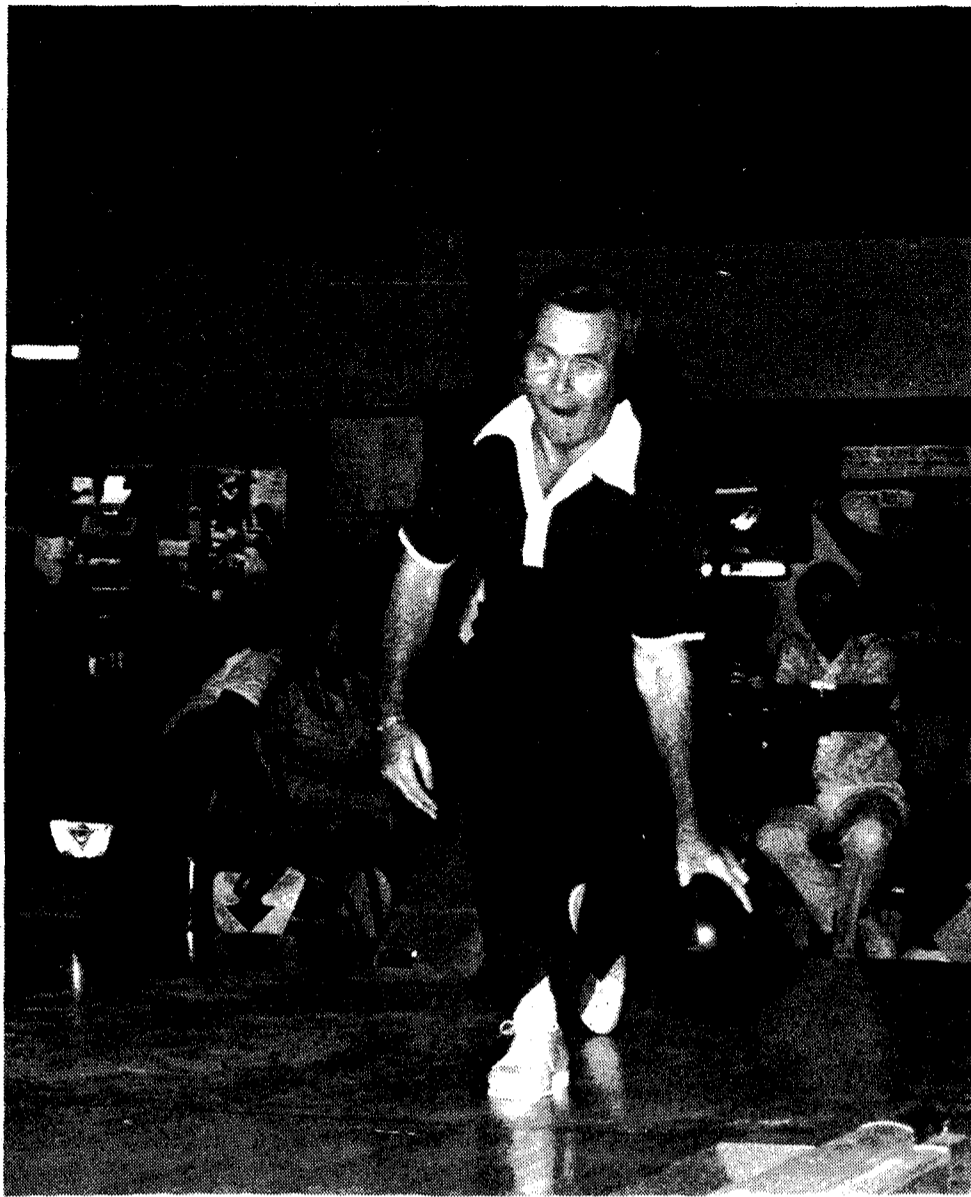

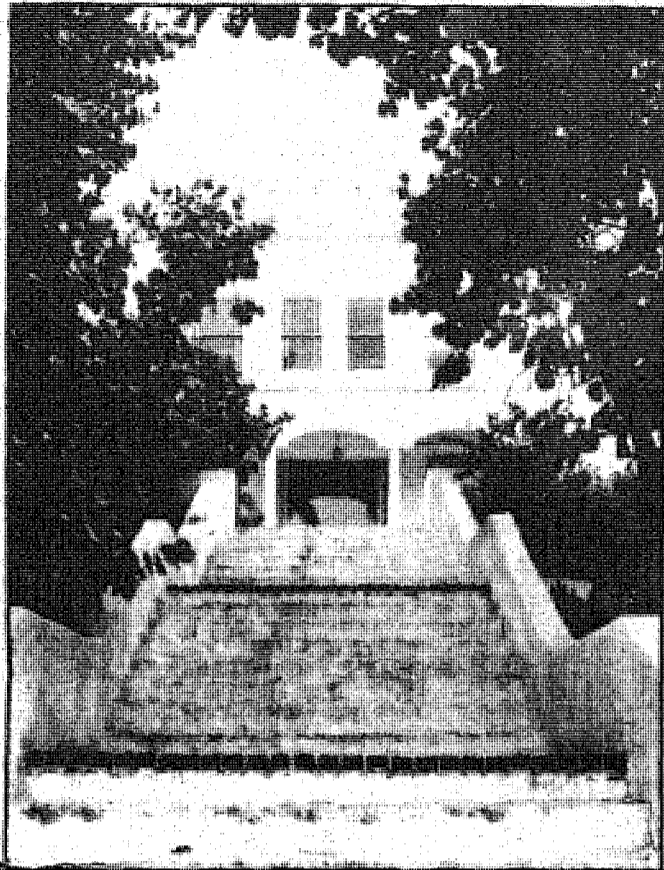

to the new Inn.

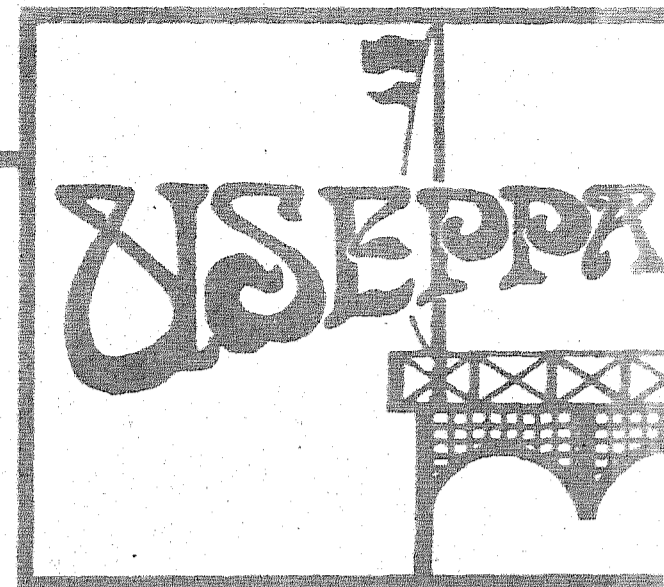

There is something about a tropical island - a certain mystique - that has captured the imagination of man since the beginning of time. Rising from the waters of Pine Island Sound and covered with lush vegetation surmounted by gently swaying palms, Useppa is just such an island. Approximately one and one-half miles long, one-half mile wide at the widest point, comprised of over 80 usable acres, and rising to an elevation of 30 feet (unusual in the waters of Southwest Florida) the island's unique topography has given it a checkered history.

Once it was the home of the Caloosa Indians, who built extensive shell mounds throughout the area. Spaniards and pirates roamed the surrounding waters at will, and it is believed the island's name is a corruption of "Joseffa", favorite mistress of the famed Gasparilla.

The military considered the island a strategic point during the Seminole Wars of the 1840's, even selecting it as a possible site for a military outpost in 1848. In the 1890's John Roach, Chicago streetcar magnet, purchased the island and by 1902 had converted it to a fishing camp for the wealthy with life centered around a 20 room inn.

In 1912 Baron Collier acquired Useppa and began an expansive and expensive program of improvements, the remains of much of which may still be seen today. Money was no object to the wealthy Collier, but it still gives the mind pause to consider that in the early 1900's this remote-island boasted every imaginable amenity to the Baron's friends and guests - a hotel, swimming pool, tennis courts, nine hole golf course complete with club house, and the ultimate - an imported white sand beach. These were surrounded by Collier's pillared mansion, still an island landmark, and a scattered assortment of guest bungalows. Small wonder the wealthy flocked here to revel in the island's tropical beauty and delight in fishing for the tarpon which still abound in the area. Collier went so far as to establish the exclusive Isaac Walton Club of Useppa with the following supplication

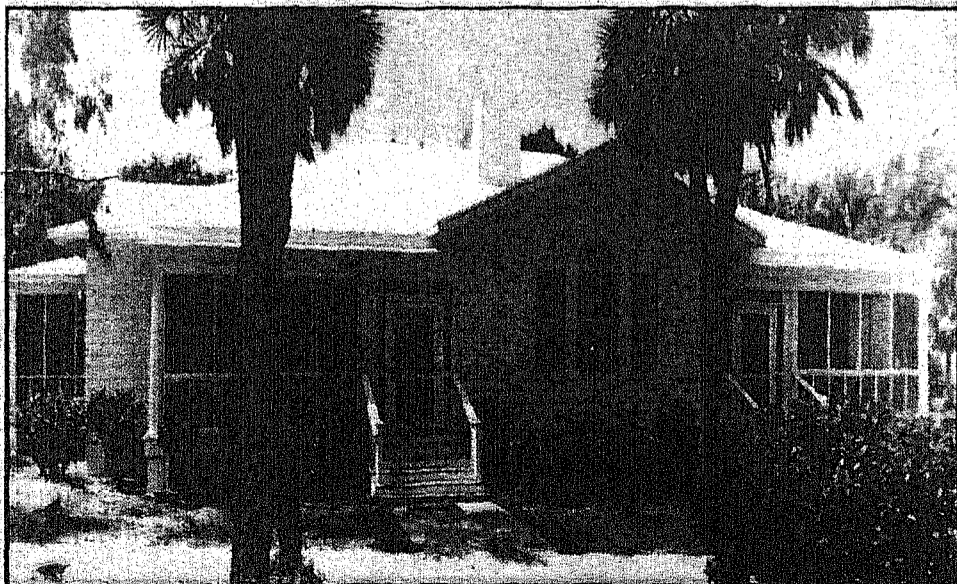
to members: "Lord suffer me to catch a tarpon so large that even I, in talking of it afterwards, shall have no need to lie."

Subsequent to Collier's demise, the island passed through the hands of a number of owners and slowly drifted into a state of disuse. It reached its nadir when, in 1960, it was reportedly used as a training camp for exiled Cubans who later launched the abortive Bay of Pigs invasion.

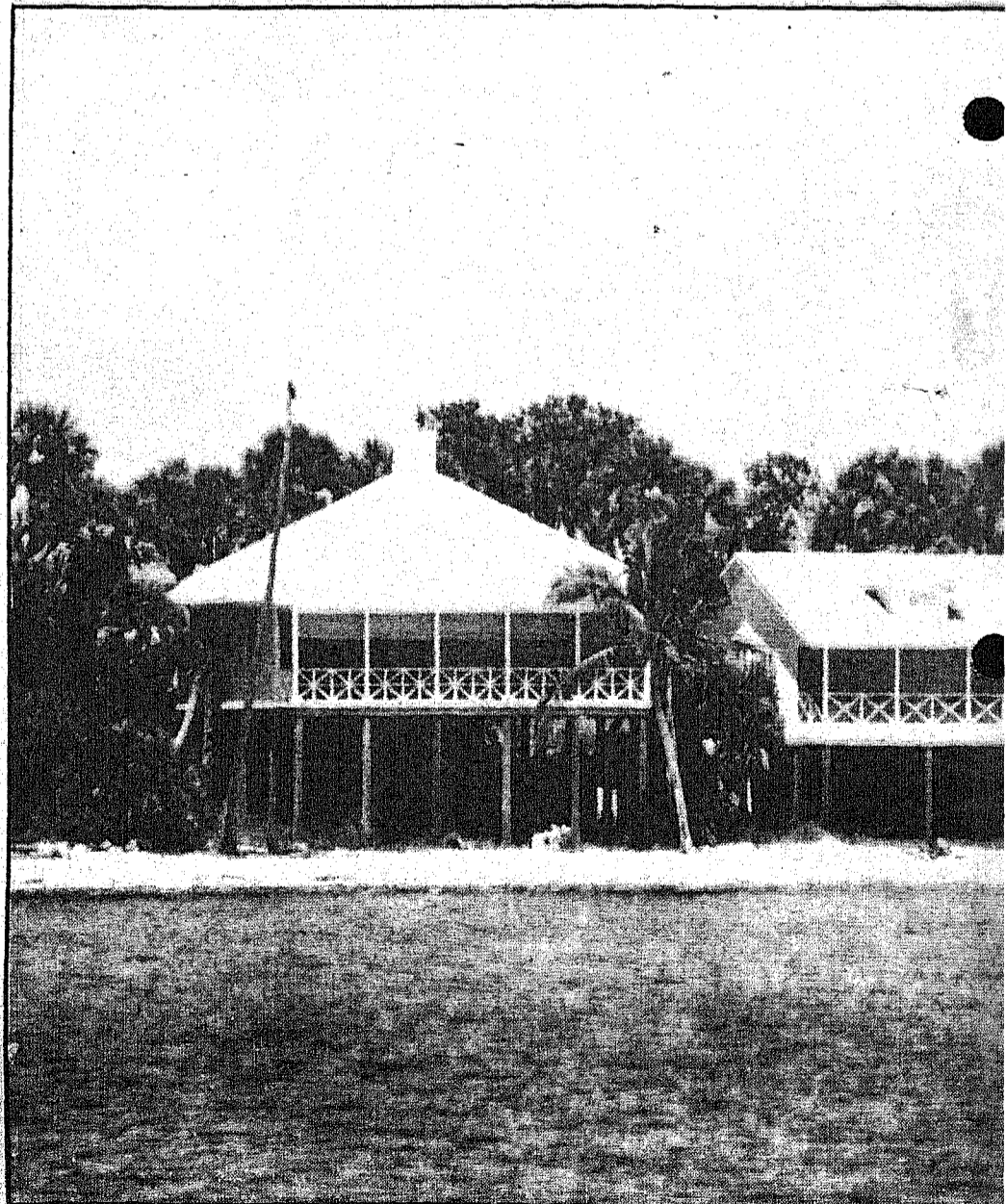
The island was left to the ravages of time and nature until the Useppa Inn and Dock Co. took charge in 1977. Under the direction of Garfield Beckstead, President, and with "a firm commitment to restoration," the island has been largely restored to its earlier grandeur. The overall program is threefold: to authentically restore the island's amenities; to establish the entire island as a private membership club, and to select 80 widely scattered cottage sites to be sold to members. The latter will utilize only 20 percent of the island under a low



Before: A bungalow awaiting restoration




After: A newly restored bungalow on Useppa

density development concept, leaving the balance in a natural state.

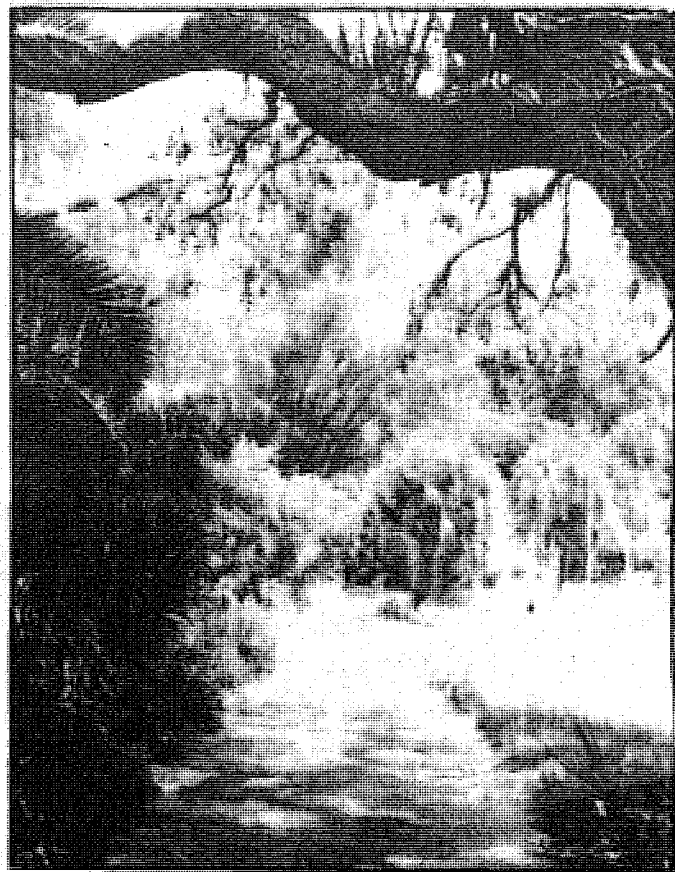
After a year and a half, the results of this program are readily discernable. The jungle growth and accumulated debris have been cleared away, revealing an extensive pink colored walkway meandering nearly the length of the island among magnificent banyans, live oaks, palms, and other exotics. Two grand staircases have been unearthed, flanked by monumental urns. Under the guidance of Daniel Turner, architect and resident of Captiva, virtually all of the major buildings have been restored. In addition, a number of private homes have been constructed in conformation with original island architecture. The pool and tennis courts are once again in use, the general store with its bar and lounge once again welcomes members and guests, the golf pro shop serves for meetings, receptions, and as a gameroom, and the Collier Inn serves diners amidst revolving ceiling fans and wicker furniture.

Everywhere one is surrounded by antique cypress paneling painstakingly restored to its natural beauty. The overall effect is one of subtly understated elegance. Even the Isaac Walton Club has been reactivated. Each member of the Useppa Island Club is presented with a plaque bearing his or her name and emblazoned with a signed and dated tarpon scale from the early 1900's.

While Useppa is an island, and its attraction is to those of a more adventuresome spirit, it does provide many of the comforts of mainland areas. A reverse osmosis plant, unique in this area, provides some 30,000 gallons of potable water a day. While at present electricity is generated on site, a submarine cable will connect the island with Lee County Electric in the near future. Also, the general store will soon be stocked to provide an adequate shopping center. A full time staff is on hand to provide service, maintenance, and security. Access to the island is provided by scheduled launch from South Seas Plantation; small planes may land on the island's 1700 foot strip, and taxi boats may be summoned to meet arrivals at Bokelia on Pine Island. In the near future helicopter service will be initiated from Page Field. The island is ideally situated on the Intracoastal Waterway, providing easy access by even large private yachts.

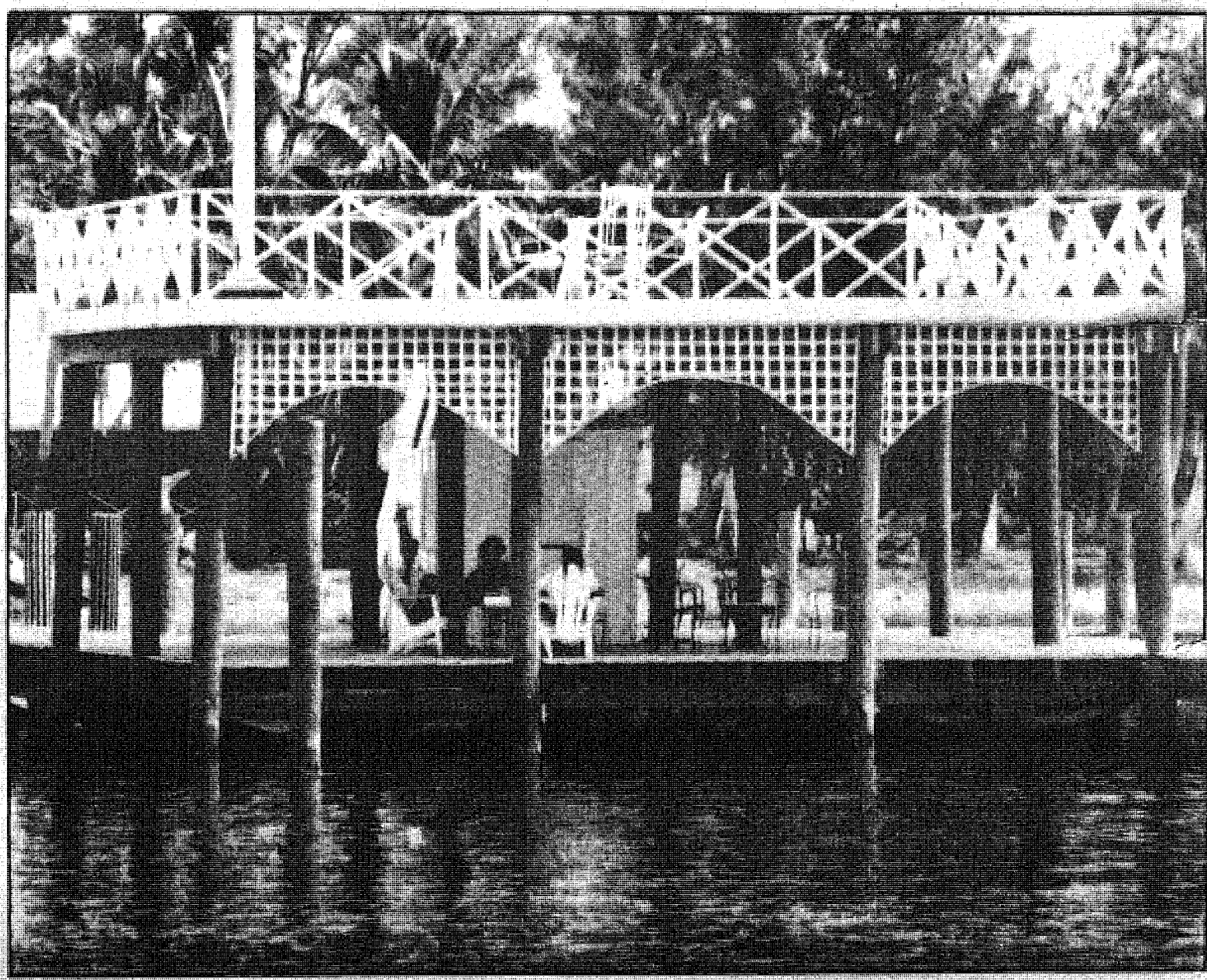
Membership is set at a fixed number, and already two thirds of the memberships have been sold. The main sales thrust is to attract members who reside in the area from Naples to Sarasota so that they will utilize the island as a retreat and support its facilities, though membership is not limited to those from this region.

The island is just that - an island - providing an island retreat for seclusion and relaxation. It will never provide grand scale amenities or activities, so it is not for everyone. But for the discerning few who appreciate old world charm and a more leisurely pace, it is paradise restored.

## speaking of turtles

Our island might well be called tiny Turtledoms because of the scholarly authorities in this field who are in residence, reigning over the realm. These professionals know all the facts about the many different species of our hard-shelled friends. They even know how to pronounce their latin names.

This is not the time to name the names of those men and women who are dedicated to the preservation and care of these interesting and important creatures and besides, you must know about them already if you read local papers. We have been kept up-to-date on their involvements and activities by numerous marvelous photographs and write-ups, and we regret that some personal turtle pet stories that have never appeared in print cannot be told right now. There are so many enchanting tales to be told ...

The point of this unscholarly mini-dissertation is to share with our readers some information pertaining to turtles that may not be common knowledge. The condensed facts were recently gleaned from one of the most mixed-up collections of everything

Added to that pearl of wisdom is the fact that Turtles International, Inc. sponsors a variety of special events during "International Turtle Awareness Week." It offers a number of official turtle accessories for sale: flying turtle pins, bumper stickers, jacket patches, turtle power T-shirts, and a 45 rpm record of the Turtle Song as recorded by "ole" lonesome George Gobel.

Members have included former Mayor Richard Daley of Chicago, Howard Hughes, Johnny Carson, and 50 astronauts. There are more than 5 million card-carrying Turtles in the world today.

Unquote the People's Almanac. We did not check its authenticity with any improper sources, but we know for sure that they left out a few vital statistics. These can be verified by local Card-carrying Turtles.

It seems that somewhere along the line, no one seems to know exactly when, a very private Turtle Club gained headway. The rules, now printed on the official cards, could well have been invented by a bunch of flyboys at some point. Their particular style seems evident.

In order to be a member in good standing, the procedure goes like this: first, you ask someone if he or she is a Turtle. # food for thought

Some people can't get beyond spaghetti when they think of pasta. Too bad. There's a wonderful array of shapes, sizes and fanciful names to pique the imagination and decorate the plate.

In the accompanying photo, some of the myriad shapes of pasta are gathered in a jug. Sticking out the top are the squiggly fusilli (twists), spaghetti twisted like a corkscrew. Behind the fusilli are mostaccioli rigati. The name means "grooved small moustaches," according to "The Complete Book of PASTA." Why they named them that, I can't say.

Behind that, good old familiar spaghetti.

Then broad lasagne, with ripple edges. The Italians call it lasagne riccie. The word lasagne is derived from the Latin word for "pots," so lasagne riccie would mean curly pots.

The thinner noodle that looks like a narrow version of lasagne is mafalda (or mafalde), a broad noodle rippled on both edges.

Behind it is fettuccine, which means "small ribbons," one of the most popular of Italian noodles. It's sold as straight and folded noodles.

Rounding out the top layer is vermicelli, "little worms," a very thin spaghetti sold straight, or in clusters.

Filling up the pasta jar are long, narrow tubes, called mostacciolini (tiny moustaches); short tubes (such as those used in macaroni salad) called tubetti, or tubettini, for the very smallest; and farfalle, or "butterflies," which look like little bow ties with pinked edges; and spiral-shaped rotelle (small wheels).

From this, you can begin to appreciate the variety that awaits the pasta cook.

In cooking pasta, there are a couple of generalities that need to be gotten out of the way.

First, use plenty of water. PLENTY of water. At least six quarts of water for a pound - seven quarts if you go along with some sources.

Have it boiling rapidly. And the water should be salted, with at least 2 teaspoons of salt, added right before the pasta.

Sources vary on this next point, but I add a little oil - not butter or margarine - to the water, perhaps 1 tablespoon or 2, and never have sticky pasta. Olive oil is best for flavor, but about any oil will stop the sticking.

While the water is rapidly boiling, drop in the pasta. Push down long strands as they soften, if needed. Cook uncovered, stirring gently every now and then.

Cooking time is a matter of some dispute. There are charts, but the best judge of pasta cookery is you - your teeth to be specific.

Pasta shouldn't be cooked to the point of mush, or extreme softness, but beyond that it's largely a matter of taste, or bite. Some people prefer their pasta very al dente, firm, others like it a little more tender. Your own preference should be your guide.

Now that you have the pasta in hand, you'll need sauces to go with it. Some purists like their pasta served with a little butter, and perhaps some freshly grated cheese. But a savory sauce seems to set it off.

From "Hunts Tomato Paste Recipe Collection," a 122-page collection of recipes using tomato paste, here's a basic spaghetti and meatballs recipe. This is a nifty little cookbook, spiral bound so it lies flat on the counter.

## SPAGHETTI WITH MEATBALLS

2 eggs, beaten  
2-six oz. cans tomato paste  
¼ cup minced onion  
¼ cup grated parmesan cheese  
2 tbsps. minced parsley  
1 clove garlic, minced  
Salt  
1 lb. ground beef  
¾ cups soft bread crumbs  
3 tbsps. oil  
2½ cups hot water  
1½ tps. hugar  
1 tsp. basil  
1 tsp. oregano  
¼ tsp. pepper  
1 lb. spaghetti, cooked and drained

Blend together eggs, 1 tablespoon tomato paste, onion, cheese, parsley, garlic and 1 teaspoon salt. Add beef and bread crumbs; mix thoroughly.

Form into 20 balls, about 1-inch in diameter. Lightly brown in Dutch oven on all sides in hot oil; drain fat. Blend remaining tomato paste with hot water, sugar, basil, oregano, 1 teaspoon salt and pepper. Pour over meatballs; cover and simmer 10 minutes. Uncover, and simmer until done, about 20 minutes longer. Serve over spaghetti. Serves six.

This is a terrific, and quite easy, sauce for fettuccine. The egg cooks on the hot pasta, and helps the other ingredients cling to it.

## CARBONARA SAUCE

¼ lb. Italian sausage (mild)  
¼ lb. prosciutto sliced thin  
4 tbsps. butter  
½ lb. fettuccine, cooked and drained  
½ cup parsley, minced  
3 eggs  
½ cup freshly grated parmesan  
Pepper

The sauce goes onto the fresh, hot pasta, so don't cook it until you have the sauce at least started. You can put it all together at the table, for an impressive show.

Remove casing from sausage and crumble meat. Chop prosciutto finely and combine half of it with sausage and 2 tablespoons butter. Cook, stirring, until sausage is lightly brown. Blend remaining prosciutto with the mixture.

(At the table, if you'd like,) blend hot, freshly cooked pasta with the sausage mixture. Stir in remaining butter and the parsley.

Mix quickly. Pour in the beaten eggs and quickly mix, to coat pasta with egg. Still working quickly, toss in the cheese and the pepper. Serve on hot plates or bowls. Serves four as a first course. (Double the recipe to serve six as a main course.) Pass more grated cheese to sprinkle on the top.

One of the best sauces for pasta is a white clam sauce.

While the original recipe didn't call for it, I like to add a little half and half, perhaps ½ to two-thirds cup, to the sauce, boiling it (yes, boiling) until it thickens a bit. This adds a delicious hearty creaminess, similar to Fettuccine Alfredo.

## PASTA WITH WHITE CLAM SAUCE

1 garlic clove, peeled and cut in half  
One-third cup olive oil  
½ cup clam juice  
¼ tsp. salt  
Freshly ground pepper (lots)  
One-third tsp. dried oregano  
1-seven ½ oz. can minced clams  
2 tbsps. chopped parsley  
1 lb. pasta  
½ to two-thirds cup half and half, optional

Put the pasta water on to boil; you'll cook both at once. Saute garlic in oil until golden. Using a fork, flatten the garlic halves, stirring them well into the oil to incorporate the garlic flavor. Remove garlic and discard. Add juice, salt, pepper and oregano. Simmer five minutes.

If using cream, add it and the juice from the can of clams,

to the mixture. Cook, at a high simmer, so liquid will reduce and thicken, about 10 minutes. Watch it carefully so it doesn't scorch. Meanwhile, put the pasta in the boiling

water. Stir clams and parsley into the cream sauce. Keep this hot, but not boiling, until the pasta is cooked.

Toss drained pasta with half the sauce. Serve the rest spooned above individual servings. Makes four generous servings.

## STUFFED GIANT SHELLS WITH TOMATO SAUCE

6 cups basic tomato sauce  
18 giant pasta shells  
1 tbsp. olive oil  
1½ lbs. fresh ricotta cheese, drained  
4 tbsps. parmesan cheese, grated  
6 slices prosciutto, diced  
2 tbsps. parsley, minced  
1 egg yolk  
Pinch sugar  
Freshly ground black pepper  
½ tsp. salt

Prepare tomato sauce and allow it to simmer. Cook shells in boiling water with the oil, to less than al dente stage (they'll soften more while baking).

Remove from water with slotted spoon; drain and cool. Blend ricotta, parmesan, prosciutto, parsley, yolk, sugar, pepper and salt, blending well. Stuff each shell with some of the mixture.

Pour some tomato sauce into a casserole or baking dish. Place stuffed shells in the sauce; spoon more sauce over each shell. Bake in preheated 400-degree oven for 20 minutes. Serves six, with three shells each, as first course.

fire! This is cave man stuff and should not be tolerated, since their hallmark is the bulldozer. We must think of images.

9. We all know that land covered with vegetation can absorb and hold more moisture and water. For the CULP tells us so. Somehow the South Florida Water Management District must get into this, since it clearly involves the fresh water lens, to say nothing of the Suanee and Hawthorn Acquifers...yes and even the gulf itself. Have we even lost our concern for the sea shells?

10. I would strongly urge Council to deny this permit...or at least require that it go through the normal development permit route. This would naturally kill the whole idea. Should, on the other hand, there be an Act of God (lightening), we might process a permit, permitting it to continue. That would certainly be satisfactory. But then again, it is clearly contrary to the CLUP. We shouldn't mess with Mother Nature!

11. Naturally those not concerned with our unique and delicate barrier island will say that the benefits far outweigh the costs of such a controlled burn. This causes me to do a slow burn, for we all know they do not have data to support that contention. What we need is an environmental impact study. Since so much acreage is involved, this becomes a matter for the Regional Planning Council.

Let the torch bearers provide for us a statement from a registered professional engineer (P.E.) supporting the contention that the benefits will outweigh the costs. After that is submitted, we can then require that they provide supporting data. That should delay the whole thing a little longer. By then it will be too late.

12. Perhaps we could have a regulated rate of burn...say only 150 acres per year. With 5,000 acres in the wildlife preserve, this would take about 33.33333333 years, for a full burnout. (This figure agrees with previous COTI ratios, and thus is very workable.) This would enable a few "lucky animals" to finish out their life cycle in peace. But then again who amongst us wishes to play God?

13. Please let me know when the public hearing is to be held on this matter. If legislation is needed, let me know and I

will have it drafted. It only takes a short time to do so, and it is so permanent. Besides it is cheap, not effecting taxes...at least not very much...and we all share in the expense anyhow...those of us who own land, that is.

Should petitions be required, we can arrange that too. Perhaps a referendum could be held. Do we need a consultant to study it? Or one to interpret the reports of the previous consultants?

14. If you need me to help form a committee, please let me know. Perhaps it could be an extension of the Sanibel Snoopers, even though it is not as yet 1984! Anything to help.

15. Maybe we could set up a trailer near the preserve...sort of a "Check Point Charlie" to prevent people with matches from entering the preserve. Perhaps even a match tax could be imposed, based on the number of matches carried...or we could require a match license...or even a match-walking ordinance!

16. Perhaps a fire moratorium would be appropriate. An emergency ordinance would do quite well. We might even go to a "PEOPLE" MORATORIUM. Now there's a good idea, that I'll bet no one has thought of before.

Maybe some of the present residents would even donate their homes so that we could prevent this ungodly burn. Is money needed? Let's set up a defense fund.

17. If sacrifices are needed, perhaps some more driveways could be ripped out in exchange for a certain number of acres to be spared the torch.

The prevailing theme seems be, "lets not worry about the means employed; its the end that counts! Thus nothing need stop us!!

18. Isn't anyone listening or watchin Really...isn't it important that we have air to breath? Can't we stop the "controlled burn" and the toll it is taking on the humanity in our community?

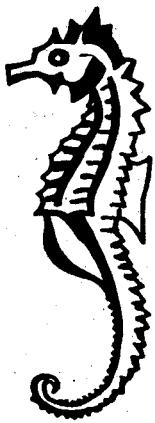

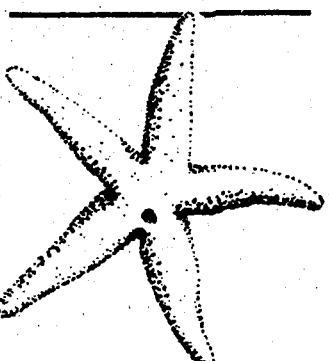

# revised county budget holds tax rate

County Commissioners adopted a revised budget formula last Friday that could hold the line on any tax increase next year.

County Administrator Lavon Wisner presented a proposal to the commission, which they accepted, calling for the use of \$1.3 million in federal revenue sharing funds to offset the costs of items currently in the proposed 1978-79 county budget.

Mrs. Wisner said the use of revenue sharing funds for already budgeted county expenditures, combined with an expected 20 percent increase in tax revenues because of reassessments and growth, should be enough to hold the line at the present millage levels or slightly less.

County Commissioners have already tentatively approved more than \$38 million for the county's budget next year, which would require an increase in the millage to 9.2 mills. By using the revenue sharing funds combined with the increase in tax revenues expected, commissioners say they think they can now hold the line at the current millage levels of 7.2 mills or less and still fund the \$38 million budget.

To fund the \$38 million tentative budget, the county commissioners as a Budget Review Committee had adopted a formula that would increase taxes by 14 percent and would have brought the total county and Municipal Services Taxing Unit (MSTU) taxes to \$19,447,602, Mrs. Wisner said.

With the changes she proposed to commissioners, that figure was reduced to \$19,414,129, or a 13.80 percent increase in taxes. Mrs. Wisner said she did not delete any of the expense appropriations recently made by the county commissioners in their budget hearings.

To obtain the reduced tax total, she reworked revenues, allocated reserves, and the cash carry-over. She increased revenues by \$700,000, reduced allocated reserves by \$300,000, and made adjustments to the grant funds for the Senior Citizens Center and included a \$2,160,000

cash carry-over. That budget also included interest of \$1,350,000 for bond indebtedness of the road bond issue.

Mrs. Wisner submitted to commissioners a proposal which would further reduce the budget to only a 10 percent increase for taxes. She accomplished this by deleting \$1,300,000 in present budget expenditures and assigning them to the budget of the federal revenue sharing funds. Mrs. Wisner estimated that with the projected 10 percent in new growth, and another 10 percent for reassessments, the county millage level could be lowered to as low as 6.7 mills, although she said "I would prefer to say simply that I think we can hold the line at the present millage" level of 7.1 mills.

Commissioners also accepted her recommendation to reduce the county contingency fund by \$300,000 to a level of \$1.2 million and appropriate a 5 percent cost of living increase for all county employees.

"The cost of living index is up over 7 1/2 percent and studies done by my office and the Personnel Department reflect that the (county) pay plan needs at least a 5 percent adjustment," Mrs. Wisner said.

She indicated that she had planned to make the recommendation earlier in the budget session but did not do so because of pending collective bargaining elections.

Mrs. Wisner said that with the growth rate of the tax roll of 10 percent, "this would mean that the individual taxpayers would pay no more taxes on their tax bill with this formula."

The \$1.3 million in federal revenue sharing funds includes tentative funding of \$119,800 for the Senior Citizens Center, \$367,500 for two county property purchases, and \$190,600 for installation of federally-required safe drinking water equipment, well plugging, lab equipment, and drainage and water control equipment in the county's water system.

Commissioners also budgeted approximately \$574,600 worth of road construction from the transportation fund and assigned it to the revenue sharing.

This leaves an estimated \$260,000 for commissioners to allot to pay for some of the more than \$2 million worth of requests submitted this week by citizens for use of the revenue sharing funds.

County commissioners set Sept. 26 at 9 a.m. for a public hearing on the revised tentative budget and the separate millage budgets for various lighting and other special taxing districts.

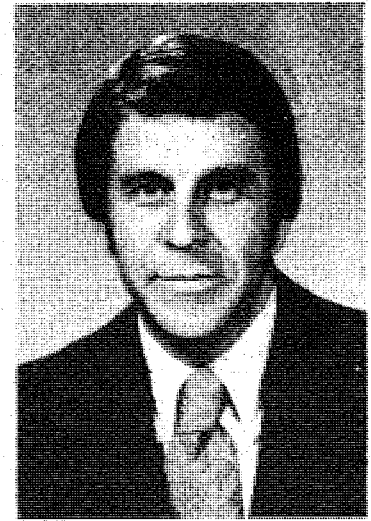
Scaffé recently resigned that post to run for Lee County Commission District 4 with the intention of bringing an experienced "common sense" government philosophy to the commission.

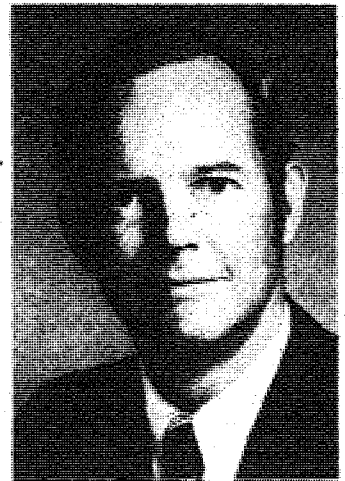



# THE TRUTH ABOUT THE TOURIST TAX

A little over a year ago, the Legislature of the State of Florida passed a bill entitled the "Local Option Tourism Development Act".

The bill enables local government (in this case, Lee County Commissioners) to enact an ordinance providing for a tax of up to 2 percent of the gross rental income from any hotel, apartment hotel, motel, resort motel, apartment, apartment motel, rooming house, tourist or trailer camp or condominium rented for a term of 6 months or less.

The ordinance as enacted by the County Commission must be passed by a referendum vote by a majority of the electors voting in such an election:

All monies collected under the tax must be used for one of three purposes:

- a. To acquire, construct, extend, enlarge, remodel, repair, improve, maintain, operate, and promote one or more publicly owned and operated convention centers, sports stadium, sports arenas, colosseums or auditoriums within the boundaries of the county.
- b. To promote and advertise tourism in the State of Florida and nationally and internationally.
- c. To fund convention bureaus, tourist bureaus, tourist information centers, and news bureaus.

The bill also permits the local government to sell bonds pledging this revenue for the purposes set forth above in paragraph (a).

The bill also provides for repeal of this tax by petition of 15 percent of the voters for a referendum to repeal the tax and the vote of the majority of the electors voting in such an election.

However, any repeal by the voters shall be subject to any outstanding bonds for which the tax has been pledged.

In talking with Legislators who passed this bill in Tallahassee, we were informed that the intent of the bill was basically to give local government the taxing power to promote tourism in their area since tourism in many areas of Florida is the prime industry in that area.

Now, let's see what our local County Commissioners have Done!  
 On August 2, 1978, they passed Lee County Ordinance No. 78-14 calling for the **Maximum** tax of 2 percent and placed this ordinance on the September 12, 1978 ballot.

If this ordinance is passed by the voters, the County will sell \$7,500,000 in bonds for a period of 30 years (total cost over life of the bonds will exceed \$18,000,000.00 and use the monies as follows:

1. Enlarge Ft. Myers Exhibition Hall	\$400,000.00
2. Enlarge Cape Coral Civic Auditorium	151,000.00
3. Enlarge & remodel Terry Park Stadium	200,000.00
4. Enlarge & maintain Lee County Agricultural & Recreation Center	300,000.00
5. Construct Fine Arts Auditorium	3,500,000.00
6. Construct Southwest Florida Sports Stadium in Cape Coral	1,390,000.00
7. Construct Aquatic Sports Stadium at Terry Park	500,000.00
<b>Total</b>	<u>\$6,441,000.00</u>

The balance of the funds from the bond issue amounting to \$1,059,000.00 shall be placed in a separate fund for maintenance and operation of projects 5, 6 & 7 above. After one (1) year any monies left over in this fund must be used to help liquidate the bonds.

The ordinance states that expected revenue from this tax will be \$955,977.00 the first year and increase to \$1,137,230.00. Where did these figures come from? No one seems to know....

Don Bottoroff of the Chamber of Commerce reports there are 6,000 motel and hotel rooms in the county. The Lee County Motel Association reports that average income per room per year is \$5,000.00. 2 percent of this total room rental per year would amount to only \$600,000.00. Maybe the balance of the so called expected revenue is to be collected from people renting their beach house, condominium or apartment for a week or two at a time and reporting this on the honor system. We doubt it!

How is it possible to expect the revenues the second year to increase by \$181,253.00 or 19 percent over the first year? What businessman increases his business by raising his prices? It all amounts to economic nonsense.
