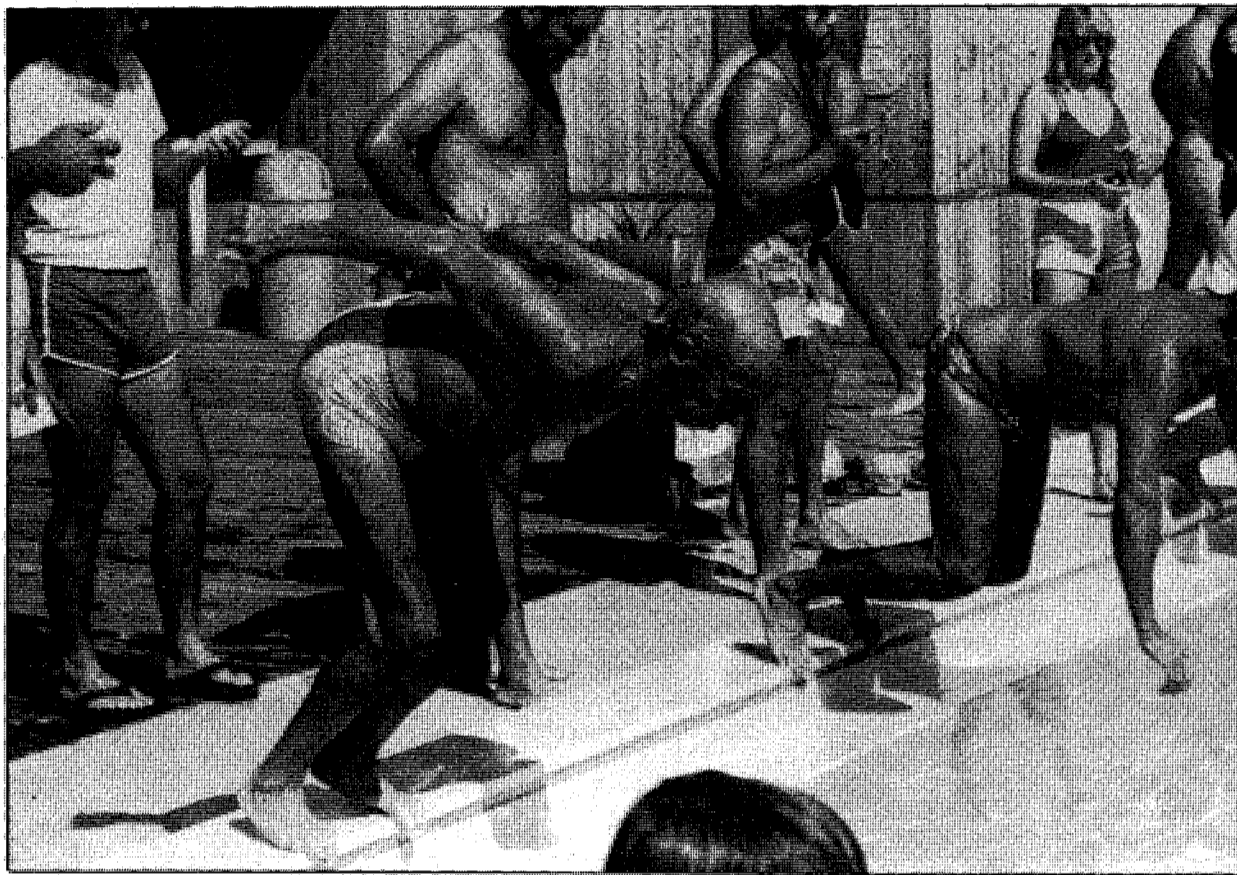

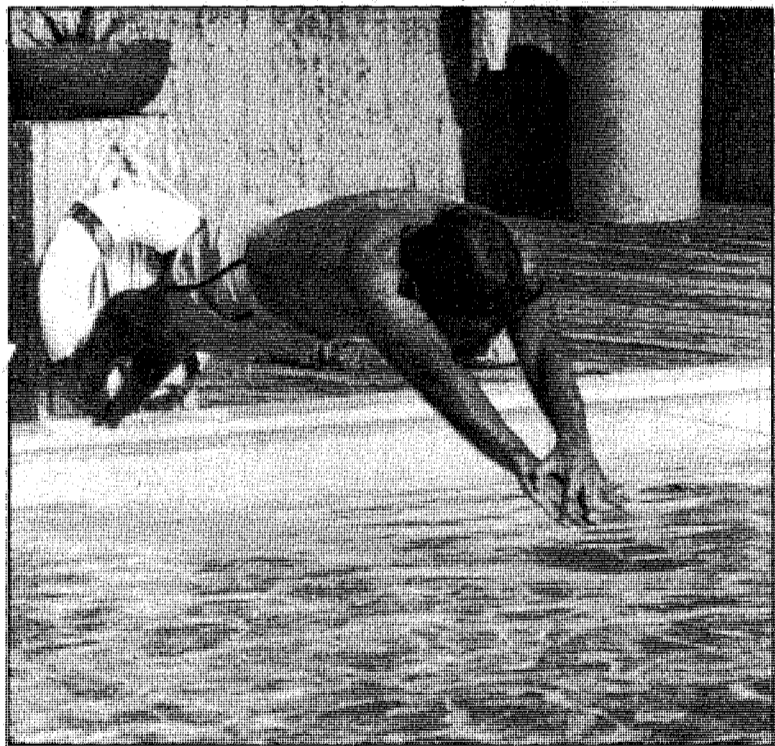

SPD wins first Fishbowl Classic

The first Annual Sanibel-Captiva Fishbowl Classic was held last Saturday, and was a great success with over thirty swimmers from Kiwanis, Lions and Sanibel Police Department competing.

The competition was very close between all three teams until the relay events at the end. At that point the Lions fell off the pace because they could only field three swimmers under 36 and therefore could not enter the under 36 relay races. After that it was neck and neck between the Kiwanians and the Sanibel Police Department with SPD finally winning the competition on the last two races. Final Scores: SPD 114, Kiwanis 100, Lions 69. Interestingly enough, the Kiwanis team scored more first place finishes than did the Police Department, but SPD's many second and third place finishes made up the difference. 'Black Box' seized on Sanibel

The State Attorney's office, with United Telephone Company (U.T.&T.) and the Sanibel Police Department confiscated a "black box" Sunday evening from the home of Fred and Emily Chozianin, Lake Drive on Sanibel. The box is a device that, when attached to a telephone, shows no record of a roll or long distance call.

The investigation, which has been ongoing for several months according to U.T.&T. security supervisor Hermon Behrens, was carried out in cooperation with New York Telephone authorities and coordinated by

telephone company Security head John Kelly.

According to Behrens late Monday, the box had been tested and was found to be in working order. Utilization of a "black box" is a violation of Florida statute 817.482 (1) (A) and is a first degree misdemeanor.

Bill McQuinn, who executed the search warrant for the State Attorney's office, was unavailable for comment at press time but sources indicated that it seems likely that warrants will be forthcoming.

chamber of commerce holds public meeting to review CLUP

Thursday night's public meeting-the result of the review of the Comprehensive Land Use Plan (CLUP) by the Chamber's Civic Affairs Committee-was well attended. Bill Frey, Chairman of the Committee, conducted the meeting and reviewed 11 sections of the plan which seem to present chronic problems.

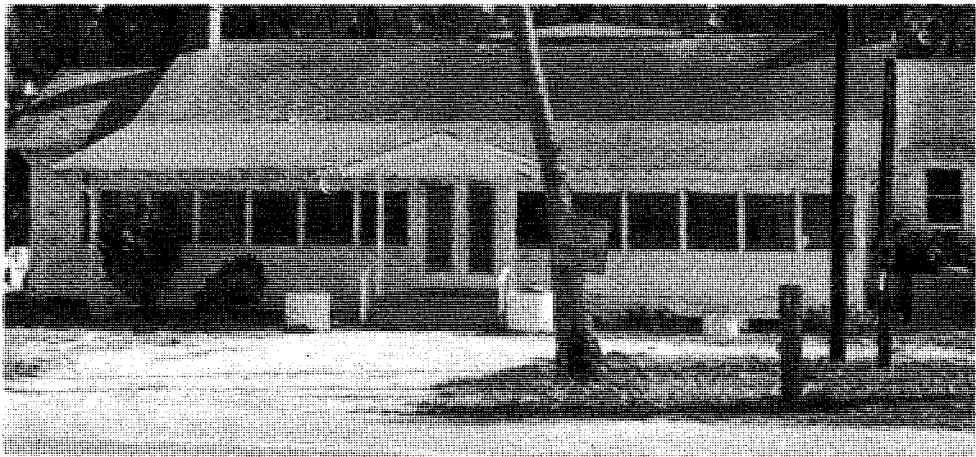
Delays in building permit processing could be resolved by separating the Planning Commission into two functions: planning and processing, Frey reported. It was also suggested that

the CLUP be codified and made more precise.

Considerable discussion centered around the problem of owning contiguous lots but being permitted to build only one home. "This is clearly a problem of equity," said Frey "and one that needs to be addressed."

While the Vegetation Committee was lauded for its performance, it appears to have become dogmatic, Frey pointed out, "and the trend is that the

recommendations of the Vegetation Committee usually appear on Development Permits as a requirement of the City."

"We are persuasive, I admit," replied Vegetation Committee Chairman George Campbell. In order to encourage the building of single family homes, it has been suggested that coverage requirements in certain areas be increased to 35 percent rather than being held at 20 percent.

Ordinances, some called "nuisance" must be reviewed and certain ordinances eliminated, according to the committee. Restraints should be exercised in the passage of all new ordinances, the Committee recom-

mended.

Possible rate of growth legislation has caused considerable concern especially among those who bought for retirement. A possible solution suggested at the meeting would be to exempt single family dwellings from any rate of growth ordinance. While a new Circulation Element is approaching final form for inclusion in the land use plan, the Civic Affairs Committee suggests that traffic planning and storm drainage be given top priority over the next two years.

The meeting, held on an informal basis, was well attended by members of the Planning Commission and City Council.

Mariner properties files suit against former city employee

Mariner Properties, Inc., a Sanibel-based developer, has filed suit in Lee County Circuit Court against former assistant to the city manager Steve Maxwell. The suit, arising out of allegations made by Maxwell to the State Ethics Commission involving the firm, requests compensatory and punitive damages of \$100,000. The case has been assigned to Judge Wallace R. Pack.

Maxwell alleged to the Ethics Commission that Mayor Zee Butler and Councilman Porter Goss had financial interests in the firm and that they had voted in favor of Mariner Properties in permits and ordinances. Goss and Butler have denied the charges and the Ethics Commission has made a qualified dismissal of the complaint based on legal insufficiency.

Mariner's complaint alleges that Maxwell's charges were "reckless" and "untrue."

Mariner also maintains in their legal complaint that the allegations by Maxwell "although not alleging any direct misconduct on the part of the plaintiffs corporations (Mariner), impute to the plaintiffs by direct inference and unnuendo acts of con-

spiracy, political favoritism, and general dishonesty in their past dealings with the City Council of the city of Sanibel."

Mariner stated that they have been engaged in various business activities on Sanibel since 1971 and "have labored to develop both a reputation as a leading development firm and for honest, straightforward dealings with all persons."

Mariner Properties President Robert Taylor stated that his firm filed the suit because Maxwell's charges "effect our ability to do business with the city. The fact is that we have to work with city officials," Taylor stated, "and his charges can color people's thinking."

In his ethics complaint, Maxwell alleged that Porter Goss' wife, Murial, had a partners share in Mariner Properties as evidenced by her name appearing on the 1977 Partnership Tax Return for the Mariner Group Inc. and Mariner Properties.

According to Goss, the partnership on the tax form is for the equivalent of four percent interest in Useppa Island. Mrs. Goss was one of the 16 original owners of the island when it was purchased in 1972, according to

Lee County records.

When the island was sold to the Useppa Inn and Dock Company in 1977, Mrs. Goss reportedly received a four percent unsecured note, held by all the members of the Useppa Trust. The former Sanibel Mayor has indicated that advice from city attorney Neal Bowen was that his wife's interest in the Useppa transaction presented no legal problems.

Taylor also complained that Maxwell has indicated that he received his information by studying a tax return filed by Mariner while his wife was an employee of the accounting firm of Taylor, Edenfield, Gilliam and Wiltshire in Fort Myers. "How would you like somebody to make your tax return public?" Taylor asked, adding, however, that the allegations that Maxwell made about the return were false. "Taking tax returns is a criminal act," Taylor stated flatly.

Maxwell is claiming that it was because Goss and Butler each waived their rights of confidentiality about the Ethics Commission complaint that the charges were made public and any damage that was done arose from that act.

Taylor disagreed. "I can't except that if an individual files a false charge and it is made public, then it is somebody else's fault," he said.

Taylor also complained about the activity, or lack thereof, on the part of the State Ethics Commission "They haven't done anything to clear up these charges," he said.

Maxwell, who was terminated by Nungester in May, for "attitudinal differences" has been indicated as one of a group of Sanibel citizens who approached State Attorney Joe D'Alessandro with charges on wrongdoing involving his former boss, city manager Bill Nungester and the Building Department. After an investigation, D'Alessandro ruled that there was no evidence of criminal wrongdoing. In September, Maxwell filed a charge with the Florida City and County Management Association against Nungester charging that Nungester has not lived up to the Association's Code of Ethics. A final decision on those charges has not yet been made public.

Mariner's suit against Maxwell has not been scheduled a court time.

commentary

The race for the State Attorney, to be decided today, will be one of the closest of this election year. Incumbent Joe D'Alessandro faces stiff competition from challenger Frank Alderman. Alderman has an excellent record as a defense attorney and has the support of many local lawyers.

The ISLANDER, however, believes


that D'Alessandro would still be the better choice for the following reasons: His policy of effective cooperation with local law enforcement agencies, including the Sanibel Police Department, is an excellent one and, if this cooperation doesn't exist and we feel it might suffer under a new state attorney, then the quality of law en-

forcement also must suffer.

Secondly, the manner of practicing law differs between defense and prosecution attorneys. A defense attorney wins his cases on legal technicalities, while a prosecutor concentrates primarily on issues and evidence. Thirdly, the crime rate

under D'Alessandro has been low in Lee County.


These factors are of vital importance to successfully keeping crime to a minimum and we recommend that we would be better off maintaining these important strengths. For this reason, the ISLANDER endorses Joe D'Alessandro for state attorney.



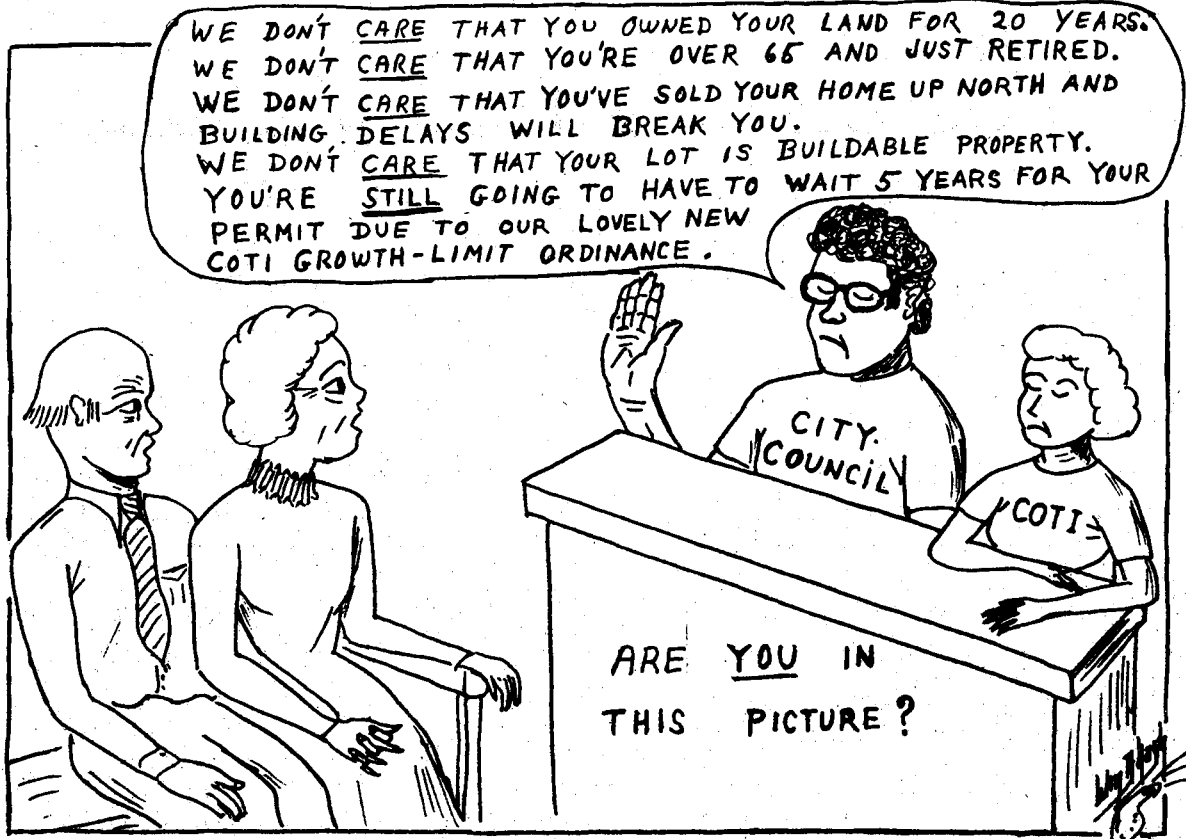

PLANTS for SIGHT

Second annual health fair scheduled for Sat., Nov. 18

The high turnout at last year's Health Fair has prompted the organization of a second event on Saturday, November 18 from 10 a.m. to 4 p.m. at the Sanibel Community Association Hall.

Health Fair Coordinator, Dr. I. H. Simmons, has remarked that this is the only community project that has

the full joint support of most of the Island's service groups: The Kiwanis Club, the Lions Club, the American Legion, the Sanibel Community Association and the Chamber of Commerce. Each club is contributing equal financial support for its success.

Exhibits that are planned for the

Fair will show proper nutrition and dietary specialties required for specific conditions; diabetes and blood pressure screening will be available and blood donors will be typed. The Kiwanis blood bank will be in operation.

The Lions Club will be involved in sight and hearing tests including

those for glaucoma and vision screening and hearing tests for the four basic tones.

Tetanus immunization will be available at no cost. Dr. Simmons emphasized the need for people in this area to have that inoculation, especially people working with soil and natural fertilizers.

energy audit underway

The Regional Energy Action Committee (REAC) of Southwest Florida is conducting an "energy audit" to determine the sources, types, and quantity of energy being used in the six Southwest Florida counties of Charlotte, Collier, Glades, Hendry, Lee and Sarasota.

The effort in this region, known as REAC IX, is directed by REAC Chairman Zee Butler, Mayor of Sanibel, with the assistance of Vice-Chairman Frank Balogh, Chief Environmental Specialist of the Lee

County Environmental Laboratory. The Chairman is appointed by the State Energy Office in Tallahassee.

The initial audit is directed at power consumed in buildings occupied or used by city and county governmental agencies; Lee county has 140 such buildings. Each city of each county has appointed an energy officer who is charged with the duty of determining energy consumption. "No one knows what we're burning" states Frank Balogh, "though we know air conditioning is eating us up". In the at-

tempt to conserve energy, we're trying to determine what we're consuming in order to determine how to conserve and save money.

Balogh stated to demonstrate what may be accomplished, last year the Lee County Schools' \$1.6 million expenditure for electricity was examined and recommendations to conserve energy were initiated. The result was a savings of \$160,000. "The school system has become very efficient in energy conservation programs" he

says. "We also plan to determine how much gasoline, oil, and other energy consumables are being used to operate patrol cars, fire engines, utility trucks, etc."

While the initial audit is directed at the public sector, the private sector will also be examined. "Only when we know what is being used where and for what purposes", he concluded, "can we begin to get a handle on the energy situation in Southwest Florida, and only then will we begin to know what it is we are dealing with."

Shark expert first speaker in nature series

Dr. Gordon Hubbell, director of education and research at the Crandon Park Zoo in Miami will be the first speaker in the new Gulfside Nature Series to be presented Saturday, November 11, 4 p.m. - 6 p.m. at Sanibel Beach Club II resort on Lighthouse Road, Sanibel Island.

His program, "Jaws on Sanibel" will draw upon Dr. Hubbell's internationally acknowledged expertise on sharks. The program will relate to sharks of Florida with special reference to Sanibel.

The new programs in the "Gulfside Nature Series" have been planned and produced by Nora and Don Dietlein, Captran's Environmental and Conservation Division directors. In announcing the featured speakers the Dietleins said: "We plan to have speakers who are highly qualified in the fields of animal and land conservation. The majority of guest speakers will be talking on issues relevant to Florida and will include many talented Sanibel residents."

"We personally hope that island residents will be as enthusiastic about this lecture series as we are and we hope they will take the opportunity to come to the lectures and meet the speakers personally."

Additional speakers scheduled are Mario Hutton who, with Elaine Patton, former television actress and currently proprietor of the Owl and the Pussycat gift shop and gallery, will present his appealing Photo Verse programs featuring island scenes he has photographed during his longtime residence on Sanibel. "Photo Verse" will be presented on Saturday evening November 18, at 4 p.m.

On November 25, also at 4 p.m., Jerry Lenz, zoological director of Tampa's Busch Gardens will speak on the role of animal parks in animal conservation.

Paul Mohler, director of the division of threatened and endangered reptiles of Florida for the State's Game and Fresh Water Fish Commission, will talk on the endangered reptiles of

Florida with special reference to the Florida Crocodile, on December 2, at 4 p.m.

Additional guests scheduled include Warren Zeiller, director of the Miami Sea Aquarium, Mrs. Helen Allin, an expert on the techniques of making local jelly, Dr. Glenn Woolfenden, professor of Ornithology at the University of South Florida in Tampa, and Robert Baudy who will speak on the Florida Panther.

Dr. Hubbell, who will be the first speaker, became interested in shark fishing in 1966 and to date has caught 157 sharks in South Florida and the Bahamas. Fifty three per cent of these sharks have been caught on spinning tackle.

He has kept accurate records on all sharks caught -- recording species, length, weight, sex, location, bait, tide, moon phase, weather conditions, and stomach contents.

This data has been used in two scientific papers dealing with shark populations.

Shark jaws which have been

prepared by Hubbell are now in the collections of the New York Aquarium, Shedd Aquarium, Vancouver Aquarium, New England Aquarium, Steinhart Aquarium, Marineland of Florida, Marineland of the Pacific, and the Seaquarium, as well as several zoos, museums and universities for use in educational displays.

Dr. Hubbell said "three years ago my wife and I were introduced to fossil hunting in the phosphate mines of Central Florida. We've made a total of 24 fossil hunting trips collecting almost 51,000 shark teeth. Approximately 30 percent of the teeth collected are in good shape; the remainder are chips and pieces. Almost 80 percent of the fossil teeth that we find are identical to sharks which live today. Our goal is to develop an identification key to the fossil sharks of Florida.

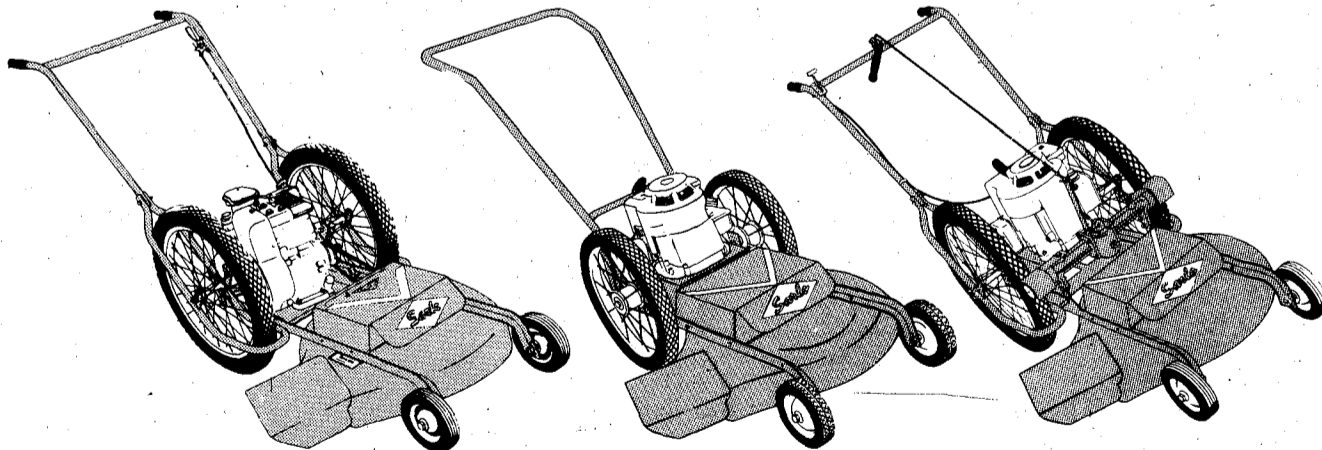
Hubbell is a Doctor of Veterinary Medicine who received his degree from Ohio State University. He resides with his wife Katherine, daughter Carol Lynn and son Steven in Key Biscayne.

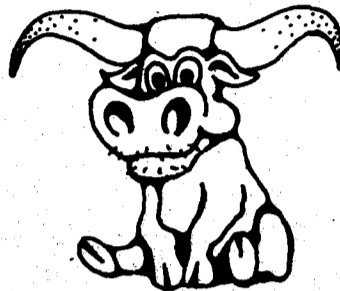
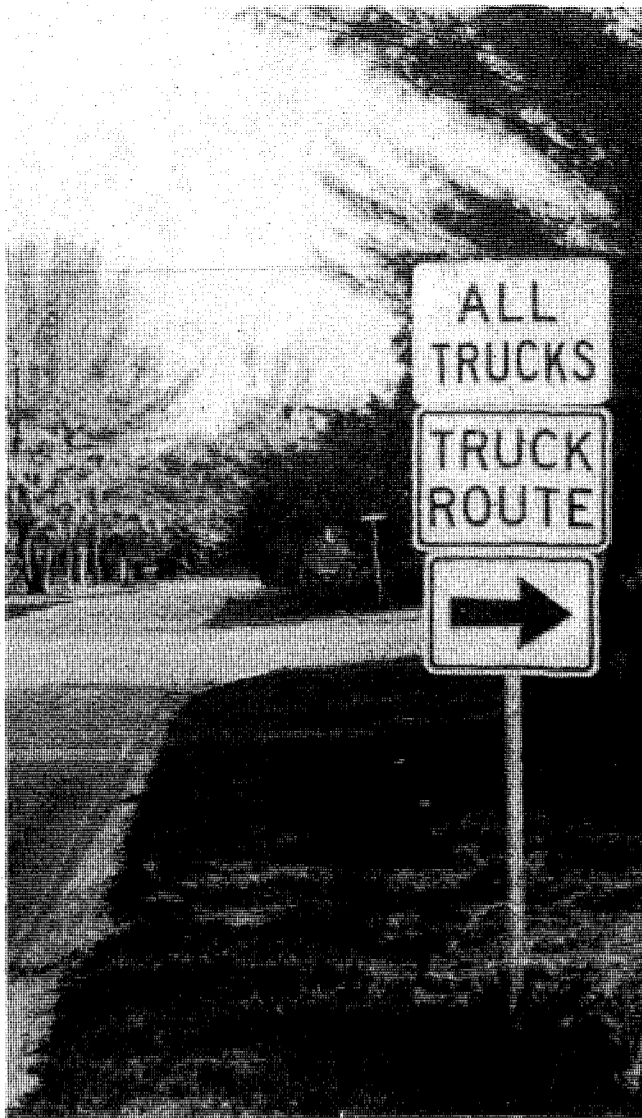

on the water by mike fuery

A couple of months ago, I mentioned that there probably will be some interesting changes in outboard engines this year and in the coming months. I said that there was some industry talk about diesel outboards and now there are two such machines on the market.

The only problem with the diesels is that the machinery isn't exactly a delicate little bundle of joy. For instance, the Italian-made Carniti engines offered for the first time in the United States this year are real heavy weights.

The six horsepower Carniti weighs 150 pounds. And it's bigger brother, the 16-hp engine is 264 pounds, which is well over double the weight of American-made outboards of similar power.

The practical applications or uses of these diesels would have to be on slow moving displacement hulls to be of any use so far, but lighter models are coming.

While at the Miami-Dinner Key Boat Show recently, I tried to find a dealer for the Carniti engines, but so far no one locally seems to be dealing with them.

Incidentally, my personal opinion of new corp boats, engines and accessories is that the industry is going flashier in appearance and poorer in quality.

There's a lot of feature-stealing between boat manufacturers. It seems to me one company hits on a good design

on their boat and the next year, all the boats have it. Robalo boats came out with their "t" top sun cover and several firms have nearly exact copies of it for sale.

I know you've been reading about fishermen bringing in some good redfish catches and you can get in on the action too. The reds have finally come up in numbers. The standard popping cork rig, with large shrimp is a best bet for fishing the islands in Pine Island Sound and around the wildlife sanctuary areas. There have been several nice reds taken from Redfish Pass in the past week too. A good supply of small pinfish seem to be the key here to good angling.

Up in Captiva Pass, anglers are having a ball with small grouper. Remember that the grouper have to be 12 inches to keep, so with all the Florida Marine Patrolman in the area on drug busts, you better carefully measure that fish before you put it on board.

The other day we must have caught 15 or so grouper on a yellow half-ounce jig in Captiva Pass. This deep jigging method often works well, but when you snag out that lure you can wave goodbye to 75 cents or a dollars worth of lure. In all those fish, taken within 45 minutes, I don't think there were more than three or four over 12 inches long. Incidentally, ISLANDER writer Jack Roemer was fishing with me that day and we released all the fish taken.

If you are new to the island, or a visitor, remember that there is a free

fishing pier at the lighthouse end of Sanibel Island which often offers good fishing. There are sheepshead, trout and, as usual, a lot of catfish and jacks.

The steady strong winds are all but killing any serious trout fishing out on the grass flats. There were several

boats trying their luck just north of the second set of power lines this past week, but I didn't see them pulling in very many trout at all. Once that wind calms, or between cold fronts, a quick trip to the flats will probably produce a couple dozen good trout in an afternoon.


Fishing is not just a sport - it is a way of life. In a sense it's like living on the islands - a unique and mysterious something really grips one and a gut feeling tells you there is something rather special taking place within you.

I say, find a man who truly loves to fish and invite yourself along on his next trip. You will doubtless return home tired, dirty, with fish to clean and cook, and hooked on fishing. Fishing, unlike other pastimes requires none but yourself - maybe that is part of the secret. A good fisherman must like himself so that he can spend that time alone. It also does not of necessity demand much in the way of gear - the small boy with his stripped willow limb, string, safety pin and worm and the marine fishing in the Potomac with

a piece of cotton for bait point up the truth in this. And who is to say that their joy is any less than the fellow with a full tackle box and the very finest rod and reel (or vice versa). Surely not I.

Aside from the competition and the contemplativeness, fishing develops the ingenuity and stirs the imagination. No good fisherman is going to head home just because some fish snapped his line and took his hook and leader - or just because his live bait fell overboard. After the initial anger, he then comes up with some other method of catching Mr. Fish. He will also learn from the past. Next time his line will be stronger, next time his bait more secure.



 In between these points on gulf or bay - guesstimate - and have good fishing and or shelling.

One of the fish he might encounter around the islands these days is the redfish. In fact he would have difficulty not running into at least one of them of

some dimension if he spent any time on the water a'tall...

Now the redfish is not really red (or at least not in the sense we usually think of as being red), however the flesh color is let us say, a paler tone of that vivid hue we conjure up in our minds. And he is marked, with a black spot at the base of his tail. He is also known as a bottom fish who feeds

primarily on crustaceans but is not averse to taking a mullet or two. Those who inhabit the Gulf waters do not participate in coastal migrations as do their Yankee cousins, and possibly this is one of the reasons that this particular species often suffers from mass mortalities due to freezing weather.

In these waters when you sight a fisherman standing waist deep, surf-

casting, more than likely he has redfish on his mind. Now this is truly a game fish and fun to catch because, though he is not a jumper, when hooked he will head straight for China and will put up a steady, hard fight until the moment he is landed.

Aside from the joy of the catch, Mr. Redfish is well worth any effort put forth as he most assuredly has to fall into that group of fish termed "mighty good eating."

Let it not be said he is the only fish hereabouts these days - Zack Pierce, a 13 year old Islander, caught a 13 lb. snook, using a No. 2 silver spoon as bait. He did this deed casting out from the bar at Tarpon Bay. Several other good sized snook were brought in from the causeway area this week. Trout has taken over the headliner spot and can be found all over.

Mackerel should start running soon, in the meantime good fishing! good catching!

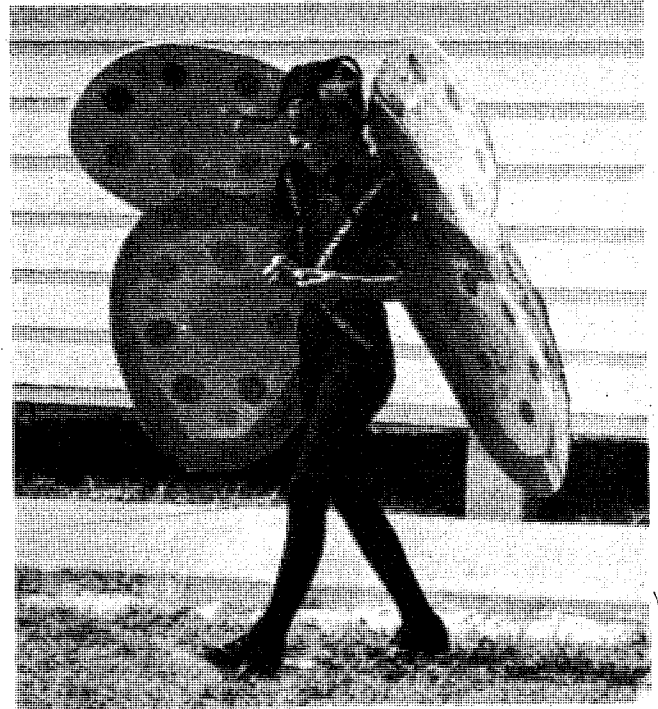
Halloween on the islands

food for thought

ignored vegetables

Want to know how to tell a good restaurant, a really good one, especially when it comes to Italian or Greek cooking?

Order a dish that contains eggplant or zucchini and see if it is served with pride, steaming hot, (especially eggplant parmigiana).

In this country, eggplant and zucchini are treated with less than their due share of respect. If a restaurant handles either of these vegetables well and serves them properly, it usually follows that it offers a good overall menu.

Both vegetables are members of the squash family and grow with great proliferation here and in the Mediterranean regions. They are almost impossible to kill (although I have killed them) and are fun to watch grow.

Along with other vine-type plants such as watermelon, they are filled with a lot of water. They are also inexpensive to buy in Florida. It is often possible to get a whole bushel of eggplants for a few dollars. Sometimes they're marked at 15 to 19 cents each, no matter what the size. Zucchini is often available at 30 cents a pound for a dollar, even cheaper if you pick your own.

Instead of a lengthy background into their histories and family origins, I will share some of my favorite recipes for serving them, both hot and cold.

Use them as often as you can and see those food costs come tumbling down while you eat well.

STIR-FRIED ZUCCHINI OR EGGPLANT

Large eggplant or 1-2 lbs. of zucchini
1 medium onion
1/4 cup soy or teriyaki sauce
1 cup chicken broth (optional; water or tomato juice will do fine)
2-3 Tbsp. cornstarch mixed with above liquid

Cut whichever into about 1/2 inch cubes. Pour about 2 tablespoons peanut or other oil into wok or frying pan and quickly cook while tossing frequently the zucchini or eggplant and minced onion.

Add soy sauce and cornstarch mixture. Toss frequently until desired thickness of sauce.

Serve over rice or as a side dish with any form of dinner desired.

EGGPLANT OR ZUCCHINI FRITTERS

1 small eggplant or zucchini
1 recipe basic fritter batter

Prepare the eggplant for frying according to the instructions that follow. Dip the slices into the fritter batter one piece at a time, then drop several at a time into hot oil at 375 degrees. Brown on one side, then turn and brown on other. Remove with slotted spoon and drain on paper toweling.

These eggplant, zucchini or even cauliflower fritters

may be drained and frozen, and then reheated as you would with frozen french fries.

BASIC FRITTER BATTER

1 1/2 cup sifted all purpose flour
1 tsp. salt
2 Tblsp. oil
1 well-beaten egg

Sift the flour and salt together into a medium bowl. Add the oil, egg and about 1 cup of cold water or enough to make a thick batter. If the batter does not adhere to the vegetables, add 1 or 2 tablespoons of water to the batter. This will make about 2 cups of batter.

PREPARING EGGPLANT OR OTHER SQUASH FOR FRYING

Cut into thin slices about 1/4 inch thick. Lay out on paper or turkish toweling.

To remove any trace of bitterness and excess moisture sprinkle with salt and allow to sit for about 30 minutes.

Soak in a bowl of water for about 10 minutes to remove all traces of excess salt and pat completely. Proceed to fry.

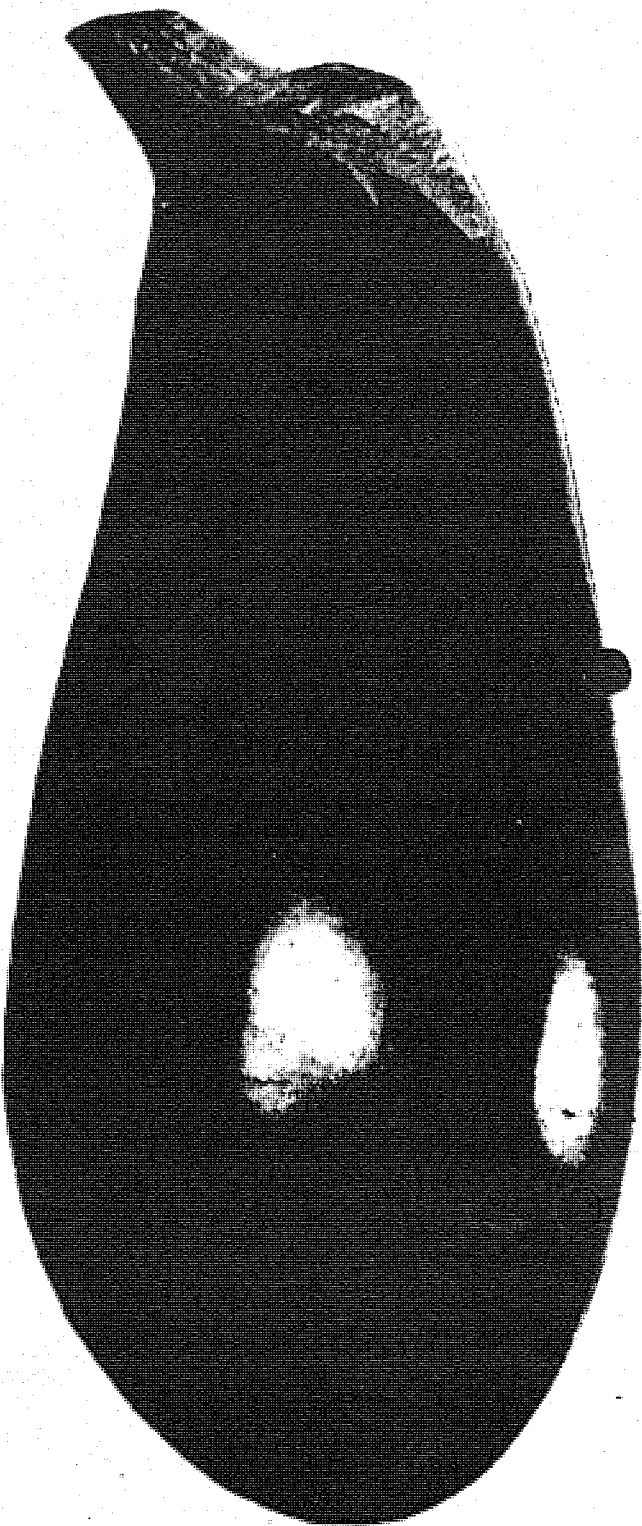
RATATOUILLE

1 medium eggplant
1 large sweet red pepper (if available, otherwise use green)
4 medium tomatoes
3 small zucchini
one-third cup olive oil
2 medium onions, finely chopped
2 small cloves of pressed or minced garlic
2 tsp. minced parsley
1 1/2 tsp. salt
1/4 tsp. pepper
1 tsp. sugar

Trim the stem from eggplant but do not peel. Cut into 1/2 inch slices, then cut into cubes. Place eggplant slices in a bowl with salted water to cover and weight down with plate. Soak for at least 15 minutes.

Remove seeds and membrane from pepper, then cut into strips and chop coarsely. Peel the tomatoes and chop coarsely. Cut the ends from zucchini, then slice crosswise thinly.

Heat oil in "dutch oven" until sizzling, then add onion, sweet pepper and zucchini. Cover and cook for five minutes, stirring occasionally. Combine the garlic and parsley, then stir into onion mixture. Drain the eggplant thoroughly, then stir it into the rest of the mixture. Cover and cook for five



more minutes. Add the tomatoes, salt, pepper and sugar and mix thoroughly. Cover and cook for 5-10 minutes or until flavors blend.

Serve hot or cold as desired.

Optional are sliced green olives. Cold, this makes a 'heck uv a salad.'

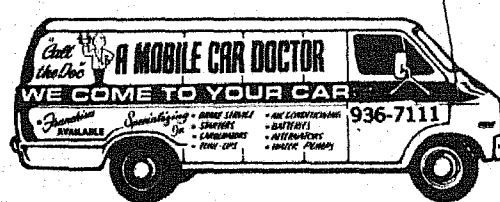

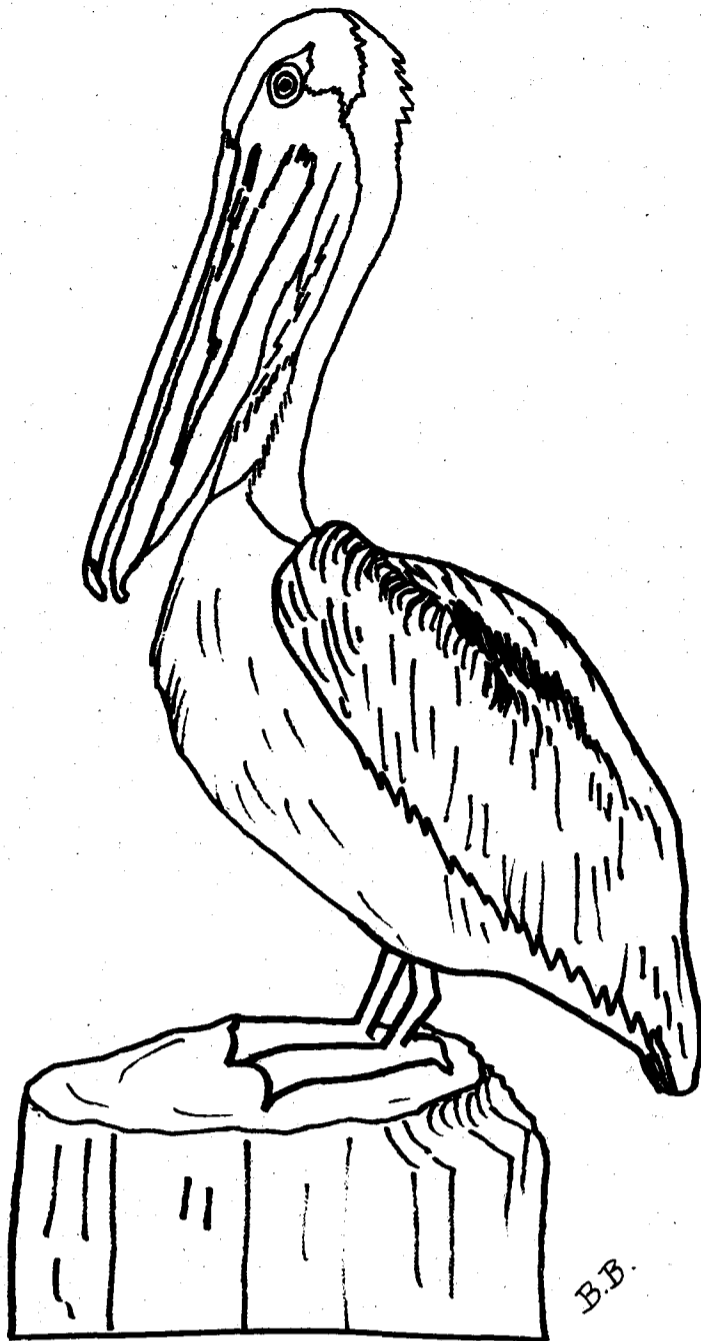

WOODBURNING: A NEW OLD CRAFT

One of the first forms of art was created with wood, fire and primitive tools. The electric woodburning pen and modern woodcutting tools have revived this beautiful art. Rich walnut and cream colored basswood are now available in rounds, planks, and ovals. Many manufacturers of unfinished wood boxes, pocketbooks, picture frames, and other wood novelties became a success when decoupage (the art of embedding a picture to a surface) was popular. With all these pieces of wood available and the decoupage popularity declining, crafters have eased into woodburning.

The beauty of natural wood is enhanced by the textured designs of a woodburning tool. The electric pen retails for about \$6. Choose one with a versatile tip. It should have a thin "cutting" edge for straight lines which can be turned sideways to a flat edge for shading. When the blade is turned over, the tip can be used for curved lines and detail. The flat, shading edge creates a beautiful rounded effect, when it is quickly moved inside a line.

For a first project, I have drawn a pelican pattern for you to trace. Graphite paper is the most common way to transfer the lines to the wood. Transfer pens are now available. Use them with tracing paper, then turn the print face down on the wood and rub the back of the paper. The lines will transfer. You may wish to just trace the outlines and burn the detailed lines into



the wood freehand. Heat the electric pen for five minutes. Try a few lines on the back of the wood to test the pen and to practice. Use the blade side for the long lines of the bill, then outline the large areas. To shade, move the flat side of the blade on the inside lines, especially under the wing. Use the point to make fine lines for the feathers and outline the eye. Remember not to press too hard. Move the pen slowly as it burns the wood.

Color can be added. First protect your product with an acrylic spray. For a subtle effect, use colored pencils or rub oil or acrylic paint into the wood with your finger tip. Brush on paint for brighter colors. Use gray for his wing, dark gray for his breast, black for his feet and bill, white for his neck and yellow for

the top of his head.

The uses for the craft are only as limited as your imagination. Wouldn't the pelican make a nice house sign with your name burned on it? A clock could be made by attaching battery clock works through the back. If you add a few hooks to the front of the wood and burn the letters KEYS, guess what you'll have? The hooks could also hold pot holders. If you shrink the pattern and burn it into a small piece of wood and add a chain and a name, you have a personalized key chain. Now it's your turn to create something!

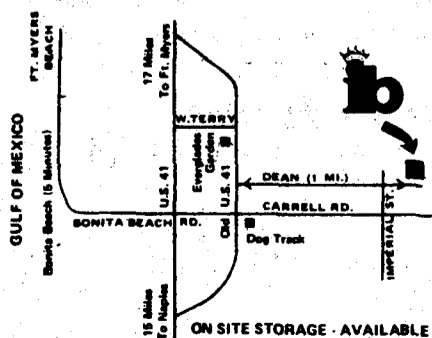

Kay McRae, well - known Sanibel artist and plant fancier, gave us her permission to refer to her as a fine, feisty person. She knows we mean it as a compliment.

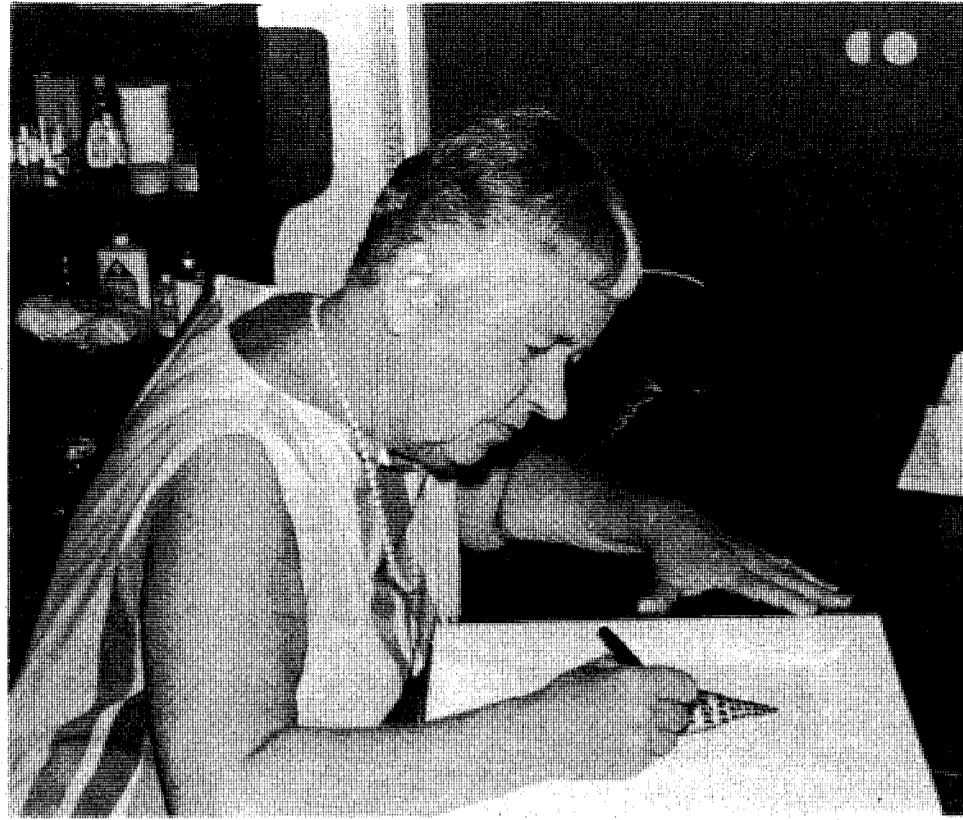
To some people, the meaning of the word "feisty" is a downer. Actually, after a long period of time during which this particular word was not in common usage, you see it in print quite often these days. It's a popular description of colorful candidates for one office or another who get things done in their own colorful ways. You read about a feisty Senator, Governor, member of the Supreme Court, or whatever. All outstanding leaders in their various fields.

The dictionary lists two meanings of the word: "spirited; frisky", and "touchy, excitable, quarrelsome."

Well, even some of our most gentle and proper friends have their moments of being a bit touchy or excitable or quarrelsome. When you concentrate on the definition of being spirited and frisky, you come up with the complimentary side of the word in question.

Kay McRae is one of the outstanding members of our community in these respects.

Those who know Kay well and find her friendship a joy forever, realize and appreciate the fact that she is an individualistic non-conformer who says what she thinks with few punches pulled. Feisty folks are not inclined to infringe on the rights of others who may not agree with them, but neither are they looking for approval, as such, nor

do they give a hoot about what the neighbors may say. Let Mr. Jones keep up with himself sort of thing. They cherish their right to privacy and their own personal lifestyles and are generally extremely creative individuals.

The Kay of today has come a long way from having been brought up by a proper Bostonian family who lived in Falmouth, Mass. Cape Codders of the

old school, although Kay says her father was apt to be an improper Bostonian when he felt like it. They did a lot of sailing together and she adored him. As the young Catherine Cobb, Kay attended private schools in and around Boston but obviously was never the white gloves type. Always an outdoor girl.

In due time Kay met and married

Milford Lawrence, who owned a florist landscape and nursery business in Falmouth. In order to be of more help to her busy husband, she took a course in the fundamentals of flower arrangements in a Boston Florist School. It was exciting to be of help in every aspect of the business, especially when it meant meeting and getting to know favorite customers and friends of Milford's, among whom were the Kennedy family living in their nearby Hyannisport compound.

While were reminiscing, Kay told us one of her favorite stories typical of that period in her life. "People were always asking my husband what landscape architecture meant", she said. "Milford had a great sense of humor. He loved to astonish them by answering 'it means dealing in twees and shrubs wid widdle wed bewwies that dwy up and dwop off'...."

The Lawrences started spending their winter vacations at Casa Ybel in 1951. Kay had already made an impulsive trip to Sanibel by herself in 1940, so it was that long ago that she first developed a serious case of shell fever. After several years of staying at their favorite resort, the results of long hours of ardent shelling produced quite a fabulous collection. Edith Mugric, a close friend of Kay's and the owner of the Sea Shell Shop, at that time helped Kay organize her shells into an outstanding exhibit which she lent to Casa Ybel for display.

Kay and Milford bought a lovely home on Kings Crown Drive and enjoyed as much time as they could spend there until Milford's death in 1971. Kay sold that house as soon as possible and built a Michigan Home on Anchor Drive where she lived for five years, during which time she married Guy McRae, who is also a well known sanibelite. She and Guy are now

happily living together in what Kay calls her "doll-house" on Roseate Lane which they bought in 1976. It was such a pleasure to meet this amazing woman for the first time. 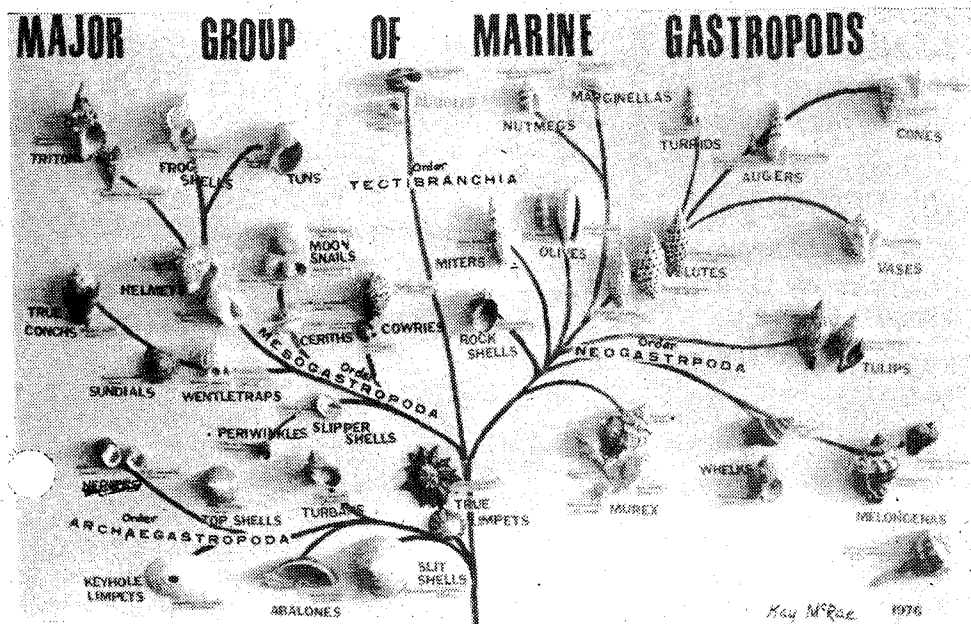
shells come first, then the beautiful and unusual plants, hanging everywhere throughout the house.

Kay has a married daughter, Dorothy Kirkwood, who lives in Atlanta, and two granddaughters; Vivian, a freshman at Georgia Tech., and Claire, now in junior high school and living with her mother. She's a loving mother and grandmother but has little time to talk about it. Her days are not long enough even though she gets up with the birds at 6 a.m.

Manatee awareness month coincides with migration

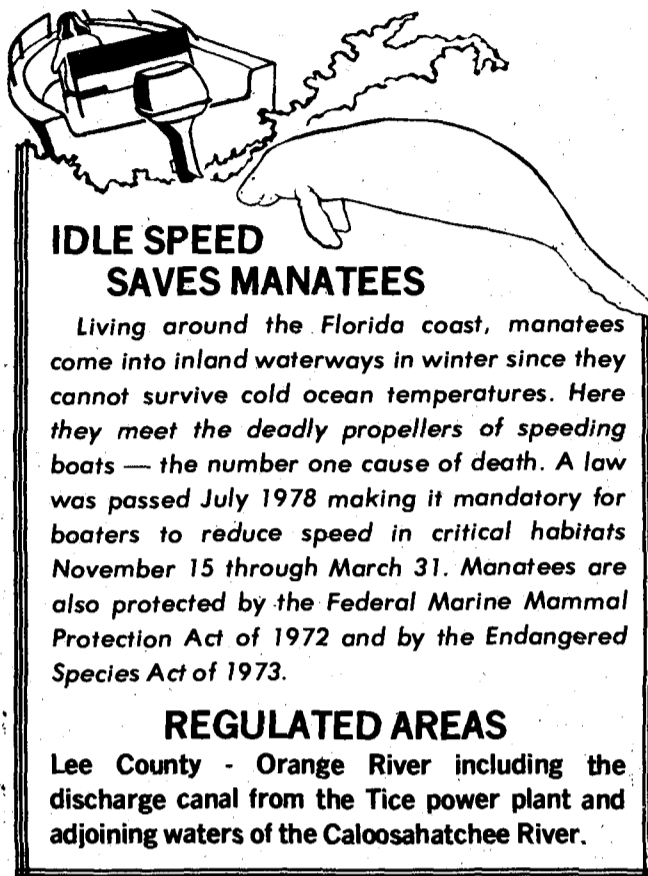
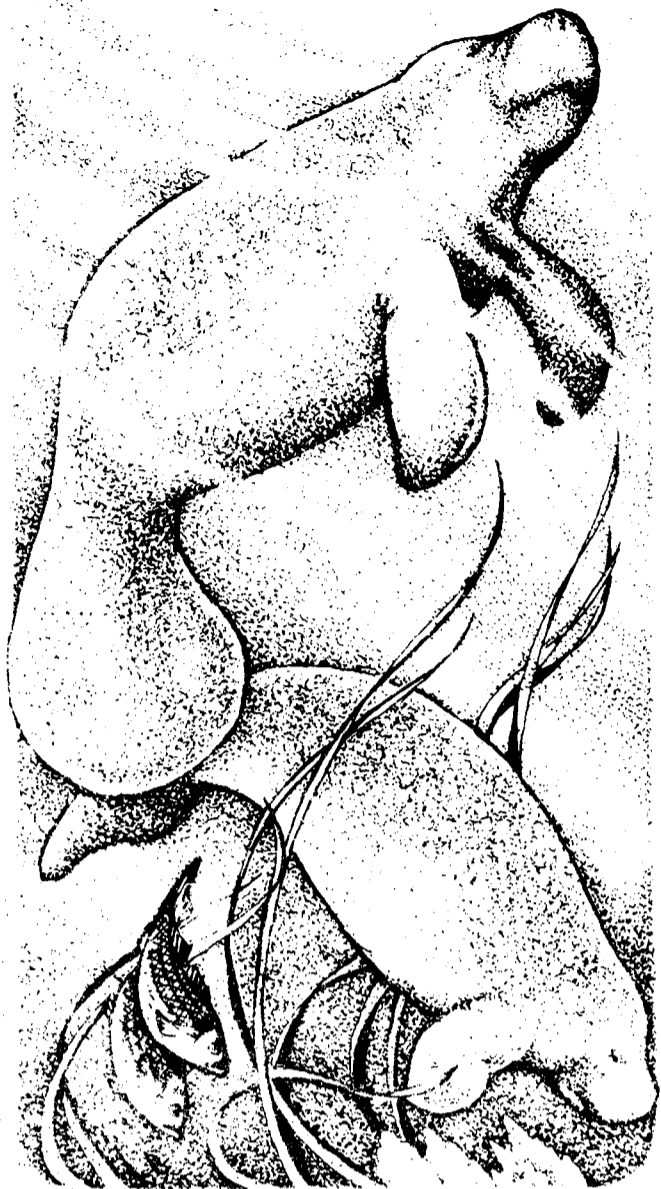
It begins silently, as it has for the centuries before man set foot on the untouched wilderness now called Florida.

But the annual fall migration of the shy and gentle manatee from the cooling edge of the Gulf of Mexico to the quiet backwash of the Orange River may be a crossroads for the survival of this unusual marine animal.

As the manatee seeks the refuge of the warm waters of the Orange River — warmed by the discharge from Florida Power and Light Co. (FPL) massive power plant — it gropes for a toehold that could be its last stand before extinction.

But State Department of Natural Resources (DNR) officials have launched a massive public awareness program they hope will bring the manatee back from the brink of extinction in Southwest Florida and throughout the state.

Governor Reubin Askew has proclaimed November "Manatee Awareness Month" to coincide with the fall manatee migration and the imposition of tough new boating restrictions in 10 manatee sanctuary areas in Florida.



IDLE SPEED SAVES MANATEES

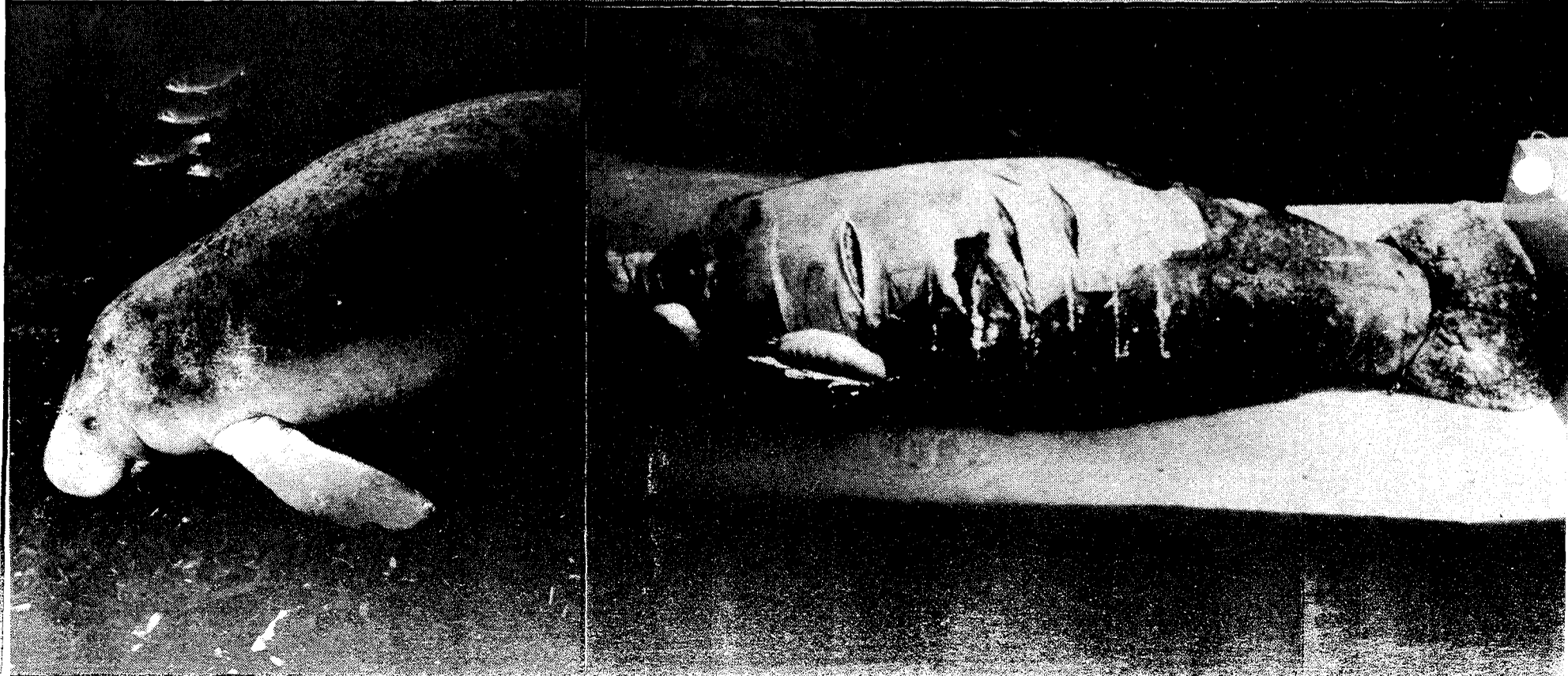
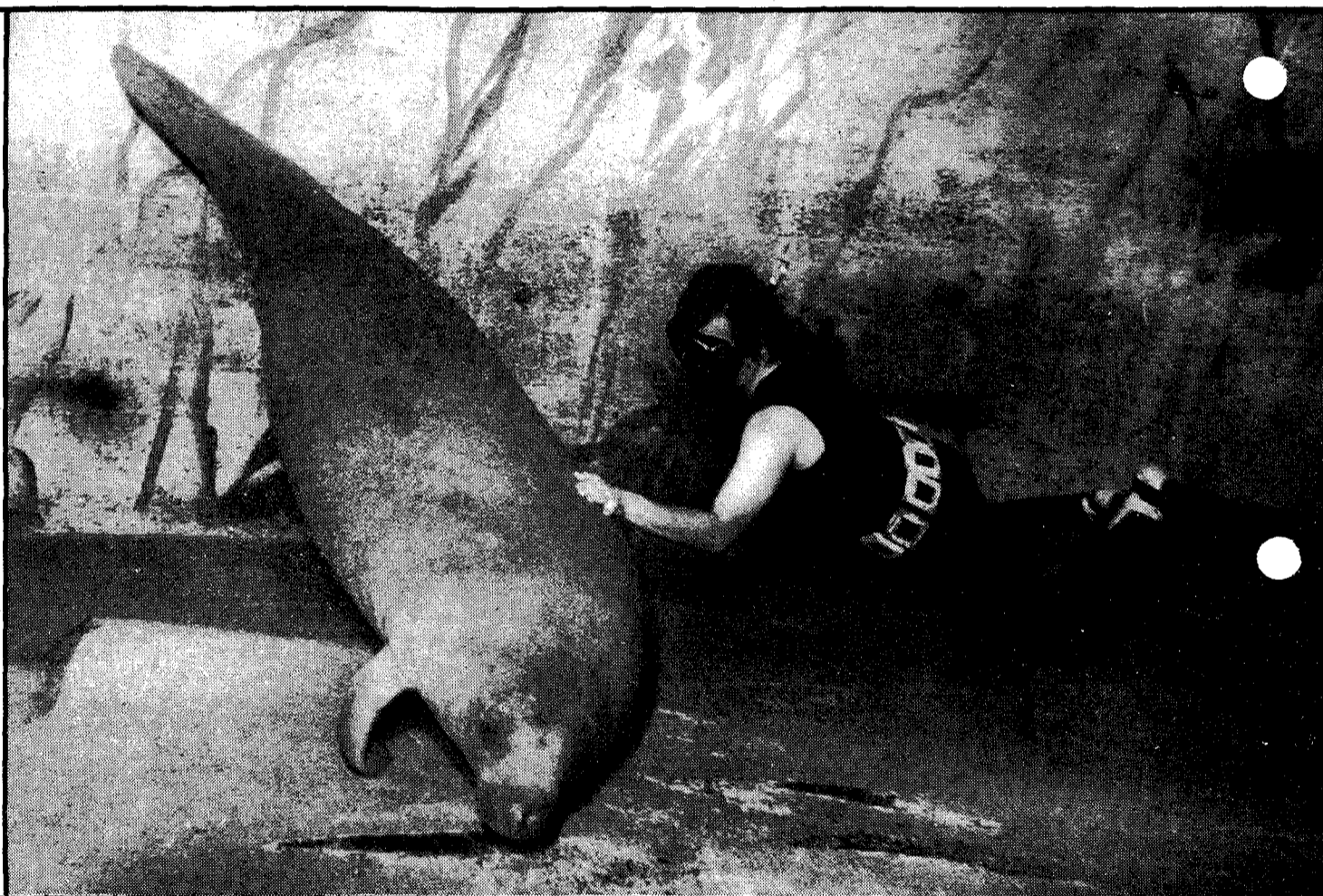
Living around the Florida coast, manatees come into inland waterways in winter since they cannot survive cold ocean temperatures. Here they meet the deadly propellers of speeding boats — the number one cause of death. A law was passed July 1978 making it mandatory for boaters to reduce speed in critical habitats November 15 through March 31. Manatees are also protected by the Federal Marine Mammal Protection Act of 1972 and by the Endangered Species Act of 1973.

DNR's \$135,000 public education and conservation enforcement program is designed to put teeth into tough new regulations for manatee protection passed in last year's legislature.

The new program also includes the establishment of a 24-hour hotline for the public to report injured manatees or those that are being unlawfully harassed.

State Rep. Frank Mann, who sponsored a manatee protection bill in the Florida House this year, says that the key to the program's success will be determined in Southwest Florida and the upper reaches of the Orange River. Scientists say those regions have the largest winter concentration of manatees in the state.

More than 250 manatees have been counted near the thick marine grass beds of the Orange River - apparently attracted by the warm water discharge of the FPL plant.

Dr. Matt Brennan of the county's Environmental Education Center questions the impact of the power plant discharge. "We don't really know if the warmer water is attracting them or not, or what will happen if the discharge is halted."

State DNR officials have declared 10 manatee sanctuaries throughout the state - the majority located near power plants.

Boating is being restricted in those sanctuary areas from Nov. 15 to March 31 of each year. The Florida Marine patrol will be enforcing new speed regulations that allow boats to travel only at idle speeds in the Orange River during this period, and will enforce slow speed limits on the Caloosahatchee River within

one mile of either side of the mouth of the Orange River.

Almost every adult manatee bears ugly propeller scars as evidence of a close encounter with a speeding boat. For many manatees, that encounter is fatal. The animal, an air-breathing mammal, must surface to breathe, and will dive again when it hears the propeller of an approaching motorboat.

But the slow moving mammal does not have time to avoid boats, and local Marine Patrol officers note that some manatees may be injured when larger vessels enter the shallow Orange River to use the marina facilities.

There are only three species of manatees that still exist in the world - and all are considered endangered.

Those three species have continued to retreat from man's encroachment, and the Florida Manatee (*Trichelus manatus latirostris*) - now found only in this state - once inhabited waters from North Carolina to the Texas gulf coast.

The Florida manatee is a sub-species of the Caribbean manatee, which inhabits the Caribbean islands and the north coast of South America. The Amazonian manatee inhabits the vast and remote Amazon River basin and the West African manatee is found along the river basins from Senegal to Angola.

Although state and federal law protects the

manatee, protection efforts have proved largely ineffective because the state lacked the power to regulate boat speed in areas where manatees concentrated during the winter months.

The mammal can weigh up to almost a ton and grow to more than 15 feet in length. There is little known about the mammal's reproductive behavior, but it is believed to have a gestation period of about 13 months, with newborn manatees taking from 6 to 10 years to mature.

"This lengthy gestation period and extended period of time that the baby manatee must be with their mothers - combined with the deadly threat of increasing motorboat traffic - makes the manatee's toehold in Florida extremely precarious," Brennan noted.

bridge...

By Jimmie P. Smith

Bridge, as reputed, is a complicated game. Let's take this complicated game apart and see what makes it work—and how it will work for you. The game consists of two parts, Auction and Play.

To learn the AUCTION part of this two-part game, you must learn POINT COUNT, basic to everything that takes place during the play as well as during the auction. Since the late forties, the system popularized by Charles Goren has been universally used as Goren's simplified system spread the game around the globe: 4-3-2-1 for high cards and for suit shortness.

Although POINT COUNT lacks perfection, it is an attempt to describe in simple numbers the evaluation of a hand—of its face card strength and of its trumping power. It's the easiest system yet devised to learn and the simplest to play.

Let's take a good look at POINT COUNT:

HIGH CARD POINTS	DISTRIBUTION POINTS	MORE DISTRIBUTION POINTS (DUMMY)
A-4	Doubleton-1.....	Doubleton-1
K-3	Singleton-2.....	Singleton-3
Q-2	Void-3.....	Void-5
J-1		

I trust that many beginners or those who are toying with the idea of bridge read my column s. So, will you others take a commercial break while I explain in more detail Distribution Points (DP)?

The second column showing an increase in DP is correct: When you are able to support your partner's suit, you increase the value of the suits in which you hold two cards, one card or no card, Your hand, you see, will make a good DUMMY for your partner since he may gain extra tricks by ruffing some of his losers with your trumps—when he is not able to follow suit in Dummy's short suits and must trump.

The commercial break is over. As good bridge players know and as beginners must be exposed to over and over again is that the 4-3-2-1 was not carved in granite. It contains some flaws. But, it is still the best system as well as the easiest to use—there are, you see, no fractions. Absolute beginners may prefer not to clutter their minds with these

imperfections, but all who are interested in reasonable accuracy should be aware of a few inherent flaws or imperfections and be prepared to make adjustments for them.

Wouldn't you really have an Ace than two Queens or four Jacks? Yet they all add up to 4 HCP. Look at this hand: Spades K97, Hearts A532, Diamond J108, and Clubs Q64. The Ace is worth, you feel, more than four if the Queen is worth two and the Jack one. If you could give the Ace a plus and the Queen and Jack a minus, wouldn't you still end up with 10 HCP? That's one of the real beauties of the system—beginners taking the 4-3-2-1 literally won't be off more than a point or two than if they knew how to make some refinements.

That doesn't mean that judgment doesn't enter into using 4-3-2-1.

In your judgment, are the Aces worth more than four points each: A532 A97 A64 A 108? Then, join many other experts and give yourself an additional point for possessing all Aces. And how about this one: QJ32 QJ4 QJ 6 QJ 5? Twelve points. But, think. Is it really worth 12 points? No. Then, subtract a point for the lack of an Ace.

Now suppose those suits headed by Q's were headed by K's along with the 1/2's. The kings would flush out the Aces and leave you with trick taking Queens!

But, suppose you still have those puny suits headed by Q's and J's. If your partner bids these suits, these Q's and J's suddenly become more valuable. Suppose your partner has suits headed by A's and K's—now your puny hand suddenly acquires muscle.

Judgment enters into your use of the 4-3-2-1 system. You don't, however, have to rely solely upon your own judgment. With some study, you will be grateful that the experts have worked out a system to assist you in making the correct JUDGMENT.

1. If you have support for the suit your partner bid and you expect it to be the trump suit, you should promote honors in the trump suit. They are, aren't they, worth more than honors in a side suit? In the trump suit, promote the King, Queen and Jack one point if the total HCP you hold in the trump suit is under four. A QJ would be promoted to four; a King to four; a KJ would not be promoted at all.

2. If you are the opener and hold no Aces, deduct 1 point. If you are the opener and hold all Aces, add 1 point.

3. If you are bidding a suit and hold a square hand (4-3-3-3) deduct a point since this distribution means you have no ruffing power.

4. If you have named the suit and your partner supports you, you may now add 1 point for the 5th card in the trump suit and 2 points for each card over 5 in the suit. The more cards you and your partner hold in the trump suit, the fewer the opponents hold—and the more valuable your cards in that suit become.

Now, comes some judgment that many otherwise knowledgeable players forget and which many who play by the seat of their pants seem to have been born knowing.

5. When using the 4-3-2-1 system, the bids made by your opponents as well as by your partner must be taken into consideration. Suppose you are sitting with all four kings when your right-hand opponent suddenly bids One No Trump. You must assume that he holds three or four Aces. Since you play after he does, you may assume that your four Kings will win at least three tricks. But, suppose your right hand opponent passes and your left-hand opponent enters the auction with a No Trump bid. He plays after you do. Your Kings now do not appear to be so strong—you will be lucky if the four win even one trick.

We've discussed adjustments for unguarded honors and for positional bidding. But, how about adjustments for distribution? There is no adjustment for DP.

Distribution Count has nothing to do with HCP

One more word for you grammarian bridge players. You noted that I used the term "correct judgment." A redundant expression since judgment means the "ability to make accurate determinations"? Ah..h. Wait. Hear this. Our good friends Laura Mae and Ray play a lot of bridge. Laura Mae isn't overly enthusiastic about playing with Ray as her partner. Ray, she complains, doesn't credit her with thinking as she bids and plays. "Ray is wrong. I do think," she insists. "I don't always think correctly—but I do think!" I'm with her.

When you sit down opposite a partner at the bridge table, remember that each of you will be thinking and using judgment. If, perchance, you conclude that your partner's thinking of judgment lacks accuracy—relax and keep mum. Bridge is, you know, a fun game—what makes it fun is much laughter with minimum criticism. Fun and bridge out there!
