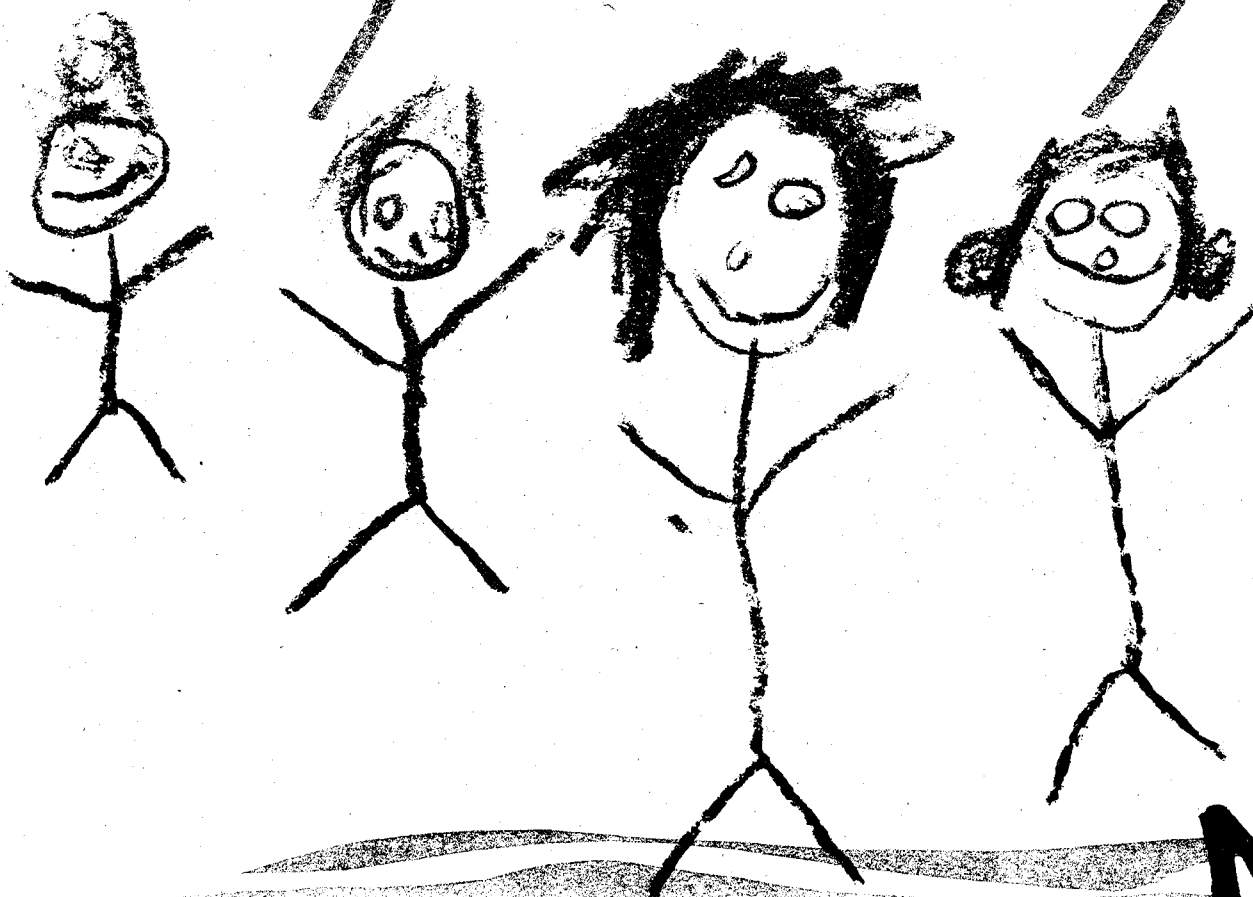

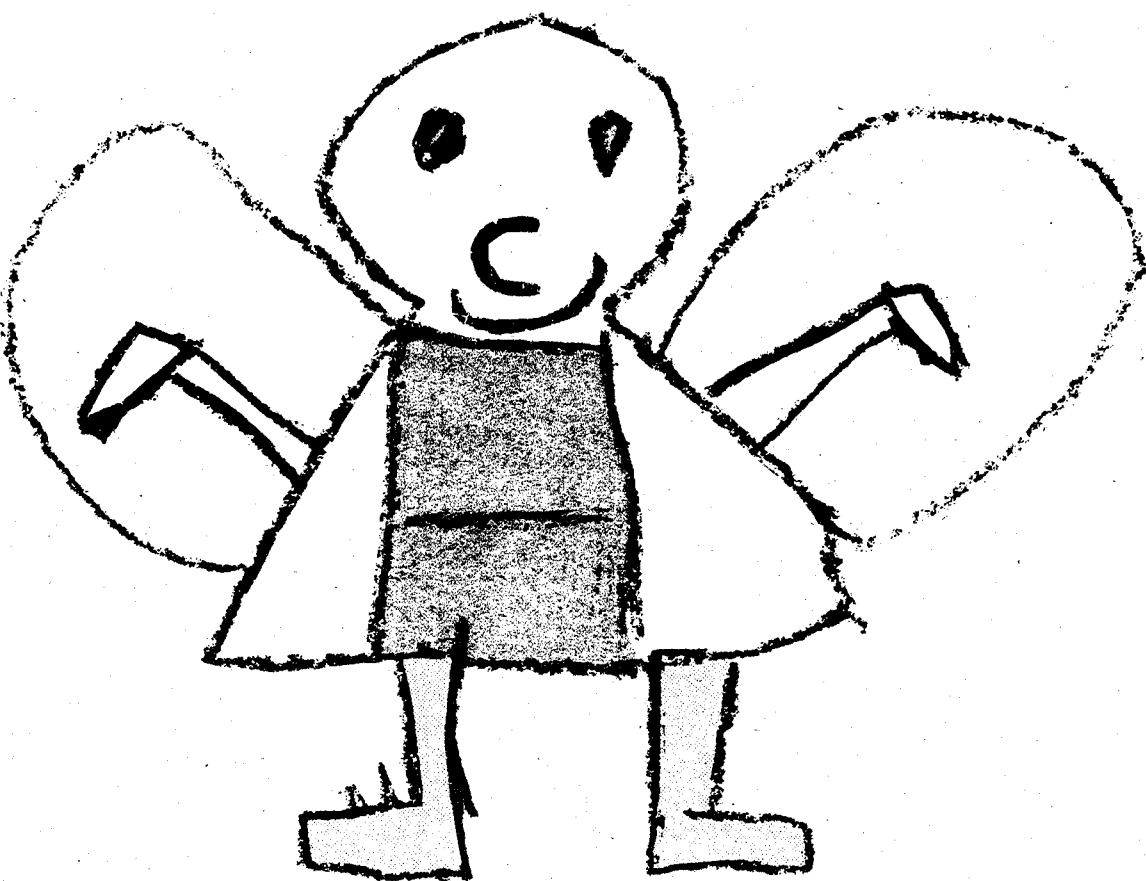


Mrs. Irene Larrabee's Kindergarten class at Sanibel Elementary School drew the things that they were most thankful for to celebrate Thanksgiving Day.

# Planning Commissioner Robinson addresses League of Women Voters

Planning Commissioner Betty Robinson was the featured speaker at the second meeting this season of the League of Women Voters yesterday, Monday, November 20. Ms. Robinson, who holds a Master's degree in social research, has lived on Sanibel since 1971 and has served on the Planning Commission since 1976. She analyzed various elements of the Sanibel's comprehensive land use plan and outlined the relationship between the Sanibel City Council, the Planning Commission, and the Planning staff employed by the City.

"The plan was developed in four phases," she explained, "the first of which was data gathering which was under the supervision of nine task forces." According to Robinson, one of the major reasons for the high number of people involved was to keep the final version of the plan as close as possible to what the majority of the people wanted. That phase was finished in July, 1975.

The second phase, that of identifying island-wide problems, like traffic, water and sewage, was completed a month later.

The third phase was to establish options for each problem. "In all cases," Robinson stressed, "the Planning Commission chose the most stringent of the options - the least number of dwelling units suggested by the City's outside planning firm, for instance.

"The land-use is primarily determined by the ecological zone it is in," she said. "The plan basically determines how the land may be used to preserve the environment we cherish."

Several League members had questions about the discrepancy in the exact number of dwelling units currently on Sanibel. "We've heard 6,000, 7200 and 7800," said one. "Which is correct?"

According to Robinson, the best estimate is only that - an estimate and her best guess was about 5,000. She outlined some of the modifications that went on in some areas during the formation of the plan. "Take Shell Harbor subdivision," she said. "The original density was 2.2 houses to the acre but that meant that many lots which were, at the most, a quarter of an acre were unbuildable. So

we decided to allow anyone who had a lot to build one house. If they owned more than one lot, they were still only allowed to build one lot which has led to the problems of contiguous lots.

In explaining the relationship between the Council, Planning Commission and the staff, she said that Council's function was primarily legislative. "The planning staff, who are paid employees, issue permits, check applications against plan requirements and give the ultimate approval in the form of certificates of occupancy (residential) or completion permits (commercial).

Robinson said that the Commissioners were able to spend increasing amounts of time on overall planning functions, now that the specific cases have diminished in number. She also responded to a question from the audience that addressed the fact that, now the City has a Rate of Growth law, growth seems to have slowed dramatically. Robinson pointed out that several moratoria, imposed by the City and the Island Water Association, had produced a sort of panic building when

they were lifted and that mortgage rates and increasing building costs were also responsible for the lack of anticipated applications.

Other areas she described where the City's expectations have not materialized included the amount of appreciation for Gulf-front apartments.

"When we zoned the Gulf Ridge five units to the acre, we thought that, although a developer could make some money, it wouldn't really be worth it. Nobody knew how much those apartments would increase," she said. The Commissioners also did not anticipate the spurt of economic activity on Sanibel, she continued, pointing out that the preliminary report on commercial activity on Sanibel is to be presented to the Commission next Monday.

The next meeting of the League will be a "social" one on Monday, December 17 at 9:30 a.m. at West Wind Inn to hear about the experience in China of two League members. A workshop on the League's plans for 1980 will be held on December 3 at the home of Dorothy Leslie.

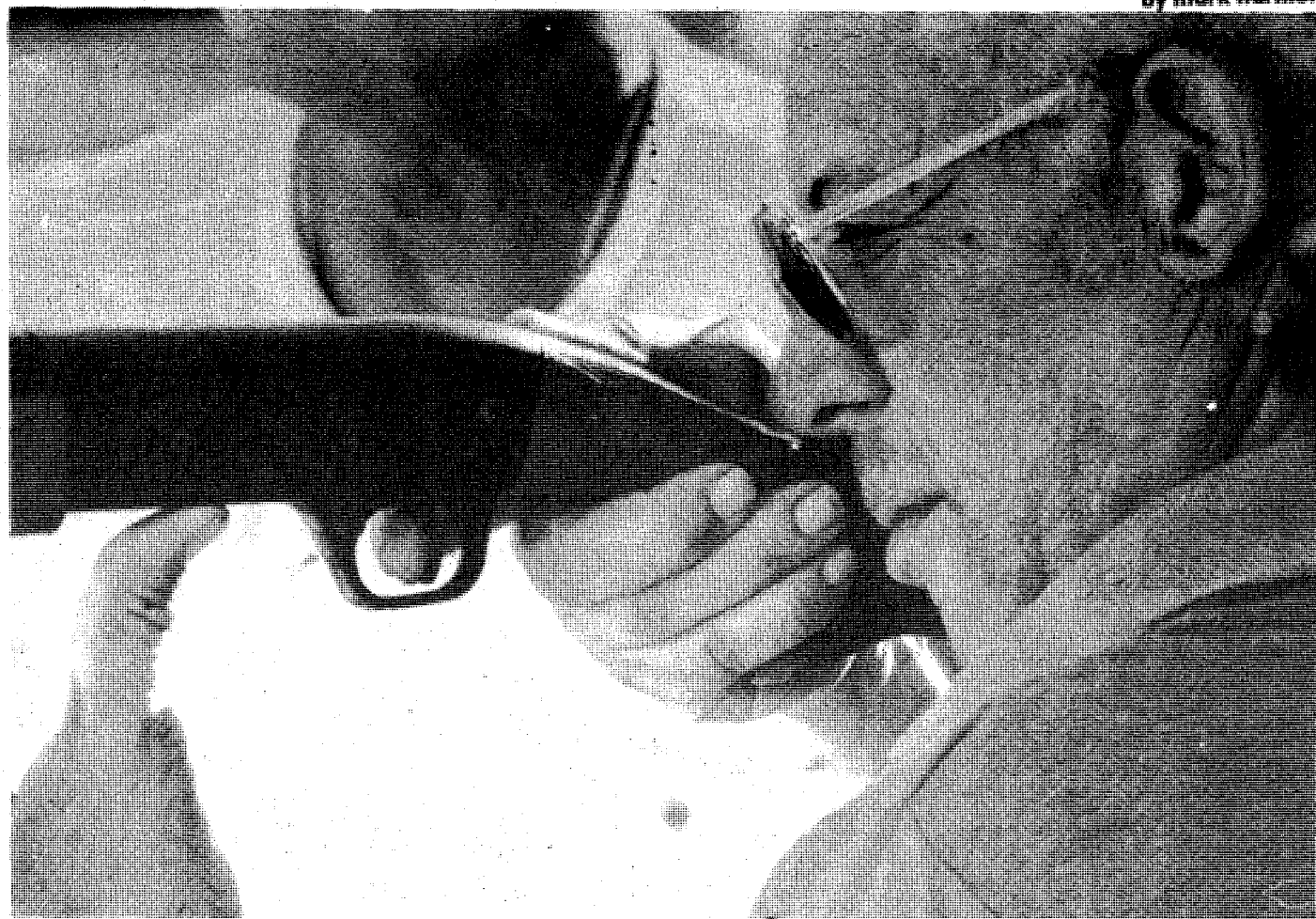
## Caloosahatchee Marching & Chowder Society to hold Thanksgiving Cruise

# Shoemaker exchanges guilty plea for life sentence

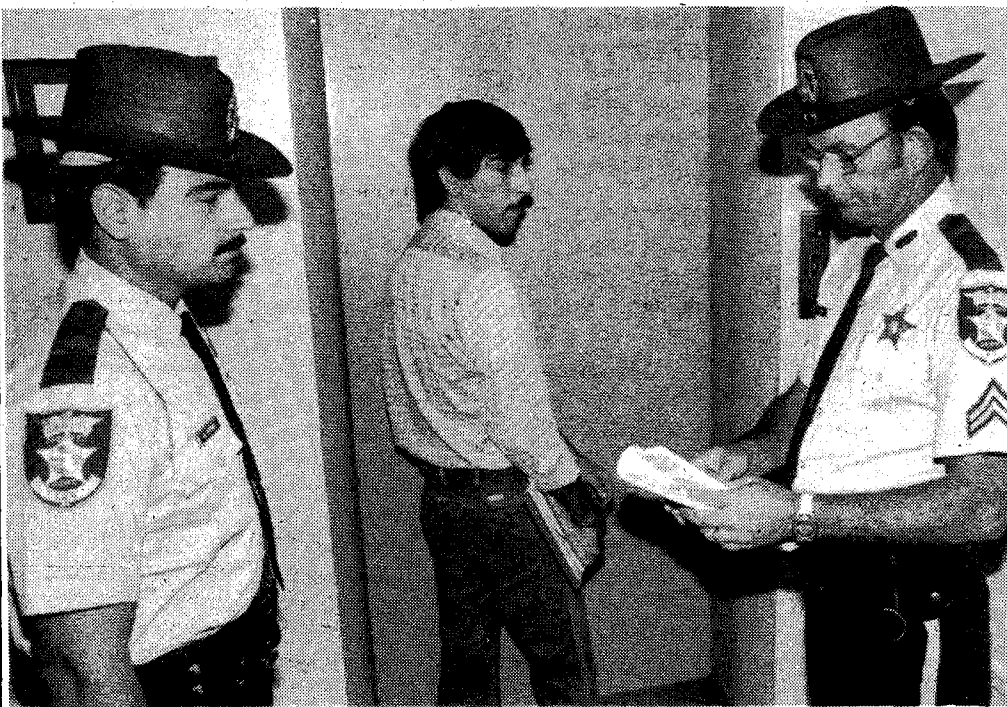
Frank Allen Shoemaker, a 24 year old Fort Myers Beach shrimper, pled guilty last Thursday to the first degree murder of 30 year old Beach resident Patricia Ann Horn in exchange for a waiver of the death penalty.

The blue-jean clad Shoemaker stood before Circuit Judge Robert T. Shafer in the Judge's chambers and entered a guilty plea to both the first-degree murder indictment and a charge of sexual battery against a minor.

Shoemaker was arrested June 29 by Lee County Sheriff's deputies after being identified by a 17 year old Fort Myers Beach woman as her alleged rapist in an incident occurring the night of June 28.

According to the woman, she had been approached in the parking lot of Casey's Tavern shortly before midnight by a man she had been introduced to earlier in the day. He asked for a ride to the downtown area of Fort Myers Beach but after she agreed, according to her statement, he then asked to be taken to the S & H shrimp docks. Upon arrival at the dock area, the woman then charged that Shoemaker began to make sexual advances. When she tried to stop him he began to beat her about the face and attempted to strangle her.

Upon his arrest Shoemaker confessed to the sexual battery and after further questioning by law officials also confessed to the May 29 Beach murder of Patricia Horn. Ms. Horn, whose partially clad body was found floating in the back bay behind Estero Blvd., had been brutally beaten. An autopsy ruled the death a drowning.

In his confession Shoemaker said he had also requested a ride to the docks from Ms. Horn after meeting her in the parking lot of Casey's Tavern exactly one month before the attack on the minor. She also refused his sexual advances, whereupon he began to beat and strangle her. After she became unconscious he then placed

her body in the water, according to his confession.

Judge Shafer sentenced Shoemaker to life imprisonment without chance of parole for 25 years on the first-degree murder charge, and 15 years imprisonment, to run concurrently with the life sentence, on the sexual battery charge.

### The Wheels of Justice...

There can be a no more helpless feeling in the human experience than the one suffered by Patti Horn just before losing consciousness to an assailant's blows - unless it is the one suffered last week by her parents as they sat face to face, in drab courtroom chambers, with their daughter's self-confessed murderer.

The scene in the chambers of Circuit Court Judge Robert T. Shafer at 8:30 a.m. last Thursday morning was that of the ultimate "bottom line." One woman was dead, another had been physically assaulted and emotionally scarred, and a 24 year old shrimper from Baltimore, Maryland, responsible for the pillage, was there to plead guilty in exchange for his life.

The high drama inherent in such law and order TV operas was nowhere to be found. In its place was a look of sadness on the face of the man who would decide Shoemaker's fate, gasps of desperation and disbelief on the face of the accused man's mother's face, silent tears of one victim's parents, and awesome fear in the eyes of the young woman who was very nearly the shrimper's second fatality.

Frank Shoemaker, father of two small children, stood unflinchingly before the Judge's bench and answered questions in a calm, steady voice.

"I'm 24 years old."

"Married but separated."

"High school graduate."

"Worked as commercial fisherman and meat cutter."

"I have not suffered any mental disorder in the past...to the best of my knowledge."





By depicting a fictional character, Brian, during the era when Jesus lived, taught, died and rose again, the film mocks the Son of God. The central character, Brian, is the son of a prostitute who joins a group called the People's Liberation Front of Judea. He is credited for miracles he didn't do and comes to be

considered a Messiah by the people. He is eventually crucified by the Roman Army. All this, including crucifixion, is portrayed in a humorous manner.

Yet there's nothing funny about a film mocking our Christian faith. It is grossly offensive to those who accept Jesus Christ as their Lord and Savior and who call themselves Christians. And it should be equally offensive to any person who

believes that religious faith should not be ridiculed or demeaned by overt and perverse sacrilege.

What can be done to stop such a movie as "Brian"?

First, don't see "Life of Brian". In the entertainment business, money - or lack of it - talks. With no income at the ticket window, the movie doesn't last very long.

Secondly, witness to your beliefs. Tell

others why you are not seeing that movie and be sure they know why.

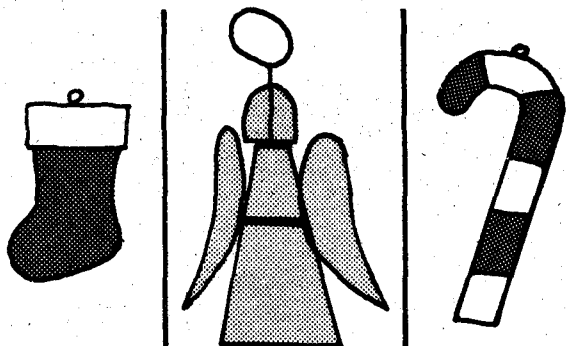

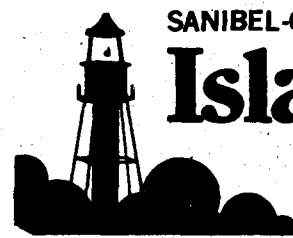

# Seashore refuge proposal recommendation— turned down by Planning Council

A request to endorse a proposal to protect small barrier islands off the coast of Southwest Florida from development and establish them as wildlife and recreational areas met with defeat in the chambers of the Southwest Florida Regional Planning Council last week. The proposal, which the City of Sanibel has passed as a resolution, was presented to the Council by Dinesh Sharma, southeastern coordinator for the National Barrier Island Coalition.

The islands specifically referred to in the City's resolution and Sharma's report include Knight-Don Pedro, Lovers' Key, Little Estero and Keewadin and are, Sharma says, "the only undeveloped or relatively undisturbed areas available for public use and protection".

Sharma's request was rejected, according to one spokesman, because "it was not clear what was being requested. The council members were nervous about endorsing this proposal because they felt that Sharma was really after acquisition of the Islands and they didn't know where the funding would come from and they were afraid they would lose local control over the Barrier Islands. It was confusing whether or not he wanted the Council to study the feasibility of the program or actually endorse a purchase," the spokesman explained.

Sanibel Council member Zee Butler disagreed. "This is just to get a grass roots movement going," she said, "to make our senators and Tallahassee establish a policy to look into the barrier islands to see what should be acquired and what use it should be put to." Butler stressed that the time to start this grass

roots movement is now. She cited the possibility of development on the islands in the near future and the increasing cost of the islands if the government were to purchase them.

Sharma's proposal has thus far been

endorsed by the Sanibel City Council, the Environmental Confederation of Southwest Florida, the Lemon Bay and Collier County conservancies and the Southwest Florida Audubon Society. Charlotte County commissioners rejected the

proposal earlier last week.

Lee County Commissioner Harry Rodda, who voted in support of the proposal at last week's Planning Council meeting, is expected to place the plan before Lee County Commissioners on November 28.

## Moderate cost housing ordinance delayed pending economic review

The Moderate Cost Housing Committee (MCH) last week decided not to distribute a draft ordinance on the purchase of MCH units to the Planning Commission and City Council until they hear back from an outside financial consultant.

In earlier meetings, the committee had decided to define moderate cost housing units according to the income levels of those who require them. Determining those figures for Sanibel has proved to be a stumbling block since no data has been collected.

Committee chairman Zee Butler has submitted a formula, drawn up by Dr. Louise Johnson, to an outside economic advisor for his review. Johnson took the 1970 census percentage difference between Lee County and the south Fort Myers area (145 percent) and applied it to recent figures from the Department of Housing and Urban Development, concluding that the upper range of Sanibel's median income is \$20,880. She then took HUD's figure of 80 percent of that number which is what the federal bureau estimates to be the upper range of

moderate income. She multiplied that figure (\$16,704) by 3 to get a possible purchase price for moderate income homes — \$50,112.

That, broken down into monthly payments, including tax and insurance works out to slightly less than \$400 per month.

Ray Fenton observed that a majority of the people who completed the moderate cost housing questionnaire last spring had indicated a willingness to pay in that area for a home.

Although Community and Housing Resources Co-Chairperson, Peter Valtin, suggested that the committee append Johnson's figures to the proposed ordinance to get it started through the City's legislative machinery, the issue was left hanging.

Butler said that she "couldn't even guestimate" what the outside consultant's time frame might be, but, she promised the committee, "I'll ask him and, depending on his answer, call another meeting". She said that she had been advised against releasing the ordinance with Johnson's figures by City Attorney Neal Bowen. "I can't go against

what I've been told by Neal," she told committee members who were pressing her to release the ordinance containing Johnson's formula.

At press time, no date had been set for the next committee meeting.

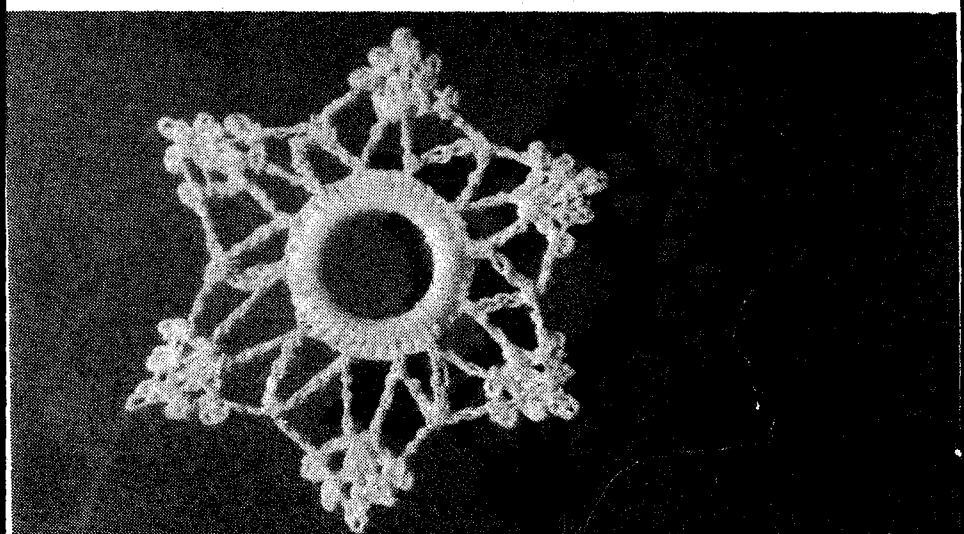

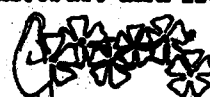

Lee County Circuit Court Judge John Schoonover heard several motions last week in a judicial confrontation between the owners of 415 acres on Wulfert Point and the City of Sanibel. The owners are attempting to get their land density changed from the 46 units allowed under Sanibel's land use plan to 1800 units. Under Lee County zoning, the land was previously zoned for over 3000 dwelling units.

The City won two of its six motions to dismiss the case in last Wednesday's hearing. Judge Schoonover ruled in favor of the City in a motion by the plaintiff's that the land use plan is unreasonable as applied to their property on the grounds that they have failed to exhaust their administrative remedies. The Wulfert Point owners have never petitioned the City for an amendment to change the density delineated under the Plan.

## City wins two motions in Wulfert Point suit

City Attorney Neal Bowen said after the hearing that the Judge's decision was a most significant one because it "constitutes a basic recognition by the Court that local government should be given the primary opportunity to decide local issues". Bowen

said he viewed Schoonover's decision as judicial deference to the legislative side of government — that is, to local governmental bodies.

Schoonover also dismissed a count alleging that the City's planning consultant's

for the land use plan, Wallace, McHarg, Roberts and Todd, failed to prepare the Sanibel plan in accordance with the Local Government Comprehensive Planning Act.

The Court denied the City's motion that the statute of limitations had expired as well as the City's motion to dismiss the developers' request for an ouster from the City of Sanibel. Schoonover told the litigants that it would be premature to rule on that motion until the matter is at issue.

Schoonover also agreed to allow the Sanibel-Captiva Conservation Foundation to intervene on behalf of the City of Sanibel.

The plaintiffs have 30 days to file an amended plea or they can file a petition for an amendment with the City.

Neal Bowen and Ed Ryan, the latter of Ross, Hardies et al, Chicago, represented the City; Jim Humphrey was the Conservation Foundation's attorney and James Spioto, also of Chicago, is representing the plaintiffs.

## 346 attend Scout camporee

154 Cub Scouts and leaders and 192 Boy Scouts and leaders attended the 1979 Fall Camporee sponsored by Troop 88 of Sanibel and Captiva.

Scouts and leaders from 15 Boy Scout troops and 8 Cub Scout and Weblo packs attended from as far away as Naples to the south and Sarasota to the north. The Camporee was held October 26, 27 and 28 and turned out to be the largest and most well received Camporee held in the Southwest Florida Council for quite some time.

Rather than the customary patch usually given out at Scout outings, each participant attending the Camporee received a neckerchief designed by Ron Sebal, scoutmaster of Troop 88 and camporee chairman.

Friday evening was spent by the troops checking in and setting up tents and camp in the dark.

Saturday started with 7 a.m. reveille and assembly for flag raising and breakfast, followed by free time to make camp improvements and a campwide game of "Capture the Flag."

Immediately following lunch, the afternoon activities started which consisted of:

After Dark Man Down Rescue: The patrol had to rescue a patrol member without being able to see him. After rescuing him from a fall, the patrol was to treat the victim for a broken arm and shock.

Tug-O-War: Each patrol member was to tie a piece of rope to the person's rope in front of him and use it for the Tug-O-War.

Catch The Snapper: Many poles had to be lashed together to make a long fishing pole with a line to catch a mouse trap.

Obstacle Course: Each person had to run a rugged 2 minute course.

Orienteering Course: Each patrol had to use a map and compass to run about a 1/2 mile compass course.

Archery Skills: Each person got to try his luck with a bow and arrow.

Log Raising Relay: Each person had to throw a rope 25 ft. over a pole, tie it to a log, raise it off the ground and tie it off with a clove hitch to a stake.

Split The Match, String Burning Contest: Each patrol had to build a fire not over 12 in. high and light the match with an axe and use that match to light the fire and burn a string 18 in. off the ground.

At this time many of the awards were given out and each of the scouts received their neckerchiefs. # shelling tips

Ever pick up a shell such as a shark's eye and notice that on the reverse side of the "opening" is a perfect little hole, perhaps the size of a pencil lead?

If you look more closely, you'll begin to notice that there are many shells on the beaches with similar little round holes. These shells have been the victim of another shell which catches the "host" and then proceeds to drill a hole and take out the host's body for food. There are several drill shells in the shells you can find on Sanibel and Captiva Island beaches.

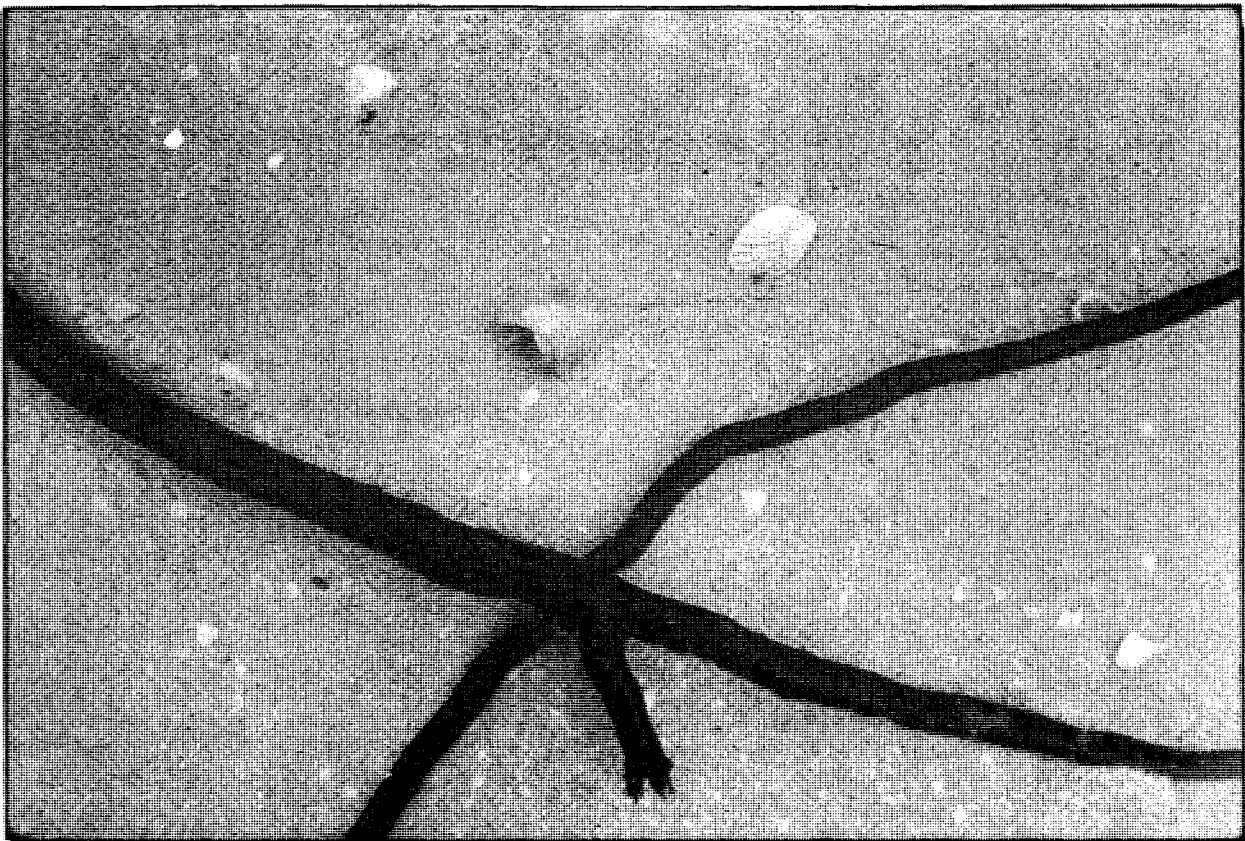
It's interesting to note that on the shelling grounds, both in-shore and off, there is a constant survival game going on. It's hard to imagine a slower cat and mouse game than that played between two shells. Some of the fastest shells, the tulipa, for instance, can only manage a few feet in a couple of hours. The process of finding, then capturing, shells is a long, long hunt. In the water, the big shells feed on the smaller ones and so on down the line. At the top of the chain are the large whelks and horse conches. At the other end are the microscopic little fellas that feed by sifting through water for food.

It's not unusual to come upon a live whelk on the sand or mud flats in Pine Island Sound. On some of my shelling trips to the upper islands, my guests have been invited to observe the live shells and to try and guess just why the big shells would be in a shallow flat, rather than out in deeper water, out of harm's way.

Most novice shellers think the big shells are there because they are traveling from one grass bed to another, but what the shells actually are doing is "dredging" the sand or mud for shells on which to feed. And the shells they seek are there to feed on smaller shells, and so on.

Everyone seems to prefer the color and shape of the big horse conches to the big whelks, but I never seem to get tired of observing the whelks. I've come upon two big whelks seemingly in locked battle, only to discover that they are fighting...but over a clam each has tried to wrestle away from the other.

There is a mud flat in the northern end of Pine Island Sound that has a large supply of big clams. Some of these clams are the size of a man's fist and one day, I found a huge whelk gamely trying to open a big clam. I had to admire the whelk's optimism and it probably did dine on the clam, but can you imagine how long it takes a whelk to find, then capture such a clam?



I've always felt that observing live shells is as interesting as picking them up for a collection. The life of a grass flat is fascinating and is no different than that of life in a jungle or on a desert. The big feed on the small. Next time you find a shell with a tiny hole drilled in it, you can bet that the shell in your hand met an untimely death.

The best part of drilled shells is that if you want to make jewelry or hand shells, you already have the hole.

In between these point gulf or bay - guessimate and have good fishing and or shelling.



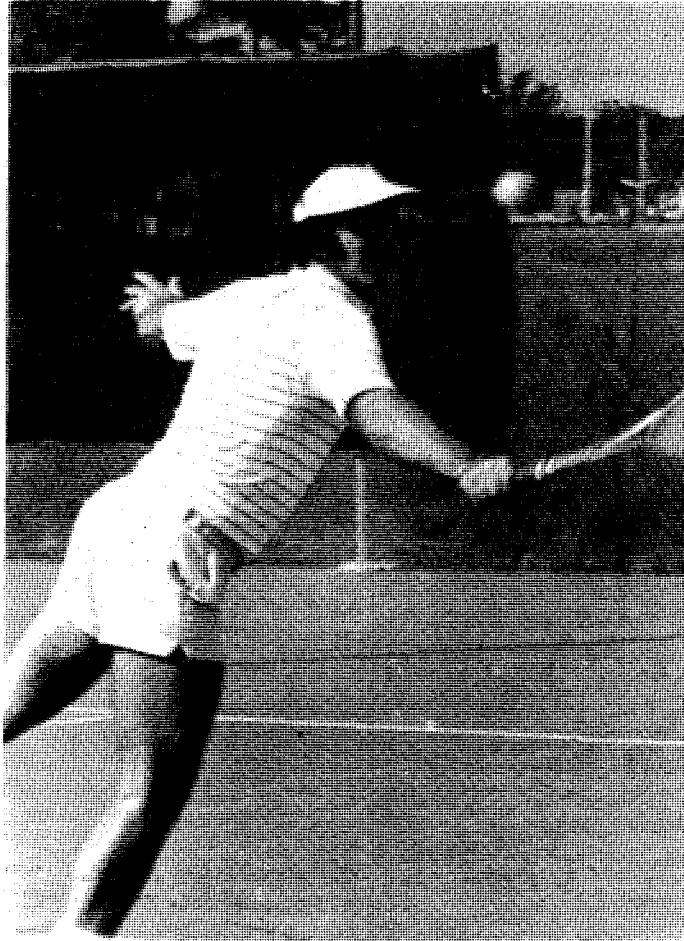
# tennis

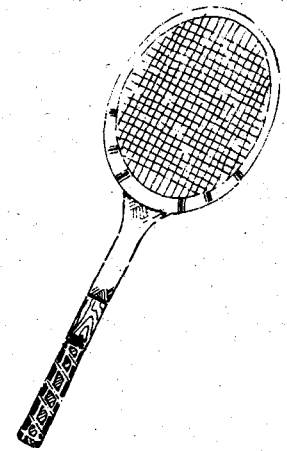

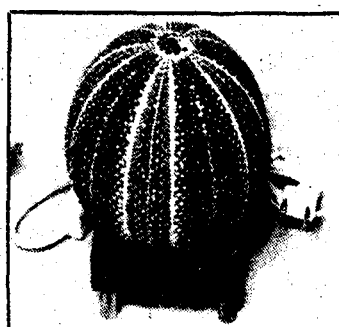

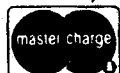

The following are some of the winning recipes.

#### Shrimp Supreme Barbara Toomey

#### Entree or Appetizer

3 lbs shrimp (18-22 to the pound)  
4 thin slices preserved ginger  
8 scallions chopped fine  
one-third cup dry sherry  
4 tbs soy sauce  
½ tsp salt  
4 tbs sugar  
3 tbs cooking oil (Crisco)  
2 garlic cloves - minced

Remove heads and legs from shrimp - leave shell intact unless vein is very black or gritty. (If so, remove vein.)

Combine all ingredients. Marinate

shrimp two hours.

Skewer shrimp and grill over hot fire turning once about four minutes each side. Serve hot.

For an appetizer, cook and chill ahead of time.

#### Casa Ybel Coconut Pudding Evelyn K. Spencer

2 cups sugar  
6 eggs  
1 cup milk  
½ cup butter  
1 fresh coconut, grated

Cream sugar and butter, add beaten eggs, then milk and coconut. Bake in 375 degree oven. Watch closely and as soon as it begins to brown, stir thoroughly.

Repeat this four or five times until the pudding is thoroughly brown.

Delicious but rich. Serve sparingly.

#### Crab-stuffed Artichokes Buncy Jeffries

8 artichokes with prickly tips removed  
2 cup crab meat  
½ cup chopped onion  
½ cup chopped celery  
2 cloves garlic  
1 tsp tabasco  
2 tsp worcestershire  
2 tsp lemon juice  
½ cup mayonnaise  
salt and pepper to taste  
Note: Canned artichokes may be substituted for less class.

Steam artichokes until tender - remove choke. Sauté onion, garlic and celery. Mix in remaining ingredients - taste to add more if needed.

Stuff artichoke filling in the hole where the choke was removed and between leaves. Serve with Louis dressing: ¾ cup mayonnaise, ½ cup chili sauce, ½ cup orange juice, salt and pepper.

#### Culinary Clam Bisque Leslie Anding 8 servings

1 large onion, finely chopped  
¾ stick of butter  
6 tablespoons flour  
3-8 ounce cans minced clams - with liquid  
2 cups clam juice  
3 cups light cream

3 tablespoons tomato paste  
3 tablespoons lemon juice

Saute onion in butter until soft. Stir in flour until blended and bubbly. Stir in clams and clam juice and boil one minute. Simmer 15 minutes. Blend in tomato paste with wire whisk, lemon juice and cream. Heat slowly until just hot - do not boil or cream will separate.

No one will guess how simple this is.

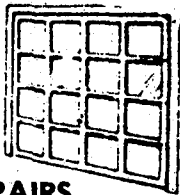

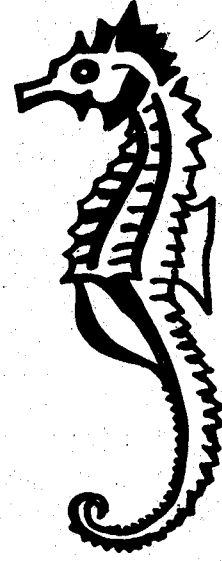


Sanibel Police Officer Jamie Phillips puts the handcuffs on William Bryant after a three-car collision on Periwinkle Way last Wednesday.

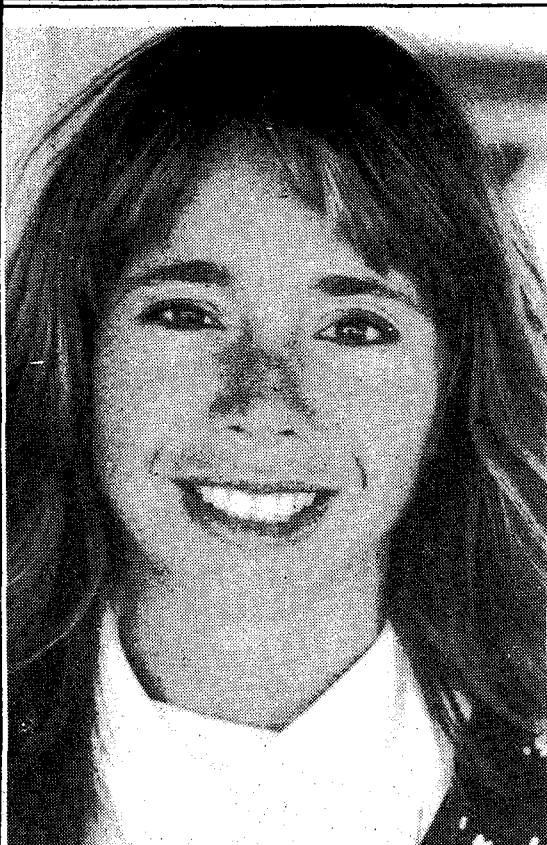

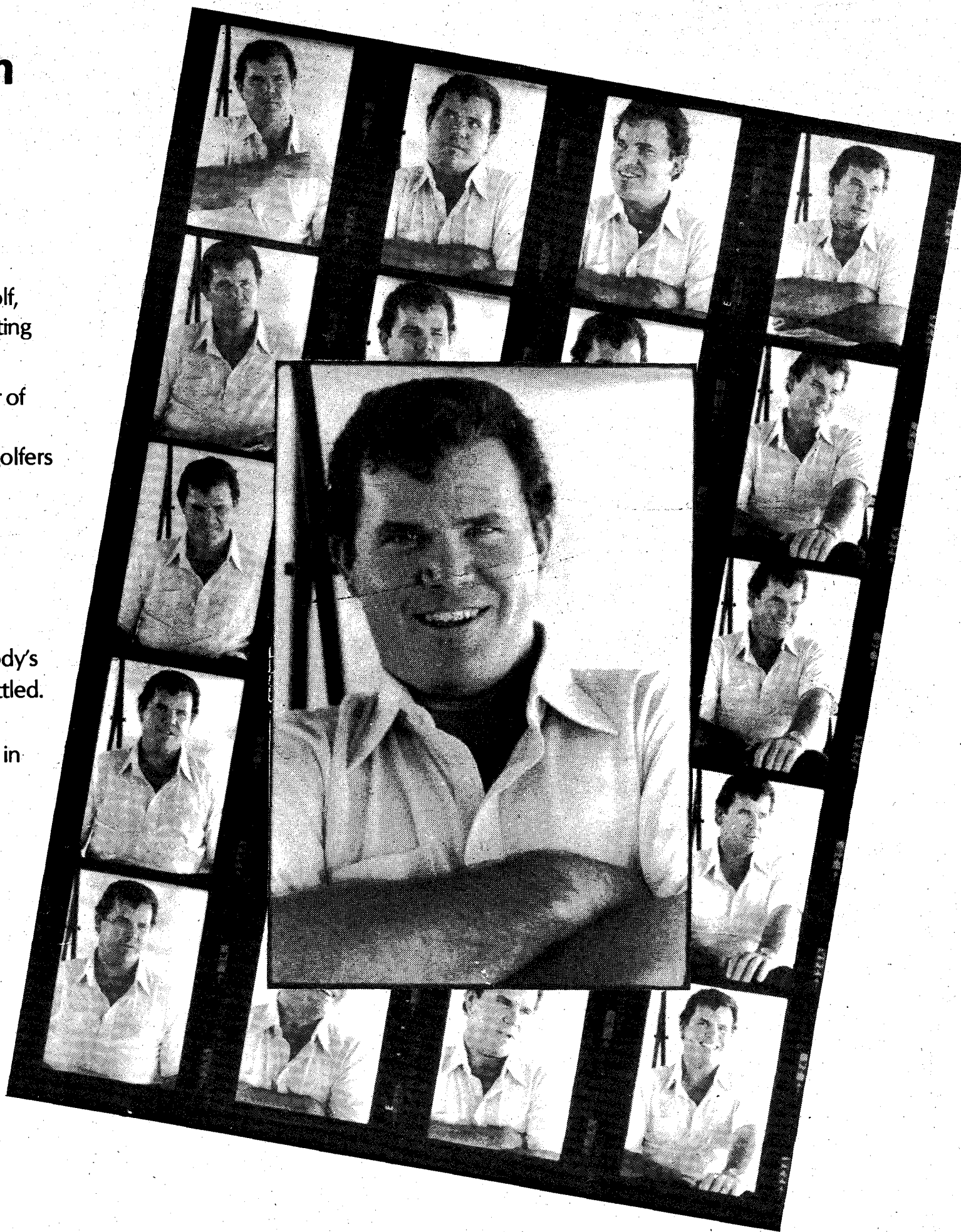

Not many people are fortunate enough to be able to make a living at the one thing they really love to do, but Beachview Golf Club's Golf Pro Robby Wilson is an exception to the rule.

From the time his father first stuck a golf club in his hand at the age of nine, Robby has been putting around local greens. It helped to belong to a family whose entire constituency played the game, just as it helped being raised three blocks away from the Fort Myers Country Club.

Robby has been playing golf all of his life. "It was just one of those things I picked up as kid," he says, "but I stayed with it."

As a student at Fort Myers High School, Robby played both golf and baseball but it was golfing ability that won him scholarships first to Edison Community College and then Florida State University where he studied hotel-restaurant management.

"I knew that eventually I'd be working for a club," he says of his resort training. But before settling down to a

steady job he took a shot at the tournament circuit. "All us young guys try the tour," he says laughingly, adding, "I played tournament golf for three years and not very well!" But of course that's not entirely true. He did win "some" money, he just never won a pro tournament - just like a lot of other pros who travel the circuit.

In 1969 Robby's father, Truman, built the Beachview golf course. It was closed during the time the Island was going through land use pains but re-opened two years ago with Robby as a permanent fixture. He gives lessons, runs the cash register, manages the club and pro shop, and, to hear the patrons talk, is in charge of snake education and fair weather.

Administrative chores keep Robby from playing golf as often as he'd like, but he does manage to practice three or four times a week just to keep in shape. About 250 people a day use the course during the season and everyone's goal is, of course, to beat the pro! Robby obligingly plays with the members, managing to miss a shot here and there "to make

them feel good."

Golf is a "mind bender" says he, "A totally psychological game of mind over muscle...It's a game played with yourself, by yourself, and for yourself - and confidence and concentration" are the tools of the trade.

Robby also believes that it's getting easier to get into professional golf. "There are more courses, more clubs, more people playing than ever before. Getting on the tour is something else again, but it's best to do it when you're young - the competition doesn't scare you so much!"

He is also of the opinion that Sanibel has evolved into a good golf community. "Five years ago," he says, "nobody played golf here, but now everyone does." There are even a dozen or so Beachview members who play every day, 365 days a year!

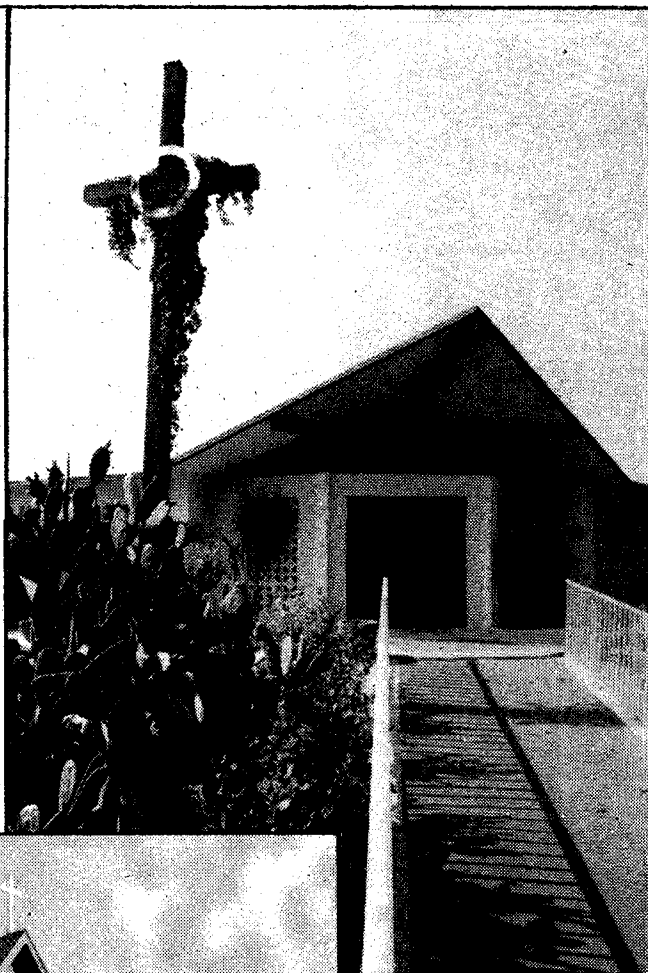
As for himself, Robby has found his dream. "I get to do a lot of things here," he says. "Travel, teaching, playing in maybe 20 State tournaments a year, be outside - this is what I want to do. What else is there?"

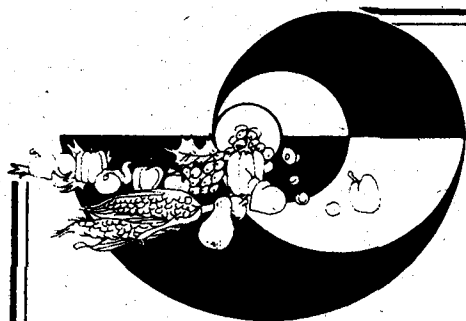
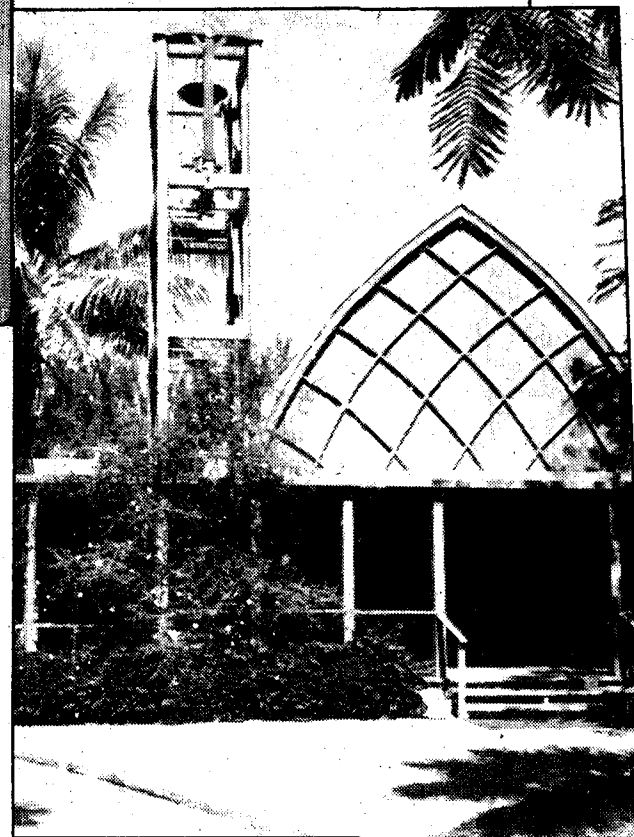

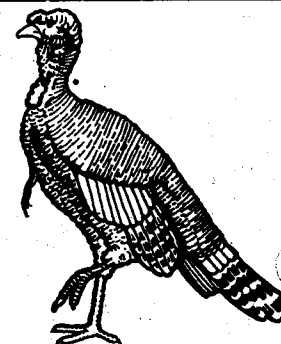

# PROPERTY SPEAKING

SENIOR REAL ESTATE PRESIDENT

Several of our customers are talking about waiting to purchase property when interest rates drop. In the last Kiplinger Florida Letter, Mr. Kiplinger said, "If you are buying, our view, as reported last month, still holds: there's no point in delaying if you can get financing. The slackening in home building now will create pent-up demand, and a fresh burst of price increases later."

Mr. Kiplinger no doubt is correct, because the home you have your eye on now, will also cost you more in monthly payments two years from now even if the interest rates drop a full percentage point from their current high.

For example, take a home that costs \$100,000 with a 36 percent down payment and financed with a 35 year, 13 percent

mortgage. Monthly payments would be \$921.27. A year from now, if prices rise at the rate of 10 percent per year, the \$100,000 home would be likely to cost at least \$110,000.

If, on the other hand, the interest rate decreased to 12 percent, not only would the down payment be \$2,000 more, but the monthly payments on this \$100,000 home would increase to \$926.85, while if the interest rate stayed at 13 percent during the year, the payment would have risen to \$992.50 due to inflation.

So it's obvious that the overall value of the home - not the interest rate - makes the biggest impact on your monthly payment. Since there is no indication of property values decreasing, the moral of the story is - buy now or pay more later.

## barrier island study delayed again

"A Plan for Protecting the Barrier Islands Along the Atlantic and Gulf Coasts", a study done at the instigation of a presidential directive last spring, has again met with another delay. According to the Ron Cooksy, who is in charge of the project, the study has been "temporarily held up" at the Office of Management and the Budget. It was originally scheduled for release in early September.

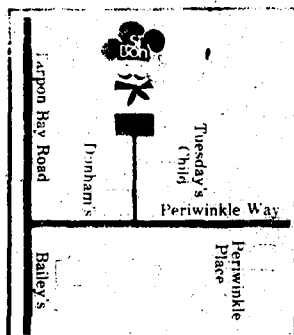
The delay came, Cooksy said, because various people want to examine the study and the different options outlined therein "to make sure we aren't backing the president into a corner with our recommendations".

The study examines federal programs which, through subsidies, loans, grants, permits or acquisitions, contribute either to the protection or the development of barrier islands. The study provides alternatives on three levels, according to Cooksy, and examines the results of each alternative.

After the study is released, Cooksy said there will be a 45-day public comment period before his staff goes to work on a "decision document" for the Secretary of State to present to the President. That process, Cooksy estimates, should take 4-6 weeks, although he commented, "I've just about given up on time frames".

Some of the alternatives which will require new legislation could be fairly dramatic, Cooksy said, but he added that he did not foresee a large acquisition program. (Congressman Phil Burton of California, however, is currently sponsoring a bill that calls for the federal government to acquire substantial numbers of barrier islands.)

Cooksy estimates that the current delay in the barrier island study should take only about two weeks. For a copy of the report, when it is released, write Ron Cooksy, HCRS, U.S. Dept. of the Interior, Washington, D.C. 20240.

## THE SHRIMP LESSON

Contrary to popular belief, shrimp do not grow into small, medium and large sizes. After they are caught they are graded by weight. The largest shrimp available are called U-10's (under 10). That means that 10 shrimp equal 1 lb. The grading continues upwards in size increments of 5; 10-15's (about 12 shrimp will equal 1 lb.), 16-20's, 21-25 and up to 120-130's (those are tiny shrimp). The more shrimp per pound, the less they cost, that is because you are buying more shell and tail which is not usually eaten.

THE TIMBERS, we buy only 10-15 size shrimp from Ft. Myers beach, to use in our entrees. This means you get more shrimp in our baked stuffed shrimp and shrimp scampi. They cost us a little more, but they taste a whole lot better.

## on the water

by capt. mike fuery

Having an inexpensive, accurate depth recorder on your boat just might be the most important aide you can have on your side while looking for fish.

There are many models on the market that are said to be "fish finders", but that term is somewhat inaccurate. They don't find and pinpoint fish as such but, used properly, they can help locate likely fishing areas. This week, let's take a look at some things you can do with a good depth finder.

First of all, these instruments are often called "flashers", or "sounders". The majority of these are sonar type systems where a sound wave is sent to the bottom and the time it takes to bounce off the bottom and return to the sending unit on the boat is converted into feet. You can see where the light on the gauge is flashing and that indicates the depth of the water you are in.

Some of these units, costing from about 60 to 200 dollars, work best while the boat is drifting or moving very little. These are not of much help, but they are on the less expensive side of the scale and if the boat budget only allows one of these portable units, then it's still better than using a marked depth pole or something similar.

Expect to pay about 125 dollars for an installed, brand-name depth sounder. There are several fairly good ones on the market.

These flashers can show you schools of fish, but for the average fishing requirements along the Sanibel and Captiva Island chain, the shallow waters don't really allow you to see much.



Rather, what you will most likely use your new flasher for is finding holes or pockets, or for locating the magical five-foot trout depth.

The other day, I was poking around some isolated mangrove islands on the Pine Island Sound side, when the recorder went from a steady 3-foot flash to 10 feet deep! I checked the small craft chart, but it didn't show the hole. I circled the depression to get an idea of how big it was and by accident came upon a very nice fishing spot for trout and for redfish in the coming months when the big fish pull back for deep holes when the tides get abnormally low.

As many of the best trout fishermen will tell you, sea trout are more likely to hit when you're in about 5 feet of water on

the grass flats of Pine Island Sound.

One of the other advantages of the depth recorder is to help navigate. By checking your charts and adjusting for the tide differences, you can tell how far off shore you are, just by reading the flasher. They don't put mileage markers out in the Gulf of Mexico, so when you're watching your gas and time, you'd better know how far out you are when you can't see land. With the flasher, you can generally keep track of your location.

It's a valuable tool to add to your boat. If you have one, learn to use it for finding fishing spots. It's just like having a huge eye under your boat.

## islander angling

Fish around the Island are apparently in a rut. For the third week in a row the waters off Sanibel have been yielding good catches of trout, and redfish has been the prize catch of Captiva anglers. The one new development is the arrival of sheepshead.

Trout sized from one to three pounds are still plentiful on most any grassflat. Catches have been reported from the Causeway flats, in Tarpon Bay, at the mouth of the Caloosahatchee, and at Buck

Key.

Reds are being pulled from Redfish Pass, and from the mangroves of Buck Key and in the sanctuary.

Sheepshead are beginning to move in to the area. They have been popular at the public pier, near pilings, and Tween Waters reports catches of sheepshead off the surf. Flounder are also being caught near the pier, on the Causeway flats, and in the canals.

## the green thumb

No landscape on the Islands is complete without at least one hibiscus. The large vibrant blooms, as well as the lush green foliage make it one of the most popular outdoor garden plants.

The hibiscus has been the subject of hybridizers for quite some time. Some of these people have developed strains of hibiscus with blooms up to 12 inches in diameter. The common bloom is a mere five inches, and one interesting characteristic is that it only lasts one day - whether left on the plant, cut and floated in water, or worn in the hair as so many of the Island women do. When dusk approaches the bloom begins to fade, regardless of where it is.

The hibiscus can grow up to 30 feet in height, as the specimen at the corner of Periwinkle and Donax is struggling to do. If given another three to five years and peace from reckless drivers it will easily be able to do it.

The weather we enjoy on the Islands offers the hibiscus an appropriate climate to grow as well. They never have a

dormancy period and, quite interestingly, never die of old age. The hibiscus likes to have moist soil, which is no problem during the summer but necessitates watering in the winter. Watering is not critical for outdoor plants but they should be watched carefully nevertheless and a feeding schedule of once a month maintained. Any good indoor-outdoor fertilizer should do the job.

One trouble signal to keep an eye out for is yellowing leaves. Many times it is caused by a low nitrogen content and, if your fertilizer has less than 20 percent nitrogen, a fertilizer with a higher content will be occasionally necessary.

You can propagate your hibiscus from stem cuttings but be sure not to take the older stems as they are very slow to root. Younger stems are a better choice although you shouldn't expect them to root quickly either. Root your hibiscus cutting in moist sand or perlite and, if you plan to

do a lot of cutting, a good root hormone powder is well worth your money. Bottom heating will help speed any rooting of plants, meaning 70 - 80 degrees.

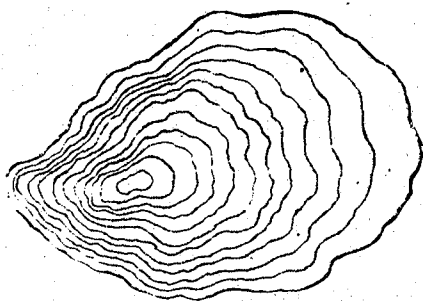
The best time to take a cutting from a hibiscus is in the early Spring when the plant is vigorously growing. A special note: If your plant is getting a little overgrown or unshapely you can prune it back as far as you like - even to within a few inches of the ground - and it will make a fine new growth during the early Spring, which is the only time to do such a severe pruning.

I personally feel the hibiscus would be unable to produce new growth fast enough to sustain itself any other time of the year.

All our plants are important to the environment but few give us the beauty a healthy hibiscus does and with so little care.

## City receives safety award

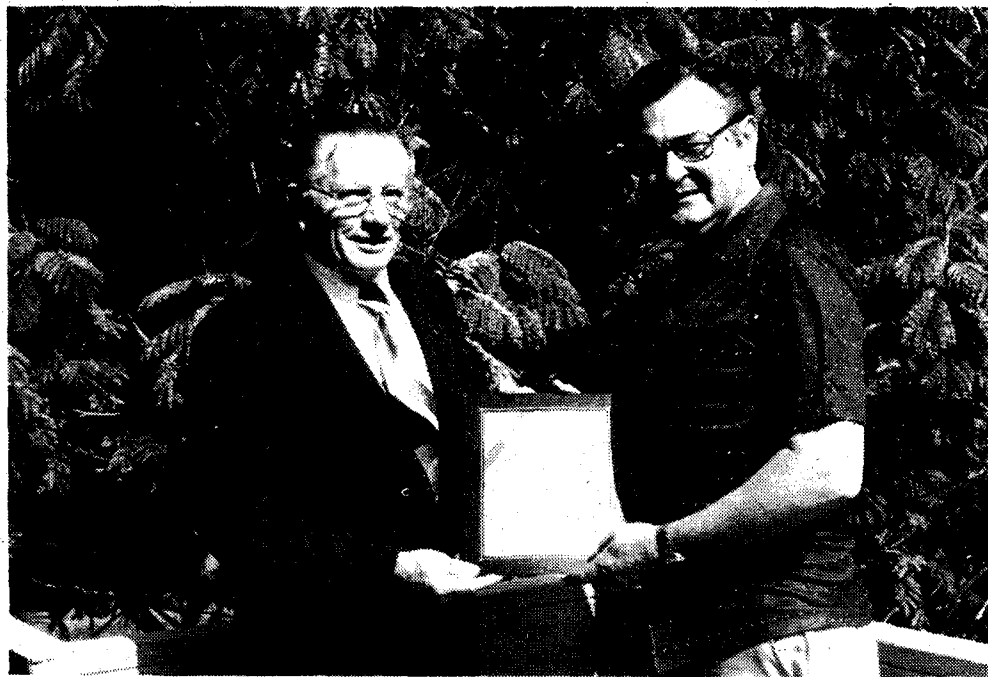
The City of Sanibel has earned the Pedestrian Safety Citation from the American Automobile Association for its achievement in the prevention of pedestrian fatalities and injuries.

On the Island Friday to present the award to City officials was Hampton Dunn of Tampa, Vice President of the Peninsula Motor Club (AAA). Dunn said the Pedestrian Safety Citation is one of 350 top citations to be presented by AAA clubs across the country in the federation's 40th annual Pedestrian Safety Inventory.

A record number of more than 2,750

cities participated this year, representing 80 percent of all cities with populations in excess of 25,000. The AAA survey evaluates and recognizes outstanding pedestrian achievements of participating communities for the previous calendar year.

Communities in the AAA program are judged with others of comparable size and characteristics. Program areas evaluated include maintenance of records, safety legislation, quality of school traffic safety programs and active public information and education programs.



## New channel markers being placed to aid navigation

New channel markers are being placed from Matanzas Pass south to the county line as the result of a \$38,000 project by the Lee County Recreation Department and volunteers from the Coast Guard Auxiliary, according to Marshall Treadwell, superintendent of recreation.

The project, funded by boat registration fees, has been underway since Oct. 17 and is tentatively slated for completion by the end of November. The firm contracted for the project, Coastal Diving, Inc., out of Tampa, has already placed new markers from the Carl Johnson Park south to the county line, and is now working its way north.

According to Treadwell, this is the first time the county has worked on these markers.

"The pass (Matanzas) was never clearly marked by anybody, so the (people) concerned got together."

Treadwell praised the efforts of those involved.

"The Coast Guard has been very, very cooperative and very helpful to us... in the planning and early stages," Treadwell noted. "The Coast Guard Auxiliary worked closely with us to get this thing off the ground."

Coast Guard Chief Timothy Vaught felt the necessity prompted the placement of the new markers.

"We had individuals put in private aids (to assist in safe boating in the pass), but this is the first complete system."

Vaught noted that the Coast Guard issued permits for the markers and, once they are installed, will inspect them as standard procedure.

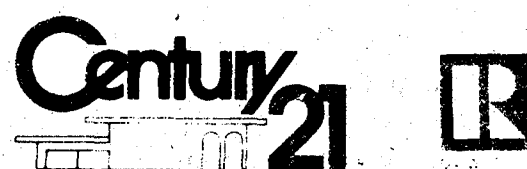

The attorneys point out that three different psychiatrists have found Shoemaker sane. His mother is crying uncontrollably, loud, shoulder-shaking sobs.

The Judge questions him further. Did you, on the night of May 29, in Lee County, premeditatively beat and place in the water the body of Patricia Ann Horn?

The casual response cuts through the courtroom like a knife: "I did."

Patti Horn's mother cries silently into a handkerchief. Her husband takes her hand.

Outside the chambers an impatient attorney asks a bystander, "What's going

on in there? A divorce?" The bystander replies that it's a murder case.

"Murder? In chambers? Why's that?"

"Apparently because the guy is going to plead guilty in exchange for a life sentence," comes the bystander's response.

"What, is the guy black or something?"

"No, white. As were his two victims."

Astonishment. "Wonder why they didn't get him off on insanity or something?"

Back in Judge's chambers, silent hysteria reigns. Judge Shafer is delivering the sentence. The first-degree murder indictment receives life imprisonment - with no death penalty and possible parole after 25 years. The sexual assault charge is good for 15 years, the maximum, but runs concurrently with the 25 minimum for murder. A legal "deal" has been made.

The Judge feels compelled to add a personal comment; "The law has imposed on you the punishment which is provided...for crimes against society...your next concern is to make peace with your maker."

The chambers begin to clear. Law enforcement officials place handcuffs above the fists that have killed one woman and brutally beat at least one other. He is fingerprinted. And in the back of the room his mother wails a plea of futility, a knell to undo what has been already been done for nearly six months.

And in the hallway another grieving mother cries out for her dead child.

The wheels of justice roll on. Case numbers 79557CF and 79556CF are closed.
