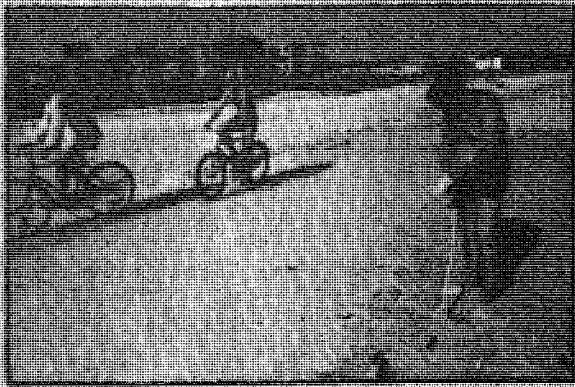

## Dual Taxation Committee to pursue questions through League of Cities

The Tri-City Committee on Dual Taxation decided last week to follow advice from Lee County officials and pursue, through the Florida League of Cities, questions dealing with the budgeting system used by the County.

Committee chairman Fred Zander had earlier requested the Committee obtain a legal opinion from the State Attorney as to what extent the County had to break down its budget. The Committee has held a city-by-city budget breakdown showing that the amount of revenues expended by the County is crucial in determining the dual taxation problem. Currently, the County budget is broken down into countywide and non-countywide expenditures.

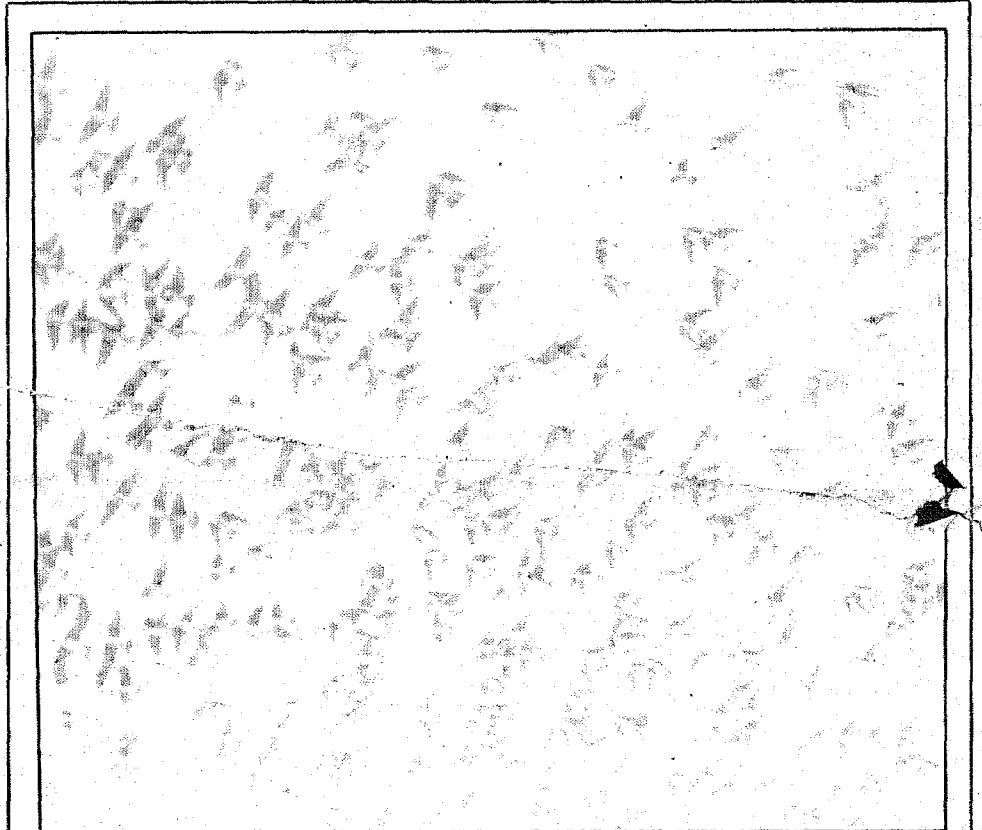
However, Committee member Roger Henderson said the League of Cities has no former experience with the dual taxation problem, which could be an indication that the League has attempted to circumvent the issue. Henderson suggested the Committee contact the State Attorney directly. "I don't think he'll volunteer any information unless we ask him," Henderson said.

Committee member John Blomquist then suggested that the Committee "try the League first, with a timetable. If they can't do it, we'll handle it ourselves."

Blomquist added that a formal resolution by the three municipalities of Cape Coral, Fort Myers and Sanibel could be mandated by the League. "We have no formal root" with that agency, Blomquist said, "but member cities do."

Henderson also suggested the Committee look into a budgeting system currently in use by Longboat Key, a City in Manatee County. That city, Henderson said, has a taxing and budget system that

## City to conduct roadside trip survey

The City of Sanibel will be conducting an Origin and Destination (O & D) study on March 25, 28, and 30 and on April 5, to help determine the who, what, where, when, why and how of Sanibel's tourists, daytrippers, residents and workers. The survey will furnish the City with much needed information concerning the use of Island beaches, shops, roads and accommodations.

According to Assistant City Manager Gary Price, the City hopes to evaluate 25 percent of the total Causeway traffic during the four days the study is con-

ducted.

An extra traffic lane will be established on Causeway Road across from the Chamber of Commerce office and vehicles will be tallied between 6:30 a.m. and 6:30 p.m. A Roadside Trip Survey Questionnaire will be administered by volunteer workers and information collected will include: date, time, vehicle license number and state issued, whether the vehicle is a car, motorcycle, pickup, auto with trailer, recreational vehicle, 2, 3, 4, or 5 axle, number of occupants in the vehicle, residency, whether they're visiting

Sanibel or Captiva and for how long, type of accommodations, the purpose of their trip (work, personal, shopping, sightseeing, vacationing etc.), the frequency with which the trip is made and whether a toll was paid or a bridge ticket used to cross the Causeway.

According to Price, the City is looking for volunteers to help man the survey traffic lane. Three four-hour shifts per day will be established with seven volunteers working each shift. Volunteers may contact the City Manager's office at 472-4135.

Commissioners  
frown on  
"Lopsided O"

Yesterday's Sanibel Planning Commission session opened with only four "regulars" in the audience. Fred Valtin was the only absentee Commission member.

Commissioner Judy Workman kicked off the meeting by condemning the City Council's recent approval of the "lopsided O" intersection at Causeway Road and Periwinkle Way. She recommended that the City Council be memorandized that "nothing should have been done to the intersection at this time." Her recommendation was adopted by the Commission with only Commissioner Manchester dissenting.

The first case for Commission consideration was a City-initiated Special Amendment to the Comprehensive Land Use Plan (CLUP). It was proposed that the Ecological Zones Map be revised to conform to the recently-approved development and plat for a sector of the East Rocks subdivision off West Gulf Drive. There were objections by Commissioner Workman and members of the audience to the manner in which the previous approvals of the Army Engineers, Department of Environmental Regulation (DER), and the City was accorded the development. After considerable

## "Year of the Coast" voyager visits the Islands

Mark ("Bird") Westall of Sanibel and Miami native Peter Quincy paddled a canoe into Timmy's Nook on Captiva at 4 p.m. last Tuesday, completing a 12-mile leg of Quincy's 904-mile expedition around the Florida coastline from Pensacola to Jacksonville.

The two began their day's journey at Pt. Boca Grande on Gasparilla Island around 9 o'clock that morning. Westall, representing the Sanibel-Captiva Audubon Society, accompanied Quincy across the waters of the Pine Island Sound Aquatic Preserve.

Quincy, who embarked alone from the Sanibel Lighthouse Wednesday morning, is making the voyage as a representative of the Florida Audubon Society. The trip was geared to dramatize the "Year of the Coast" as proclaimed by President Carter and Governor Graham and is the Society's way of focusing attention on the state's long and fragile coastline and the need for a comprehensive coastal resource plan to protect it. The Pine Island Aquatic Preserve is one of the regions for which protective regulations are sought.

The Sanibel-Captiva stop represented the completion of some 470 miles of Quincy's trip. By nightfall Wednesday, he was destined to travel another 26 miles across the waters to Ft. Wiggins, just south of Naples.

The trip began February 25 at Pensacola. From there, Quincy travelled eastward across the icy coastal waters of the panhandle, enduring temperatures as low as 20 degrees F. He has made numerous stops as he paddled southward along Florida's West Coast and will make many more as he winds around the peninsula moving northward to Jacksonville.

Seeking both cooperation and funds for the many coastal projects of the Florida Audubon, Quincy talks with local citizens at every stop.

"Florida's coastline is its strength," he says, calling attention to the longest coastline in the 48 contiguous states.

Westall, who is known on the Islands for his birding canoe tours, joined Quincy at Pt. Boca Grande Tuesday morning to serve as one of several partners scheduled to help Quincy with the oars.

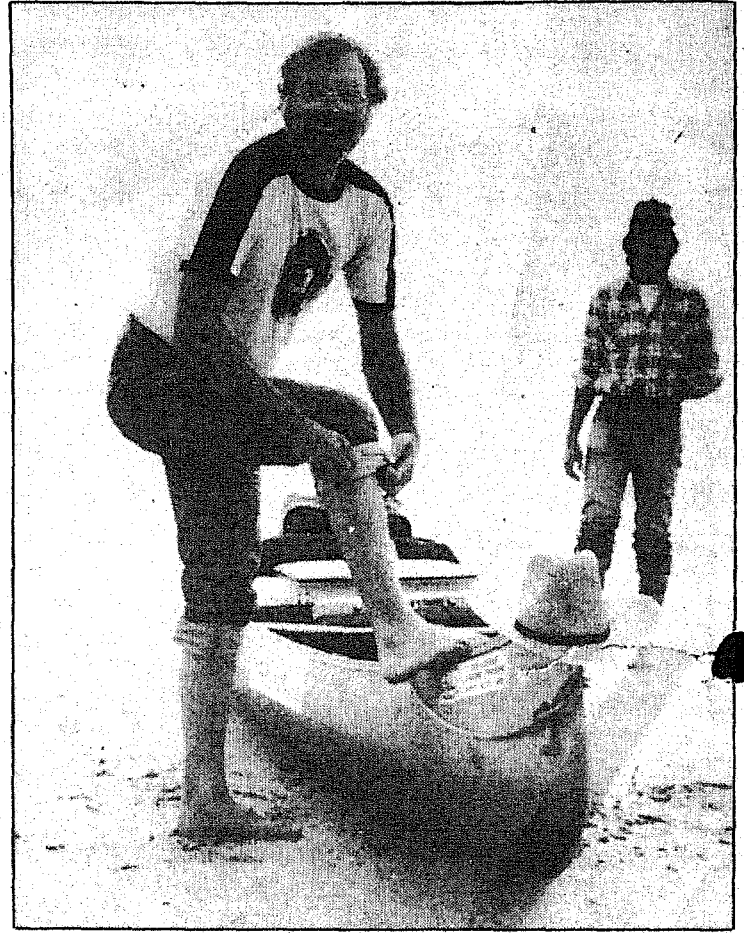
Tuesday's segment of the voyage was not difficult according to Quincy, who was greeted by Islanders at a reception at the Sanibel-Captiva Conservation Society Tuesday night at 8 p.m. He reported that the weather was no real obstacle. The wind was favorable part of the day but then shifted to oppose their course. "But with Westall in the bow, we really had no problems," said Quincy. "This trip wouldn't be at all difficult for me if I had someone like him paddling with me all the way. He is accustomed to frequent canoeing and is in condition for it."

Quincy described the waters between Boca Grande and Sanibel as an especially beautiful section of Florida's coastline - "An area well worth preserving," said Quincy.

"We saw many ospreys and possibly some eagles breeding under all sorts of conditions. Most of the grass beds are undisturbed. In other areas we have seen coastline ruined by over-development. In this area, however, the only problem observed was some erosion of beaches. The water was a bit cloudy, but this was probably due to turbulent weather conditions of the previous three days."

High winds and rain over the previous weekend made the Saturday and Sunday

portions of the trip "very interesting," according to Quincy.

He described Sunday's voyage as "kind of neat," explaining that with the wind's force in the right direction, the canoe had made rapid progress at speeds up to seven knots, without the assistance of either of its occupants.

To date the canoe has not capsized. Only once has it been swamped. That was when a large boat named "The Sweet Revenge," passed at full speed within only a few yards of the lone canoe.

In addition to Quincy and his partner, the 17-foot canoe carries 250 to 300 pounds of equipment and supplies.

Included are a sleeping bag, tent, life preservers, dry clothes, a three to five day supply of food, a 76-quart ice chest, a CB radio, flares and a camera. The boat and equipment for the voyage were provided by Sears.

Quincy, who has lost 10 or more pounds during the trip, said he doesn't recommend such a voyage for everyone. Anyone vulnerable to over-exposure, to wind, sun, or to heart and blood pressure problems should not even think of it.

"But it would be nice to know that the natural beauty I've seen will still be there for the enjoyment of others for years to come," he concluded.

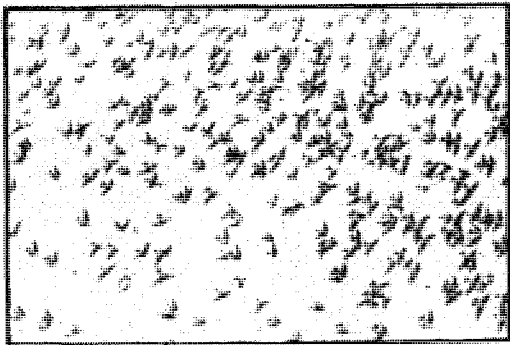
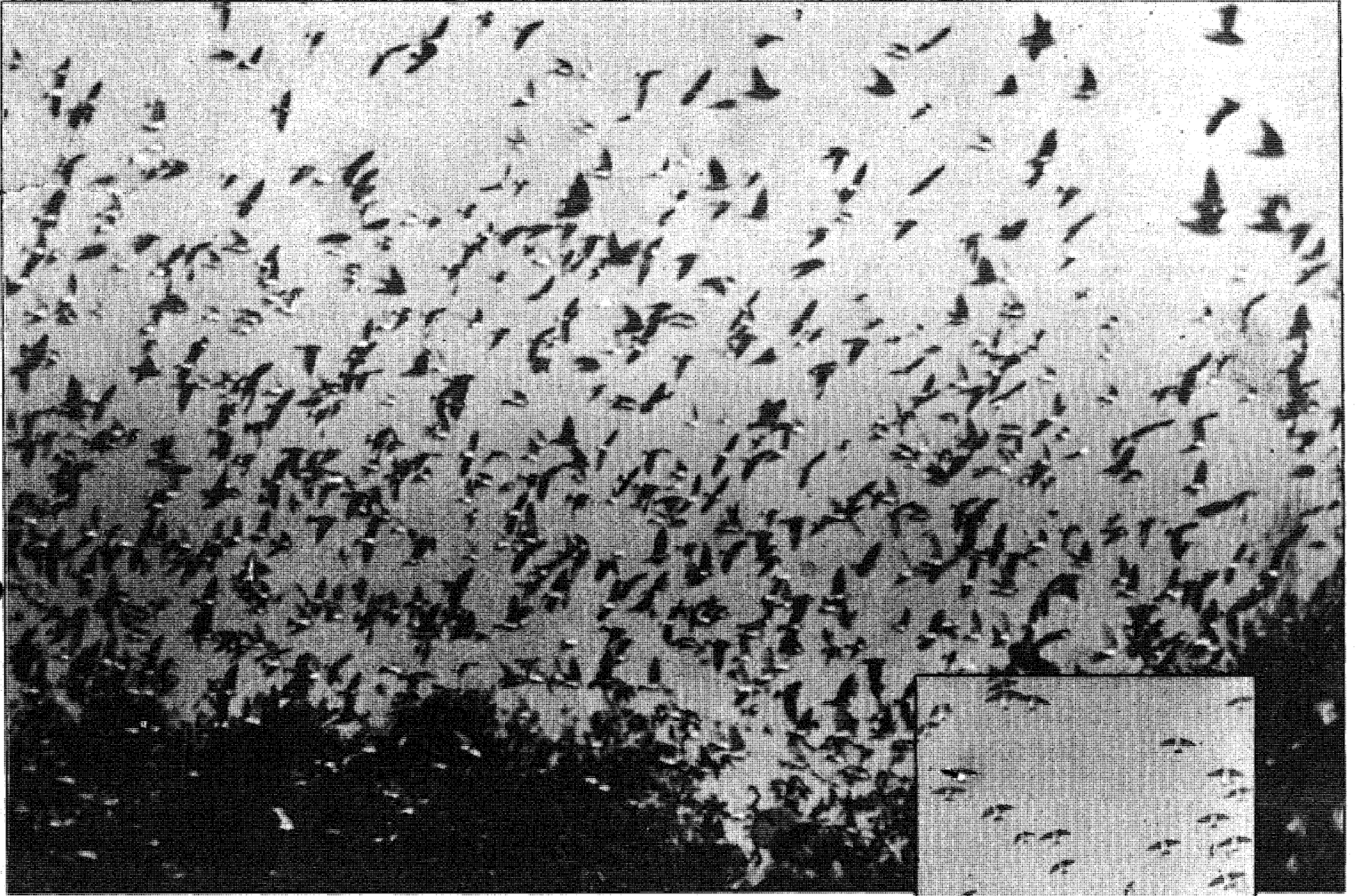

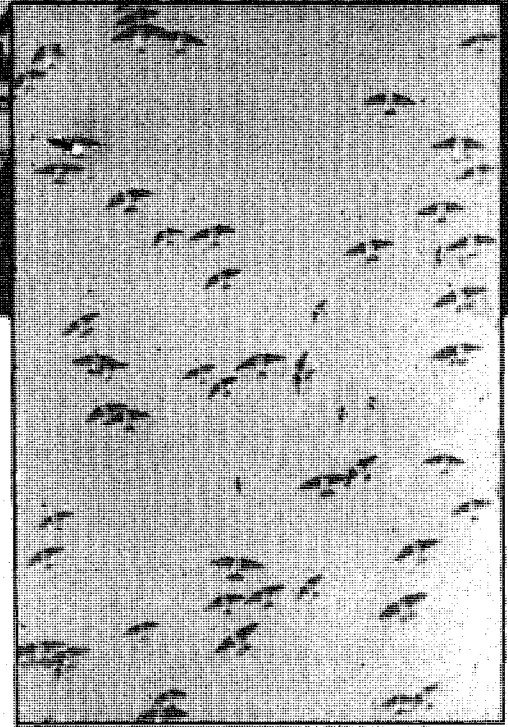

# Spectacular Tree Swallows

A very exciting event occurred on February 18 of this year as I was approaching my home on the Island in the West Rocks.

As I headed home I saw three separate flocks of Tree Swallows, *Iridoprocne bicolor*, flying overhead. I estimated each flock at about 10,000 birds, all flying at an altitude of approximately 500 feet. As I watched, they melded into one huge flock and then split into three distinct groups again, circling cyclonically above the natural forest regenerating around West Rocks.

The attraction for the Swallows to this area is the Southern Bayberry, *Myrica cerifera*, a tree very closely related to the one whose leaves can be purchased in the grocery store for seasoning soups and stews and whose wax is used to provide the aroma for old-fashioned Bayberry soaps and candles. At this time of the year the Southern Bayberry is heavily laden with round, bird-shot size, blue-gray fruit which is highly calorific due to its high wax content.

During the winter phase of its life cycle the Tree Swallow is unable to find the aerial plankton that serves as its usual warm weather diet. By aerial plankton I, of course, mean the insects and other invertebrate life that fly or drift through the air. Did you know that many spiders are found among the aerial plankton? They float freely on webs for considerable distances. Mosquitoes, flies, some moths and various other insects attracted to light in the summertime comprise the highly proteinaceous diet the Tree Swallow requires for summertime nest-building and baby-rearing

activities. Protein in the diet, after all, builds strong young bodies while wax, in its proper place and time, provides high levels of readily available energy.

In the wintertime Tree Swallows migrate in vast numbers to Florida and can be seen anytime between December and April. Considering the chill weather we've had off and on since February (and now in March) it would be quite impossible for there to be much in the way of invertebrate plankton in the air. Consequently, these huge numbers of birds have to subsist on waxberries from the Southern Bayberry tree.

As I watched the three flocks separate and meld into one, and then separate again, they were drifting westward at a considerable elevation and did not appear to be searching for food. But, upon arriving at my home, I took up a favorite vantage point near some very fine and highly productive Bayberry trees and waited. Soon the huge flock, now estimated at about 50,000, descended on a Myrica tree only 20 or 30 feet away from where I was concealed. With a great fluttering of wings the beautiful, bi-colored, iridescent, tiny green-backed birds settled in all their thousands upon a 30 foot tree, bending many of the branches in such a way as to nearly break them. The combined weight of the thousands of birds must have equalled hundreds of pounds because the tree was badly distorted as they fed upon the abundant fruit, emitting a liquid call and causing a great vibrant disturbance with their very audible fluttering.

Again and again they rose from the same tree only to descend again. This aspect of the Swallow's eating habits

was new to me for I had, in previous years, thought that they consumed all of the fruit from a tree in one fell swoop and then traveled on to another. In this instance, the feeding was rather sloppily accomplished. Later I found, on a smooth surface under the same tree, thousands of uneaten berries carelessly dropped and wasted. Walking on that littered smooth surface was like traveling a sidewalk covered with small ball bearings - kind of risky. There being many Myrica in the immediate vicinity of my observation point, I watched as the flocks settled on various other trees over a period of about an hour. As they flew over the cabbage palm canopy the sound was like that of a minor hailstorm, for the seeds were passing through the birds' digestive tracts with amazing rapidity, spattering down upon the palm trees like miniature hailstones on a forest of drumheads.

There is some indication that seeds having passed through the gut of a Tree Swallow germinate more readily than those that simply fall from the tree - a kind of naturally evolved scarification. That afternoon, while discussing this orthological phenomenon with a neighbor, I learned that a few thousand Tree Swallows had passed over her home also. While dipping down to drink from her swimming pool the birds has dropped a neat layer of "ball bearings" on the pool's bottom.

As far as I'm concerned, that's the only problem this species creates and, since my pool is screened, I think it's a small penalty for others to pay to view this incredible sight here on the Islands each year.



# South Seas scores Commission victory

On Wednesday, March 19 the Army Corps of Engineers will hold a public hearing on the proposed South Seas renourishment project. The meeting will be held at the Captiva Community Center at 7 p.m. and the public is invited to comment.

After listening to nearly three hours of testimony, both for and against the proposed South Seas property owners dredging project, the Lee County Commissioners voted 4-1 last week to recommend approval of the project.

The South Seas group must now attain permits from the Army Corps of Engineers, the Department of Natural Resources (DNR) and the Department of Environmental Regulation (DER) before taking further action on the project that will dredge 765,000 cubic yards of sand and

place it along 10,000 linear feet of South Seas shoreline.

After viewing a slide show presented by South Seas president Allen TenBroek and hearing conflicting opinions from more than 20 concerned citizens, the Commissioners asked for a report from Commissioner Harry Rodda - representative for Sanibel and Captiva - who has participated on the committee established

to study the issue.

Rodda, without discussing any of the issues raised by the numerous speakers, told the Commission that he believed the project would not injure the "environmental integrity of the shoreline" and pointed out that the Commission had always "supported renourishment in concept." In addressing the possible long and short term environmental impacts of the dredging, Rodda said he resented the Commission being put in a position to rule on technical matters for which they had no

expertise.

"It's not appropriate for this board to be put into a situation to determine something this technical," he said, adding, "I don't see how our board can make this decision."

Rodda then told the Commissioners that in his estimation the proposed project was "in the public interest."

"If we're not interested in renourishment we shouldn't be pursuing acquisition of barrier islands," he added.

Rodda then moved for approval of the project with the following conditions: that the County's environmental concerns be examined by the DER; that a detailed monitoring program of the project's af-

fects be implemented; that loggerhead turtles in the immediate vicinity of the renourished beach be relocated and appropriate stabilizing vegetation be planted.

Rodda's motion was seconded by Commissioner Wade Scaffa and passed by a 4-1 vote with only Commissioner Roland Roberts (Fort Myers Beach) dissenting.

The City of Sanibel's recommendations, delivered to the Commission by City Planning Director Bruce Rogers, went undiscussed by the Commission. The City Council had earlier in the week approved the recommendations in the event the Commission gave the dredging project a vote of approval.

The Council asked that approval of the project include conditions addressing the issues of lowered densities on South Seas and Captiva, adherence to the DNR setback line on Captiva rather than the Lee County setback, the examination of alternative traffic routes for Captiva, the adoption of a hazard mitigation program for Captiva and a recognition that public resources were being used to protect private property.



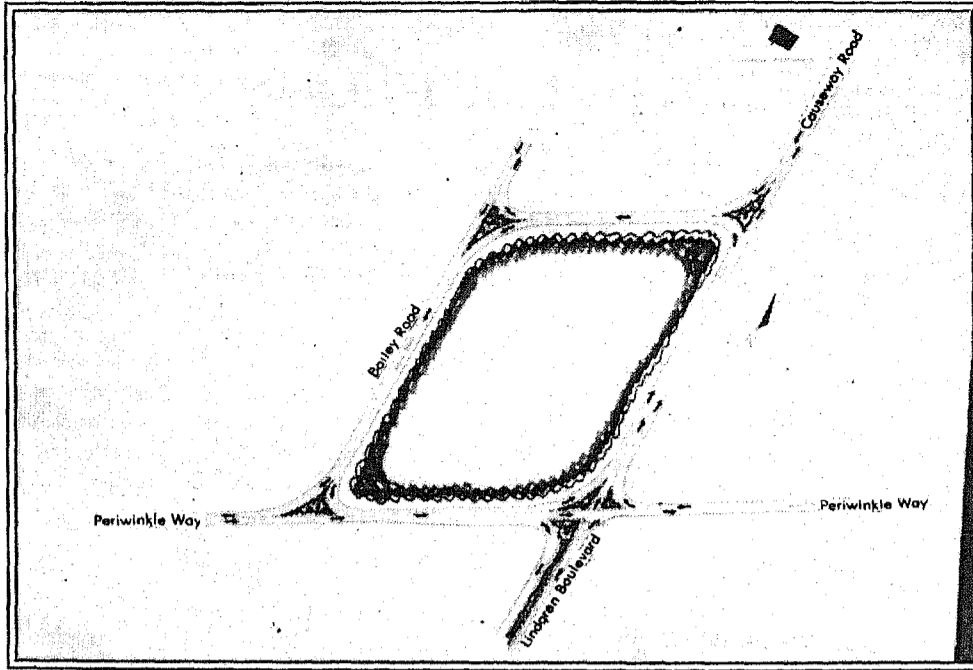
# City approves Causeway - Periwinkle redesign

Acting on what Councilmember Zee Butler called "an opportunity we'll never have again," the Sanibel City Council last week approved a design for the entranceway to the Islands that Councilman Porter Goss dubbed "the lopsided O intersection."

The passing 3-2 "lopsided O" vote came after two other intersection designs - a T-intersection and a rotary - were voted down. The project is expected to cost between \$150,000 and \$180,000 and will completely reroute vehicles traveling onto the Island from the Causeway, vehicles traveling down Periwinkle from the Lighthouse and vehicles wishing to make a left hand turn onto Periwinkle from Lindgren.

Engineering consultants, Howard, Needles, Tammen and Bergendoff submitted five designs to the City, including one suggested by Sanibel resident Arthur Hunter. Butler submitted a T-intersection design by Fenton and White Architects, but it was Hunter's "lopsided O" that got the Council's vote.

Under the approved plan a new road will



be cut through the Causeway property to Bailey Road. Traffic from the Causeway will be routed along a one-way road to Periwinkle. The entire design functions as a one way intersection, with vehicles traveling from Lindgren and the Lighthouse having to travel a half mile out of the way down Bailey Road to gain entrance to Periwinkle Way. Eastbound Periwinkle traffic will be able to turn onto Causeway Road without stopping.

Harry Bertossa, one of the consulting engineers, estimated the traffic capacity of the new design to be about 3,000 vehicles per hour. Bertossa told the Council, "We haven't presented anything to you that will solve all your problems," and pointed out that most of the designs submitted would work more efficiently with traffic lights. The Council, however, took an adamant stand against signalization despite resident Paul Howe's warning that they were "turning themselves inside out to avoid traffic lights."

The proposed intersection now goes before the Planning Commission for final design approval, and if no snags are hit, construction could begin as early as July.

discussion with audience input, a motion to approve the Specific Amendment was unanimously adopted.

A request for a Specific Amendment to CLUP was submitted by realtor Donald Bissell to permit a Restricted Commercial classification for a parcel just west of the Trailer Park on Periwinkle Way. The parcel is now zoned residential. The request was prompted by a recent court decision rezoning an adjacent parcel. Objections were raised to the change, pending completion of the commercial

study by the City now underway. Motion to approve failed with a tie vote.

A requested Development Permit for "Dunes" work, discussed at previous Commission meetings, was again discussed. Two changes were made in the plan as a result of the discussion. The changes involved a relocation of a road and a reconfiguration of several lots. Disagreement arose over the road drainage plans as to whether a grassy swale or a culvert-catchbasin system would be used. The applicant requested that the case be continued for further

investigation of the drainage problem. The Commission approved the requested continuation.

includes the breakdowns the Committee is requesting from the County. "Let's get more information on this system and see if it can be applied to Lee County," Henderson said.

Committee members also discussed a report from Zander reviewing the revenues and expenditures of the Lee County Division of Transportation. In the report, Zander found that "in 1978 the City of Cape Coral received absolutely no

financial support nor services from the Division of Transportation for the construction or maintenance of any roads and bridges within the City."

"Conversely, road and bridge ad valorem, federal, state and countywide taxes were used by the County Commissioners to fund road and bridge projects in the unincorporated areas of the County."

### Why a census?

A treasure of historical sidelights on the Federal Decennial Census is buried in the information made available to me as Sanibel's volunteer representative on the Public Information Division of the Regional "Complete Count" committee.

Many complaints are currently being voiced in the local media about the intimate nature of the questions to be answered on April 1. Central to those gripes is the pervading belief that the answers constitute irrelevant invasions of privacy because they are not essential to "just a basic head count."

Contrary to a widely held belief, the U.S. Constitution does not call for the census to be merely a "head count." It actually provides that the enumeration shall be made "in such a manner" as the Congress "shall by law direct." Ever since the first census in 1790, the Congress has freely exercised that prerogative. Looking back over the questions asked in the Nation's 19 censuses since, reveals an interesting catalogue of changing statistical needs of our mushrooming growth as a new republic.

In planning that very first census, Congress wisely saw it as a ready tool for getting facts on key problems needed to formulate sound policies on the future of our national destiny. The 1790 census, therefore, counted the number of "free white males both over and under 16." This was done to determine the industrial and military potential of our original 13 states.

The 1810 census was planned with the clouds gathering for America's War of 1812 with its former Mother Country - upon whom it still depended for most of its factory goods. Accordingly, the manufacturing data sought was for determining our degree of dependence on Great Britain for supplies and the nature of such materials.

In like manner, the number and variety of questions were

fashioned for subsequent censuses. Mental health data was sought in 1880; labor union participation in 1890; such items as illiteracy, inadequate housing, ownership of radio and TV sets etc. were probed until the need for answers became obsolete and they were dropped in favor of more current demands.

Nowadays Congress is demanding data on: the bases for revenue sharing and grant programs; the structure of overlapping governmental bodies; taxing potentials; condition and capabilities of the nation's farms and factories; the size and shape of election and voting districts; availability of raw materials for domestic trade and a

welter of other subjects pertinent to bringing us out of our economic doldrums. The answers are badly needed as we soar into a population range over the 203 million recorded in 1970.

In light of these revelations it behooves each of us to fully answer the 1980 questions on April 1 - be they on the "Short" or "Long" form. Remember that if ALL the questions are not answered it will cost our Federal Treasury \$200 to send out a special enumerator to get the missing data. This will waste both your and his time and money.

Uncle Sam is again counting on you for a Complete Count on April 1!

WINK - FM has capitulated to commercialism! That means that the 90-minute program of symphonic music which used to be aired from 7 to 9:30 p.m. will no longer be heard. Instead, the station will fill our air waves with ROCK - like all the other commercial stations.

We believe there are two things that we citizens can do. One is to take the opportunity to make a negative comment the next time any one of the WINK stations come up for re-licensing. The other is to support the Edison Community College efforts to get a PUBLIC radio station and a PUBLIC television station in Lee County. Only when this is accomplished will there be an alternative to the mediocre programming which we are subjected to on every commercial radio or television station.

It is clear that commercial broadcasting is entirely concerned with mass audiences and commercial messages. We the public deserve an opportunity to escape from that dull fare.

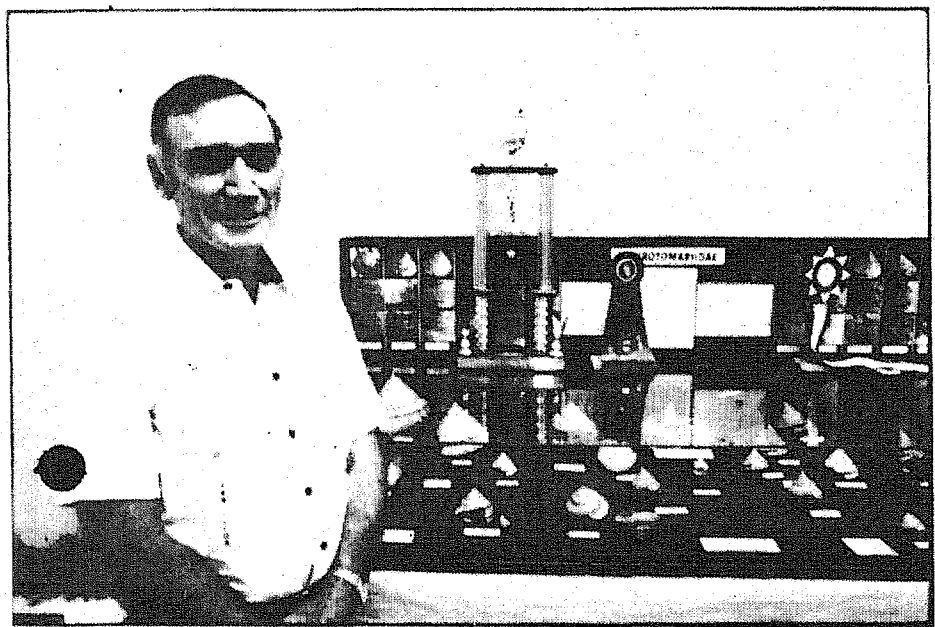
# 1980 Shell Fair

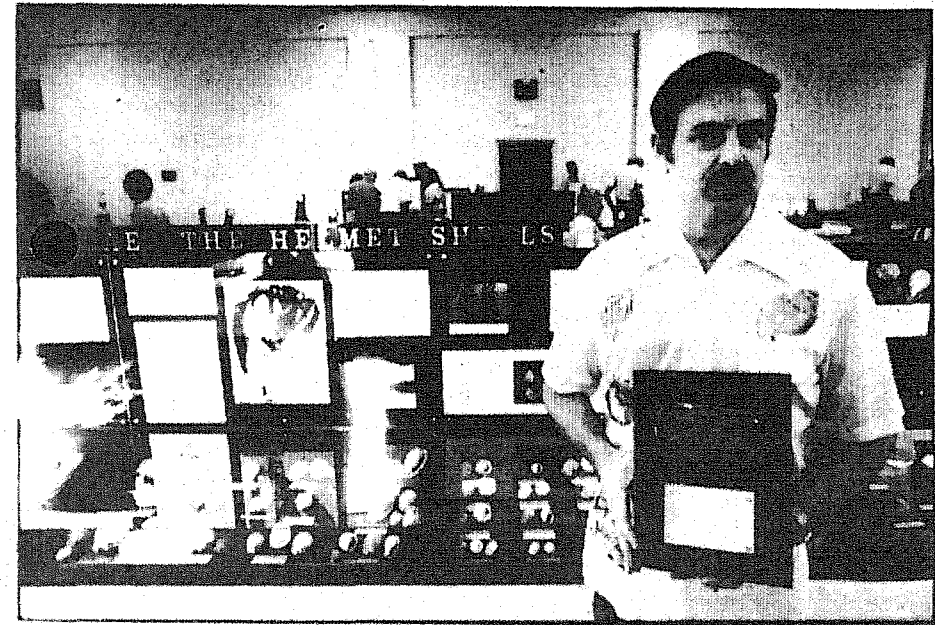

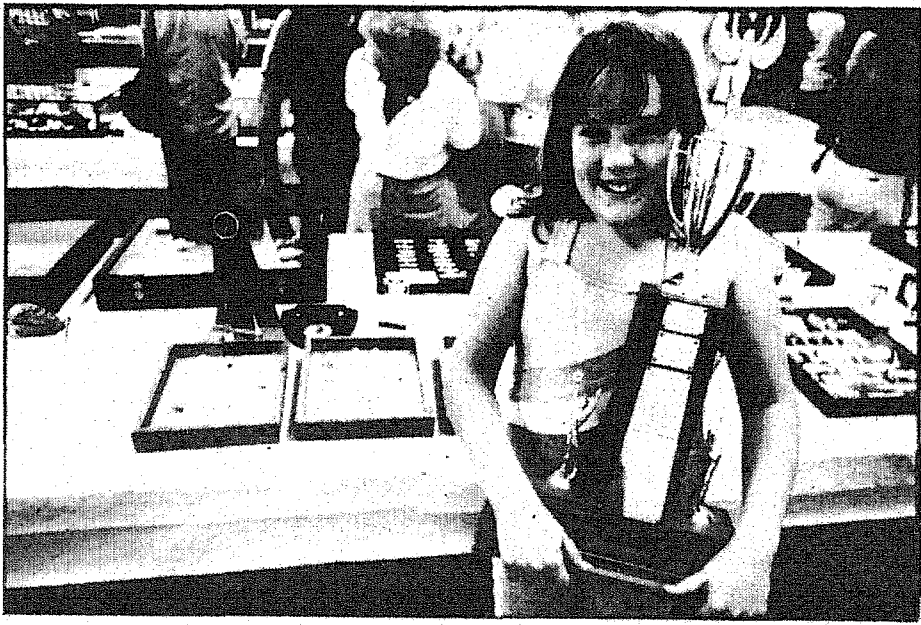
People's Trophy, Scientific - Lee and Stuart Armington

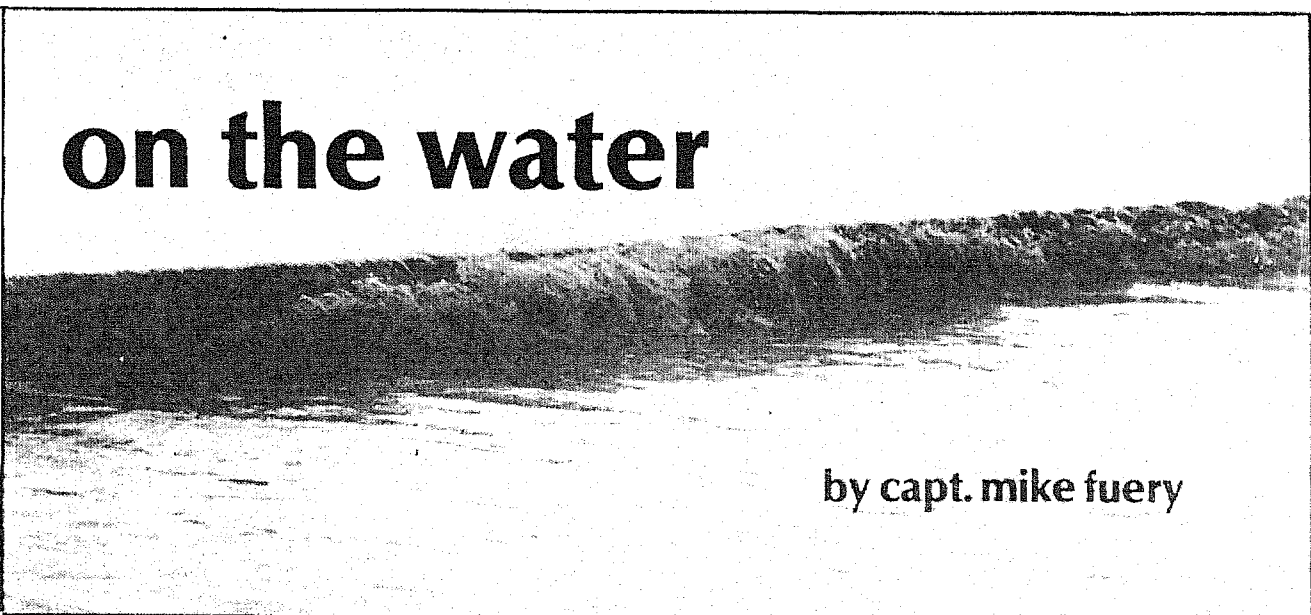


The Mary Cunningham Memorial Trophy - Shemie Baum

# on the water

Between fitting a dead pigmy killer whale into my boat, finding a bottle with a note and two "joints" in it, and of course about freezing to death while out shelling, I had what we call in the news business, a busy week!

You might recall that a couple of years ago I found another note in a bottle and decided not to open it, going on the time tested theory that no good news ever travels by bottle. I didn't open that one, but someone else did and gave me the message and that started all sorts of time consuming correspondence. From that time on I ignored notes in bottles. That is, until last week.

I was up on Cayo Costa Island with a shelling party when I about tripped over a half-buried wine bottle. There was a cork in the end and I could see that there was a note inside. Not this time, I said to myself, and walked on a few paces. But no one ever said you have to be smart to be a fishing

Oh, and there was another item in the bottle also--a package of empty cigarette rolling papers. Nothing suspicious there to me! I put the bottle on board unopened and forgot about it.

When I went home with the story and the bottle, my wife, Carol, said I might as well find out what was inside. If it was grass, then call the Lee County Sheriff's Department have them come out and pick it up and let them worry about

it. I sniffed the cork on the bottle. Cheap disguise. That's my brand. I decided to open it. The two rolled joints bounced around happily on the bottom.

# Shelling Tips

rare shell, finding one is an accident and could happen on any beach on any Island.

Keep searching. No one ever gathered a prize set of collector shells in one outing. It takes many, many trips. These persistent cold fronts have brought in some great shelling for those brave enough to venture out. I heard from someone that a three inch junonia had washed ashore just the other day.

We often think of sea shells as being intricately curved and sculptured things with curious forms, such as that of the arm shell. But there are at least two shells which collectors search the beaches for that are flat, or nearly so, and that's what makes them valuable.

One of the most sought after shells on Sanibel and Captiva Island beaches is the lion's paw. Now there are a couple of "paw" shells, such as the cat's or kitten's paw, which are always much smaller and so thicker.

The Lion's paw is often two or three inches at the longest point and shaped somewhat like a big scallop but there are striking differences. One of the most prominent differences is the apparent lack of curvature which gives the lion's paw the overall appearance of being flat. Actually, the flatter it is, the more valuable it might be.

The other day a woman in my shelling party found a lion's paw about two inches long and wide like an oyster. I have still never found both valves, or sides, of a lion's paw. I've seen some beautiful specimens in collections and I often wonder where they come from, but so far the best I can do is come up with singles.

If you are more inclined to like shells as jewelry rather than under glass, then the lion's paw becomes one very interesting decorative shell. Most shell shops sell them in tiny clasps that you can attach to your prized lion's paw shell. Some people put a couple of light coats of varnish on the shells for extra enhancement of

their necklace.

There is one other very popular shell for both jewelry and collecting and it's called a flat shell, or more often a "fan" shell.

The fan shells are usually a dark brown, like the lion's paw. Both shells often have color variations but, even so, you can't mistake the identity of the two because of their obvious flat form.

The largest fan shell I've ever come upon on Island beaches was about an inch and a half long. That's not very large compared to some that I've seen for sale in shops. They often look like they would come close to being four inches or more in length and nearly that in width.

The flat shells not only make fine jewelry but can be set easily into picture frames under glass. I've seen some very nice displays in frames, but so far I haven't collected enough to design one of my own.

I wish there was a section on one of the Islands that I could direct you to to pick up a lion's paw or fan shell, but like any

## exhibits

Sanibel's Artfac Gallery will be featuring a photographic exhibit by Conrad Bailey from March 14 until April 11.

The exhibit will begin with a reception - open to the public - from 5 p.m. to 7:30 p.m. on March 14. The Gallery is open daily between 10 a.m. and 5 p.m., Monday through Saturday.

The show will include some of Bailey's more recent works, including local landscapes, wildlife, portraits and still life subjects. One of the most interesting aspects of this exhibit will be a group of wide-angle landscape scenes shot with a 100 year old Russian camera. "I not only can't remember the name of the camera, I couldn't even pronounce it," says Bailey.

This will be Bailey's first local exhibit, as most of his work is seen in advertisements and fashion photos, including Time, Life, Mademoiselle, Harpers Bazaar and Vogue magazines.

Bailey studied art at Indiana University and other various schools of photography and apprenticed under some of the finest photographers in Chicago and New York. He was chief photographer for several leading Chicago creative firms, one of which was headed by Wesley Bowman, now a Fort Myers resident.

Bailey was also president of his own firm, working as a photo illustrator, set designer for films and television and lighting consultant for motion pictures and

television. During this period Bailey also owned and operated his own film and television production company in Chicago and New York. His national and international assignments were for leading corporations and advertising agencies in the United States and abroad.

Now a full-time resident of Sanibel, Bailey still accepts national and international advertising photographic assignments, but manages to devote considerable time to this area where he is in demand for television commercials, photographic assignments and serves as director of photography for Lee Living Magazine.

The Schoolhouse Gallery will be featuring an exhibit of Sanibel artists Polly and Ikki Matsumoto's work beginning March 16.

Ikki Matsumoto, born and raised in Tokyo, Japan, attended the Tama Art Institute of Tokyo, the John Herro Art

School in Indianapolis, and is a graduate of the Art Academy of Cincinnati.

Before moving to Sanibel, Mr. Matsumoto worked for several Cincinnati advertising agencies, illustrated text books for McGraw Hill and Houghton Mifflin publishing companies, did 300 illustrations (and redesigned the cover) for the latest edition of the Joy of Cooking cookbook, designed a set of paper sculpture animals marketed by Rand McNally under the name "Zoo-It-Yourself," did numerous book, magazine, toy, furniture and textile designs and designed a set of ceramic dinnerware, napkins and table runners for Denby of England.

Since moving to the Island, Mr. Matsumoto's work has focused on original drawings and paintings in various media and hand printed silk screens.

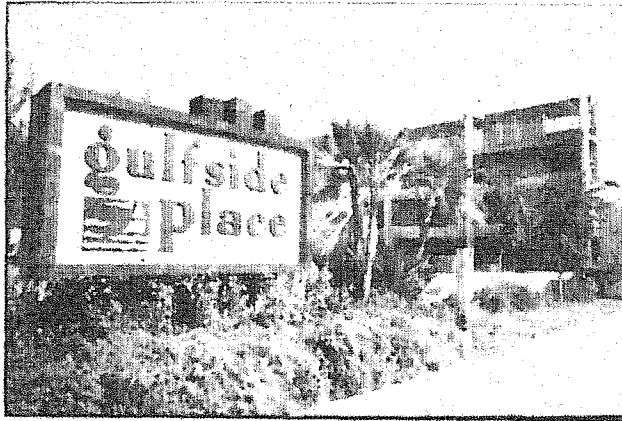
## Gulfside Place denied Building Permit extension

The Sanibel City Council demonstrated their dismay at the slow development of Gulfside Place Condominium last week by voting 3-1 against granting a further extension of the project's Building Permit.

The first Building Permit for Gulfside Place was issued in October, 1977 but was later declared invalid in May, 1978 for not having met a 60 day foundation inspection requirement. That decision was appealed by the owner and in August, 1978 the appeal was upheld by the Board of Adjustment and Appeals.

Since that time the Sanibel City Council has granted three 90 day extension periods of the developer's Building Permits. When the developer's attorney appeared before the Council last week a memo was submitted from Acting City Manager Gary Price recommending approval of the fourth extension "since the project is proceeding and is 65 percent completed."

Councilman Duane White told the at-



orney that in his opinion "You people have tried to hoodwink us." City Manager Bernie Murphy pointed out to Council that the "Staff is not overwhelmed by their progress," but Building Official George Blaine interjected that "The contractor is

working diligently...and the project appears to be moving well."

When questioned as to an approximate completion date the City Official estimated the time to be about six more months.

Councilmembers expressed mixed emotions regarding the project, tired of repeated extensions but fearful of the possibility of a deserted half-built project.

Councilmember Zee Butler told the attorney "The City of Sanibel wants this project over and done with," and Councilman Charles LeBuff echoed her sentiments saying, "It's getting near the end of the rope for extensions as far as I'm concerned."

Councilman White moved to deny the day Permit extension (the current permit expires March 18) and Councilman LeBuff seconded. The motion passed 3-1 with Mayor Bailey dissenting and Councilman Porter Goss absent.

Now the developer must reapply for a Permit, which if secured, will be good for a period of one year. White also asked that a thorough inspection be conducted of the existing development.

## City-Library contract in the works

Sanibel Library Vice President George Tenney appeared before City Council last week to request a committee be formed to draft a contract between the Library and the City.

The Library Board must give the Lee County Commissioners notice of the cancellation of the Library-County contract before July 1 and, according to Tenney, "The day the City and Library enter into contract the County-Library

contract will be cancelled."

A committee consisting of the City Manager, City Attorney, Councilmember Zee Butler, Paul Howe, George Tenney, Howard Hulsman, Harriet Howe and Arthur Clark was established to draft the City-Library contract.

Tenney also told the Council that the Library's name was being shortened from The Sanibel Island Free Public Library to The Sanibel Free Public Library.

## Council supports efforts to lower Fort Myers Beach density

The Sanibel City Council passed a Resolution last Tuesday requesting the Lee County Commission lower the maximum density per acre on Fort Myers Beach.

Councilmember Zee Butler introduced the request in response to a letter from Dennis Simon, secretary of the Beach Voters Association.

The Lee County Commission is expected to hear arguments April 2 concerning a

request for rezoning Beach property from 30 to 14 units per acre.

Calling the lowered density an "unconscionable amount still," Councilmember Porter Goss drafted the Resolution in support of "further reduction of density on Fort Myers Beach," citing beach access, traffic congestion, hazard mitigation, water quality and drainage, and environmental impacts of the Beach's high density as factors affecting Sanibel.

## City approves Aloha Taxi

City Council last week granted unanimous approval to an Occupational License for the Aloha Taxi service, owned and operated by Jeanette Daniel, President of Trans-Oceanic Resort, Inc.

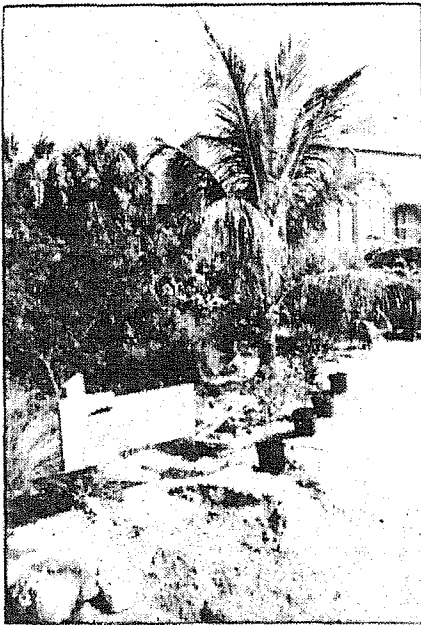
According to City Code Enforcer Dick Baker, the License will allow Ms. Daniel to

house her "corporate headquarters" in her Tahitian Gardens place of business.

Ms. Daniel asked for approval of three taxis on the Islands with options for a total up to 11. According to Baker, the taxis will not be housed on the Islands but will work instead out of Kingston Square in Iona-McGregor.

## City supports census

City Council approved a request from the Citizen's Census Committee for an allocation to help with the Island's 1980 census. The motion to approve an amount "not to exceed \$300" passed unanimously.



## Cyprina Beach denied Graphics variance

Cyprina Beach Condominium was turned down last week by City Council on their request for a Graphics Ordinance variance that would have allowed two small signs in place of their existing one (permitted by the Ordinance).

Appearing on behalf of the owners, a representative from Environmental Graphics told the Council that Cyprina Beach was requesting two small signs - one at each entry to the development - in place of their one large sign currently standing in between the two drives. Maintaining that this was a special case - because the two separate drives do not interconnect inside the development - the spokesman said that both signs together would not equal the maximum space allowed for the large single sign currently permitted.

Claiming that the vegetation buffer and the location of the drives made it impossible to see the single sign coming from both directions, the spokesman told Council that granting a variance for Cyprina would not set a precedent.

Councilmember Zee Butler agreed that the Cyprina Beach sign "was attractive" but added, "there's no doubt in my mind that it's a graphic. I can't see where you'll be hurt by our turning this down." Duane White agreed, adding, "I'd like to see people make an honest effort to comply with this Ordinance."

Mayor Francis Bailey pointed out that perhaps this was a special case and reminded Council, "We've agreed to review these on a case by case basis." Council, however, voted 3-1 against the variance, with Bailey dissenting.

## Triplex request withdrawn

Robert Sagers of Sanibel Estates last week withdrew his request to Council for an Amendment that would have allowed conversion of a single family home to a triplex.

Sagers, who admitted installing two kitchens in "closets" without receiving City approval, told the Council that after meeting with City Staff members and the Planning Commission he knew he would not "ever be able to get approval," and was therefore withdrawing his request.

When questioned by Council as to whether the home was being used for purposes other than a single family residence, Sagers responded no, "I swear to God," it has never been rented and is now being used as a single family home.

## Standard & Poor's Register offers executive information

Who are the officers of Eastern Airlines? Who is the vice president in charge of nuclear affairs of the Florida Power and Light Company? How many persons are employed by the American Telephone and Telegraph Company? What are the annual sales of the Florida Land Company?

Of what companies is David Rockefeller a director? What is his education, his age, his business address? Where can I find a list of manufacturers of pens and mechanical pencils?

All of these questions and similar ones can be answered at the Sanibel Public

Library. The Library has recently added the 1980 edition of "Standard & Poor's Register of Corporations, Directors and Executives" to its Reference Collection.

This three-volume set contains a list of 37,000 corporations with officers and directors in the first volume; brief biographies of 75,000 executives and directors in the second volume; a classified industrial index, and a geographical index of corporations as well as lists of executives who have died since the previous edition and those who have

been added to the new edition in the third volume. It is the most complete national directory of corporations and their personnel published today.

Here are some of the ways the "Register" can be used: to verify correct titles and proper spelling of names of important company officials; to identify interlocking business connections of officials; to determine importance of a company by checking number of employees and annual sales; to locate headquarter offices and home addresses of

corporation executives; to locate technical officers and engineers; to locate companies that are engaged in the same type of business and are in the same area; to identify personal acquaintances.

The Sanibel Public Library has a staff of 70 volunteers with a special group trained in the use of the reference books. Do not hesitate to ask for assistance when you visit the Library located on Palm Ridge Road next to the Fire House. It is open every day except Sunday from 10 a.m. until 4 p.m.



# Photography as art means higher prices

Even though he admits that "My own photographs are uniformly horrible and out of focus," Harry Lunn has helped revolutionize the world of photography. As the owner of two galleries and a leading dealer in the art, Lunn has been a major force behind the dramatic price increase in photographic prints over the past few years.

Exhibiting photographs by Ansel Adams, Robert Frank, Henri Cartier-Bresson, and Yousuf Karsh, Lunn shared his experiences from the photographic market at Sundial last Saturday. The program was sponsored by The Photographers' Gallery.

Lunn wasn't always involved with photography. He began as an art dealer handling lithographs and etchings. One day he happened to view a few photographs by Ansel Adams at a friend's gallery - and was immediately impressed

"with the freshness of the prints." He later arranged to have a showing of Adams photography at his own Washington D.C. gallery.

When the show generated a bigger response from both the media and the viewers than any other he had previously presented, he decided to "take a closer look at photography."

Lunn began handling Adams' work in 1971, and was in the perfect position when the artist made the momentous decision to refuse any more commercial print orders after 1975.

Two dealers, Light Gallery and Lunn, surmised the impact of Adams' decision. They both placed large orders for Adams' prints.

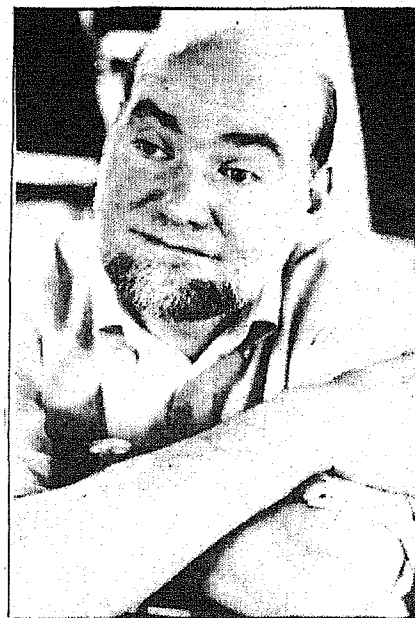
The demand for Adams' photography was still growing, but now the supply of prints was limited. Prices skyrocketed. The most dramatic increase was

demonstrated in a print Lunn calls an emblematic image, "Moonrise, Hernandez, New Mexico." In 1972 a print of "Moonrise" was selling for \$150, the asking price now is \$20,000!

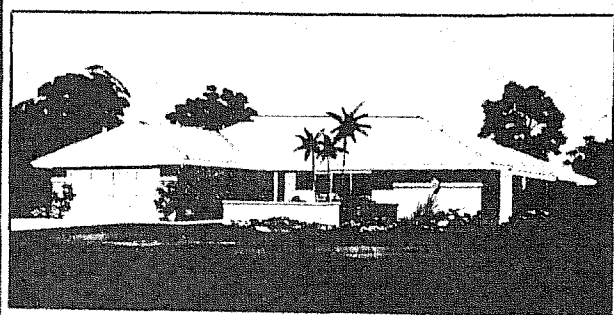
Later Lunn began buying entire collections of other established photographers' work. He currently handles the photographs of Walker Evans, Robert Frank, Ansel Adams, and Yousuf Karsh.

The commercial practice of Adams is now being copied by other photographers. By limiting editions of prints, other established photographers are now riding the increased price bandwagon started by Adams and Lunn.

The photographic art boom has yet to benefit the unestablished photographer. For that photographer Lunn recommends limiting prints and holding on to them for as long as one can afford to.

"In macro-photography, I see an opportunity to suggest the preciseness and the ambiguity of nature," says Mrs. Foskett.

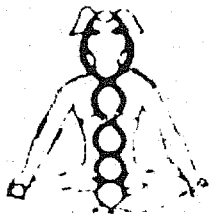
Mrs. Foskett's exhibits hang in the Conservation Center and the Photographer's Gallery on Sanibel, and in several locations throughout Wisconsin

## On the TAX SCENE

### MUTUAL FUNDS

**QUESTION:** I bought some mutual fund shares this year. I have received an earnings report showing \$700 gross dividends consisting of \$100 qualifying dividends, \$265 capital gain dividends, \$80 return of capital and \$255 non-qualifying dividends. I have reinvested these dividends in additional shares and have not received any cash. Do I have to report this income on my return?

**ANSWER:** Yes. Gross dividends are includible in income in the year constructively received. Qualifying dividends are eligible for the \$100 exclusion, nonqualifying dividends are fully taxable, capital gains are eligible for capital gains treatment and a return of capital reduces the basis of the stock on which paid—only amounts that exceed the basis are taxable.

## TUESDAYS AT THE CENTER —

### Passive solar technology can cool your home

You can minimize the sun's scorching affect's on your home this summer and reduce the need for air conditioning, according to Peter Valtin, last week's speaker at the Sanibel-Captiva Conservation Center.

Valtin, an Island carpenter who specializes in solar passive construction, stressed measures other than carpentry to reduce the sun's effects on your home. He said that changes through carpentry should be used as a last resort.

It's important to study your home, its orientation with other homes in the area, and the vegetation surrounding it, according to Valtin. "Study the direction of the sun through the windows and doors. Study the trees in the yard to see where the shadows fall," he said. "Shadows can be very helpful in protecting areas from heat."

Plants in the yard can either block breezes or channel them to maximize effective ventilation and cooling without air conditioning.

By getting maximum benefit from breezes and shielding a home either with plants or with the addition of overhangs and shutters, air conditioning may even become unnecessary.

In a home in which air conditioning is absolutely necessary, the approach will be somewhat different. As the home should remain as airtight as possible, breezes should be channelled away from windows

and doors of the home. In considering what should be done to get maximum (or minimum) benefit of breezes, it should be remembered that winds in this area generally come from the south and southeast, Valtin said.

To shield a home from the hot summer sun, medium-sized shade trees, possibly evergreen, should be located on the northeast and northwest corners of the home to protect it from the low angle of the sun's rays in June.

The placement of very tall canopy trees at the southeast and southwest corners will do much to protect the home from the even hotter August sun.

The breeze flow into and around your house is largely determined by its position in relation to other homes in the neighborhood. In some cases other homes help to channel an existing breeze. When a natural channel such as this does not exist around your home, shrubs can be planted to form a tight web of growth that can serve as a wall to channel and intensify breeze effectiveness.

Valtin recommends that you make a diagram of your home and the other homes on the street. Indicate on your map the direction of breezes, and the customary angle of the sun's rays. By studying the diagram, he said, you will begin to understand how to make your home solar passive.

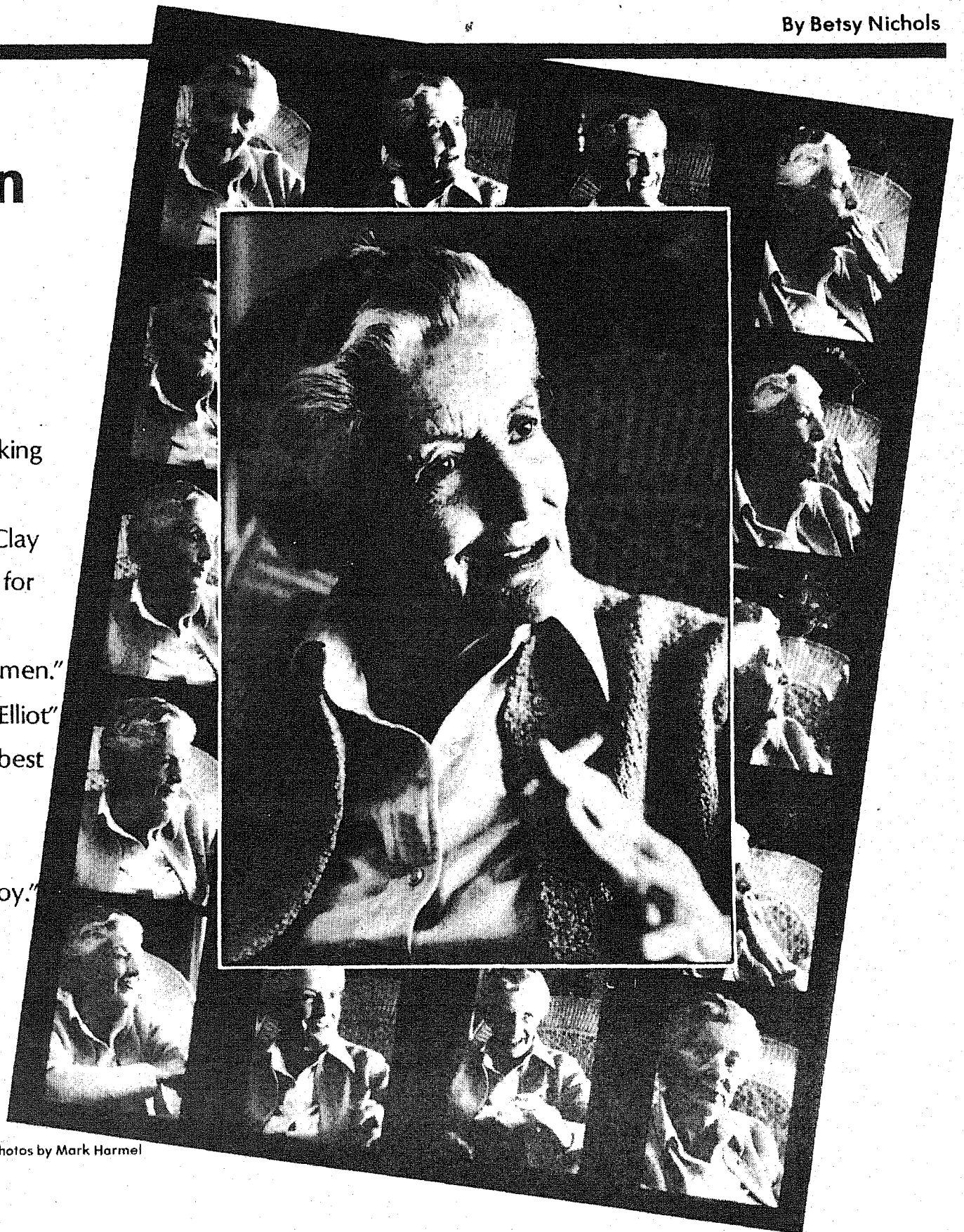

Having successfully published her first two books of poems since her 68th birthday, Captivan Marian Cannon has a lot to feel good about.

As a result of her accomplishments as a poet she has won numerous awards and served as poet-in-residence at several colleges and universities in North Carolina, including Belmont Abbey and St. Andrews.

Soon to be 75 years old, Marian radiates the excitement of continuing involvement and accomplishment. Her eyes reveal her enthusiasm for life - warm with a soft glow of mischief. One moment they may flicker with amusement and the next moment dance with excitement and then they may flash with the fire of a cause.

Marian Cannon has devoted her life to causes. A native of Charlotte, North Carolina, where she still has a home, she calls herself "very, very Democratic, very liberal, and very integration oriented." She has been a leader of the Charlotte Civil Rights Movement since the early 1950's.

Marian is not only the product of Charlotte's prevailing Southern aristocracy but a product of a mixed marriage as well. A poem published in her first book best sums up her roots:

"My father was a Methodist.  
My mother was a Jew.  
And that makes me quite different  
From either you or you.

Aaron holds one hand up high.  
Wesley holds the other;  
I am divided, split and torn,

But every man my brother."

After traveling North to Columbia University, where she attended school with Black students, Marian returned to Charlotte a true crusader. Later, as chairman of the Council for Human Relations, she received repeated midnight calls from the Ku Klux Klan and learned (from the FBI) that her phone was tapped. It was then she learned the meaning of personal harassment - all the while taking great delight in the slow progress being made.

"Through the years," she says today, "we have accomplished a lot. But so much more still needs to be done." Charlotte is the only city in North Carolina where a strict 60-40 ratio of black and white is enforced through school busing. "It is working," she maintains, "with no ill effects on the quality of education there."

Her published poems reveal her ardor for the "cause." Both books are currently out of print but will soon be reprinted as a single volume. Titled "Another Light" and "Second Wind," Marian's books reveal her life. A poem from "Second Wind" sums up her feelings for the Civil Rights Movement:

"Until this year I was a revolutionary.  
I've marched and picketed,  
Written to my Senator, voted 'left.'  
I've shouted slogans, even coined a few;  
Lost old friends, made new.  
But I look upon the world with tired eyes.  
I've changed it not at all.  
There is still war, and poverty and hunger.  
The ears in Congress are deaf and voices dumb.

What shall I do with the brief time I have?  
Cultivate my garden? No!  
I'll carry banners for a losing cause!"

Other poems tell of her love for her Island home located in the midst of South Seas Plantation.

Fourteen years ago she built a piling home so she could see over the tops of the dunes and seagrapes to the Gulf beyond. Today those dunes are gone, along with many of the sea grapes. Erosion has claimed 60 feet of beach that was once there.

A rope swing drops some 20 feet from the ceiling of her atrium living room and, except for the extra long rope, looks like a child's tree swing. Does she swing in it? "Why, all sorts of people do!" she twitters with amusement.

From the swing or from her favorite chair Marian enjoys a full view of the Gulf and the pounding of the surf. The sea's ebb and flow are in her blood, she says.

Here in front of the Gulf she reflects her past and plans her future. Perhaps another trip? She has recently returned from the People's Republic of China where people are "much warmer than the Russians." She has visited Moscow, Africa, Australia and for nine years lived in Europe. Next month she will take one of two grandchildren on a Caribbean cruise.

"There is so much to do in this world. So much I still have not experienced. So much more to be accomplished. So much more to learn and enjoy," she says. "I love old age because I can say and do what I want with less complication. People tend to let you be."



## Property Speaking

Condominiums have become a new way of life here on Sanibel and Captiva as well as in most areas of the country. They have survived their infancy and matured into an excellent way of life.

Much of the negative publicity surrounding condominiums has involved escalating lease agreements on the grounds and recreational areas. Here on Sanibel and Captiva we are very lucky in that all but one condominium is a "pure condominium" in which every owner owns his share of the common areas and there

are no grounds or recreational leases.

A condominium offers the ready-to-retire person an opportunity to purchase a home and not have the normal concerns as to care for that piece of real estate. Condominium Associations are set up with a maintenance fee to cover the normal maintenance problems that many non-handly home owners run into. Here on the Islands the maintenance fees vary from \$55 to \$215. This fee covers a multitude of things including: ground maintenance, pool maintenance, insurance, water, trash

pick-up, outside lighting, sewage treatment and maintenance of the building and common areas. Inflation has however, certainly affected maintenance fees here on our Islands.

Many people have asked about maintenance problems on condominiums on the Islands. Generally speaking there are few problems. However, in many cases the maintenance fee is too low. Having attended several condominium association meetings I find that obtaining enough money to properly maintain the condominium project is a frequent problem. As the project ages, timely maintenance will become more and more important.

I have also been to condo association meetings where the budget was set - but rather important maintenance was not included. No doubt this is partly because many folks purchased their condominium units as a short to medium term in-

The Cypress Lake High School wrestling team finished its season recently, placing fourth in the Southwest Florida Conference with a 12-4 record.

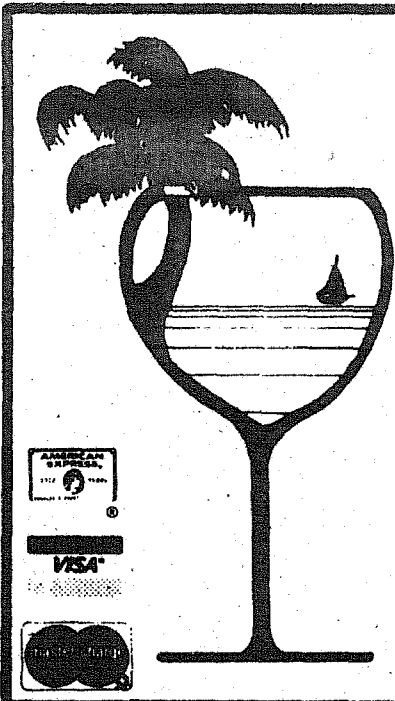
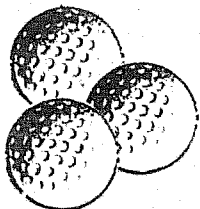

vestment and do not want to put their money into roofs and other major repairs that will be forthcoming in the distant future. This is certainly shortsighted, as with condominium units selling at premium prices it pays to keep one's investment in top shape. If a condominium association does not provide a budget that includes funds for needed maintenance then the association must pass an assessment.

An assessment is usually a significant amount of money which may be spent for a major expenditure such as the replacement of the roofs, renovating the balcony porches or some other major maintenance item. If you are thinking about purchasing a condominium I would recommend that you check into the quality of maintenance the association has under contract.

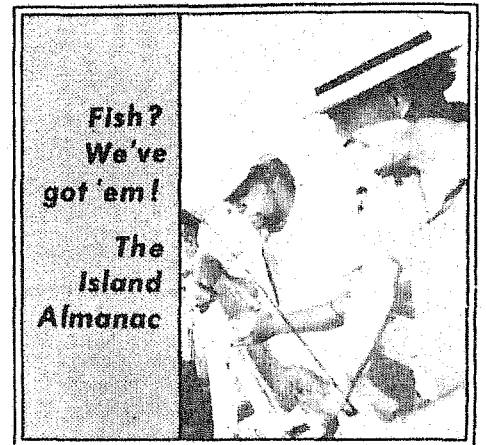
One can easily check those items by finding out if the building's exterior paint is up to standard. Don't just look at the exterior wall carefully, but inspect the facer boards and soffets to see if they are in good shape also. The soffets will show the need for repair first. Additionally, check the pool and the pool furniture to see if it is clean or if it needs repair. The grounds will also tell you whether or not the association is trying to skimp - remember, here on our Islands we get about 56 inches of rain per year and most of that falls in the summertime, so lawn care in the winter dry months gives you the real clue to good ground maintenance.

The management can also be a good indicator. If the management is highly motivated and appears to be happy, the project probably is receiving adequate

funding and the association leadership that it needs. If you do find a unit that you like but the project isn't up to your standards, don't immediately rule it out if the price is right. As a voting member of the association you can be a moving force to see that proper maintenance is given a higher priority. You can also easily get yourself appointed to the board and have a larger voice in how your association is run. This is especially true if you live there a significant part of the year.

Condominium ownership is growing every year and is an excellent way to have worry-free home ownership. Condominium ownership plus meticulous maintenance of the project can add up to an owner satisfaction that is hard to match!

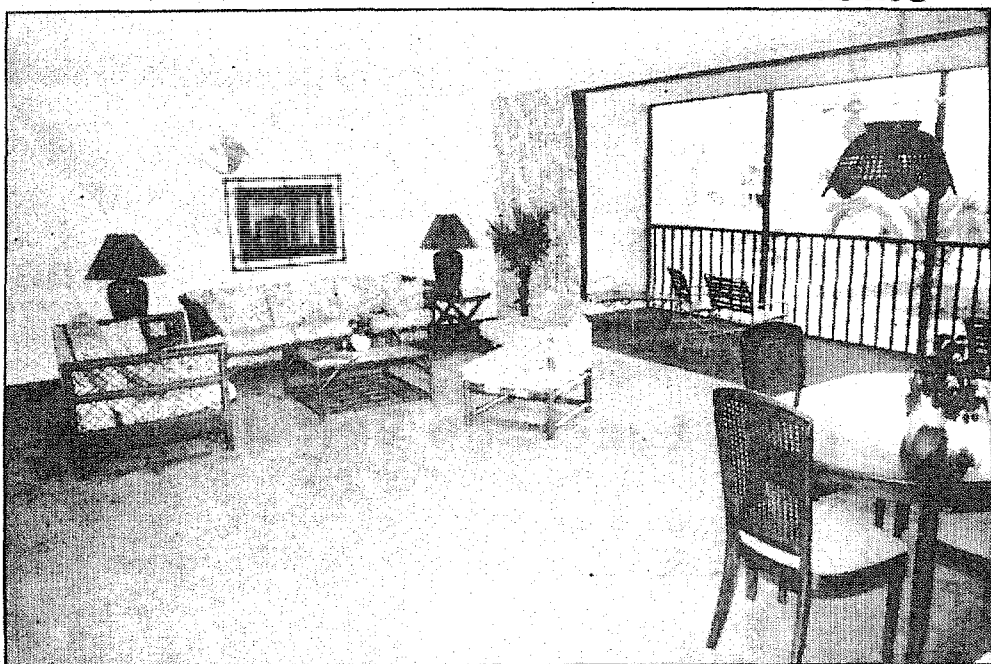

# Police Beat

## Islanders receive threatening phone calls

According to Sanibel Police Chief John Butler, a number of obscene and threatening phone calls have been received recently by Island residents. Numerous phone calls of the same type have been reported by mainland residents and the SPD is working closely with the Lee County Sheriff's Department to determine whether the calls are related.

Florida law prohibits the use of a telephone for the purpose of harassment,

annoyance, abuse, or threatening, obscene or indecent calls and provides for a punishment of up to five years imprisonment or a fine of up to \$1,000 upon conviction of a violation.

Chief Butler advises a person receiving such a call to listen for identifying background noises and observe carefully the caller's dialect. It is best not to respond verbally to the caller and the police should be contacted immediately.

## Stay off the bike paths!

The Sanibel Police Department has announced that they will be paying special attention to vehicles driving on the bike path and passing on the right by driving off the pavement onto the shoulder of the road - in violation of State law and City ordinances that prohibit vehicles from driving or parking along the bike path.

State law also prohibits passing on the right of a vehicle when the passing vehicle is driven off of the paved portion of the roadway.

Persons found violating these laws will be issued citations by the Sanibel Police Department

The Southwest Florida Steel Band will

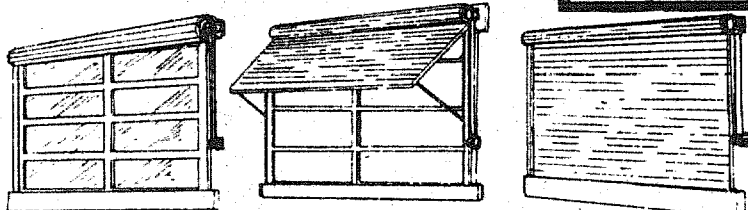

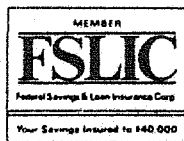

Illegally parked vehicles, sprinklers spraying excessive amounts of water on the road, lost wallets and cameras, visitors removing live shells and a dalmation threatening a postal employee were all just part of the job this month for officers of the Sanibel Police Department.

On March 3 at 6:07 a.m. SPD personnel responded to a call that a man was suffering from a possible heart attack near Sundial. Upon arrival of the SPD and Emergency Medical personnel it was learned that Mrs. William Deverna, returning from shelling on the beach to her vehicle, found her husband in a possible state of cardiac arrest. Three visiting residents of the Periwinkle Trailer Park, Richard Pierce of Alexandria, Virginia, Hillary K. Pandak of Stanton, Virginia and Steven Trozienski of Cresskill, New Jersey were performing cardio-pulmonary resuscitation on Mr. Deverna. Despite

their efforts, William Junior Deverna, 56, of Brooklyn, New York was pronounced dead on arrival.

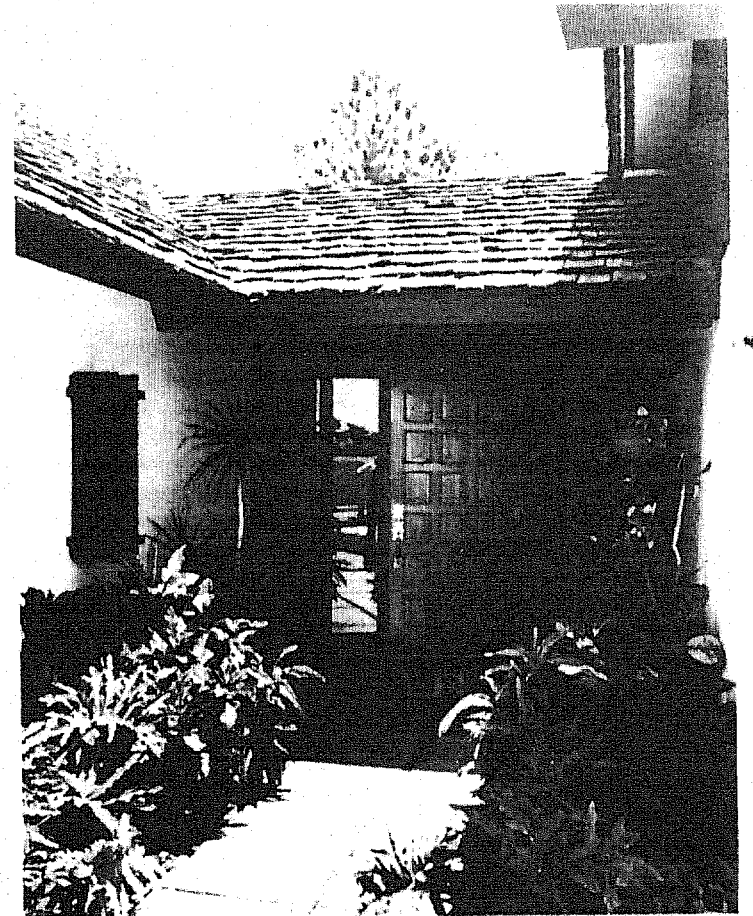
On March 5, Officer Lew Phillips responded to a 5:25 a.m. emergency call from a resident of Pointe Santo. The caller told Officer Phillips that he had woke up to find a 16-18 year old blonde youth standing in his bedroom door. The caller said he had then jumped from his bed and pushed the youth out of the front door. The intruder, he said, had not spoke a word nor did he offer any resistance. Phillips could find nothing missing or disturbed in the residence and no breakage to gain entry was apparent.

While checking the surroundings the Officer discovered that the sliding glass doors to the residence could not be secured. Two partial fingerprints were discovered on a metal door frame and investigation into the incident is continuing.

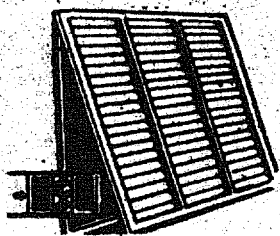

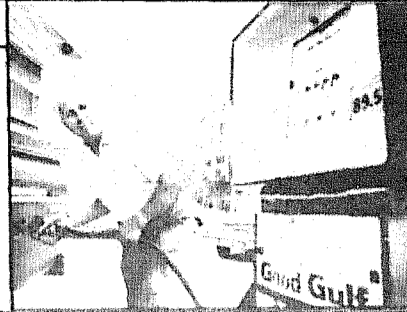
## Beach Access

# The Right Side of the Law



## CAMPING

Camping on the beach is prohibited and while everyone enjoys a beach fire, you'll have to get a permit to have one on a Sanibel public beach. The Fire Department on Palm Ridge Road will supply you with a fire permit for \$1.00. In addition, you'll be required to make a \$25.00 deposit, returnable the day after your beach party when the beach has been inspected for litter or debris. Make sure you clean the area thoroughly or you'll be out \$25.00! Condo owners or managers may submit a letter to the Fire Department, acknowledging that they will assume responsibility for clean up after a fire in front of their buildings. The \$25 deposit will be waived in those circumstances.

## GATORS

Feeding alligators anywhere within the Sanibel city limits is not only illegal (violators of the law are subject to a fine of up to \$500, or up to 60 days in jail, or both.), but can be extremely dangerous. Alligators can run 45 m.p.h., so if you're close enough to feed an alligator, he's close enough to feed on you. An alligator fed for fun loses his natural fear of humans and becomes a potential threat to children and pets.

## FISHING

While no license is required for salt water fishing, fishing in fresh water ponds or the Sanibel River requires a Florida fishing license, available at Bailey's General Store on Periwinkle Way. The fee is \$3.75.

## SHELLING

The City of Sanibel Resolution limiting the taking of shells to 2 live shells per person per species is one to be scrupulously obeyed. As a matter of fact, in order to preserve Sanibel's beautiful shelling beaches, most collectors refuse to take ANY live shells whatsoever.

## SPEED LIMITS

The varying speed limits as one comes across the causeway may seem almost schizophrenic, but there is a very good reason for them. The stress and strain of traffic over the years has weakened the bridge supports (not to the point where there is any danger, fortunately) so in an effort to preserve the existing structure, the speed limits have been imposed.

They are to be taken seriously, for they are rigidly enforced by radar on a 24-hour a day basis by the Lee County Sheriff's Department. Observe them, please.

## DOGGY DO'S... & DONT'S

If you're visiting Sanibel with the family Fido in tow, all the better. All family members can enjoy Southwest Florida sun and surf. The Chamber of Commerce can tell you what accommodations are available for families with pets. REMEMBER - wherever you are - CLEAN UP AFTER YOUR PET! The friendly reminder - "Leave nothing on the beach but footprints" - applies to dogs, too. There's no leash law on Sanibel, but of course an excitable or unruly animal is better off when controlled with a leash.

## BICYCLE RULES

If you're not used to a lot of bicycle traffic, watch out for it on Sanibel. The extensive network of bike paths on the island is clearly marked along the edge of the road. Observe caution when driving near the bike path. A state law and a city ordinance combine to PROHIBIT PARKING OR DRIVING ON THE BIKE PATH. MOPEDS ARE NOT PERMITTED ON THE BIKE PATHS.

Planning on spending some time on a bike to enjoy the island sun and sights? Make sure your vehicle is equipped with a bike flag, horn, good brakes and a light for night riding. Under Florida law, bicycle riders have the same rights and responsibilities as motor vehicle drivers. DRIVE SAFELY.
