**Planners approve vegetation disposal plan**

The August 25 Sanibel Planning Commission meeting started with the recommendation of approval for an Occupational License to permit piano playing at the Cafe Orleans on Periwinkle Way.

An unscheduled discussion by a large group of the residents in the Shell Harbor Subdivision selected Mrs. Schuler and Urban Palmer to present their objections to the MARAND Corporation's proposal to build docks for the use of a commercial boat rental business in their residentially-zoned areas. The matter had been discussed at the July 9 City Council meeting. No action was taken by the Planning Commission on the proposal.

Sanibel Public Works Director Gary Price outlined a proposed vegetative disposal, two-year, pilot project. It would be located in a fenced-in area on land owned by the Sanibel-Captiva Conservation Foundation and would utilize a mechanical chopper or mulcher for vegetation matter only - no garbage or similar trash would be handled. The site is located no closer than 1,200 feet from any residential area. The Commission concurred with the Planning Staff's approval for recommendation.

Gulf Pines Subdivision owner Charles Prete and his builder, Bill Frey, requested a variance to the comprehensive land use plan (CLUP) to construct a structure up to 2,200 square feet. Disagreement arose over the City's classification of the lot as upper or lower wetlands, which determines the permitted lot coverage. To afford time to settle these questions, continuance of the hearing was granted.

Realtor Bert Jenks' application for a development permit to "cosmetically" modify "Weeds & Things" on Periwinkle Way was approved by the Commission after a brief illustrated presentation.

The discussion of the dredging of the Shell Harbor area canals was deferred pending the results of a 2 p.m. Tuesday meeting at MacKenzie Hall to discuss amendments to the consulting engineer's proposals.

The morning meeting ended with the continuance of the Surf Rider Motel's proposal to convert to time-sharing units. The applicant proposed including in their Condominium Documents safeguards on density usage and pro-ration of the cost and responsibility of disposing of disaster ruins among the myriad weekly owners of the time-share units. No action was accorded the application at press time.

and make the pens look the way they should.

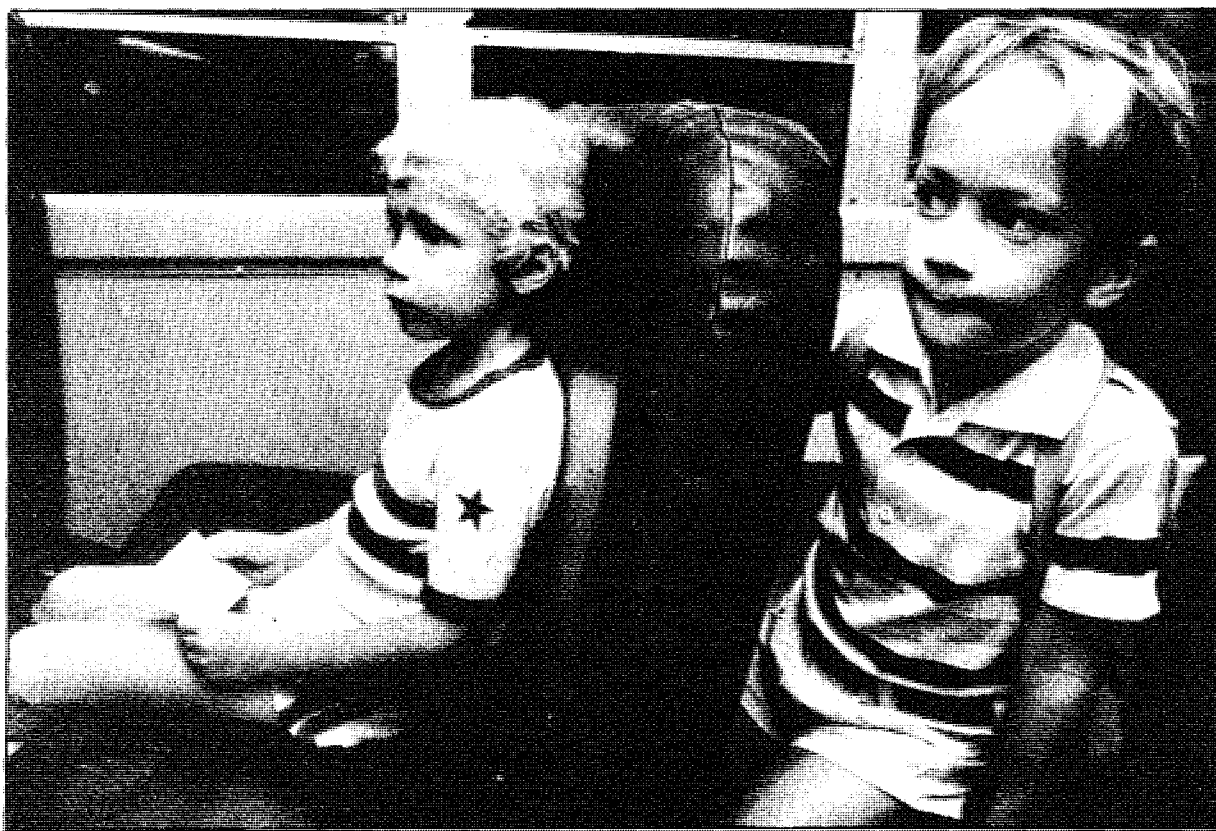

8 a.m. Mrs. Jan Ciesienski approaches her kindergarten class with a warm smile and a friendly 'Hello.' All eyes are upon her as she unlocks the door to the classroom - and the future. Everyone files in, parents and all, to help the children feel as comfortable as possible in this new surrounding.

8:10 a.m. All the parents are gone now. The halls are empty except for a few latecomers and those children still trying to figure out where they belong.

8:15 a.m. Everything seems to be in order. The voice of Mrs. Ward, the principal, can be heard over the PA system as she welcomes everyone to school. "Please stand and place your right hand over your heart for the Pledge of Allegiance," she says.

School is officially in session.

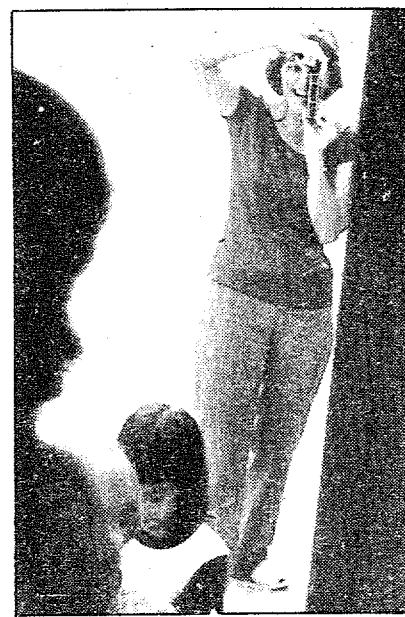

## CONA accepts resolution on Causeway Property

At their last week's meeting the Committee of Neighborhood Associations (CONA) approved a resolution drafted by Paul Howe, head of the fact-finding committee, objecting to the construction of public restrooms near the beach-front area of the Causeway Property.

According to Urban Palmer, CONA president, the organization opposes placement of the facilities on the City owned property due to the fact there are existing facilities, owned by Lee County, on the Causeway.

"We would have three public toilets in a three mile span," said Palmer. "One on the Causeway, one at the boat ramp and one on the Causeway Property. We don't need a \$40,000 welcome mat at the entrance to the Island."

The 28 acre Causeway Property was purchased by the City for \$1,804,400 after approval by public referendum. The conditions of the Farmers Home Administration (FmHA) loan used to finance the property require the installation of "public facilities;" usually considered to be picnic tables and restrooms.

"If we have to have a restroom there," said Palmer, "we should put it up at the Chamber of Commerce. The first thing people want to do after driving 400 miles is find a restroom." The Causeway Property runs from the waterfront to Periwinkle Way.

Tomorrow is the deadline for City Council candidate's review by CONA. Endorsements by the organization for Council candidates is expected later this week.

## Gov. expected to approve South Seas project today

Governor Bob Graham and the Florida Cabinet are expected to approve the South Seas beach renourishment project today when they meet in regular session.

The State Department of Natural Resources (DNR) last week made a recommendation to the Governor that the dredge and fill project be approved. DNR, however, in a precedent setting move, recommended rejection of South Seas' request to set an erosion control line giving two-thirds of the new beach created through renourishment to the private resort.

DNR also recommended to the Governor and Cabinet that South Seas not be charged \$765,000 (\$1 per cubic yard) in

dredging fees since the renourishment project would provide hurricane protection to the entire area, not just the South Seas resort.

DNR's recommended approval was also contingent on the approval of the Department of Environmental Regulation (DER). DER officials have indicated in the past that they will not approve the project on environmental grounds due to the sensitivity of the proposed Redfish Pass borrow site.

The proposed \$2.5 million renourishment project, sponsored by the Captiva Erosion Prevention District and paid for by South Seas property owners, calls for the dredging of 765,000 cubic yards of sand from the Redfish Pass area and placing it along the South Seas waterfront property.

## City applies for dredging permit

The City of Sanibel has applied to the Army Corps of Engineers for a permit to deposit approximately 664 cubic yards of native sand-shell material onto approximately 0.3 acres of upland-wetlands to construct a road connecting Gulf Drive with Casa Ybel Rd.

Any comments on this application should be directed to the Jacksonville District, Corps of Engineers, P.O. Box 4970, Jacksonville, Fla. 32201.

The comment period ends Sept. 18, 1980.

## Valtin announces candidacy

Planning Commissioner Fred Valtin has announced his candidacy for City Council seat number three (Porter Goss' seat).

Valtin's announcement came in a three paragraph press release issued last Wednesday.

Valtin, also manager of Sanibel Cablevision and president of the Island Chamber of Commerce, said that his decision was made after much encouragement by numerous Islanders.

"Since my friend Porter Goss has let it be known that he would seek re-election only to prevent the election of a disaster-type candidate, and assuming that he does not consider me to fall into this category, I will declare for seat number 3 during the upcoming qualifying period," said Valtin's release.

The first day for Council candidate registration is September 2, and the qualifying period ends September 16.

# SPD returns from olympics disillusioned

Five Sanibel policemen competing at the International Police Olympics in New York last week have returned home with few honors and much disillusionment.

Officers Jack Primm, Don Case, Dick Church, Dick Noon and Sgt. Bill Trefny were the Island's representatives to the international event.

Case took a fourth in the 800 meter run and Noon chalked up a fourth in the butterfly competition and a fifth in the breaststroke.

According to Dick Noon however, things were less than kosher at the Big Apple event.

First off, said Noon, "In the Florida

Olympics you can only qualify for three events, but in the Internationals you can qualify for five." A lack of communications however, contributed to the Sanibel representatives being unaware of the rules change. Consequently, they were not entered in events they might have scored much higher in.

Then, the SPD learned that the states of California and New York had entered the four fastest swimmers from their individual states as entries for the relay competition - instead of limiting team members to individual departments. Learning this, the Sanibel relay team dissolved itself and picked up three expert

Florida swimmers to join with Dick Noon in the relay competition. It proved to be a winning combination - the Florida relay team came in second, only four seconds behind the first place winners.

And then they were disqualified.

"One of the guys on our relay team had just moved to Georgia," said Noon. "He had competed in the Florida Police Olympics and Georgia has no state olympics, but the judges ruled he was a Georgia resident and disqualified us."

"We're pretty discouraged and depressed," added Noon. "The New York Police Dept. has 28,000 policemen to pick their entries from - and they're competing

against small teams like ours."

The Sanibel Department intends to write a formal letter of protest to the International committee, according to Noon, and if the rules established this year are allowed to remain, the SPD may not enter International competition again.

"I was pleased with what I did," said Noon, "considering I'm two years older than I was in the last competition. But the way the whole thing was held was very discouraging."

SPD representatives swept 17 silver and gold medals in the Florida Police Olympics held in Tallahassee last June. They were the smallest department represented in the entire competition.

# Taxation committee asks County for relief - again

A resolution calling for relief from dual taxation in the County park system will be presented to the County Commission this Wednesday. Fred Zander chairman of the Tri-City Committee on Taxation, will attend the regular Commission meeting and present the resolution.

Committee members drafted the resolution after examining the County park system and determining that residents of the cities of Sanibel, Cape Coral, and Fort Myers are unjustly taxed to support parks from which they receive no benefit.

A similar resolution regarding the county-wide taxing system for road and bridge maintenance was presented to the Commission in June and accepted with no comment from any of the Commissioners.

Tax committee member Fred Voltan

said he expects the Commission to receive the park resolution in much the same manner. "I think the Commissioners will receive this one in absolute silence," Voltan said.

"Then they'll hand it to (County Administrator) Lavon Wisher for her to file (with the other petition)."

County officials have not responded directly to the road and bridge maintenance resolution, but they still have a few weeks to meet the 90-day deadline.

The County has, however, tentatively adopted a new method of taxing the unincorporated areas for road and bridge work that does not benefit residents of the three cities.

Tax committee members have said they think the road tax proposal represents a definite step toward solving taxing inequities that have long been a bone of

contention between city and county officials.

The park-resolution that Zander will present to the Commission next week asks that certain parks be removed from county-wide taxing system and funded only by those residents who actually use

the parks.

Zander said he will remind the Commission when he makes the presentation

that the three cities represent a total of 36,000 registered voters and 69,000 taxpayers.

She is survived by husband John B. Cook, daughter Nancy Cook Walton, of Birmingham, Alabama, son George

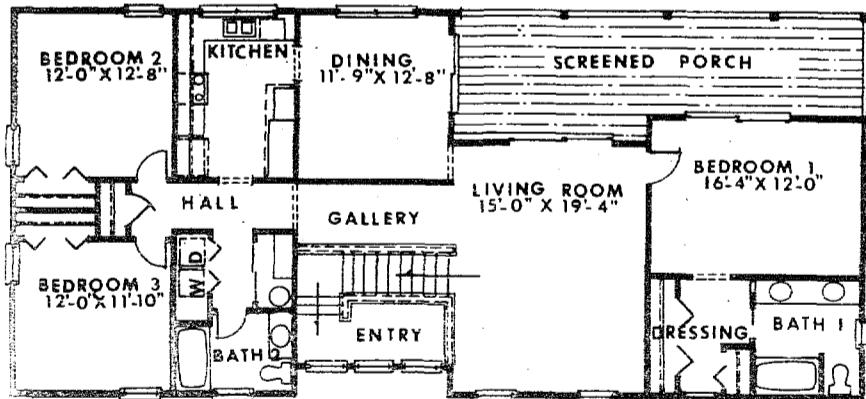
Edward Cook of Paragould, Arkansas, one brother and four sisters, and seven grandchildren.

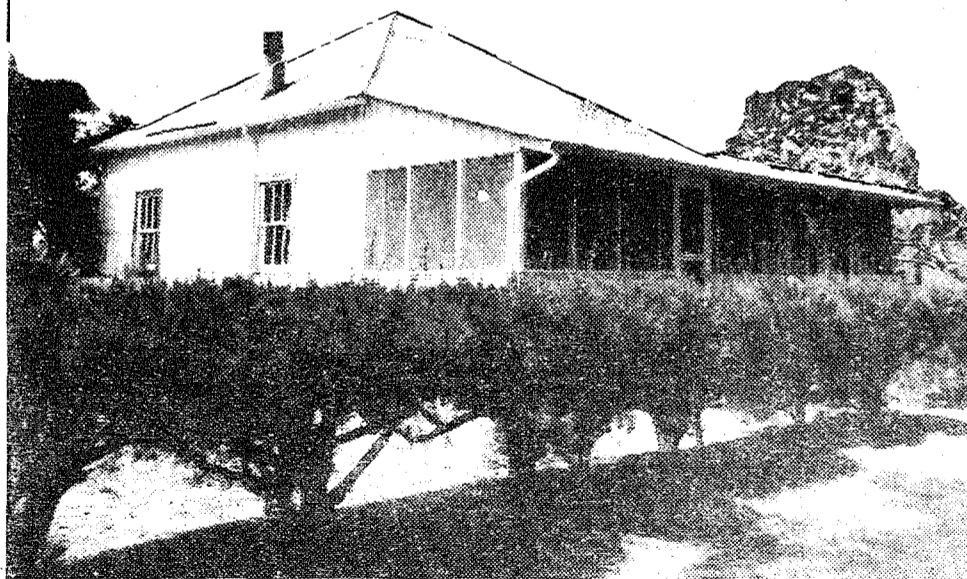

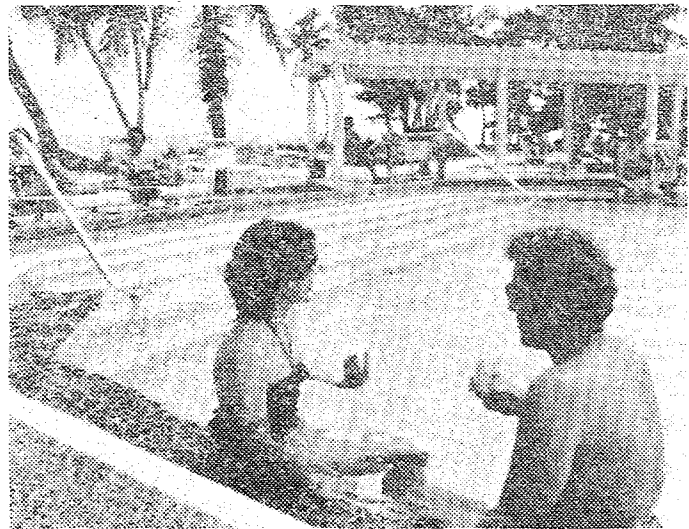

## Wastewater study approved

Sanibel's City Council endorsed a wastewater management and marketing study last week, authorized by the Lee County Board of Commissioners which investigated the disposal of sewage treatment plant sludges.

Fred Biery, representing the consulting engineers who conducted the study, appeared before Council to explain the findings of the study and answer any questions.

The current Lee County 201 Facilities Plan recommends the disposal of dried, digested sewage sludge at the Lee County landfill. According to Biery, this practice is acceptable, but does not provide for the economical return to the citizens of Lee County that recycling of the sludge material would.

Sludge material will be processed into a marketable material which may be utilized in manufacturing organic fertilizer. Biery said that such material is used by farmers, garden shops, and landscaping companies. At the present time, such material is being shipped into Lee County from cities as far away as Houston and Chicago.

The product generated from sludge processing is a pelletized or granular dry material with a consistency similar to coarse sand and is odorless and dark brown in color. This nitrogen enhanced material reportedly has several benefits and advantages over other products currently used in fertilizer blending.

Councilmember Zee Butler personally endorsed the program, saying, "I think it's a step in the right direction."

Councilman Duane White said that, "The program has validity, however, I don't see that Sanibel's Councilmember comments will have any weight one way or the other." Biery responded, "The program

generates revenue, which will flow back to the customers, and you might be benefited in that way."

Butler moved to instruct City Manager Bernie Murphy to write a letter to the Lee County Commissioners expressing approval of the wastewater management and marketing study.

The motion passed unanimously, 3-0 (Councilmembers Charles LeBuff and Porter Goss were absent).

The second reading of an ordinance, which would ultimately provide four dwelling units on the Island for below market rate housing, was continued last week, apparently due to a misunderstanding. The request was submitted by Peter Valtin for Colonel John Sawbridge.

Valtin explained to the Council that in mid-January he approached Col. Sawbridge as a representative of Community Housing and Resources (CHR) and together they had worked out a proposal for below market rate housing. The proposal was then brought before the Planning Commission and substantially altered; it was decided that the dwelling units should be clustered.

Valtin went on to say that the land to be donated for BMR housing is suitable for development. Over one-half of the land is located on the mid-Island ridge; the remainder is on upland-wetlands. He explained that Sawbridge would donate the land to the City, the City would then give the land to CHR.

Councilman Duane White asked Valtin, "Are you anticipating that the City will release this land to CHR?"

Valtin agreed that this was his anticipation.

## Election date set

An ordinance calling and fixing an election for November 4, to elect Council members for seats one, two, and three, was passed unanimously at last week's City Council meeting.

If necessary, a run-off election will be held on November 18, 1980.

A polling place has not been established as yet.

"If you're going to tie expectations into the record then that will throw this case into a whole new light," White said.

"We do expect a commitment that this will be used for BMR housing," Valtin said.

To that White responded, "No one is any more concerned or interested in BMR housing than I. If you want us to hear this case strictly on its merits, fine. I'm not going to write any conditions into it."

Valtin asked if he could request a continuance and re-affirmed that it was his expectation that the land donated to the City would be given back to CHR.

Councilmember Zee Butler said that she was "disturbed that you believe that we're going to donate this land to CHR."

"I assumed that," said Valtin, "because it is through CHR that this land is available for BMR housing."

Mayor Francis Bailey said that he had no idea that the City was expected to deed the property back to CHR. "I don't know how we can turn this over to another individual no matter how high your ideals are," he said.

Councilmember Butler moved continuance. The motion passed unanimously.

## COTI requests commercial moratorium

Committee of the Islands (COTI) Board-member Larry Simon appeared before City Council last week to present a statement calling for a moratorium on commercial growth on Sanibel.

The COTI statement requests a moratorium until regulations can be developed to control the commercial growth on the Island in a manner "similar to the City's control of the growth rate on residential housing."

This moratorium is requested, according to the statement, because, "There has been recent evidence that serious problems of water and electric power supply have occurred. The traffic congestion, sewer problems, drainage difficulties, hazard mitigation, beach access, and many qualities of public health and safety are all interrelated with uncontrolled commercial growth."

"The current congestion on the Island raises serious doubts about the Comprehensive Land Use Plan (CLUP) baseline figure of 2.3 persons per residential unit. If this baseline reference is not correct much of our planning becomes questionable."

"The statement speaks for itself," Simon said.

Councilman Duane White promised Simon that the subject would be discussed at a future Council meeting.

## Quarterdeck challenges graphics ordinance

The Sanibel graphics ordinance came under fire once again at last week's City Council meeting.

Bill Boyd, an owner of the Quarterdeck restaurant, appeared before City Council to request that a log structure at the base of the restaurant's sign be allowed to remain.

The graphics ordinance makes no provision for this type of structure; it only regulates surface plane plus supports of the sign.

However, the Comprehensive Land Use Plan (CLUP) defines this as a structure, regulated by a section under Commercial Yard Requirements, which requires this type of structure be set back a minimum of 100 feet from the centerline of rural collector roads.

Approximately ten other signs on the Island have similar structures located at the base for planting or protection purposes.

"We should find some way to allow him to keep this," Mayor Francis Bailey commented. "It improves the sign."

Councilmember Zee Butler said that the graphics ordinance should be reviewed to allow for this type of structure; City Manager Bernie Murphy agreed and said that he would have the City staff look into it.

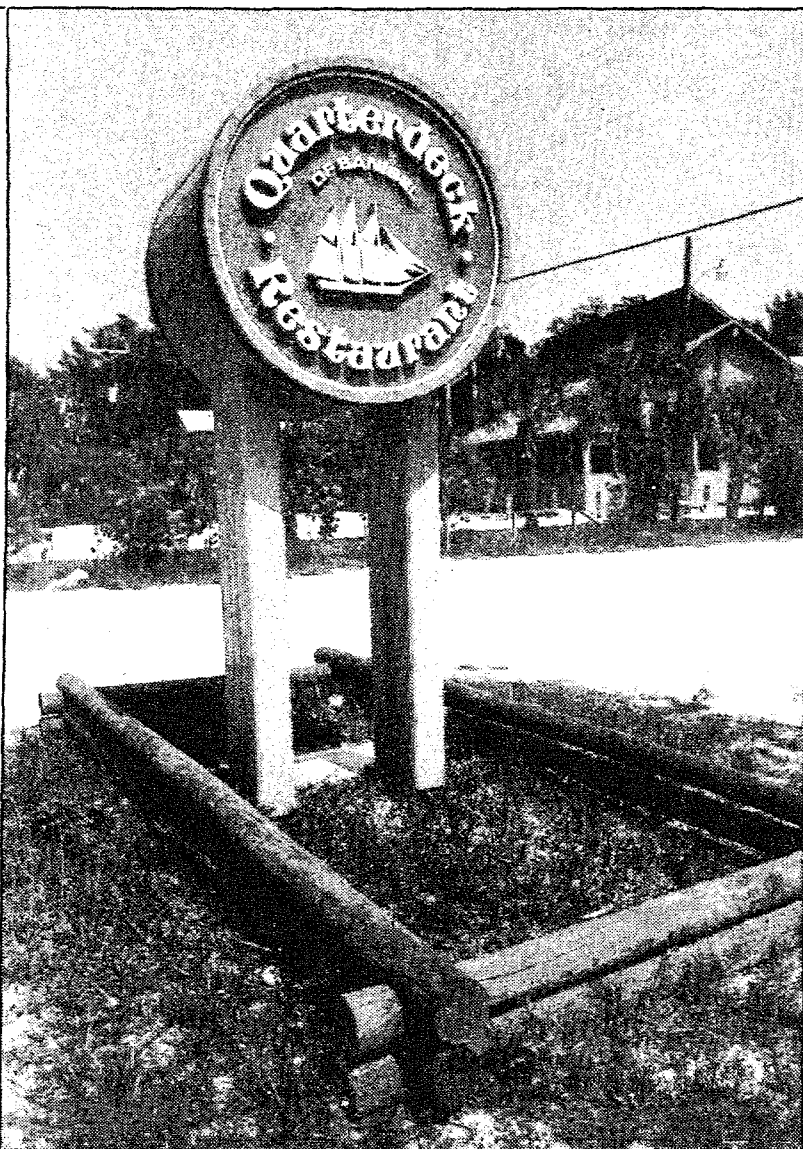

## Hearing on canal dredging held

A special City Council meeting was held last Thursday evening to hear first reading of ordinances creating two special tax districts for canal maintenance and dredging.

Also, at that meeting, the first reading of an ordinance calling an election on November 4 to decide whether the majority of the qualified electors residing within the special taxing districts are in favor of creating the districts was also held.

Preliminary engineering reports have been submitted to the Sanibel City Council by the City's consulting firm of Howard Needles Tammen and Bertossa (HNTB) which explain procedure, possible cost and time estimates. City Manager Bernie Murphy said that a meeting would be held with residents of Shell Harbor to explain how the cost estimates were derived.

Establishment of the taxing district does not establish the mill rate; that figure will be decided upon by a special governing board after the establishment of the district. Sanibel's City Council is the governing board and will be known as the Board of Governors for whatever districts are created.

The two districts considered at Thursday's meeting were the Shell Harbor and Sanibel Estates special taxing districts.

Also at Thursday's meeting, Assistant City Manager Gary Price asked for Council approval to put to bid the plans for the proposed Periwinkle-Casa Ybel intersection.

The plans Price submitted to the Council were not totally complete, however he explained that their approval at that meeting was necessary to stay within the planned construction schedule. At the present time, estimated date of completion is January 9, 1980.

Councilmember Zee Butler made the motion that Council authorize Price to go to bid with the plans; it passed 4-0 (Councilman Porter Goss was absent).

## City Council and IWA workshop slated for Sept. 17

City Councilmembers and representatives from the Island Water Association (IWA) will hold a special workshop and meeting on September 17 to discuss the recent comments by Planning Commission Chairman Ann Winterbotham that water supplies on the Island are not adequate to meet population.

The workshop begins at 9 a.m. at MacKenzie Hall.



# 'Lopsided O' is dead and the 9-T is born

"Lopsided O" is dead - but the idea that something should be done to improve the Causeway-Periwinkle Way intersection is still very much alive.

Last week, City Councilmembers requested in a 2-1 vote (Councilmembers Goss and LeBuff were absent) that City Manager Bernie Murphy provide details and plans for a left turn stacking lane at the intersection.

Harry Bertossa, of the engineering firm of Howard, Needles, Tammen, and Bertossa (HNTB), appeared before Council and presented five more designs and concepts for possible changes to the intersection.

Murphy had been instructed by Council to have the firm of HNTB re-address the intersection problem and re-evaluate what might be done to improve it. The firm of HNTB had been informed that none of the previous six designs could be re-submitted.

Three of the five designs submitted by Bertossa were variations of the T-type intersection. Bertossa explained that the T-type intersection design favors through-traffic and low speeds.

Cost of the designs presented varied from \$150,000 to \$300,000 and required rights of way from one-half acre to three and one-half acres.

Design number nine, which features a left turning lane to Bailey Road and a right hand turn lane, was the proposal finally approved by the Council. It will require a stop, and will have to be police controlled during peak traffic hours during the season. Bertossa said that between 1,000 and 1,500 cars per hour would be able to exit the Island if this change is implemented.

Councilmembers also appeared to approve, at least in theory, design number 12 - which is the extension of Sandcastle Road to the Causeway. This would, in theory, give the people living in the Dunes subdivision an egress out of the area, and reduce the Periwinkle traffic. Bertossa's plans for the Sandcastle extension include a rustic bridge over the mangroves in the area.

Councilmember Zee Butler expressed annoyance at Bertossa's presentation, saying, "This has been the most ludicrous presentation, and I cannot believe you have presented this for our consideration. All this is a contrivance of what was rejected before. I am terribly disappointed, and I don't want to consider anymore designs until someone can present an innovative concept for this difficult problem."

suggested that perhaps a modified approach to design number nine (the stacking lane) should be considered.

City Manager Murphy said, "I'd like to remind the Council that this is a darn near impossible situation. The Causeway is where it is; it's not going to go away, daytrippers and tourists are not going to go away, and there just aren't many options. You can have a "T" and "O" or a square. Those are the options. I could support - and urge you to consider - design number nine. It would give some relief while we are examining further what might be done.

"From May 1979 to May 1980 there were 62 accidents on Periwinkle," Murphy continued, "and 31 of those were rear-end collisions. One half of those accidents were experienced by residents of Sanibel. The number of rear-end accidents is disproportionate to the number of accidents. Most of those happened in the daylight, which should suggest that they were due to stack-up problems."

"I think we should put this project on the back burner," Butler said. "Maybe after Christmas we can get to it again."

But Councilman White disagreed. "This intersection is continuously on my mind," he said. "In our six years as a City we've done very little with the situation. I hope to high heaven that the Council will do something to alleviate the situation by this time next year."

Bertossa and Assistant City Manager Gary Price said that the stacking lane could be completed fairly quickly if the Council decided that it should be constructed.

White made the motion to instruct the City Manager to look into the possibility of a stacking lane. Mayor Francis Bailey seconded, but Butler said that she "wouldn't go with the motion."

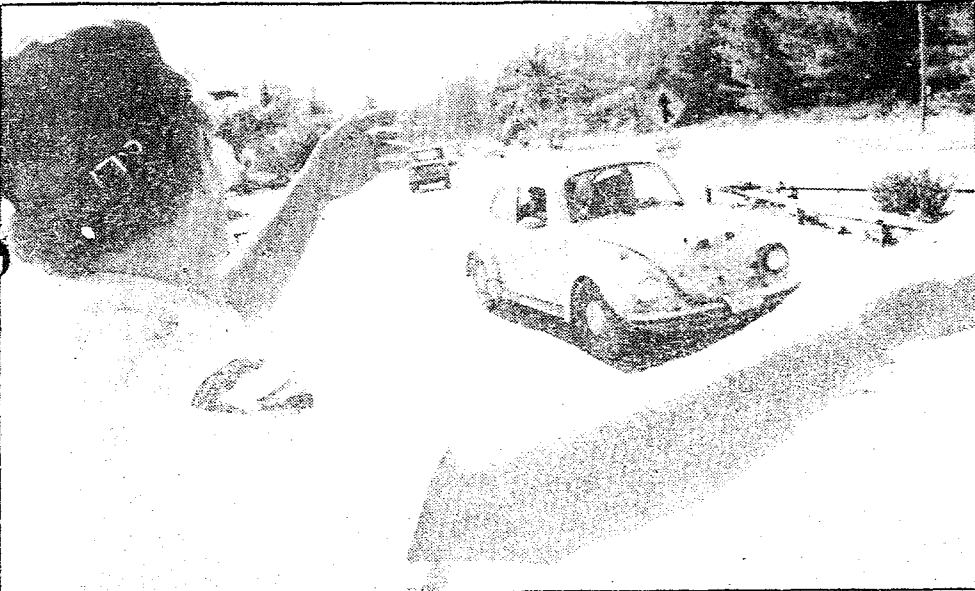
"We're not approving the specifics," White said, "just the scheme."

"But I don't like the fact that we're creeping and creeping," Butler said. "We're spending upwards of \$100,000 and we're not doing all that much."

Bailey said, "We need to try to improve that intersection. It is an awful lot of money in one sense, but if we save one life it would be worth it."

"I'm sorry you put it in that concept," Butler responded.

Planning Commissioner Fred Valtin, who was in the audience, said, "What is proposed comes close to the community feeling;



"I can't really argue with you," Bertossa replied. "This really is nothing new. You have every warrant for a traffic signal today, and the designs I've presented don't include one. How innovative can we get? We're limited in just what we can present. I would like to offer you a utopian situation, but I frankly don't think you can have one."

Councilman Duane White told Bertossa, "Maybe what we want is a hope and expectation that can't be realized. You know what people want and if you're telling us that can't be done then maybe we can find another firm. We need to take steps to alleviate the peak problems." White then

furthermore, any improvement that would result in 40 to 50 percent more cars leaving the Island would be astoundingly good and worth \$100,000."

The question was called and White's motion carried 2-1.

Finally, resident Larry Simon said, "At the risk of being ex-communicated, how about raising the issue of 'Why don't we put in a traffic light?' Let's find out what the Islanders would like to see there. Let's explore that again since we have that mess and it's only getting worse."

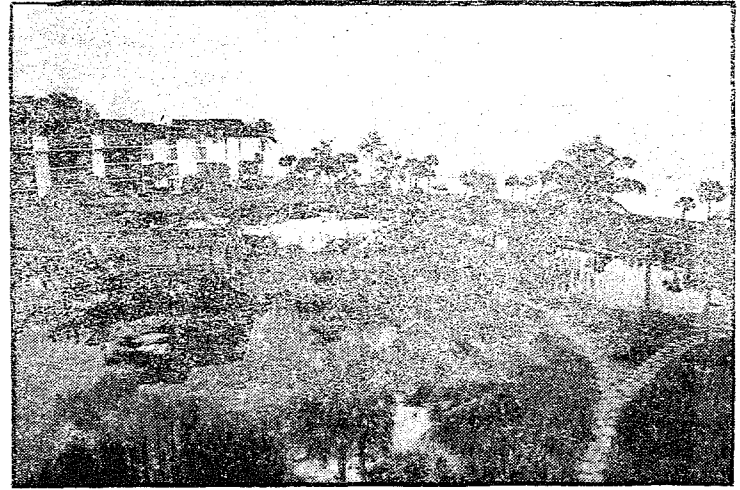
Councilmen did not comment on Simon's suggestion.

# On the water

This year, we thought we would prepare a slightly off-key, tongue in cheek version of hurricane preparedness for boaters. Surely, we all know about how to protect our marine interests after years of "what-to-do" lists, but did you ever wonder what veteran hurricane survivors REALLY do when the big one is aimed at the Islands?

The following is an outline of what usually goes on, in varying order, beginning a day or so before the storm hits to a day after.

**SUPPLIES.** Stock the liquor cabinet. There is no telling what kind of line you are going to have to wait in, so get to the store early. While you are there, get 50 lbs. of block ice. Speaking from experience, there is nothing more depressing than drinking warm beer during a hurricane. Also, there is the matter of food. You can never tell how long these things are going to last.

Accordingly, have plenty of chips, pretzels and dip in stock. Many people like to barbeque during a hurricane. The reason is, for once the darn fire stays lit with all the wind. On the bad side, you have to cook indoors. It gets a bit smoky, but after three days of systematically cleaning out the liquor cabinet, eating chips and smelling like a walking charcoal fire, no one is going to care anyway.

One important item to remember in the supply list is what to read. Outside of Hustler, for the single people in the family, I would suggest insurance policies. Why is it that no one ever reads the fine print until the winds reach 80 mph? I know this is true, and on my policy I have printed, near the "exceptions to the strong winds clause," several slang words that describe my insurance man quite well.

As best as I can understand, I'm protected if the hurricane originates in Orlando or Buffalo, but not protected if the hurricane at anytime touches water. Well, that finally explains the low insurance rates. My flood insurance is something else again. They say that if the water should rise, a small electrical pump will be mailed to me so I can drain out my basement. They say the pump should be stored in the attic when not in use. What, me worry? Naw!

**BOATING INTERESTS.** Here is a trick I learned from some guys several years ago. When the winds look like the worst part of the storm is about to strike, run (you can't walk in a hurricane) over to your boat and move it so it will rest between a large, immovable dock and a huge boat.

Wedge your boat in there and stand back. This is best done at night. Well, of course your boat is going to be crushed to smithereens. That is the plan! When your neighbor returns

to check his boat, there is yours, busted and sunk, clear the victim of the storm.

How did you figure there were so many new boats around here after every hurricane?

**EVACUATION.** When it comes time to bail out, you have two basic choices. A, you can leave in April and return in November. Some call these people "winter visitors," but in reality, they know what's going on and stay in Ohio until the all-clear horn goes off, about November 15.

And there is Plan B. In this plan, you organize your friends into a tiny building company, complete with hammers, nails and lots of plywood. Then you hot foot it to the bar on the Island with the highest elevation, and you then proceed to board the place up. At midnight you jump on the pool table and proclaim, "LET THE PARTY BEGIN." In a bad storm, you don't usually see these people ever again.

The most dangerous people I have ever met are the ones who tell you, "I've been through a dozen hurricanes and never got hurt yet!"

Seriously, be careful and get out early if the authorities say it's time to evacuate and you'll be around to read this again next year.

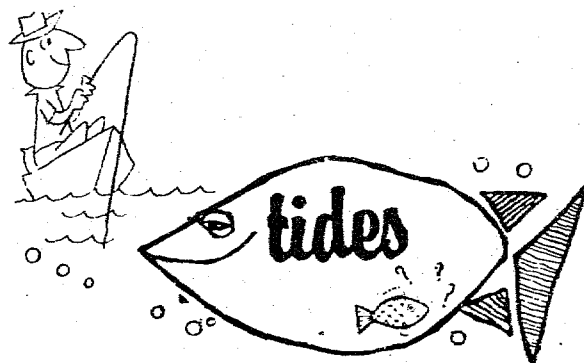

Conversion table: The above tides are for the lighthouse point of Sanibel only. To convert for Redfish Pass (North tip of Captiva), add 55 minutes to the time shown for every high tide. Subtract two minutes for every low tide.

For Captiva Island Gulf side, subtract 30 minutes for each high tide, and subtract hour and 16 minutes for each low tide.

For Captiva Island, Pine Island Sound (Bay) side, add 1 hour and four minutes for each high tide and add 52 minutes for each low tide.

In between these points, gulf or bay; guesstimate and have good fishing or shelling.

# Shelling Tips

If there is one shell more decorative than all the others found on our Sanibel and Captiva Island Beaches, it has to be the sand dollar. This week, let's talk about some of the innovative things shellers can do with this round, flat shell.

Not too long ago, my wife and I were in a gift shop up in Punta Gorda and were interested to find a driftwood display for sale which featured hanging sand dollars. It was a simple idea, with a thin, bleached branch, suspending perhaps a dozen dollars of different sizes on monofilament fishing line. You could have taken it home for \$15.

That brings to mind some other decorative ideas I've seen created with sand dollars and perhaps you have noticed even different displays.

Some of my favorites are the small sand dollars used for jewelry. You can carefully use them for women's necklaces, but the smaller ones are always very, very fragile. I always recommend to my shelling parties that they strengthen the dollars as much as possible with coatings, before trying to use them for this purpose.

One of the easiest methods is to get a small bottle of white glue and mix it half and half with water and paint your sand dollars with the solution several times. It gives the shells a slightly glossy appearance, but also helps to keep them from cracking or chipping. Even this won't really protect the delicate shell, so even though you treat the sand dollar, you are still working with an easily broken item.

When it comes around to the Christmas Season, you might see sand dollars put on the tree. You can paint these about any color you want, of course, and for an Island touch, you can't beat it when your northern friends have a look at the decorations!

If you have the ability to paint (as in artist, not house), then you can put your talents to work on these shells. I've seen some very nicely done beach and nautical scenes painted on sand dollars and then framed for display. It takes

patience and work.

Of course, you need the basic ingredient for any display and that brings us down to where to find the sand dollars. The most accessible beach area is still off Bowmans Beach, towards the Blind Pass end of Sanibel Island.

This is a free, public beach lined with trees instead of condos and it's also relatively uncrowded, at least on the weekdays.

You can find sand dollars in the water anywhere from 100 to 200 feet out. You aren't going to have to be in deep water, however, to find these. I would say that neck deep water or less puts you in the right area. The sand dollars are on the surface of the sand and you will probably find live and dead (white) sand dollars here if you search long enough. We encourage you to take the dead shells.

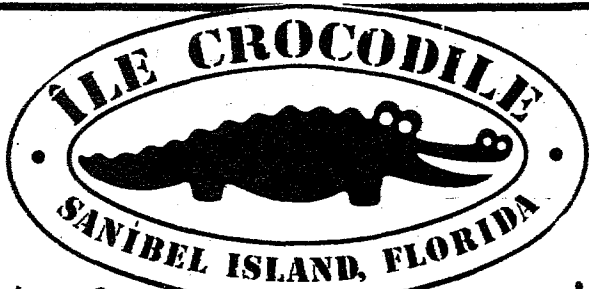
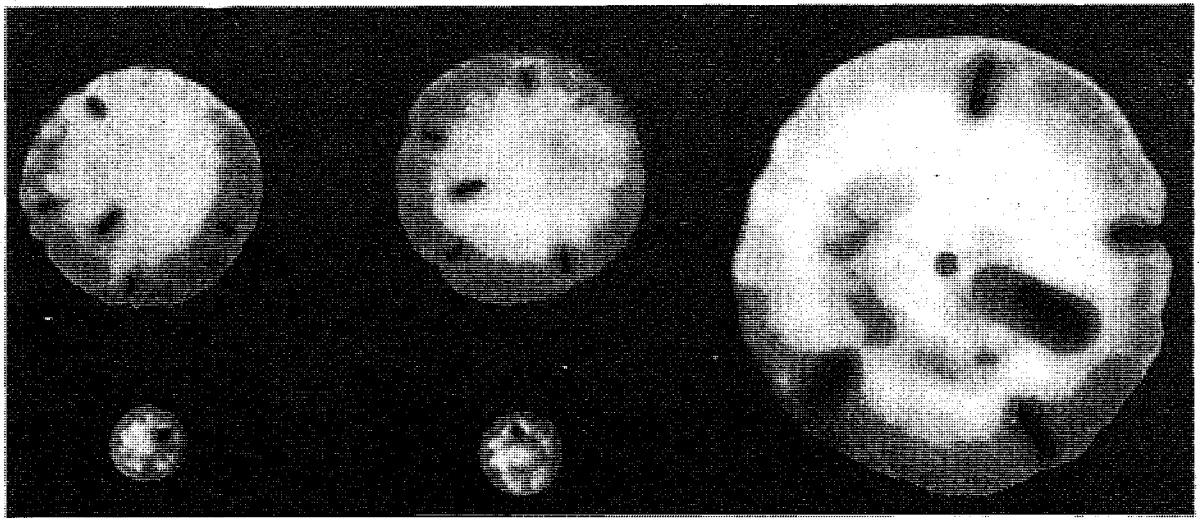
The sand dollar colonies appear sporadically, so don't

expect to wade out, put down a hand and start loading up. You'll have to look quite a bit. I usually start a few hundred yards east of the main entrance to the beach.

When you finally do locate them, take them back to the room and get a bucket. Then get to a store and buy the cheapest bleach you can find. Place the shells in the bucket and pour in the bleach and forget about the works for a day or so. When it is time to work with the shells, you will find them snow white and free from distracting color blotches. Now you can do about any decorative thing you want with them.

Good shelling and keep in mind the limit of two live shells, per person, per species while you are on our beaches.

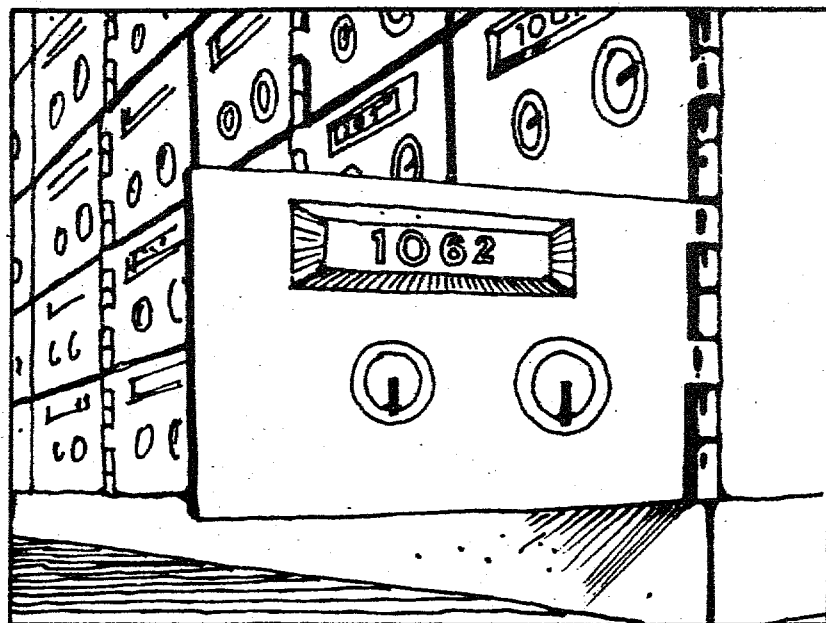

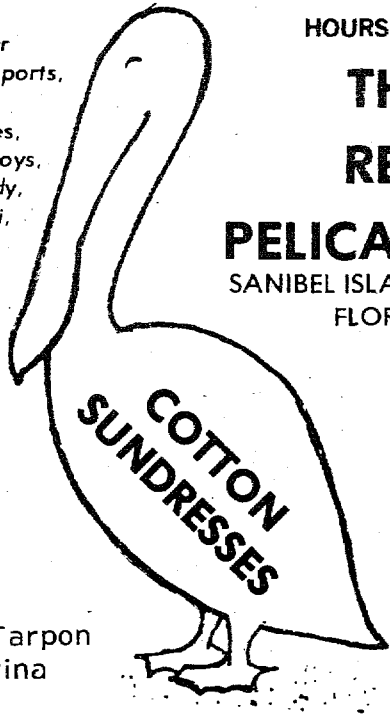

# Island SHORTS

## No tickee, no passee

The recent Sanibel Causeway policy of requiring each car to have its own ticket book has caused some mixed feelings among the Island populace, including downright anger.

Since the new rule was instituted, some drivers have managed to get around it by handing their ticket book first to the ticket-taker, then getting out of their car and handing the book to the driver behind them, then walking back to their car and driving on.

Toll facility director Fred Lescher says he understands why people do this, but that a law is a law, and should be obeyed. The toll-booth workers don't have arrest power, he says, and they don't want to get into a hassle with drivers.

"When we get into our busy season," Lescher said, "some of these hot tempered people are going to be sitting in line and see these people running around, and there's going to be a free-for-all."

Lescher said both toll lanes are sometimes opened during heavy traffic and there is a chance that a driver or passenger running back and forth between cars could cause an accident.

In order to discourage the ticket book passing activity, the toll booth office has tried calling the Lee County Sheriff's Office for assistance but there has been no response.

To be an effective deterrent, however, the new rule would require an officer on duty all day. Even this would not necessarily solve the problem, according to Sanibel Police Chief John Butler.

Butler said that if an officer was stationed in front of the toll booth and witnessed the ticket book drop about to take place, he could tell the driver to move on (without getting out of his car) or face a citation.

On the officer's side in this case would be Florida Uniform Traffic Control Law No. 316.072, paragraph 3, which reads, in part: "It is unlawful and a misdemeanor of the second degree for any person willfully to fail or refuse to comply with any lawful order or direction of any police officer who is invested by law or ordinance with authority to direct, control or regulate traffic."

The flaw in this, Butler says, is that the officer can only order the driver to move on; he cannot order passengers to remain in their car. Thus the passenger can easily walk back to the trailing car, and give that driver the book.

Conceivably, Butler said, the County could draft an ordinance whereby it would be illegal for any person, driver or passenger, to get out of a vehicle in or near the toll booth.

But again, American ingenuity would probably manage to make such a ruling worthless. Butler suggested that people

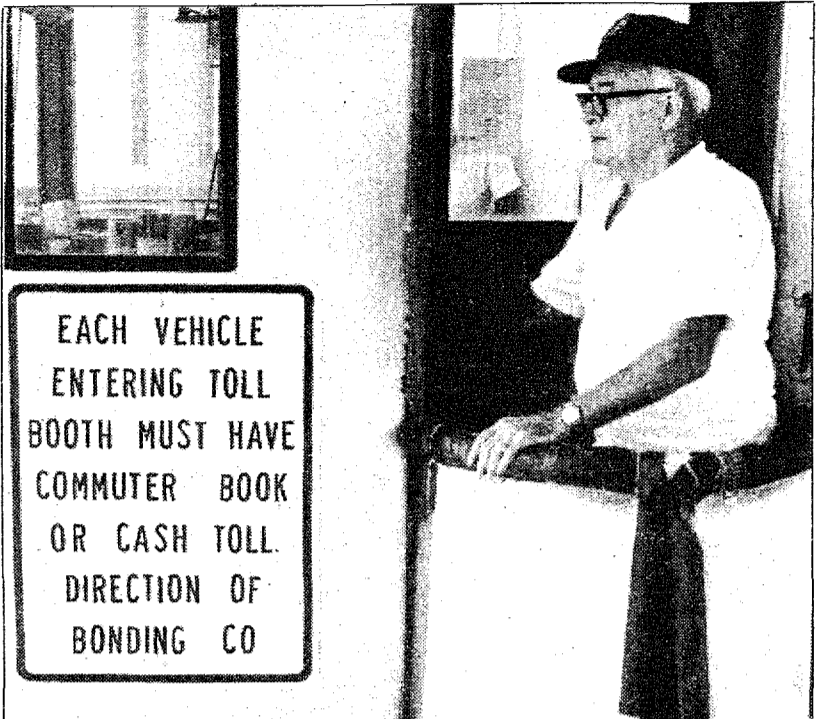

were liable to toss the book back from car to car, or even attach it to a line where it could be sent back.

Another way to get around the law would be for 19 cars to gather in the Punta Rassa public boat dock parking lot. The twentieth car could pull up to the toll booth and buy a

book. After the attendant tears off ticket number one, the car could drive through, pull over to the fence, and toss the book over the fence to car number two, and so on.

It appears that some rules are easier made than enforced. -B.M.

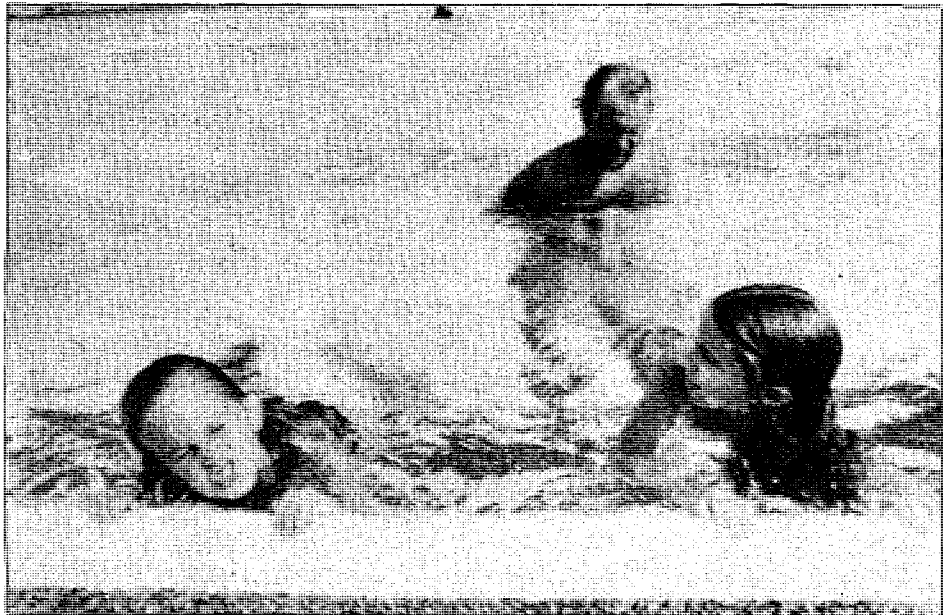

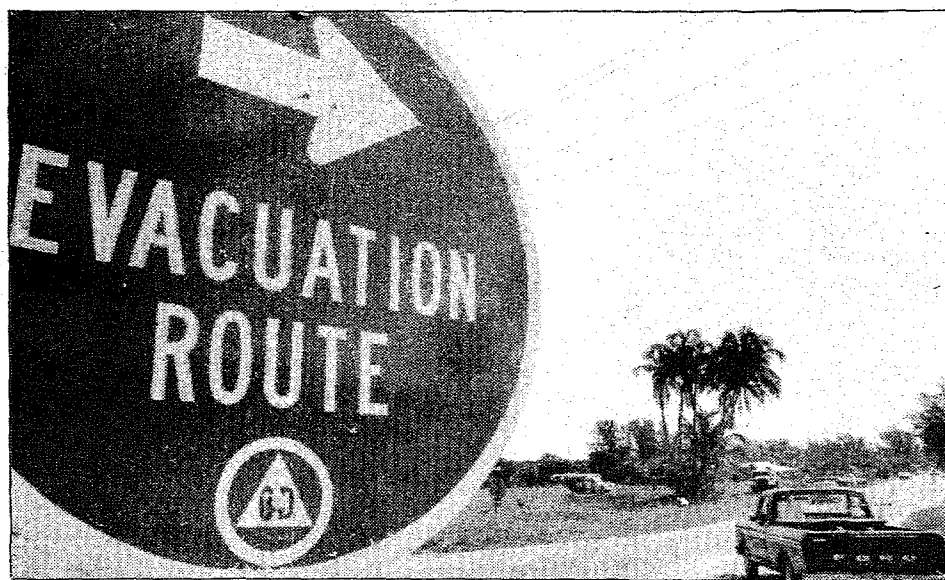

## Library closed in September

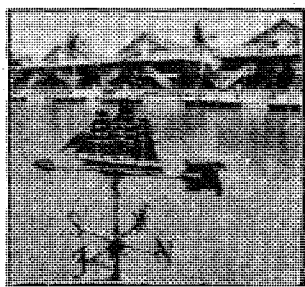

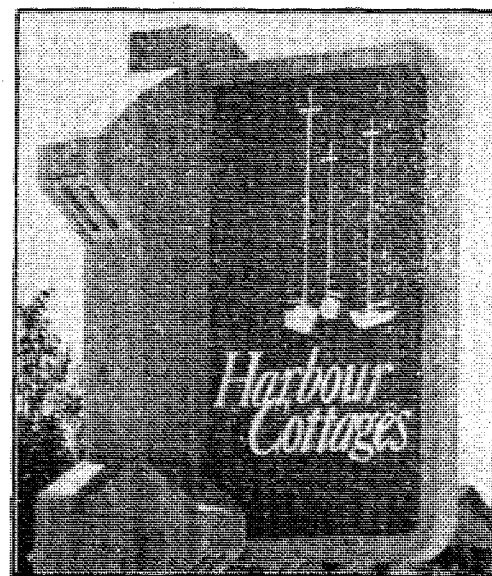
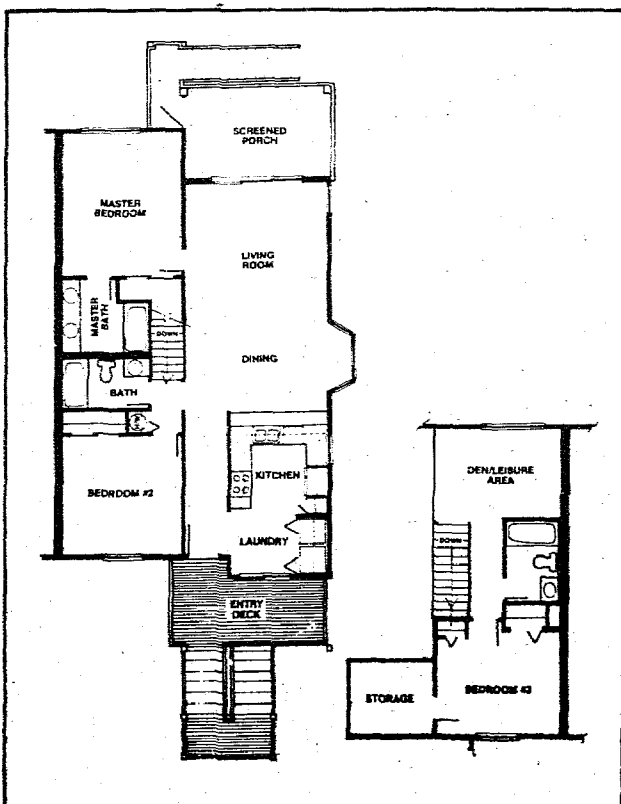

### Chips for children

The Sanibel Elementary School is passing out chips again this year; but they're not potato chips and they're not poker chips.

Instead, the school is continuing with last year's successful "management contingency chips plan" initiated to promote good behavior and discourage misbehavior.

This year's program has been expanded to include mandatory homework assignments aimed at developing a sense of responsibility and good work habits in each student.

"This is something new I'm going to try," explained Mrs. Barbara Ward, the principal of Sanibel Elementary. "I think it will be very good. We'll see."

Parents and students will be receiving a school handbook explaining the rules of the classroom and spelling out school expectations. There will be an opportunity to ask questions if something in the handbook is not fully understood.

"We will all be reading from the same sheet of music," said Mrs. Ward. "It makes for a happier school with less negative talk and less negative action."

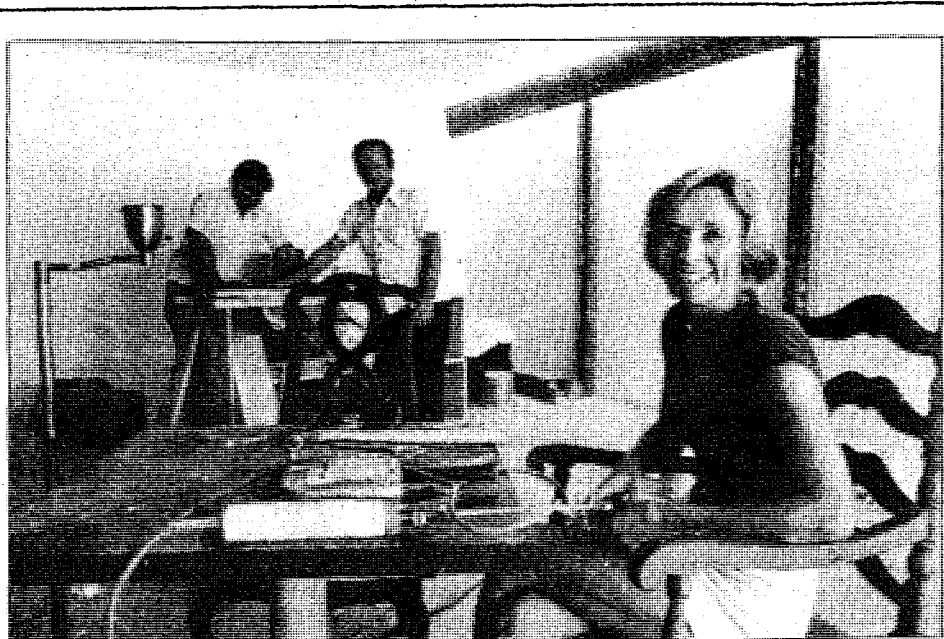
The contingency management plan reportedly worked very well during the 1979-80 school year. When a child misbehaves,

one of the reasons is thought to be for the attention the act achieves. By simply removing a chip (children are given five chips each Monday) from the misbehaving child, no time is wasted on scolding. Therefore, the child gets little or no attention at all. This method leaves the teacher free to direct her attention to the children striving to be good students, thus discouraging improper behavior.

Homework, by the same token, will be assigned each Monday and Wednesday evening in grades two through five. These assignments will be due the next day. If for some reason a student does not have his or her homework completed, a note will be sent home with the child to be signed by the parent and returned with the completed assignment the following day.

If the assignment and note are still not turned in, the school will deal with it by removing chips or keeping the child in detention after school.

Mrs. Ward, the faculty, and parents' main goal is to instill within each child a sense of responsibility. This new plan is just one small step each child must take towards becoming a responsible adult in the community.

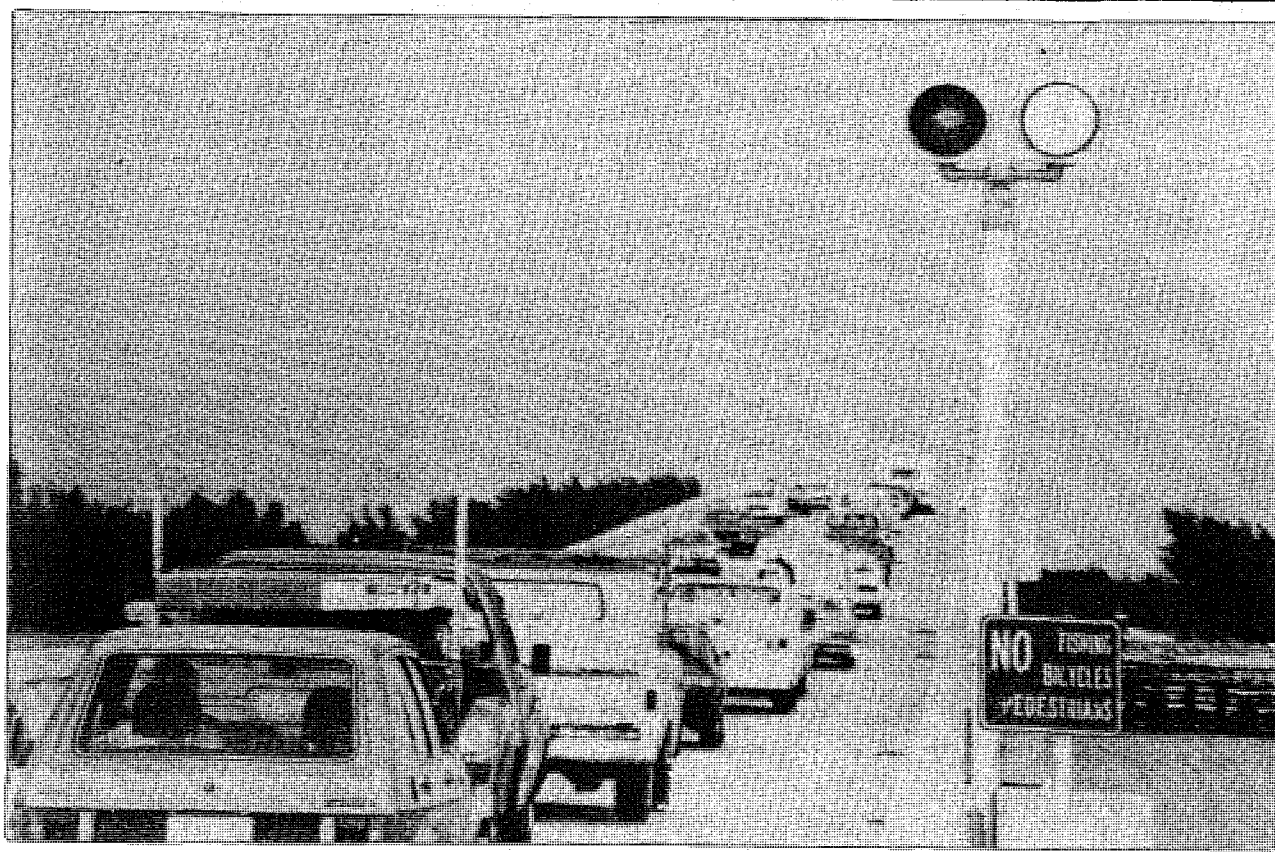

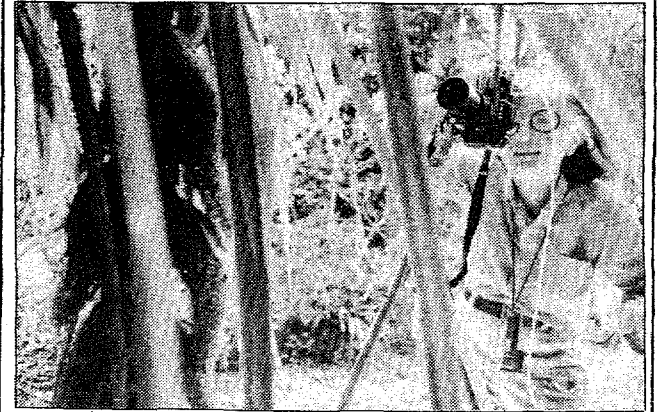

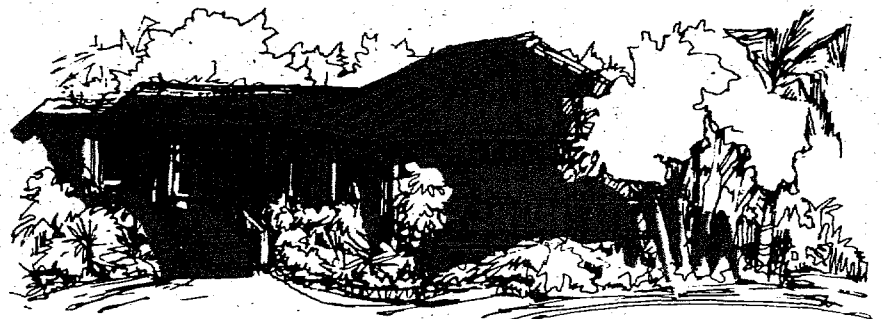

Did you ever wish that the Islands had a zoo? Well, the next best thing just opened up about three weeks ago - and the animals don't even bite.

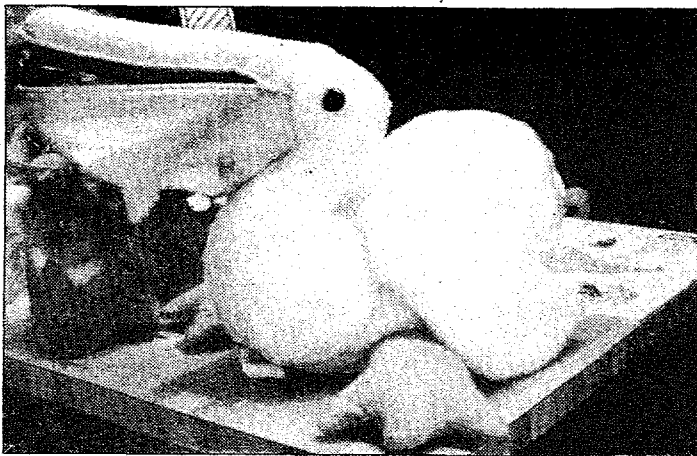

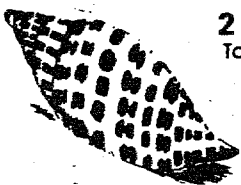

The owners are hoping that good prices and quality merchandise will satisfy the customers - tourists and Islanders alike.

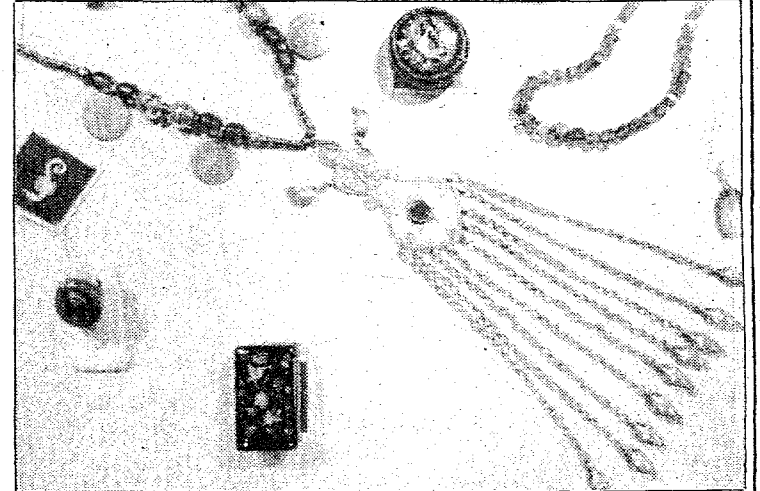
"We've had a good reaction from the Islanders," Danny says, "they admire the merchandise and like the styles and prices."

## Useppa announces final offering of island homesites

The Useppa Inn & Dock Company Ltd., has announced the final offering of private homesites on Useppa Island, a private resort community under historical redevelopment northwest of Fort Myers, Florida.

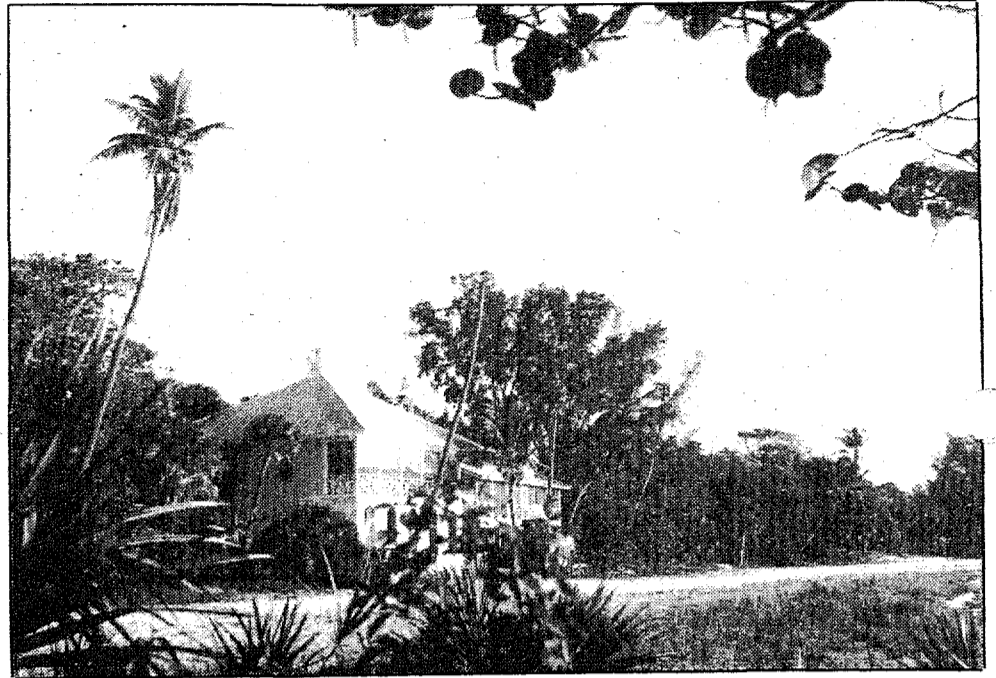

Useppa Island was considered one of America's premier private resorts in the early to mid-1900's. Besides an estate home, Collier constructed cottages and recreational facilities on Useppa for use by his social contemporaries. Useppa developed a reputation as the location of Collier's exclusive tarpon fishing group, the Izaak Walton Club.

An ambitious program of theme restoration was undertaken on Useppa by the Useppa Inn & Dock Company in 1977 toward the goal of re-establishing Useppa as a private resort facility in the spirit of its past. 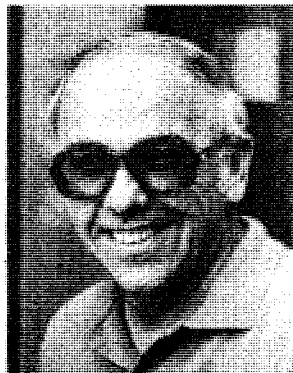

The Mellon Bank previously financed time-sharing development in South Carolina.

Mariner president Allen Ten Broek views the new loan commitments as a reflection of Mariner's market success with time-sharing properties: the company posted \$7.8 million in interval property sales for the first quarter of 1980, representing the purchase of 1100 unit intervals at South Seas and Casa Ybel.

Mariner has been involved in time-sharing property development since 1976. The privately-held company is primarily a development and management concern with over 15 resort, commercial and residential properties, realty, and construction affiliates.

## Tentative millage approved by Council

The Sanibel City Council tentatively approved plans to levy a 3.337 mills tax rate for the 1980 tax year in a special meeting held last Thursday night.

A mill is \$1 tax for every \$1,000 worth of taxable property.

The proposed millage rate is expected to raise \$988,512 in property taxes for the City. Other proposed income includes \$147,800 in building permits and \$98,088 in state shared revenues. The estimated total incoming revenue for 1980 is \$1,768,804.

Although this year's proposed millage is lower than last year's, Sanibel taxpayers may not see a reduction in taxes. Lee County Property Appraiser Harry Schooley has re-evaluated the Lee County property tax rolls to assess property at 100 per cent of market value.

The estimated expenditures for the 1980 tax year include: legislative, \$196,079;

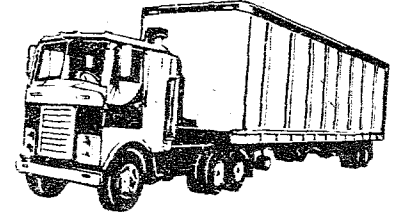

# Police Beat

Snakes and dogs were the recurring items on the Sanibel Police Department blotter this week.

Last Tuesday, a West Gulf Drive resident called the SPD to report a "big black snake" in her bedroom. Officer Lew Phillips responded to the call and found a five foot indigo, a protected species, inside the residence. The snake had an open wound in its abdomen and was turned over to Steve Phillips at the Conservation Foundation for treatment.

Last Wednesday, the SPD received a report that four men were driving around the Island with what the caller believed to be a water moccasin. The men, reportedly driving a late model small black car, could not be located by the police.

Last Friday, Officer Jamie Phillips was called to Buttonwood Lane after a resident reported a rattlesnake in the area. The three-and-a-half-foot eastern diamond back rattler was identified by Steve

Phillips and taken into custody by Jamie.

Two baby loggerhead turtles were discovered at Blind Pass last week and transported by a concerned citizen to the police department for safekeeping. Charles LeBuff, Island loggerhead expert, was contacted.

Last Monday, a Doberman was reported scaring people at the Tarpon Bay beach access and a large husky was reported frightening the tenants at the Blue Heron Cottages on Gulf Drive. Both dogs were gone upon arrival of the SPD.

On Tuesday a small beige and white longhair dog was reported found on Palm Ridge Road and on Wednesday, a dog identified as "Murphey," was reportedly harassing people at the Beachcomber Apartments.

One caller to the SPD requested information on laws against dogs on Sanibel's beaches. When he found there were none he reportedly told the dispat-

cher that he would not be coming to Sanibel to visit ever again.

On August 15, a man walked into the police department with a fist-full of credit cards he had found near the Shell Island Beach Club. Investigation into the incident turned up more credit cards, several wallets and purses in a wooded area now being cleared. The credit cards had never been reported stolen to the SPD and the items looked to be over a year old.

An Island resident received a call from a person claiming to be conducting a survey for Lee Memorial Hospital. The caller soon revealed himself to be a crank and a later check with the hospital revealed no such survey was in progress. Several similar complaints have been filed around the county.

A rod, reel and a rifle valued at \$175 were reported stolen from the Sanibel Ship's Store and a purse containing jewelry and cash worth \$5810 was reported stolen from Ocean's Reach.

A man's bike valued at \$139 was reported stolen from Sundial and a dinner ring and \$60 were reported stolen from the Coquina Beach Condominium.

One of three funnel clouds traveling past Pine Island took a swing past the Dunes, traveling about 2000 feet above the ground, on Aug. 18. The funnel passed over the Island and into the Gulf without causing any property damage.

A large truck registered to Farren Tree Surgeons of Jacksonville overturned on San-Cap Rd. last Wednesday. No injuries were reported.

## More arrests made in theft ring

Three men were arrested last week in connection with what law enforcement officials have labeled a professional theft ring.

On Monday, August 18, charges of burglary of a dwelling with a dangerous weapon and grand theft were brought against William Bryan Caldwell, 39, of Fort Myers. The charges stem from the June 26, robbery of a Naples woman. More than \$12,000 worth of jewels and furs were stolen in the incident.

Caldwell was also arrested last month in connection with the \$250,000 jewel robbery of a Sanibel resident.

Douglas Arlotta, 30, and David Anfinson,

21, both of Fort Myers, were also charged last week in connection with the Naples robbery.

Caldwell and Arlotta were implicated in the Collier County robbery when police officers investigating the Sanibel robbery discovered furs from the Naples robbery in a Sanibel condominium.

Det. Johnson of the Collier County Sheriff's Dept. said investigation is continuing into a multi-county theft ring and other arrests are expected to be forthcoming. Last week's arrests stem from a two-month investigation by the Collier and Lee County Sheriff's departments and the Sanibel Police.

**To the Editor, The Islander:**

Of all the obscurantist drivel dished up weekly in these columns by Sanibel's self-appointed curmudgeon-watchdog, his latest lament-laden logorrhea concerning congregate living provides a clear perception of the forensic fatuousness, personal pique, and sheer paddywhackery such sofa sophists and power-manipulating poseurs so often seek to foist on a community.

Surely the time has come for the blustering Brahmin of the dinosaur wing of Sanibel's shadow council to belay his blubbering and pack up his bag of anachronistic, reactionary bafflebagg once and for all.

Fortunately, his latest flapdoodle is

being quickly flushed away, thanks to its forthright rejection by Ann Winterbotham and her colleagues on the City Planning Commission, along with the appropriate outcry from the Island's young people.

As one articulate voice in the latter group noted, the so-called bedroom ordinance seems to contain a strain of economic, class, racial or religious prejudice.

In bestowing well-deserved benisons, laurels, and kudos upon Ms. Winterbotham, one must concur with her comment that there are other and better means for protecting the community's peace and quiet that have nothing to do with the numbers of unrelated persons who share a common residence.

Moreover, the enforced homogeneity in the life styles of Sanibel's residents proposed in the bedroom ordinance is but one of the pernicious consequences projected, given the puritanical bans which might be expected, such as the sort of censorship some communities have considered and are enforcing against art expression for instance.

Then, can we anticipate that the would-be protectors of our morals will next press for an ordinance to get rid of all sorts of people - religious, ethnic, economically-deprived, disabled - who do not happen to share their rigid and narrow views?

If indeed the City Council finds it must devote its time to a discussion of the bedroom ordinance, one hopes its mem-

bers will bear in mind these passages from "On Liberty," by the British philosopher-economist John Stuart Mill:

"(F)rom this liberty of each individual follows the liberty, within the same limits, of combination among individuals: freedom to unite, for any purpose not harmful to others...As it is useful that while mankind is imperfect there should be different opinions, so it is that there should be different experiments in living."

# For Your Information

**BEACH ACCESS**  
Sanibel has miles of public Gulf-front beaches, any one of which is only minutes from your lodging. Lighthouse Point is a stretch of Federal land on the Eastern tip of Sanibel Island, and from there, the Gulf beach is accessible again at the end of Donax Street, at Tarpon Bay Road, at Bowman's Beach Road (off Sanibel-Captiva Road) and Turner's Beach, which is located at Blind Pass, between Sanibel and Captiva Islands.  
On Captiva Island, public beach access can be found at Turner Beach (which has public facilities) or further north, just past the entrance to South Seas Plantation.

**NOTE: STATE LAW PROHIBITS NUDE SUNBATHING ON ALL FLORIDA BEACHES. VIOLATORS WILL BE PROSECUTED.**



**CAMPING**  
Camping on the beach is prohibited and while everyone enjoys a beach fire, the Sanibel Fire Board has signed into law an ordinance prohibiting open beach fires. Prior to the ordinance, a permit was necessary for a beach bonfire, but as of July 18, 1980, it is now illegal. An exemption to the ordinance is a fire in an approved cooking container (not to exceed 48" X 24" X 12" deep with an extruded metal grill) for non-commercial food preparation. This type of container will be allowed on the beach without a permit. After you have had your beach party, it is recommended that you assume the responsibility for the cleanup of any debris or litter in your area.

he's close enough to feed on you. An alligator fed for fun loses his natural fear of humans and becomes a potential threat to children and pets.

**FISHING**  
While no license is required for saltwater fishing, fishing in freshwater ponds or the Sanibel River requires a Florida fishing license - available at Bailey's General Store on Periwinkle Way. The fee is \$3.75.

**SHELLING**  
The City of Sanibel Resolution limiting the taking of live shells to 2 live shells per person per species is one to be scrupulously obeyed. As a matter of fact, in order to preserve Sanibel's beautiful shelling beaches, most collectors refuse to take any live shells whatsoever.

**SPEED LIMITS**  
There are varying speed limits (20-30 m.p.h.) as one comes across the causeway, and there is a very good reason for them...to preserve the bridge supports from strain and stress. This speed limit is strictly enforced with the use of radar on a 24-hour basis by both the Sanibel Police Department and the Lee County Sheriff's Department.  
Driving or parking a motor vehicle or moped on the bike path is strictly prohibited. Violators will be ticketed.

**BICYCLE RULES**  
If you're not used to a lot of bicycle traffic, watch out for it on Sanibel. The extensive network of bike paths on the island is clearly marked along the edge of the road. Observe caution when driving near the bike path. A State law and City Ordinance combine to PROHIBIT PARKING OR DRIVING ON THE BIKE PATH. MOPEDS ARE NOT PERMITTED ON THE BIKE PATHS.  
Planning on spending some time on a bike to enjoy the island sun and sights? Make sure your vehicle is equipped with a bike flag, horn, good brakes and a light for night riding. Under Florida law, bicycle riders have the same rights and responsibilities as motor vehicle drivers.  
Drive Safely!

**DOGGY DO'S & DON'TS**  
If you're visiting Sanibel with the family Fido in tow, all the better. All family members can enjoy Southwest Florida sun and surf. The Chamber of Commerce can tell you what accommodations are available for families with pets. Remember: wherever you are, clean up after your pet! The friendly reminder... "Leave nothing on the beach but footprints"...applies to dogs, too. There's no leash law on Sanibel, but of course an excitable or unruly animal is better off when controlled with a leash.
