Police chief, CONA members talk Island crime

Sanibel's recent rash of home burglaries could be curbed by residents' participation in the Neighborhood Watch program and by the addition of two sworn officers to the city's Police Department, Police Chief John Butler said last week.

Butler made his remarks as the guest speaker at the monthly meeting of the Committee of Neighborhood Associations.

The police chief said he thought the recent burglaries did not constitute a dramatic increase in Island crime, but CONA members expressed unanimous concern that the problem is escalating and must be addressed immediately.

"Islanders are incensed," CONA President Urban Palmer said at the meeting. "This to me is a dangerous situation. People are getting panicky," he added.

One break-in in the Lake Murex neighborhood "destroyed the whole psychology of the neighborhood," one CONA member said.

The 13 CONA members at the meeting agreed that Butler's request for a budget increase to accommodate two new police officers should receive the enthusiastic support of all Island residents.

"You have to give me the means to make stricter neighborhood patrols possible," Butler said, in defense of an increased

Residents, off-Islanders line up for city parking permits

A line of cars moved slowly from Tarpon Bay Road to the entrance of Bailey's General Store all day Friday as Sanibel beach lovers paid up to \$15 for permits to park at designated areas along the Gulf and bay.

When the permits, which will be required after July 1 in residential and restricted parking zones, went on sale at 8:30 a.m., the first customers were already waiting in line.

Police Department personnel checked proofs of residency needed to buy residential parking permits for \$1. The permit will allow Islanders to use either the residential or restricted parking areas. Also for \$1, non-resident property owners can buy restricted parking permits.

Members of the public paid \$15 for permits for use in the restricted zones only. The permits expire Nov. 30. The annual fee for restricted parking is \$30.

Among the early birds Friday were several Fort Myers residents who said they visit Sanibel beaches regularly. They said the \$15 fee was worth it.

Islander Mary Ann Minarcin, who lives at Sanibel Arms, has easy access to the Gulf beach, but said she wanted a permit to go shelling on other parts of the beach.

Joseph Slovada, who moved to a home in Lake Murex from Freeport, N.Y. May 1, was on hand early to get his resident parking decal to insure his return to the Island after an emergency evacuation.

"I can walk to the beach from where I live," Slovada said.

The parking permits were on sale all weekend at Bailey's and will be sold there again June 19, 20 and 21 from 8:30 a.m. to

4:30 p.m.

The permits can also be obtained anytime at the police station on Palm Ridge Road. Applicants must bring their vehicle with them so police personnel can affix the decal on the lower right side of the windshield.

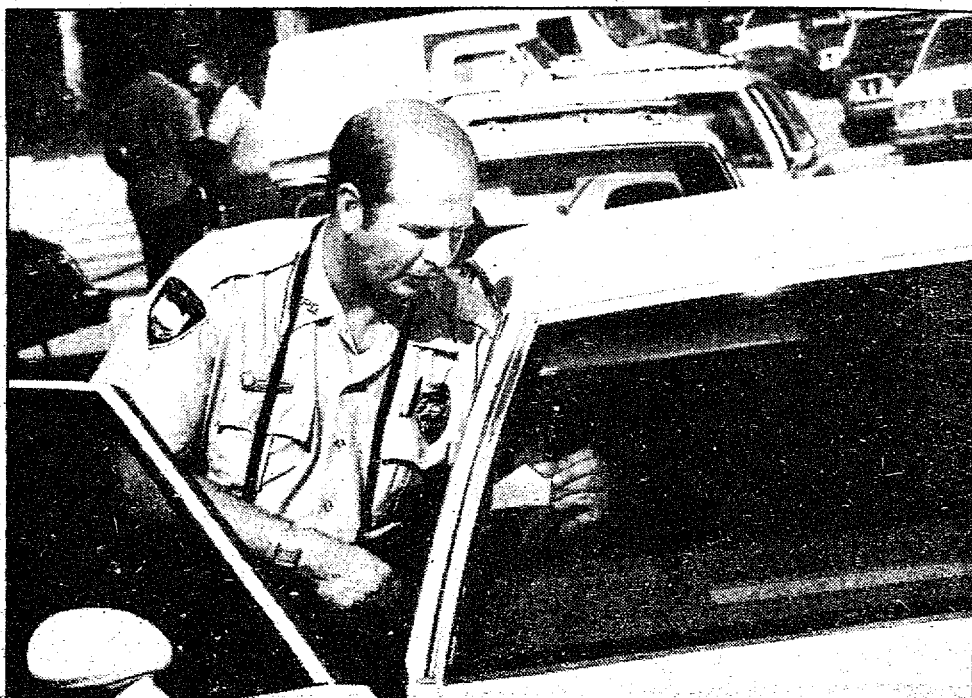
The restricted beach parking is part of a parking strategy devised for the entire Island and is implemented in an ordinance that will become effective July 1. The ordinance was adopted last February by the City Council.

The ordinance bans parking in all public areas and rights-of-way other than those designated by the city manager.

Violations of the restricted parking regulations are punishable by a \$50 fine. The fine will be reduced to \$35 if paid within 12 hours, a police spokesman said.

Parking permits are not required for bicycles or mopeds, but these vehicles must

use the racks provided at the beach access lots.

Vehicles more than 20 feet in length, including buses, are banned from parking in the specially designated areas.

However, 370 spaces of unrestricted parking at no charge are available at the Sanibel Lighthouse and fishing pier, the Trost lot on Tarpon Bay Road north of West Gulf Drive, and Bowman's Beach. No permit is needed to park at any of the three locations.

Parking in both residential and restricted parking zones is confined to the hours between 6 a.m. and 9 p.m. during Daylight Savings Time and between 7 a.m. and 8 p.m. during Eastern Standard Time.

All locations with the exception of Henderson and Lost Colony at the western end of the Island will be open July 1. Assistant City Manager Gary Price said.

Residents, businesses left in the dark

Three Lee County Electric Cooperative crews were on Sanibel Monday morning inspecting the Gulf circuit feeder line searching for the "mysterious" problem that caused two power outages over the weekend.

More than 1,300 households along the Island's Gulf shore from Blind Pass to the Lighthouse area were without electricity between 9 p.m. and midnight Saturday and again for more than two hours in the same time period on Sunday night.

Diane Christensen, the co-op's vice president for public relations and communications, said at press time, "The reason for the power failure is still not known, but we are doing everything in our power to isolate the cause."

Christensen said emergency personnel would be on duty Monday night at the substation on the San-Cap Road and at strategic points along the entire circuit hoping to find the problem that is causing the blackout.

"We are satisfied that the demand on this circuit is not exceeding its capacity at this time," she said. The Gulf feeder line was overloaded by 27 percent last summer, co-op officials have said.

The fact that the outages on both Saturday and Sunday nights occurred at approximately the same time has baffled the Co-op's engineers.

"We have even been accused by some Sanibel residents of doing it on purpose," Christensen said. "But that is absolutely untrue."

The four residential subdivisions that objected to the co-op's proposed plan to construct a third feederline on the island

through their neighborhoods were among the areas affected by the weekend power failure, Christensen said.

Two of Sanibel's larger resort complexes - Sundial Beach Hotel and the Ramada Inn - were victims of the outage.

Both hotels were filled to capacity Saturday night; their management said.

Sundial manager Paul Gaeta said he had to deal with irate customers all weekend. "We had eight or 10 checkouts Sunday morning," he said. "The whole thing cost us about two thousand bucks."

The Sun Dial restaurants were able to function using lighting powered by battery packs and candles, Gaeta said.

Glenda Sharp, assistant manager of the Ramada Inn, said four or five disgruntled guests checked out Sunday because "there was no television in the rooms, but they were appeased by refunds."

She said only two people were not served at the Ramada restaurant because the lights were out. Other diners settled for the salad bar, she said.

At the Timbers Restaurant at Rabbit Road and San-Cap Road, customers ate cold salads and drank "on the house" when the power failure closed the kitchen.

Christensen acknowledged Monday that the co-op is still "a little mystified" but said she couldn't speculate on the cause.

"Though it is an overhead problem, it is not the same type of defect that caused a line on West Gulf Drive to fall down a month or two ago. There are no lines down," she said.

She said she was personally answering all complaints from Sanibel customers. "And we have had quite a few calls," she added.

Commercial study gets mixed reviews from city officials

The results of a study outlining future commercial needs on the Island received mixed reviews from city officials last week.

Scott MacDonald, the economic consultant of Barton-Aschman Associates hired by the city to conduct the commercial study, presented the survey results to the City Council and to the Planning Commission.

In identical presentations to the council and the commission, MacDonald unveiled the preliminary findings from resident, visitor and shopper surveys to estimate the demand for different types of commercial development on Sanibel.

Planning Commissioner Bill Hagerup hailed the results of report.

"It provides a whale of a lot of information. Some of it raised my eyebrows," he said.

Commissioner Joe Searing's opinion that "this report only confirms what (Associate City Planner) Bob Duane told us more than a year ago," was echoed by Acting Mayor Mike Klein two days later.

In his study of the city's future commercial needs last year, Duane found an overwhelming amount of property zoned commercial. He conducted the study at the

request of the council.

There is approximately 500,000 square feet of commercial property in the city not yet developed, Duane discovered.

Currently, 230,000 square feet of space is occupied by retail businesses, MacDonald estimates.

Based on the retail demand reflected in the surveys, MacDonald said the projected supportable net space in 1985 for food stores is 13,945 square feet. Conversely, apparel businesses and eating establishments are already overbuilt, he said.

To arrive at these results, MacDonald

said, he used the Urban Land Institute's productivity factor based on median sales per square foot for stores in community shopping centers throughout the United States.

Commissioner Larry Simon and Councilman Francis Bailey called his use of nationwide figures unfair.

Simon asked if the data recognized variables.

"Sanibel stores are packed for four months of the year only, and then business

Planning Commission rules Gulf Beach chickie hut must go

Claims of Attorney Richard Brodeur that a chickie hut on Gulf Beach in front of the Janthina condominium is an "attractive and nostalgic reminder of Sanibel's past" and should be preserved were refuted last week by the Planning Commission.

The chickie, located 160 feet seaward of the Coastal Construction Setback Line, is in violation of the Comprehensive Land Use Plan stipulation that only elevated beach accessways can be located in the Gulf Beach ecological zone, the commissioners agreed.

At a hearing last week they unanimously denied John Armenia's request for a specific amendment to permit the chickie to remain as a recreational area for the Janthina condominium owners.

Commission Chairman Ann Winterbotham took exception to Brodeur's suggestion that the chickie should be preserved in memory of its original owner, Miss Willie Glass, "a long-time Sanibel resident."

"Willie Glass didn't live here very long -- no longer than I have," Winterbotham said. "I remember when the hut was rebuilt about 1968. It has no nostalgic value."

But Armenia said it was his understanding the hut had been built "right after World

War II," and that it had been an Island landmark for many years.

"It is not a hazard, has not caused any erosion on the beach, and it is compatible with the surroundings," Armenia argued.

There are two similar structures on the beach on either side of the Janthina chickie, he added.

But Commissioner Bill Hagerup called the 144-square-foot cement slab on which the chickie sits as "dangerous as a missile in a storm."

Commissioner Louise Johnson acknowledged the compatibility of the chickie, but added that it "is a non-conforming structure, and this gives us an opportunity to remove it for valid reasons."

Code Inspector Dick Baker refused last November to issue a certificate of occupancy for the six-unit Janthina condominium complex. Until the chickie hut is removed, he said, the project is in violation of its approved development permit.

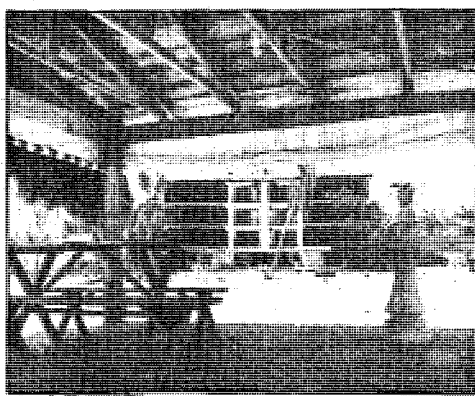
Because all improvements were to be cleared from the West Gulf beachfront property, including relocation of the Glass homestead, to make way for construction of the condominium, a tennis court, pool and dune walkover, the development was not

subject to CLUP, Baker said. The chickie, forward of the CCSL, was not shown on the project site plan, he said.

It was left off inadvertently, Armenia explained.

Hagerup said that if the chickie had been shown on the original plan presented to the Planning Commission he would have voted to remove it because it is not in accord with the city charter.

His motion recommending the City Council deny the specific amendment was passed by a 6-0 vote of the commission. Commissioner Don Manchester was absent.

Grocery store plans back to drawing board

A grocery convenience store in the Sea Horse Shopping complex at the eastern end of the Island would fill an acknowledged need, the Planning Commission agreed last week.

But David Arnold's plan to add the shop failed to solve the parking problems the commissioners said would be created.

Arnold's request for a specific amendment and relief from the commercial moratorium was continued until Arnold can revise his plans.

Mimi Palmer, a designer draftsman hired by Arnold, said the plan for parking was submitted by Joe Gault, the former owner, several years ago and was approved by the Planning Department.

It would provide the 25 additional parking spaces required to comply with CLUP. Seven of the spaces would be behind the store in an area now used as a water retention basin.

Arnold said the furniture shop at the complex was being phased out to make room for the convenience store.

But the Commission objected the proposed location in the complex of the high level of traffic that would be generated by the convenience store.

Commission Chairman Ann Win-

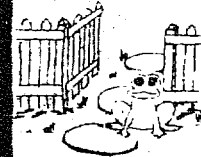

Development permits approved for four more Lakeside Villas

Mariner Properties, Inc. was granted development permits for the construction of four duplexes under the zero lot line concept by the Planning Commission last week.

Ten duplexes have already been built in Mariner's Phase II Lakeside Villas and sold to individual owners under the concept that clusters homes with the nearby open space in joint ownership.

The commission also approved replatting of two lots in the Dunes Phase II development with the condition that a reciprocal easement of at least four feet for maintenance purposes be provided for the ad-

joining lots.

The commission also granted James Evans' request for a development permit to construct two duplexes on two lots in the Sanibel Hamlet subdivision on the west side of Rabbit Road.

The hearing was continued from May 11 so Evans could explore the feasibility of developing the property under the zero lot line concept.

But Evans chose to follow the conventional mode and will compete with other applicants for multi-family units in the July 13th Rate of Growth allocations.

Grocery continued

terbotham suggested that putting the new store in the middle of the complex with the entrance in the rear would encourage use of the new parking area behind the complex.

Commissioner Larry Simon, who lives in Shell Harbor, said a grocery store at the east end of the Island would undoubtedly reduce traffic along Periwinkle Way.

But the traffic flow on Arnold's parking plan is "backwards," Simon said.

The planning staff reported that Arnold's proposal as submitted does not comply with four land development regulations. The staff also reported, however, that there is a need for a grocery store east of Lindgren Boulevard. With revisions, the Sea Horse could be a suitable location, the staff added.

With a denial of his request obvious, Arnold opted to go back to the drawing board with his plans.

"I'd rather get it right the first time," he told the commissioners.

CLUP review public hearing set for June 22

The Planning Commission's discussion of four elements of the Comprehensive Land Use Plan was cancelled last week because Commissioner Don Manchester, assigned to work on the revision, was not present at the regular meeting.

The next public hearing in the CLUP five-year review is set for the afternoon session of the June 22 commission meeting.

The hearings will be continued at a special meeting Monday, June 29 for interested residents.

Commercial moratorium ordinance scheduled for first reading

An ordinance calling for a commercial moratorium until the city's current commercial study is completed will be aired at a public hearing and first reading by the City Council at 5:01 p.m. today.

The ordinance was started on its way the second time around on February 27 following the general amendment route.

It is identical to one overturned by Circuit Court Judge Wallace Pack's ruling in a suit filed against the city by businessman Robert Buntrock.

In the suit Buntrock charged the city did not have the authority to enact a moratorium, that it was unreasonable at the time, and that making it retroactive was illegal.

In declaring the moratorium invalid, Pack cited the procedure the city used in enacting the moratorium but did not address the merits of the case.

Pack labeled the freeze on commercial development a "zoning change," and said, therefore, it should have been adopted as a general amendment to the Comprehensive Land Use Plan, a process that requires months.

Pack ordered the city on March 9 to post a

\$300,000 bond within 14 days to reimburse Buntrock for any perceived damages from the delay or "process development and building permits to allow Buntrock to begin construction of a new headquarters for his business on Periwinkle Way."

The council's denial to grant Buntrock relief from the moratorium last December lead to the lawsuit.

On April 7, at the advice of City Attorney Neal Bowen, the council refused to post the bond and lifted the freeze on all development and building permits applied for between Sept. 16, 1980, when the commercial moratorium went into effect, and Feb. 27, the date the new moratorium ordinance was initiated.

Buntrock was told he could proceed with his construction at his own risk pending the outcome of the city's appeal of Pack's ruling to the Second District Court of Appeals.

Scheduled at 5:25 p.m. today is a public hearing and first reading of a general amendment ordinance that provides that rental units larger than 600 square feet and rented for periods of less than one month will be units of high impact.

Nutmeg Village parking lot okayed

The Planning Commission last week approved paving of a 540-square-foot parking lot for guests at the Nutmeg Village Condominium.

The lot will provide three additional parking spaces the complex needs to comply with standards of the Comprehensive Land Use Plan, the planning staff said.

This will increase the impermeable coverage on the site to 37 percent. CLUP guidelines permit only 20 percent coverage.

But because the proposed paved area is

less than one half of 1 percent of the site, the planning staff recommended granting the specific amendment requested by the Nutmeg Village Condominium Association.

Commissioner Arthur Wycoff said it appeared to be a "trade off of non-conformities."

Commissioner Larry Simon, pointing out there would be "little impact on the permeability and no precedent set," made the motion to approve.

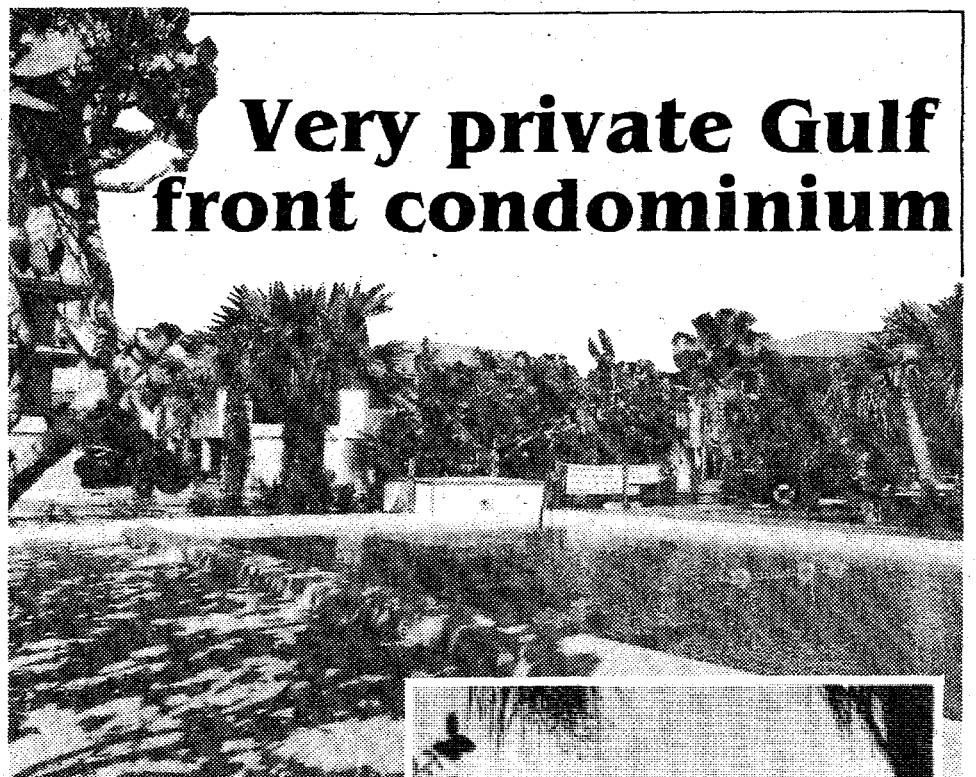

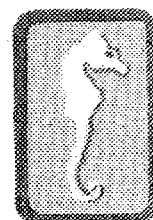
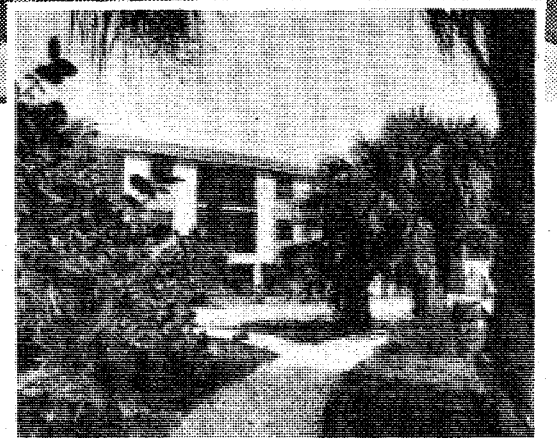

Baby alligators found strangled at construction site

The strangled bodies of two baby alligators were found at a Rabbit Road construction site on Friday, June 5.

Ding Darling Wildlife Refuge Manager Del Pierce said the 12- and 16-inch gators had been dead for approximately three days. They were strangled with twine that was found near the bodies at the construction site just south of 615 Rabbit Road.

Pierce said.

Residents of the area had reported seeing an adult alligator with five babies during recent weeks.

Sanibel Police were alerted to the incident by Jeff McLendon of 615 Rabbit Road. According to police reports, McLendon said his mother had witnessed construction workers kill three young alligators by "tying

ropes around their necks and slinging them around in the air" until they died of strangulation.

Pierce said a thorough search of the area turned up only the two young gators. Neither McLendon nor his mother could be reached for comment.

Pierce said the gators' bodies were taken to the refuge office and placed in a freezer

pending further investigation.

Killing an alligator is a felony offense and is punishable by a fine of up to \$500, 60 days in jail or both.

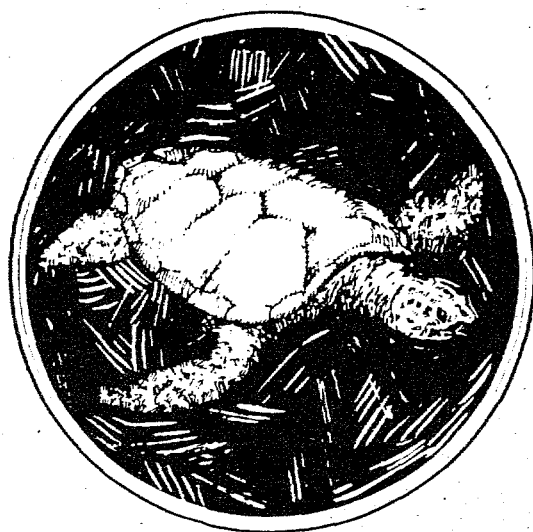

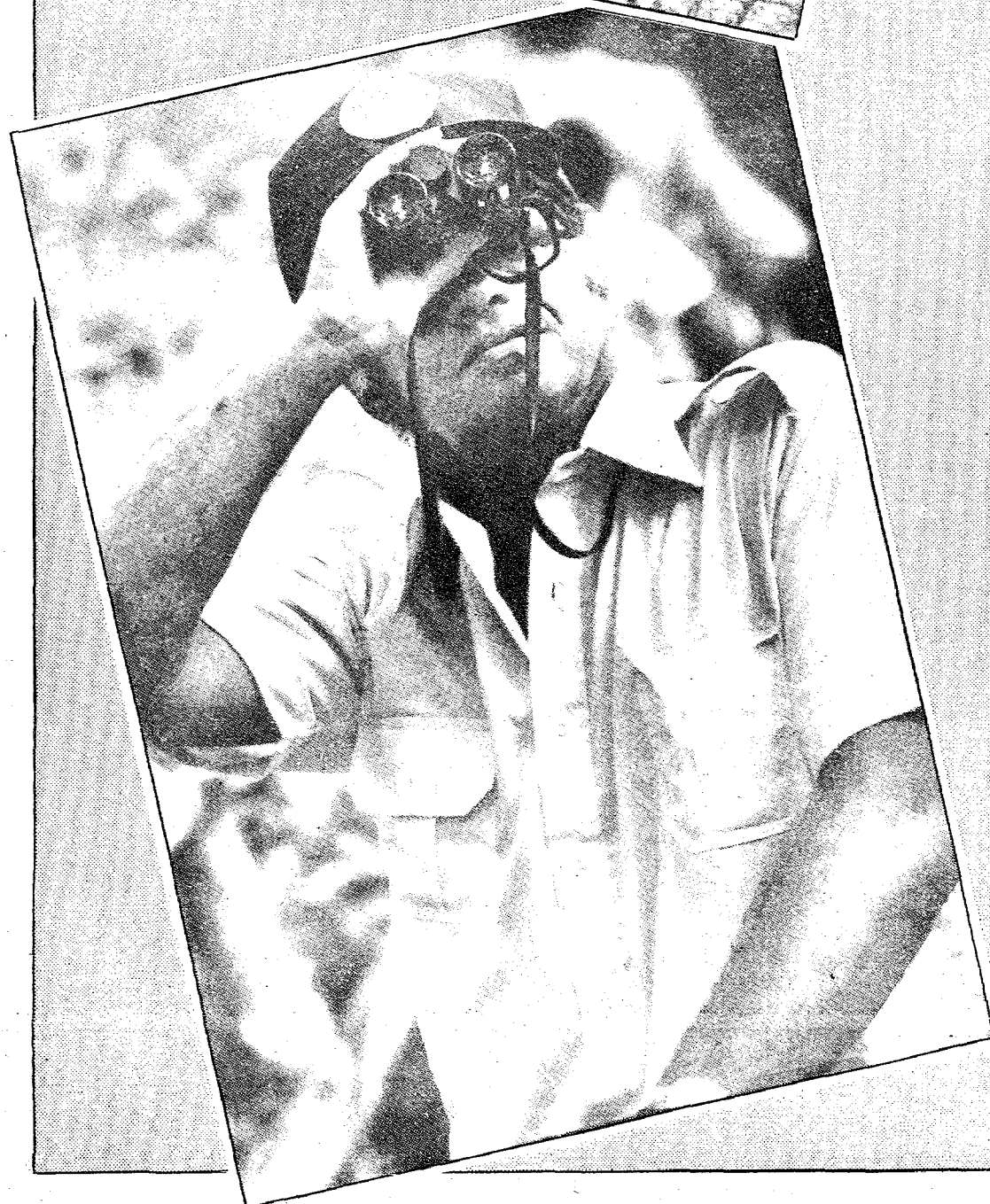

Wood Stork Generation

It has been described as "a million miles from Miami." 11,000 acres of wilderness containing the largest strand of virgin Cypress in the country, and one of the few protected nesting spots for wood storks in the state.

At the Corkscrew Swamp Sanctuary near Naples, a most spectacular birding experience - the nesting of the woodstork - is coming to a close.

Down to one tree from three treeloads and approximately 90 easily accessible nests at the end of the boardwalk, the sights and sounds are diminished from their peak weeks ago. But there is still time to view the nesting of this country's only stork.

At the height of the nesting season the tops of the 700-year-old bald cypress trees serve as an Atlanta Airport for the woodstorks. Nesting storks at the sanctuary busy themselves soaring in and out to provide the 400 pounds of food each fledgling stork needs.

The noise level at the nesting site is as high as an airport, too. But it is not the whine of turbines that fills the air -- it is the sqwaking of fledgling storks calling out to their parents.

The nestlings call out to their parents as they soar back on a thermal air current from Lake Okeechobee with their bellies full of fish that they regurgitate on the side of the nest.

The mute adults, who lost their vocal chords when they matured, can't call back to their young as they land, extending their 66-inch wings and lowering their legs, "putting on their airbrakes," describes local bird guide George Weymouth.

Dry weather is needed before the woodstorks begin nesting. As water recedes, fish are concentrated in the remaining ponds and ditches, which become, in Weymouth's words, "living soup - fish on top of fish."

But the recent drought has been hard on the storks, making them fly even farther than their normal 35-mile range looking for food.

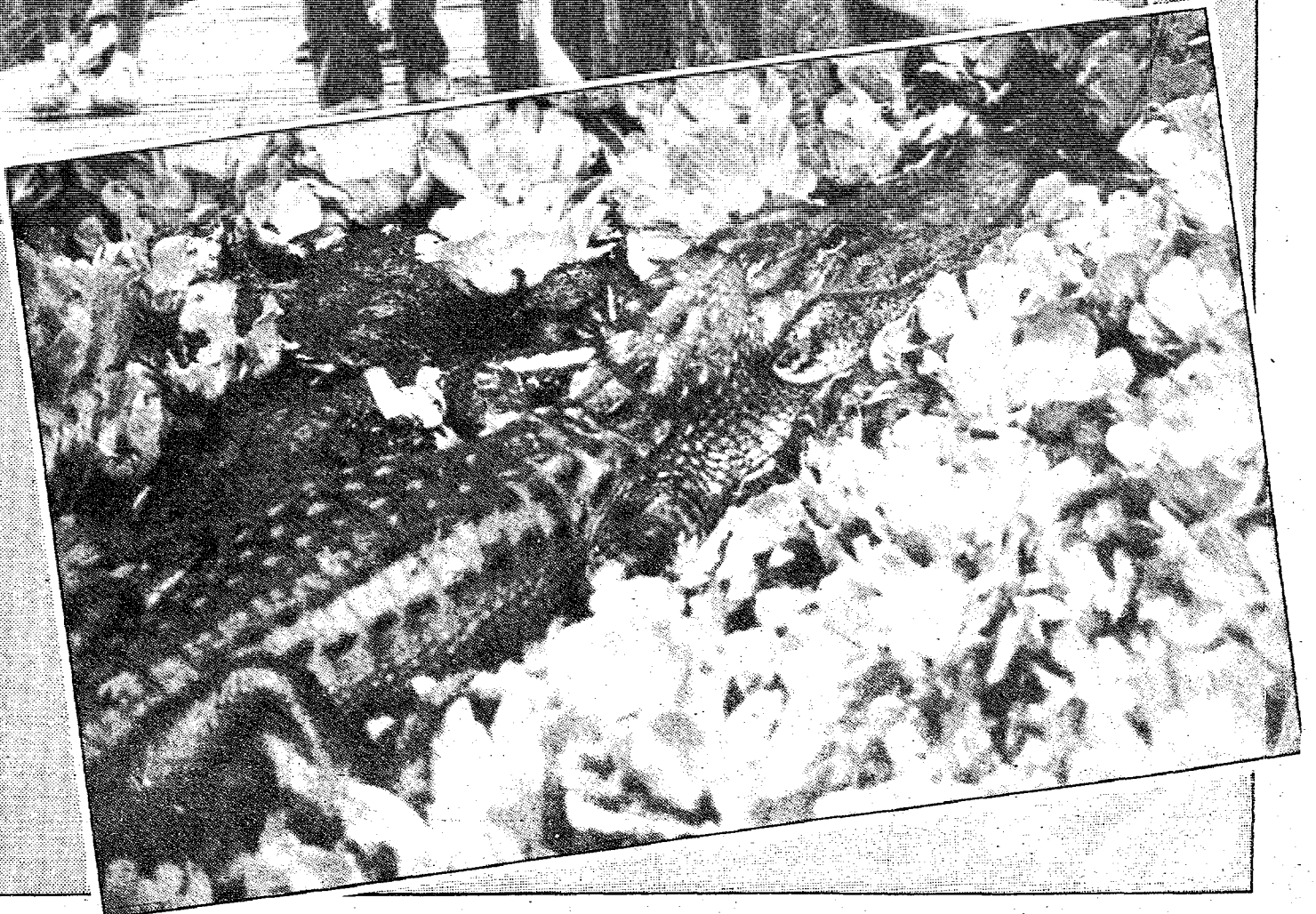
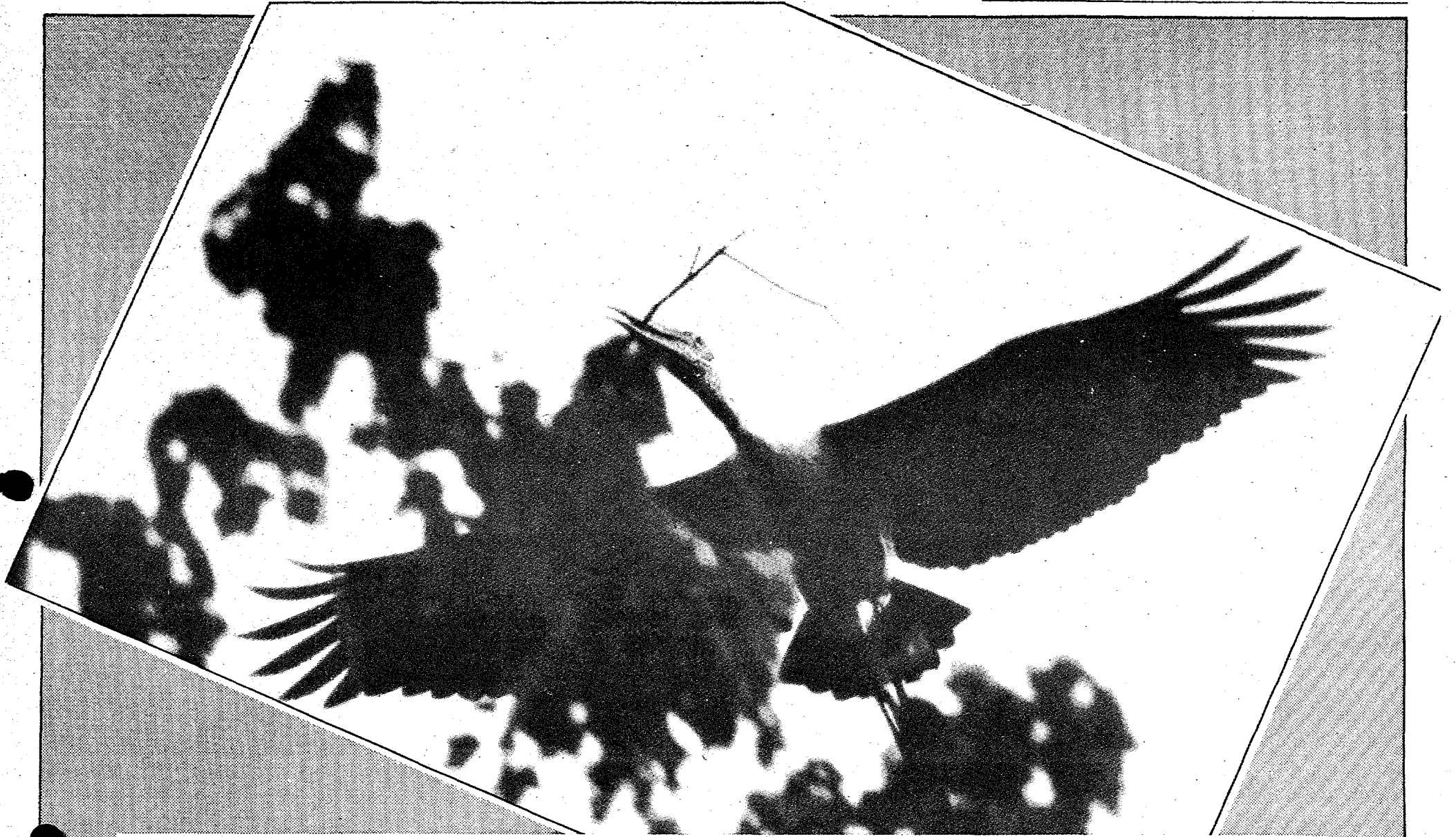
The other wildlife attraction at the bug-free swamp is in the lettuce lakes, "where the action is," Weymouth says, near the end of the boardwalk.

As one of the few wet spots in the swamp, the lakes attract birds, alligators and soft-shell turtles.

It is fascinating to watch the alligators play a hide and seek game with egrets, herons and the rare purple gallinule and limpkin.

The gator, looking for a meal, swims under the floating lettuce plants toward the birds but is almost always discovered before getting too close. The bird flies a short distance away, and the game starts over.

Corkscrew Swamp Sanctuary can be reached by travelling U.S. 41 south toward Naples to County Road 846. Turn left on 846, which also serves as a U.S. 41 bypass around Naples, and look for the small signs leading to the sanctuary.

On the water

If you have ever wanted to try your hand at shark fishing, now is as good a time as any to get at it, because there are some large ones being taken on everything from big game outfits to trout rods.

Shark fishing has never been very popular, per se, as a style of fishing around Sanibel and Captiva Islands.

I wondered about this, because in many parts of the state, shark fishing is very popular. Up north of us, in Venice, there are two very active shark fishing clubs that roam all over their area of the Gulf of Mexico looking for sharks during contests.

I talked with a few people who are distant relatives of ours who fish out of Destin, Fla., way up in the northwest part of the state, and they too do a lot of big game shark fishing.

I often thought that we never did a large amount of shark fishing because there were too many "eating" fish around. That is, our local or visiting fishermen like to catch something they can eat, like snook or sea trout.

Well, other parts of Florida have their eating fish, too, but they mix that fishing in with shark fishing, and I wondered why we didn't.

If the snook continue to be hard to catch and the proposed

dredging of Redfish Pass takes place on schedule in early July, then we might start looking to shark fishing as an alternative.

Now, I'm certainly no expert in shark fishing, but I'll relate what little I know about shark fishing, and added with perhaps some of your knowledge, we can get into place where the action is good.

First, sharks are tough fighters with rough skin, so you might as well use wire leader rather than mono. Something in the 75- to 100-pound class wire will do the job in most cases. You also need heavy duty hooks, preferably forged.

For line, you can't do much with less than 30-pound test. Doesn't seem to matter if you like braided or mono line on the reel, just make sure it is new, free of nicks and heavy enough to get a shark back to the boat.

Boat rods of six to eight feet and large capacity reels, either spinning or revolving type reels, are best.

You will need a couple of good stout boat gaffs and a club for calming down the shark if you are going to take it back home for eating or mounting.

Sharks are all along the gulf and sometimes found on the Pine Island Sound waters, too.

Most shark fishermen get out early in the morning and either anchor or drift slowly a couple of miles out in the Gulf. There is no "shark hole" that I know of; they are roamers and don't stay put at any one spot for long. That's why drifting works well.

Use a bait that has a high blood content, like one of the jack or bonito family. Ladyfish, catfish and mullet also work well.

If you are a swimmer and reading all this about sharks being along the shore, don't worry. We've had very few shark incidents in recorded history in our area, and to my knowledge, no one has ever been killed by a shark. They are deep water feeders, so forget about them and enjoy your swimming.

For you potential shark fishermen, I would suggest handling them carefully. Lots of fishermen hang them on the side of the boat, out of water, until they are dead. These are dangerous fish, and always use caution around them when they are hooked.

You might call a couple of restaurants and see if they would like to buy your catch. Good fishing, and we'll talk more about shark fishing in a few weeks.

Conversion table: The above tides are for the lighthouse point of Sanibel only. To convert for Redfish Pass (North tip of Captiva), add 55 minutes to the time shown for every high tide. Subtract two minutes for every low tide.
For Captiva Island Gulf side, subtract 30 minutes for each high tide, and subtract hour and 16 minutes for each low tide.
For Captiva Island, Pine Island Sound (Bay) side, add 1 hour and four minutes for each high tide and add 52 minutes for each low tide.

Shelling Tips

Recently I had the chance to talk with a family of shellers from Texas, and they had some interesting things to say about following their hobby on the other side of the Gulf of Mexico.

The Gulf is such a vast body of water, but basically around its edges, the same conditions exist.

Some of those shared things include warm waters, shallow waters and a slow sloping decline which allows shells to be gently moved up to the shoreline.

There were some fascinating observations, however, from this group of knowledgeable shellers working beaches in Florida and Texas.

First, we discussed the sand dollar and found that our medium-sized dollars of say three inches across would be giants over on Padre Island.

This barrier island chain is like ours in some ways. My wife, Carol, and I have walked the beaches of Padre Island many times outside of Corpus Christi, Texas, but we didn't do very well shelling.

These folks said their sand dollars hardly ever get really large but they are more round. I mentioned that we have two types of sand dollars, the round variety and the arrowhead design.

One of the more prized shells they find is in the wentletrap

family. They described a particular shell, but I've never heard of it nor seen it on our Sanibel-Captiva Island beaches.

Incidentally, our most cherished shell, the junonia, is also high on the list of desired shells in Texas. They said one place to look for junonias is in the bottom of the nets of the returning shrimpers.

You might recall that the wife of famous shell book author, R. Tucker Abbott of Melbourne, said that is one way Floridians might find a junonia without walking the beaches for years.

Probably the thing that interested me most about the shellers from the Texas coast was that they kept picking up shells and asking me, "What's the season for this one?"

Season? It seems that in Texas they have certain times of the year when they get certain shells.

They went wild over dead sea urchins because they hardly ever find all they want in Texas.

They couldn't believe that all the lettered olives on the beach would be found most any time of the year. If they find a good, colorful, clear olive, it's time for celebration.

One thing I was very pleased with was that the Texans didn't take live shells either in Texas or here. Seems that their shells over on Padre Island are getting harder and

harder to find. Sound familiar?

As we talked about the similarities between our Islands and their islands on the Texas coast, I found that there is a serious beach erosion problem there also.

Much of that island is in a national seashore protection, and the government was building a huge pavilion for beach goers when a hurricane hit last year. They said the beach eroded so quickly that it brought the two-story pavilion down to one level as the tides ripped at the beach. Some places lost more than 50 feet of sand.

Another interesting comparison they made was that there are hardly any trees on the Texas islands. But then, they might have had more storms than we have had.

The family's final comparison came down to the fact that we have much more of a variety of shells -- and to a serious sheller, that's a big difference.

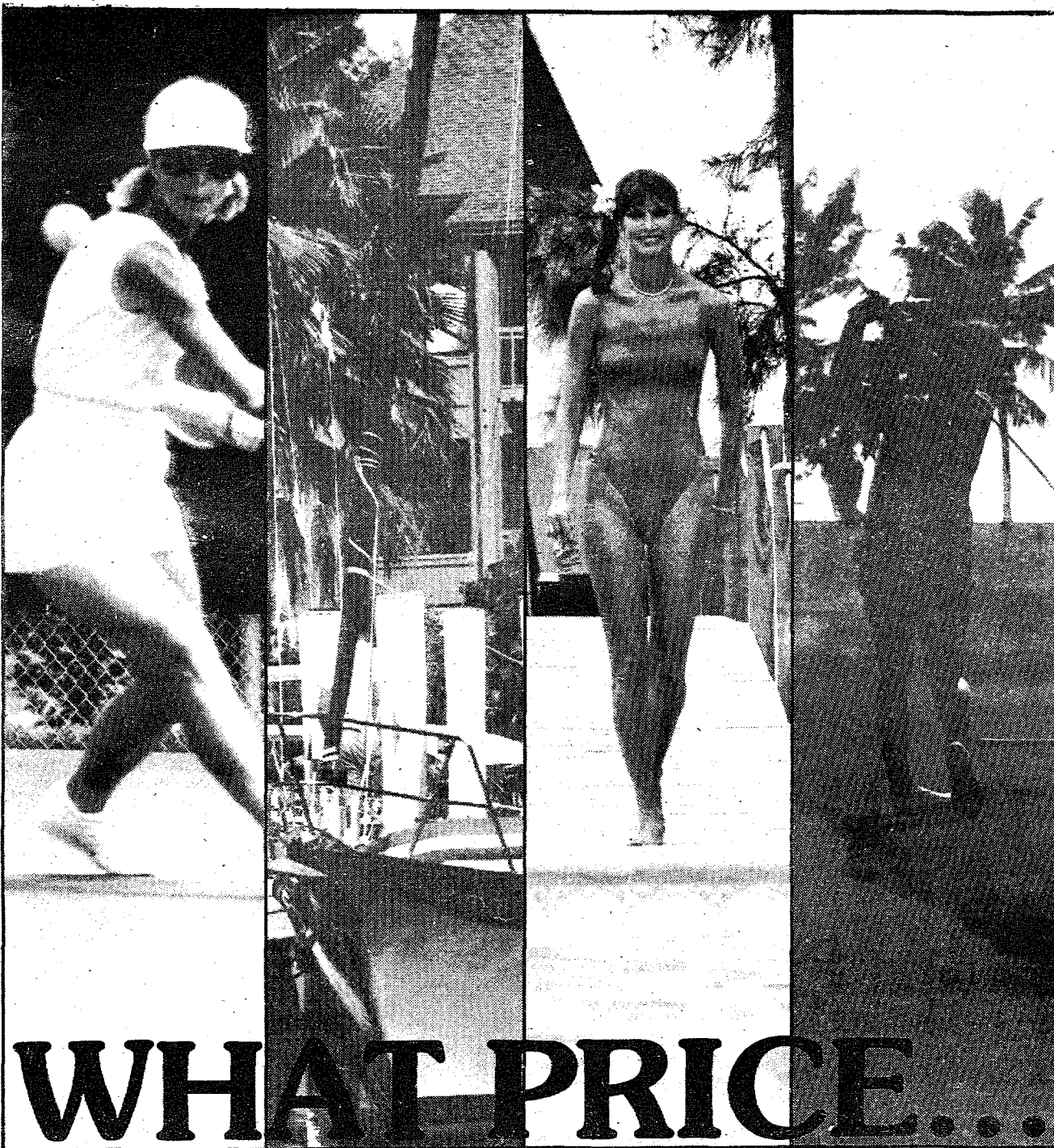

New City Hall should be 'simple, informal, natural'

Sanibel's new City Hall should be simple, informal and natural if it is to reflect the values of the people city government serves, architect J. Benton Stewart said in a report that is to be delivered to the City Council today (Tuesday).

"Sanibel's public owned buildings should be an example of what type of construction is desired on Sanibel ... humble, modest, tasteful and natural, having a feeling of openness, and fostering an awareness of nature while being efficient and informal,"

the report said.

Stewart arrived at the list of characteristics based on interviews with 11 Sanibel elected officials, citizens and city employees.

The interviews were conducted in April and consisted of informal discussions about when the interviewees first came to the Island, how long they have lived here, why they chose to live here and what they think are the most outstanding and unique characteristics of the Island.

As a result of the interviews, Stewart determined that, "Sanibel's goal appears to be to preserve the dream of a semitropical island lifestyle in harmony with nature and history," the report said.

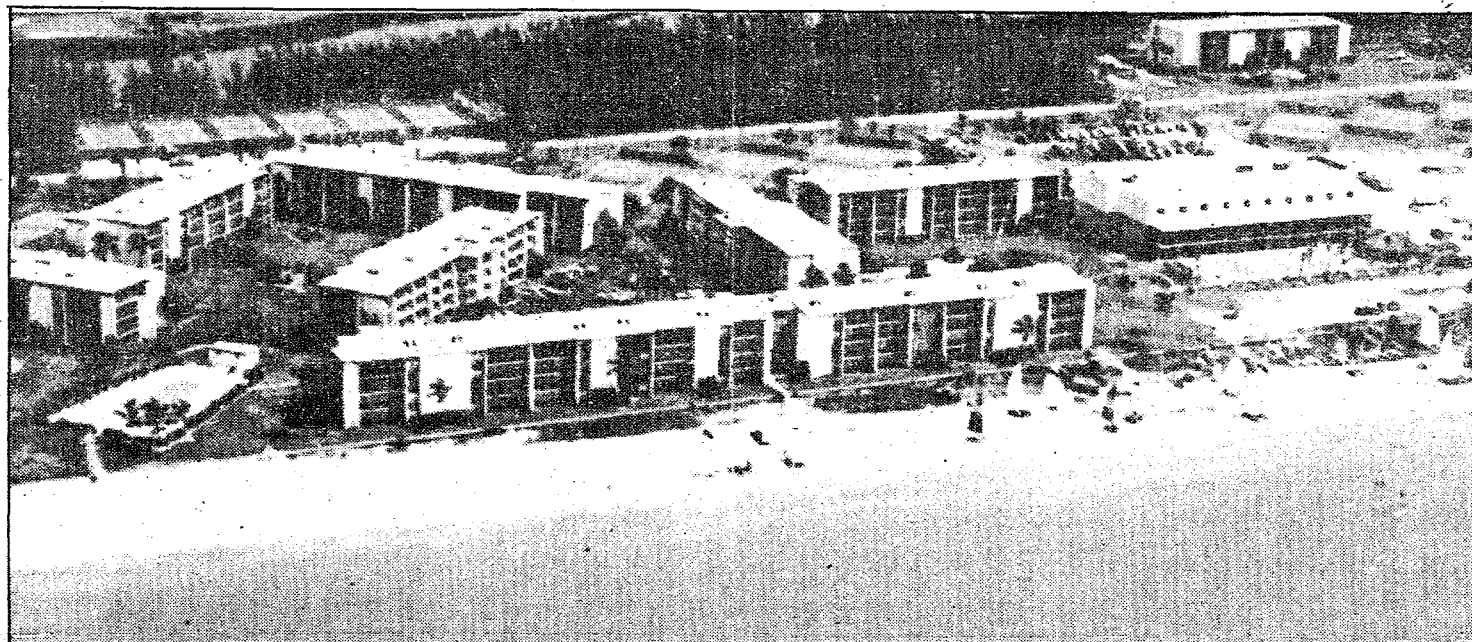
"To achieve this goal and desire," it continued, "The built environment of Sanibel should take a subservient position to the natural beauty and native vegetation of Sanibel, encouraging nature to intermingle with the built environment."

"Thus, we believe," the report concluded, "It appears desirable to attempt to incorporate into the design of the City Hall and its surrounding grounds, proper recognition of Sanibel's relationship to nature and history."

After hearing the architect's image perception report today, the council is scheduled to hear from the City Hall Site Selection Committee about its preferred site for the new complex.

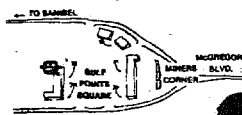

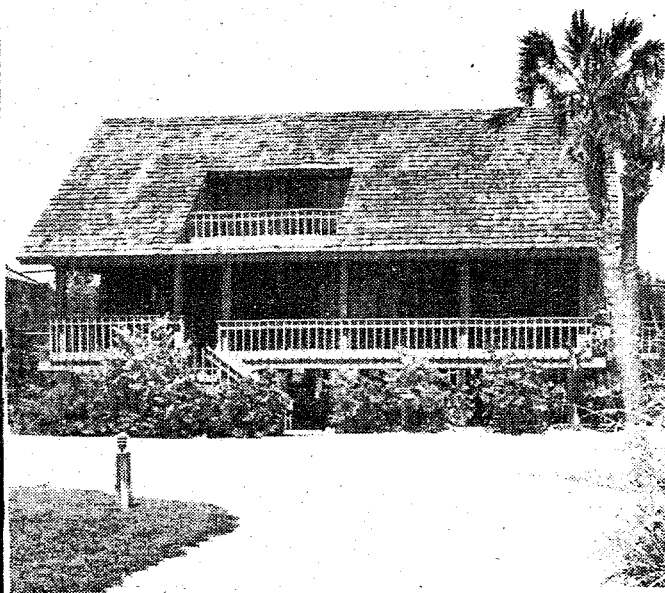

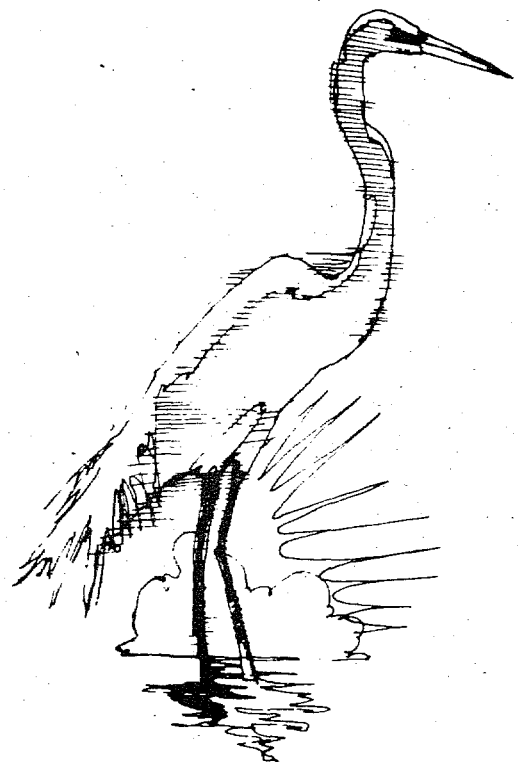

For friends of the B-Hive who come back day after day, smiling Trudy and the joking Georges are reason enough to visit — not to mention the delicious, custom-tailored sandwiches.

George, Trudy and George Jr. don't consider their clients customers. They consider them friends, and the B-Hive has become not only a trading-post but somewhat of a chamber of commerce and information center for the east end of the Island.

"It's like a clearing house for all of the phone calls on the Island," George Jr. laughs. "Would you tell my husband when he comes in that he has to go pick up my daughter," he mimics for example, adding, "Or tell them I left the cigarette burning in the ashtray."

"They'll also say," Trudy chimes in. "I need a new housekeeper. Could you find me one?" He (George Sr.) found a secretary for someone and for weeks men would come in and say 'I want a secretary just like the one you found for...'"

People leave messages with the Kohlbrenners. They call them up when they find injured animals and they don't know what to do. The family also serves to some as real estate and travel information sources. The list of what the Kohlbrenners do for Islanders and their visitors goes on and on. But in many ways, that is just reason why the Kohlbrenners are here on Sanibel.

"Sanibel, all of Sanibel, the people on the Island — everyone is just a little bit nuttier than the other one, and that's why it worked out so great!" George Jr. explains.

"I mean you can call anybody with any problem at all and somebody's going to take care of it no matter how crazy it sounds," he says with conviction.

And if the Kohlbrenners can't find a solution for somebody's problem, they simply call somebody else who can.

There is no doubt that the Kohlbrenners put in long and crazy hours, which sometimes leads them to ask, "Why am I doing this anyway?"

They are quick to realize however, "Where else could you live on an Island like this? Really, you have everything down here (of course, you don't get to use much of it), but really it is a paradise," Trudy explains of how they deal with the frustrating days.

But those feelings are generally short-lived until an Island pal comes in laughing and cheers them up, or a shipment of goodies arrives and brings a feeling of Christmas into the store, which quickly revitalizes the proprietors' energy.

naturally to them and which they share so eagerly with everyone who walks through the B-Hive door.

"You have to have a closer relationship with the people," Trudy explains.

"With Bailey's 10 doors away people don't have to shop here," George Jr. interjects.

"There's no reason people have to shop here," George Jr. continues. "We don't have customers; we have friends. They can go anywhere to shop, but they shop here because you know them and you talk to them and say hello."

People also shop at the B-Hive because the Kohlbrenners will carry the bags out for them, and because they let friends-customers slide until tomorrow if they can't pay today, and because they'll make a trip into Fort Myers for a special kind of soap if an Islander needs it.

"It's a good relationship with everybody," Trudy says referring not only to the customers but to the family practice of sending people to Bailey's or Huxter's if the B-Hive doesn't have what they want and vice versa.

There is no sense of competition, but rather a strong sense of pulling for the common good with the help of the other businesses, she explains.

The Kohlbrenners are the type who bend over backwards for the people they care about — and that includes just about everybody.



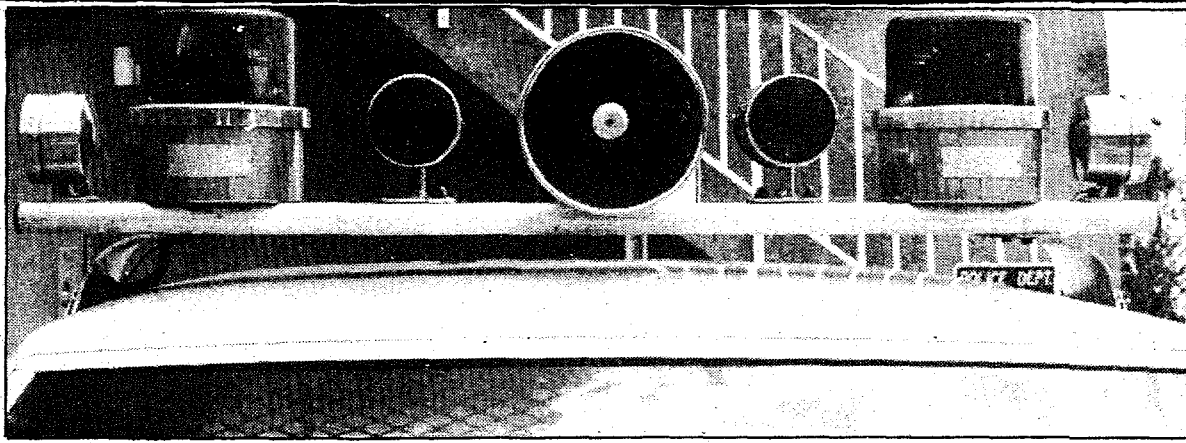

Historic Island home up for sale

The City of Sanibel has been offered the right of first refusal to buy "Uncle Clarence" Rutland's Island home to preserve as an historic site.

City Manager Bernie Murphy will bring the matter to the attention of the City Council at today's meeting.

Frank Joyce, a real estate associate of Executive Services, Inc., said the asking price for the white-frame dwelling next to Jim's Shell Shop on Periwinkle Way is \$250,000. Terms are \$100,000 down, with the balance payable monthly over a five-year period at 14 percent interest, he added.

"We offered it first to the city," Joyce said. "We would really like to see the old Island landmark preserved as an historical museum."

The two-bedroom, one-bath house with with the rooms opening off a central hall would adapt very well to that use, he added.

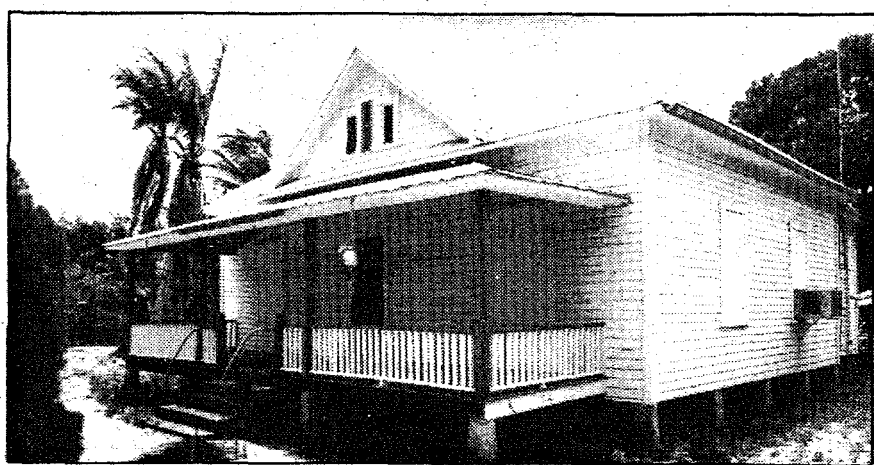
"There are 5.66 acres in the property, and there is a possibility that the rear portion could be used for another purpose," he said.

Though the listing is now public, Joyce said his first choice would be to sell to the city.

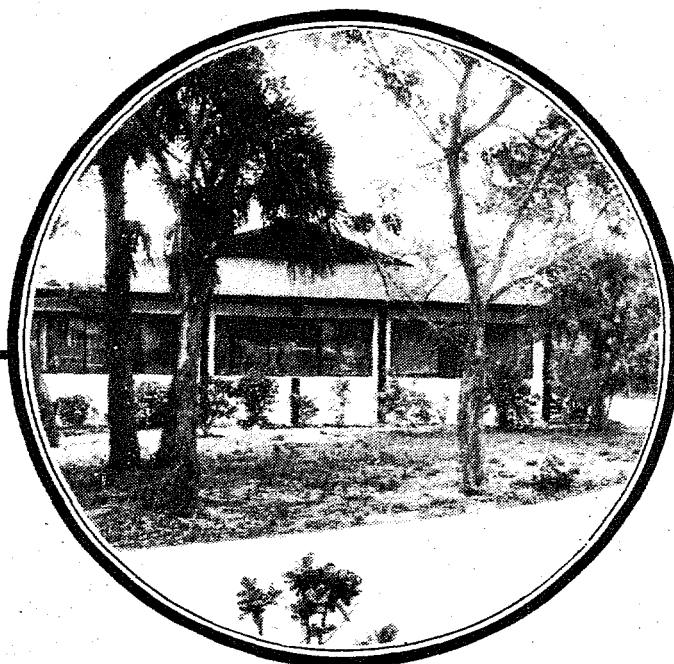
Described as a "unique property -- a true Florida-style home...reminiscent of the early days on Sanibel," the house was built in 1931 and occupied by Clarence Rutland for almost 50 years.

Rutland, now 91, is a patient at the Shell Point Village medical facility. His affairs are handled by his niece, Mrs. James Williams.

The house was placed on Sanibel's list of historic buildings in 1975. At the urging of the city's Historical Preservation Society earlier this year, the City Council asked Mrs. Williams for first refusal should the property ever be put on the market.

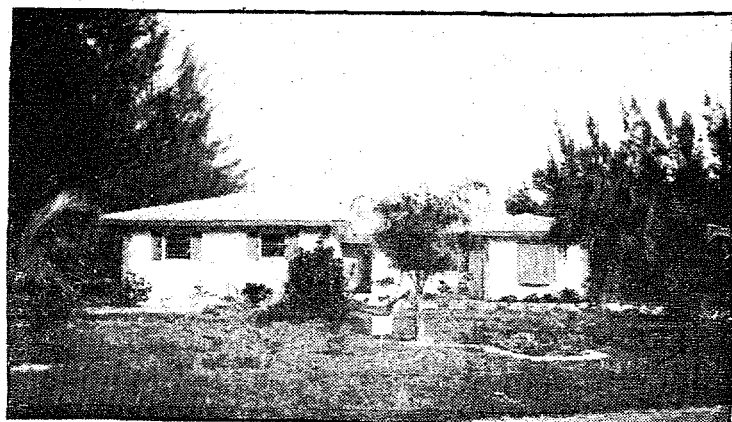

Harmel exhibit opens Sunday at Photographers' Gallery

An exhibit of photographs by Sanibel resident Mark Harmel opens Sunday, June 21, from 5 to 7 p.m. at the Photographers' Gallery.

"At least a third of the images have been taken in the Sanibel, Fort Myers and Cape Coral area," says Harmel. "The others are from either California or Michigan."

A unique feature of Sunday's opening will be a "guided tour" of the images that will be conducted by the photographer.

"The purpose of the tour is to create an interchange between the viewer and myself," explains Harmel. "I plan on talking about where, how and why the picture was taken, and answer any questions that may arise," he says.

The 27 year-old member of the Gallery's Board of Directors is a graduate of Thomas Jefferson College in Allendale, Mich. with a degree in social sciences and photography.

Before his current position as photo editor at the Sanibel-Captiva Islander, Harmel worked as a night photographer at the Cape Coral Breeze.

His photographs have also been published in The Grand Rapids Press, Coast magazine in Los Angeles, and Fort Myers' Home and Condo, and Lee Living magazines.

During his two years at the Islander, Harmel has won eight awards from The Florida Press Club and The Florida Press Association.

Many of the 43 images on display have been published in the Islander, including photographs of the Conservation Center's

barn owl and portraits of James Dickey, Eben Joy, Linda Wassum and Ikki Matsumoto.

"Part of the fun of this show is exhibiting style of my work that is outside the realm of photojournalism," Harmel says. "Most of these pictures have only been shown to my photography classes, and the inside of my closet."

One group of images is grab shots taken on the streets in Grand Rapids and Los Angeles. "I still consider myself a street photographer, but down here the streets and beaches aren't crowded enough to work in close like I want," he explains. "So I am left to shoot vegetation and birds."

Close-up images taken from television sets are among his newest work. The black-and-white shots are taken so that the color dots are exaggerated, giving the photos a sense of texture. Walter Cronkite, grinning during his farewell message, stills from the movies "Wizard of Oz" and "Grease," and some commercials are included as subject matter.

A selection of color prints showing a different side of Harmel's vision will also be on display.

"When I am shooting color film I am an entirely different photographer," he relates. "I concentrate on subject matter and composition, when I have black-and white film in my camera, but when I shoot with Kodachrome my subject is dominated by pure color."

If a fortune teller told Islander Jill Goodman two years ago what the crystal ball had in store for her, she would have been shocked. What Jill is doing now is at the polar end from what she was doing then.

A sensitive, graceful and intelligent woman, Jill is one who at the height of a fascinating career with Estee Lauder cosmetics stopped to smell the roses and ended up making the biggest change in her life.

"A lot of people desire to change things and to do new things," Jill muses today. "I did it and I realized it's okay to change. It's good."

A product of the now-outmoded female role playing philosophy, Jill explains her suburban New York upbringing with visions of rose-colored picket fences and fat little babies.

"My mother raised me to be a mother," she says today. "I played with the proper dolls, I did the proper things and I was going to catch me a man who'd take care of me for the rest of my life so I would never have any worries again," she adds.

With that breeding in mind, it's no wonder Jill headed for Manhattan in her late teens to seek what she thought every woman wanted.

She floated from company to corporation with a secretarial pool in the Big Apple until she was in her mid-20s. "The job was a job until something happened and until I found someone to marry," she says candidly.

That "something," Jill says, was a position with the Estee Lauder company during its infant stage. At the same time, she also married.

"I joined, at the great fortune, the Estee Lauder company, oh, about 1965. At that point it was Estee Who?" she laughs.

"When I joined the company I never heard of them really," Jill confesses now. But she says the Lauder's were such a fascinating family with such wonderful plans for the future world of cosmetics that she decided to give it a whirl.

Once in the bustle of the beauty business, Jill instantly fell in love with her job. "I went to work for them as anybody," Jill says emphatically. "I mean I wore so many hats I could be anything!"

Jill handled the firm's cooperative advertising for the entire country. She wrote copy for the packages, handled the accounts and helped inventory the stores. She learned how to sell Lauder products and handle the phones and complaints and so on.

"It was wonderful!" she says wide-eyed. "It was the best on-the-job training anybody could ever dream of."

The company was very new when Jill came along. Therefore, any and all innovative ideas from the 30 people who headed "Estee Lauder U.S.A." at that time were always welcomed. And, Jill says, they were frequently put into practice.

"I can't describe the satisfaction when you say, 'Wouldn't it be fun if...' and then two months later, see if happen," Jill says of the flood of ideas available in the then infant field.

Mrs. Lauder, she says, was a great believer in "trying on a make-up the way you try on a dress."

But in those days, Jill says wryly, "Cosmetics fell in the eyes of the department stores and retailers somewhere between Vaseline Intensive Care and baby oil. Believe it or not, there were no cosmetic departments as you know them today."

Mrs. Lauder, who introduced the popular "gift with purchase concept," asked her able staff to put on a spectacular promotion called "The Beautiful American" in the "embryonic Bloomingdale's cosmetic department."

This idea, with its creative use of beauty advisors and models, was a smash success and became the catalyst for a brand new concept in cosmetic marketing. It was also an area that greatly interested and intrigued Jill.

"This was the beginning of the whole area in this company and I said, 'Hey Lauder family, this is what I want to do. I don't want to do cooperative advertising. I don't want to do

copy. Let me handle your special events area.' And they said, 'Go ahead Jill. It's yours,'" she says.

Jill spent several years enthralled by her work. "The special events area was new, and I had the good fortune to be behind the division and the growth of it. I worked very, very hard and it was great fun," she says.

A number of years passed, and while Jill and the company continued to succeed, her marriage failed. Then the Estee Lauder Company literally became Jill's life.

But something was beginning to change within Jill. "I was no longer bouncing out of bed in the morning. I no longer looked forward to being involved with my very precious job - that position which I built and created!" she explains of her increasing disenchantment.

With stress problems beginning to magnify, Jill went to Key West for some soul-searching and ended up making a 180-degree about-face that ultimately changed every single thing in her life.

She met a new man, Arnold, who some months later became her husband. Together they left New York and all the stress and frustrations of their jobs behind and headed for Sanibel.

budget. "You want (police) to stop canal speeding and causeway speeding and enforce the new beach access regulations, too," he added. "We'll do what we can with what you give us."

The present Police Department staff provides for one officer to patrol the Island between midnight and 8 a.m.

The consensus of the CONA membership was that Islanders are ripe to support an increased police budget.

"I think the people will okay a budget to get more police protection on this Island. It is absolutely vital," Palmer said. "Now is the time to stike while the iron is hot."

The two new officers will be included in Butler's 1981-82 budget request, which will be presented to the council for final approval in September.

In the meantime, Butler said, he will see that police officers patrol Island neighborhoods more often and watch for suspicious activity.

"We concentrate on the city's commercial areas," he said about nightly patrols. "That's where most of our activity is."

CONA member Paul Howe said he did not think it was right that residents should sacrifice their own protection so police can patrol the city's business areas.

Butler said active participation in the Neighborhood Watch program could insure

more protection for residents.

"Neighborhood Watch is a great thing," he said. "I would urge every neighborhood on the Island to get the program started."

While Butler talked about crime on the Island, one CONA member noticed four suspicious people across the street from the home where the meeting was held.

Someone else in the Shell Harbor neighborhood apparently noticed the group, too, and a police car arrived at the scene shortly after.

Butler excused himself from the meeting to check on the incident and returned to report the people were from the Jehova's Witness church in Fort Myers.

Although they turned out to be harmless, the incident was a good example of how residents can protect themselves and their neighbors from burglars, Butler said. "That's what Neighborhood Watch does," he added.

Butler praised Sanibel residents for their communication with police regarding any suspicious activity they observe.

"Sanibel is unique in that respect," he said. "You people aren't afraid to call the Police Department and talk about what's going on."

"If we keep that relationship going," he said, "We can make the Island safer."

'Crime watch camera' could deter thieves

Thieves who collect their loot and then quickly leave the Island never to be seen again would be deterred by a closed circuit television camera at the causeway toll booth exit, Sanibel Police Chief John Butler said last week.

The camera would film both the driver and the license plate of every car that leaves the Island, he explained.

Butler said he plans to include \$11,000 for the camera in his budget request for the 1981-82 operating year.

Many crimes on the Island can be pinned down to a specific time span of a few hours or less, he said. Film from activity at the causeway exit during the hours of the crime could be examined for possible suspicious cars or vehicles matching descriptions from victims, he added.

"We've had so many incidents on the Island where the victim can offer only a partial description of the car or license

plate," Butler said. Film to study could have proven invaluable in apprehending the criminals, he explained.


Butler said Lee County Sheriff Frank Wanicka has endorsed the proposal. County officials must approve the concept because the causeway is county property, he added.

Concerns that the camera would constitute an invasion of privacy for drivers are unfounded, the police chief said.

"Channel 11 can stand on the causeway and film travelers all day long," he said. "There's nothing wrong with that."

Butler introduced the causeway camera idea at the monthly Committee of Neighborhood Associations meeting last week.

The concept received the unanimous support of the 13 CONA members at the meeting, who said they would endorse the police chief when he makes his budget request to the City Council in September.



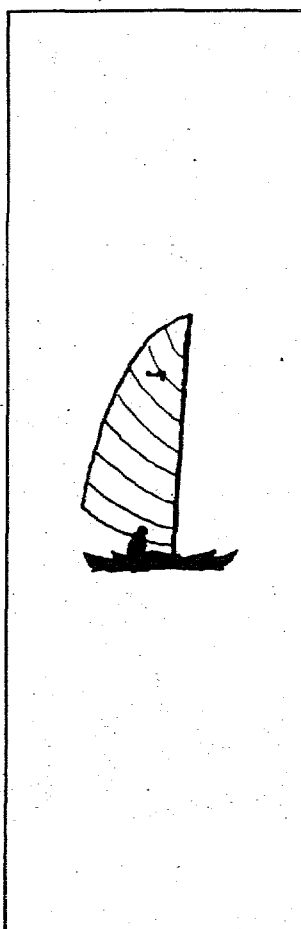





slacks off," Simon pointed out.

Bailey acknowledged that business at his general store drops off an average of 66 percent from the winter season peak.

"My engineer says the ULI productivity figures used in the study are too low and four or five years old," Bailey added.

Councilman Fred Valtin said it is "difficult for me to accept that in five or 10 years we will need 12,000 to 15,000 square feet less space for restaurants than we have now."

MacDonald agreed that this conclusion might be an aberration and he would check it out.

He said the figures for projected net supportable retail space will be reexamined when the results of the merchants survey are analyzed next week.

MacDonald pointed out two unmistakable conclusions: Sanibel residents do not want further commercial development on Periwinkle Way with the majority opting for open space; and the undeveloped commercial property on the Island far exceeds projected demand through 1990.

MacDonald said he was surprised that parking at existing stores was not as big a problem as had been perceived. Although 90 percent of resident respondents found winter season traffic a problem, 45 percent of said it was only minor.

MacDonald agreed with Valtin's statement that, "The surveys prove the

residents are pretty well satisfied with services as provided."

The surveys also revealed that respondents made 40 percent of their grocery purchases off island.

"The market for retail growth is here on the Island," MacDonald said.

Twenty-seven percent of the respondents said there was a need for another grocery store especially on the east end of the Island. However, they objected to business intruding into residential areas.

Commissioner Louise Johnson said the grocery shopper survey, conducted between 10 a.m. and 5 p.m. at the larger shopping complexes in mid-April, might be misleading.

"Most year-round residents shop early in the morning during the winter season to avoid the crowds," she said.

Searing questioned the reliability of the sample. Only 1,200 of the 3,000 homes that received the questionnaires returned them, he said.

But MacDonald said a 34 percent return was exceptional compared with an average response rate of 27 percent.

At last Wednesday's meeting with the council, MacDonald asked for guidance in setting policy in order to complete the study by the July 1 deadline.

"I need to know if the council believes it is in the best interest of the public to limit

commercial development, and if so, to what extent," he said.

To make recommendations for alternative uses for excess commercial-zoned property, MacDonald said he had to know the degree the city would intervene in the private market to control future business growth.

Bailey said that, "A lot more work needs to be done before he can make that decision."

"I don't agree there's enough land in the right configuration to supply demands of retail outlets in the future."

"I would like another workshop when the other two councilmen are present," Bailey added. Mayor Duane White and Councilman Porter Goss were not present at last Wednesday's discussion.

"I doubt that a consensus will emerge on such a basic problem without input from the full council," Valtin said.

Planning Director Bruce Rogers said that before final meetings are scheduled, the council should have the results of the merchants survey and "sufficient information to cover the full range of study objectives, at least one week in advance."

MacDonald said research has been completed for all phases of the study.

"I would like Rogers and City Attorney Neal Bowen to sit-in and the members of the Planning Commission invited to participate in another workshop," City Manager Bernie Murphy said.

MacDonald had said he would need legal advice to recommend alternative land use.

MacDonald has already eliminated Transfer of Development Rights as a method to compensate property owners.

"There's not enough land to transfer," he explained.

Other ways McDonald is considering limit commercial development include rate of growth mechanism for commercial property similar to the present ROG allocations for residential development; a system for monitoring the retail demand by yearly surveys and adjusting growth meet it.

MacDonald said the city could also rezon commercial property for non-retail use, rezoning it for other uses such as offices or set up a fund to purchase the excess commercially-zoned property for use as public open space.

June 30 was set as the date for another workshop, and MacDonald promised to furnish the information requested a week earlier.

Klein will be on vacation, but the other four councilmen are expected to be in town on that date.

MacDonald's presentation of his final report is tentatively scheduled for July 1 after Klein's return.

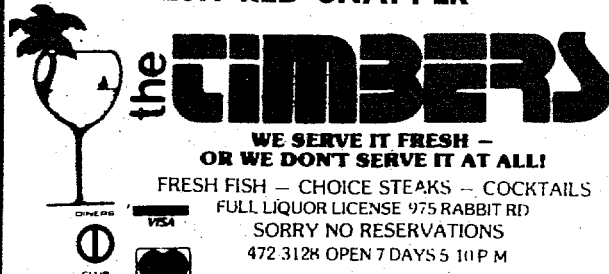

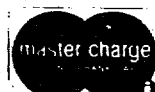

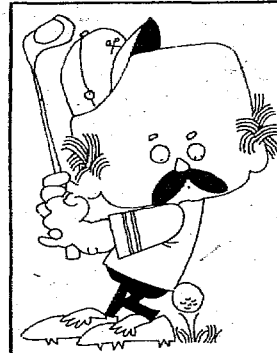


Sanibel swimmers sink competition

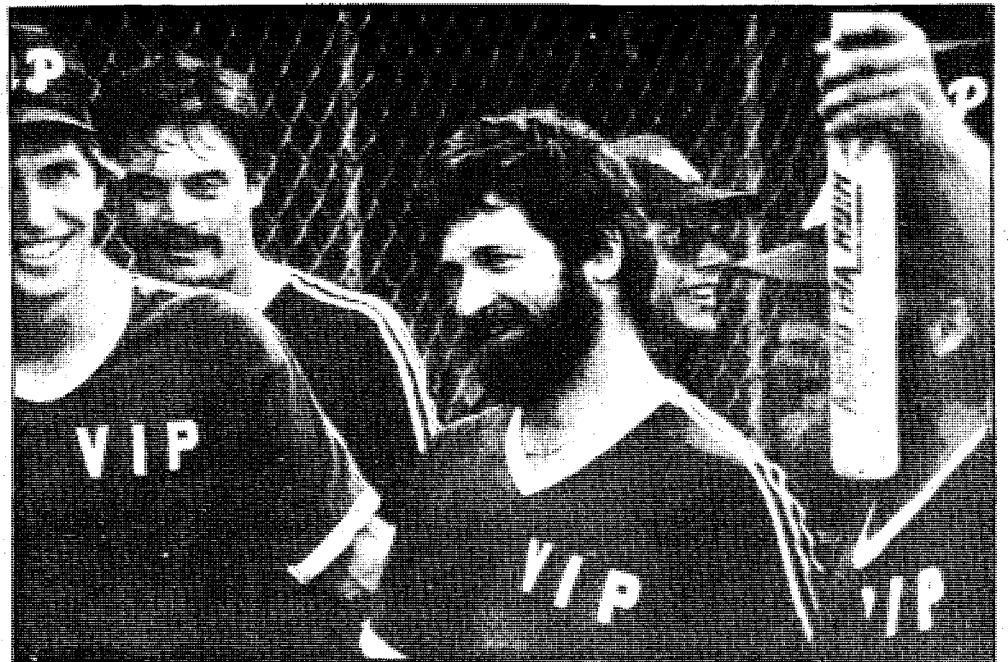

In support of Coastal Management Programs

Dear Secretary Tschinkel:

Thanks for the thoughtful letter expressing the Department's appreciation for my publicly-stated support for continuance of Federal funding of Coastal Management Programs. I am confident that we share our Senator Paula Hawkins' regret that a slash in those funds is being seriously considered by the President's advisors.

Nonetheless, an important aspect of the coastal management plan that also impacts on Florida's interior regions is the proposed set of standards for water supply facilities by your DER.

Recently, AP's Ken Klein outlined your progressive attitude on "the State's effort to conserve water and guard against depletion

or pollution of fresh-water supplies." That effort is basic to achieve the 10-year goal to standardize the regulation of water-use by the State's five water management districts. In light of the recent frightening drought, it is most essential to hit that target very soon.

Equally important is the need to install an interconnected system for supplying potable water from water-abundant northern Districts to those in the south where inordinate growth creates sporadic shortages that affect tourism.

The recently reported opposition by local public officials to an Army Engineers' suggestion to pipe excess Suwannee River fresh water to the thirsty south was a deplorable dog-in-the-manger attitude that needs curbing by the State. It is incongruous to the "full beneficial use" concept expressed by the Declaration of Policy of the Water Resources Act of 1972.

The urgent need for such a water supply grid system prompts me to suggest an affirmative use of the powers and duties granted by s.373.026 F.S. That could be done by DER coordinating groups of various

District officials in developing a feasible plan for constructing, operating, and financing an appropriate grid system.

Some basic financing tools for achieving that goal are the recently enacted HB492 authorizing State bonds to finance or refinance water supply and distribution facilities and SB 620 making increased Documentary Stamp Tax funds available for acquisition of sensitive lands near rivers.

When the smoke clears away from the current Legislative front, I would appreciate your views on the above suggestion.

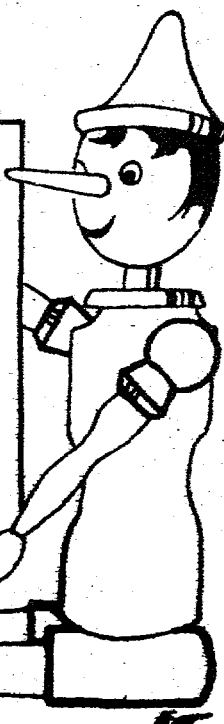

Russell Denyes dies in South Carolina car accident

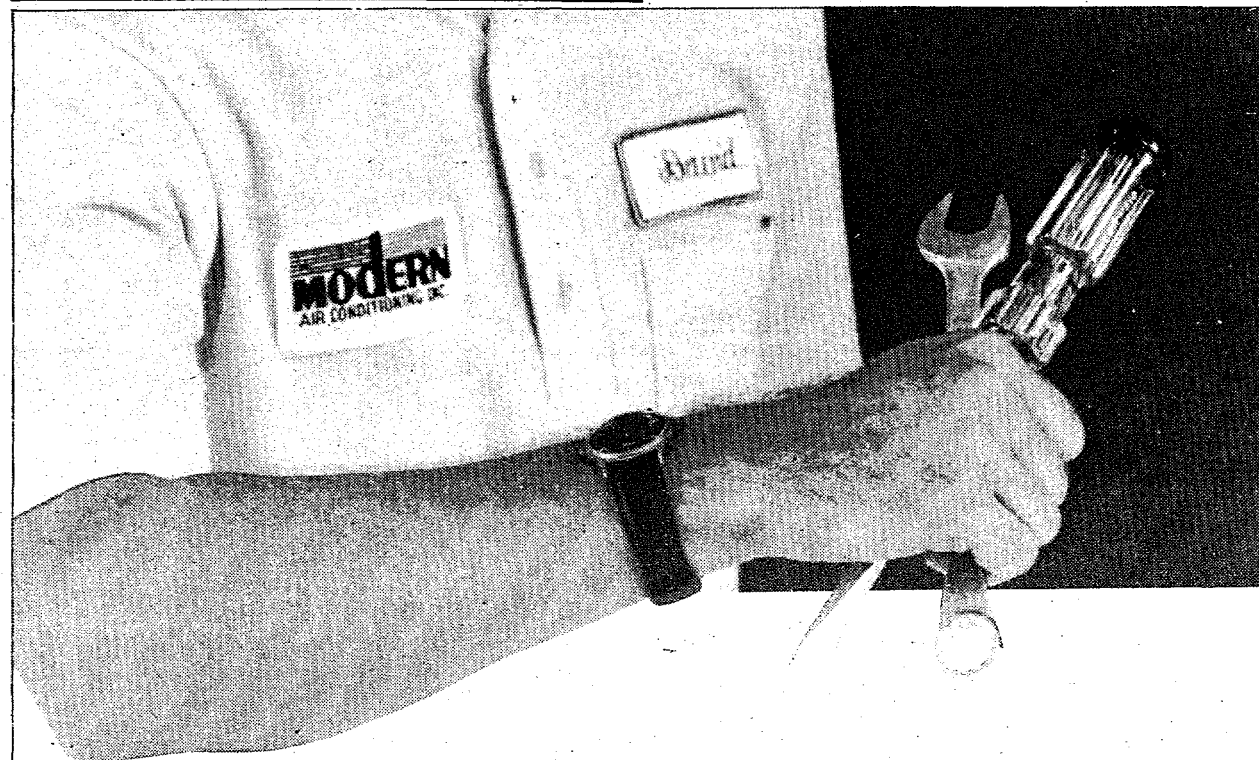

Book report from the Sanibel Library

By Harriet Howe

THE WORLD OF FARLEY MOWAT edited by Peter Davison. For nearly 30 years, Farley Mowat has been observing and writing about life, human and animal, north of 46 degrees north latitude. But he also writes with delightful humor about other things.

For openers there are selections from "The Dog Who Wouldn't Be," that incredible Mutt who "was not really handsome, yet he possessed the same sort of dignified grotesquerie which so distinguished Abraham Lincoln and the Duke of Wellington."

In other selections from his works, Mowat describes with poignancy the People of the Deer, who accept their world and live in harmony with it and with whom Mowat lived for a time.

As a naturalist employed by the Canadian government, he was dispatched to the Keewatin Barrens 300 miles northwest of Churchill to study wolves.

Among other observations it was noted that wolves eat mice, and lacking a control for an experiment he planned, Mowat became the guinea pig.

He developed a gourmet (?) recipe for

Creamed Mouse which he calls *Souris a la Creme* and generously shares with his readers.

Mowat tells of his grueling experiences in Italy during the war; he writes about the Newfoundlanders who make their precarious living from the sea; he tells of a visit to Siberia.

His writing is serious and thought-provoking, but he can always inject a bit of humor. An enjoyable book well worth reading.

The Best American Short Stories 1980 edited by Stanley Elkin - Twenty-two stories taken mostly from The New Yorker.

The Terrible Secret by Walter Laquer - The author explores the suppression of the truth about Hitler's concentration camps. A Window Over The Sink by Peg Bracken - As the jacket states, a mainly affectionate memoir.

SHOPPING

Sanibel is a veritable shopper's paradise. Tasteful boutiques and casual Island shops join forces to present visitors with everything - and anything - a vacation shopper could hope for.

At the Lighthouse (Eastern) end of the Island, Punta Ybel Plaza and The Sea Horse Shops are right across the street from each other, providing a variety of products that can cure your sweet tooth or tickle your shell finder's fancy. Need a good haircut or coiffure? You can get it in either of these shopping centers. Most businesses open at 10 a.m. and close at 5:30 p.m. This holds true for many Island stores, although during the winter season, some are open evenings.

Tall Australian pines shade Periwinkle Way as the shopper travels west along this main thoroughfare. This stretch of road is truly a shopper's paradise! It's all here...the fast and not-so-fast eating spots, casual and elegant boutiques, hand-wrought jewelry, craft designs, shell shops and balms for health produce fanatics.

Watch to your right and left as

you drive or cycle along. Photographic supplies, bait and tackle, deli foods, fresh seafood and baked goods, knick-knacks and what-nots can all be found along the drive to the intersection of Periwinkle Way and Tarpon Bay Road. Along the way, shopping centers such as the Heart of the Islands, Periwinkle Place and Tahitian Gardens offer a variety of Island delights.

Palm Ridge Road, the Periwinkle Way turn-off to Captiva, offers several new shopping centers featuring everything from imports to gift shops for the discriminating shopper, plants and shells, a sandwich shop, ice cream parlour, pizza parlour, boutique shop and the Island Apothecary pharmacy.

At the Tarpon Bay-Periwinkle Way intersection, the Island Shopping Center features the Island's only supermarket, dry cleaners and movie house.

A left on Tarpon Bay Road takes the visitor past Sanibel's original schoolhouse, which now holds original Island watercolors and woodcuts. Then on to West Gulf Drive and westward to an interesting little artisan's

At the intersection of Periwinkle Way and Tarpon Bay Road, you may choose instead to turn right and follow the signs to the Tarpon Bay Marina, where you will find a cluster of quaint shops overlooking the back bay...Some antiques, shells and shellcrafts, what-nots and clever clothes can be found here, as well as a great seafood sandwich and soft drinks.

The spectacular ride to Captiva, with its lush foliage and enchanting view of the Gulf, is well worth a day's outing. Talented artists display their works in one roadside shop, while others feature some nifty gifts for Grandma to take home to little hands as a pleasant hodge-podge of remembrances from these barrier islands.

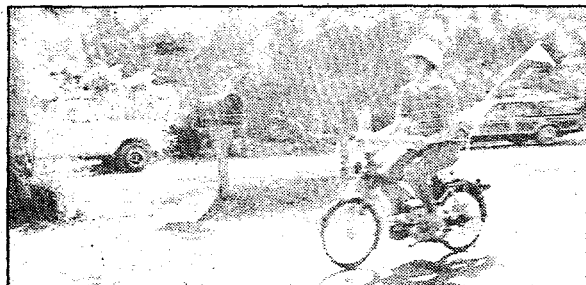

BEACH ACCESS

Sanibel has miles of public Gulf-front beaches, any one of which is only minutes from your lodging. Lighthouse Point is a stretch of Federal land on the Eastern tip of Sanibel Island, and from there, the Gulf beach is accessible again at the end of Donax Street, at Tarpon Bay Road, at Bowman's Beach Road (off Sanibel-Captiva Road) and Turner's Beach, which is located at Blind Pass, between Sanibel and Captiva Islands.

On Captiva Island, public beach access can be found at Turner Beach (which has public facilities) or further north, just past the entrance to South Seas Plantation.

NOTE: STATE LAW PROHIBITS NUDE SUN-BATHING ON ALL FLORIDA BEACHES. VIOLATORS WILL BE PROSECUTED.

CAMPING

Camping on the beach is prohibited and while everyone enjoys a beach fire, the Sanibel Fire Board has signed into law an ordinance prohibiting open beach fires. Prior to the ordinance, a permit was necessary for a beach bonfire, but as of July 18, 1980, it is now illegal. An exemption to the ordinance is a fire in an approved cooking container (not to exceed 48" X 24" X 12" deep with an extruded metal grill) for non-commercial food preparation. This type of container will be allowed on the beach without a permit. After you have had your beach party, it is recommended that you assume the responsibility for the cleanup of any debris or litter in your area.

GATORS

Feeding alligators anywhere within the Sanibel City limits is not only illegal (violators of the law are subject to a fine of up to \$500, or up to 60 days in jail, or both), but can be extremely dangerous. Alligators can run 45 m.p.h., so if you're close enough to feed an alligator, he's close enough to feed on you. An alligator fed for fun loses his natural fear of humans and becomes a potential threat to children and pets.

WARNING! SAFEGUARD YOUR VALUABLES.

In order to protect your valuable possessions from theft, it is recommended that you TAKE THEM TO A BANK OR HOTEL VAULT FOR SAFEKEEPING. Do NOT leave them in your room or car.

SPEED LIMITS

There are varying speed limits (20-30 m.p.h.) as one comes across the causeway, and there is a very good reason for them...to preserve the bridge supports from strain and stress. This speed limit is strictly enforced with the use of radar on a 24-hour basis by both the Sanibel Police Department and the Lee

County Sheriff's Department.

Driving or parking a motor vehicle or moped on the bike path is strictly prohibited. Violators will be ticketed.
