## County Commission

puts \$26 million

price on Causeway

The Lee County Commission last week voted to offer the causeway property to the city of Sanibel for a cool \$26 million.

Although the commission is open to bargain on some terms of the sale, Commissioner Harry Rodda said the price tag on the causeway is non-negotiable.

"I think the price we have come up with is very, very equitable as far as the real value of the bridge," Rodda said. "If the city can't go along with that, then we should back away from the table."

Rodda will make the formal offer of the property to the City Council later this summer. "Then we'll let the city examine our proposal," he said during last week's regular commission meeting.

Sanibel Mayor Duane White, who chairs the city's committee to examine the causeway acquisition, said Friday he would reserve specific comment on the county's proposal until the city receives the official offer from Rodda.

White did say, however, he would urge that the City Council not consider buying the causeway "at any inflated price" until the city obtains a detailed engineering report on the structural conditions of the causeway and bridge as it exists today.

"I would also request an estimate of the life expectancy of the bridge as it stands right now," White said.

The mayor also stressed that he believed the council should not make a financial decision of the causeway purchase magnitude without giving Islanders their chance for input in the form of a referendum.

White serves on the causeway committee with Ed Underhill and Carlton Simmons.

The County Commission retained former County Attorney Jim Humphreys to develop the proposal for the causeway sale. Humphreys outlined further conditions of the sale last Wednesday.

The council should be consulted before the city enacts any toll rate changes on the bridge.

Any rate changes should include no preferential treatment toward Islanders over the general public.

The causeway facility would be properly maintained by the city.

Under the county's proposal the city would receive 40 percent and the county 16 percent of the revenue generated by the causeway toll.

Four percent of the revenue would go to

## Stormy weather, resulting mechanical problems keep Islands in the dark

For six nights straight beginning June 13, lights flickered and went out over Sanibel, leaving thousands of residents in the dark.

But the longest and most widespread power failure occurred last Thursday night, when the Island was lashed by driving rain and winds up to 55 mph.

Diane Christensen, official spokesman for the Lee County Electric Co-operative that services both Sanibel and Captiva, said Mother Nature was the culprit in most of the outages.

The trouble began between 6 and 6:30 p.m. when lightning struck a pole on San Carlos Bay Drive knocking it to the ground and uprooting a tree, Christensen said. That incident plunged the Dunes and other areas on the northeast side of the Island into darkness.

Mini-tornados in other areas scattered over the Island blew lines from the pole and wrapped them around trees and native vegetation, she said.

With three emergency crews rushed to the Island, power was restored in most of the affected areas by 8:30 p.m., Christensen said.

But it was 1:30 a.m. Friday before the lights went on again in homes in the Rocks subdivision on West Gulf Drive and in the Middle Gulf Drive area that includes the Sundial Resort complex.

A pole downed by the storm turned the lights out all over Captiva Island including South Seas Plantation resort Thursday night. But lights were back on by 8:30 p.m., Christensen said.

"It was a most unusual night," she said. "The phones were ringing off the wall. We

appreciate customers reporting the outages because it helps us pinpoint the extent and area of the outage."

Most of the power failures were weather-related, Christensen said.

Wednesday night a line servicing Tahiti Shores, Chateau Sur Mer, Trade Winds and Gulf Pines was knocked out after lightning struck a pole in Tahiti Shores and blew out a transformer about 8:30 p.m. Power was restored 4½ hours later, Christensen said.

Last Tuesday night a power failure on the Lighthouse Circuit, one of the two main feeder lines on Sanibel, darkened portions of Gumbo Limbo, homes along Dixie Beach Boulevard, in Water Shadows and the Dunes, beginning at 8 p.m.

A mechanical failure caused that outage,

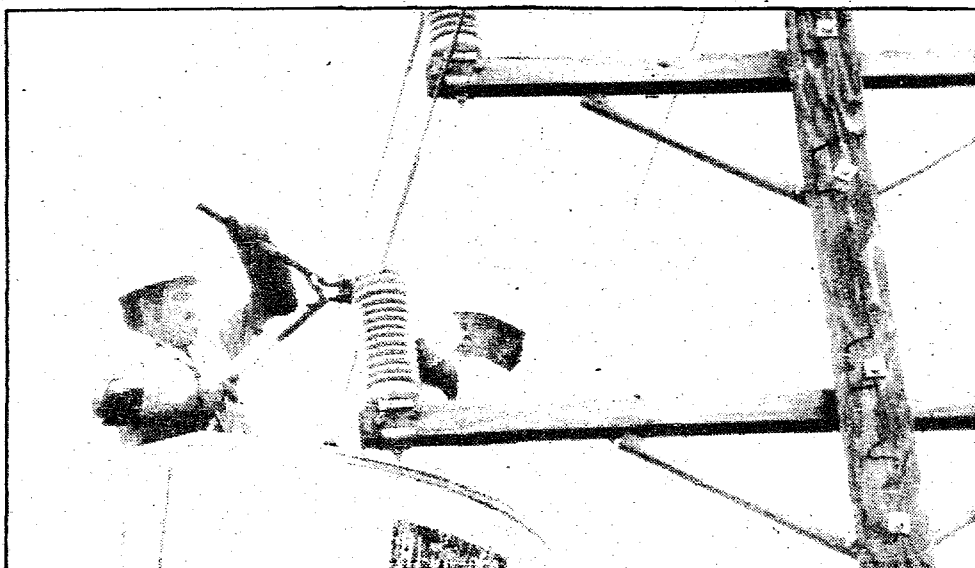
Christensen said. The initial trouble came from a switching device on Dixie Beach Road, and power was restored for most of people in the affected area within an hour.

But a problem developed a little later in a 250-foot stretch of underground cable in the Dunes. Four consumers there had no electricity until Wednesday evening while an emergency crew dug up and replaced the rotted out cable, Christensen said.

"That's the problem with underground lines," she said. "When they go out it takes much longer to repair the damage than for overhead lines."

It took co-op crews two days to spot the source of the outages that plagued 1,300

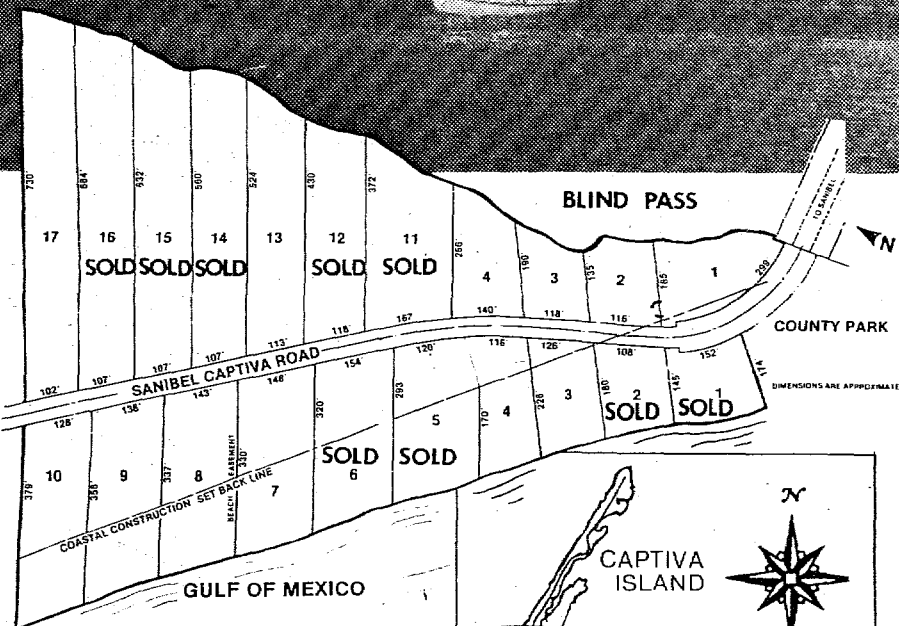
Afterwards the children roamed the library selecting books to take home.

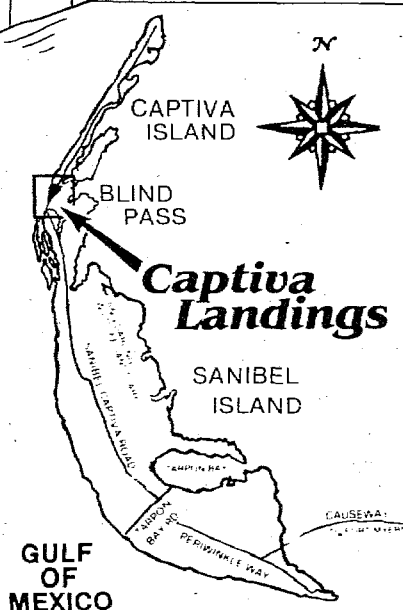

## Buntrock requests development permit

Robert Buntrock, exercising an option granted by the City Council, Monday requested a development permit to construct a 15,000-square-foot business complex on Periwinkle Road just east of the Palm Ridge Shopping Center.

Buntrock, denied the permit last year when the council failed to grant him relief from the commercial moratorium, went to court and won.

Circuit Judge Wallace Pack ruled the moratorium invalid and ordered the city to issue the permits to Buntrock or post a \$300,000 bond to reimburse Buntrock for any perceived damages stemming from the delay.

On the advice of City Attorney Neal Bowen, the council April 7 refused to post the bond and told Buntrock he could apply for the development permit, following the usual procedure. Construction would be at his own risk pending the outcome of the city's appeal of Pack's ruling.

Monday Architect Ray Fenton presented to the Planning Commission plans for construction of 10 1,500-square foot buildings on the 3.2-acre site, which is zoned restricted commercial.

The planning staff report cited 15 reasons against recommending approval of the plans as proposed.

In general, the proposed center meets or exceeds the minimum standards found in Section 3 of the Comprehensive Land Use Plan, the staff acknowledged. But it suggested fewer buildings of larger size in a different configuration would better meet the staff concerns about the site plan.

This would solve some of the problems

concerning setbacks, additional parking and an adequate area for loading and unloading, Associate Planner Bob Duane said.

But to increase the size of the buildings beyond the 1,500-square footage permitted in restricted commercial zoning, would require a specific amendment to CLUP.

Fenton showed a preliminary sketch of an alternate plan that calls for two 6,000-square foot buildings elevated to provide parking underneath and one 3,000-square-foot building at a slightly lower elevation.

This plan, Fenton said, would provide the same area of space for offices and retail shops but would permit 70 parking spaces, 10 more than the original concept. He agreed to dedicate to the city a 17-foot easement along Periwinkle Way plus a 10-foot vegetation buffer that would screen the center from the street.

In addition, the new configuration would allow a wider setback from St. Michael's and All Angel's Episcopal Church, the adjoining property.

The Commission agreed it was a better plan and voted to continue the hearing until its next regular meeting.

The continuation will give Fenton an opportunity to complete the new site plan and file for a specific amendment to permit buildings larger than 1,500 square feet.

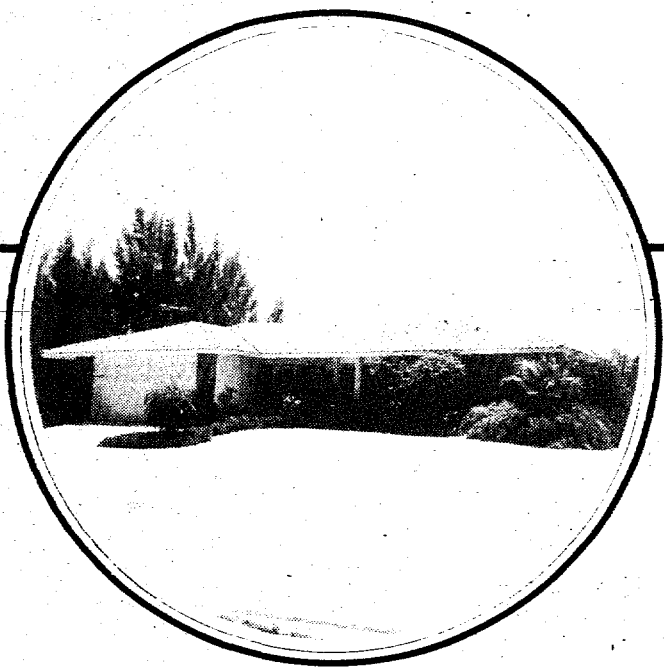
Fenton requested that the first reading of the specific amendment be placed on the agenda before the continuation of the request for the development permit for the 10-building plan is heard.

"This way I'll have another chance if the specific amendment is turned down," he explained.

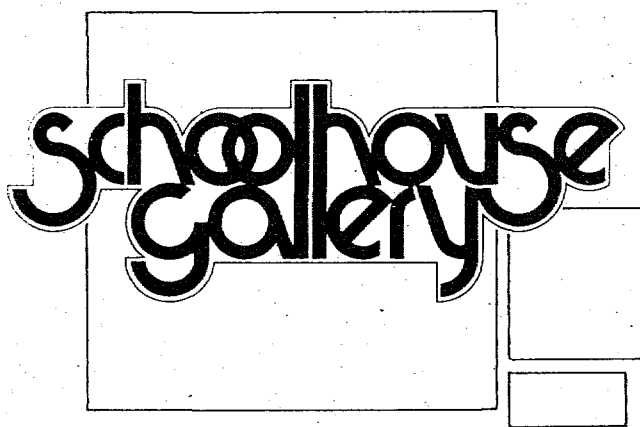

## Beach access parking permits prove popular on and off Sanibel

Sanibel beach access parking permits sold literally like hot cakes during the first week of sale.

Through last Thursday, Police Chief John Butler said, more than 800 bona fide residents purchased decals for \$1 allowing them to park at all designated sites.

"Surprisingly, 75 restricted parking permits were purchased by off-Islanders for \$15 each," he said. "Fifteen restricted parking permits were sold to non-resident property owners for a fee of \$1."

All permits issued before July 1, when the new parking regulations go into effect, expire Nov. 30. The yearly fee for the non-resident restricted parking permits will be \$30.

The rush from residents to get the \$1 decals early was prompted by a misunderstanding that the supply is limited, Butler said.

"A parking permit will be issued to any Sanibel resident and non-resident property owner who wants one," Butler stressed. However, restricted permits for non-residents are limited to 1,500 during any one year, he added.

Butler said the resident decals will be used as identification to make it easier for residents to return to the island after a hurricane evacuation.

"But any form of identification will be acceptable if you don't have a sticker," he added.

In a status report to the City Council last Tuesday, Butler showed a brochure that will be given to toll ticket book holders and everyone who pays \$3 at the Causeway toll booth.

It contains a map of the Island pinpointing parking areas and outlining the new parking regulations that will be strictly enforced, the chief said.

One Sanibel officer will be assigned exclusively to patrol the special parking areas and write citations, Butler said. Violators will be fined \$50, which will be reduced to \$35 if paid within 12 hours.

When the parking areas are filled, a sign will be posted at the Causeway entrance.

Butler said 10,000 brochures have been printed at a cost of \$500.

In addition to the parking information, the brochures will contain explanations of other regulations unique to Sanibel, including beach camping laws, fire regulations, bike path laws, live shelling restrictions, the ban on feeding alligators, controlling pets, removing gopher turtles, and the legal speed limits.

Emergency phone numbers will be listed and the locations of emergency call boxes indicated in the brochure.

Assistant City Manager Gary Price, who has coordinated implementation of the new parking strategy with Chief Butler, said Friday 60 signs identifying all special parking zones are in place.

"The signs will be covered with plastic bags until the opening day (July 1)," Price said. Railroad ties were used to construct the special parking corrals compatible with Sanibel's venue.

Councilman Porter Goss was concerned that several of the residential parking corrals along West Gulf Drive are in front of vacant lots.

"I'm afraid when these owners discover public parking in front of their property, we'll have a problem," Goss said.

Goss also stressed the need for "public orientation to the program."

Police personnel sold the parking permits

in front of Bailey's store again last weekend. From now on they are available at any time at the police station.

Applicants must have their vehicles with them as the stickers must be affixed by police personnel, Butler said.

## Hurricane expert to conduct 'dry run' on Island

Despite Councilman Fred Valtin's skeptical views of the value of Dr. Robert Simpson's probabilistic hurricane warning system, the City Council has engaged the nationally known expert to conduct a "dry run" this summer on Sanibel.

Simpson, a nationally known expert on hurricanes and a consultant for the city's Hazard Mitigation study, has agreed to come to Sanibel if and when a storm appears to threaten the island, Planning Director Bruce Rogers told the council last week.

As a part of the study, Simpson will computerize information needed for his warning system from the National Hurricane Center in Miami, from which he can predict at least 72 hours before landfall the probability of a hit or miss on Sanibel, Rogers said.

Simpson will be available on an on-call, as needed, basis and a \$300 per diem fee, plus out-of-pocket expenses, Rogers said.

Simpson will do his predictions on a time delayed basis for the first "dry run," Rogers said.

Simpson emphasized that the operation must be carried out in coordination with county and state hurricane evacuation officials, Rogers said.

Valtin, who had questioned the reliability of Simpson's warning system after the meteorologist explained the system to Sanibel officials a month ago, opposed Sanibel's being used as a "guinea pig."

"If the National Hurricane Center really endorses the system as Simpson says, why aren't they testing it themselves?" Valtin asked.

But the majority of the council viewed the experiment as a positive action.

"It will give Sanibel's decision makers, who must decide whether to evacuate a when, a better chance of being right," Councilman Porter Goss said.

Councilman Mike Klein called it a "great opportunity. Any additional information will be a big help to the EPERT team and others who have to make the decisions, he said.

"We could never do any better than Dr. Simpson as a consultant," Klein added.

## Council selects Casa Ybel Road site for city hall

Sanibel's new municipal complex will be built on an eight-acre site on Casa Ybel Road just east of Sanibel Highlands subdivision if last week's City Council decision stands.

Objections from Highlands residents to building the complex near their residential neighborhood have already surfaced.

The undeveloped property owned by Reina Armstrong was the first choice of the three-man City Hall Site Selection Committee.

The City Council enthusiastically endorsed the committee's selection last Tuesday and instructed City Manager Bernie Murphy to immediately begin negotiations for its purchase for \$125,000.

But if a second property on Casa Ybel Road — the 150-acre air strip — were available now, it would have won hands down, Committee Chairman Al Edwards told the council.

The acreage has been offered to the city in exchange for a Transfer of Development Rights, Murphy acknowledged.

Lloyd Sheehan of Naples, owner of the air strip property, has filed a general amendment to Sanibel's land use plan to allow him to use the 24 dwelling units assigned to the

acreage at another location on the island, Murphy said.

"But that is a long process," Murphy said. "At best it might take a year for the city to acquire title."

"With inflation rising at the rate of 1.5 to 2 percent a month, the increase in the cost of construction would eat up the \$125,000 savings," he added.

The council did not discuss the Sheehan proposal.

"I don't want to even mention the name," Mayor Duane White said.

"I want this decision made by us without the slightest cloud on it," Councilman Fred Valtin said.

Councilman Porter Goss raised a more important issue. "Where do we get the \$125,000?"

Murphy said that if payment can be delayed until Oct. 1, "there's no problem. Otherwise it will have to come from Causeway surplus funds."

The Armstrong property was a strong contender from the start, Edwards said, because of its location off Periwinkle Way; its size, which is larger than the minimum

required by the architect; its ecological zone (uplands-wetlands); and its price, which was the lowest of the 11 properties under consideration.

The 8.8-acre Anderson property on Periwinkle Way east of Dunlop Road came in a distant second. The committee used 28

different criteria to rate the entries.

Edwards, with Urban Palmer and Ed Underhill, began the search for an alternate city hall site last March in response to citizens' objections to the council's choice of the city-owned Causeway property.

## Vegetation Recycling Center reopens on trial basis

Sanibel's Vegetation Recycling Center on the Island Inn Road resumed operation last Thursday.

Closed since early April, the center will now be open on Tuesdays and Thursdays from 7:30 a.m. to 3 p.m., Public Works Director Gary Price said. It will be closed Saturdays.

Vegetation that can not be chipped must be deposited in dumpsters at the site, which will entail sorting of vegetation.

The new procedure is being tried on an experimental basis, and the final fate of the recycling center rests on how well it works, Price said.

## Trailer park owners buy Rutland property

The historic "Uncle Clarence" Rutland home has been sold — but not to the city of Sanibel.

The City Council, believing it was to be given "first refusal," was shocked last Tuesday to learn the house and 5.66 acre property had been purchased by the Muench family, owners of the Periwinkle Trailer Park.

Jerry Muench confirmed the sale but said the family would donate to the city one acre of land, fronting on Periwinkle Way, as "an outright gift."

Included in the offer is the house, the garage and two graves on the site, Muench said.

The family hopes to expand the trailer park on the remaining 4½ acres, Muench said, but will need to file a specific amendment to the Comprehensive Land Use Plan to accomplish that objective.

"Your offer is very generous," Mayor Duane White told Muench. "But is it conditional on approval of the specific amendment?"

Muench declared there was "no condition," but added the gift to the city would be a part of the specific amendment.

Charlotte White, chairman of the city's Historical Preservation Society that wants to preserve the house as an historical museum, expressed appreciation for the Muenchs' offer.

"The house is not an architectural gem," she admitted. "But it is a tie to the past, linking the Lighthouse era to the present. We accept and hope to be able to preserve the house as a pioneer museum."

The house was placed on Sanibel's list of historic buildings in 1975.

Frank Joyce, a real estate associate of Executive Service, Inc., in a letter to City Manager Bernie Murphy dated June 4 informed the city that the Rutland home was on the market.

"Since time is of the essence in the sale," Joyce wrote, "I would sincerely hope our City Council would address this at their earliest convenience."

Murphy placed discussion of the offer on the agenda of last Tuesday's council meeting.

The property was listed at \$250,000. Terms were \$100,000 down, with the balance payable monthly over a five-year period at 14 percent interest.

Shortly after the listing was made public a week ago, the Muenches signed a contract for the purchase, Joyce said.

The city's request for first refusal was never acknowledged by Mrs. James Williams, Clarence Rutland's niece, who is handling his affairs, Joyce explained after the sale to Muench was revealed last Tuesday.

"The letter from the city, written last January, is still laying on her TV," Joyce said. Joyce said he personally was "very desirous of the home being preserved as an

historic site."

Councilman Fred Valtin expressed doubt that the property was "affordable by the city."

"It's coming to us as a gift. We should check that and worry about details later," Valtin added.

White said Muench's offer is contingent on action taken by the city on the specific amendment, "and it is not really a gift."

"If we don't get the specific amendment we won't tear the house down, we'll work with the city," Muench promised.

In order to expand the trailer park on the Rutland property the Muenches need a variance for the residential density which currently allows two units to the acre.

## Bids awarded for Island road improvement projects

Bids for the improvement of two busy Sanibel intersections and the construction of a new road that will connect East Gulf Drive with Middle Gulf Drive at Donax were approved by the City Council last week.

Macasphalt, Inc. received the contract to improve the intersection of Ferry Road and Periwinkle Way at a cost of \$32,496.25 and Periwinkle-Causeway Road and Lindgren Boulevard for \$178,443.20.

A contract to build the East Gulf Drive neighborhood access road went to Couch, Inc., who submitted the low bid of \$319,744.81.

Macasphalt's bid for the Ferry Road intersection work, that requires the removal of a large Australian pine tree to straighten the curve, was \$17,179.25 higher than the January estimate made by Howard, Needles, Tammen & Bergendoff, the city's consulting engineers, City Manager Bernie Murphy said.

At that time city crews were scheduled to assist in the work, which reduced the labor cost factor in the project, Murphy said. That is no longer feasible, he added.

Captran has donated \$9,500 for the project, and the remaining \$23,000 will be financed from Weight Fees and Causeway Surplus funds, Murphy said.

Work on the three projects is expected to be completed by Sept. 1, Public Works Director Gary Price said.

Five rights-of-way, dedicated to the city by the Episcopal Theological Seminary, YMCA of Tampa, and John, Sam and Francis Bailey, needed to straighten a jog in the section of the East Gulf Drive connector between Loggerhead Cay and Diboe were accepted by the City Council last Tuesday.

Five other rights-of-way, dedicated previously by the same owners and found to be in the wrong location were vacated by the council action.

## High cost involved halts steamboat renovation

Sanibel City Council last Tuesday balked at the staggering cost of \$443,000 to rehabilitate the steamboat Algiers for public use and ordered its engineering-planning consultants, Gee & Jensen, to stop further work on the study.

The council agreed that it had the answer to its original question regarding whether the former auto ferry, beached along the Gulf near Casa Ybel and converted as a residence for Helen Hooper Brown and her husband, Lathrop, 22 years ago should be saved or demolished.

But Gee & Jensen engineer Paul Carroll's \$150,000 estimate for the cost of demolition was also prohibitive, the council decided.

Carroll said the Algiers "as it is is an unsafe structure."

City Manager Bernie Murphy said the consultants, hired to explore possible use for the structure that Councilman Francis Bailey called "a white elephant," have spent approximately 30 percent of the \$10,000 authorized for the study.

Disturbed by the consultant's progress report, Murphy requested Gee & Jensen on June 10 not to proceed further until the council had reviewed the preliminary findings.

Carroll said cosmetic repairs to the steamboat with no provision for public access would cost an estimated \$39,000.

He said he found severe deterioration of the framing beneath the first deck and deterioration and rusting of the steel frame.

To repair and rehabilitate the first deck area of the boat would cost \$340,000, Carroll said.

Full utilization of the structure with the \$430,000 price tag could include a small conference room, and the 2,600 square-foot enclosed first deck area could be re-

## 'Membership club' underway at Caribe Inn

A membership club being formed at the Caribe Inn, a Gulf beach motel, offers its members pre-paid vacations for 30 years at a one-time fee ranging from \$3,000 to \$6,000 depending on the season.

David Franklin, manager of the Caribe, told the City Council last week the scheme is not time sharing per se.

"We are not selling a specific unit or a specific week but rather guaranteed reservations during one of five seasons," Franklin said.

Planning Director Bruce Rogers agreed that the project does not fit the description of

a time-share estate found in Sec. 3.1.31 of CLUP, and no developments permits are required for a conversion.

"We are still a hotel and have reserved five units that will be available to the public," Franklin said.

The club membership also entitles members to exchange units with time-share complexes in the United States and Europe for an \$38 fee, he said. Each member is assessed \$95 yearly club dues, which may be increased annually using the price index as a base.

The concept is very popular in Europe,

especially in England, where it started in 1948, Franklin said.

The main advantages of the plan, Franklin said, are guaranteed reservations for pre-paid vacations and a hedge for inflation.

The club set-up and membership agreements are under the control of the state attorney general's office and have been approved, Franklin said.

Councilman Fred Valtin expressed concern about consumer protection, the stability and continuity of the present management, and insurance coverage.

Twenty units at the Caribe Inn are being refurbished and re-decorated, Franklin said.

Sales are brisk, he said, adding that he expects to sale more than 500 memberships.

## Two amendments pass; one sent back to commission

Two specific amendments to the Comprehensive Land Use Plan were unanimously approved by the City Council on second reading last Tuesday, but a third was remanded to the Planning Commission for a re-hearing.

Dolph Price's request for a four-foot variance to install a boat davit on the dock at his Shell Harbor home six feet from the property line was unanimously denied by the Planning Commission several weeks ago.

Price was not present to explain his need for the variance from CLUP requirements that stipulate davits must be 10 feet from adjoining property lines.

At last Tuesday's council hearing Steve Beard, an attorney representing Price, explained the elderly man needed the extra room in the canal to maneuver to dock his 19-foot boat.

"It's a safety factor," Beard said.

George Henderson, also representing Price, agreed with Councilman Fred Valtin that "lack of seamanship" was a factor in Price's need for extra room to maneuver.

Because the Planning Commission did not have the benefit of this information when making its decision, the council approved Valtin's motion to continue the hearing and send Price's request back to the commission for another go-round.

Howard Guenther's request to build a

partitioned to provide a large meeting room and several smaller rooms with restroom facilities.

A small portion of the second deck could be allocated for administrative offices. By screening in the remaining portion of the first deck, more than 5,000 square feet of space could be added for outdoor conferences, Carroll said.

To realize the potential for a conference center aboard the Algiers would require extensive structural, electrical and mechanical repairs to bring the facility into conformance with Sanibel's building code, he said, adding that parking facilities for at least 50 cars would be needed.

Before the council makes a final decision

on the fate of the Algiers, it is in the public interest to hold a public hearing, Councilman Fred Valtin said.

A public hearing on the question was set for the July 7 council meeting.

Mayor Duane White said he was not yet ready to abandon ship.

White suggested Gee & Jensen be instructed to prepare the appropriate procedure for demolition and go no further with the study.

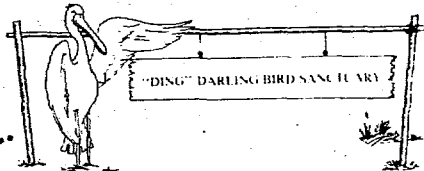
Murphy said that in his experience he has found "wide, wide variations in demolition bids and a lot of variables," and suggested the \$150,000 price tag be tested in the market.

## \$500 cap set for building permits

Building projects valued at less than \$500 no longer require building permits from the city.

The Council unanimously approved on second reading last Tuesday an ordinance raising the value cap from \$100 to \$500.

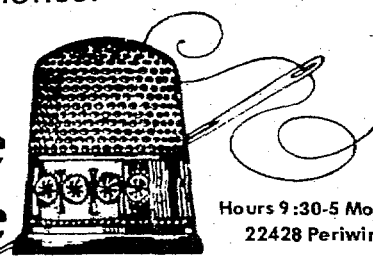

## Commercial moratorium, high impact ordinances set for final hearings

Two general amendments survived first readings last Tuesday, but both need revisions before public hearings and final adoption by the City Council July 7.

A new relief section will be added to the ordinance establishing a commercial moratorium in effect until Sept. 16.

An almost identical ordinance was struck down last February by Circuit Judge Wallace Pack.

Pack's decision last February cited the method by which the city enacted the ordinance. On Feb. 27 the council started the current ordinance on its way by the general amendment route.

Councilmen Porter Goss and Fred Valtin initiated the move Tuesday to revise the relief route that now requires an applicant to

prove "untenable hardship to the land."

"We know from practical experience that is impossible," Valtin said.

Goss said there "should be more latitude and a less cumbersome way to obtain relief."

Mayor Duane White pointed out that "this is standard procedure in adopting moratorium ordinances. No relief is necessary."

The council agreed to add a new paragraph that will grant relief from the freeze on construction to commercial development that conforms to all the current provisions and performance standards of the Comprehensive Land Use Plan.

City Attorney Neal Bowen shot down Saul Goodman's suggestion that conversions to

interval ownership projects should be subject to the moratorium.

"They're really big business," he said.

But Bowen said time sharing units are classified as resort use, and their addition would require a title change and "starting the ordinance all over."

A second general amendment adds single-family units rented for less than a 30-day period to the units of high impact category.

A difference of opinion on the definition of the time period the units can be rented resulted in two drafts of the ordinance.

Both were passed on first reading and the decision deferred until July 7.

The first draft, recommended for council approval by the Planning Commission, defined the rental time period as "one month

or less."

A second draft proposed by Councilman Mike Klein uses the wording "less than one calendar month."

Klein said the first version might inconvenience motel and hotel owners by making booking changes mandatory.

Other council members said the impact might make it illegal for owners of single family homes to let other family members or relatives occupy their homes for periods of less than one month.

Planning Director Bruce Rogers said the ordinance was initiated by Planning Commissioner Bill Hagerup to correct abuses created by renting single-family homes in the Gulf Pines subdivision.

Associate Planner Bob Duane said a number of units outside the resort area are rented for less than 30 days, which is a violation of the permitted uses in the land use plan.

"It's very hard to administer," he added.

George Christensen said there are these same type of abuses in Gumbo Limbo, which is also in violation of the subdivision's deed restrictions.

Ray Pavelka, development director for Mariner Properties, said, "There are already laws on the books that are not enforced but that can be looked to when needed."

"We enforce them on complaint," City Manager Bernie Murphy said. "But we're not running around counting heads."

The council appealed to the planning staff for help with the verbiage before the second reading in July.

bathroom on the ground floor of his piling home in Tahiti Shores received council approval.

But the council included Planning Commission conditions that the structure must be free standing, below the main structure but not attached to it.

Guenther had agreed to the restrictions because he said his wife's physical demands require that bathroom facilities are available on the ground level.

The land use plan defines a floor with a bathroom as "habitable." Flood proofing regulations prohibit use of the ground level as a habitable floor.

The Planning Commission had recommended approval despite the planning

staff's recommendation for denial.

Planning Director Bruce Rogers said the council's action to approve might be a signal to others in similar circumstances to seek relief by the specific amendment route.

He acknowledged the bathroom variance would have "no effect on the city's subsidized flood insurance program."

Councilman Fred Valtin opposed the "bathroom ordinance."

Councilman Porter Goss said the ordinance would be reassessed during the Five Year Review of the Hazard Mitigation element of CLUP.

"A distinction should be made between piling homes in the V zone and those in the A zone," Goss said.

Developer Dean Mitchell, a Sanibel property owner for 56 years, last Tuesday won council approval for the development of six single-family lots in Castaways Estates.

Mitchell needed a specific amendment to the residential densities requirement of the land use plan to develop his property in the Blind Pass area where only one unit per acre is permitted.

Mitchell's original eight lots were reduced to six buildable lots by combining three lots on the San-Cap Road and three lots on Dinkins Bayou into two one-acre lots.

Four other lots, each with more than 19,000 square feet, are buildable under the council-approved variance.

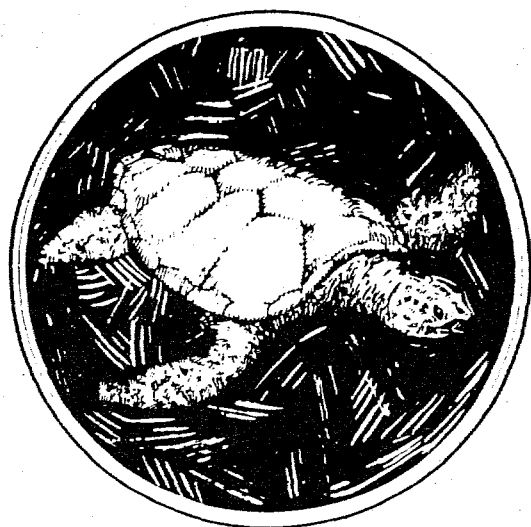

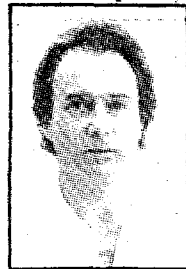

the county for use on Captiva, and the remaining 40 percent would go toward refunding the bonds necessary to purchase the property.

The commission is anxious to sell the causeway property because it would add approximately \$16 million to county coffers for road projects throughout the county, Rodda said.

Because of a Florida Supreme Court decision on the revenue generated by the \$3 toll, the county can only use causeway revenue to repair roads that carry causeway-bound traffic.

The courts were not as strict regarding how funds from the toll could be used on the Island, Rodda explained, adding that purchase of the property "would carry definite advantages for Sanibel."

Part of the county's decision to offer the

causeway to Sanibel was based on the county's cursory analysis of the city's financial situation.

"We felt an obligation to look at Sanibel's financial picture," Rodda said. "We found that the city could purchase the causeway without having to go for a general obligation bond."

Purchase without such a bond issue, however, would require a toll increase, he added.

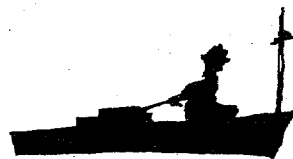
Rodda said the city would be responsible for conducting its own financial study to determine the feasibility of purchasing the causeway. "It's up to the city now," he said. He added that the county should stay out of negotiations with the city regarding causeway traffic until the purchase issue is decided.

The Sanibel Causeway will be closed for repairs to the drawbridge from midnight to 6 a.m. Sunday, June 28 through Wednesday, July 1, Causeway Manager Fred Lescher said last week.

Repairs are necessary on the gears of the drawbridge, Lescher said.

The causeway will be closed to all vehicular traffic between midnight and 6 a.m. during the four days indicated.

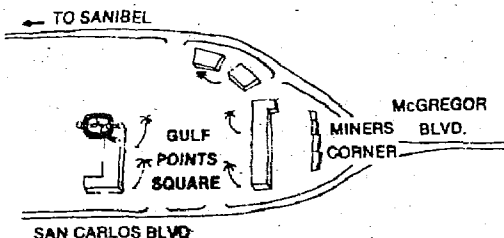

# On the water

These June days will go into the books as being some of the hottest on record, and more than once you will hear someone ask, "What's all this heat going to do to the fishing?"

If you are a trout fisherman who gets up about eight, down to the boat by nine and fishes until lunch, then you probably have seen your last fish until the weather cools in autumn.

Trout and several other kinds of fish are sensitive to heat and the associated light that comes with a high, hot sun in the sky. I can't think of a fish that bites better in the middle of the day than in the cooler times.

So how does this affect your fishing?

First, if you are out for fish and you want to work in the daytime hours, you are going to have to be on the fishing spots by dawn. Many of our fish, including snook, tarpon, trout, redfish and whiting, become more active an hour or so before, and for a couple of hours after, the sunrise.

If you are an old fresh water bass fisherman, you probably know all about getting up early to try and catch a fish that is also harder to catch once the sun is up.

The same goes for saltwater fish to some extent. Now, the tides can enter into the problem, and if there is a dead water low tide at dawn, don't expect to knock them dead as opposed to a high tide time.

Lots of anglers just aren't going to get out of bed before dawn on their vacation to chase fish, so they wait for the other end of the scale — sunset — to fish. By this time of the day, the winds have usually calmed and the temperatures dropped a bit, and often the fish do strike better than a few hours before when it was hot and cloudless.

The last option, of course, is night fishing. One of the guides told me once that it's a time when fishing is easier, less crowded certainly, and better. Only trouble is, in hot weather it's sometimes midnight before it cools down enough to be pleasant, and those of us who work probably wouldn't be worth much the next day after starting to fish at midnight.

There are a lot of good things to be said for night fishing however. Where in some spots during the day you see 20 boats, now you see two. And, should you find a good hole for

fishing, you can be fairly sure you won't come back the next night and find it's been "discovered."

There are little things to make night fishing more difficult. One is if you are buying your bait, you are out of luck if you run out after around 8 p.m., when most marinas close for the day.

At times, the smallest tasks get to be major problems when night angling. One is to tie a leader — ever try holding a flash light in your mouth while you tie a leader? Or ever try to take a frisky catfish off the hook in the dark?

Some night fishermen have this worked out, naturally, but for the occasional fisherman, that big light bulb in the sky is surely missed when things go wrong — like when that sand bar you thought your boat could skirt suddenly finds the prop of your boat.

Fishing in the middle of the night is difficult, but I have seen some fine snook taken then and other fish, too.

It's more pleasant to work during the cooler time of the day, and really, fishing for fun and pleasure is what it is supposed to be all about — isn't it?

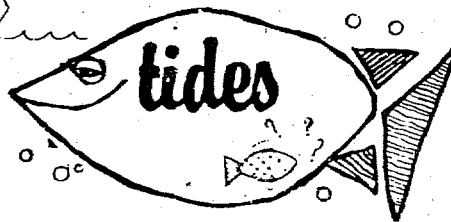
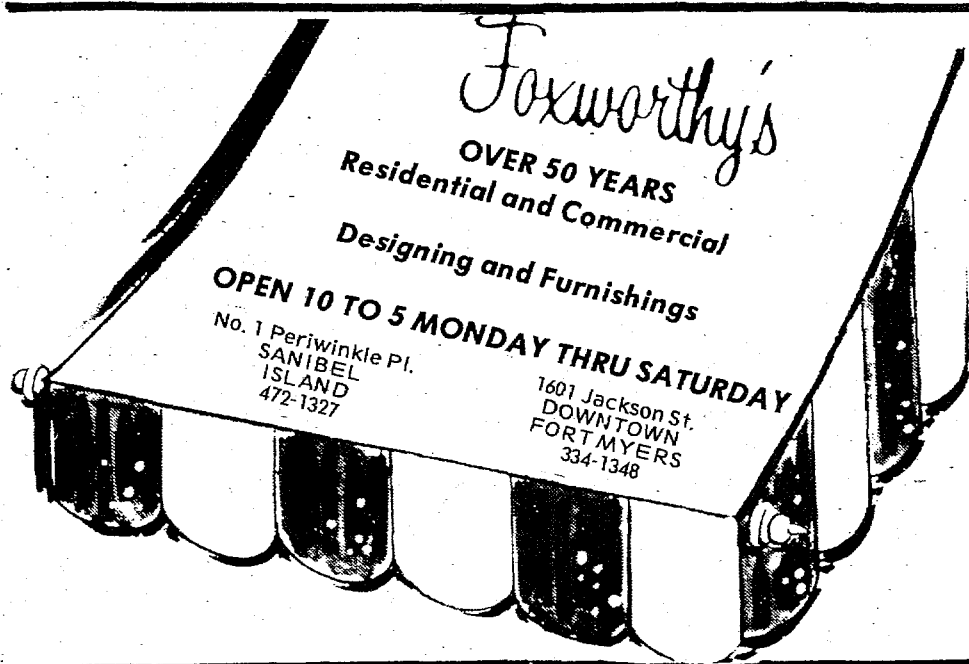

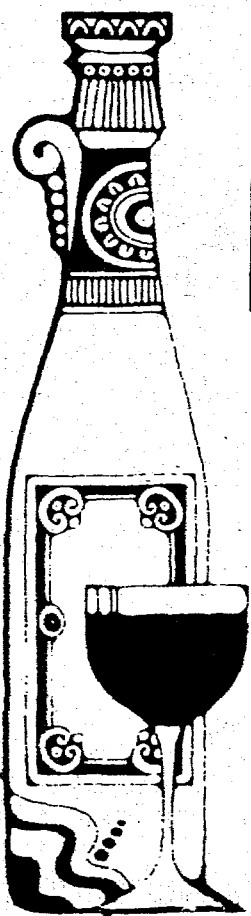

# Shelling Tips

I can't help but be amazed at the toughness of many of our shells found along Sanibel and Captiva Islands. And at the same time, there are others, big and colorful, that are crushable in one's hands.

The other day I was searching along a shell line and noticed a very colorful, large fighting conch. As with many shells, when I bent over to pick it up, I could see that it was broken.

That's going to happen often enough, but as I examined the conch, I noticed that it had broken in nearly a perfect cut, almost as if someone had taken a saw and made a clean cut to make the edges neat and trim.

Can you imagine the force it must take to break a hearty shell like that?

I got to thinking that so many of our shells arrive at the beach broken, the victim of a collision between other shells, or perhaps rocks along the shore. I took that conch and with a hard throw slammed it down on the beach sand. Nothing happened. Not even a chip came off that already broken shell. More evidence of the violent tumbings that must take place to cause the kind of breaks found in many shells.

Then there is the other side of the shell, er... coin, and that's the highly breakable shells.

Surely, we all have found our limit of "nearly" perfect shells. That Scotch bonnet with just a chip out of the top, or three-quarters of an otherwise perfect sand dollar.

Some larger shells, the angel wing for instance, can range up to six or more inches when a mature adult, but in the years that it was growing, its shell never became layered for strength. Consequently, the full grown angel wing shell could easily be broken by a child's hand.

Shells that are larger usually have a heavy outer protective covering, but one of my favorites, the paper fig, is another which easily breaks in the surf and somehow occasionally gets washed up in perfect shape.

Paper figs look much like whelks, but as per the name, the shell is light and fragile. A large paper fig might be five inches tall, and how it ever gets to the beach in one piece is somewhat of a miracle considering all the rolling and tumbling it must go through.

And then there are some shells that look just as if they could go through about any pounding surf and come out as good as ever.

One that always remains in good condition it seems is the nutmeg. These shells average about an inch or so tall. They are roundish, colored white, with spots of brown. They are

more apt to roll than offer resistance and be broken, I would guess.

The lettered olive shell is in the same category of "survivor" shells. I've seen some very good olives wash up on the beaches in the most violent winter storms and still be in perfect shape. Of course, you will find many olives that get dashed too. But overall, the olive, like other roundish shells, often comes up in numbers and in great condition.

While some shells get the easy life on the bottom of the Gulf or sound, there are also the poor old sea urchins and pen shells, which always seem to get the worst end of the deal when it comes to rough weather beach landings.

Urchins lose footing and get tumbled upon the beach, often in great quantities. The birds quickly find them and eat the meat inside, at the same time usually ruining the shell remains for collectors.

And the lowly pen shell, that ice cream cone-shaped brown shell, is another of the not-too-lucky shells that often gets piled up on the beach, broken beyond use for a collection. Both of these shells are light "skinned" creatures and don't take a beating very well when it comes to shell vs. beach.

Good shelling out there this week.

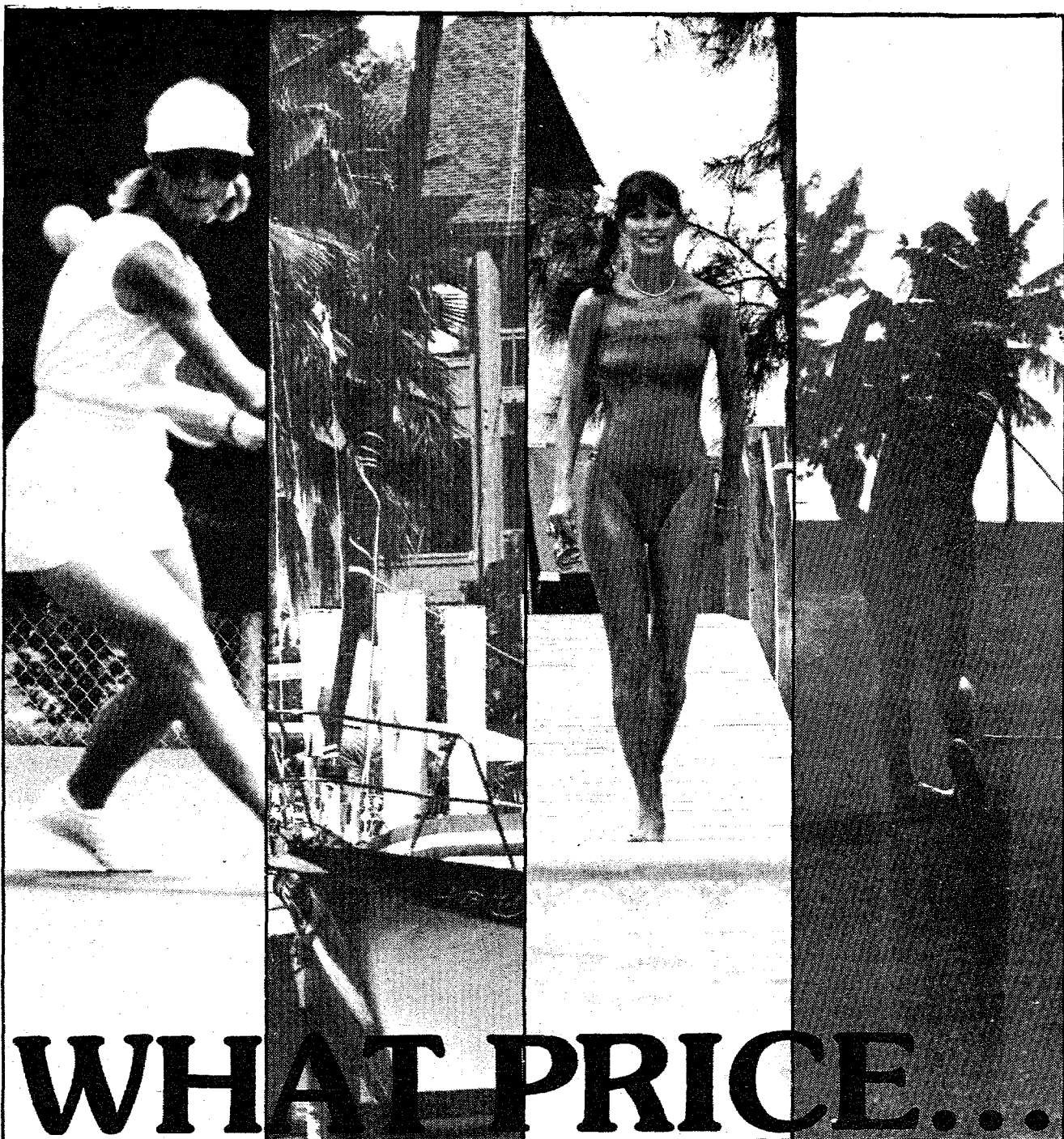

## Co-op customers face darkness, heat without power

sweltering consumers on the Gulf Drive circuit, darkening homes for several hours on Saturday evening, June 13 and again on June 14.

It was not until Monday when linemen, inspecting the circuit inch by inch, climbing each pole along the line, found the trouble, Christensen said.

The excessive high temperatures that weekend along with a possible overload on the circuit caused one of the three live lines on the pole to overheat and sag, she explained.

The line sagged enough to come in contact with a fourth neutral line on the pole beneath it and shorted out. The wires burned, and the circuit breaker at the substation on the San-Cap Road opened, shutting off the power along the whole circuit.

When the demand stopped, the line cooled off and returned to its original position, Christensen said.

"That's why the linemen had such a hard

time locating it over the weekend," she explained.

A consumer who lives near the American Legion reported seeing a blue flash caused by the shorted wires, which helped the co-op locate the trouble, she added.

Though over-loading was not thought to be part of the problem at first, Christensen said that a demand measurement taken at 5:50 p.m. June 15 showed the Gulf Drive circuit was overloaded by 39 percent.

"Until the third feeder line on Sanibel is built, we will most likely continue to have these problems," she pointed out.

The controversy with some Sanibel consumers who object to the route along which the Co-op prefers to install the new line has delayed its start, Christensen said.

"We had hoped to begin construction by May. This is the best time of year to do that kind of work," she said. Once started it will take about 90 days to install the line, she added.

## Storms bring high winds, rain

Mother Nature wreaked havoc on the Islands last Wednesday and Thursday in the form of electrical, wind and rain storms.

Unofficial estimates from Islanders put Thursday's winds in excess of 55 mph. Sanibel-Captiva Chamber of Commerce Executive Director Walter Klie said 1.28 inches of rain fell during the storm.

No official storm statistics for the Islands were available from the Fort Myers office of the National Weather Service, which does not maintain equipment on the Island.

The storms kept local Police and Fire officials, United Telephone System and Lee County Electric Co-op crews busy through the nights answering calls about downed power lines, exploding transformers, one beached sailboat and a missing pick-up truck camper.

Wednesday evening's electrical storm set ablaze a cabbage palm tree next to the Black Pearl shop on Periwinkle Way. The fire destroyed the tree and scorched the side of the Black Pearl building.

Thursday's storm kept the Police Department switchboard flashing almost non-stop between 5:45 and 7:30 p.m.

Two additional sworn police officers and two auxiliary officers were called in to help with activity during and after the storm.

Kirsten Wilson of Fort Myers reported high winds lifted the camper off the truck she was driving as she crossed the causeway at the peak of the storm Thursday.

Police could find no sign of the missing camper.

Officer Mike Blackmore found a sailboat aground at Mariner Pointe Beach, and the Mariner Pointe Condominiums reported numerous shingles and wind turbines blown from roofs.

Trees fell and blocked traffic on several Sanibel streets during the storm, as did electric and television cable lines.

Areas of the Rocks west of Tarpon Bay Road were without power for five hours from 6:15 to 11:20 p.m.

The Sanibel Fire Department answered calls of blown transformers and smoking air conditioners that apparently overloaded when power returned to the circuits.

Vince Vecciarelli of the National Weather Service in Fort Myers said the rain and high winds did not affect most areas of Lee County.

"It looks like you were the one to get the worst of it," Vecciarelli said. "We only had a trace of rainfall at the airport and no winds anywhere near what the Island has reported."

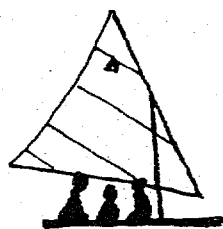

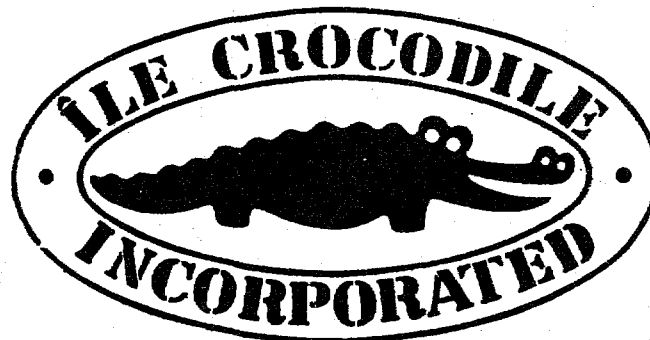

# 1981 summer heat follows record-setting winter pattern

No doubt everyone would have welcomed a "Nestea plunge" everyday last week during the Islands' unprecedented hot spell.

The highest temperature recorded on Sanibel last week was a whopping 99 degrees on the 13th. Coupled with a steaming humidity factor, Sanibel and Captiva were pushed into an almost unbearable temperature range.

Wilted Islanders and visitors neared the melting point within seconds of stepping outdoors.

Air conditioned businesses, homes and cars offered the only relief from the relentless heat. Even a dip in the pool or Gulf was like going into a sauna bath.

According to Jim Reif, chief meteorologist at WINK-TV, the normal highs for June are near 90 degrees with the normal lows in the

low 70s.

But 1981 continues to follow a trail of record weather started with unseasonable lows this winter. So far this summer, temperatures are seven to eight degrees above normal, Reif said.

For the first 19 days of June this year, average temperatures for Southwest Florida reached 97.8 degrees with the average lows dropping only to 77.6 degrees, he said.

June's average high temperature for the Islands is 96.7 degrees with an average low of 78.3. Surf temperatures range from 85 to 90 degrees.

Vince Vecciarelli, chief spokesman for the National Weather Service, explained that the heat wave was influenced by a high pressure ridge over the southern coast.

There have been no clouds, no thun-

derstorms and nothing to prevent the sun from beating down, which ultimately caused temperatures to soar, Vecciarelli added.

The raging storm which hit Sanibel and the neighboring vicinity last Thursday night was the needed break in that high pressure system, both weathermen agreed.

"We should go back to the normal June pattern," Vecciarelli said after the storm.

However, Reif said, the thermometers won't magically go back to temperatures in the low 90s but should stay around the mid to upper 90s.

**JANIATA VALLEY** Virginia Cassel. The story is concerned with the fates of five families homesteading in western Pennsylvania during the French and Indian War.

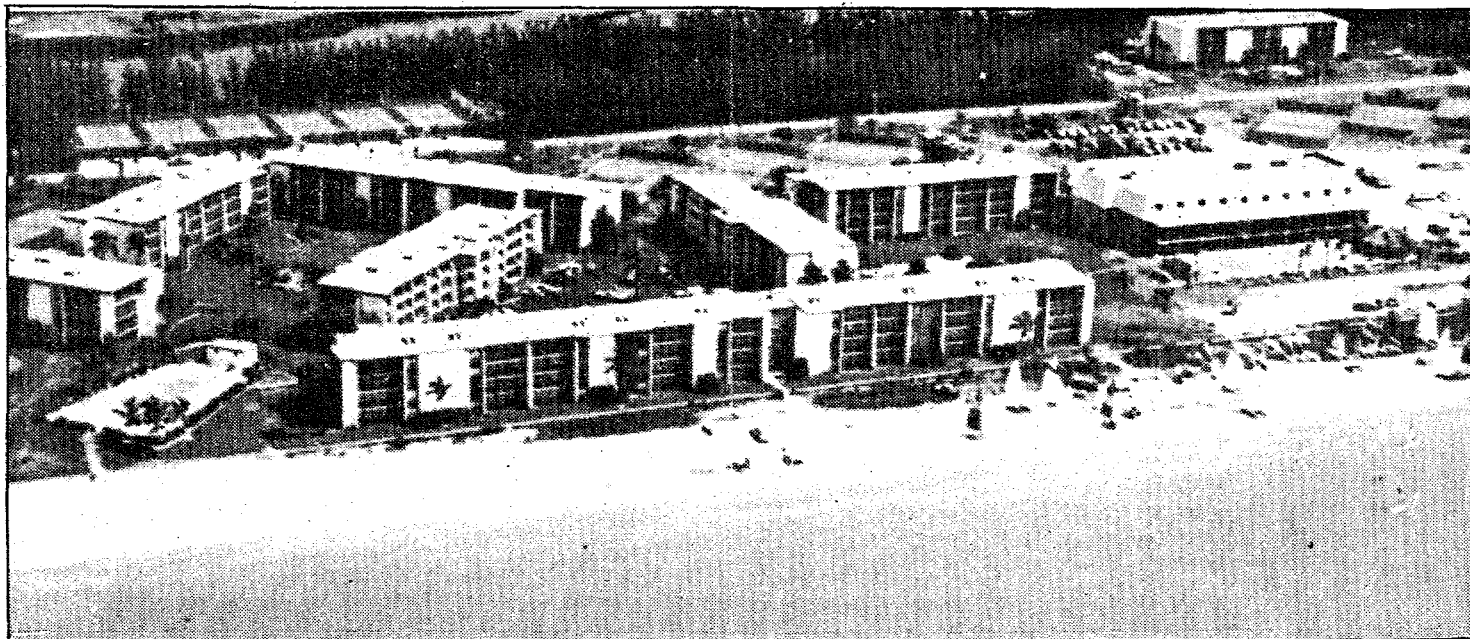

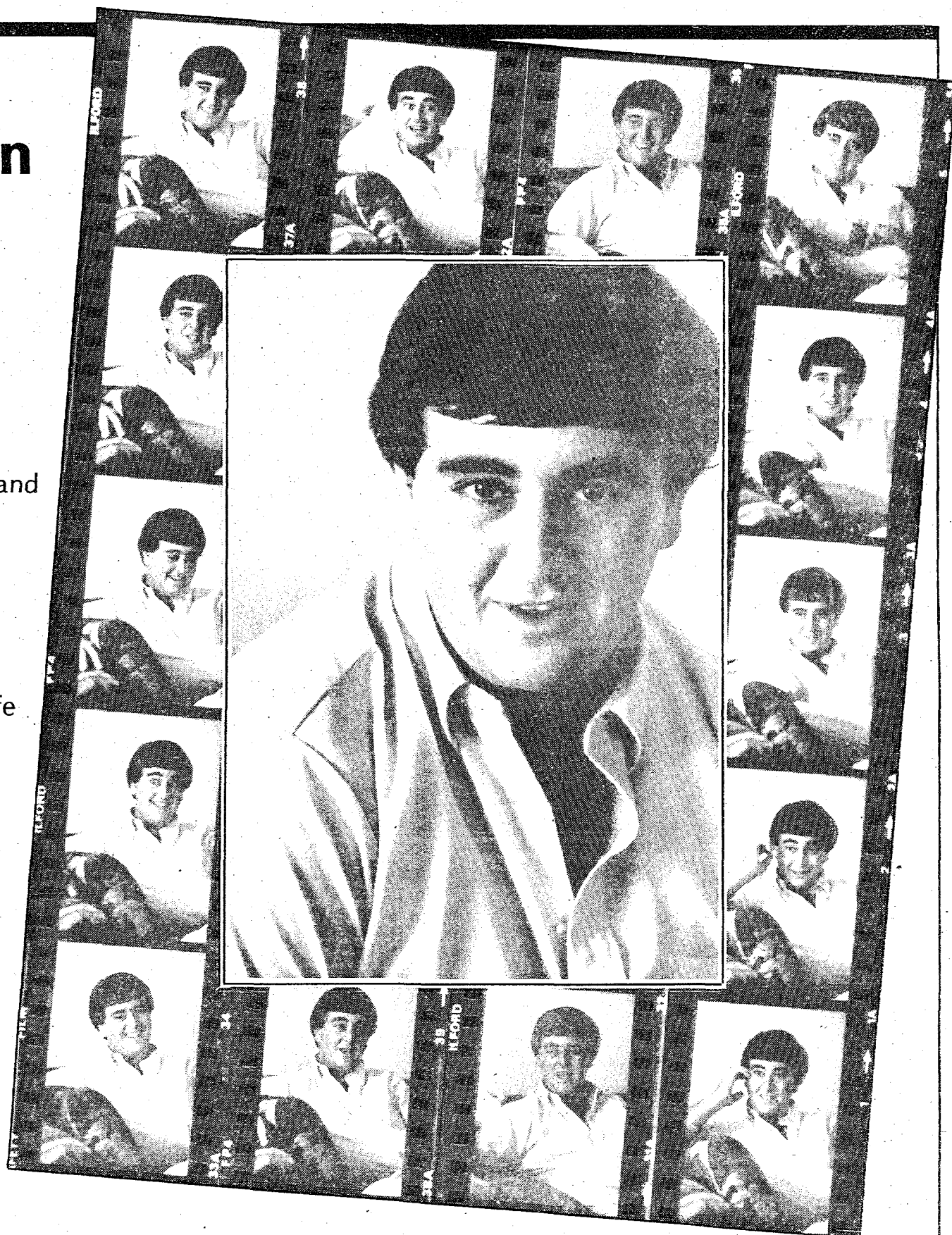

"Good evening and welcome to the Mucky Duck.

"Our menu opens to the left and reads to the right tonight's special glistens with an effervescent taste titillating palate pleasing mouth watering steamed shrimp whatever the fish whatever the price tonight is broiled red snapper don't forget to eat your vegetables what's this red light on my collar? it's my b.s. light and it just lit up when you walked in listen I gotta go I'm nervous talking to strangers."

In a matter of seconds, without a break for air, Victor Mayeron delivers his scintillating spiel and leaves only the patrons at Captiva's Mucky Duck English Pub breathless and dizzy.

The spiel varies slightly from table to table, just enough to convince each customer he is the sole benefactor of an original, ad-libbed recitation.

The unconventional welcome and accompanying sidebars that spike every diner's evening at the Mucky Duck are all a part of Victor's philosophy that concentrates on happiness -- not just the customer's happiness, but Victor's and all his employees' happiness, too.

"The restaurant business is the best business in the world," he says. "Where else could you meet so many people and talk with them one-to-one?"

"If I didn't enjoy it as much as I do," he adds, "I wouldn't be here." Victor has been at the Mucky Duck for five years. His father, Don Mayeron, and the Mucky Duck chef, Andreas Bieri, co-own the restaurant that Victor manages. Victor is obviously in his element as he sashays between

busy tables and chatters endlessly to his customers.

"I had a pair of pants just like that once," he remembers telling a tourist in polyester slacks covered with nautical signs. "My wife made me wash the car with them."

Then there's the time he described the evening special as "hair-raising" and used a bald customer as living testimony.

He once offered to pick up the tab and even throw in Mucky Duck t-shirts for everyone in exchange for "just one" of the Rolex watches on the wrists of everyone at a table of "wealthy Texans."

Few people take offense at Victor's endless brazen humor, which he says simply helps him maintain control over crowds of hungry or hot (or both) tourists and locals alike. "It's all a show," he says.

When he finds himself being a bit too sarcastic, he makes an effort to tone things down. But once they get used to it, most customers welcome Victor's guff as part of an evening at the Mucky Duck.

Restaurants have been Victor's life blood since he was 13, when he spent 11 weeks working in a summer camp kitchen.

"We served 450 kids three meals a day," he said. "I did everything in the kitchen -- all for \$200 for the whole 11 weeks."

The fact that he stayed in the restaurant business from that day on and earned a degree in hospitality administration ("I did work on a golf course for three days once," he admits), is evidence enough that Victor belongs in the business.

Perhaps the only place where Victor is more in his element than at "The Duck" is in the Island home he has made with his wife, Kathy, and their daughter, Jessica -- and even the young family's history is colored with shades of "the Duck."

Victor and Kathy met at the restaurant one evening 3 1/2 years ago when Kathy was visiting the Island from Ontario, Canada.

Victor proposed before that first evening ended, and they were married less than a year later.

Kathy caught "the Duck" fever and waited on tables at the restaurant even through her pregnancy last year. And when Jessica was born, Victor remembers, the doctor announced, "It's a waitress!"

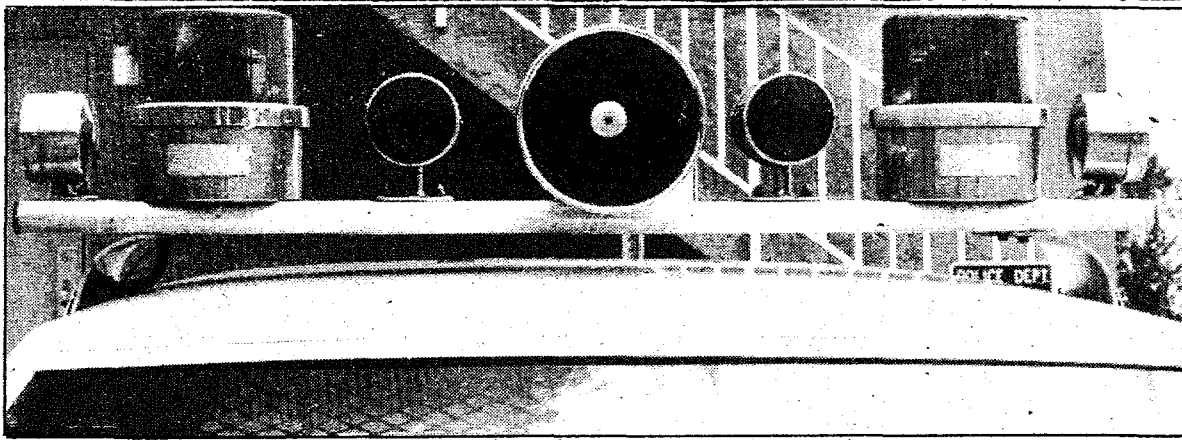
Jessica is the prime focus of Victor and Kathy's life now, and she has already been introduced to the Mucky Duck scene.

"I take her in and announce (rather loudly, no doubt) 'Wow, Jessica -- just look at all these grandmothers!' Of course they all want to see her," the proud father says unabashedly. "Then we go into seventh heaven."

Seventh heaven seems to be a state of being for Victor these days. Does he expect it to remain? "I don't see why it should ever stop being fun," he says matter-of-factly.

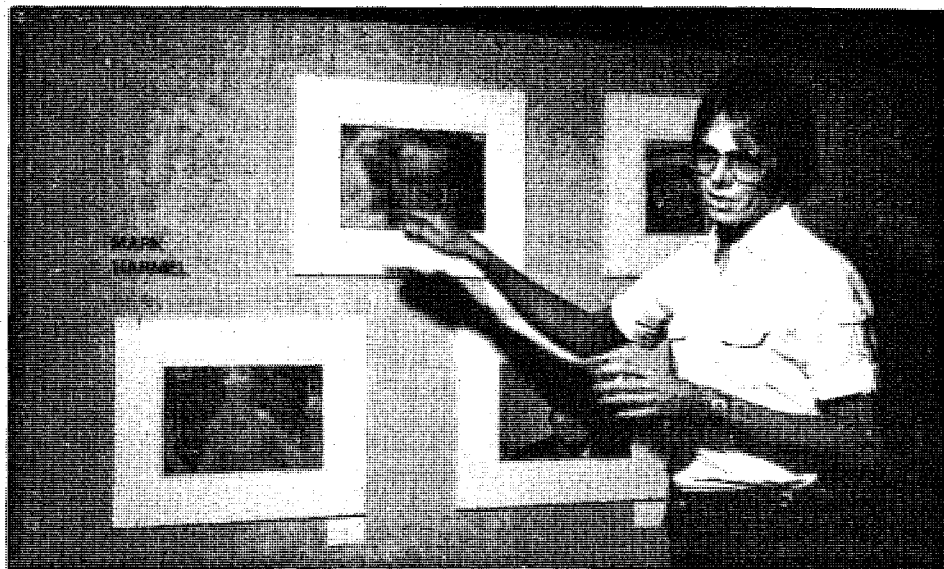


## Mark Harmel's exhibit opens at Photographers' Gallery

### Warning of Causeway acquisition

To the Editor:

Sanibel's taxpayers must now make a crucial decision about their City's future. It is: Do we want to go into hock to become the foremost collector of "Monstrous White Elephants?"

Thus far, the City has established itself as a leading contender. It has blithely assumed the costs and-or responsibility for: the "Algiers" steamboat property; the Causeway Road property; the County's San-Cap Road that serves well Captiva; the County's parking and restroom facilities at Bowman's Beach Road access; parking and beach access facilities at Tarpon Road, Lighthouse, Dixie Beach and similar locations; and the County-School Board pool and recreation program at the school grounds.

It is no wonder that our County Commissioners view us as the "Millionaire's Island!" Of course we can afford the maximum Dual Taxation levy to carry on our backs the County treasury's property tax load -- as well as Sanibel's!

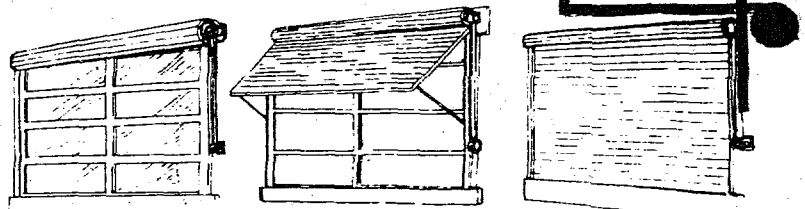

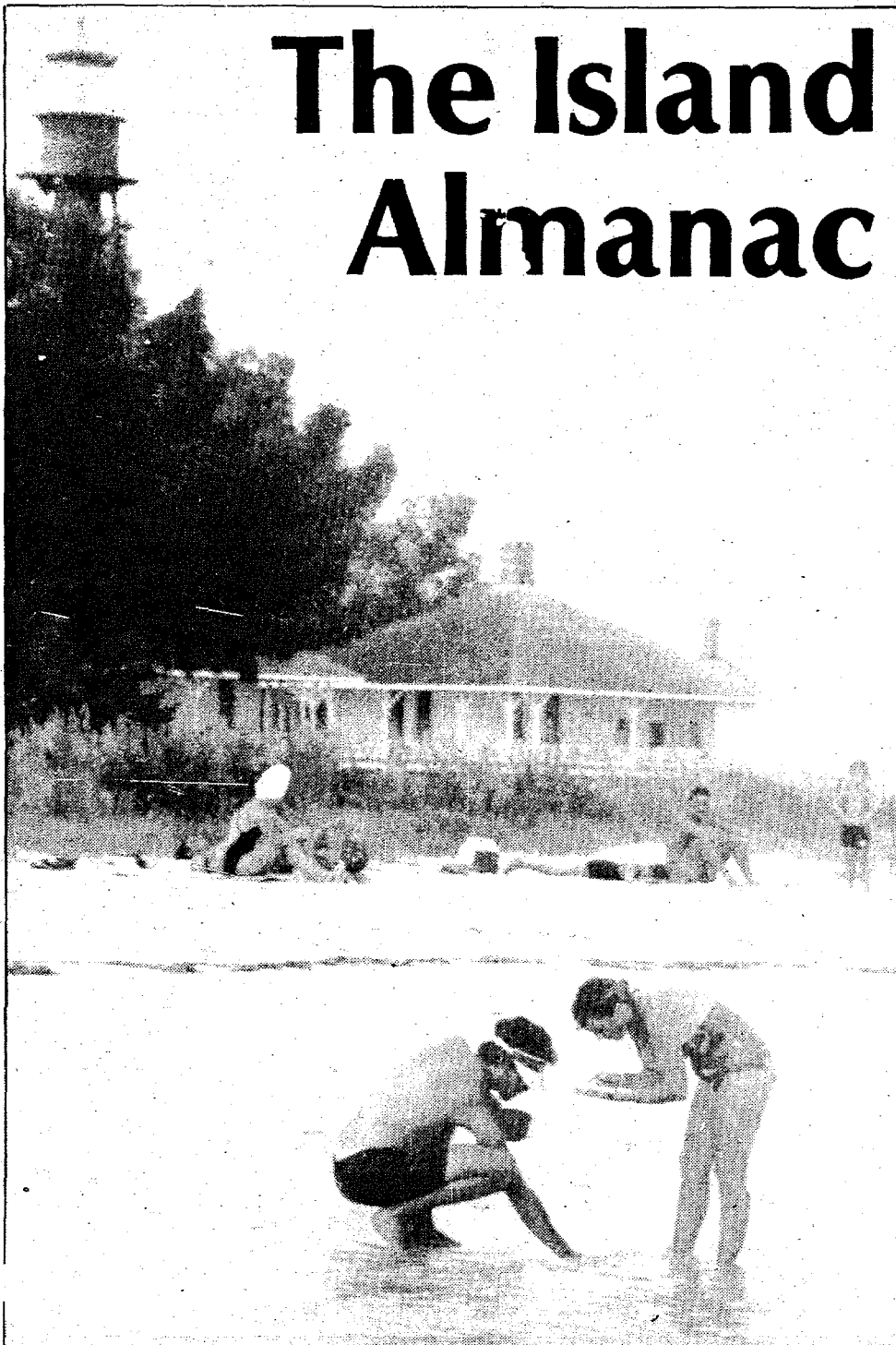

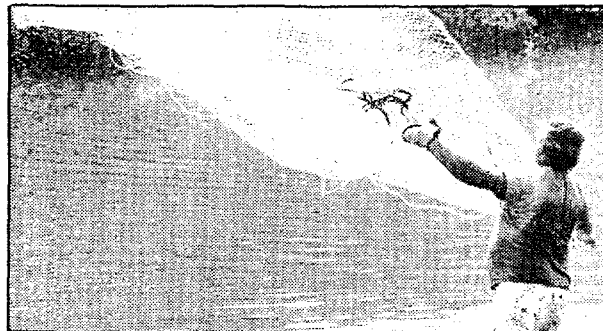

A left on Tarpon Bay Road takes the visitor past Sanibel's original schoolhouse, which now holds original island watercolors and woodcuts. Then on to West Gulf Drive and westward to an interesting little artisan's

shop and gallery.

At the intersection of Periwinkle Way and Tarpon Bay Road, you may choose instead to turn right and follow the signs to the Tarpon Bay Marina, where you will find a cluster of quaint shops overlooming the back bay...Some antiques, shells and shellcrafts, what-nots and clever clothes can be found here, as well as a great seafood sandwich and soft drinks.

The spectacular ride to Captiva, with its lush foliage and enchanting view of the Gulf, is well worth a day's outing. Talented artists display their works in one roadside shop, while others feature some nifty gifts for Grandma to take home to little hands as a pleasant hodge-podge of remembrances from these barrier islands.

Whether for shopping, or merely browsing, island shops offer a surprising variety - from one-of-a-kind collectibles for the discerning shopper to postcards for the simple souvenir hunter and of course, for all, shells, shell jewelry, shell lamps, just plain shells...the most beautiful shells in the world from the most beautiful shelling beaches in the world.

## BEACH ACCESS

Sanibel has miles of public Gulf-front beaches, any one of which is only minutes from your lodging. Lighthouse Point is a stretch of Federal land on the Eastern tip of Sanibel Island, and from there, the Gulf beach is accessible again at the end of Donax Street, at Tarpon Bay Road, at Bowman's Beach Road (off Sanibel-Captiva Road) and Turner's Beach, which is located at Blind Pass, between Sanibel and Captiva Islands.

On Captiva Island, public beach access can be found at Turner Beach (which has public facilities) or further north, just past the entrance to South Seas Plantation.

**NOTE: STATE LAW PROHIBITS NUDE SUN-BATHING ON ALL FLORIDA BEACHES. VIOLATORS WILL BE PROSECUTED.**

## CAMPING

Camping on the beach is prohibited and while everyone enjoys a beach fire, the Sanibel Fire Board has signed into law an ordinance prohibiting open beach fires. Prior to the ordinance, a permit was necessary for a beach bonfire, but as of July 18, 1980, it is now illegal. An exemption to the ordinance is a fire in an approved cooking container (not to exceed 48" X 24" X 12" deep with an extruded metal grill) for non-commercial food preparation. This type of container will be allowed on the beach without a permit. After you have had your beach party, it is recommended that you assume the responsibility for the cleanup of any debris or litter in your area.

## GATORS

Feeding alligators anywhere within the Sanibel City limits is not only illegal (violators of the law are subject to a fine of up to \$500, or up to 60 days in jail, or both), but can be extremely dangerous. Alligators can run 45 m.p.h., so if you're close enough to feed an alligator, he's close enough to feed on you. An alligator fed for fun loses his natural fear of humans and becomes a potential threat to children and pets.

## WARNING! SAFEGUARD YOUR VALUABLES.

In order to protect your valuable possessions from theft, it is recommended that you TAKE THEM TO A BANK OR HOTEL VAULT FOR SAFEKEEPING. Do NOT leave them in your room or car.

## SPEED LIMITS

There are varying speed limits (20-30 m.p.h.) as one comes across the causeway, and there is a very good reason for them...to preserve the bridge supports from strain and stress. This speed limit is strictly enforced with the use of radar on a 24-hour basis by both the Sanibel Police Department and the Lee

## County Sheriff's Department.

Driving or parking a motor vehicle or moped on the bike path is strictly prohibited. Violators will be ticketed.

Under Florida law, bicycle riders have the same rights and responsibilities as motor vehicle drivers. Drive Safely!
