


A Gainesville lawyer with extensive experience in zoning and land use regulations and litigation will take over as Sanibel's city attorney on Feb. 7.


Before David La Croix comes on board, however, Neal Bowen, who served in the post for almost seven years, will depart for

### Goss appointment made official

Former Sanibel Mayor Porter Goss' appointment to the Lee County Commission became official last Thursday just in time for Goss to participate in the regular meeting of the Metropolitan Planning Organization.

Goss was named a week ago by Gov. Bob Graham to fill the commission seat vacated by the suspension of Com-

Daytona Beach. There he will join as an associate Cobb and Cole, a governmental law firm that has a state-wide practice.

"It's a tremendous opportunity," says Bowen, who during his tenure has successfully defended several challenges to the city's landmark land use plan. He will work closely with State Representative Sam Bell, who is also an associate in the firm's governmental law section.

Bowen earlier agreed to stay on with the city on a week-to-week basis until his replacement would be available. But last Tuesday he alerted the council that would




## Driftwood sessions yield crafts for upcoming show



### Power outage hits Islands

The lights were out on Sanibel and Captiva for 40 minutes last Wednesday night in the first major power outage of 1983.

The outage occurred when a lightning arrestor exploded and put the Lee County Electric Cooperative's transmission station in North Fort Myers out of commission. Jim Reed, the co-op's director of communications, said the power failure affected more than 17,000 customers on Sanibel and Captiva Islands, Pine Island, Cape Coral, parts of Burnt Store and North Fort Myers.

The outage began at 10.56 p.m. and power was restored at 11.32 p.m., Reed said.




Homer Workman of Lake Road South died on Monday, Jan. 17, 1983. He was 77. He moved to the Island 10 years ago from Charleston, W.V.

The toll rate for commuters on the Sanibel Causeway will be reduced effective March 1 from \$20 per book to \$15. The tourist or single trip rate will remain the same.







# Howe reconsiders amendment to proposed shelling ordinance

A copy of the following letter to the Sanibel City Council was given to The Islander for publication Dear Councilmen,

My Dec. 30, 1982, memorandum on the live shelling ordinance proposed amending section 2 of the ordinance by inserting after the word "take" the words "or possess."

After meaningful discussions with seasoned members of the Sanibel-Captiva Shell Club, I have concluded that the word "possess" might seriously inhibit desirable research and study of live shells by students of the Sanibel Elementary School and others in higher schools as well as recognized malacologists specializing in Sanibel shells.

I recommend, therefore, that the word "possess" not be used. The word "taken" suffices.

Insofar as the word "transport" is concerned, I recommend that a modest licensing system be adopted to authorize the transport of live shells for such study purposes and for shells that have not been "taken" on Sanibel.

The city's Live Shelling Committee might be continued as a standing committee to provide recommendations to the city manager on applicants for live-shell transportation licenses.

My findings also support the desirability of an annual review by City Council of the need for amending or continuing the ordinance.



# Council balks at paying for vegetation buffer on private property

The City Council faced a dilemma last Tuesday. The councilmen were in accord that they must live up to an agreement made with Stanley Johnson to exempt the new parking lot at the rear of the Priscilla Murphy Realty office on Causeway Road from vegetation buffering requirements.

Tuesday, January 25, 1983

The city had agreed to install the necessary buffers on the city's side of the north and south property line with each party contributing \$500 to purchase the plantings.

The deal was negotiated as a condition of the city's purchase of property needed to connect two other city-owned parcels on Causeway Road.

But the council balked at paying for a 10foot vegetation buffer at the front of the realty office on Johnson's land.

The Planning Commission insisted on the buffer to screen the complex from Causeway Road at the time it recommended courcil approval of the specific amendment excluding Johnson from the vegetation requirements.

Assistant City Manager Gary Price clouded the issue further last Tuesday when he revealed, "There is no way I can buffer even the two side property lines for \$1,000." The project would cost closer to \$5,000, he added.

City Manager Bernie Murphy said in any

event he cannot ask Johnson to put up more money. "And I have a real problem in using taxpayers money to beautify private property," he said.

"We negotiated in good faith with Johnson and and as a part of the deal made the concessions to plant the buffers on city land because there was no room on Johnson's side," Murphy said.

The council agreed to the compromise in order to finalize the purchase of the land at a very good price, he added.

Councilman Louise Johnson pointed out that the city has "a responsibility to abide by its own standards."

Some councilmen were puzzled why the vegetation buffer on Causeway Road was not required when Johnson's development permit for expansion of the Causeway office was approved several months ago.

Planner Ken Pfalzer said that roadside buffers are required only for new commercial construction or remodeling that classifies as a "substantial improvement." Priscilla Murphy's expansion was neither, he added.

The council "put off until tomorrow" looking for a solution to the dilemma. "This is only a first reading," Mayor Mike Klein said. "We have until March 1 to come up with an answer."

## Public hearing scheduled for discussion of netting ban in Sanibel saltwater canals

A hearing to test public reaction to a proposal to prohibit netting saltwater fish in manmade saltwater canals on Sanibel has been set for the Feb. 1 City Council meeting.

The city has asked the state Legislature to prohibit netting saltwater fish in Sanibel's saltwater, manmade canals. The city has no control over private waters, but the Legislature does.

Fritz Holtz, newly elected chairman of the Committee of Neighborhood Associations, told the council last Tuesday that commercial fishermen using fixed nets were taking hundreds of fish from inland waters late at night and creating problems for Islanders who live on canals.

"After two such visits there are no fish left," a Shell Harbor resident confirmed. Holtz said CONA's board of directors had voted to ask the City Council to petition state legislators to introduce legislation similar to a statute passed for Cape Coral that would make it unlawful for

anyone to take any fish from manmade

waters except by hook and line or no more

than five crab traps. Mayor Mike Klein feared that such a

### Deli owners, neighboring attorney appeal order to remove picnic table

Attorney James Dvorin, whose law office is next door to the Dr. Munchies deli in Punta Ybel shopping center, told the City Council last week he would be the first to complain if the deli were not operated "in a proper manner."

Dvorin appeared before the council with Ken Ziegler, a partner in the Dr. Munchies operation, to appeal Code Enforcement Officer Dick Baker's ruling that an outdoor picnic table violates the deli's "take out only" occupational license.

Baker said the table constitutes "onpremise restaurant seating."

Ziegler contended that "on-premise" is

confined to the 1,200-foot space he leases in the Punta Ybel building. He added he had no intention of breaking city laws when he installed the table for the use of customers who were "sitting on the stoop" to eat food purchased in the deli.

He said he considered it "a public service to provide a place for the elderly to rest" and would like to at least provide benches for this purpose.

The picnic table has been removed, he said.

Dvorin showed snapshots of benches outside ice cream stores, a doughnut shop, near trash cans and at the Island Shopping Center.

"You can buy fried chicken at Bailey's store and sit down on a bench outside and eat it," he pointed out.

Councilman Francis Bailey said he had no objection to the installation of a couple of benches not to exceed six feet in length, but only Councilman Bill Hagerup supported the suggestion. Bailey's motion failed by a 2-2 vote with Councilman Fred Valtin absent.

Councilman Louise Johnson said the council had imposed the ban on on-premise eating in response to fears of residents of the neighborhood that the deli would "become a hang out for young people and a nuisance."

Mayor Mike Klein said Ziegler had previously agreed to the restriction and his actions were "flying in the face of the council."

Johnson withdrew her motion to deny the request for a table and-or benches outside the deli when Dvorin, foreseeing another deadlock, asked for a continuance until Feb. 1, when a full council will be present.

Meantime Dvorin said he hoped the council members will pay a visit to the deli to see for themselves.

### Density increase approved to permit duplex project

H.L.U., Inc. received final council approval last week for an increase in density to pave the way for a 24-unit duplex project on a 4.5-acre tract on Periwinkle Way just east of the Burger Emporium.

The council agreed to double the density as an incentive for residential use of the 49acre property that was zoned commercial until last February.

The specific amendment was approved last Tuesday by a 3-1 vote of the council with Councilman Louise Johnson dissenting. Councilman Fred Valtin was absent.

Though Johnson agreed with her colleagues that the conceptual plan for the project was good, she said 24 units were too many for the 4.5-acre area of the property that is developable. Twenty units would be more reasonable, she added, and would not set a precedent.

During the city's revision of the commercial element of the Comprehensive Land Use Plan last year the zoning on H.L.U.'s property was downgraded to residential in line with the city's goal to slow down commercial development on Periwinkle Way.

Attorney Beverly Myers, representing H.L.U., told the council her clients had agreed to dedicate to the city a 26-foot right-of-way along Periwinkle Way and in addition would plant a 20-foot vegetation buffer behind the new property line to screen the project from the road.

The 12 duplex structures will be sited 91 feet from the center line of Periwinkle Way, she said.

Myers said H.L.U. will submit a covenant that there will be no development of the approximately 45 acres of lowlands wetlands in the rear. The property will be

preserved in its natural state either by a homeowners association or a non-profit conservation organization, she added.

H.L.U. will remove Brazilian peppers on the site using a chemical injection to kill the noxious plants, she said.

Under the 2.2-units-per-acre density permitted to encourage residential development of commercial property on Periwinkle Way, the H.L.U. land is entitled to 12 dwelling units.

# **Council approves special use for Pirate Playhouse**

After four months of deliberations and delays the City Council last week approved establishment of a Special Use District to provide for the continuance of the 19-yearold Pirate Playhouse as a community theatre.

By the council's action the front 50,000 square feet of the two-acre property on Periwinkle Way was rezoned from residential to special use to permit construction of a new 150-seat theater and a parking lot for 50 cars and retention of the original playhouse as a museum.

But the council agreed that if a development permit for this use is not applied for within three years the parcel will revert to residential uses only.

The present residential zoning will be retained on the 69,500 square feet of the property remaining at the rear and up to four dwelling units will be permitted.

Access to the residential area must be provided that is separate from the theater parking lot. Purdy Drive was ruled out as

an access because its use is confined by deed restrictions to property owners in the Sanibel Lakes subdivision.

The theater can be used for "entertainment and cultural performances only with 10 percent of the operating time devoted to other than live performances."

This restriction allayed council fears that the facility sometime in the future might be converted to a movie house but at the same time left the door open for showing occasional classic films or other

non-live art forms of entertainment.

The Pirate Playhouse, one time the school for white children on the Island, was operated for almost 20 years by Philip and Ruth Hunter.

To insure continuance of the repertory theater featuring local talent after their retirement, the Hunters last September requested removal of the playhouse from its lawfully existing use category.

New commercial regulations adopted by the city last February that prohibit expansion of these properties and rebuilding in the event they are 50 percent or more destroyed after Jan. 1, 1990, were viewed as a threat to the Hunters' dreams.

The original plan for the future use of the property included an enlarged theater, three special retail art studios and three single-family homes.

The Planning Commission could not support the commercial studios on

residential land and turned down the Hunters' request but with the recommendation that the council continue to work toward a solution to the problem.

On Dec. 7 the council continued a second hearing of the request until the planning staff reviewed a revised plan that deleted the studios and asked for four singlefamily homes.

Philip Hunter died on Christmas Day, and his daughter Robin said this week that worry over the playhouse's future may

have been a contributing factor in his fatal heart attack.

Last Tuesday Hunter's widow breathed a sigh of relief when the council voted 4-0 to approve the Special Use District designation for the playhouse property. Councilman Fred Valtin was absent.

"I'm glad its finally settled," the 81year-old Ruth Hunter said after the meeting. "I couldn't take any more of it." Her son-in-law, Eugene Karr, who ap-


peared before the council with architect

Ray Fenton, said from "seven hours distance I can't see that the city rubber stamped anything or acted impulsively.

# ON THE WATER

#### By Captain Mike Fuery

One comment I often hear from first-time fishermen goes like this: "The water seems awfully dirty. Is it always like this?"

Florida seems to have the reputation of clear waters where you can see down a dozen feet or so. That is true on the lower southeastern coast, but the majority of the coastal waters around the state are of various colors and clarity.

The usual water condition is a kind of semi-clear water where you might be able to see a lure or bait say two feet below surface. This condition does not imply that our waters are contaminated that something else is wrong.

The same holds true with our Pine Island Sound and the adjoining Gulf of Mexico waters. Rarely do they ever clear up to where you can see the bottom other than right next to shore.

There are exceptions to this, and just so you don't run out of things to worry about while on the water, about the worst time to go fishing is when the water is what they call "gin clear."

I have rarely seen it fail. Get the wind just right, usually after it has blown gently out of the same direction for two or three days, and the waters will clear up considerably. Only trouble is, the fish don't bite!

After observing this on several occasions and finding out through painful trial and error fishing, fish not only don't feed well, they even seem to leave that clear water area.

There are pockets of water south and west of Useppa Island and Cabbage Key where waters will clear with gentle winds from the northeast. This generally happens in a wind shadow of the islands. Often you can look down as the boat drifts and spot large shells or bottom features.

Why do the fish, particularly sea trout, stop biting if the water clears too much? I have to guess, but I suspect that it comes down to the presence (or lack) of baitfish.

I think when the waters clear too much visibility becomes very good for predatory fish. The baitfish know they can be found hiding in the grasses or around structurers more easily. So they seek out more "normal" water where they are comfortable and have some degree of protection.

Just the opposite can be true, too. We notice that around the large passes such as Redfish, Captiva and Boca Grande, a murky, stirred-up incoming tide from the gulf will drive inside waters fish away. Too much turbulence suspends great amounts of sand in the water and makes it difficult for fish such as the popular sea trout to find food.

What is the ideal water condition? As you might have noticed, our normal water color is a kind of clear-coffee hue. This is from staining from mangrove trees that line the shore. It is as pure and clean as any around the state -it's just coffee colored. And that's just what the fish look for. You should, too.

If you find yourself fishing in water that is very clear or way too murky, keep moving until you get into stable conditions. This might mean a move down the shore or in the boat of a hundred yards. Sometimes in those clear waters found up around the northern islands, a mile run with the boat will be needed to locate stable water.

The best thing is that whether it's clear or cloudy, it probably won't be like that for very long. Wind and tide conditions will alleviate the condition, often in as little as six hours or the time of a normal tide change.

Good fishing this week. Keep warm and get to know your water conditions for the best "luck."

SHELLING TIPS

### By Captain Mike Fuery

Have you ever walked the beach, picked up a curious shell you can't identify and made a mental note to check it as soon as you get home?

As you learn shells this will happen a great deal at first. But for a couple of years I've been saying to myself that I'll look up one particularly interesting specimen.

During the past couple of years I've called this one a bubble shell. Sometimes I call it a margin shell. And sometimes I just think, "Who cares what it's called? I'll take it anyway."

It took some looking, but the roundish, striped shell that only stands half an inch high at maturity is what I believe to be a coffee bean snail.

They have a coffee colored exterior shell with thin cream colored stripes around it. The trouble with these bean snail shells is that they look a great deal like a couple of others, particularly the margins and bubbles I've mentioned.

Actually, there might be two different kinds of these shells often lumped into a group of shells called salt marsh snails.

As with so many of the more interesting and valued shells found locally, I've never come upon a live coffeebean snail. So you are welcomed to take all you can find, as long as they are dead. I find the best of the shells in the higher shell lines on the beaches.

Being round, they offer little resistance to wave land tidal action and, therefore, can reach way up on the beaches. Other shells, like Florida Fighting Conchs and so on are designed by nature not to roll or move. But roundish shells travel more at the whim of nature.

When you are looking for a half-inch shell, you need to get down on the shell lines and carefully search. Their color is not a stand-out as a golden horse conch might be, so be diligent.

There might even be a couple of types of salt marsh snails around our waters. Besides the coffee bean, there is a necklace snail. These are all the same size, incidentally.

While checking one of my reference books the other day I found that these snails are supposed to be a food source for wild ducks in some areas. We have a lot of wild ducks on our waters at this time of the year, but in the depth of water I see them, I doubt they are searching for snails.

Another thing I found interesting about these snails is that they have the ability to live out of water for some time. They also are active in natural state, being able to


attach to and climb up wide blade sea grasses as they feed.

Getting back to the common bubble shell, the similarities are many in the living shells. There is one great difference, however, should you find that you have collected bubbles and coffee bean snails and can't tell which is which.

The bubble will have a lighter shell, and if you want to give it the final test you will find that without much pressure you can break a bubble between thumb and forefinger quite easily. Of course, too many tests like this will eliminate your supply of bubbles!

Good shelling this week and please remember the limit of only taking two live shells per species, per person. Watch for the outcome of the city of Sanibel's action on possibly stopping all live shelling with exception of a couple of species.

# Senate committee approves eminent domain bill that applies to Cayo Costa, Upper Captiva

A bill to give the state Department of Natural Resources power to condemn and acquire environmentally endangered lands in Southwest Florida and three other Florida counties passed its first legislative hurdle late last week and appears to be heading for early consideration by the Florida State Senate.

The bill by State Sen. Frank Mann and State Sen. Pat Neal would allow the DNR to exercise eminent domain power to acquire land on Cayo Costa, Upper Captiva and Mound Key in Lee County; Rookery Bay and the Fakahatchee Strand in Collier County, and several other tracts around the state.

The Senate Natural Resources Committee voted to approve the eminent domain bill last week. The committee also adopted an amendment to add Josslyn

Island in Lee County to the list of projects slated for eminent domain acquisition at the request of Mann.

Mann said that the bill is moving smoothly through the legislative process and added he has had several conversations with House leaders to smooth the way for passage on the House side of the legislative chambers also.

The House Natural Resources committee is expected to consider early an identical companion bill to Mann's legislation being sponsored by State Rep. Fred Burrall and State Rep. Keith Arnold.

Mann emphasized again that the legislative granting of eminent domain authority to DNR is only for acquisition of the specific parcels listed in the legislation and is not a broad delegation of this power to the department.

"The important thing to remember in this limited eminent domain bill is that we are not granting this power to some state bureacracy with no controls, but rather the power to exercise eminent domain is limited to only those projects identified by the legislature," Mann said. "Thus the ultimate authority over the use of this power rests in the hands of elected officials responsive to the voters."

A similar measure passed the House during the last session of the state legislature but died without consideration by the Senate. The Senate passed the same measure during one of the special sessions of the legislature last year also, but that meaure was unilaterally killed by then-House Speaker Ralph Haben when it came to that side of the legislature.









Every young woman who has ever questioned her capabilities should take a lesson from Betty Lloyd. Young men could learn from the educated, liberated 67-year-old, too; her philosophy about learning and living applies across-the-board.

Betty's advice to young people is that they should get the best liberal arts education they can "to help sort out what is important to you, what you stand for."

Then, she says, "Pass on the marvelous information you learned to help better the human race." That's just what she has tried to do.

Encouraged and inspired by a mother and father who were both well educated and liberated even by today's standards, Betty never thought that as a woman she shouldn't have her own education, her own job, her own money and her own vacations. After all, her mother had all those things.

"I thought all children wore latch keys around their necks so they could get in the house after school," she laughs. "I didn't know any mothers were waiting at home after school."

A professor at the University of Denver, Betty's mother

passed along to her only daughter a deep desire to learn. "She was most upset when I got married before I earned a master's degree," Betty remembers. "She thought that was a terrible waste."

Betty's marriage to Allen Lloyd, however, proved anything but a waste. The couple has always enjoyed "great intellectual sparring," Betty says, and they consider it a challenge every day to see who will come up with the most interesting information.

Their marriage came only after Betty graduated sixteenth in a class of more than 400 women at New York's Smith College and after she worked on her own in New York as a research assistant for an anthropologist at the Carnagie Institute.

Domesticity was all new to the young career woman, who confesses she "knew how to cook rice and thought I should buy a broom" as a bride. But she raised three children and "did the whole routine from PTA to Cub Scouts" before she went after a master's degree.

She was 40 years old when she started graduate school at the University of Cincinnati in teaching exceptional children with physical handicaps. With master's degree in hand, Betty started teaching children who suffered from cerebral palsy, multiple sclerosis and other crippling diseases. Most of her students were black, and she went from house to house to teach them.

"I adored those children," she says. "But sometimes the black neighbors resented the white teacher, and I wasn't always very safe."


So she moved to Cincinnati's public schools and then to the area's prestigious private schools to teach Latin.

The Lloyds moved to Sanibel in 1975. They are active in several community concerns and are forever nurturing their love of reading and learning.

"We're not much interested in jewelry, cars or furnishings," she says. "But we've always been able to have good books and take nice trips."

Betty is convinced that she has been afforded no extraordinary opportunities in her lifetime. "I always worked for what I wanted," she says. "It's just through luck that I happen to be a woman to whom the Equal Rights Amendment does not apply." Tuesday, January 25, 1983

# Dogs, photographic equipment lost as fire guts Seagrape Lane duplex

Fire destroyed one side of a wooden duplex on Seagrape Lane last week, taking with it two dogs owned by winter residents Holger and Ann Stockholm.

The fire damaged much of Stockholm's photographic equipment and slides only three days after the wildlife photographer delivered a presentation at the Sanibel-Captiva Audubon Society's weekly meeting at the Sanibel Community Association hall.

One fire engine and 16 firemen and volunteers responded to the scene after a neighbor noticed flames creeping up the roof.

A search for the two dogs, Reggie and Rose, proved futile as they had already died of smoke inhalation.


The cause of the fire is unknown, but fire

officials believe it was accidental.

Stockholm said the damaged house and camera equipment were insured, but said he and his wife were most distressed by the loss of their dogs. Stockholm spoke of the sentimental value of what was lost. "You can replace

# The eyes have it **Optometrist takes the scare out of bifocals**

Bifocals. Few words in the English language elicit such a response. To many people bifocals are a sign of old age. To others they symbolize the arrival of middle age, and to still others bifocals mean weak eyes.

But to everyone bifocals should symoblize the normal and natural changes that occur in the human body.


The word bifocals is given to a special kind of lens. "Bi" means two, and "focal" means to be clear at two different points. One wears bifocals to facilitate clear vision at two distances.

Unknown to some people who wear bifocals, the two distances can be any

place they desire. Most, however, choose to see clearly at a far distance and close up. Trifocals give clear vision at three distances. And, yes, there are quadfocals to facilitate clear vision at four distances away from the wearer.

What is all this for? To see clearly, or course. From the moment you are born the lens inside your eye grows by adding layers of cells. Instead of losing cells in everyday life, as occurs with other body cells, however, eye cells grow more dense and compacted to accommodate the new cells. This makes the lens stiffen and

#### toughen as time goes on.

When a person focuses on something small muscles inside the eye pull on the lens. The tension varies with the amount of focusing needed, which increases as objects get closer to the eye.

But as cells in the eye accumulate the lens does not bend as much as it used to. The muscles are not weakening; they simply cannot do their job as well. People react to this by either straining their eyes or by moving the object farther away.

Eventually, however, arms get too short -- and bifocals are prescribed. The top part of the bifocal lens is the distance lens; the bottom part is the close up lens.

As time goes on the eye lens gets less and less maleable, which is why the bottom of

your bifocals will need stronger power. That explains why you need "new" glasses every few years.

By the time you reach 65, however, you will have lost almost all the ability to focus and your bifocals do it all for you. Changes from now on are mostly from other causes. Almost everyone who wears them has

some problems with bifocals. They are not

ideal, and they take some getting used to. Small changes in your reading, watching and walking patterns will have to be made to accommodate bifocals.

Just remember -- it's all a part of being lucky enough to live a long and healthy life to the stage where you need bifocals.

# Fiddlers on the marsh

sanibel Sander

Sanibel is populated by many kinds of crabs. Some are edible, such as the Stone Crabs and the Blue Crabs; some are hard to see, such as the Ghost Crabs, those sandcolored nighttime phantoms of the Gulf Beach; some are Hermits that utilize the empty shells of mollusks for -protective homes rather than growing hard shells of their own.

Among our most interesting crabs are the 1- to  $1\frac{1}{2}$ -inch long crabs of the genus Uca, commonly called Fiddlers for reasons that are immediately apparent upon examination.

These tiny denizens of beaches and mud flats are of several species, all equipped with two claws or chelipeds immediately forward of the four pairs of legs. In the females these claws are useful appendages for feeding. After all, females must feed efficiently in order to produce lots of eggs loaded with sufficient nutrients to feed the incubating babies.

In the males, one claw is of modest, useful size. The other claw, either left or right, is a great, cumbersome, inch-long, fearful looking pincer that is of no use in food gathering but is very useful for posturing, driving off rival males and attracting females.

This macho gesturing has a dual purpose -- war and love. As in most animals, the warding off of competing males is largely ritualistic; real warfare and injuries seldom take place during male encounters. Occasionally two males will lock claws briefly and usually harmlessly.

But the same gestures that drive away males are used to attract females, though they are sometimes speeded up a bit once a female has been identified. Only females that are physiologically and reproductively ready will mate.

Let's assume our ludicrously gesticulating male has sent all rivals packing and has succeeded in attracting a ripe female. Love has conquered war. He will attempt to herd the already submissive female into his burrow and, once successful, he plugs the entrance and follows her down to a subterranean chamber where mating takes place.

The female will remain in the burrow during incubation. The male, meanwhile, will emerge and start his fiddlewaving beside a newly dug burrow.

Strong, successful males may breed again and again, thus passing along to future generations strong and successful genes. Darwin, if he were here, would approve of all this.

The burrows are dug by the males, who pelletize the sand or mud and carry it out to the entrance where it can be seen in little spoil mounds until washed away by the next tide. The pelletized spoil is rolled up to the entrance hole by the sideways-moving crab, employing, naturally, the legs on only one side of his body.

Crabs have adjusted their behavior to the tides. Normally, diurnal males wave their fiddles on low tides to drive off males or attract females only in daylight. But what if there is a good nighttime low tide during which reproductive activities should be taking place if the economics of life, energy and time are to be fully exploited?

With nightfall the males cease waving their fiddles and undertake a new activity to attract females and ward off competitors. They scrape their major, or fiddle, cheliped on the front edge of their shells and produce sound -- an attraction to females, but a warning to intruding males. the high spring tides and the low neap tides.

Thus these animals utilize to the best advantage reproductive opportunities in darkness as well as in daylight.

Fiddler females practice a kind of birth control. They have been observed refusing to mate until about five days before a spring tide is due. This way the larvae will hatch on the next neap tide and have sufficient time (about three weeks) to metamorphose through several instars, changing into the young adult form from the planktonic larval stages exactly at the time of the next spring tide. (See chart). Thus one lunar month plus about five days passes from mating to young adulthood.

In other ways, too, Fiddler Crabs adjust to the tides, enabling the young adult to be on the right estuarine territory to start a new generation cycle. The larvae migrate upstream near the water's surface on flood tides, thus riding into the estuary on a rising tide. In order to stay there, they then move toward the bottom where the out-going current is slower on falling tides.

As a result, when they finally become young adults, they are more likely to find themselves well up in an estuarine situation.

I have been having some trouble figuring out how this

process works. But not wishing to be out-smarted by a crab, I persisted and reduced the process to the simple explanation above, ably illustrated by Ann Win-terbotham's accompanying charts.

Fiddler Crabs mob (zoologists call it "drove"). Huge mobs appear, the males waving aloft their fiddle batons. They may mob to find food more efficiently, or perhaps they seek more suitable habitat after a major disturbance such as a storm.

Mobbing is not well understood, but this social function is beautiful to watch. On a warm day on many small beaches of the J.N. "Ding" Darling National Wildlife Refuge one can see, at low tide, huge armies of Fiddler Crabs migrating first in one direction then, on disturbance, reversing in unison.

A skilled choreographer could develop a charming Crab Ballet. (Apres-midi d'un Crabe''?) Maybe Nureyev would come and perform it on our beach.

But if you are a snowbird, you probably won't see such a ballet, for most of the Fiddlers are hibernating this time of year. In any case, you should come some summer and see the true Sanibel. For Sanibel realy comes alive in the summertime!

# 'Wildlife hot spots' take center stage as Audubon society winter program series continues

Nature photographer Lee Canfield has focused on 14 of the nation's "wildlife hot spots" for his color slide presentation-lecture at the Sanibel Community Association hall this Thursday evening.

Canfield's program is the fifth in the winter series presented by the Sanibel-Captiva Audubon Society. Capacity audiences have greeted each of the first four programs, society President Bud Ryckman reports.

Canfield, who usually spends the winter on Sanibel, now resides in Wilmington, N.C., and has recently concentrated his photographic efforts on the water birds of the Cape Hatteras area as well as those of Sanibel.

The "hot spots" depicted in his local lecture will include Big Bend National Park, Texas Rio Grande, Arkansas Sanctuary, Saguaro country, Madiera Canyon, Organ Pipe Park, Grand Canyon, the Tetons, Yellowstone Park, Banff-Jasper in Canada, the Buckeye country and the Maine wilderness in addition to the Carolina coast and Sanibel.

The season's lecture and slide show programs are held at 8 p.m. each Thursday evening through March 31 at the Sanibel Community Association. The final presentation will be a "slide surprise" show combining carefully selected nature photographs taken on Sanibel and Captiva by members and friends of the society. ### Live Shelling Committee discusses Shell Club survey

The city's Live Shelling Committee met on Friday, Jan. 21, in a special session as requested by the City Council in response to a survey recently conducted by the Sanibel-Captiva Shell Club.

The agenda was limited to a review with Shell Club representatives of the results of the club's survey regarding the proposed ordinance that would ban live shelling on Sanibel.

Seven members of the Live Shelling Committee joined committee Chairman Dr. K.C. Emerson for the meeting with eleven members of the public. Shell Club President Art Ford and Alice Anders, chairman of the club's ad hoc committee to study the proposed ordinance, represented that organization.

Each of the more than 10 issues raised in the survey questionnaire was addressed in detail. Everyone at the meeting was given repeated opportunities to address each issue

Of much interest was the issue of taking and possessing live shells for educational and scientific purposes. The committee will recommend to the City Council that a permitting procedure similar to the vegetation permitting procedure be enacted for this purpose.

The committee adjourned without setting a date for its next meeting.

The initial meeting of the SCCF Research Committee took place on Jan. 15, 1980, under the leadership of Dr. Kenneth Preston and during the tenure of Dr. William Webb as foundation chairman.


As SCCF chairman, Webb was instrumental in establishing several committees, including the Publications and Environmental committees. One of the most significant committees, however, was the Research Committee.

Five members attended the first meeting of the Research Committee with the chairman. Eleven members attended the most recent meeting of the committee at the home on Dr. and Mrs. Herbert Rhinesmith on Jan. 14, 1983.

In the three years since its formation the committee has grown substantially and has undertaken a number of projects and studies, including those on barn owls, osprey nesting structures, composting using soldier flies and beach renourishment employing "natural" erosion control and sand accumulation structures.

Perhaps the most significant Research Committee project, however, deals with

# Refuge sets winter programs

The program schedule for the 1983 winter season at the J.N. "Ding" Darling National Wildlife Refuge has been set, acting refuge Manager Bob Ziobro said last week.

In order to help the more than 160,000 visitors who normally tour the refuge between February and April understand what the refuge does to manage wildlife, the following programs will be given from Tuesday, Feb. 1, through Saturday, April

16:

Orientation slide program -- At 9 a.m., 1 p.m. and 3 p.m. on Tuesdays and Thursdays at the Visitor Contact Station auditorium.

Wildlife talks -- At 10 a.m. and 2 p.m. on Wednesdays and Saturdays at the observation tower on Wildlife Drive. At 10 a.m. and 2 p.m. on Fridays at the boardwalk on Wildlife Drive. Subjects will vary. No sign-ups are required for either program. The five-mile Wildlife Drive, walking trails and the two canoe trails on the refuge are open to the public seven days a week from sunrise to sunset. Wildlife observation is best at sunrise, sunset and at low tides.

The Visitor Center Contact Station off Sanibel-Captiva Road is open from 8 a.m. to 3:30 p.m. Monday through Friday. Anyone with questions is encouraged to visit the center or call 472-1100.

water -- its quality, management and perservation in aquatic habitats.

Rhinesmith advises a volunteer team on sampling and testing water samples for many water quality factors such as acidity, alkalinity, sulfites, carbon dioxide, dissolved oxygen, calcium, total solids and salinity.

The city of Sanibel and the SCCF jointly support this important project. Automatic digital titrators that are both very accurate and easy to operate have been acquired to aid the study. Reagent cartridges for different tests are simply inserted in this equipment and the results are accurately and quickly shown on liquid crystal displays.

There are almost three dozen sampling sites at various points on Sanibel's waterways. The study group has been responsive to special water problem situations, but they are not equipped to respond to every fish kill or waterway odor problem. The base line data being accumulated

will provide answers to many of Sanibel's habitat deterioration questions.

Dee Slinkard was invited to suggest projects from her perspective as manager of the SCCF Native Plant Nursery. She chose to highlight certain plant species of special interest and potential to the native plant industry: Leather Fern (Acrostichum danaeaefolium); Myrsine (Rapanea guianensis); and its close relative, Marlberry (Ardisia escallonioides).

Slinkard also cited Joewood (Jaquinia keyenses) and Coontie (Zamia floridana) as being of much interest. Because of its slow growth, Joewood would hardly ever become an important plant in the industry. But Coontie could well become so.

Coontie is a member of the cycad group

related to the conifers in spite of its somewhat "palm-like" appearance.

SCCF Manager Steve Phillips said the widespread planting of Coontie would possibly enable a dependent endangered butterfly species that feeds on Coontie leaves to populate Sanibel if it were reintroduced.

The species of primary interest to Slinkard among those listed was the Leather Fern. She said she hopes data can be accumulated relating to culture techniques, growth rates and growth periods and whether the plant should start from spores or gametophytes.

Slinkard explained that in the Leather Fern there is an alternation of generations. Guidance from an expert in fern culture will be sought, and the name of Penny Rogers was mentioned.


Preston sought the committee opinion on the live shelling issue so he could report to the SCCF Board of Directors. Other foundation committees has also been asked to address the live shelling issue. After considerable discussion the

Research Committee reached the concensus to support the pending ordinance that would ban live shelling on Sanibel except for whelks, clams and oysters.

The control of harvesting whelks, clams and oysters is prempted by the state of Florida. The state does not provide any definitions beyond the designations cited above.

Preston will carry the committee's recommendation to the next SCCF board meeting, which will take place before the ordinance goes to the City Course for final action.

The next meeting of the Research Committee will be held at 2 p.m. on Friday, Feb. 11.



# 'Eagle Lady' returns to Island for encore

As part of the ongoing celebration of the 200th anniversary of the bald eagle as the nation's symbol, "Eagle Lady" Doris Mager will lead an encore eight-mile walk through the J.N. "Ding" Darling National Wildlife Refuge on Saturday, Feb. 5.

Young and old alike are invited to participate in the walk or to sponsor walkers on a per mile basis. Last June 20 walkers on Sanibel braved a searing sun and biting insects to raise more than \$400, which benefitted the Florida Conservation Foundation's raptor research and education program, which Mager heads. She led similar walks in 15 Florida communities last summer, covering 200 kilometers.

Mager has spent much of her life working to improve the plight of raptors. Over the past 20 years she has rehabilitated hundreds of birds of prey, including 45 eagles.

In 1979 Mager garnered national attention by staging a "nest sit-in," spending seven days and six nights in an abandoned eagle's nest in an effort to draw attention to the plight of the bald eagle.

Mager will bring a bald eagle to Sanibel and plans to show it to elementary school students the day before the walk and to walkers at the end of the eight-mile trek.

Sanibel-Captiva Conservation Foundation Manager Steve Phillips says he hopes to double participation and pledges this year.

The first 50 finishers in the walk will earn a signed bald eagle print donated by artist Lew Phillips. The top pledge-getter will receive a framed Florida bald eagle print, a limited edition signed by artist Richard Younger and valued at over \$200. Second and third prizes are a bicentennial eagle print by artist Guy Coheleach.

Registration for the eagle walk starts at 7 a.m at the Ding Darling Visitor Center on Feb. 5. The the walk will begin at 8 a.m. The entry fee is \$1, and each walker will receive a bald eagle guardian pin and identification card. There will be checkpoints and refreshments at each mile.

Mager will lead the walk through the refuge and back to the Visitor Center via the bike path on San-Cap Road.

In addition to Mager and other walkers who participate, pledgers will have an opportunity to sponsor the following Sanibel "celebrity" walkers who have already signed up for the event: Holly Davies, Bill Hagerup, Louise Johnson, Mike Klein, Charles LeBuff, Dick Noon, Steve Phillips, Mark "Bird" Westall and George Weymouth. 

The driftwood is real, too. Wallace says he collects it



She has created leading roles in world premieres or works by Bernstein, Menotti and Moore and has sung and recorded works by Rorem and appeared in concerts with him.



Bill Arthur. Lions state chairman for leader dogs, reported an excellent program on the activities of the leader school in Michigan. A total of 308 dogs were trained and released to legally blind clients in 1982, he said.

Four of the 308 leader dogs were sent to Florida, and the area hopes to receive more dogs for the blind in 1983. Florida has received 15 dogs over the years and is fifth in donations in the school.

There is no charge to the client for the leader dogs, even though it costs \$6,500 to train each dog. The training expense is covered by Lions Clubs all over the United States. Anyone who desires more information about lead dogs should contact the local Lions Club.

The Captiva Christian Fellowship, a mission of the Sanibel church, will hold its first service on Sunday, Feb.


6, at the Captiva Community Center.
